The nucleon form -factors of the energy m om entum tensor in the Skyrm e m odel

The nucleon form factors of the energy-m om entum tensor are studied in the large-N $_{\text{c}}$ lim it in the fram ew ork of the Skyrm e m odel.

I. INTRODUCTION

The inform ation contained in the nucleon form factors of the energy m om entum tensor (EM T) [1] allows to address, am ong others, questions like: How are the total momentum and angular momentum of the nucleon [2] shared among its constituents? Or, how are the strong forces experienced by its constituents distributed inside the nucleon [3]?

An answer is known only to the st of these questions. Deeply inelastic lepton nucleon scattering experiments show that at scales of several GeV 2 about half of the nucleon momentum (considered in the in nite-momentum frame) is carried by quarks, the other half by gluons. An appropriate tool allowing to deduce further information on the EMT form factors became available only during the last decade, namely generalized parton distribution functions [4] accessible in hard exclusive reactions [5, 6, 7, 8, 9, 10, 11, 12, 13], see [14, 15, 16, 17, 18] for reviews.

The perspective to learn in this way about the EMT form factors motivates theoretical studies. The nucleon EMT form factors were studied in lattice QCD [19, 20, 21, 22], chiral perturbation theory [23, 24, 25], and models such as the chiral quark soliton model [26, 27, 28]. (Particular aspects of the EMT form factors were discussed in this model in [29, 30, 31, 32, 33].) In this work we study the nucleon EMT form factors in the Skymem odel [34].

The Skymmem odelhas important virtues. First, the model respects chiral symmetry which plays a major role in the description of the nucleon. Second, it provides a practical realization of the picture of baryons as solitons of elective meson elds motivated in QCD in the limit of a large number of colours N_c [35]. Though $N_c = 3$ in nature does not seem to be a large number, large- N_c relations are often found to agree with phenomenology, although the approach has also its limitations [36]. Hereby it is also important to keep in mind that the chiral limit and the large- N_c limit do not commute [37]. Last not least, the simplicity of the Skymmem odelmakes it an appealing ground for numerous theoretical studies [38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49], see [50, 51, 52] for reviews.

The purpose of the present study is threefold. First, the study of the EMT will shed some light on the model itself. Of particular interest in this context is the stability of the Skyrm ion. Second, we calculate the nucleon EMT form factors in the Skyrmem odel which are of phenomenological interest for the studies of the hard exclusive reactions. Third, we compare the Skyrmem odel results to the outcome from other chiralmodels, in particular, from the chiral quark soliton model [27, 28]. This comparison will help to recognize general features of the EMT form factors which are common in the large-N $_{\rm C}$ soliton approach and therefore likely to be robust.

For completeness we remark that the general chiral structure of the EMT was discussed in chiral perturbation theory and/or chiral models in [53, 54, 55, 56]. Issues of pion EMT form factors in lattice QCD were addressed in [57, 58].

The note is organized as follows. In Sec. II we introduce the nucleon EMT from factors. In Sec. III we brie y review how the nucleon is described in the Skyrme model. In Sec. IV we derive the model expressions for the form factors. In Sec. V we discuss the densities of the static EMT, i.e. Fourier transforms of the form factors. In VI and VII we discuss the properties of the form factors and the numerical results, and conclude in Sec. VIII. The Appendices A-F contain remarks on the notation, technical details and proofs of the theoretical consistency of the approach.

II. FORM FACTORS OF THE ENERGY-MOMENTUM TENSOR

The nucleon matrix element of the total symmetric EMT are characterized by three form factors as follows [1]

where $P = (p + p^0) = 2$, $= (p^0 p)$ and t = 2. The norm alizations $hp^0pi = 2p^0(2)^{3/(3)}(p^0 p)$ and $u(p)u(p) = 2M_N$ are used, and spin indices are suppressed for brevity.

In QCD it is possible to de ne gauge invariant separate quark and gluon parts of the EMT having both decom positions analog to (1) with form factors M $_2^Q$ (t), M $_2^G$ (t), etc. In these decom positions, however, in addition the term s appear g c^Q ; G(t) with c^Q (t) = c^Q (t) which account for non-conservation of the separate quark and gluon parts of the EMT, as only the total EMT is conserved. The quark (gluon) EMT form factors are related to M ellin moments

of unpolarized quark (gluon) generalized parton distribution functions [2] which enter the description of certain hard exclusive reactions [14, 15, 16, 17, 18]. In the following we shall focus on the total EM T . For our approach it is of importance that in the large-N $_{\rm C}$ lim it the nucleon EM T form factors behave as [16]

These relations hold also separately for the quark- and gluon-part of the EM ${\tt T}$.

The form factors of the EMT in Eq. (1) can be interpreted $[\beta]$ in analogy to the electrom agnetic form factors [59] in the B reit fram e characterized by $^0 = 0$. In this fram e one can de ne the static EMT

The initial and nalpolarization vectors of the nucleon S and S 0 are dened such that in the respective rest-frame they are equal to (0;s) with the unit vectors denoting the quantization axis for the spin. The respective form factors are related to T (r;s) by (the following Eqs. (4,5) hold also separately for quarks and gluons)

where the primes denote derivatives with respect to t. The form factors are renormalization scale independent and satisfy at t = 0 the constraints

The rst two constraints mean that in the rest frame the total energy of the nucleon is equal to its mass, and that its spin is 1/2. The value of d_1 is not known a priori and must be determined experimentally. However, being a conserved quantity it is on equal footing with other characteristic nucleon properties like mass, magnetic moment, etc. [60, 61].

The components T_{00} (r;s) and "ijk $r_j T_{0k}$ (r;s) describe the distribution of nucleon momentum and angular momentum, while the components T_{ik} (r) characterize the spatial distribution of strong forces experienced by the partons inside the nucleon [3]. In fact, T_{ij} (r) is the static stress tensor which (for spin 0 and 1/2 particles) is given by

Here p(r) describes the radial distribution of the pressure inside the hadron, while s(r) is related to the distribution of the shear forces [3]. Both are related due to the conservation of the EMT by the dierential equation

O ther important relations originating from conservation of EMT are the stability condition

It is worth to review brie y what is known about d_1 . For the pion chiral sym m etry dictates d_1^Q , = M_2^Q , [60, 61]. For the nucleon the large-N_C lim it predicts the avour-dependence $jd_1^u + d_1^dj - jd_1^u - d_1^dj$ [16] which is supported by lattice calculations [20, 21, 22] and results from the chiral quark soliton model [26, 27, 28, 29, 30, 31]. Both lattice

QCD and chiral quark soliton model yield a negative $d_1^Q = d_1^u + d_1^d$. Also for nuclei d_1^Q is found to be negative [3, 62]. In Ref. [27] it was conjectured on the basis of plausible physical arguments that the negative sign of d_1 is dictated by stability criteria.

The value of d_1 is of interest for phenom enology, since it contributes to the beam charge asymmetry in deeply virtual C om pton scattering [30]. HERMES data [9] indicate a d_1^0 of negative sign though this observation depends to some extent on the employed model for the behaviour of generalized parton distributions in the small-x region [63].

III. THE SKYRME MODEL

In this Section we introduce brie y the Skyrm e m odel. The Lagrangian of the Skyrm e m odel is given by

where U is the SU (2) pion eld, m is the pion mass, e is a dimensionless parameter, tr_F denotes the trace over the avour-SU (2) matrices, and F is the pion decay constant, with F = 186M eV in nature. The parameters scale as

in the large N $_{\rm C}$ lim it, such that L = 0 (N $_{\rm C}$) which guarantees the correct large-N $_{\rm C}$ scaling of the theory.

In the large-N $_{\text{c}}$ lim it the chiral eld U is static. U sing the Skygm e (or \hedgehog") Ansatz, U = exp[i e $_{\text{r}}$ F (r)] with r = jxjand e $_{\text{r}}$ = x=r, one obtains the soliton m ass M $_{\text{sol}}$ = d^3x L as functional of the radial function F (r)

The soliton pro le F (r) which m inim izes (14) is determined by the following di erential equation

In order to ascribe spin and isospin quantum numbers to the soliton one considers U(x)! A (t)U (x)A 1 (t) in (12) with an arbitrary SU (2) matrix $A = a_0 + ia$, introduces conjugate momenta b = 0L=0ab, and quantizes the collective coordinates according to b! i0=0ab0 considering the constraint $a_0^2 + a^2 = 1$. This yields the Hamiltonian

where J^2 and I^2 are the squared spin and isospin operators, respectively. These operators act on the nucleon or wave functions which can be expressed in terms of the collective coordinates a_i , for example, the wave function for a proton with spin up is given by \dot{p} i = $(a_1 + ia_2)$ = , etc. [38]. Here denotes the soliton moment of inertia

It is custom any to treat F and e as free parameters. One way to x them consists in adjusting F and e such that the masses of nucleon and -resonance are reproduced [38, 39]. Hereby one is rest determines the function F (r) which minimizes M sol and then projects on the proper quantum numbers. I.e. one considers the nucleon and -resonance (and hyperons in the SU (3) version of the model) as dierent rotational excitations of the same object.

In order to guarantee a consistent description of the EMT form factors we proceed as follows: We minimize M $_{\rm sol}$ and quantize collective coordinates as described above. In general the model expression for any observable A is

where A_{LO} appears in leading order of the large-N $_{\rm C}$ expansion, while $A_{\rm rot}$ arises from soliton rotations and is suppressed by 1=N $_{\rm C}$ with respect to A_{LO} . For sym metry reasons A_{LO} could vanish. If A_{LO} 60 we shall neglect the contribution of $A_{\rm rot}$ (unless it happens to vanish anyway). In other words, we consider corrections due to soliton rotation if and only if the leading order gives a vanishing result. This step is consistent from a rigorous large-N $_{\rm C}$ lim it point of view, but it implies that we strictly speaking have to lim it ourselves to the comparison of isoscalar and separately isovector avour

com binations of nucleon properties, see Table. I, which are in general of di erent order in the large-N $_{\text{C}}$ expansion. The results obtained below for the total EM T form factors refer, however, both to the proton and neutron. The reasons why other approaches are not favourable are discussed in App. C.

The m asses of the nucleon and \rightarrow resonance as they follow from (16) are of the type (18). (In this case A_{rot} is suppressed with respect to A_{LO} by two orders in $1=N_{C}$.) In our approach M_{N} and M are degenerated and

Experimentally the nucleon and masses dier by about 30% which indicates the typical accuracy we may expect (in the best case) for our results. The Skyrmem odel is, in fact, observed to agree with phenomenology to within a similar accuracy [51]. From this point of view our approach is \within the accuracy of the model.".

In order to x the param eters F and e we choose to reproduce exactly the following observables 1

The experimental value of F=186 M eV is underestimated by 30% which is typical in this model. In order to gain intuition on the performance of the model with parameters xed according to (20, 21) we consider several nucleon observables: isoscalar (I=0 proton + neutron) and isovector (I=1 proton neutron) electric and magnetic charge square radii $hr_{\rm el}^2i_{\rm I}$ and $hr_{\rm m}^2i_{\rm I}$, magnetic moments $_{\rm I}$, the axial coupling constant $g_{\rm A}$, and pion-nucleon sigmaterm $_{\rm N}$. The latter is evaluated analogously to Ref. [39] yielding $_{\rm N}=84 {\rm M}$ eV, which agrees well with results from recent analyses [65], see Table I, which indicate a larger value for $_{\rm N}$ than earlier extractions [66], and also with results from other models, see [67]. All results are summarized in Table I, and agree with phenomenology to within an accuracy of 30% with the exception of $g_{\rm A}$ which, however, comes close to its estimated large-N $_{\rm C}$ value [40].

It is of interest to consider nucleon observables in the chiral lim it. For that it is necessary to specify what happens to the Skymem odel parameters F and easm varies. In this work we shall keep these parameters xed at their

A lso other choices are possible. In this way, however, we preserve the \tradition" [38, 39] of using baryon m asses for param eter xing, and obtain a comparably satisfactory description of the nucleon, see Table I. We stress that in our approach Eq. (20) does not imply that M $_{\rm N}$ and M $_{\rm N}$ are correctly reproduced. Instead, due to (19), one has M $_{\rm N}$ = M $_{\rm N}$ = 1085M eV which agrees to within 15% with the experim ental values. Notice that the nucleon mass appears overestim ated also in other soliton models. The origin of this problem is understood, and one way to solve it was discussed in [52] where it was demonstrated that quantum corrections due to meson uctuations signicantly reduce the soliton energy. A different way of understanding this problem, namely on the basis of notions and methods known from nuclear physics, was indicated in [64].

values in the physical situation in Eq. (21). Hereby we neglect the fact that in general F depends on m [68, 69]. In this way we not that the nucleon (and) mass are reduced in the chiral lim it by

which is within the range of the values considered in chiral perturbation theory. The isovector electric and magnetic charge square radii diverge in the chiral limit. Further results are shown in Table I.

We remark that the description of the nucleon in the Skyrmem odel with the parameter xing (20, 21) is both for nitem and in the chiral limit, see Table I comparable to that in Refs. [38, 39].

IV. THE EMT FORM FACTORS IN THE SKYRME MODEL

In the Skyrm e m odel the canonical EM T , which \mid introducing the notation U $_0$ + i $_a$ $_a$ \mid is given by

is already symmetric. (Notice that in (23) one has to sum over a=1;2;3; and 0 must not be considered as an independent eld, since it is constrained by $0^2+0^2=1$.) For the respective components of the static EMT in Eq. (3) one obtains (c.f. App. C)

From the large-N_c behaviour (13) of the parameters F and ewe see that M_N = 0 (N_c) and = 0 (N_c) such that M₂(t) = 0 (N_c), J(t) = 0 (N_c) and $d_1(t) = 0$ (N_c) holds in agreement with the general large-N_c result (2).

Next we verify the internal consistency of the derived model expressions and demonstrate that they satisfy the general relations (7, 9, 10). For that we extract take the lim it t ! 0 in Eq. (28) and use the fact that $d_1(t)$ is well-de ned at t = 0, see below. By considering Eqs. (14, 19) we see that the extraction in Eq. (7) is satisfied

Now we are in the position to check the third constraint in Eq. (7) for d_1 (t) at zero mom entum transfer. Expanding the expression in (29) for small t, one obtains $\frac{j_0(r^p-t)}{t} = \frac{1}{t} + \frac{r^2}{3!} + t \frac{r^4}{5!} + 0$ (t²). The coefficient of the $\frac{1}{t}$ -term in this series is proportional to $\frac{1}{t}$ or $\frac{r^2}{t}$ or $\frac{1}{t}$ in term sofp(r), cf. Eq. (11). The expression for $\frac{1}{t}$ in term sofp(r) automatically follows from integrations by parts and the relation (9) which we have shown to be valid in the model, see Eq. (34).

V. PROPERTIES OF THE DENSITIES AND RESULTS

It is instructive to consider rst the Fourier transform s the nucleon EM T form factors (28-30), namely the \densities" $T_{00}(r)$, J(r), p(r) and S(r) in Eqs. (24-27). Some of their properties can be derived analytically in the Skyrmem odel. For example, at small r the densities behave as

which one concludes from solving the di erential equation (15) iteratively at small r, see App.D. All constants T_{00} (0), p(0) and A, B, C in (35-38) are de ned to be positive numbers, see App. D for explicit expressions.

A lso the large-r behaviour of the densities can be determined analytically from that of the soliton pro le function. Chiral symmetry and the variational equation (15) dictate the large distance behaviour of the latter to be as follows

In the chiral lim it the constant R $_0^2$, which is introduced here for later convenience, is related to the axial coupling constant g_A according to²

Due to (39) the densities decay at larger exponentially form > 0, but exhibit power-like decays in the chiral lim it

² The relation of q_A to the asymptotics of the prole (39) is valid only in the chiral limit. For example, for the parameters used here Eq. (40) would imply for g_A the value 0:76 to be compared with the correct result 0:73, see Table I, which follows from evaluating directly the axial current m atrix element. We are grateful to the referee for drawing our attention to this fact.

We see that in the chiral lim \ddagger : hr_E^2 i is nite, hr_J^2 i diverges, $d_1 / {R_1 \atop 0} \, dr \, r^4 p \, (r)$ is nite, but the slope of d_1 (t) at zero m om entum transfer, d_1^0 (0) $/ {R_1 \atop 0} \, dr \, r^6 p \, (r)$, diverges.

The same small—and large—r behaviour of the densities was observed in the chiral quark soliton model in [27, 28]. (For the latter this is expected because (41-44) follow from the chiral behaviour of the soliton pro le (39) equally respected in both models.) This indicates that the properties (35-38) and (41-44) are general features in the large-N $_{\rm c}$ chiral soliton approach and independent of dynam ical details of underlying theories.




FIG. 1: (a) The energy density in the nucleon normalized with respect to the nucleon mass, $T_{00}(r) = M_N$, as function of r in the Skyrme model (solid line), and the baryon density B (r) for sake of comparison (dashed line). Both curves yield unity upon integration over the full space. (b) $T_{00}(r) = M_N$ as function of r in the Skyrmem odel in the physical situation (solid line), and in the chiral limit (dashed line). (c) The same as (b) but for the normalized energy density $4 r^2 T_{00}(r) = M_N$, i.e. here the curves yield unity upon integration over r.

Next we discuss the num erical results for the densities starting with the energy density T 00 (r) of static EM T 00 (r) normalized with respect to the nucleon mass as function of r for the physical pion mass in comparison to the baryon density B (r) which coincides with the isoscalar electric charge distribution in the Skymme model. Both curves in Fig. 1a have the same normalization and yield unity when integrated over the full space. The similarity of the curves for r $^{<}$ 1 fm means that nucleon mass and baryon charge are distributed similarly in this region. At large r, however, B (r) falls o much more rapidly than T $_{00}$ (r), in the chiral limit B (r) $^{/}$ 1=r 9 vs.Eq. (41). Therefore the mean square radii, $hr_{\rm E}^2$ i = $(0.73~{\rm fm})^2$ for the physical pion mass (and $(0.94~{\rm fm})^2$ in the chiral limit) in Table II, are much larger than the corresponding values of $hr_{\rm el}^2$ in Table I. The energy density in the center of the nucleon is $2.3~{\rm GeV}$ fm 3 , i.e. roughly 10 times the equilibrium density of nuclear matter. Figs. 1b and c show the behaviour of T $_{00}$ (r) in the chiral limit compared to the physical case with emphasis on the small- and large-r regions.




FIG. 2: (a) The angular momentum density $_J$ (r) normalized with respect to the nucleon spin $S_N=\frac{1}{2}$ as function of r for the physical pion m ass (solid line), and in the chiral limit (dashed line). The curves yield unity when integrated over the full space. (b) The same as (a) but for the normalized angular momentum density $4 r^2 _J$ (r)= S_N , i.e. here the curves yield unity upon integration over r.

Fig. 2 shows the results for the angular momentum density $_J$ (r) which is related to the T 0k components of the static EM T (3) according to Eq. (25). In the chiral lim it $_J$ (r) is strongly decreased in the small-r region compared to the physical situation, see F ig. 2a. This is compensated by the slower decay of $_J$ (r) in the large-r region, see F ig. 2b, which ensures in either case the correct normalization d^3r_J (r) = $S_N = \frac{1}{2}$, cf. Eq. (7). For the mean square radius hr_J^2 i of the angular momentum density (46) we obtain hr_J^2 i hr_J^2 in the physical point. In the chiral lim it hr_J^2 i diverges, see above.




FIG. 3: The distributions of (a) pressure p(r) and (b) the shear forces s(r) as functions of r in the Skyrm e m odel for the physical pion m ass (solid line) and in the chiral lim it (dashed line).

Finally we discuss the distributions of pressure and shear forces which characterize the T ik components of the static EMT according to (8). The pressure, see Fig. 3a, assumes at r=0 its global maximum with 3 p(0) = 0.48 G eV fm 3 . It decreases with increasing r, initially according to Eq. (36), changes the sign at $r_0=0.64$ fm till reaching its global minimum $p_{min}=0.012$ G eV fm 3 at $r_{min}=0.82$ fm. For $r>r_{min}$ the pressure increases tending to zero but remaining always negative according to (42). The distribution of shear forces, shown in Fig. 3b, satisfies s(r) 0 and becomes zero only for r!=0 and r!=1 according to Eqs. (37, 43). The shear forces exhibit one maximum at $r_{max}=0.41$ fm with $s_{max}=0.15$ G eV fm 3 . The above-mentioned numbers refer to m=138 M eV. In the chiral limit the distributions are qualitatively similar, see Fig. 3.

The positive sign of the pressure for $r < r_0$ corresponds to repulsion, while the negative sign in the region $r > r_0$ means attraction. In a mechanically stable object the repulsive forces in the inner region must precisely be balanced by the attractive forces in the outer region | in order to satisfy the stability criterion (10). In Sec. IV an analytical proof was given that the condition (10) is satisfied. It is instructive, however, to investigate in more detail how the stability is realized. For that we decompose the pressure in Eq. (26) into the parts which originate respectively from the 2-and 4-derivative term in the Lagrangian (12) | considering for simplicity the chiral limit where the mass term drops out. (The contribution of the 4-derivative term is labelled in Eq. (26) by the factor $1=e^2$.)




FIG. 4: The decomposition of the pressure in the chiral limit in Skyrmem odel. The graph shows the contributions to $r^2p(r)$ as functions of r due to the 2-derivative (dashed) and 4-derivative term (dashed-dotted) in the Lagrangian (12), and the total result (solid line).

The contribution of the 2-derivative term is negative for all r, see Fig. 4, which means that this term provides only attraction. This is an alternative way of stating that there is no soliton solution in the $\lim_{n \to \infty} 1 = e^2 \cdot 1 = 0$ in Eq. (12). The soliton collapses (shrinks to zero) in this $\lim_{n \to \infty} 1 = e^2 \cdot 1 = 0$ in Eq. (12).

The 4-derivative (Skyme) term \mid introduced, in fact, for the sake of stabilizing the soliton \mid is always positive, see Fig. 4, i.e. responsible for repulsion. For $r < r_0$ the repulsive forces from the 4-derivative term dominate over the attractive forces of the 2-derivative term. For $r > r_0$ the situation is reversed. The two terms yield contributions to the stability condition (10) which are of opposite sign

This corresponds to 8 10^4 New ton= m^2 . One may gain some intuition on this number by considering that this is about an order of magnitude higher than the pressure in the center of a pulsar according to typical neutron star models. By multiplying p(0) with a typical hadronic area of, say, 1 fm^2 one obtains a force 0.5 GeV fm 1 which is about half of the QCD string tension.

Studies in the chiral quark soliton model [27] suggest the following interpretation. The region $r < r_0$ is dominated by the \quark core" where Pauli principle is responsible for repulsion. The region $r > r_0$ is dominated by the pion cloud responsible for binding forces in the elective chiral theory, and thus attraction. Due to the lack of explicit quark degrees of freedom no such interpretation is possible in the Skyrme model but the results are in qualitative agreement with [27].

VI. CHIRAL PROPERTIES OF THE FORM FACTORS

Before we turn to the study of the chiral properties of the EMT form factors (28, 29, 30) it is in portant to remark that the lim its N $_{\rm C}$! 1 and m ! 0 do not commute [37]. The reason for that is the special role played by the resonance. The mass dierence M ${\rm M_N}$ = 0 (N $_{\rm C}$) vanishes for N $_{\rm C}$! 1, and one has to consider the on equal footing to the nucleon as an intermediate state in chiral loops.

One consequence of the non-commutativity of these limits concerns the coe cients of the leading non-analytic (in the current quark masses) contributions (i.e. terms proportional to odd powers or logarithms of m), which are model-independent | i.e.must follow from any consistent chiral approach. These coe cients depend on whether N $_{\rm c}$ is kept nite or taken to in nity. For example the chiral expansion of the nucleon mass reads

For scalar-isoscalar quantities the \discrepancy" is found to be always $k_I=1$ for nite N $_{\text{c}}$ vs. $k_I=3$ for large N $_{\text{c}}$. For vector-isovector quantities a di erent factor k_V appears which is $k_V=1$ for nite N $_{\text{c}}$, and $k_V=\frac{3}{2}$ for N $_{\text{c}}$! 1. The factors k_i follow from soliton symmetries [71]. The form factors M $_2$ (t) and d_1 (t) are of scalar-isoscalar type.

Scalar-isovector or vector-isoscalar quantities (J (t) is an example for the latter) appear at subleading order of the large- N_c expansion and arise in the soliton approach from soliton rotations. For such quantities the non-commutativity of the limits N_c ! 1 and m ! 0 exhibits a more complicated pattern. A rst example for that was encountered in the Skyrme model, where the isovector electric mean square radius diverges in the chiral limit as 1=m [39] | and not as lnm [70]. The reason for that is that by limiting oneself to $1=N_c$ -corrections due to soliton rotations only, one ignores pion-loop corrections which appear at the same order in $1=N_c$. The probably most advanced exploration of such corrections was given in [52]. Taking them here into account would go beyond the scope of the present study. Let us discuss rst the chiral properties of the form factor d_1 (t). Its chiral expansion at t=0 reads, see App. E,

Here and in the following the superscript—above some quantity denotes its value in the chiral limit. Thus, d_1 is nite in the chiral limit. Noteworthy it receives a large leading non-analytic (linear in m) contribution.

From the large-r behaviour of the distributions of pressure and shear forces in Eqs. (42, 43) we concluded that the derivative of d₁ (t) at zero m omentum transfer diverges in the chiral lim it. M ore precisely, we obtain, see App. E,

For the chiral expansion of the mean square radius of the energy density, which is de ned in (45) and which will be needed in the discussion of the behaviour of the form factor M $_2$ (t), we obtain, see App.E,

Thus, hr_E^2 i increases in the chiral lim it | as all m ean square radii do | but rem ains nite. The normalization of the form factor M $_2$ (t) at zero m omentum transfer is xed to unity, see Eq. (7). However, its derivative which is given in terms of hr_E^2 i and d_1 , see below Eq. (53), has a non-trivial chiral expansion, namely

A lso the norm alization of J (t) at zero-m om entum transfer is xed, see Eq. (7), and what is of interest is e.g. $J^0(0)$ whose chiral behaviour follows from that of the mean square radius of the angular momentum density (46), namely

see App.E. We see that hr_J^2 i diverges in the chiral lim it which con rms our qualitative conclusion drawn from the large-r behaviour of the density $_J$ (r) in Sec.V. In (54) one could elim inate the soliton moment of inertia in favour of the -nucleon mass-splitting M $M_N = \frac{3}{2}$.

The results for the chiral expansions in Eqs. (50-54) agree with the results obtained in the CQSM [27]. This is not surprizing. Both models describe the nucleon as chiral solitons whose structure is characterized by certain soliton prole functions. Those are determined by dierent dynamics, but what they have in common is the long-distance behaviour (39) uniquely xed by chiral symmetry. (It is worthwhile remarking that it is possible to de ne a formal limit in which the Skyrmem odel expressions follow from the chiral quark soliton model [72].)

For d_1 (t) and M $_2$ (t) which appear in leading order in the large N $_c$ expansion our results agree with those obtained in chiral perturbation theory at nite N $_c$ [25] | up to the expected factor k_I = 1 vs. 3, see Eq. (49). For J (t) which appears at subleading order of the large N $_c$ expansion we obtain J 0 (0) / 1=m vs. lnm at nite N $_c$ [25] which is also expected, see the discussion above.

In the next Section we will discuss up to which values of m the chiral expansions (50-54) provide useful approximations for the exact model results.

VII. RESULTS FOR THE FORM FACTORS




FIG. 5: The nucleon EMT form factors M₂(t), J(t) and $d_1(t)$ as functions of t in the Skyrmem odel for the physical value of the pion mass (solid lines) and in the chiral limit (dashed lines). In the chiral limit J(t) and $d_1(t)$ exhibit in nitely steep slopes at t = 0, see text.

Taking according to Eqs. (28–30) the Fourier transforms of the \densities" T_{00} (r), $_J$ (r), $_P$ (r) discussed in Sec.V yields the nucleon EMT form factors. The large-N $_C$ approach can describe form factors for $_T$ $_J$ $_J$ $_J$ Here we restrict ourselves to 0 (t) $^<$ 1 G eV 2 . In this region of t relativistic corrections were estimated not to exceed 30% [46] which is within the accuracy of the model. The results for the nucleon EMT form factors M $_Z$ (t), J (t), d $_I$ (t) are shown in Fig. 5. For the physical pion mass all EMT form factors can be well approximated to within an accuracy of (1–2)% by dipoles of the type

for 0 (t) $^{<}$ 0.8 G eV 2 . Fig. 5 shows the form factors also in the chiral limit. Here dipole approximations are not useful for J (t) and d_{1} (t) which exhibit in nitely steep slopes at zero momentum transfer.




FIG. 6: Nucleon form factors normalized with respect to their values at t=0 in the Skymmem odel as functions of t: The EMT form factors M $_2$ (t) (solid line), J (t) (dashed line), d $_1$ (t) (dotted line), and the isoscalar electric form factor G $_E$ (t) (dashed-dotted line) for the physical value of the pion mass (a), and in the chiral limit (b).

It is instructive to compare within the model the EMT form factors to the electromagnetic form factors | for example to the electric isocalar form factor $G_E^{I=0}(t) = G_E^p(t) + G_E^n(t)$ | $G_E(t)$ | [45]. Fig. 6 shows $G_E(t)$, $M_2(t)$, J(t), $d_1(t)$ normalized with respect to their values at t=0 where necessary. For the physical pion mass $M_2(t)$ and J(t) exhibit a similar t-dependence as $G_E(t)$, while $d_1(t)$ exhibits a faster fallo, see Fig. 6a. The similarity of $M_2(t)$ and $G_E(t)$ persists in the chiral limit, but $d_1(t)$ and $d_1(t)$ have in nitely steep slopes at t=0 and fallo much faster with decreasing t than $M_2(t)$ and $G_E(t)$, see Fig. 6b.




FIG. 7: Relation of stability and the sign of d_1 . (a) $r^2p(r)$ as function of r for the physical pion m ass. Integrating the curve over r yields zero because the inner-positive-pressure-region precisely cancells the outer-negative-pressure-region. (b) $r^4p(r)$ multiplied by the constant $\frac{5}{4}$ M N 4 as function of r. Integrating this curve over r yields d_1 which apparently has a negative sign.

No principle was the normalization of the form factor d_1 (t) at zero-momentum transfer | in contrast to M $_2$ (t) and J (t). On the basis of stability requirements it was conjectured that d_1 d_1 (0) must be negative [27], i.e.

In fact, the conservation of the EMT dictates $^{R_1}_0$ dr 2 p(r) = 0. For a mechanically stable object the pressure must be positive (repulsion) in the inner region r < r_0, and negative (attraction) in the outer region r > r_0, as we observe also in the Skyrmem odel, see Sec. V. This picture of the distribution of pressure forces, Fig. 7a, imm ediately dictates a negative sign for d_1 / 0_0 dr 4 p(r) = 0, Fig. 7b. Thus, the Skyrmem odel fully con rms the conclusion (56).

Num erically we obtain $d_1 = 4.48$ at the physical value of the pion m ass for our choice of parameters, which con m s not only the sign but also the magnitude of results from the chiral quark soliton model [26, 27, 28, 29, 30, 31].

It is also of interest to compare the chiral expansions in Eqs. (50-54) to exact model results which is done in Fig. 8. Figs. 8a, b show that the exact chiral behaviour of d_1 and the mean square radius of the energy density in the model is dominated by the leading non-analytic contributions in Eqs. (50, 52) up to the physical value of the pion mass.




FIG. 8: (a+b): The constant d_1 and the mean square radius of the energy density hr_E^2 i as functions of m . Solid lines: exact results. D ashed lines: C hiral expansions up to 0 (m²) according to Eqs. (50, 52). (c+d): The numerical conmations that d_1^0 (0) and hr_J^2 i diverge in the chiral limit as 1=m according to Eqs. (51, 54).

Figs. 8c, d show that the slope of d_1 (t) at t=0 and the mean square radius of the angular momentum density diverge in the chiral lim it as 1=m precisely as predicted by Eqs. (51, 54). (The smallest nite value of m computed numerically in Figs. 8c, is about 1 M eV.)

Finally, we turn our attention to the trace of the EM T . Due to the trace anomaly in QCD [73] the operator of the trace of the total EM T is given by

Let $F_{\rm tr}(t)$ denote the scalar form factor of the operator (57) which is, of course, not independent but a linear combination of the EMT form factors. The small-t expansion of $F_{\rm tr}(t) = 1 + thr_{\rm tr}^2 i = 6 + 0$ (t^2) denose the mean square radius $hr_{\rm tr}^2 i$ which is related to $hr_{\rm E}^2 i$ and d_1 as [27]

In the chiral lim it $h_{\rm tr}^2$ is the mean square radius of the gluonic operator F F . The large value obtained in (59) is rather interesting, in particular, if we confront it with the mean square radius of the traceless part of the EMT estimated by means of QCD sum rules to be about 0:1 fm 2 [74]. A possible explanation why the radii of the trace and the traceless part of the EMT dier so much could be provided in the instanton vacuum model [75], see [27] for details.

VIII. CONCLUSIONS

In this work we presented a study of the form factors of the energy momentum tensor of the nucleon in the Skyrme model. The numerical results for the form factors are in good qualitative agreement with results from the chiral quark soliton model [27]. Also the Skyrme model yields a negative constant d_1 and con rms the conclusions drawn in [27] that d_1 must be negative for a mechanically stable object. Numerically we not for the constant $d_1 = 4.88$ in agreement with estimates from the chiral quark soliton model [26, 27, 28, 29, 30, 31].

Results from both models suggest that all form factors can be well approximated by dipole ts for 0 (t) $^{<}$ 1 G eV 2 . M $_{2}$ (t) and J (t) exhibit a similar t-dependence as the isoscalar electric form factor, while d_{1} (t) shows a much faster fall-o with decreasing t. B oth the Skyrme and chiral quark soliton model [27] predict for d_{1} (t) a dipole mass

of $0.7\,\mathrm{G}\,\mathrm{eV}$. The predictions for the t-dependence of d_1 (t) could contribute to an explanation of the t-dependence of the beam -charge asymmetry observed at HERMES [12]. Of particular interest is also the predicted t-dependence of the form factor J (t) which is of relevance for extracting from data the quark angular momentum contribution to the nucleon spin [76]. From the experience with the description of other observables in the Skymem odel we expect our predictions to hold to within an accuracy of (30{40}% though, of course, as always data will have the nal say.

In this work we used the sim plest version of the Skyrm e m odel [34]. It would be interesting to study the nucleon EMT form factors in extended versions of the Skyrm e m odel which include e.g. vector-m esons [47, 48, 49], in order to see how these degrees of freedom contribute to the stability of the soliton and to the constant d_1 .

APPENDIX C:ROTATIONAL CORRECTIONS FOR T_{00} (r), p(r) AND s(r)

The expression for a quantity in the Skyrmem odel is in general of the type (18). In this work we have chosen to consider rotational corrections to a quantity if and only if it receives no contribution from the leading order of the large-N $_{\rm C}$ expansion. This Appendix aim s at making the arguments in favour of this procedurem ore clear.

In our approach we have, in particular, neglected rotational corrections to the densities T_{00} (r), p (r) and s (r). What would have happened if one kept these rotational corrections? Let us denote the densities with included rotational




FIG. 9: $r^2p(r)$ in the Skyrmem odel as function of r. Dashed line: Result obtained following the procedure (A), see text, used e.g. in Ref. [38]. Solid line: Result obtained following the procedure (C) used in this work. B oth curves refer to the chiral limit.

A. One procedure, used e.g. in [38, 39], consists in m in in izing only the soliton energy M $_{\rm sol}$ in Eq. (14), but keeping the respective rotational corrections understood as small perturbations. Then e.g. the nucleon or mass are obtained by adding up the minimized soliton energy M $_{\rm sol}$ and the rotational energy $\frac{S(S+1)}{2}$. This procedure strictly speaking does not yield a stable soliton. This can be demonstrated e.g. by evaluating the pressure p(r) with the proble function which minimizes M $_{\rm sol}$. For the parameters used in [38] we obtain the result shown in Fig. 9. Clearly, the p(r) evaluated in this way is always positive and violates the stability condition (10). This is not surprizing because from the proofof the stability condition in the Skyrmem odel given in App.B it is clear that (10) will be satis ed if and only if one evaluates the pressure with that prole function which minimizes the full energy.

Thus, also with included rotational corrections one obtains a consistent description of the form factors of the EM T. The problem is, however, that (C 4) has no solution in the chiral lim it, while the solutions which exist for su ciently large m yield results in con ict with chiral sym m etry [43, 44], see also the review [51].

The m inim ization of M $_{sol}$ = M $_{sol}$ + $\frac{S(S+1)}{2}$ would be unsatisfactory also from the point of view of large-N $_{c}$ counting, as no contribution of O (N $_{c}^{0}$) is included. Such terms could in principle be taken into account by adopting the Peierls-Yoccoz projection technique in non-relativistic many body theory [77, 78, 79]. If one assumes the "small overlap approximation" the energy is similar to the one obtained approximately by pion corrections to the Skyrme model [80]. In the chiral quark soliton model, which is in this respect similar to the Skyrme model, this has been discussed in Ref. [64].

C. A consistent description of the nucleon EMT which respects chiral symmetry is obtained by adopting the procedure used in this work. After quantizing the soliton one neglects rotational corrections with respect to the leading order contribution unless the latter is zero. I.e. rotational corrections are considered if and only if the leading order contribution happens to vanish for symmetry reasons.

In this way one strictly speaking cannot describe the proton and neutron separately, but has to limit oneself to isoscalar and isovector quantities which are in general of dierent order in the large- $N_{\rm c}$ expansion. This is what we did in this work, see e.g. Table. I. However, the results obtained here for the total EMT form factors refer both to the proton and neutron if one neglects isospin violation (and electrom agnetic corrections).






FIG. 10: Solid lines: The dimensionless quantity = $F^{0}(0) = (eF^{0})$ as function of eE^{0} = eE^{0} in the region of (a) small eE^{0} 0:5, and (b) up to eE^{0} 25. Dashed lines: The function eE^{0} = eEE^{0} + 1 which is smaller than eEE^{0} demonstrating that eEE^{0} 0 0.5,




FIG.11: The function f (r;m) de ned in Eq. (E1).

The function f(r;m) can be determined uniquely from (E1) after Eq. (15) has been solved for F(r) with the boundary values F(0) = and F(r) ! 0 as r ! 1. where G₂ (a;m) is a function similar to (but much lengthier than) that in Eq. (E6), whose smallm -expansion reads

which yields the chiral expansion of d_1 quoted in Eq. (50). Starting from the expression (11) which expresses d_1 in terms of p(r) one reproduces the result in Eq. (50) by a similar calculation. We stress that also the calculations leading to (50) respect the model equations of motion.

Next we consider the mean square radius of the energy density dened in (45). Since $T_{00}(r) / \frac{1}{r^6}$ at large r, see Eq. (41), the mean square radius of the energy density has a well dened chiral limit. Its rst chiral correction appears already in linear order in means of a calculation which is completely analog to that in Eq. (E8) and yields the result quoted in Eq. (52).

Finally, we consider the mean square radius of the angular momentum density which is dened in (46). A calculation analog to that in Eqs. (E3-E7) yields the result quoted in Eq. (54).

The last result holds for all mean square radii. The functions G (y) are dierent for the dierent quantities.

If one choosese, F di erently from the parameter xing used in this work in Eqs. (20, 21), then the relations (F1) allow to rescale the results for the respective quantities in terms of the new parameters. Strictly speaking one needs for that the m -dependence of the respective quantities which we have provided in Sec. VII for quantities of interest.
