KINETIC EQUATIONS FOR LONGWAVELENGTH EXCITATIONS OF THE QUARK-GLUON PLASMA

A bstract

We show that longwavelength excitations of the quark-gluon plasma are described by simple kinetic equations which represent the exact equations of motion at leading order in g. Properties of the so-called \hard therm al loops", i.e. the dom inant contributions to am plitudes with soft external lines, nd in this approach a natural explanation. In particular, their generating functional appears here as the e ective action describing long wavelength excitations of the plasma.

Signi cant progress has been achieved recently in understanding long wavelength excitations of a quark-gluon plasm a [1, 2, 3]. In equilibrum, at high tem perature, such a plasm a m ay be viewed as a gas of weakly interacting, m assless quarks and gluons. W hen coupled to weak and slow ly varying perturbations, this system m ay acquire a collective behaviour on a length scale 1=gT, where T is the tem perature and g the coupling constant, assumed to be small. In this letter, we present a consistent and physically intuitive description of such long wavelength phenom ena, based on a set of coupled m ean eld and kinetic equations, to which the exact equations of m otion reduce in leading order in g[4, 5].

The kinetic equations encompass all the so-called \hard them alloops" and clarify the nature of their remarkable properties, left largely unexplained by their original derivation in terms of Feynman diagram s[6, 7, 2]. These hard them alloops (HTL) are the dominant corrections, at high temperature, to am plitudes involving soft external lines. (Following the usual term inology, we call an energy or a momentum \soft" when it is of order gT, and \hard" when it is of order T; at equilibrum, most particles are hard.) As they are of the same order of magnitude as the corresponding non-vanishing tree level am plitudes, HTL need to be resummed consistently in higher order calculations[1, 2].

O ur equations isolate consistently the dom inant term s in g in the hierarchy of equations which describe the response of the plasm a to weak and slow ly varying disturbances, i.e. varying on a scale of order 1=gT. In doing so, we treat bosons and ferm ions on the same footing and introduce an average ferm ionic eld (X) in parallel with the average gauge eld A (X). A noteworthy feature of the present problem is that g, besides m easuring the interaction strength, controls the wavelength of the soft space-time variations and, for consistency, also the strength of the mean elds. One nds for example that, in order for the deviations away from equilibrium to stay small, the gauge eld strength tensor should be at m ost of order gT²; then gA gT is of the same order as the derivative of a \slow ly varying" quantity [4, 5].

The dom inant interactions which determ ine the response of the plasm a are those which take place between the hard particles and the soft mean elds. In leading order, we can neglect the direct interaction between the hard particles, which allows us to truncate the equations at the level of the 2-point functions. The motion of a given hard particle is only slightly perturbed by its interaction with a soft mean eld. However, because the mean elds vary over distances much larger than the interparticle distance (1=T), they a ect coherently many hard particles, giving rise to collective \polarization" phenomena. These show up as \induced sources" which add to the external ones in determining the properties of the mean elds.

The equations for the quark and gauge average elds are

Here and j^a are external sources, $a = 1; ...; N^2$ 1 are color indices for the adjoint representation of the SU(N) gauge group, while ; = 0; ...; d 1 are space-time indices (d = 4 throughout this work). The covariant derivative is D (e + igt^aA^a and F [D ;D]=(ig). When using a covariant gauge, one should also consider equations for ghost mean elds. These are not written here as it turns out that they are trivial, i.e there are no induced sources for the ghost mean elds[5]. A fler functional di erentiation, the induced sources yield the one particle irreducible amplitudes with soft external lines. Thus for example the ferm ion self-energy is given by $(x;y) = i^{ind}(x) = (y)$, the gluon polarization tensor by $i^{ab}(x;y) = j^{ind a}(x) = A_{b}(y)$, etc...

In leading order, the induced sources can be expressed entirely in terms of 2-point functions. For example, $^{ind}(x) = g t_a h A^a(x) (x) i_c$, where the subscript c indicates a connected expectation value which, in leading order, involves only the hard particles. The abnorm all quark-gluon propagator which enters ind is nonvanishing only in the presence of the ferm ionic mean eld . It vanishes in equilibrum, as does the induced color current j^{ind} . This current receives contributions from both ferm ionic and bosonic particles, and accordingly may be written as $j^{ind} = j_f + j_b$. The quark contribution is $j_{fa} = gh(x) t_a(x)i_c$. In an arbitrary covariant gauge, the bosonic piece involves contributions from both hard gluons and hard ghosts [5]. The polarization phenom ena m ay be induced either by a gauge eld A, or by a ferm ionic one, . Correspondingly, we set $j_f = j_f^A + j_f$ and $j_b = j_b^A + j_b$. Here, for instance, j_f^A is the color current associated to the collective motion of hard ferm ions induced by the soft mean eld A. It is independent of the ferm ionic eld . In contrast, we shall see that j has generally a dependence on A in posed by gauge covariance. Note also that the ghosts do not contribute to j_b , as they have no direct interaction with the ferm ionic mean eld.

In order to implement the condition that the average elds are slowly varying, it is convenient to use the W igner transform of the 2-point functions, such as

for the quark propagator. Note that, in contrast to other authors, we do not insist on de ning manifestly gauge covariant W igner functions [8]. Covariance will be recovered

later, when calculating physical quantities. The induced sources are then integrals over k of W igner functions, which we refer to as k-space densities. For example:

where K^a (k; X) is the W igner transform of the quark-gluon propagator K^a (x; y)

hI (x) A^{a} (y) i_{c} . Thus k(k;X) t^a $k^{a}(k;X)$ t^a K^a(k;X) is the k-space density for ^{ind}(X). The densities for the induced currents are denoted by $J_{f;b}^{A}(k;X)$ and $J_{f;b}(k;X)$. For example, the ferm ionic density is $J_{f}^{a}(k;X) = Tr$ t^aS(k;X), where the trace refers to both spin and color indices.

At leading order in the coupling g, the equations for the densities of the induced sources read [5]

In these equations, $H'(k;X) = K'^{y}(k;X)^{0}$, C_{f} (N² 1)=2N is the quark Casim ir, N_f is the number of quark avors and f^{abc} denote the structure constants of SU (N). Furtherm ore, (k) $_{0}(k)N(k_{0})$ and $^{\sim}(k) _{0}(k)n(k_{0})$, where $_{0}(k) = 2$ (k_{0}) (k^{2}) is the spectral function for free massless particles, and N (k_{0}) and n (k_{0}) denote respectively boson and ferm ion occupation factors. The factor (d 2) in Eqs. (5) and (9) re ects the fact that only the transverse gluons e ectively contribute to the densities.

Eqs. (5-9) have a number of interesting properties: i) They are independent of the gauge xing parameter which enters calculations in general covariant gauges [4, 5]. ii) In their right hand sides, all possible vacuum contributions cancel. iii) They transform covariantly under a local gauge transform ation of the mean elds A , and . The densities J_f , J_b and k involve W igner transform s which are gauge covariant in leading

order. The current induced by a gauge eld involves k-space densities, J_{f}^{A} and J_{b}^{A} , which are derived from non covariant W igner functions. However, these densities are dened up to a total derivative with respect to k which does not contribute to the integrated current. We have used this freedom in order to make the densities explicitly covariant [4, 5]. iv) The symmetry between Eqs. (6) and (9) rejects the fact that hard quarks and gluons respond similarly to a soft gauge eld. The same symmetry is apparent in Eq. (5) expressing the elect of the fermionic mean eld on the hard particles. v) Note nally the presence of the factor (k²) in the rhis of these equations. This rejects the elementary dynamics of the hard particles: they remain on their unperturbed mass shell and only undergo essentially forward scattering on the mean elds.

As these remarks strongly suggest, the motion of the hard particles described by Eqs. (5-9) exhibits many features of classical dynamics. This becomes more transparent if one makes explicit the structure of the various densities in plied by these equations. For instance, Eq. (6) in plies

where $n = n^a t^a$ are uctuations in the quark color densities induced by the gauge eld. These uctuations satisfy (with $k = \frac{3}{5}$)

In the abelian case, this equation coincides with the linearized V lasov equation. Here, the color electric eld not only modi es the motion of the particle, but also induces a $\precession"$ of the densities in color space. The other equations may be given similar interpretation. Thus, Eq. (5) for the quark-gluon W igner function K describes uctuations where, under the action of a soft ferm ionic mean eld, quarks are converted into gluons and vice-versa.

The total current induced by a gauge eld A is $j^{A} = j_{f}^{A} + j_{b}^{A}$. Its k-space density, $J^{A} = J_{f}^{A} + J_{b}^{A}$, satis es

This equation generalizes the V lasov equation to nonabelian plasm as. P revious attempts to derive such an equation led to more intricate results. However, they were based on di erent approximation schemes which mix leading and non leading contributions in g and, as such, are not entirely consistent [8]. One can also combine Eqs. (7) and (8) into a single equation for the total current density induced by the fermionic edds, $J = J_f + J_b$;

This equation is similar to the corresponding one in the abelian case [4]. In doing the sum of Eqs. (7) and (8), the typical non-abelian e ects cancel; these are contained for example in the second braces in Eq. (7), and involve the 3-gluon vertex leading to gauge eld insertions on the hard gluon lines. This kind of cancellation was rst noted by Taylor and W ong [9] in relation with the HTL's for am plitudes involving one pair of quarks and any number of soft gluons (albeit their proof is only explicit up to three external gluons).

We have thus reduced the set of equations (5-9) to three fundam ental equations, namely Eqs. (5), (12) and (13) for the densities of the induced sources. From the gauge-covariant character of these equations, it follows that, under local gauge transform ations, ^{ind} transforms like , while j^{ind} transforms like F . Provided the external sources are chosen so as to satisfy the same property, the mean elds equations (1) and (2) are then gauge covariant, as are the classical equations of motion derived from the QCD action.

Eqs. (5,12,13) contain all the information on the generalized polarizability of the plasma. After solving Eq. (5), we compute the fermionic induced source according to Eq. (4) and obtain

with $!_0^2$ C_f ($g^2T^2=8$) and v (1; v), v $k=_k$. The angular integral runs over all directions of v, and U (x; y) is the parallel transporter along a straight line joining x and y[4]. The kernel _A is the self energy of a soft ferm ion propagating in a background gauge eld. The current induced by ferm ionic mean elds results from Eq. (13):

The correction $^{\mathbb{A}}$ to the quark-gluon vertex m ay be easily read out from this equation. Finally, the current induced by soft gauge elds is determined from Eq. (12) to be

Here $!_p^2$ ($g^2T^2=9$) (N + N_f=2) is the plasm a frequency. By successive functional di erentiation with respect to A of Eq. (16) we derive corrections to the equilibrum amplitudes for soft gluon elds. All the amplitudes obtained in this way, as well as those contained in $_A$ and in A , coincide with the HTL's of the diagram matic approach.

Eqs. (14-16) in ply the following covariant conservation laws for the induced currents [5]:

By dimensional distributions with respect to the meds, one obtains relations between HTL referred as Q ED -like W and identities" in Ref.[7, 2]. Finally, by using these relations, together with the Jacobi identity [D; P; F] = 0, we see that the external sources must satisfy

in order for the mean elds equations (1,2) to be consistent.

By elim inating the induced sources from Eqs. (1,2), using their explicit expressions (14-16), one obtains nonlinear equations ofm otion which generalize the M axwell equations in a polarizable m edium. In particular, for vanishing external sources, these equations describe the norm alm odes of the plasm a. Note that in general, as a consequence of gauge covariance, quark and gluon m odes m ix.

These non linear equations for the mean elds can be generated by the minimal action principle applied to an elds action $S_{eff} = S_0 + S_{ind}$. Here S_0 is the classical QCD action, while S_{ind} contains the elds of the interactions between the soft elds and the hard particles of the plasma. It follows that S_{ind} must satisfy $S_{ind} = (X) = i^{ind}(X)$ and $S_{ind} = A_a(X) = j^{inda}(X)$. These conditions are satisfied by $S_{ind} = S_f + S_g$, with [5]

where the trace acts on color indices only. This gauge invariant action coincides with the generating functional for HTL's derived in [9] on the basis of gauge invariance. Here S_{eff} has a di erent, more physical, interpretation: it is the classical action describing long wavelength excitations in the hot quark-gluon plasma, at leading order in the coupling g.
