## FERM ION DENSITY INDUCED INSTABILITY OF THE W -BOSON PAIR CONDENSATE IN STRONG MAGNETIC FIELD <sup>1</sup>

## ABSTRACT

The electroweak vacuum structure in an external magnetic eld close to the lower critical value is considered at nite ferm ion density. It is shown that the leading e ect of the ferm ions is to reduce the symmetry of the W -pair condensate in the direction of the magnetic eld. The energy is minimized by the appearance of a helicoidal structure of the condensate along the magnetic eld.

1. In the presence of strong external magnetic elds the ground state of the W einberg-Salam theory exhibits a very interesting structure. W hen the eld is increased above the critical value  $H_{c1} = m_W^2 = 10^{4}$  G auss,  $W^+ - W$  pairs condense in an Abrikosov-type vortex lattice. Increasing the eld above  $H_{c2} = H_{c1} = \cos_W$  leads to the vanishing of the Higgs vacuum expectation value and a restoration of SU (2) U (1)-symmetry. It is thus possible to reach the ordered phase of the electroweak theory not only by increasing the temperature but also by increasing the magnetic eld [1], [2], [3].

P reviously, the development of the instability for  $H > H_{cl}$  has been studied by neglecting the presence of ferm ions in the system. For gauge and Yukawa couplings in the perturbative regime, the elect of the D irac sea will be to renormalize the elective action of the bosonic elds. The presence of a nite density of ferm ions, however, gives a qualitatively new elect on the intermediate phase, because of the ferm ion number nonconservation in the W einberg-Salam theory.

The lattice of vortices, found in [1], is how ogeneous in the direction of the external eld. In the presence of nite ferm ion density, however, the developm ent of an inhom ogeneity in the eld direction causes (through the B + L-anom alg) some occupied positive energy levels to fall into the D irac sea, bwering the Ferm i energy. This energy gain m ay overcome the energy loss due to the inhom ogeneity, leading to the form ation of a structure that is periodic in the direction of the eld. The physics of this instability is rem iniscent of the Peierls transition in 1-d m etals [4], or m ore closely, of the instability of the charged-W condensate in cold nonneutral ferm ionic m atter [5].

This letter is organized as follows. In sect 2 we review the essential properties of the Ambj m-O lesen solution. We show that the ferm ion number anom aly leads, at nite chem ical potential, to an instability towards the formation of a helicoidal structure of the W-pair condensate along the eld direction. In sect 3 we discuss the ferm ionic ground state at H  $p H_{cl}$  and for ferm ion masses and chem ical potential obeying m f eH. For elds close to the lower critical value, the state in a hom ogeneous magnetic eld can then be treated as the unperturbed ground state, and the W-pair condensate as a perturbation. We show that under these conditions the leading e ect of the ferm ions is the destabilization of the W-condensate towards inhom ogeneity in the eld direction. Sect 4 contains discussion of the results and possible applications.

2. Let us consider st the bosonic sector of the standard model. The static energy functional in the unitary gauge is [6]:

Here  $W_i$   $(W_i^1 \quad iW_i^2) = \frac{p}{2}$  is the charged-W eld,  $Z_i = W_i^3 \cos B_i \sin r$ , the electrom agnetic vector potential is  $A_i = W_i^3 \sin r + B_i \cos r$ , and is the Higgs scalar.

In the presence of a static hom ogeneous magnetic eld H > H  $_{cl}$ , pointing in the third direction, the ground state is characterized by nonvanishing W, Z,A, (v)-condensates. For the static solution, found by Ambj m and O lesen [1]

The condensates are how ogeneous along the third axis and periodic in the plane perpendicular to the magnetic eld. The vortex-lattice structure has a unit cell with area  $S_k = 2 \ k = m_W^2$ , where k is the winding number of the phase of the W - eld along the cellboundary. The W - eld has k zeros inside the cell. The energy is minimized for k = 1 and a hexagonal lattice [6].

The properties (2), (3) of the W -condensate are su cient to demonstrate that a nite density of fermions causes it to be unstable towards inhom ogeneity in the eld direction. In the presence of nite ferm ion density the ferm ion number anom aly in the standard model leads to the appearance of a Chern-Sim ons term in the bosonic elective action [7]

where f is the number of doublets, and

To understand the appearance of (4) in the elective action, it is useful to note that the introduction of the chem ical potential is equivalent to coupling an external "ferm ion number gauge eld" F to the ferm ions, such that F = (;0;0;0). Then calculating the term in the elective action, linear in and quadratic in the background, is equivalent to computing the correlator

where  $J^{f}$  is the ferm ion number current,  $J^{a}$ ,  $J^{b}$  are SU (2) and U (1) currents. The totally antisymmetric contribution to this correlator is determined by the anomaly equation:

(F<sup>a</sup>, F<sup>a</sup> and F, F<sup>a</sup> are the SU (2) and U (1) eld strengths and their duals, respectively) and coincides with (4).

From (2), (3) it follows that (5) reduces to:

W e see that the appearance of an inhom ogeneity in the third direction leads to nonzero density of the Chem-Sim ons number of the condensate.  $n_{CS}$  is equal to the number density of the positive energy ferm ion levels which have fallen into the D irac sea. Note that for the original solution (2), (3)  $n_{CS} = 0$ . To nd the form of the condensate which m inim izes the energy we have to consider the total bosonic energy functional, which includes the energy loss due to the inhom ogeneity:

where  $E_0$  is given by (1). We see that an  $x_3$ -dependent isospin rotation of the W -condensate around the third axis

does not a ect  $E_0$  except for the term with two derivatives (recall that for the Ambj m-O lesen solution all components along the third axis vanish). This two-derivative contribution represents the "elasticity" energy loss due to the inhom ogeneity. On the other hand, the  $E_{CS}$  contribution is linear in  $k_3$ , the total energy change being:

C learly, for small enough  $k_3$  the linear term dominates and E is negative and m inimized for a nonzero value of  $k_3$ :

The last two expressions show that the nite density of ferm ions causes an instability of the vortex lattice towards inhom ogeneity in the direction of the magnetic eld and leads to the form ation of a helicoidal structure of the W -condensate.

Being determ ined by the exact anom aly equation the Chem-Sim ons contribution  $E_{C\,S}\,$  is valid for all momenta (well below the UV cut-o ) of the background  $\,$  elds. Therefore the density-induced instability has a quite general character.

For arbitrary ferm ion densities and elds much stronger than the lower critical one, the W -condensate is not small and we are not aware of the nature of the ferm ionic ground state. In particular, then we cannot insist that the most important in uence of the ferm ions on the condensate is the appearance of the inhom ogeneity.

3. Let us therefore consider magnetic eld strengths close to the lower critical value H $_{\rm cl}$  and show that the instability described in the previous section is then the leading e ect of the ferm ions.

Let us decompose  $A = A + A^0$ , where A is the electrom agnetic vector potential, corresponding to the hom ogeneous part of the m agnetic eld background, and introduce the sm all parameter =  $(H + H_{c1}) = H_{c1} = 1$ . For such elds the  $A^0$ ; W; Z; v condensates are sm all [6]:

Their characteristic momenta in the direction perpendicular to the magnetic eld are [6]:

Now let us couple ferm ions to the above background. The radius of the lowest Landau orbit [8] of a ferm ion with charge eq, e > 0, in a constant hom ogeneous magnetic eld is

Note that for H '  $m_{W}^{2} =$  this is of the order of the unit cell size  $p_{\overline{S_{1}}}$ , and that  $k_{1;2}^{W}r_{H}$  1, which m cans that the condensates vary slow ly along the Landau orbit. Therefore we will consider the state in a hom ogeneous m agnetic eld as the unperturbed ground state, i.e. treat the constant part of H exactly and consider  $A^{0}$ ; W; Z; v as sm all perturbations.

For chemical potential, obeying

$$m_f \qquad p_{\overline{eH}}, \qquad (12)$$

all ferm ions will occupy the lowest Landau level. Their number density is then  $n_q = ejqH = (2^2)$ , and the energy density:  $E_q = ejqH^{-2} = (4^{-2})$ . From (12) we see that the Ferm ienergy density can be neglected in comparison with the energy density of the constant magnetic background:  $E_q = H^{-2} = 2$ .

For the elds under consideration the shift of the D irac sea energy can also be neglected [9]: For a ferm ion with m ass m<sub>f</sub> and charge qe in m agnetic eld H m<sup>2</sup><sub>f</sub> = (jqje) it equals:

and becomes comparable to  $E_{\rm H}$  = H  $^2$ =2 only for eld strengths of the order of

Finally, higher derivative terms in the elective bosonic action can be neglected if the momenta of the background in the direction perpendicular to H obey  $k_{1,2}$  p = H, and the ones along H :  $k_3$  [5]. The rst condition is obeyed for elds close to the lower critical one, as follows from (11); the second is seen to hold from (10).

The above considerations show that for sm all coupling and eld strengths

 $H_{c1}$  quantum corrections due to ferm ions lead to renorm alization of the coe cients of the bosonic energy functional only. Therefore, the Chem-Sim ons term generated by the anomaly is the leading contribution to the bosonic elective action, and the ground state is characterized by the heli-coidal structure (8) with wave vector (10).

Let us note that we cannot prove that this is the only instability occuring. All we have shown is that (10) m inim izes the energy within the Ansatz (8).

The  $x_3$ -dependent phase of the W -condensate leads to a current ow along the third axis, which in its turn will a ect the system, but in the small coupling regime these e ects are suppressed by additional powers of e.

The scale of the inhom ogeneity  $k_3^{-1}$  is much larger than the unit cell size, for the densities for which the above analysis is valid. If however (10) is taken at face value, they become comparable only for  $m_W = g^2$ . At these densities however, the system is classically unstable towards transition to the vacuum with di erent ferm ion number. Note that in our case there is no true ferm ion number violation – if the magnetic eld is turned o the levels appear again and the initial number of ferm ions is restored.

4. Turning to possible applications, we note that the conditions necessary for the realization of the ferm ion-induced instability might be present only in the early Universe. The values of the critical elds H <sub>c1</sub>, H <sub>c2</sub> go to zero as T ! T<sub>c</sub>, where T<sub>c</sub> 100G eV is the critical temperature of the electrow eak phase transition. Therefore, slightly below T<sub>c</sub>, elds much smaller than  $10^{24}$  G auss could drive the system in the intermediate phase [2]. Such elds might be present before the phase transition, being generated by quantum uctuations during in ation [10]. They could also be created during the electrow eak transition itself, realizing thus a "vacuum dynamo" e ect [2], [11].

The result for the ferm ion generated  $E_{CS}$  holds at nite temperature as well, to leading order in the high temperature expansion ;m<sub>f</sub> T [7]. If there were some "seed" magnetic eld [10] prior to the electroweak transition, then below  $T_c$  the mixed phase might be energetically favourable for

some period of time. As we saw above it has two distinct scales of inhom ogeneity –  $(m_W)^{-1}$  in the direction perpendicular to the magnetic eld, and  $4eH = (g^2n_f) - 4m_W^2 = (g^2n_f) - (m_W)^{-1}$  in the longitudinal direction. This strong anisotropy would a ect the gravitational wave background [12], but it is not clear whether its am plitude is strong enough to lead to any observable e ect.

To conclude, we have shown that a nite ferm ion density destabilizes the W -pair condensate in strong magnetic eld and breaks the translational invariance in the direction of the eld, leading to the appearance of a helicoidal structure.
