# A pplication of M ossbauer-T ype Sum $R$ ules for B M eson D ecays

## ABSTRACT

Sum rules originally derived for the $M$ ossbauer E ect are applied to weak sem ileptonic B decays. The sum nules follow from assum ing that the decay by electrow eak boson em ission of an unstable nucleus or heavy quark in a bound system is described by a pointlike coupling to a current which acts only on the decaying ob ject, that the H am iltonian of the bound state depends on the m om entum of the decaying ob ject only in the kinetic energy and that the boson has no nal state interactions. The decay rate and the rst and second $m$ om ents of the boson energy spectrum for xed $m$ om entum transfer are show $n$ to be the sam $e$ as for a noninteracting gas of such unstable $o b$ jects $w$ ith a $m$ om entum distribution the sam e as that of the bound state. B m eson sem ileptonic decays are show $n$ to be dom inated by the low est-lying states in the charm ed $m$ eson spectrum.

Sim ple features of the spectroscopy and weak transitions ofhadron states containing heavy quarks have recently been discussed in detail [1,2]. The contributions to a B jorken sum rule [3] have been exam ined [4,5]. T he B jorken sum nule recalls sim ilar sum rules derived for the $M$ ossbauer e ect $[6-8]$ which can also be viewed as the em ission of an electroweak boson in a pointlike vertex by a heavy ob ject bound to a com plicated system, where the transition involves a change in the $m$ om entum and the $m$ ass of the heavy object without a change in the interactions betw een the heavy ob ject and the rest of the system. W e derive sum nules for the m om ents of the energy spectrum of the em itted boson for decays of bound heavy quarks, analogous to those previously derived for the M ossbauer e ect [9]. In addition to the B jorken sum rule for the decay rate we nd two additional sum rules show ing that the $m$ ean and $m$ ean square energies of the em itted boson or lepton pair are independent of the detailed dynam ics of the bound state, depend only on the $m$ om entum spectnum of the heavy quark in the in itial state and are thus identical to those for the decay of a free heavy quark in a gas w ith the sam e m om entum spectrum as in the bound state.

The weak decay from an initialstate denoted by ito a nalstate denoted by $f$ is described by the Ferm i golden rule of tim e dependent perturbation theory

where $H_{\text {weak }}$ denotes the weak $H$ am iltonian and $\left(\mathbb{E}_{f}\right)$ is the density of nal states. For the case of a sem ileptonic decay where a lepton pair is em itted with $m$ om entum $q$, the $m$ atrix elem ent for a transition from an initial hadron state at rest $\ddot{H}_{b} i$ containing $a b$ quark to $a$ nal state $\mathrm{f}_{\mathrm{c}}(\mathrm{q}) \mathrm{L}(\mathrm{q})$ i of a hadron $\mathrm{f}_{\mathrm{c}} \mathrm{w}$ ith total m om entum $q$ containing a c quark and a lepton pair w th m om entum $q$ factorizes into a leptonic factor depending only on the lepton variables and a weak vertex describing the heavy quark transition,

where $g_{k}(q)$ is a function of the lepton variables and $J_{k}(\mathrm{q})$ is the fourier com ponent of the avor-changing weak current form om entum transfer $q$ and the index $k=0,1$ describes the spin character of the heavy quark transition; i.e. $J_{1}$ transform $s$ like a vector under spin rotations and describes spin - ip transitionsw hile $J_{\circ}$ is sim ply the identity operator and describes non ip transitions.

The result (1) is exact to rst order in the electrow eak interaction described by the standard $m$ odeland exact to allorders in strong interactions ifthe initialand nalstates considered $\ddot{H}_{b} i$ and $\mathbb{f}_{c} i$ are exact eigenstates of the strong interaction ham iltonian. W e do not need to assum e the validity of $C$ CD , perturbative or otherw ise, or even the validity of local eld theory at this stage. All we need is the existence of a ham iltonian for strong interactions and its eigenstates.

In heavy quark transitions this description applies to sem ileptonic decays and also to nonleptonic decays in cases where factorization holds; i.e. there are no nal state interactions between the hadrons produced by the $W$ and the nalbound state.

W e now derive the sum rules explicitly for the case of a heavy quark transition (1). The
 the heavy quark and determ ine com pletely the dependence of the transition on the hadronic wave functions.

It is convenient to norm alize the current and the coe cient $\mathrm{g}_{\mathrm{k}}$ (q)

where the factor $g_{k}(q)$ depends upon the strength of the interaction and depends upon the kinem atic variables only via the $m$ agnitude of the $m$ om entum transfer $q$ and not upon the initialm om entum of the heavy quark and $k$ is a spin factor acting on the spin of the heavy quark and norm alized to satisfy the relation

The transition probability or branching ratio is proportional to the square of this $m$ atrix elem ent and multiplied by kinem atic; e.g. phase space factors which do not depend on the explicit form of the hadron wave functions but only on hadron $m$ asses and the $m$ om enta of the extemal particles. T his $m$ atrix elem ent is seen to satisfy the sum rule

The Ham iltonian of the bound state of a heavy quark of avor $f$ and light quark \brown $m u d k$ " can be written as a fiunction of the co-ordinate $X$, the $m$ om entum $P$ and the $m$ ass $m_{f}$
of the heavy quark, and all the degrees of freedom in the brow n m uck denoted by

where $\mathcal{B}_{\mathrm{k}}$ i denotes the state produced by the operator k acting on the initial state $\dot{i}_{b}$.

W e have thus obtained sum nules form om ents of the nal state energy distribution at a xed m om entum transfer $q$ in term $s$ of expectation values caloulated in the initial state $\ddot{H}_{3} i$.

The case $n=0$ is just the $B$ jorken sum nule, show ing that the sum of the squares of all transition $m$ atrix elem ents at xed $m$ om entum transfer $q$ is com pletely independent of the ham iltonian $H$ describing the dynam ics of the bound state and is the sam e as for a free b quark decaying to charm .

T he sum rules reduce to a particularly sim ple form for the rst and second $m$ om ents, $n=1$ and $n=2$, if one sim ple additional assum ption is $m$ ade which holds in all conventionalm odels; nam ely that the state $\mathrm{B}_{\mathrm{k}}$, produced by the operator k acting on the initial state $i_{0}$ is an eigenfuntion of the bound state H am iltonian $\mathrm{H}_{\mathrm{b}}$

This assum ption holds trivially for the case $k=0$ where the spin operator $\circ$ is just the identily. It is a good approxim ation for the case $k=1$ if spin e ects are neglected as well as in all models where ipping the spin of the heavy $b$ quark in the $B m$ eson produces the vector B state. T hese include both sim ple constituent quark m odels as w ell as m ore general models which assum e the approxim ation of heavy quark sym $m$ etry. It also holds in all sim ple $m$ odels for the b baryon where the b quark carries the spin of the baryon, all other degrees of freedom are coupled to zero angularm om entum and ipping the spin of the b quark sim ply ips the spin of the whole baryon.

For the nst and second $m$ om ents, $n=1$ and $n=2$, the operator $H_{b}$ appears in eq. (6b) only as acting either to the right on $\mathcal{B}_{\mathrm{k}}$ i or to the left on $\mathrm{hB} \mathrm{B}_{\mathrm{k}} j$ to give the m ass eigenvalue $\mathrm{M}\left(\mathrm{B}_{\mathrm{k}}\right)$. T hus for $\mathrm{n}=1$ and 2 ,

where the approxim ate equalties hold for the case where the nonrelativistic approxim ation is used for the heavy quark kinetic energy, which is assum ed to contain all the dependence of $H$ on $P$ and the heavy quark $m$ ass. The quantity $R(q)$ is just the free recoil energy; i.e. the change in kinetic energy of a free charm ed quark when its $m$ om entum changes from $P$ to $\mathrm{P}+\mathrm{q} . \mathrm{T}$ he quantity $\mathrm{I}_{\mathrm{bc}}$ is just the \isom er" or \isotope" shift; i.e. the change in the binding energy of the bound state $w$ hen the $m$ ass of the heavy quark changes from $m_{b}$ to $\mathrm{m}_{\mathrm{c}}$.

The two sum rules are expressed in term s of expectation values of operators depending only on the change in the $H$ am iltonian when the heavy quark $m$ om entum $P$ is replaced by $\mathrm{P}+\mathrm{q}$ and the heavy quark m ass is changed from $\mathrm{m}_{\mathrm{b}}$ to $\mathrm{m}_{\mathrm{c}}$. They thus depend only on the m om entum distribution of the heavy quark in the intitial state and are independent of the brown muck in all models where $P$ enters only into the kinetic energy term in the bound state H am iltonian and the change in hyper ne energy with quark m ass is neglected. T hey are therefore the sam e as for the decay of free b quarks in a gas w th the sam e $m$ om entum distribution as in the bound state.

The sum rules can be written in various ways appropriate for di erent applications. These depend upon which experim ental quantities are $m$ easured and upon assum ptions about values of param eters which are not directly measured like quark $m$ asses and hyper ne energy contributions.
$T$ he sum rules can be expressed in term sof the energy $\mathrm{E}_{\mathrm{W}}$ ( q ) carried $\circ$ by the W and observed as the energy of the lepton pair or hadrons produced from the W which m ust have m om entum of for m om entum conservation. From energy conservation

The $m$ ean energy carried by the $W$ is seen to di er from the heavy quark $m$ ass di erence $m$ by three corrections: the free recoil kinetic energy, the \isom er shift" and a spin correction
$M$ ( $H_{b}$ ) M ( $B_{k}$ ) which is present in the case ofspin- ip transitions and is equal to the hyper ne splitting. If we $m$ ake the nonrelativistic approxim ation for the heavy quark $m$ otion, and neglect the dependence of the hyper ne energy on the heavy quark $m$ ass the two sum rules reduce to sim ple expressions for the $m$ ean energy and the dispersion of the energy distribution of the em itted $W$ at xed $m$ om entum $q w h e n$ appropriate kinem atic factors (i.e. phase space) are taken out of the observed distributions.

W hen the $m$ om entum transfer $q$ and the $m$ ean $m$ om entum $P$ of the heavy quark in the bound state are both $s m$ all in com parison w th the heavy quark $m$ ass, the dispersion vanishes and the $m$ ean lepton energy is just the quark $m$ ass di erence $m_{b} \quad m_{c}$. The transition is alw ays to the ground state of the charm ed system and the di erenœes in the brow n muck wave functions in the two cases is negligible. W hen the m om entum transfer q is negligibly sm all, the correction resulting from the nite $m$ om entum of the heavy quark in the bound state is just the di erence in the heavy quark kinetic energies in the initial and nal ground states. $T$ his is just equal to the di erence in binding energies to rst order in the $m$ ass di erence.

W e now derive a sum rule for the $m$ ean excitation energy of the charm ed nal state above the ground state of the charm ed system. The the exact ground state energy is not known since it depends upon the binding energy of the brown muck to the heavy quark. W e express this ignorance by writing

where $M\left(D_{k}\right)$ is the $m$ ass of the charm ed analogue of the state $B_{k}$. The LHS of eq. (12) is just the $m$ ass $M\left(D_{k}\right)$ in the heavy quark symmetry lim it and is exact to rst order in the di erence $\left(\frac{1}{m_{c}} \frac{1}{m_{\mathrm{b}}}\right)$. The correction is therefore second order and can also be seen to be positive, since the perturbation result is also variational and gives an upper bound for the mass,

The $m$ ean excitation energy $E c$ of the observed spectrum above the ground state is obtained by com bining eqs. (6c), (9c) and (12) to obtain

In nearly allm odels generally considered all the dependence of $H$ on the heavy quark $m$ om entum $P$ is in the kinetic energy; i.e. all dependence of the forces between the heavy quark and the brown muck upon the velocity of the heavy quark is neglected. In that case $R(q)$ is just the free recoil energy; the kinetic energy gained by a free quark with $m$ om entum P as a result of absorbing a m om entum transfer q . Thus the m ean excitation energy including corrections to the binding energies which are rst order in the di erence of $1 / \mathrm{m}$ is just the free recoil energy $R(\mathbb{q})$.

In contrast to the $M$ ossbauer ect, where the whole system has a very high $m$ ass and the recoil kinetic energy of the whole system is negligible, the contribution of the recoil kinetic energy of the nal charm ed state to the $m$ ean excitation energy (13) is appreciable. W e therefore express the sum rule (13) in term $s$ of the invariant $m$ ass $M_{f}$ of the nal state $\mathcal{F}_{c} i$ and the excitation energy of the rst p-wave resonance in the charm ed system denoted by E 1 k .

The sum rule (14) can be sim pli ed by introducing param eters

The excitation spectrum of the nal charm ed states is seen to have a mean excitation energy above the ground state $\mathrm{D}_{\mathrm{k}}$ whose scale is set by the param eter. . This param eter is just the di erence between the charm ed hadron $m$ ass and the energy of the charm ed quark and is roughly equal to a light constituent quark $m$ ass and bounded by eq. (15b). For low values of $q^{2}$ the $m$ ean excitation energy is even low er by the ratio $q^{2}=2 M\left(D_{k}\right)^{2}$.

From these inequalties (19) we obtain upper bounds for the probability of B decays into excited cham ed states.

This result eqs. (20) is an upper bound for the total probability of decays into states other than the ground state, when the phase space factors are assum ed to be equal for all nalstates. Including phase space factors will give an even stronger upper bound. The maxim um value of $q^{2}$ which leaves the energy available just at the threshold for producing the low est $p-w$ ave charm ed state[10], $D(2420)$ is $q^{2} \quad 1: 25 \mathrm{M}\left(D_{k}\right)^{2}$, which gives $=1: 5$. This occurs when the lepton $m$ om enta are exactly parallel and they carry the $m$ inim um possible energy for a given
value of $q^{2}$. This gives an upper bound on the probability of producing an excited charm ed m eson state of less than 56\% for the quoted values[10], M (D) $=1: 87 \mathrm{GeV}, \mathrm{m}_{\mathrm{c}}=1: 35 \mathrm{GeV}$, $\mathrm{E}_{1 \mathrm{k}}=0: 55 \mathrm{G} \mathrm{eV}$. A n even sm aller upper bound is obtainable if som e estim ate of the kinetic energy of the heavy quark can be used in eq. (15b). An upper bound for the probability of producing a given state $\dot{f}_{c} i w$ th higher $m$ ass is given by eq. (21) for the extrem e case where no low er excited states are produced. The probability of producing the ground state is thus
$50 \%$ even under these extrem e conditions and increases rapidly w ith m ore realistic low er values of $q^{2}$. T hus the excitation spectrum $w$ illbe dom inated by the ground state $D_{k}$ and the rst low-lying D 's.
