b! s and Z ! bb in Technicolor with Scalars

Abstract

We consider the radiative decay b! s , and the correction to the Z bb vertex in technicolor models with scalars. In these models, the scalar develops a vacuum expectation value when the techniferm ions condense, and the ordinary ferm ions develop masses via Yukawa couplings. Since the sym metry breaking sector involves both a fundamental scalar doublet and an isotriplet of composite scalars (the technipions), the phenomenology associated with the charged scalars is similar to that found in a type-I two-H iggs doublet model. We show that the correction to the Z bb vertex is small over the allowed parameter space of the model in the two limits that we consider, and that there can be large, potentially observable, contributions to the b! s branching fraction.

1 Introduction

The phenom enology of technicolor models with scalars has been considered extensively in the recent literature [1, 2, 3, 4, 5]. In this class of models, the techniferm ions and the ordinary ferm ions both couple to a weak scalar doublet, which replaces the conventional ETC sector. When technicolor becom es strong, and a techniferm ion condensate form s, the Yukawa coupling of the condensate to the scalar produces a linear term in the scalar potential. As a result, the scalar develops a vacuum expectation value (vev), which is responsible for giving the ordinary ferm ions mass. It has been shown that m odels of this type do not produce unacceptably large contributions to K $^{0} \overline{K^0}$ or $B^0 - \overline{B^0}$ m ixing, nor to the electroweak S and T parameters [1, 3, 4]. In addition, the new scalars in the model can be made heavy enough to evade detection, even in the lim it where the scalar doublet is assumed to have a vanishing SU (2) U (1) invariant mass [3]. Technicolor with scalars is interesting on more general grounds because it can arise as a low-energy e ective theory in strongly-coupled ETC (SETC) models [6], providing that som e degree of ne-tuning is allowed. This ne-tuning is necessary in any workable SETC model to maintain a su cient hierarchy between the ETC and technicolor scales [7].

It is the purpose of this letter to consider two other in portant phenom enological issues that have not been studied in the context of technicolor models with scalars: the correction to the Zb coupling, and the branching fraction B (b! s). In conventional ETC models, it has been shown that there is a reduction in the Z $b\bar{b}$ coupling proportional to m_t , which can decrease $(Z ! b\bar{b}) = (Z ! hadrons)$ by as much as 5% [8]. In two-H iggs dou-Rh blet models, and in the minimal supersymmetric standard model, the Z bb coupling can shift as a consequence of radiative corrections involving charged scalars that couple b to t through the large top-quark Y ukaw a coupling. Technicolor with scalars is similar to a type-I two-Higgs doublet model, in which only one scalar doublet (in our case, the fundam ental scalar) couples to both the charge 2/3 and charge -1/3 quarks. Unlike the situation in conventional ETC models, the main correction to the Z b coupling in technicolor models with scalars comes from the radiative e ects of the physical charged scalars in the low-energy theory. It is therefore possible to adapt much of the existing analysis of the Z bo coupling in two-H iggs doublet m odels to study the parameter space in the m odels of interest to us here.

The other process that we consider, b ! s , vanishes at tree-level in the Standard M odel due to the G IM m echanism, but can occur at one-loop through penguin diagram s. Since the Standard M odel branching fraction depends on sm allG IM -violating e ects, it has been suggested that this decay m ode m ay provide a sensitive probe of physics beyond the Standard M odel [9]. The recent m easurem ent by the CLEO collaboration of the inclusive b ! s decay width has yielded the bound $M_{\rm H^+} > 260 \, {\rm GeV}$ for the charged scalar m ass in type-II two-H iggs doublet m odels [10]. This gives us substantial m otivation to study whether b ! s can receive in portant contributions in technicolor m odels with scalars. A gain, existing calculations of the inclusive decay width in type-I two-H iggs doublet m odels can be m odi ed to enable us to determ ine the b ! s width throughout our m odel's param eter space.

2 The M odel

The model that we consider has been described in detail elsewhere [1, 3], so we summarize only the essential components. In addition to the Standard M odel gauge structure and particle content, we assume a minimal SU (N) technicolor sector, with two techni avors that transform as a left-handed doublet and two right-handed singlets under SU $(2)_W$,

and that have the weak hypercharge assignments Y ($_{\rm L}$) = 0, Y ($p_{\rm R}$) = 1=2, and Y ($m_{\rm R}$) = 1=2. The ordinary fermions are technicolor singlets, with their usual quantum number assignments. The technifermions and ordinary fermions couple to a weak scalar doublet which has the quantum numbers of the Higgs doublet of the Standard M odel

The purpose of the scalar is to couple the techniferm ion condensate to the ordinary ferm ions and thereby generate ferm ion masses.

W hat is relevant to the phenom enology that we consider here is that the technipions (the isotriplet scalar bound states of p and m) and the isotriplet components of will mix. One linear combination becomes the longitudinal component of the W and Z. The orthogonal linear combination remains in the low-energy theory as an isotriplet of physical scalars. Denoting the physical scalars $_{\rm p}$, the coupling of the charged physical scalars to the quarks is given by [3]

where V is the Cabibbo-Kobayashi-Maskawa (CKM) matrix, f is the technipion decay constant, and v is the electroweak scale 250 GeV. Here U and D are column vectors in avor space, and the Yukawa coupling matrices are diagonal $h_U = \text{diag}(h_u;h_c;h_t), h_D = \text{diag}(h_d;h_s;h_b)$. Notice that (2.3) has the same form as the charged scalar coupling in a type-I two-Higgs doublet model.

The fact that the quarks couple only to the fundam ental scalar, but not to the technipions, also accounts for the dependence of (2.3) on f=v. The technicolor scale and the scalar vev, which we will call f^0 , both contribute to the electroweak scale

In the lim it that f ! 0, the fundam ental scalar vev determ ines the electroweak scale, and the longitudinal components of the weak gauge bosons are mostly the fundam ental scalar. Thus, the physical charged scalars are now mostly technipion in this lim it, and we expect their couplings to the quarks to vanish. The couplings in (2.3) have the correct behavior in this lim it.

The chiral Lagrangian analysis in Refs. [3, 4] allows us to estimate the mass of the charged scalars. At lowest order, the mass of the physical isotriplet is given by

where h is the average techniferm ion Yukawa coupling h $(h_{+} + h_{-})=2$, and where h_{+} and h are the individual Yukawa couplings to p and m, respectively. The constant c_1 is an undeterm ined coe cient in the chiral expansion, but is of order unity by naive dimensional analysis (NDA) [11]. We set $c_1 = 1$ in all numerical estimates to follow. Since we are only working to lowest order, c_1 and h always appear in the combination c_1h ; thus the uncertainty in our estimate of c_1 can be expressed alternatively as an uncertainty in the value of h.

The only remaining ingredient that we need for the numerical analysis is the dependence of f and f⁰ on the free parameters of the model. In general, f and f⁰ can depend on h₊, h, M, and , where M is the SU (2) U (1) invariant scalar doublet mass, and is the ⁴ coupling. Two limits have been studied previously in the literature: (i) the limit in which is small and can be neglected [1], and (ii) the limit in which M is small and can be neglected [3]. O ne advantage of working in these two limits is that the phenom enology of the model can be described simply in term sofa two-dimensional parameter space, either (M, h) or (, h). (This is possible because h₊ and h enter on ly through the combination h = (h₊ + h)=2 at lowest order in the dhiral expansion.) In general, the condition that the Higgs eld (the isoscalar component of) has no vacuum expectation value

gives us the constraint

where the last term is induced by the technicolor interactions [3, 4]. In either lim it (i) or (ii) described above, f and f^0 can be found by solving (2.4) and (2.7) simultaneously in terms of the two remaining free parameters.

If we also include the largest Colem an-W einberg corrections to the potential

(setting $h_{+} = h$ for simplicity) and de ne the renormalized ⁴ coupling $_{r} = V^{000}(f^{0})=3$ in order to remove the -dependence in (2.8), then the form of (2.7) will remain unchanged providing that we work with the shifted parameters

in limit (ii). It is convenient for us to adopt these new parameters because they absorb the elects of the radiative corrections, as far as they all ect the phenomenology of the charged scalars. However, the isoscalar mass movill have a dill erent functional dependence on the new parameters. In limit (i)

In this paper we will again study limits (i) and (ii), in the interest of com - pleting the phenom enological discussion presented in Refs. [3, 4].

3 Results

G iven the couplings in (2.3), and estimating the charged scalar mass, from equations (2.4), (2.5) and (2.7), we can apply previously published two-H iggs doublet model results to study our model in limits (i) and (ii). The one-loop e ects of charged scalars on the Z \overline{bb} coupling are discussed in R efs. [12, 13]. We adapt the results given in the appendix of B oulware and F innel [12]. We compute the quantity $R_b=R_b$, where R_b is dened by

The contours of constant $R_b=R_b$ are plotted in Figures 1 and 2, for them odel in limits (i) and (ii) respectively. In both cases, we show the parameter space already excluded by $B^0-\overline{B^0}$ mixing (the area below the B-line), and by the constraint $m + > m_t - m_b$ (the area to the left and below the $m = m_t - m_b$ line). We assume a Standard M odel top quark, with $m_t = 175 \text{ GeV}$ and with no decay to +b, consistent with the recent CDF results [14]. The $hf^0 = 4 - f$ line shown in Figure 1 indicates where the chiral Lagrangian analysis breaks down; above this line, the techniferm ion current m asses are no longer sm all com pared to the chiral symmetry breaking scale, and we can make no claim s about the phenom enology. Note, how ever, that this problem atic region is avoided in limit (ii), because this area is already excluded by the constraint of vacuum stability, m² > 0 [3]. The di ering form of (2.11) and (2.12) explains why we obtain a strong constraint from the the LEP lower bound [15] on the mass of the light neutral isosinglet scalar in lim it (ii), but not in lim it (i). In lim it (i), one must go to negative values of M beforem becomes in con ict with the LEP lim it m > 58:4 G eV; however, the isotriplet scalars become unacceptably light long before then. In both lim its we see that the -1% contour for $R_b=R_b$ is almost contiguous with the B-line, and that $R_b=R_b$ becomes smaller as one moves away from the excluded region in the lower right-hand portion of the plots. Thus, we see that a more dramatic e ect corresponding to a larger top quark Yukawa coupling is already precluded by the B⁰-B⁰ m ixing constraints.

The partial width for b ! s in two-Higgs doublet models has been computed in Refs. [16, 17]. We adopt the results of Grinstein, Springer, and W ise (GSW) [16] in our analysis. In Figures 3 and 4 we plot contours of constant = , the percent shift in the b ! s partial width relative to the theoretical prediction in the Standard M odel (The Standard M odel prediction corresponds to a branching fraction of 2:75 10^{4} [10]). In term s of the function C₇ de ned in GSW, we plot contours of constant

where 2H D here refers to a type-I two-H iggs doublet model. Notice that the contours are roughly parallel to the B-line, and may eventually provide a tighter constraint. The 95% condence level lower bound found by CLEO corresponds to the -64% contour on the plot, but this statem ent does not take into account the theoretical uncertainty in (3.14). If we assume that $C_7 (m_b)$ can be calculated to within 15%, as is suggested in [16], and we assume, conservatively, that (3.14) is known within 30%, then the region absolutely excluded in our model lies below the -83% contour. This boundary is almost contiguous with the B-line, and does not eliminate any additional parameter space. W hat is interesting is that there is plenty of parameter space in which the correction to b! s is signi cant, (between -1% and -50%) yet not in conict with the lower bound on (b! s) found by CLEO. In addition, the region of the parameter space in which the correction to b! s is less than -1% includes the region discussed in Ref. [5] which should include a light, extrem ely narrow technirho.

4 Conclusions

W e have extended the phenom enological analysis of R efs. [1, 3, 4, 5] to include corrections to b! s and to the $Z b \overline{b}$ vertex in technicolorm odels with scalars. We have shown that the correction to R_b is negative throughout the allowed region of our model's parameter space in the limits that we considered, but never larger than -1%. This result is consistent with our expectation that corrections to the Z bo coupling are suppressed in SETC models by an increased ETC scale [18]. Since the current experimental measurement is larger than the Standard M odel prediction by two standard deviations [19], it may still be possible to rule out this model if the Standard M odel is ruled out on similar grounds. In addition, we have found sizable corrections to the b! s width, yielding a branching fraction that is smaller than the Standard M odelexpectation. Nevertheless, in both cases our results indicate that stongly-coupled ETC m odels, of which ourm odel is the low -energy lim it, easily survive the current experim ental constraints. Unlike the electroweak S and T parameters, the b! s branching fraction can be calculated more reliably in these models, giving us relatively de nitive predictions. Since the deviation from the Standard M odelbranching fraction can be sizable in some regions of our model's parameter space, this e ect may be observable given improved measurements of the b! s inclusive decay width.
