## Non-Universal Correction To z ! bb And Flavor Changing Neutral Current Couplings

## ABSTRACT

A non-universal interaction, which involes only the heavy quarks  $(t_{\rm L}\,;\,b_{\rm L}\,)$  and  $t_{\rm R}$ , modi es the neutral current couplings and induces avor changing neutral currents (FCNC). The size of the FCNC e ect depends crucially on the dynam ics of the ferm ion mass generation. In this paper, we study the e ect of the non-universal interaction on Z bb, Z bs, Z ds and Z db, by using an e ective lagrangian technique and assuming the quark mass matrices in the form of a generalized Fritzsch ansatz. We point out that if thing R b = (Z ! bb) = (Z ! Hadrons) to the LEP data within 1 , the induced FCNC couplings are very close to the allowed bounds of several rare decays.

Recently the CDF collaboration[1] at FNAL presented evidence for a top quark with a mass m<sub>t</sub> 175 GeV. Since m<sub>t</sub> is of the order of Ferm i scale, the top quark couplies strongly to the electroweak sym metry breaking sector and will play a key role in probing new physics beyond the standard model. This kind of new physics (i.e. non-universal interaction since it acts on only the top quark) can become manifest in top quark production processes at the hadron and next generation linear colliders. It can also a ect the partial width of Z! bbm easured at LEP because the SU (2)<sub>L</sub> group places (t<sub>L</sub>; b<sub>L</sub>) into a common doublet. The experimental observed value for the ratio  $R_b = (Z! b\bar{b}) = (Z! Hadrons)$  is slightly higher than the standard model expectation. This may be an indication of the non-universal interaction, if it is more than a statistical uctuation.

It is known that a non-universal interaction will induce avor changing neutral currents (FCNC) among the light fermions[2-5]. However, the size of the FCNC e ect depends crucially on the quark mass mixing matrices. So one can not predict quantatively the induced FCNC e ect without specifying the mass matrices. At present it seems far too early to attempt an actual solution to the issue of mass generation. However, there has been a great amount of activities in looking for the relation between fermion masses and their mixing matrix elements, as commonly referred to as texture studies. One expects that a \successful ansatz can provide clues to the dynamics of the fermion mass generation.

In recent years, most studies on the implication of ferm ion mass ansatz were focused on grand unication theories with and without supersymmetry. In this paper we take a phenomenological, model independent approach to new physics beyond the standard model, i.e., the elective lagrangian technique, and consider the implication of the ferm ion mass ansatz on the induced FCNC elect. Specifically, we will use one variation of the Fritzsch [6] ansatz to study the correlated

e ects of new physics on  $Zb\bar{b}$  and  $Zb\bar{s}$ , etc. We will point out that when thing  $R_b$  to the LEP data within 1, the induced FCNC couplings are very close to the allowed bounds of several rare decays. Our results show that the new physics associated with top quark may be revealed by the presence of FCNC processes.

We rst discuss Z !  $b\bar{b}$ . Following the general approach, we assume that anomalous, non-universal interaction is SU (2)<sub>L</sub> U (1)<sub>Y</sub> invariant. Hence the b quark will participate in any t quark interactions when the left-handed doublet is involved. This can result in a modi cation of the Z  $b\bar{b}$  vertex. We can parametrize the modi cation by introducing a parameter  $_{j}$ , which shifts the standard model tree level coupling,  $g_{j}$ , to elective coupling  $g_{j}^{eff}$ ;

$$g_{j}^{eff} = g_{j} (1 + j)$$

where j = L(R) denotes the left-(right) hand, and  $g_j$  are the standard model coupling strengths of the neutral current,

$$g_L = \frac{1}{2} + \frac{1}{3} \sin^2 w$$
;  $g_R = \frac{1}{3} \sin^2 w$ : (1.16)

The contributions of the new physics to the Z !  $b\bar{b}$  width are proportional to  $g_L^2$  and  $g_R^2$ . Since  $g_L^2$  >>  $g_R^2$ , we will neglect the modi cation to the right-handed interaction in this article. De ning — to be the purely non-universal correction of the new physics beyond the standard model to the Z !  $b\bar{b}$  width,  $b\bar{b}$ , we have

$$\frac{1}{100} \cdot 2 \frac{g_L^2 L}{g_L^2 + g_R^2} \cdot 2 L : \qquad (2)$$

Then the R<sub>b</sub> becomes

$$R_b R_b^{SM} 1 + \frac{1}{bb} R_b^{SM} (1 + 2_L);$$

where the standard model value  $R_b^{SM}=0.2157$  for  $m_t=175G\,eV$  and  $m_H=300\,G\,eV$ . The experimental value of  $R_b$  measured at LEP is  $R_b=0.2192-0.0018\,[7]$ , which is roughly within 2 of the standard model expectation. A positive L would improve the situation.

In general, L can be viewed as functions of  $q^2$  [8], where q is the 4-m om entum of the Z-boson, and at LEP,  $q^2 = m_Z^2$ . Expanding L in terms of  $q^2$ , we have

Gauge invariant operators describing  $_{\rm L}$  have been constructed explicitly in elective lagrangian with a non-linear[2] realization of SU (2) $_{\rm L}$  U (1) $_{\rm Y}$ . In this paper we use an elective lagrangian with a linear realization [9] of SU (2) $_{\rm L}$  U (1) $_{\rm Y}$  for the discussion. The new physics elects are parametrized by a set of higher dimension operators 0  $^{\rm i}$ , which are required to be invariant under the standard model gauge symmetry and contain only the standard model elds. The new physics elects on the light fermions are assumed to be negligible, so the higher dimension operators involve only ( $t_{\rm L}$ ;  $b_{\rm L}$ );  $t_{\rm R}$ , the gauge and scalar bosons. For dimension 6, there are two operators which generate directly [F.1] a  $^{\rm 0}_{\rm L}$  in eq.(4)[10],

where is the doublet Higgs eld of the standard model and  $^{\rm T}_{\rm L}$  = (t;b)<sub>L</sub>. Let us introduce the elective lagrangian, L eff, containing higher dimension operators given in eqs.(5):

where  $c_i$ ; i = 1;2, are real param eters, which determ ine the strength of the contributions of the operators,  $L^{SM}$  is the standard model lagrangian, is the cuto of the elective theory.

A fler the electroweak symmetry breaking, the anomalous couplings for  $Z \ b\bar{b}$  and  $Z \ b\bar{s}$ , etc., from  $L^{eff}$  are contained in

and v  $^\prime$  250 G eV , U  $_{\rm L}^{\rm (d)}$  is unitary rotation m atrix on the left-handed down quarks. The Cabibbo-Kabayashi-Maskawa (CKM) mixing matrix for the charged weak current is

$$V = (U_{L}^{(u)})^{Y}U_{L}^{(d)} ; \qquad (9)$$

where  $U_L^{(u)}$  is the unitary rotation m atrix for the left-handed up quarks. Note that in the standard model, which corresponds to  $L^{\rm eff}$  in the limit! 1, the individual  $U_{L;R}^{(u)}$  and  $U_{L;R}^{(d)}$  are not measureable, but only V in eq.(9) is. Furthermore, the universality of the weak interaction in the standard model also guarantees the vanishes of the FCNC at tree level.

The relative size of the Z  $b\bar{b}$  to the FCNC couplings, Z  $b\bar{s}$ , etc., in eq.(7) depends on the rotation matrix  $U_L^{(d)}$ . The elements of  $U_L^{(d)}$  can be evaluated once

the corresponding mass matrix is given. In the literature a widely used ansatz is the one suggested by Fritzsch [6] and its variations. The latter is given by

where  $x_q$ ;  $y_q$ ;  $!_q$  and  $z_q$  are realparam eters and q=u (d) denotes the up (down) type quarks. The original Fritzsch ansatz is given by putting  $!_q=0$ , which predicts a too small top quark mass m<sub>t</sub> 90 GeV [11]. Here we consider one variation [12] which can have an acceptable top quark mass m<sub>t</sub> 190 GeV, and ts the current experimental data on the CKM matrix. In the variation [12], the rotation matrix, U  $^{(q)}$  (=  $U_L^{(q)} = U_R^{(q)}$ ) is given by

where  $m_1$ ;  $m_2$ ; and  $m_3$  correspond to  $m_u$ ;  $m_c$  and  $m_t$  for q = u, and  $m_d$ ;  $m_s$  and  $m_b$  for q = d, and  $w_u = m_c$ ;  $w_d = 0$ , q and q are responsible for the CP violation phase in the CKM matrix.

In table I, we give the theoretical values of FCNC couplings and the corresponding experimental upper limits. One can see that if thing  $R_b$  to LEP data within 1, the induced FCNC couplings are close to the allowed bounds of several rare decays F 2]. For example, assuming a positive L and thing  $R_b$  to the ex-

In our calculations we have not considered the  $q^2$  dependent terms in eq.(4), which are generally proportional to  $m^2 = 2$  where m is a typical m assof a process under consideration. The operators in eqs.(5) give rise to terms proportional to  $v^2 = 2$ . Therefore the m omentum dependent terms are generally suppressed at low energies. We should point out that if a dierent ansatz from that in (11) is taken, the relative size of anomalous Z boto Z

m atrix elements caused by the uncertainties in the values of ferm ion masses, CKM mixing angles and the analytical approximation used in ref.[12].

Table I: Theoretical prediction on FCNC couplings, and corresponding experimental upper limits taken from Ref.[13].  $\sim_L = U_L^{y(d)}$  diag [0;0;  $_L$ ]  $U_L^{(d)}$ . The elements of  $U_L^{(d)}$  are calculated by taking the central values of the down quark m asses evaluated at  $= 1\,\mathrm{GeV}$ ,  $m_s = m_b = 0.033$ ;  $m_d = m_s = 0.051$ . For Z!  $b\bar{b}$ ;  $\sim_L^{bb} = _L$ , and using de nition of  $_L$  in eq.(1.a) we have  $_L = g_L$   $_L$ ; so  $\frac{R_b}{R_b^{SM}} = \frac{2}{g_L}$ .
