Thermal Two Point Function of a Heavy M uon in hot QED plasma within Bloch Nordsieck Approximation

A bstract

The therm alpropagator of a heavy muon propagating in a hot QED plasm a is exam ined within the Bloch-Nordsieck approximation, which is valid in the infrared region. It is shown that the muon damping rate is nite, in contrast to the lower-order calculation with hard thermal loop resummations taken into account.

I. IN TRODUCTION

Because of much interest in the early Universe as well as in the quark-gluon plasm a to be produced in heavy-ion collisions, many authors have studied gauge theories at high tem perature. Them all propagators of bosons in real-time them all eld theory carry the Boltzm ann factor $1=(e^{E^{-T}} 1)$. For a massless boson like gauge boson, this factor behaves as T=k at the infrared region, k T, which leads to stronger infrared divergences in them all amplitudes than in vacuum theory. In vacuum theory, it is well known [1{3}] that all the physical quantities are free from infrared singularities, provided one sums over all degenerate nall states (Bloch Nordsieck mechanism). An important exception to this general statement is the so-called C oulom b singularity. For them all reaction rates, due to the stronger infrared singularitiesmentioned above, it is not known if they do not possess infrared singularities, except again for C oulom b singularities. Up until now, a proof is available of absence of leading infrared singularities in a generic them all reaction rate [4] and of all infrared singularities in a brem sstrahlung process within some specific approximation [5].

It has been established [6,7,14] that, to obtain a consistent perturbation expansion, resum m ations of hard-therm al-loop (HTL) contributions are necessary. A coording to this HTL resum m ation scheme, infrared behaviors of therm alam plitudes are softened or screened com pared with those in naive perturbative calculation. this softening renders some otherwise divergent physical quantities nite [7,8]. There are, however, some other physical quantities which are still infrared divergent to leading order in HTL resummation scheme. A wellknown example is the quark (muon) damping rate in a hot QCD (QED) plasma [9]. As a m atter of fact, the quark (m uon) dam ping rate diverges due to the Coulomb singularity. In naive perturbation calculation, the divergence is of power type. In HTL resummation scheme, as mentioned above, the infrared behaviour is softened and the infrared divergence becomes to be of logarithm ic type. It is expected, at least for quark case, that the infrared singularity is screened when still higher order resumm ation is performed. As far as the infrared behaviour of a spinor eld in QED is concerned, Bloch-Nordsieck approximation is a good approximation [10,11]. In this paper, the thermal two-point function of a heavy muon in a QED plasma is computed within this approximation. Various properties of the result are discussed, am ong those is an especially important conclusion: The decaying behavior of a heavy muon does not su er from divergence.

II. THERM AL TW O POINT FUNCTION OF A HEAVY MUON

By the term \heavy muon "we mean so heavy a muon that it is not therm alized, i.e., $e^{E=T}$ 1. The hot QED plasm a means that the temperature T of the plasm a is much higher than the electron mass m, T m. As discussed in Sec. I, the infrared behavior of the theory is responsible for the divergent damping rate. Thus, we employ the Bloch-Nordsieck approximation to the muon sector of the QED Lagrangian. The Lagrangian density is obtained [10,11] by substituting a constant vector u ($u^2=1$) for in the muon sector of the standard QED Lagrangian density:

where ; ; M ; m , and A stand, respectively, for heavy muon eld, electron eld , muon m ass, electron m ass and photon eld. It is known that, in the infrared region, the spinor structure of the heavy muon does not play any signi cant roles [10,11]. Then the above Lagrangian density well approximates the exact QED Lagrangian in the infrared region.

To obtain the therm altwo-point function of the heavy muon, we start from the Euclidean or imaginary-time formalism of thermal eld theory, initiated by Matsubara [12], in which a time arrow ows from zero to i=T in a complex time plane. In this form alism, the energy is discrete; $p_4 = 2 \text{ nT} (n = 0; 1; 2;$) for a boson eld and p(2n + 1)T for a ferm ion eld. At the nal stage, we analytically continue the two-point function, thus obtained, to real time (or real energy). A four vector $a = (a; a_4)$ in the imaginary-time form alism is obtained from the counter part $(a_0;a)$ in M inkowski space by an analytic continuation, ia. Sim ilar continuation is made for tensors.

The generating functional is introduced as usual,

In Eq. (2.10), $k_4 = \text{odd"}$ indicates that the sum m ation runs over n as defined in Eq. (2.11). Since the heavy muon is not therm alized, the muon determ in ant has been reduced to $\text{det}(\text{iu}_E)$ @ M) as in vacuum theory [10]. Using the formula deta = $\exp(\text{Trln a})$ and Furry's theorem [13], we have

Here G_0 (x y;m) denotes a bare electron propagator. As seen from Eq. (2.8) with Eq. (2.12), in the heavy-muon two-point function, the contributions of electrons enter through therm all electron loops. Here we employ the HTL resummation scheme for the electron sector: To leading order, among such electron loops, only HTLs that yield corrections to soft-photon external lines are important. In hot QED considered here, the O (e⁴) term in Eq. (2.12) vanishes [14] to leading order in the HTL resummation scheme. We then ignore it in the following.

where is the ne structure constant. Here, in order to regulate the ultraviolet divergence, we have employed the dimensional regularization, D=3 with >0. (A dimensionful parameter is introduced, as usual, so that e remains dimensionless.) In the HTL approximation, which we employ for the electron sector, the explicit form of $_{\rm T}$ and $_{\rm L}$ are known [6{9,15}:

III. PHYSICAL CONTENTS OF THE TW O POINT FUNCTION

We study the behaviors of D $_R$ in Eq. (2.36) in various limits of parameters involved. We divide the region 0 < 1 into several regions, which are discriminated by the two parameters $_A = \frac{1}{j_2 j_1}$, $_B = \frac{1}{m \text{ so} j_2 j_3}$ (see Appendix A).

where is the gamma function. When > 3, < 0 in Eq. (3.4). This is just as in vacuum theory [10], which we do not discuss any further. When = 3, G_E in Eq. (3.4) behaves as the bare propagator.

We are now in a position to discuss the decaying behavior of the heavy muon. For this purpose, we should study G_R near on the muon mass shell M p uj 0. The time dependence of the heavy-muon two-point function is obtained through the Fourier transform ation;

We discuss two cases separately. It is to be noted that juj $\frac{1}{M}$ jpj= $\frac{p-\frac{jvj}{2}}{1-\frac{jvj^2}{2}}$ with v being the external muon velocity:

In the region a) above, the behavior of G_R is gauge-parameter dependent, and we cannot draw any physically sensible conclusion. In the region b), the factor $\frac{M}{E}$ $\frac{M}{E}$ $\frac{T}{2}$ $\frac{M}{2}$ $\frac{T}{E}$ in G_R , Eq. (3.9), dominates over others. Then, the leading part of G_R is gauge-parameter independent and increases as tincreases. In the region c) the dominant part of G_R is gauge-parameter independent, which retincreases and then decreases. The turning point in t is approximately given by $\frac{E}{M}$ $\frac{T}{M}$ \frac{T}

In the region a) and b) the situation is the same as the $\,$ rst sentence in the above case. In the region c) G $_{R}\,$ decreases m onotonously.

Let us discuss the large t region c) more elaborately. The leading contribution comes from logarithmic parts of F (t) in Eq. (3.11) (cf. Eq. (3.3)). It is to be noted that the gauge-parameter dependent part in Eq. (3.11) may be neglected and Eq. (3.11) is gauge independent:

A striking feature is that Eq. (3.12) is divergence free or nite. The damping rate $_{\rm d}$ is usually de ned through the behavior of G $_{\rm R}$ at large t; G $_{\rm R}$ = e^{iE t $_{\rm d}$ t} (t ! 1). We are it not for the factor in t in Eq. (3.12), the damping rate would be identified from Eq. (3.10) with Eq. (3.12). Eq. (3.12) indicates that, at large t, the heavy muon in a QED plasm a decays much faster than the constant damping rate. In any case, the quantity, F (t), in Eq. (3.12) governs the damping behavior of the heavy muon. The behavior of F (t) in Eq. (3.12) is as follows:

This is always negative and the heavy muon decays.

IV.SUM M ARY AND DISCUSSION

In this paper we have derived and discussed the two point function of a heavy muon passing through a QED plasm a within the Bloch Nordsieck approximation. The assumption of heavy muon means that the muon line is hard. The electron sector only comes in as thermal radiative corrections to photon lines. Among those, we only take into account the HTL corrections to soft photon lines. HTL corrections to vertices are not necessary.

It is well known that, to leading order of HTL resum mation scheme, the damping rate of a quark (muon) diverges due to the Coulomb-type infrared singularity even to the lowest non-trivial order of resum med perturbation theory. It is because only the electric sector of soft gluon (photon) line is screened by the thermal mass. As far as QCD is concerned, the infrared singularity is screened by the magnetic mass which is expected to arise through still higher order resum mations. But in QED, no magnetic mass is induced.

In this paper, within the B loch Nordsieck approximation, it is shown that the \damping rate" of a heavy muon in a hot QED plasma is nite. More precisely, the heavy muon decays as t $\frac{MT}{E}$ jst at large t.

Finally it is worth mentioning the case where the HTL corrections to the soft photon line are ignored. (Explicit computation is given in Appendix B). For M p uj M, the gauge parameter dependent parts of G_R (cf. Eq. (2.36)) is the same as Eq. (3.5). Also for = 3, G_R reduces essentially to the bare propagator. In the nearly on the mass shell case the time dependence of G_R is quite dierent from that of Eq. (3.10) with Eq. (3.12):

the anti-dam ping behavior! From this fact, we learn that the HTL resum mation for soft photon lines plays an crucial role for obtaining a physically sensible dam ping behavior.

A coording to the HTL resum mation scheme, when the external photon lines are soft l_4 ; jl_5 0 (eT), the HTL corrections are necessary. Since l_4 is 2 nT (n = 0; 1; 2; l_4), l_5 with $n \in 0$ is no longer in the soft region. Then we should take care of the n = 0 m ode only.




