#### A bstract

The D  $_4$  D  $_5$  E  $_6$  m odel of gravity and the Standard M odel with a 130 G eV truth quark is constructed using 3 3 m atrices of octonions. The m odel has both continuum and lattice versions. The lattice version uses HyperD iam ond lattice structure.

#### Foreword.

In the D  $_4$  D  $_5$  E  $_6$  m ode, all tree level force strengths, particle m asses, and K-M param eters can be calculated. They can be found at W W W URL http://www.gatech.edu/tsm.ith/home.html [71].

W ithin 10% or so, they are consistent with currently accepted experim ental values except for the truth quark m ass. A cocording to the D  $_4$  D  $_5$  E  $_6$  m odel, it should be 130 G eV at tree level, whereas CDF at Ferm ilab has interpreted their data to show that the truth quark m ass is about 174G eV .

Ferm ilab's announcement is at W W W URL http://fnnews.fnalgov/ [26].

M y opinion is that the CDF interpretation is wrong, and that currently available experimental data indicates a truth quark mass in the range of 120  $\,$  145 GeV , which is consistent with the 130 GeV tree level calculation of the D  $_4$  D  $_5$  E  $_6$  m odel.

The D $_4$  D $_5$  E $_6$  m odel uses 3 copies of the octonions to represent the 8 rst generation ferm ion particles, the 8 rst generation ferm ion antiparticles, and the 8-dim ensional (before dim ensional reduction) spacetime.

This paper is an e ort to describe the construction of the D  $_4$  D  $_5$  E  $_6$  m odel by starting with elementary structures, and building the model up from them so that the interrelationships of the parts of the model may be more clearly understood.

The starting points I have chosen are the octonions, and 3 matrices of octonions [25].

Since the properties of octonions are not well covered in most textbooks, the rst section of the paper is devoted to a brief sum mary of some of the properties used in this paper.

3 3 m atrices are chosen because m atrices are well-covered in conventional m ath and physics texts, and also

because 3 3 traceless octonion m atrices can be used to build up in a concrete way the Lie algebras, Jordan algebras, and sym m etric spaces that are needed to construct the D  $_4$  D  $_5$  E  $_6$  m odel.

In particular, 3 3 traceless octonion matrices can be divided into hermitian and antihermitian parts to form a Jordan algebra  $J_3^0$  o and (when combined with derivations) a Lie algebra  $F_4$ .

Then  $J_3^{\circ}$  o and  $F_4$  can be combined to form the Lie algebra  $E_6$ .

The components of the matrix representation of E $_6$  can then be used to construct the Lagrangian of the D $_4$  D $_5$  E $_6$  model of G ravity plus the Standard M odel for rst generation fermions.

By extension to the exceptional Lie algebras  $E_7$  and  $E_8$ , the model includes the second and third generation ferm ions.

Since the E-series of Lie algebras contains only E  $_6$ , E  $_7$  and E  $_8$ , there are only three generation of ferm ions in the model.

To get an overview of what this paper does, represent the E  $_{\rm 6}$  Lie algebra by

where the R represents the real scalar eld of this representation of E  $_6$ ; O is octonion; S  $^7$  represents the imaginary octonions; a;b; c are real numbers (octonion real axis); and G  $_2$  is the Lie algebra of derivations of O .

Then, use the components of E  $_6$  to construct the 8-dim ensional Lagrangian of the D  $_4$  D  $_5$  E  $_6$  m odel:

where? is the Hodge dual;

 $\mathfrak{E}_8$  is the 8-dim ensional covariant derivative,  $\mathfrak{E}_8$  is the 8-dim ensional D irac operator, and

 $F_8$  is the 28-dim ensional Spin (8) curvature, which come from the Spin (0;8) gauge group subgroup of  $E_6$ , represented here by

 $_8$  is the 8-dim ensional scalar eld, which comes from the R scalar part of the representation of E  $_6$ ;

 $V_8$  is 8-dim ensional spacetime, and which comes from the O  $_{\rm v}$  part of the representation of E  $_6$ ;

 $S_8$  are the + and 8-dim ensional half-spinor ferm ion spaces, which come from the  $O_+$  and  $O_-$  parts of the representation of  $E_6$ ;

As a theory with an 8-dim ensional spacetime, the D $_4$  D $_5$  E $_6$  m odel is seen to be constructed from the fundamental representations of the D $_4$  Lie algebra Spin (0;8):

8 com es from the trivial scalar representation;

 $F_8$  com es from the 28-dim ensional adjoint representation;

V<sub>8</sub> com es from the 8-dim ensional vector representation; and

 $S_{8+}$  and  $S_{8-}$  com e from the two 8-dim ensional half-spinor representations.

As all representations of Spin(0;8) can be built by tensor products and sum s using the 3 8-dim ensional representations and the 28-dim ensional adjoint representation,

(the 4 of which make up the D  $_4$  D ynkin diagram, which looks like a M ercedes-Benz 3-pointed star, with the 28-dimensional adjoint representation in the middle) plus the trivial scalar representation, the D  $_4$  D  $_5$  E  $_6$  modele ectively uses all the ways you can look at Spin (0;8).

If you use exterior w edge products as w ell as tensor products and sum s, you can build all the representations from only the representations on the exterior of the D ynkin diagram,

in this case, the 3 points of the star, the 3 8-dim ensional vector and half-spinor representations,

plus the trivial scalar representation.

In this case, it is clear because the adjoint representation is the bivector rep-

resentation, or the wedge product of two copies of the vector representation. For discussion of more complicated Lie algebras, such as the E $_8$  Lie algebra, see A dam s [2].

Our physical spacetime is not 8-dimensional, and the D $_4$  D $_5$  E $_6$  m odel gets to a 4-dimensional spacetime by a process of dimensional reduction.

D im ensional reduction of spacetime to 4 dimensions produces a realistic 4-dimensional Lagrangian of Gravity plus the Standard Model.

Then force strength constants and particle m asses are calculated, as are K obayashiM askawa param eters.

(The calculations are at tree level, with quark masses being constituent masses.)

The structures in this paper are exceptional in m any senses, and can be studied from m any points of view .

This paper is based on the structure of 3 3 m atrices of octonions. For a discussion of 3 3 m atrices of octonions from a somewhat dierent perspective, see Truini and Biedenham [75].

I have also looked at the D  $_4$  D  $_5$  E  $_6$  m odel from the C li ord algebra point of view [68].

Som e useful references to C li ord algebras include the books of G ilbert and M urray [31], of H arvey [37], and of P orteous [54].

From the point of view of the exceptional Lie algebra  $F_4$  and the Cayley M outang plane OP<sup>2</sup>, see the paper of A dam s [1].

From the point of view of the 7-sphere, the highest dimensional sphere that is parallelizable, and the only parallelizable manifold that is not a Lie

group, see papers by Cederwall and Preitschopf [6], Cederwall [7], M anogue and Schray [45], and Schray and M anogue [63].

From the point of view of Herm itian Jordan Triple systems, see papers by Gunaydin [35, 36] and my paper [67].

General references for dierential geometry, Lie groups, and the symmetric spaces used herein are the books of Besse [4], Fulton and Harris [28], Gilmore [32], Helgason [38], Hua [40], Kobayashi and Nomizu [42], Porteous [54], and Postnikov [55], and the papers of Ramond [56] and Sudbery [73]. An interesting discussion of symmetries in physics is Saller [57].

A notational comment - this paper uses the same notation for a Lie group as for its Lie algebra. It should be clear from context as to which is being discussed.

#### 1 Octonions.

There are 480 di erent ways to write a multiplication table for an octonion product. Since the purpose of this paper is to construct a concrete representation of the D  $_4$  D  $_5$  E  $_6$  physics model, one of these is chosen and used throughout.

For a good introduction to octonions, see the books of Geo rey D ixon [18] and of Jaak Lohmus, Eugene Paal, and Leo Sorgsepp [43], as well as the paper of Gunaydin and Gursey [34].

For many more interesting things about octonions, see the book and papers of Geo rey Dixon [15, 16, 17, 18, 19, 20, 21].

The following description of octonion products, left and right actions, and automorphisms and derivations, is taken from Dixon's book and papers cited above, and from a paper by A. Sudbery [73].

#### 1.1 Octonion Product.

For concreteness, choose one of the 480 multiplications: Let  $e_a$ ; a=1; ...; 7, represent the imaginary units of 0, and adopt the cyclic multiplication rule

$$e_a e_{a+1} = e_{a+5} = e_{a-2};$$
 (4)

a=1,...,7, all indices m odulo 7, from 1 to 7 (another cyclic multiplication rule for 0, dual to that above, is  $e_ae_{a+1}=e_{a+3}=e_{a-4}$ ). In particular,

$$fq_1 ! e_a; q_2 ! e_{a+1}; q_3 ! e_{a+5}g$$

de ne injections of Q into Q for A=1,...,Q. In the multiplication rule Equation (4) the indices range from Q to Q, and the index Q representing the octonion real number Q is not subject to the rule.

This octonion multiplication has some very nice properties.

For example,

if 
$$e_a e_b = e_c$$
; then  $e_{(2a)} e_{(2b)} = e_{(2c)}$ : (6)

Equation (6) in combination with Equation (4) im mediately implies

$$e_a e_{a+2} = e_{a+3};$$
 $e_a e_{a+4} = e_{a+6}$  (7)

(so  $e_a e_{a+2^n} = e_{a-2^{n+1}}$ , or  $e_a e_{a+b} = [b^3 \text{ m od } 7]e_{a-2b^4}$ , b = 1; :::; 6, where  $b^3$  out front provides the sign of the product (m odulo 7,  $1^3 = 2^3 = 4^3 = 1$ , and  $3^3 = 5^3 = 6^3 = 1$ )). Also, 2(7)=7 m od 7, so Equations (6) and (4) imply

$$e_7e_1 = e_5$$
;  $e_7e_2 = e_3$ ;  $e_7e_4 = e_6$ : (8)

These modulo 7 periodicity properties are rejected in the full multiplication table:

A lthough the octonion product is nonassociative, it is alternative.

An example of nonassociativity from the multiplication table is that

$$(e_1 e_2)e_4 = e_6 e_2 = e_7$$

is not equal to

$$e_1 (e_2 e_4) = e_1 e_5 = e_7$$

The alternativity property is the fact that the associator

$$[x;y;z] = x(yz) \quad (xy)z \tag{10}$$

is an alternating function of x; y; z 2 0.

#### Left and Right Adjoint Algebras of O.

The octonion algebra is nonassociative and so is not representable as a matrix algebra.

However, the adjoint algebras of left and right actions of 0 on itself are associative.

For example, let  $u_1; :::; u_n; x$  be elements of 0. Consider the left adjoint m ap

$$x ! u_n (:::(u_2 (u_1 x)) :::):$$
 (11)

The nesting of parentheses forces the products to occur in a certain order, hence this algebra of left-actions is trivially associative, and it is representable by a matrix algebra.

One such representation can be derived im mediately from the multiplication table Equation (9). For example, the actions

$$x ! e_1 x e_{L1}(x); and x ! xe_1 e_{R1}(x)$$

can be identi ed with the matrices

(only nonzero entries are indicated). Note that  $e_2e_6=e_3e_4=e_5e_7=e_1$ , but because of the nonassociativity of 0, for example,

$$e_1x = (e_2e_6)x + e_2(e_6x) = e_{L26}(x)$$

in general.

In the octonion algebra, any product from the right can be reproduced as the sum of products from the left, and visa versa.

The left and right adjoint algebras O  $_{\rm L}$  and O  $_{\rm R}$  are the same algebra, and this algebra is larger than O itself. In fact, it is isomorphic to R (8).

It is not di cult to prove that

$$e_{\text{La:::bc:::d}} = e_{\text{La:::cb:::d}}$$
 (16)

if  $b \in c$ , all indices from 1 to 7.

So, for example,  $e_1(e_2(e_3x)) = e_1(e_3(e_2x)) = e_3(e_1(e_2x))$ .

In addition,

$$e_{\text{Lab:::pp:::c}} = e_{\text{Lab:::c}} \tag{17}$$

(cancellation of like indices).

Together with

$$e_{L7654321} = 1;$$

Equations (16) and (17) im ply that a complete basis for the left= right adjoint algebra of 0 consists of elements of the form

$$1; e_{Lab}; e_{Labc};$$
 (19)

1 the identity.

This yields 1+7+21+35=64 as the dim ension of the adjoint algebra of 0, also the dim ension of R (8).

$$O_{L} = O_{R} = R (8)$$
: (20)

The 8-dimensional 0 itself is the object space of the adjoint algebra.

#### 1.3 Aut(0) and Der(0).

The 14-dim ensional exceptional Lie group  $G_2$  is the automorphism group Aut(0) of the octonions.

When viewed from the point of view of a linear Lie algebra with bracket product rather than the point of view of a nonlinear global Lie group with group product, the structure that corresponds to the automorphism group Aut(O) is the algebra of derivations Der(O) of the octonions.

A derivation is a linear map D: 0! O such that for x; y 20:

$$D(xy) = (Dx)y + x(Dy)$$

Then, from the alternative property of the octonions:

D (ab)
$$x = [a;b;x] + (1=3)[[a;b];x]$$
 (22)

Let  $C_d = L_d$   $R_d$ , where  $L_d$  and  $R_d$  denote left and right multiplication by an imaginary octonion d. The imaginary octonions Im (O) are those octonions in the space orthogonal to the octonion real axis. Then

D (ab) = 
$$(1=6) ([C_a; C_b] + C_{[a:b]})$$

The algebra of derivations D er (O) of the octonions is the Lie algebra G $_2$ .

A basis for the Lie algebra of  $G_2$  is represented in  $O_L$  by:

$$fe_{Lab} e_{Lcd} : e_a e_b = e_c e_d g ! G_2 :$$
 (23)

In  $O_R$  the basis is much the same:

$$fe_{Rab}$$
  $e_{Rcd}:e_ae_b=e_ce_dg!$   $G_2:$ 

The stability group of any xed octonion direction is the 8-dimensional SU (3)  $G_2$ .

A basis for the Lie algebra of the stability group of e<sub>7</sub> is:

$$fe_{Lab} = e_{Lcd} 2 G_2 : a;b;c;d + 7g! su(3):$$
 (24)

Thus SU (3) is the intersection of  $G_2$  with Spin (6), and  $G_2 = SU$  (3)  $S^6$ .

The algebra of derivations does not give the Lie algebra all the antisym m etric m aps of a real division algebra R ;C ;H ;O unless the algebra is commutative and associative, i.e., R ;C. In the case of C, the Lie algebra of all antisym m etric m aps is

$$D \operatorname{er}(C) = \operatorname{Spin}(2) = U(1)$$

.

For H, which is associative but not commutative,

$$Der(H)$$
  $L_{Im(H)}$   $R_{Im(H)}$ 

where  $L_{\,\text{Im}\,\,(H\,\,)}$  and R  $_{\,\text{Im}\,\,(H\,\,)}$  denote left and right multiplication on the quaternions by the imaginary quaternions.

 $L_{\,\text{Im}\ (\text{H}\ )}$  is isomorphic to and commutes with R  $_{\text{Im}\ (\text{H}\ )}$  .

Since  $L_{Im (H)} = R_{Im (H)} = Spin (3) = SU (2) = Sp (1) = S<sup>3</sup>$ , the Lie algebra Spin (4) of all antisym metric maps of H is given by

$$Spin(4) = Spin(3)$$
  $Spin(3)$ 

For 0, which is neither associative nor commutative, the vector space of all antisymmetric maps of 0 is given by

Spin (0;8) = D er (0) 
$$L_{Im (0)} R_{Im (0)} = G_2 S^7 S^7$$

where  $S^7$  represents the imaginary octonions, notation suggested by the fact that the unit octonions are the 7-sphere  $S^7$  which, since it is parallelizable, is locally representative of the imaginary octonions.

The 7-sphere S  $^7$  has a left-handed basis fe<sub>La</sub>g and a right-handed basis fe<sub>Ra</sub>g.

Unlike the 3-sphere, which is the Lie group Spin (3) = SU (2) = Sp(1),  $S^7$  does not close under the commutator bracket product because  $[e_{La};e_{Lb}]=2 = e_{Lab}$  and  $[e_{Ra};e_{Rb}]=2 = e_{Rab}$  for a 6 b.

To make a Lie algebra out of  $S^7$ , it must be extended to Spin (0;8) by adding the 21 basis elements  $fe_{Lab}g$  or  $fe_{Rab}g$ .

There are three ways to extend  $S^7$  to the Lie algebra Spin (0;8).

They result in the left half-spinor, right half-spinor, and vector representations of Spin (0;8):

$$fe_{Ra}; e_{Rbc}g ! Spin (0;8); right half-spinor;$$

Therefore, the two half-spinor representations and the vector representation of Spin (0;8) all have 8-dimensional 0 as representation space.

The three representations are isom orphic by triality.

Consider the 28 basis elements  $fe_{La} + e_{Ra}; e_{Lbc} = e_{Ra} : e_a = e_b e_c g$  of the vector representation of Spin (0;8):

The 21-element subset  $fe_{Lbc}$   $e_{Ra}: e_a = e_b e_c g$  is a basis for the Lie algebra Spin (7) =  $G_2$   $S^7$ .

Therefore, the Lie algebra Spin  $(0;8) = S^7$   $G_2$   $S^7$ .

## 2 3 30 ctonion M atrices and $E_6$ .

The D  $_4$  D  $_5$  E  $_6$  m odel of physics uses 3 copies of the octonions: O  $_{\rm v}$  to represent an 8-dim ensional spacetime (prior to dim ensional reduction to 4 dim ensions);

- $O_+$  to represent the  $8_-$  rst-generation ferm ion + half-spinor particles; and
- O to represent the 8 rst-generation ferm ion -half-spinor antiparticles.

Consider the 72-dim ensional space of 3 3 m atrices of octonions:

w here

 $O_v;O_+;O_1;O_2;O_3;X;Y;Z$  are octonion,  $O_1 = a + S_1^7;O_2 = b + S_2^7;O_3 = c + S_3^7$  a;b;c are real, and  $S_1^7;S_2^7;S_3^7$  are in aginary octonion.

Consider the ordinary matrix product AB of two 3 3 octonion matrices A and B.

Now, to construct the Lie algebra  $E_6$  from 3 3 octonion matrices, it is useful to split the product AB into antisymmetric and symmetric parts.

$$AB = (1=2) (AB BA) + (1=2) (AB + BA)$$
 (27)

This will enable us to construct an  $F_4$  Lie algebra from antiHerm itian matrices that will arise from considering the antisymmetric product, and a  $J_3^\circ$  o Jordan algebra from herm itian matrices that will arise from considering

the sym m etric product.

Then the Lie algebra F  $_4$  and the Jordan algebra  $\rm J_3^{\circ}$  o will be combined to form the Lie algebra E  $_6$  whose structure forms the basis of the D  $_4$  D  $_5$  E  $_6$  m odel.

This construction is only possible in this case because of many exceptional structures and sym m etries. The D  $_4\,$  D  $_5\,$  E  $_6$  m odel therefore inherits remarkable sym m etry structures

#### 2.1 Antihem itian Matrices and Lie Algebras.

Consider the antisymmetric product (1=2) (AB BA):

The 45-dim ensional space of antiherm itian 3 3 octonion m atrices does not close under the antisym m etric product to form a Lie algebra (here, y denotes octonion conjugation):

A product that closes is

$$(1=2) (AB BA Tr(AB BA))$$
 (29)

The form of the product indicates that to get closure, you have to use only the 45-7 = 38-dim ensional space of traceless antiherm itian 3 3 octonion matrices:

However, the Jacobi identity is not satis ed, so you still do not have a Lie algebra.

As was mentioned in Section 1.3, to get the Lie algebra of all antisymm etric maps of the nonassociative, noncommutative real division algebra 0 you must include the 14-dimensional Lie algebra of derivations Der (0) =  $G_2$ .

Adding the derivations to the product that closes gives a product that not only closes but also satis es the Jacobi identity:

$$(1=2)$$
 (AB BA Tr(AB BA) D (A;B)) (31)

where the derivation D (A;B) =  $^{P}_{ij}$ D (a<sub>ij</sub>;b<sub>ij</sub>) and the derivation D (x;y) acts on the octonion z by using the alternator [x;y;z] = D (x;y)z.

The resulting space is the 38+14 = 52-dim ensional Lie algebra  $F_4$ .

The physical interpretation of this representation of F $_4$  in the D $_4$  D $_5$  E $_6$  m odel is:

- 0  $_{\rm v}$  is 8-dim ensional spacetim e before dim ensional reduction to 4 dim ensions;
- $O_{+}$  is the 8-dim ensional space representing the rst generation ferm ion particles (the neutrino, the electron, the red, blue and green up quarks, and the red, blue and green down quarks);
- O is the 8-dimensional space representing the rst generation ferm ion antiparticles before dimensional reduction creates 3 generations; and
- $S_1^7$   $S_2^7$   $G_2$  is the Spin (0;8) gauge group before dim ensional reduction breaks it down into gravity plus the Standard M odel.

Now, consider the symmetric Jordan product and the hermitian matrices that form an algebra under it.

In the next subsection, they will be studied so that their structure can be added to the F $_4$  structure of traceless antiherm itian matrices plus the derivations G $_2$ .

#### 2.2 Hem itian Matrices and Jordan Algebras.

Consider the sym metric product (1=2) (AB + BA):

The 27-dim ensional space of herm itian 3 3 octonion matrices closes under the symmetric product to form the Jordan algebra  $J_3^0$ :

Even though the full 27-dim ensional space of herm itian matrices forms a Jordan algebra  $J_3^\circ$ , only the 26-dim ensional traceless subalgebra  $J_3^\circ$  o is acted on by  $F_4$  as its representation space:

The 52-dim ensional  $F_4$  and the 26-dim ensional  $J_3^\circ$  o combine to form the 78-dim ensional Lie algebra  $E_6$ ,

the E  $_6$  of the D  $_4$  D  $_5$  E  $_6$  m odel.

 $E_6$  preserves the cubic determinant pseudoscalar 3-form for 3 octonionic matrices (see [28, 8]).

Sudbery [73] has identi ed E  $_6$  with SL (3;0).

Flynn [25], in the context of her physics m odels, has used such an identication to note the similarity of E $_6$  to SL (3;C), which is also made up of an antisymmetric part, SU (3), plus a symmetric part, an 8-dimensional Jordan algebra, and which preserves a cubic determinant.

## 3 Shilov Boundaries of Complex Domains.

In the D  $_4$  D  $_5$  E  $_6$  m odel, physical spacetime and the physical spinor ferm ion representation manifold are Shilov boundaries of bounded complex domains.

The best general reference to Shilov boundaries is Helgason's 1994 book [39].

The best set of calculations of volumes, etc., of Shilov boundaries is Hua's book [40].

That means, for instance, that physical 8-dimensional spacetime is the 8-realdimensional Shilov boundary of of a 16-realdimensional (8-complex-dimensional) bounded complex domain.

To physicists, the most fam iliar example of bounded complex domains and their Shilov boundaries (other than the unit disk and its Shilov boundary, the circle) probably comes from the twistors of Roger Penrose [53].

A nother example, possibly less familiar, is the chronometry theory of I.E. Segal [64] at M  $\,\text{J.T.}$ 

Still another example, also probably not very familiar, is the use of the geometry of bounded complex domains by Arm and Wyler [77] in his e ort to calculate the value of the ne structure constant.

To mathematicians, such structures are well known.

A standard general reference is the book of H ua [40], in which Shilov boundaries are called characteristic manifolds.

A ctually, I would prefer the term characteristic boundary, because it would describe it as being part of a boundary that characterizes important structures on the manifold.

However, I will use the term Shilov boundary because that seems to be the dominant term in English-language literature.

The simplest example (a mathematical object that Prof. Feller [23] said was the best all-purpose example in mathematics for understanding new concepts) is the unit disk along with its harm onic functions. The unit disk is the bounded complex domain, the unit circle is its Shilov boundary, and the

harm onic functions are determined throughout the unit disk by their values on the Shilov boundary.

A more complicated example of such structures, taken from the works of those mentioned above, starts with an 8-real-dimensional 4-complex-dimensional space denoted M $^{\rm C}$  with signature (2;6).

W hat are Bounded Complex Homogeneous Domains?

To see the second example, start with the complexied M inkowski spacetime M  $_{2:6}^{\text{C}}$  of Penrose twistor theory.

M  $^{\rm C}$  is a Herm itian symmetric space that is the coset space

. In the m athem atical classication notation, it is called a Herm itian symmetric space of type BD  $\rm I_{2;4}$  .

The Herm itian symmetric coset space is unbounded, but for each Herm itian symmetric space there exists a natural corresponding bounded complex domain.

In this case, B C  $I_{2;4}$ , the bounded complex domain is called Type  $IV_4$  and consists of the elements of C  $_4$  de ned by

W hat are Shilov boundaries?

The Shilov boundary (called the characteristic manifold by Hua in [40]) is a subset of the topological boundary of the bounded complex domain.

Following Hua [40], consider the analytic functions on the bounded complex domain. The Shilov boundary is the part of the topological boundary on which every analytic function attains its maximum modulus, and such that for every point on the Shilov boundary, there exists an analytic function

on the bounded complex domain that attains its maximum modulus at that point.

The Shilov boundary is closed. Any function which is analytic in the neighborhood of every point of the Shilov boundary is uniquely determined by its values on the Shilov boundary.

In the case of the bounded dom ain of Type  $IV_4$  H ua [40] shows that the Shilov boundary is

In the Penrose tw istor form alism , it is the 4-dim ensional M inkow ski spacetime M  $_{1;3}$  w ith signature (1;3)

There exists a kernel function, the Poisson kernel P (z; ) function of a point z in the bounded complex domain and a point in its Shilov boundary, such that, for any analytic f(z),

Since all the analytic functions in the bounded complex domain are determined by their values on the Shilov boundary, the Shilov boundary should be the proper domain of de nition of physically relevant functions.

That is why the D $_4$  D $_5$  E $_6$  m odel takes the Shilov boundary to be the relevant manifold for spacetime and for representing ferm ion particles and antiparticles.

There exists another kernel function, the Bergm an kernel function  $K(z;\overline{w})$  of two points z;w in the bounded complex domain such that, for any analytic f(z),

Setting z=w in the Bergm an kernel gives a Riem annian metric for the bounded complex domain,

which in turn de nes invariant di erential operators including the Laplacian, which in turn gives harm onic functions.

The Bergm an kernel is equal to the ratio of the volume density to the Euclidean volume of the bounded complex domain.

Hua [40] not only gives the above description, he also actually calculates the volumes of the bounded complex domains and their Shilov boundaries.

Suppose that, as in the D  $_4$  D  $_5$  E  $_6$  m odel, di erent bounded com plex dom ains represent di erent physical forces whose G reen's functions are determ ined by their invariant di erential operators.

Then, since the domain volumes represent the measures of the Bergman kernels of bounded complex domains, and

since the physical part of the domain is its Shilov boundary, the ratios of (suitably normalized) volumes of Shilov boundaries should (and do, in the D $_4$  D $_5$  E $_6$  model) represent the ratios of force strengths of the corresponding forces.

W hen D er (O ) =  $G_2$  is added the result is a subalgebra of the Lie algebra F<sub>4</sub>:

This Lie algebra is 8+7+7+14 = 36-dim ensional Spin (9), also denoted B<sub>4</sub>. Spin (9) is to O as SU (2) is to C.

The checkerboard 3 3 octonion traceless herm itian matrices also form a subalgebra of the 3 3 octonion traceless herm itian matrices:

It is isomorphic to the 10-dimensional Jordan algebra  $J_2^0$  of 2 2 octonion herm itian matrices:

 $J_2^{\text{O}}\,$  has a 9-dim ensional traceless Jordan subalgebra  $J_2^{\text{O}}\,$  o, and

The 1-dim ensional Jordan algebra  $J_1^{\mathbb{C}}$  o corresponds to the Lie algebra U (1).

The 36-dim ensional B  $_4$  and the 9-dim ensional  $J_2^{\rm O}$  o combine to form the 45-dim ensional Lie algebra D  $_5$ , also denoted Spin (10), the D  $_5$  of the D  $_4$  D  $_5$  E  $_6$  m odel.

Physically, D  $_5$  contains the gauge group and spacetime parts of E  $_6$ , so the half-spinor ferm ion particle and antiparticle parts of E  $_6$  should live in a coset space that is a quotient of E  $_6$  by D  $_5$ .

Due to complex structure, the quotient must be taken by D  $_5$  U (1) rather than D  $_5$  alone. The U (1) com es from action on the Jordan algebra  $J_1^C$  o.

The resulting symmetric space that is the representation space of the rst-generation particles and antiparticles in the D $_4$  D $_5$  E $_6$ m odel is the 78-45-1 = 32-real-dimensional hermitian symmetric space

The 16 particles and antiparticles live on the 16-real-dimensional Shilov boundary of the bounded complex domain that corresponds to the symmetric space. The Shilov boundary is

There is one copy of  $S^7$  RP  $^1$  for the 8 rst-generation ferm ion half-spinor particles, and one for the 8 antiparticles.

#### 4.2 2x2 Diagonal Octonion Matrices and D4.

The 2 2 octonion antiherm itian checkerboard matrices form the diagonal matrix subalgebra of the 2 2 octonion antiherm itian matrices.

When Der(O) =  $G_2$  is added the result is a subalgebra of the Lie algebras  $B_4$  and  $F_4$ :

This Lie algebra is 7+7+14 = 28-dim ensional Spin (0;8), also denoted D<sub>4</sub>.

The checkerboard 2 2 octonion traceless herm it in matrices also form the diagonal subalgebra of the 2 2 octonion traceless herm it in matrices:

It is isom orphic to the 1-dim ensional Jordan algebra  $J_1^C$  o.

The 1-dim ensional Jordan algebra  $J_1^{\mathbb{C}}$  o corresponds to the Lie algebra U (1).

The 28-dim ensional D  $_4$  Lie algebra, also denoted Spin (0;8), is (before dim ensional reduction) the sm allest Lie algebra in the D  $_4$  D  $_5$  E  $_6$  m odel.

Physically, D  $_4$  contains only the gauge group parts of D  $_5$  and E  $_6$ , so the 8-dim ensional spacetime of D  $_5$  and E  $_6$  should live in a coset space that is a quotient of D  $_5$  by D  $_4$ .

Due to complex structure, the quotient must be taken by D $_4$  U (1) rather than D $_4$  alone. The U (1) com es from action on the Jordan algebra  $J_1^C$  o.

The resulting symmetric space that is the representation space of the 8-dim ensional spacetime in the D  $_4$  D  $_5$  E  $_6$  m odel is the 45-28-1 = 16-real-dim ensional herm itian symmetric space



# 5 Global E 6 Lagrangian.

Represent the E 6 Lie algebra by



where the R represents the real scalar eld of this representation of E  $_6$  . Full E  $_6$  sym m etry of the D  $_4$  D  $_5$  E  $_6$  m odel is a global sym m etry, and is useful prim arily to:

de ne the spacetime, ferm ions, and bosons;

de ne the tree-level relative force strengths and particle m asses;

give generalized supersymmetric relationships among ferm ions and bosons that may be useful in loop cancellations to produce ultraviolet and infrared nite results;

give CPT symmetry, which involves both particle C and spacetime P and T symmetries.

Some more discussion of CPT, CP, and T can be found at WWW URL http://www.gatech.edu/tsmith/CPT.html[71].

D ynam ics of the D  $_4$  D  $_5$  E  $_6$  m odel are given by a Lagrangian action that is the integral over spacetime of a Lagrangian density made up of a gauge boson curvature term, a spinor ferm ion term (including through a D irac operator interaction with gauge bosons), and a scalar term.

The 8-dim ensional Lagrangian is:

where? is the Hodge dual;

 $Q_8$  is the 8-dim ensional covariant derivative,  $Q_8$  is the 8-dim ensional D irac operator, and

 $F_8$  is the 28-dim ensional Spin (8) curvature, which come from the Spin (0;8) gauge group subgroup of  $E_6$ , represented here by

 $_{8}$  is the 8-dim ensional scalar eld, which comes from the R scalar part of the representation of E  $_{6}$ ;

 $V_8$  is 8-dim ensional spacetime, and which comes from the O  $_{\rm v}$  part of the representation of E  $_6$ ;

 $S_8$  are the + and 8-dimensional half-spinor ferm ion spaces, which come from the  $O_+$  and  $O_-$  parts of the representation of  $E_6$ ;

The 8-dim ensional Lagrangian is a classical Lagrangian.

To get a quantum action, the D  $_4$  D  $_5$  E 6 m odel uses a path integral sum over histories.

At its m ost fundam ental level, the D  $_4$  D  $_5$  E 6 m odel is a lattice m odel w ith 8-dim ensional E  $_8$  lattice spacetim e.

The path integral sum over histories is based on a generalized Feynm an checkerboard scheme over the E  $_8$  lattice spacetime.

The original Feynm an checkerboard is in 2-dimensional spacetime, in which the speed of light is naturally c=1.

In the 4-dim ensional spacetime of the D<sub>4</sub> lattice, the speed of light is

naturally  $c = \frac{p}{3}$ .

In 8-dim ensional spacetime, the speed of light is naturally  $c = \sqrt[p-1]{7}$ , but in the 8-dim ensional E<sub>8</sub> lattice the nearest neighbor vertices have only 4 (not 8) non-zero coordinates and therefore have a natural speed of light of  $c = \sqrt[3]{3}$  that is appropriate for 4-dim ensional light-cones rather than for 8-dim ensional lightcones with  $c = \sqrt[p-1]{7}$ .

Thismeans that:

the generalized Feynm an checkerboard scheme will not produce lightcone paths in 8-dimensional spacetime;

the dim ension of spacetim e m ust be reduced to 4 dim ensions, as discussed in Section 7.; and

the 8-dim ensional Lagrangian is classical, and does not contain gauge xing and ghost term s.

Gauge—xing term and ghost term sonly appear after dimensional reduction of spacetime permits construction of generalized Feynman checkerboard quantum path integral sums over histories.

The gauge xing term s are needed to avoid overcounting gauge equivalent paths, and ghosts then appear.

The D $_4$  = Spin (0;8) gauge sym m etry will be reduced to gravity plus the Standard M odelby dimensional reduction. The gauge sym metries of gravity and the Standard M odelwill be broken by gauge—xing and ghost terms, and the resulting Lagrangian will have a BRS sym metry.

The dynam ical sym m etry that is physically relevant at the initial level is the D  $_4$  = Spin (0;8) gauge sym m etry of the Lagrangian.

It is clear that Spin (0;8) acts through its 8-dim ensional vector, + half-spinor, and -half-spinor representations on the O  $_{\rm v}$ , O  $_{+}$ , and O  $_{\rm parts}$  of the antiherm itian m atrix

It is also clear that Spin (0;8) acts through its 28-dim ensional adjoint representation on the  $S_1^7$  and  $S_2^7$  parts of the antiherm itian matrix, plus the derivations  $G_2$ , since

On the herm itian Jordan algebra matrix  $\mathbf{J}_3^{\text{O}}$  o:

the action of Spin (0;8) (as a subgroup of E  $_6$  and F  $_4$ ) leaves invariant each of the O  $_{\rm v}$ , O  $_+$ , and O  $_{\rm parts}$  of the m atrix, corresponding to the facts that the gauge group Spin (0;8):

does not act as a generalized supersymmetry to interchange spacetime and fermions; and

does not interchange ferm ion particles and antiparticles.

## 6 3 G enerations: $E_{6}$ , $E_{7}$ , and $E_{8}$ .

In the D  $_4$  D  $_5$  E  $_6$  m odel, the rst generation of spinor ferm ions is represented by the octonions O , the second by O O , and the third by O O O . The global structure of the D  $_4$  D  $_5$  E  $_6$  m odel with 8-d in ensional spacetime and rst generation ferm ions is given by

Here, the  $O_+$  and  $O_+$  in  $J_3^O$  o represent the  $O_+$  rst generation ferm ion particles and antiparticles. Using the octonion basis  $f1;e_1;e_2;e_3;e_4;e_5;e_6;e_7g$  with quaternionic subalgebra basis  $f1;e_1;e_2;e_6g$  and with octonion product Equation (4), the representation is:

The O  $_{\rm v}$  represents 8-dim ensional spacetim e.

To represent the O O second generation of ferm ions, you need a structure that generalizes Equation (52) by having two copies of the ferm ion octonions.

The sim plest such generalization is

This proposal fails because the O  $_+$  and O  $_-$  in ?E ? are not embedded in  $J_3^\circ$  o and therefore do not transform like the  $_-$ rst generation O  $_+$  and O that are embedded in  $J_3^\circ$  o.

Therefore, make the second simplest generalization:

The ??E ?? proposal also fails, because the algebraic structure of the two copies of  $J_3^\circ$  o is incomplete.

To complete the algebraic structure, a third copy of  $J_3^\circ$  on ust be added, and all three copies must be related algebraically like the imaginary quaternions fi; j;kg. This can be done by tensoring  $J_3^\circ$  ow ith the imaginary quaternions  $S^3 = SU(2) = Spin(3) = Sp(1)$ .

Since the order of the octonions in 0 0 should be irrelevant (for example, the octonion pair fe; 1g should represent the same ferm ion as the octonion pair f1; e; g), the structure must include the derivation algebra of

the automorphism group of the quaternions, SU (2).

The resulting structure is the 133-dim ensional exceptional Lie algebra  $E_7$ :

Therefore  $E_7$  is the global structure algebra of the second generation ferm ions.

For the third generation of ferm ions, note that three algebraically independent copies of  $J_3^\circ$  o generate seven copies, corresponding to the imaginary octonions f1;e1;e2;e3;e4;e5;e6;e7g; that the imaginary octonions can be represented by  $S^7$ ; and that the derivation algebra of the automorphism group of the octonions is  $G_2$ .

Therefore, the 248-dim ensional exceptional Lie algebra  $E_8$ :

is the global structure algebra of the third generation ferm ions.

Since there are only three Lie algebras in the series  $E_6$ ;  $E_7$ ;  $E_8$ , there are only three generations of ferm ions.

The rst-generation Lie algebra  $E_6$  has one copy of  $J_3^\circ$  o, corresponding to the complex in aginary i.

The second-generation Lie algebra  $E_7$  adds one more algebraically independent copy of  $J_3^\circ$  o, corresponding to the quaternionic imaginary j. Together with the icopy of  $J_3^\circ$  o, the kcopy is produced, so  $E_7$  has in total 3 copies of  $J_3^\circ$  o.

The third-generation Lie algebra E  $_8$  adds one m ore algebraically independent copy of  $J_3^\circ$  o, corresponding to the octonionic imaginary  $e_4$ . Together with the  $i=e_1; j=e_2; k=e_6$  copies of  $J_3^\circ$  o, the  $e_3; e_5; e_7$  copies are produced, so E  $_7$  has in total 3 copies of  $J_3^\circ$  o.

Therefore, transitions among generation of fermions to a lower one involve elimination of algebraically independent imaginaries.

From 2nd to 1st, it must e ectively map j! 1. This transition can be done in one step.

From 3rd to 2nd, it must e ectively map  $e_4$ ! 1. This transition can also be done in one step.

From 3rd to 1st, it must e ectively map  $j;e_4$ ! 1. This transition cannot be done in one step.

The map  $e_4$ ! 1 only gets you to the 2nd generation.

You still need the additional map j! 1 to get to the 1st.

Since the imaginaries  $e_4$  and j are orthogonal to each other, there must be an intermediate step that is electively a phase shift of =2, and the KOBAYASHIMASKAWAPHASE angle parameter should be

# 7 Discrete Lattices and Dim ensional Reduction.

The physical manifolds of the D  $_4$  D  $_5$  E  $_6$  m odel should be representable in term s of discrete lattices in order to be form ulated as a generalized Feynman checkerboard model.

General references on lattices, polytopes, and related structures are the book of Conway and Sloane [9] and the books [10, 11] and some papers [12, 13] of Coxeter.

#### 7.1 Discrete Lattice D<sub>4</sub> D<sub>5</sub> E<sub>6</sub> M odel.

As seen in section 2, 78-dim ensional  $E_6$  of the  $D_4$   $D_5$   $E_6$  m odel is made up of three parts:

38-dim ensional space of antiherm itian 3 3 octonion m atrices;

14-dim ensional space of the Lie algebra G2; and

26-dim ensional space of the Jordan algebra  $J_3^0$  o.

#### 7.2 Antiherm itian 3 30 ctonion Matrices.

Antihermitian 3 3 octonion matrices:

Individually,  $O_{v}$ ,  $O_{+}$ , and  $O_{-}$  can each be represented by the 8-dim ensional E  $_{8}$  lattice, as shown by G eo rey D ixon [20].

As Geo rey Dixon [21] has shown, the two half-spinor spaces O  $_{+}$ , and O taken together can be represented by the 16-dim ensional Barnes-W all lattice  $_{16}$ .

The Barnes-W all lattices form a series of real dimension  $2^n$  for n 2, and that the Barnes-W all lattices of real dimension 4 and 8 are the D  $_4$  and E  $_8$  lattices.

 $O_+$ , and  $O_-$  form the Shilov boundary of a 16-complex dimensional bounded complex hom ogeneous domain, and Conway and Sloane [9] note that Q uebbem ann's 32-real dimensional lattice is a complex lattice whose

 $^{\rm 2}$  16-real-dim ensional real part is the 16-real-dim ensional B armes-W all  $_{\rm 16}$  lattice.

To represent all three  $0_{\rm v}$ ,  $0_{+}$ , and  $0_{-}$  together, it may be possible to use the 24-dimensional Leech lattice.

Such a Leech lattice representation is likely to be related to the group

In a Leech lattice representation, it is likely that:

the  $O_+$  and  $O_-$  correspond to the two  $S^7$ 's of the Spin  $(0;8)_-$  brations, and to the  $X_-$ -product of M artin C ederwall [6] and the  $X_-$ 2 product on which G eo rey D ixon is working; and

the O  $_{\rm v}$  corresponds to a 7-dim ensional representation of the G  $_2$  of the Spin (0;8) brations.

The entire 26-dim ensional space of traceless antiherm itian 3  $\,$  3 octonion m atrices m ay be represented by the Lorentz Leech lattice  $_{25;1}$ , which is closely related to the M onster group.

 $S_1^7$   $S_2^7$   $G_2 = D_4$  is the Lie algebra of the Spin (0;8) gauge group of the  $D_4$   $D_5$   $E_6$  m odel (before spacetime dimensional reduction).

The gauge group Spin (0;8) acts through its gauge bosons, which can: propagate through spacetime; interact with ferm ion particles or antiparticles; and interact with each other.

P ropagation through spacetime is represented by the 8-dimensional vector representation of Spin (0;8), which in turn is represented by the octonions O  $_{\rm v}$  and, in discrete lattice version, by the E  $_{\rm 8}$  lattice.

Interaction with ferm ion particles is represented by the 8-dimensional + half-spinor representation of Spin (0;8), which in turn is represented by the octonions O  $_+$  and, in discrete lattice version, individually by the E  $_8$  lattice.

Interaction with ferm ion antiparticles is represented by the 8-dimensional half-spinor representation of Spin (0;8), which in turn is represented by the octonions 0 and, in discrete lattice version, individually by the E  $_8$  lattice.

Together, the two half-spinor representations are represented by the Barnes-W all  $_{16}$  lattice.

Interaction with other gauge bosons is represented by the 28-dim ensional adjoint representation of Spin (0;8), which in turn is represented by the exterior wedge bivector product of two copies of the vector octonions 0  $_{\rm v}$  ^ 0  $_{\rm v}$  and, in discrete lattice version, by the exterior wedge bivector product of two copies of the E  $_8$  lattice, E  $_8$  ^ E  $_8$  .

### 7.4 Jordan algebra $J_3^{\circ}$ o.

26-dim ensional space of the Jordan algebra  $J_3^0$  o:

The 25+1 = 26-dim ensional Lorentz Leech lattice  $II_{25;1}$  can be used to represent the 26-dim ensional Jordan algebra  $J_3^0$  o.

As seen in section 4., the physically relevant group action on  $J_3^\circ$  o for the Lagrangian dynam ics of the D  $_4$  D  $_5$  E  $_6$  m odel is not action by the global sym m etry group E  $_6$ , but rather action by the gauge group Spin (0;8).

Since action on  $J_3^0$  o by the gauge group Spin (0;8) leaves invariant each of the O  $_{v}$ , O  $_{+}$ , and O  $_{0}$  parts of the m atrix, the only discrete lattice structure needed for the Lagrangian dynam ics of the D  $_{4}$  D  $_{5}$  E  $_{6}$  m odel is the representation of each of O  $_{v}$ , O  $_{+}$ , and O  $_{0}$  by an E  $_{8}$  lattice, and the full Lorentz Leech lattice II $_{25;1}$  is not needed.

However, in case it may be useful to have a discrete lattice description of global sym metries (for example, in looking at generalized supersym metric relationships among fermions and bosons or at CPT sym metry), here are some characteristics of the Lorentz Leech lattice  $\mathrm{II}_{25:1}$ :

II<sub>25;1</sub> can be represented (as in Conway and Sloane [9]) by the set of vectors  $fx_0; x_1; ...; x_{24}; x_{25}g$  such that all the  $x_i$  are in Z or all in Z + 1=2 and satisfy

$$x_0 + ::: + x_{24} \quad x_{25} \ 2 \ 2Z$$

Let w = (0;1;2;3;:::23;24;70). Since  $0^2 + 1^2 + 2^2 + :::+ 24^2 = 70^2$ , w is an isotropic vector in  $II_{25;1}$ .

Then the Leech roots, or vectors r in  $II_{25;1}$  such that r=2 and r=4 are the vertices of a 24-dim ensional Leech lattice.

Also,  $(w^? \setminus II_{25;1})=w$  is a copy of the Leech lattice.

The 24-dim ensional Leech lattice can be made up of 3 E  $_8$  lattices, and so corresponds to the o -diagonal part of  $J_3^{\,0}$  o.

Each vertex of the Leech lattice has 196,560 nearest neighbors.

A space of 196,560+300+24 = 196,884 dim ensions can be used to represent the largest nite simple, group, the Fischer-Greiss Monster of order

#### 7.5 Lattice D im ensional Reduction.

#### 7.5.1 HyperD iam ond Lattices.

The lattices of type D  $_{\rm n}$  are n-dim ensional checkerboard lattices, that is, the alternate vertices of a Zn hypercubic lattice. A general reference on lattices is C onway and Sloane [9]. For the n-dim ensional HyperD iam ond construction from D  $_{\rm n}$ , C onway and Sloane use an n-dim ensional glue vector [1] = (0.5; :::; 0.5) (with n 0.5's).

Consider D  $_3$ , the fix close packing in 3-space. M ake a second D  $_3$  shifted by the glue vector (0:5;0:5;0:5).

Then form the union  $D_3$  [ ([1] +  $D_3$ ).

That is a 3-dim ensional Diam ond crystal.

When you do the same thing to get a 4-dimensional HyperDiamond, you get  $D_8$  [ ([]+  $D_8$ ).

The 4-dim ensional HyperD iam and D  $_4$  [ ([1]+ D  $_4$ ) is the Z  $^4$  hypercubic lattice with null edges.

It is the lattice that M ichael G ibbs [30] uses in his Ph.D. thesis advised by D avid F inkelstein.

W hen you construct an 8-dim ensional HyperD iam ond, you get D $_8$  [ ([1]+ D $_8$ ) = E $_8$ , the fundam ental lattice of the octonion structures in the D $_4$  D $_5$  E $_6$  m odel described in hep-ph/9501252.

#### 7.5.2 Dim ensional Reduction.

D im ensional reduction of spacetime from 8 to 4 dim ensions takes the E  $_{8}$  lattice into a D  $_{4}$  lattice.

The  $E_8$  lattice can be written in 7 di erent ways using octonion coordinates with basis

The 4-dim ensional H yperD iam ond D  $_4$  [ ([1]+ D  $_4)$  is the Z  $^4$  hypercubic lattice with null edges.

It is the lattice that M ichael G ibbs [30] uses in his Ph. D. thesis advised by D avid F inkelstein.

the E  $_8$  lattice nearest neighbor vertices have only  $\frac{4}{p}$  non-zero coordinates, like 4-dim ensional spacetime with speed of light  $c=\frac{8}{3}$ , rather than  $\frac{8}{7}$  non-zero coordinates, like 8-dim ensional spacetime with speed of light  $c=\frac{7}{7}$ , so the E  $_8$  lattice light-cone structure appears to be 4-dim ensional rather than 8-dim ensional;

the representation of the  $E_8$  lattice by quaternionic icosians, as described by Conway and Sloane [9];

the G olden ratio construction of the E  $_8$  lattice from the D  $_4$  lattice, which has a 24-cell nearest neighbor polytope (The construction starts with the 24 vertices of a 24-cell, then adds G olden ratio points on each of the 96 edges of the 24-cell, then extends the space to 8 dimensions by considering the algebraicaly independent  $\frac{1}{5}$  part of the coordinates to be geometrically independent, and nally doubling the resulting 120 vertices in 8-dimensional space (by considering both the D  $_4$  lattice and its dual D  $_4$ ) to get the 240 vertices of the E  $_8$  lattice nearest neighbor polytope (the W itting polytope); and

the fact that the 240-vertex W itting polytope, the E $_8$  lattice nearest neighbor polytope, most naturally lives in 4 complex dimensions, where it is self-dual, rather than in 8 real dimensions.

In referring to Conway and Sloane [9], bear in m ind that they use the convention (usual in working with lattices) that the norm of a lattice distance is the square of the length of the lattice distance.

It is also noteworthy that the number of vertices in shells of an E  $_8$  lattice increase m onotonically as the radius of the shell increases, while cyclic relationships (see C onway and Sloane [9]) appear in the number of vertices in shells of a D  $_4$  lattice.

#### 7.6 Discrete Lattice E ects of 8! 4 dim.

Spin (0;8) acts on the octonions O , the lattice version of which is the E  $_{\rm 8}$  lattice.

Each vertex in the E  $_{8}$  lattice has 240 nearest neighbors, the inner shell of the E  $_{8}$  lattice.

Geo rey D ixon [21] shows that the 240 vertices in the E  $_8$  inner shellbreak down with respect to the two 4-dim ensional subspaces of O , each represented by the inner shell of a D  $_4\,$  lattice, as

The two 24-element sets each have the group structure of the binary tetrahedral group, also the group of 24 quaternion units, and the 24 elements would represent the root vectors of the Spin0; (8) D $_4$  Lie algebra in the 4-dimensional space of the D $_4$  lattice.

The 192 element set is the W eyl group of the Spin0; (8) D $_4$  Lie algebra. The W eyl group is the group of reections in the hyperplanes (in the D $_4$  4-dimensional space) that are orthogonal to the 24 root vectors.

If the 8-dim ensional E  $_8\,$  spacetim e is reduced to the 4-dim ensional D  $_4\,$  spacetim e, then

The 24-element D $_4$  lattice inner shell formed by the U elements of Equation (76) form the second shell of the reduced 4-dimensional spacetime D $_4$  lattice, as described in the preceding Subsection 7.5. Denote this set by 24U.

The 24-elem ent D  $_4$  lattice inner shell form ed by the V elements of Equation (76) form the 24-element nite group (binary tetrahedral group of unit quaternions) that is the W eyl group of the internal symmetry gauge group of the 4-dimensional D  $_4$  D  $_5$  E  $_6$  m odel. Denote this group by 24V .

The 192-element W eyl group of the D  $_4$  Lie algebra of Spin (0;8) is made up of pairs, the rst of which is an element of the 24-element set of W elements.

Denote that 24-element set by 24W.

The second part of a pair is an element of the 8-element set of X elements. Denote that 8-element set by 8X.

A fler dim ensional reduction of spacetim e, Spin (0;8) is too big to act as an isotropy group on spacetim e, as it acted in 8-dim ensional spacetim e, which is of the form

.

Therefore, in 4-dim ensional spacetime, the 28 in nitesimal generators of Spin (0;8) (which act as 28 gauge bosons in 8-dim ensional D $_4$  D $_5$  E $_6$  physics) cannot interact according to the commutation relations of Spin (0;8), but must interact according to commutation relations of smaller groups that can act on 4-dim ensional spacetime.

W hat type of action should these smaller groups have on 4-dimensional spacetime?

Isotropy action is su cient in the case of the 28 Spin (0;8) in nitesimal generators in the 8-dimensional theory, because the gauge boson part of the Lagrangian  $_{8~\rm dim}$  F  $^{\circ}$  ?F is an integral over 8-dimensional spacetime

using a uniform measure that is the same for all 28 gauge boson in nitesimal generators. Physically, the force strength of the Spin (0;8) gauge group can be taken to be 1 because there is only one gauge group in the 8-dimensional D $_4$  D $_5$  E $_6$  model.

However, as we shall see now, isotropy action is not su cient for the gauge groups after dim ensional reduction.

A fler reduction to 4-dimensional spacetime, the 28 in nitesimal generators will have to regroup into more that one smaller groups, each of which will have its own force strength. The 4-dimensional Lagrangian will be the sum of more than one Lagrangians of the form  $_{4~\rm dim}^{\rm R}$  F ^ ?F , each of which will use a dierent measure in integrating over 4-dimensional spacetime. A factor in determining the relative strengths of the 4-dimensional forces will be the relative magnitude of the measures over 4-dimensional spacetime. Therefore, the measure information should be carried in the F of the 4-dimensional Lagrangian  $_{\rm R^4~dim}^{\rm R^4~dim}$  F ^ ?F , which is dierent for each force, rather than in the overall  $_{4~\rm dim}^{\rm R^4~dim}$  , which should be uniform for all terms in the total 4-dimensional Lagrangian of the D  $_{4}~\rm D_{5}~\rm E_{6}~m$  odel.

In the 4-dim ensional D  $_4\,$  D  $_5\,$  E  $_6$  m odel, the sm all gauge groups m ust act transitively on 4-dim ensional spacetim e, so that they can carry the m easure inform ation. Physically, the gauge bosons of the di erent gauge groups see spacetim e di erently

each point p.

Since the 4-dim ensional D  $_4$  D  $_5$  E  $_6$  m odel gauge groups are not isotropy groups of 4-dim ensional spacetim e, but actually act transitively on 4-dim ensional m anifolds, they are not exactly conventional "local sym m etry" gauge groups. In the conventional "local sym m etry" picture, you can put a gauge boson in nitesim al generator x (G) of the gauge group G at each point p of the spacetime base manifold, with the choice of x (G) made independently at

In the D  $_4$  D  $_5$  E  $_6$  m odel picture, the choice of x (G) at a point not only is the choice of a gauge boson, but also of a "translation" direction in the 4-dim ensional spacetime.

When you choose a gauge boson, say a 'red-antiblue gluon" of the SU (3) color force gauge group, then does your "choice" of "translation direction" x a physical direction of propagation (say, (+1 i j k)=2 in quaternionic coordinates for the future lightcone)?

If it does, the model doesn't work right. Fortunately for the D  $_4$  D  $_5$  E  $_6$  model, there is one more choice to be made independently at each point, and that is the choice to put any given element of the gauge group G in corresponce with with any element of the isotropy subgroup K or with any direction in the 4-dimensional manifold G=K on which G acts transitively.

Therefore, at any given point in the 4-dimensional spacetime, you can choose the "red-antiblue gluon" gauge boson (or any other gauge boson) and the (+1 i j k)=2 direction (or any other direction), and independent choices can be made at all points in the 4-dimensional spacetime of the D $_4$ D $_5$ E $_6$ m odel.

Since choices of gauge boson and direction of propagation are both made at once, it is natural in the lattice D  $_4$  D  $_5$  E  $_6$  m odel to picture the gauge bosons as living on the links of the spacetime lattice, with the ferm ion particles and antiparticles living on the vertices.

This type of structure m ight not work consistently in a model with less sym metry than the D $_4$  D $_5$  E $_6$  model. Particularly, the triality sym metry of 8-dimensional spacetime with the 8-dimensional half-spinor representation spaces of the rst-generation ferm ion particles and antiparticles means that the gauge boson sym metry group, which must act on ferm ion particles and antiparticles in a natural way,

also acts transitively on spacetime in a natural way. For a discussion of what types of "generalized supersymmetry" symmetries are useful, and why the D $_4$  D $_5$  E $_6$  model probably has the most useful symmetries of any model, see hep-th/9306011 [68]).

Even after dimensional reduction of spacetime, there is a residual symmetry relationship between the fermion representation spaces and spacetime. Perhaps that residual symmetry might be a way to relate the results of the D $_4$  D $_5$  E $_6$  model to the results of the 4-dimensional lattice model of Finkelstein and G ibbs. [30]

W hat can these smaller groups be? Since 4-dim ensional spacetime has quaternionic structure, they must act transitively on 4-dim ensionalm anifolds with quaternionic structure.

Such manifolds have been classied by Wolf [76], and they are

Two copies of the gauge group SU (2) act on 2 copies of S<sup>2</sup>.

Each SU (2) has 3 in nitesim algenerators,

the three weak bosons fW  $;W_0;W_+$ .

Since a given weak boson cannot carry a di erent charge in

di erent parts of 4-dim ensional spacetim e,

the 2 copies of SU (2) must be aligned consistently.

This means that there is physically only one SU (2) weak force gauge group, and that there are 3 degrees of freedom due to

3 Spin (0;8) in nitesimal generators that are not used.

Denote them by 3 SU (2).

Four copies of the gauge group U (1) act on 4 copies of S<sup>1</sup>.

Each U (1) has 1 in nitesim algenerator, the photon.

Since a given photon should be the same in all parts of 4-dimensional spacetime,

the 4 copies of U (1) must be aligned consistently.

This means that there is physically only one U (1) electrom agnetic gauge group,

and that there are 3 degrees of freedom due to

3 Spin (0;8) in nitesimal generators that are not used.

Denote them by 3 U (1).

How does all this tinto the structures 24U, 24V, 24W, and 8X?

24U and 24W are the D  $_4$  and D  $_4$  of the 4-dim ensional lattice spacetime as described in the preceding Subsection 7.5 .

The 8X , being part of a 192-elem ent product with 24W , should represent a gauge group that is closely connected to spacetime. 8X represents the 8-elem ent W eyl group  $S_2^3$  of the gauge group Spin (5).

By the MacDowell-Mansourimechanism [44], the Spin (5) gauge group accounts for Einstein-Hilbert gravity.

24V, being entirely from the part of 8-dim ensional spacetime that did not survive dimensional reduction, should represent the Weyl groups of gauge groups of internal symmetries.

As 24V is the 24-element binary tetrahedral group of unit quaternions, the inner shell of the D<sub>4</sub> lattice, it has a 4-element subgroup  $S_2^2$  m ade up of unit complex numbers, the inner shell of the Gaussian lattice.

 $24V=S_2^2$  is the 6-element group  $S_3$ , which is the W eyl group of the SU (3) gauge group of the color force.

The  $S_2^2$  is 2 copies of the W eyl group of the SU (2) gauge group of the weak force.

As U (1) is Abelian, and so has the identity for its W eyl group, 4 copies of the U (1) gauge group of electrom agnetism can be said to be included in the gauge groups of W high 24V is the W eyl group.

Therefore, 24V gives us the gauge groups of the Standard M odel, SU (3) SU (2) U (1), plus the extra 6 degrees of freedom 3 SU (2) and 3 U (1) that were discussed above.

It will be seen in Section 8.2 that 5 of the 6 extra degrees of freedom are a link between the Higgs sector of the Standard M odel and conform al symmetry related to gravity, and the 6th, a copy of U (1), accounts for the complex phase of propagators in the D  $_4$  D  $_5$  E  $_6$  m odel.

From the continuum lim it view point of Section 82, those 6 degrees of freedom are combined with the gravity sector to expand the 10-dim ensional de Sitter Spin (5) group of the M acD owell-M ansourim echanism to the 15-dim ensional conform al Spin (2;4) group plus the U (1) of the complex propagator phase, which in turn can all be combined into one copy of 16-dim ensional U (4).

From the discrete W eylgroup point of view of this section, the 3 SU (2) and 3 U (1) degrees of freedom are represented by the W eylgroup  $S_2$ . The  $S_2$  can be identified with the 3  $S_2$ 's of the gravity Spin (5)  $S_2^3$  in 3 ways, so the identification electively expands the gravity sector W eylgroup by a factor of 3 from  $S_2^3 = S_2^2$  S<sub>2</sub> to  $S_2^2$  S<sub>3</sub>, which is the W eylgroup of the conform algroup Spin (2;4) and also the W eylgroup of U (4).

#### 8 Continuum Limit E ects of 8! 4 dim.

The dimensional reduction breaks the gauge group Spin (0;8) into gravity plus the Standard M odel.

One of the few dierences between the Standard M odel sector of the 4-dim ensional D  $_4\,$  D  $_5\,$  E  $_6\,$  m odel and the Standard M odel electroweak structure is that

in the D  $_4$  D  $_5$  E  $_6$  m odel the electrom agnetic U (1) is m ost naturally put with the color force SU (3), while

in the electroweak Standard M odel the electrom agnetic U (1) is most naturally put with the weak force SU (2).

As 0 R aifearteagh [52] points out, that di erence is an advantage of the D  $_4$  D  $_5$  E  $_6$  m odel.

16-dim ensional U (4) = Spin(0;6) U (1), where Spin(0;6) = SU(4) is the conformal group of 4-dim ensional spacetime (the conformal group gives gravity by the M acD owell-M ansourim echanism [44, 47], and gauge xing of the conformal group gives the H iggs scalar symmetry breaking) and the U (1) is the complex phase propagators in the 4-dim ensional spacetime; and

Physically, the U (1) is the D irac complexication and it gives the physical D irac gam m as their complex structure, so that they are C (4) in stead of R (4).

D irac com plexi cation justi es the physical use of W ick rotation between Euclidean and M inkowski spacetimes, because C (4) is the C li ord algebra of both the compact Euclidean deSitter Lie group Spin (0;5) and the noncompact M inkowski anti-deSitter Lie group Spin (2;3).

12-dim ensional U (3)  $\,$  SU (2), where SU (2) is the gauge group of the weak force and U (3) = SU (3)  $\,$  U (1) is the SU (3) gauge group of the color force and the U (1) gauge group of electrom agnetism.

#### 8.2.1 Conform al Gravity and Higgs Scalar.

Spin (0;6) is the maximal subgroup of Spin (0;8) that acts on the 4-dimensional reduced spacetime. It acts as the compact version of the conformal group.

An 8 8 m atrix representation of Spin (0;6) is

The MacDowell-Mansourim echanism [44] produces a classical model of gravity from a Spin (0;5) de Sitter gauge group. As a subalgebra of the Spin (0;6) Lie algebra, the Spin (0;5) Lie algebra can be represented by

The 5 elements  $fa_{16}$ ;  $a_{26}$ ;  $a_{36}$ ;  $a_{46}$ ;  $a_{56}$ g that are in Spin (0;6) but not in Spin (0;5) are the 1 scale and 4 conform aldegrees of freedom that are gauge-xed by M ohapatra in section 14.6 of [47] to get from the 15-dimensional conform algroup Spin (0;6) to the 10-dimensional deSitter group Spin (0;5) so that the M acD owell-M ansouri mechanism [44] can be used to produce E instein-H ilbert gravity plus a cosm ological constant term, an Euler topological term, and a Pontragin topological term.

As Nieto, Obregon, and Socorro [51] have shown, MacDowell-Mansouri de-

Sitter gravity is equivalent to A shtekar gravity plus a cosmological constant term, an Euler topological term, and a Pontriagin topological term.

For further discussion of the M adD owell-M ansourinm echanism, see Freund [27] (chapter 21), or Ne'em an and Regge [50](at pages 25-28), or Nieto, Obregon, and Socorro [51]

The physical reason for xing the scale and conform aldegrees of freedom lies in the relationship between gravity and the Higgs mechanism.

Since all rest mass comes from the H iggs mechanism, and since rest mass interacts through gravity, it is natural for gravity and H iggs sym metry breaking to be related at a fundamental level.

As remarked by Sardanashvily [61], Heisenberg and Ivanenko in the 1960s made the rst attempt to connect gravity with a symmetry breaking mechanism by proposing that the graviton might be a Goldstone boson resulting from breaking Lorentz symmetry in going from at M Inkowski spacetime to curved spacetime.

Sardanashvily [61] (see also gr-qc/9405013 [59] gr-qc/9407032 [60] gr-qc/9411013 [62]) proposes that gravity be represented by a gauge theory with group GL(4), that GL(4) symmetry can be broken to either Lorentz SO(3;1) symmetry or SO(4) symmetry, and that the resulting Higgs elds can be interpreted as either the gravitational eld (for breaking to SO(3;1) or the Riemannian metric (for breaking to SO(4).

The identication of a pseudo-Riemannian metric with a Higgs eldwas made by Trautman [74], by Sardanashvily [58], and by Ivanenko and Sardanashvily [41]

In the D  $_4$  D  $_5$  E  $_6$  m odel (using here the com pact version) the conform al group Spin (0;6) = SU (4) is broken to the de Sitter group Spin (0;5) = Sp(2) by xing the 1 scale and 4 conform algauge degrees of freedom.

The resulting H iggs eld is interpreted in the D  $_4\,$  D  $_5\,$  E  $_6\,$ m odel as the same H iggs eld that gives m ass to the SU (2) weak bosons and to the D irac ferm ions by the H iggs m echanism .

The Higgs mechanism requires "spontaneous symmetry breaking" of a scalar eld potential whose minima are not zero, but which form a 3-sphere  $S^3 = SU(2)$ .

In particular, one real component of the complex H iggs scalar doublet is set to v=2), where v is the modulus of the  $S^3$  of m in in a, usually called the vacuum expectation value.

If the  $S^3$  is taken to be the unit quaternions, then the "spontaneous sym – metry breaking" requires choosing a (positive) real axis for the quaternion space.

In the standard model, it is assumed that a random vacuum uctuation breaks the SU(2) sym metry and in e ect chooses a real axis at random.

In the D $_4$  D $_5$  E $_6$  m odel, the symmetry breaking from conformal Spin (0;6) to de Sitter Spin (0;5) by xing the 1 scale and 4 conformal degrees of freedom is a symmetry breaking mechanism that does not require perturbation by a random vacuum uctuation.

Gauge—xing the 1 scale degree of freedom—xes a length scale. It can be chosen to be the magnitude of the vacuum—expectation value, or radius of the  ${\rm S}^3$ .

Gauge-xing the 4 conformal degrees of freedom  $\,$  xes the (positive) real axis of the S $^3$  consistently throughout 4-dim ensional spacetime.

Therefore, the D  $_4$  D  $_5$  E  $_6$  m odel H iggs eld com es from the breaking of Spin (0;6) conform al sym m etry to Spin (0;5) de Sitter gauge sym m etry, from which E instein-H ilbert gravity can be constructed by the M acD owell-M ansourim echanism .

Einstein-Hilbert gravity as a spin-2 eld theory in at spacetime: Feynman, in his 1962-63 lectures at Caltech [24], showed how Einstein-Hilbert gravity can be described by starting with a linear spin-2 eld theory in at spacetime, and then adding higher-order terms to get Einstein-Hilbert gravity. The observed curved spacetime is based on an unobservable at spacetime. (see also Deser [14]

The Feynm an spin-2 at spacetim e construction of Einstein-Hilbert gravity allows the D  $_4$  D  $_5$  E  $_6$  m odel to be based on a fundam ental D  $_4$  lattice 4-dim ensional spacetim e.

Quantization in the D  $_4$  D  $_5$  E  $_6$  m odel is fundam entally based on a path integral sum over histories of paths in a D  $_4$  lattice spacetime using a generalized Feynm an checkerboard.

The generalized Feynm an checkerboard is discussed at

W W W URL http://www.gatech.edu/tsmith/FynCkbd.html[71].

Fundam entally, that is nice, but calculations can be very dicult, particularly for quantum gravity.

The work of Garcia-Compean et. al [29] suggests that the most practical approach to quantum gravity may be through BRST symmetry.

Quantization breaks the gauge group invariance of the D  $_4$  D  $_5$  E  $_6$  m odel Lagrangian, because the path integral must not overcount paths by including more than one representative of each gauge-equivalence class of paths. The remaining quantum symmetry is the symmetry of BRST cohomology classes.

K now ledge of the BRST symmetry tells you which ghosts must be used in quantum calculations, so the BRST cohomology can be taken to be the basis for the quantum theory.

Garcia-Compean et. al [29] discuss two current approaches to quantum gravity:

string theory, which abandons point particles even at the classical level; and

rede nition of classical general relativity in terms of new variables, the A shtekar variables [3] and trying to use the new variables to construct a quantum theory of gravity.

N ieto, O bregon, and Socorro [51] have shown that the M acD owell-M ansouri Spin (0;5) = Sp(2) de Sitter Lagrangian for gravity used in the D  $_4$  D  $_5$  E  $_6$  m odel is equal to the Lagrangian for gravity in term s of the A shtekar variables [3] plus

a cosm ological constant term,

an Euler topological term, and

a Pontragin topological term.

Therefore, although the quantum gravity methods of string theory cannot be used in the D $_4$  D $_5$  E $_6$  model because the D $_4$  D $_5$  E $_6$  model uses fundamental point particles at the classical level,

the m ethods based on A shtekar variables [3] are available.

Two such approaches are:

a topological approach based on loop groups; and

an algebraic approach based on getting BRST transform ations from Maurer-Cartan horizontality conditions.

The latter approach, which is described in B laga, et. al. [5] is the approach used for the D  $_4$  D  $_5$  E  $_6$  m odel.

#### 8.2.2 Chern-Sim ons Time

An essential part of a quantum theory of gravity is the correct de nition of physical time.

Nieto, Obregon, and Socomo [51] have shown that Lagrangian action of the Ashtekar variables [3] is a Chem-Sim ons action if the Killing metric of the de Sitter group is used instead of the Levi-Civita tensor.

Sm olin and Soo [72] have shown that the Chem-Sim ons invariant of the A shtekar-Sen connection is a natural candidate for the internal time coordinate for classical and quantum cosmology, so that the D $_4$  D $_5$  E $_6$  m odel uses Chem-Sim ons time.

## 8.2.3 Quantum Gravity plus Standard M odel

A nother essential part of a quantum theory of gravity is the correct relationship of quantum gravity with the quantum theory of the forces and particles of the Standard M odel, to calculate how standard m odel particles and elds interact in the presence of gravity.

M oritsch, et. al. [48] have done this by using M aurer-C artan horizontality conditions to get BRST transform ations for Yang-M ills gauge elds in the presence of gravity.

### 8.2.4 Color, W eak, and E lectrom agnetic Forces.

One of the factors determ ining the force strength constants is the relative magnitude of the measures of integration over the 4-dimensional spacetime base manifold in each integral.

The second factor in the force strengths is based on the interaction of the gauge bosons with the spinor ferm ions through the covariant derivative.

When the spinor ferm ion term is added to the 4-dimensional D $_4$  D $_5$  E $_6$  Lagrangian for each force, you get a Lagrangian of the form

The covariant derivative part of the D irac operator  $Q_8$  gives the interaction between each of the four forces and the spinor ferm ions.

The strength of each force depends on the magnitude of the interaction of the covariant derivative of the force with the spinor ferm ions. Since the spinor ferm ions are de ned with respect to a space  $Q=S^7$  RP  $^1$  that is the Shilov boundary of a bounded complex hom ogeneous domain D, the relative strength of each force can be measured by the relative volumes of the part of the manifolds Q and D that are a ected by that force.

Let V ol $(Q_{force})$  be the volume of that part of the full compact ferm ion state spacem anifold R P  $^1$  S  $^7$  on which a gauge group acts naturally through its charged (color or electrom agnetic charge) gauge bosons.

For the forces with charged gauge bosons,

 $Q_{\rm force}$  is the Shilov boundary of the bounded complex hom ogeneous domain D  $_{\rm force}$  that corresponds to the Herm itian symmetric space on which the gauge group acts naturally as a local isotropy (gauge) group.

For U (1) electrom agnetism , whose photon carries no charge, the factors V ol(Q  $_{\rm U~(1)}$ ) and V ol(Q  $_{\rm U~(1)}$ ) do not apply and are set equal to 1.

The volum es V ol $(M_{force})$ , V ol $(Q_{force})$ , and V ol $(D_{force})$  are calculated with M  $_{force}$ ;  $Q_{force}$ ;  $D_{force}$  normalized to unit radius.

The factor  $\frac{1}{\text{Volp}_{\text{force}}}$  is a norm alization factor to be used if the di-

m ension of Q  $_{\rm force}$  is di erent from the dimension m  $_{\rm force}$ , in order to normalize the radius of Q  $_{\rm force}$  to be consistent with the unit radius of M  $_{\rm force}$ .

How much of the total mass  $f_1 = Yv = 2 = 7.5$  GeV is allocated to each of the 1rst generation D irac ferm ions is determined by calculating the individual ferm ion masses in the D<sub>4</sub> D<sub>5</sub> E<sub>6</sub> model, and

those calculations also give the values of

$$f_2 = 32.9 \,\mathrm{GeV}$$
 (123)

$$f_3 = 1;629 \text{ G eV}$$
 (124)

as well as second and third generation individual ferm ion masses, with the result that the individual tree-level lepton masses and quark constituent masses are:

Here is how the individual ferm ion mass calculations are done in the D  $_4\,$  D  $_5\,$  E  $_6$  m odel.

The W eyl ferm ion neutrino has at tree level only the left-handed state, whereas the D irac ferm ion electron and quarks can have both left-handed and right-handed states, so that the total number of states corresponding to each of the half-spinor Spin (0;8) representations is 15.

Neutrinos are massless at tree level in all generations.

In the D  $_4$  D  $_5$  E  $_6$ m odel, the rst generation ferm ions correspond to octonions O , while second generation ferm ions correspond to pairs of octonions O O and third generation ferm ions correspond to triples of octonions O O O .

To calculate the ferm ion m asses in the model, the volume of a compact manifold representing the spinor ferm ions  $S_{8+}$  is used. It is the parallelizable manifold  $S^7-RP^1$ .

A lso, since gravitation is coupled to mass, the in nitesimal generators of the MacDowell-Mansouri gravitation group, Spin (0;5), are relevant.

The calculated quark masses are constituent masses, not current masses.

In the D  $_4$  D  $_5$  E  $_6$  m odel, ferm ion m asses are calculated as a product of four factors:

 $V (Q_{ferm ion})$  is the volume of the part of the half-spinor ferm ion particle manifold  $S^7 - RP^1$  that is related to the ferm ion particle by photon, weak boson, and gluon interactions.

N (G raviton) is the number of types of Spin (0;5) graviton related to the ferm ion. The 10 gravitons correspond to the 10 in nitesimal generators of Spin (0;5) = Sp(2).

2 of them are in the Cartan subalgebra.

6 of them carry color charge, and m ay therefore be considered as corresponding to quarks.

The remaining 2 carry no color charge, but may carry electric charge and so may be considered as corresponding to electrons.

One graviton takes the electron into itself, and the other can only take the rst-generation electron into the massless electron neutrino.

Therefore only one graviton should correspond to the mass of the rstgeneration electron.

The graviton number ratio of the down quark to the rst-generation electron is therefore 6/1 = 6.

N (octonion) is an octonion number factor relating up-type quark m asses to down-type quark m asses in each generation.

Sym is an internal symmetry factor, relating 2nd and 3rd generation massive leptons to rst generation ferm ions.

It is not used in rst-generation calculations.

The ratio of the down quark constituent m ass to the electron m ass is then calculated as follows:

Consider the electron, e.

By photon, weak boson, and gluon interactions, e can only be taken into 1, the massless neutrino.

The electron and neutrino, or their antiparticles, cannot be combined to produce any of the massive up or down quarks.

The neutrino, being m assless at tree level, does not add anything to the mass formula for the electron.

Since the electron cannot be related to any other massive D irac ferm ion, its volume V ( $Q_{electron}$ ) is taken to be 1.

Next consider a red down quark e3.

By gluon interactions,  $e_3$  can be taken into  $e_5$  and  $e_7$ , the blue and green down quarks.

By weak boson interactions, it can be taken into  $e_1$ ,  $e_2$ , and  $e_6$ , the red, blue, and green up quarks.

G iven the up and down quarks, pions can be formed from quark-antiquark pairs, and the pions can decay to produce electrons and neutrinos.

Therefore the red down quark (sim ilarly, any down quark) is related to any part of  $S^7$  R  $P^1$ , the compact manifold corresponding to

and therefore a down quark should have a spinor manifold volume factor V (Q  $_{\rm dow\,n\,quark}$  of the volume of S  $^7$   $\,$  R P  $^1$  .

The ratio of the down quark spinor manifold volume factor to the electron spinor manifold volume factor is just

$$V (Q_{dow n quark}) = V (Q_{electron}) = V (S^7 R P^1) = 1 = 5 = 3$$
: (127)

Since the rst generation graviton factor is 6,

$$m d=m e = 6V (S^7 R P^1) = 2^5 = 612.03937$$
 (128)

As the up quarks correspond to  $e_1$ ,  $e_2$ , and  $e_6$ , which are isomorphic to  $e_3$ ,  $e_5$ , and  $e_7$  of the down quarks, the up quarks and down quarks have the sam  $e_7$  constituent m ass m  $e_8$  = m  $e_8$ .

A ntiparticles have the sam e m ass as the corresponding particles.

Since the model only gives ratios of masses, the mass scale is  $\,$  xed by assuming that the electron mass m  $_{\rm e}=\,0.5110$  M eV .

Then, the constituent m ass of the down quark is m  $_{\rm d}=312.75$  M eV, and the constituent m ass for the up quark is m  $_{\rm u}=312.75$  M eV.

As the proton mass is taken to be the sum of the constituent masses of its constituent quarks

$$m_{proton} = m_u + m_u + m_d = 938.25 M \text{ eV}$$
 (129)

The D  $_4$  D  $_5$  E  $_6$  m odel calculation is close to the experimental value of 938.27 M eV .

The third generation ferm ion particles correspond to triples of octonions. There are  $8^3 = 512$  such triples.

The triple f1;1;1g corresponds to the tau-neutrino.

The other 7 triples involving only 1 and e4 correspond to the tauon:

fe<sub>4</sub>;e<sub>4</sub>;e<sub>4</sub>g;fe<sub>4</sub>;1g;fe<sub>4</sub>;1;e<sub>4</sub>g;f1;e<sub>4</sub>g;f1;1;e<sub>4</sub>g;f1;e<sub>4</sub>;1g;fe<sub>4</sub>;1;1g

The sym m etry of the 7 tauon triples is the same as the sym m etry of the 3 down quarks, the 3 up quarks, and the electron, so the tauon m ass should be the same as the sum of the m asses of the rst generation m assive ferm ion particles.

Therefore the tauon mass 1.87704 GeV.

Note that all triples corresponding to the tau and the tau-neutrino are colorless.

The beauty quark corresponds to 21 triples.

They are triples of the same form as the 7 tauon triples, but for 1 and  $e_3$ , 1 and  $e_5$ , and 1 and  $e_7$ , which correspond to the red, green, and blue beauty quarks, respectively.

The seven triples of the red beauty quark correspond to the seven triples of the tauon, except that the beauty quark interacts w ith 6 Spin (0;5) gravitons w hile the tauon interacts w ith only two.

The beauty quark constituent m ass should be the tauon m ass times the third generation graviton factor 6/2=3, so the B-quark m ass is m<sub>b</sub> = 5.63111 G eV .

Note particularly that triples of the type  $f1;e_3;e_5g$ ,  $fe_3;e_5;e_7g$ , etc., do not correspond to the beauty quark, but to the truth quark.

The truth quark corresponds to the remaining 483 triples, so the constituent mass of the red truth quark is 161/7 = 23 times the red beauty quark mass, and the red T-quark mass is

$$m_t = 129.5155 \,G \,\text{eV}$$
 (130)

The blue and green truth quarks are de ned sim ilarly.

The tree level T-quark constituent m ass rounds o to 130 G eV .

These results when added up give a total mass of third generation ferm ions:

$$f_3 = 1;629 \text{ G eV}$$
 (131)

The second generation ferm ion calculations are:

The second generation ferm ion particles correspond to pairs of octonions.

There are 82 = 64 such pairs.

The pair f1;1g corresponds to the -neutrino.

The pairs  $f1;e_4g$ ,  $fe_4;1g$ , and  $fe_4;e_4g$  correspond to the muon.

Compare the symmetries of the muon pairs to the symmetries of the rst generation ferm ion particles.

The pair  $fe_4$ ;  $e_4$ g should correspond to the  $e_4$  electron.

The other two muon pairs have a symmetry group S2, which is 1/3 the size of the color symmetry group S3 which gives the up and down quarks their mass of 312.75 M eV.

Therefore the mass of the muon should be the sum of the fe $_4$ ;  $e_4$ g electron mass and the f1;  $e_4$ g, fe $_4$ ; 1g symmetry mass, which is 1/3 of the up or down quark mass.

Therefore,  $m = 104.76 \,\mathrm{MeV}$ .

Note that all pairs corresponding to the muon and the -neutrino are colorless.

The red, blue and green strange quark each corresponds to the 3 pairs involving 1 and  $e_3$ ,  $e_5$ , or  $e_7$ .

The red strange quark is de ned as the three pairs 1 and  $e_3$ , because  $e_3$  is the red down quark.

Its m ass should be the sum of two parts: the fe $_3$ ;  $e_3$ g red down quark m ass, 312.75 M eV, and the product of the sym m etry part of the m uon m ass, 104.25 M eV, times the graviton factor.

Unlike the rst generation situation, massive second and third generation leptons can be taken, by both of the colorless gravitons that may carry electric charge, into massive particles.

Therefore the graviton factor for the second and third generations is 6/2 = 3.

Therefore the sym m etry part of the m uon m ass times the graviton factor 3 is 312.75 M eV, and the red strange quark constituent m ass is

$$m_s = 312.75 \,M$$
 eV +  $312.75 \,M$  eV =  $625.5 \,M$  eV

The blue strange quarks correspond to the three pairs involving  $e_5$ , the green strange quarks correspond to the three pairs involving  $e_7$ , and their masses are determined similarly.

The charm quark corresponds to the other 51 pairs. Therefore, the mass of the red charm quark should be the sum of two parts:

the  $fe_1$ ;  $e_1g$ , red up quark m ass, 312.75 M eV; and

the product of the sym m etry part of the strange quark m ass,  $312.75\,\mathrm{M}$  eV , and

the charm to strange octonion number factor 51/9, which product is  $1,772.25\,\mathrm{M}$  eV.

Therefore the red charm quark constituent mass is

$$m_c = 312.75 \,\text{M} \,\text{eV} + 1;772.25 \,\text{M} \,\text{eV} = 2.085 \,\text{GeV}$$

The blue and green charm quarks are de ned sim ilarly, and their masses are calculated similarly.

These results when added up give a total mass of second generation ferm ions:

$$f_2 = 32.9 \,\text{GeV}$$
 (132)

#### 8.3.2 M assless N eutrinos and Parity V iolation

It is required (as an ansatz or part of the D  $_4\,$  D  $_5\,$  E  $_6\,$  m odel) that the charged W  $\,$  neutrino-electron interchange m ust be sym m etric w ith the electron-neutrino interchange, so that the absence of right-handed neutrino particles requires that the charged W  $\,$  SU (2) weak bosons act only on left-handed electrons.

It is also required (as an ansatz or part of the D $_4$  D $_5$  E $_6$  m odel) that each gauge boson must act consistently on the entire D irac ferm ion particle sector, so that the charged W SU(2) weak bosons act only on left-handed ferm ions of all types.

Therefore, for the charged W SU (2) weak bosons, the 4-dimensional spinor elds  $S_8$  contain only left-handed particles and right-handed antiparticles. So, for the charged W SU (2) weak bosons,  $S_8$  can be denoted  $S_{8-L}$ .

The neutral W  $_0$  weak bosons do not interchange W eyl neutrinos with D irac ferm ions, and so m ay not entirely be restricted to left-handed spinor particle elds S  $_8$   $_{\rm L}$ , but m ay have a component that acts on the full right-handed and left-handed spinor particle elds S  $_8$   $_{\rm E}$ .

However, the neutral W  $_0$  weak bosons are related to the charged W weak bosons by custodial SU (2) sym m etry, so that the left-handed component of the neutral W  $_0$  must be equal to the left-handed (entire) component of the charged W .

Since them assofthe W  $_0$  is greater than them assofthe W  $_0$  , there rem ains for the W  $_0$  a component acting on the full S  $_8$   $\,=$  S  $_8$   $_L$  + S  $_8$   $_R$  spinor particle elds.

Therefore the full W  $_0$  neutral weak boson interaction is proportional to  $(m_W^2 = m_{W_0}^2)$  acting on  $S_{8}$   $_L$  and  $(1 (m_W^2 = m_{W_0}^2))$  acting on  $S_{8} = S_{8}$   $_L + S_{8}$   $_R$ .

If (1  $(m_W 2=m_{W_0}^2)$ ) is de ned to be  $\sin_W^2$  and denoted by , and

if the strength of the  $\mathbb{W}$  charged weak force (and of the custodial SU (2) sym m etry) is denoted by  $\mathbb{T}$ ,

then the W  $_{0}$  neutral weak interaction can be written as:

$$W_{OL}$$
 T + and  $W_{OR}$  .

The D  $_4$  D  $_5$  E  $_6$  m odel allows calculation of the W einberg angle  $_{\rm W}$ , by

$$m_{W_{+}} = m_{W} = m_{W_{0}} \cos_{W} \tag{133}$$

The H opf bration of  $S^3$  as  $S^1$ !  $S^3$ !  $S^2$  gives a decom position of the W bosons into the neutral W  $_0$  corresponding to  $S^1$  and the charged pair W  $_+$  and W corresponding to  $S^2$ .

The mass ratio of the sum of the masses of W  $_{+}$  and W  $_{-}$  to the mass of W  $_{0}$  should be the volume ratio of the S  $_{-}^{2}$  in S  $_{-}^{3}$  to the S  $_{-}^{1}$  in S  $_{-}^{3}$ .

The unit sphere  $S^3$  R<sup>4</sup> is normalized by 1=2.

The unit sphere  $S^2$  R<sup>3</sup> is normalized by 1= 9.

The unit sphere  $S^1$   $R^2$  is normalized by  $1=\frac{p}{2}$ .

The ratio of the sum of the W  $_+$  and W  $_-$  m asses to the W  $_0$  m ass should then be (2= 3)V (S²)=(2= 2)V (S¹) = 1:632993.

The sum  $_{\rm m_W}$  = m  $_{\rm W_+}$  + m  $_{\rm W}$  + m  $_{\rm W_0}$  has been calculated to be v  $^{\rm p}$   $_{\rm w}$  = 517:798  $^{\rm p}$   $_{\rm 0.2534577}$  = 260:774 G eV .

Therefore,  $\cos_{w}{}^{2} = m_{W}^{2} = m_{W_{0}}^{2} = (1.632993=2)^{2} = 0.667$ , and

 $\sin_{_{_{_{}}}}{^{2}}=$  0:333, so m  $_{_{_{_{}}}}{^{_{_{}}}}=$  m  $_{_{_{}}}{^{_{_{}}}}=$  80:9 G eV , and m  $_{_{_{}}}{^{_{_{}}}}=$  98:9 G eV .

# 8.4 Corrections for m $_{\rm Z}$ and $_{\rm w}$

The above values must be corrected for the fact that only part of the  $w_0$  acts through the parity violating SU (2) weak force and the rest acts through a

parity conserving U (1) electrom agnetic type force.

In the D  $_4$  D  $_5$  E  $_6$  m odel, the weak parity conserving U (1) electromagnetic type force acts through the U (1) subgroup of SU (2), which is not exactly like the D  $_4$  D  $_5$  E  $_6$  electromagnetic U (1) with force strength  $_E$  = 1=137:03608 =  $\mathrm{e}^2$ .

The W  $_0$  m ass m  $_{\text{W }_0}$  has two parts:

the parity violating SU (2) part m  $_{\rm W}$  , that is equal to m  $_{\rm W}$  ; and

the parity conserving part m  $_{\text{W}}$   $_{\text{00}}$  that acts like a heavy photon.

 $\rm A\,s\,m_{\,W_{\,0}}=98.9\,G\,eV=m_{\,W_{\,0}}+m_{\,W_{\,00}}$  , and as m  $_{\,W_{\,0}}=m_{\,W}=80\,9\,G\,eV$  , we have m  $_{\,W_{\,00}}=18\,G\,eV$  .

Denote by  $_{\text{E}} = e^2$  the force strength of the weak parity conserving U (1) electrom agnetic type force that acts through the U (1) subgroup of SU (2).

The D  $_4$  D  $_5$  E  $_6$  electrom agnetic force strength  $_E$  =  $e^2$  = 1=137.03608 was calculated using the volume V (S  $^1$ ) of an S  $^1$  R  $^2$ , normalized by 1=  $\frac{1}{2}$ .

The  $_{\Xi}$  force is part of the SU (2) weak force whose strength  $_{W}=_{D}W^{2}$  was calculated using the volume V (S<sup>2</sup>) of an S<sup>2</sup> R<sup>3</sup>, normalized by 1= 3.

Also, the D $_4$  D $_5$  E $_6$  electrom agnetic force strength  $_{\rm E}$  =  ${\rm e}^2$  was calculated using a 4-dim ensional spacetim e with global structure of the 4-torus T $^4$  m ade up of four S $^1$  1-spheres,

while the SU (2) weak force strength  $_{\rm w}$  =  ${\rm w}^2$  was calculated using two 2-spheres S<sup>2</sup> S<sup>2</sup>, each of which contains one 1-sphere of the  $_{\rm E}$  force.

Therefore 
$$_{\text{E}}=_{\text{E}}\overset{p}{(2=3)}(2=4)=_{\text{E}}\overset{p}{=6},$$
  $e=e=4$   $6=e=1.565$  , and

the m ass m  $_{\text{W }_{00}}$  m ust be reduced to an e ective value

$$m_{W_{00}eff} = m_{W_{00}} = 1.565 = 18/1.565 = 11.5 \text{ GeV}$$

for the  $_{\rm E}$  force to act like an electrom agnetic force in the 4-dim ensional spacetime of the D  $_4$   $\,$  D  $_5$   $\,$  E  $_6$  m odel:

m  $_{W 00} = em _{Z 0}$ ,

where the physicale ective neutralweak boson is denoted by Z rather than W  $_{\rm 0}\,\text{.}$ 

Therefore, the correct D  $_4\,$  D  $_5\,$  E  $_6\,$  values for weak boson m asses and the W einberg angle are:

$$m_{W_{+}} = m_{W} = 80.9 \,\text{GeV};$$
  
 $m_{Z} = 80.9 + 11.5 = 92.4 \,\text{GeV};$  and  
 $\sin_{W}^{2} = 1 \quad (m_{W} = m_{Z})^{2} = 1 \quad 6544.81 = 8537.76 = 0.233.$ 

Radiative corrections are not taken into account here, and may change the D  $_{\rm 4}$  D  $_{\rm 5}$  E  $_{\rm 6}$  value som ew hat.
