# PHENOM ENOLOGICAL IM PLICATIONS OF SUPERSYMMETRY IN LEFT-RIGHT ELECTROW EAK MODEL

#### ABSTRACT

The basics of a supersym m etric SU  $(2)_L$  SU  $(2)_R$  U  $(1)_B$  L m odel are reviewed. The production and subsequent decays of the doubly charged triplet higgsino  $\sim$  in the N ext L inear C ollider are discussed. The slepton pair production in the fram ework of this model is also analysed.

## 1. Introduction

D espite of the success of the Standard M odel (SM ) there are still unsolved problems in particle physics which m otivate searches for m ore fundam ental theories. O ne of the m ost appealing extensions of the SM is the left-right sym m etric m odel based on the gauge group SU (2)<sub>L</sub> SU (2)<sub>R</sub> U (1)<sub>B L</sub> <sup>1</sup>. Am ong m any attractive features of this m odel is its capability to explain the lightness of the ordinary neutrinos via so called see-saw mechanism <sup>2</sup> which occurs naturally due to the dynam ical treatment of both left and right handed elds. Indeed, the anomalies measured in the solar <sup>3</sup> and atmospheric <sup>4</sup> neutrino uxes as well as the COBE observation <sup>5</sup> of the existence of the hot component of dark matter seem to indicate that neutrinos could have a small non-vanishing mass. A nother peculiar feature of the model is the existence of lepton number violating interactions, partly due to the massive Majorana neutrinos and partly because of doubly charged components of triplet Higgs elds which carry lepton number two.

On the other hand the left-right sym m etric m odelsim ilarly to the SM  $\,$ su  $\,$ ers from the hierarchy problem : the m asses of the H iggs scalars diverge quadratically. As in the SM , supersym m etry can be used to cure this problem .

Here we shall consider a minimal susy left-right model where the number of Higgs elds is the smallest possible  $^6$ . In particular we shall discuss how one can test the model in future collider experiments. Since the doubly charged triplet higgsinos give the most distinctive experimental signature we shall study the triplet higgsino production in possible e e;  $e^+e^-$ ; e and options of the Next Linear Collider (NLC)  $^7$ . If the doubly charged higgsino is too heavy to be produced in the NLC we shall study how its extra contribution as a virtual intermediate state would a ect the selectron production in  $e^+e^-$  collisions.

## 2. A supersym m etric left-right m odel

The minimal set of Higgs elds in the non-susy left-right model consists of a bidoublet  $_{\rm u}$  and a SU  $(2)_{\rm R}$  triplet . In supersymmetrization, the cancellation of chiral anomalies among the fermionic partners of the triplet Higgs elds requires introduction of the second triplet  $_{\rm u}$  with opposite U  $(1)_{\rm k}$   $_{\rm L}$  quantum number. Due to the conservation of the B  $_{\rm u}$  symmetry does not couple to leptons and quarks. In order to avoid a trivial K obayashi-M askawa matrix for quarks, also another bidoublet  $_{\rm d}$  should be added to the model. This is because supersymmetry forbids a Yukawa coupling where the bidoublet appears as a conjugate.

W e have chosen the vacuum expectation values for the H iggses, which break the SU (2)\_L SU (2)\_R U (1)\_B  $_{\rm L}$  into the U (1)\_{em} , to be as follows

Here  $_{\rm u,d}$  are of the order of the electroweak scale  $10^2$  GeV. The vev v of the triplet Higgs has to be much larger in order to have the masses of the new gauge bosons W  $_2$  and Z  $_2$  su ciently high  $^8$ . W ith the choice (1) of the vev's the charged gauge bosons do not mix and W  $_{\rm L}$  corresponds to the observed particle.

W e assum e the superpotential to have the following form:

Here  ${}_{L\,(R)}^b$  stands for the doublet of left (right)-handed quark super elds,  ${}_{L\,(R)}^b$  stands for the doublet of left (right)-handed lepton super elds,  ${}_{u}^b$  and  ${}_{d}^b$  are the two bidoublet Higgs super elds, and  ${}^{b}$  and  ${}^{b}$  the two triplet Higgs super elds.

In the superpotential (2) the R-parity,  $R=(1)^{3(B-L)+2S}$ , is preserved. This ensures that the susy partners with R=1 are produced in pairs and that the lightest supersym metric particle (LSP) is stable. In order to preserve the naturalness of the theory the supersym metric mass parameters  $_i$  should be close to the scale of the soft supersym metry breaking<sup>9</sup>. We assume here that the parameters  $_j$  if are of the order of the weak scale.

We are especially interested in the doubly charged ferm ions occurring in the Higgs triplet super elds. Their mass matrix is particularly simple, since doubly charged higgsinos do not mix with gauginos. The triplet higgsinos, like the triplet Higgses, carry lepton number two and therefore the nal state of their decay must also have even lepton number in the case of R-parity conservation.

There are ve charginos  $_{j}$  and nine neutralinos  $_{i}^{0}$  in this model. The physical particles  $\sim_{i}$  and  $\sim_{i}^{0}$  are found by diagonalization of the mass Lagrangian:

The masses of the particles depend on the following parameters: the soft gaugino masses, the supersymmetric Higgs masses  $_1$  and  $_2$ , the vacuum expectation values  $_u$ ,  $_d$ , and  $_v$ , and the gauge coupling constants. We have calculated numerically the composition of neutralinos and charginos for dierent values of the parameters. The neutralinos are Majorana particles, whereas the charginos combine together to form Dirac fermions. For our numerical calculations we have always taken  $g_R = g_L = 0.65$ ; h = 0.3; h =

The m ixing of the left and right selectrons is assumed to be negligible and their m asses m  $_{\rm eL}$  and m  $_{\rm eR}$  are taken to be equal.

#### 3. Tests of the model in the NLC

The allowed decay modes of the triplet higgsinos are

In large regions of the parameter space, the kinematically favoured decay mode is  $^{\rm ++}$ ! I' l' . As the masses of and W  $_2$  are of the order of the SU (2) $_{\rm R}$  breaking scale v  $^{\rm 10}$ , the rst three decay channels are kinematically forbidden in our case of the relatively light triplet higgsinos. In the following we shall assume that  $^{\rm ++}$  decay in 100% into the II nal state.

The charged sleptons I can decay as follows:

The decay mode (8) is kinematically disfavoured and we do not consider it. The decay of the the right-slepton into the neutrino channel will in general be kinematically disfavoured because of the heaviness of the right-handed neutrino. In Fig. 1 the branching ratios of the dierent channels are plotted as the function of the left-slepton and right-slepton masses. For the left-slepton decay the channel (7) becomes dominant immediately when the slepton mass exceeds the mass of the lightest chargino. The chargino has several decay channels, e.g. into a lepton-slepton pair, a W -chargino pair, and a quark-squark pair.

The NLC will, besides the usual  $e^+e^-$  option, be able to work also in  $e^-e^-$  and collision modes. In these collisions the doubly charged higgsinos  $e^-$  can be produced through the following processes:

We have chosen these reactions for investigation because they all have a clean experim ental signature: a few hard leptons and m issing energy. Futherm ore, they all have very small background from other processes. The fact that  $^{\sim}$  carries two units of electric charge and two units of lepton number and that it does not couple to quarks makes the processes (9) - (12) most suitable and distinctive tests of the susy left-right model.

Reaction  $e^+e$ !  $^{-++}$ 

The triplet higgsino pair production in  $e^+e^-$  collision occurs through the diagram s presented in Fig. 2. In contrast with the triplet Higgs elds whose mass is in the TeV scale  $^{10}$ , the mass of the triplet higgsino is given by the susy mass parameter  $_2$ ; which is a free parameter. As we mentioned before, for the reason of naturality its value should not dier too much from the electroweak breaking scale, i.e.  $_2$  = 0 ( $10^2$  G eV).

In Fig. 3 the total cross section for the process (9) is presented as a function of the mass of  $^{\sim}$  for the collision energy of  $^{\rm P}$   $\bar{\rm s}=1$  TeV and for two values of the selectron mass, m  $_{\rm I}=200$  GeV and 400 GeV. As can be seen, the cross section for these parameter values is about 0.5 pb and it is quite constant up to the threshold region. To have an estimate for the event rate, one has to multiply the cross section with the branching ratio of the decay channel of the produced higgsinos used for the search. As pointed out earlier, the favoured decay channel may be




Figure 5: Total cross section for the reaction e e !  $\sim^0$  as a function of the higgsino m ass m  $\sim$  for two values of selectron m ass m  $\sim$  at the collision energy 1TeV.

Here I can be any ofe; and with practically equal probabilities. The signature of the pair production reaction (9) would be the purely leptonic nal state associated with missing energy. In the SM a nal state consisting of four charged leptons and missing energy can result from cascade decays. In the susy left-right model there are, however, some unique nal states not possible in the SM, namely those with non-vanishing separate lepton numbers.

## Reaction e e ! $\sim^0$

The production of the triplet higgsino  $^{\sim}$  in electron (electron collision occurs via a selectron exchange in t-channel (see Fig. 4). In Fig. 5 the cross section is presented as a function of M  $^{\sim}$  for two values of the selectron m ass, m  $_{\rm e}=200~{\rm GeV}$  and 500 GeV, at the collision energy  $^{\rm h}$  s = 1 TeV. It is taken into account that the nal state neutralino m ass is related to the triplet higgsino m ass as they both depend on the parameter  $_2$ . The signature of the reaction is a same-sign lepton pair created in the cascade decay (13) of  $^{\sim}$ , associated with the invisible energy carried by neutralinos. The two leptons need not be of the same avour since the j L j = 2

Yukawa couplings are not necessarily diagonal. This may be useful for distinguishing the process from the selectron pair production e e! e e! e e + neutralinos, which is the leading process for the selectron production in the susy version of the Standard Model. In the SM the nal states e, e and are forbidden.

## Reaction e ! 1 ~

The mechanism of producing high-energy photon beams by back-scattering high intensity laser pulses of the high energy electron beams proposed by G inzburg et al. label al. It allows the NLC to operate also as a photon collider. There are three Feynman diagrams contributing to the photoproduction reaction (11): electron exchange in s-channel, selectron exchange in t-channel and triplet higgsino exchange in t-channel (see Fig. 6). In Fig. 7 the total cross section is presented as a function of the triplet higgsino mass for the electron-electron center of mass energy  $\frac{P}{S_{ee}} = 1 \text{ TeV}$ . The cross section is determined by convoluting the photon energy distribution P (y), i.e.  $(S_{ee}) = \frac{P}{P} = \frac{P}$ 

The experimental signature of the reaction is three lepton nal state associated

with missing energy. The positive lepton is any lepton, and the two negative ones can be any combination of the electron, muon and tau, provided the triplet higgsino coupling is not diagonal. A suitable choice of the nal state will cut down the SM background coming e.g. from the reaction e  $\,$ ! e Z . The cross section is above 0 (100 fm ) for a large range of the masses M  $_{\circ}$  and m  $_{\rm e}$ , providing hence a good potential for the discovery of  $^{\sim}$  .

## Reaction ! ~++ ~

This reaction is an alternative of, but not competitative with, the reaction (9) for producing a doubly charged higgsino pair. Feynm an diagram of the process is presented in Fig. 8. Because the photon energies are not monochromatic but broadly distributed, no sharp threshold will be visible in the production cross section. Moreover, the maximum collision energy will be some 20% less than the e<sup>+</sup>e energy. On the other hand, the only unknown parameter in the process is the mass Mass the couplings are completely determined by the known electric charge of the higgsino. The cross section of the reaction as a function of Mass given in Fig. 9 for the collision energy  $\frac{P}{S_{ee}} = 1$  TeV. The experimental signature of the reaction will be of course the same as for the process (9), i.e. four charged leptons associated with missing energy. The cross section is large because of the photon coupling to electric charge.

## Slepton pair production




Figure 10: Feynm an diagram s for the slepton pair production in electron positron collisions.

If the doubly charged higgsinos turn out to be too heavy to be produced in the NLC one can study their possible contributions as the intermediate virtual particles to the production of lighter susy particles. One such process is the slepton pair production (see Fig. 10)

where  $I; I^0 = e; \sim; \sim$ . Experimentally, the slepton pair production is possibly one of the 1st susy processes to be seen since sleptons are supposed to be relatively light among the superpartners of the ordinary particles. Compared with the MSSM there

is one extra s-channel diagram involving the heavy neutral gauge boson  ${\bf Z}_2$ ; ve extra t-channel diagram s due to the larger number of neutralinos and one new u-channel diagram in our model.

In Fig. 11 we present the total cross section of the selectron pair production as a function of the selectron mass m<sub>e</sub> for a xed triplet higgsino mass M<sub>~</sub>. Fig. 11a corresponds to the situation at LEP200 with  $\frac{P}{s} = 200$  GeV (here M<sub>~</sub> = 110 GeV) and Fig. 11b at a linear collider with  $\frac{P}{s} = 1$  TeV (M<sub>~</sub> = 300 GeV).

The cross sections in the two left-right symmetric model cases dier slightly because in LRM I the t-channel processes are supressed since the higgsino couplings are small, in LRM II there is no such suppression. For comparison we have plotted in Fig. 11 also the corresponding cross section in the MSSM I (II). As one can see, the cross sections in the susy left-right model are systematically appreciably larger than in the MSSM. This is due to two factors, ratly the number of gauginos is larger and secondly the triplet higgsino contribution is large, though dependent on the unknown triplet higgsino coupling to the electron and selectron.

The most intriguing dierence between the susy left-right model and the MSSM

with respect to the slepton pair production is the existence of the u-channel process of Fig. 10c. This reaction occurs only for a right-handed electron and a left-handed positron, whereas in the s- and t-channel processes all chirality combinations may enter. Use of polarized beams could therefore give us more information of the triplet higgsino contribution. Assuming that the decay mode e! e $^0_1$  is dominant, we present in Fig. 12 the angular distribution of the nal state electron e in the case the electron is right-handedly and positron left-handedly polarized (P+) and in the opposite case (P+) for  $\bar{s}=1$  TeV, me = M = 300 GeV. In model LRM I (Fig. 12a) the t-channel contributions are suppressed since the light neutralinos are mainly consisting of the higgsinos. The distribution P+ is larger and it is slightly peaked in the backward direction because of the u-channel contribution. In model LRM II (Fig. 12b) both t-channel (forward peak) and u-channel (backward peak) contributions are observable. The latter is absent in the M SSM, of course.

In the M SSM with the uni cation assumption the right-selectron is lighter than the left-selectron  $^{12}$ . If only  $\textbf{e}_{R}$  's are produced, the dierence between the M SSM and the supersymmetric left-rightm odelwould be especially large and observable in the NLC .

#### 4. Conclusions

Phenom enologically them ost intriguing prediction of the supersymm etric SU  $(2)_L$  SU  $(2)_R$  U  $(1)_B$  L m odel is the existence of doubly charged higgsino  $^{*++}$ . It carries two units of lepton number and it has a clear decay signature: two same sign leptons, which are not necessarily the same type, and the missing energy. The production

cross sections of  $^{\sim ++}$  in  $e^+e$ , e e, e and collision modes of the NLC are at the level of pb. Its contribution to the slepton pair production processes should be observable in angular distributions of the process.
