Higgs Boson Production in e^+e ! + bb

Abstract

The production of the Standard M odel Higgs boson in the fourferm ion reaction e⁺e ! ⁺ bb is studied. The complete tree-level m atrix element, including signal and backgrounds in the standard electrow eak theory, is computed and initial state radiation is taken into account in the leading-log approximation. A M onte C arlo event generator has been built and numerical results for some distributions of experimental interest for the search of the Higgs particle at future electron-positron colliders are shown, compared with those existing in the literature and commented.

A fler the experimental conmations of the standard theory of the electroweak interaction provided by the precision tests at LEP/SLC [1] and by the evidence of top quark production at the TEVATRON [2], the search for the Standard M odel H iggs boson becomes a primary task of the experiments planned at future electron-positron and hadron colliders. For the case of a light or intermediate H iggs particle (M_H $2M_W$), the B jorken brem sstrahlung process e⁺ e ! H Z is known to be the main production mechanism at e⁺ e colliders up to 0.5 TeV [3]. Detailed studies about the production of the H iggs boson in e⁺ e collisions are given in Refs. [4, 5]. From these investigations it emerges that the speci c four-ferm ion reaction

provides the cleanest event signature coupled with \small" backgrounds.

A complete tree-level calculation of the four-ferm ion process (1), including all possible diagrams and their interferences, has been performed in two recent papers [6, 7]. On the one hand, in Ref. [6] a M onte C arb approach has been adopted but the e ect of the initial state QED corrections, large and hence necessary for the data analysis, has been neglected; on the other hand, initial state radiation has been included in [7], but according to a sem i-analytical procedure which is limited from the point of view of event simulation purposes. The aim of this letter is to present a M onte C arb event generator for the process $e^+e^-l^+$ bb based on the calculation of the full set of diagram s contributing in the standard electroweak theory to the assigned four-ferm ion nal state and on the inclusion of initial state QED corrections in the leading-log approximation. We will only sketch the basic theoretical ingredients, putting m ore emphasis on the phenom enological aspects of the study and on the potentials of a \specialized" event generator for future searches of the Higgs boson at LEP2 and NLC energies.

The kinematics of the 2! 4 process at the Born level has been treated according to the general recipe for a four-ferm ion nal state described in [8]. E sentially, seven independent dimensionless quantities are introduced and chosen, together with a trivial overall azim uthal angle, as independent variables from which the full four-momenta of the outgoing particles are reconstructed in the laboratory frame by explicit solution of the kinematics.

The inclusion of initial state radiation is simply achieved by dressing the incoming leptons with QED structure functions [9]. They allow to include,

by virtue of factorization theorem s, the long-distance universal contributions in soft and/or collinear approximation.

Taking into account the initial state radiation, the total cross section can be expressed as a nine-fold convolution of the form

where dPS] denotes the volum e element in the 7-dimensional phase space connected to the independent variables of the hard scattering reaction in the cm. frame. The scale of the hard scattering cross section is the reduced cm. energy $s = x_1 x_2 s$ which is the main e ect of the initial state radiation together with the boost of the cm. frame with respect to the laboratory one, which is also taken into account by properly rescaling the independent variables of the hard kernel cross section in the cm. frame.

In the kernel cross section the complete set of tree-level diagram s contributing in the Standard M odel to $e^+e^-!$ bb is included. Twenty-ve diagram s have to be computed and they can be classified as follows:

the signal diagram $\stackrel{*}{\bullet}$ e $\,$! H Z followed by the decays H $\,$! bb and Z $\,$! $\,$ ^+ $\,$;

the eight t channel diagram s relative to ZZ; ; ; Z exchange;

the sixteen s channel diagram s corresponding to the brem sstrahlung of a neutral vector boson from the ferm ionic nal states (radiative processes).

Each am plitude has been computed by means of SCHOONSCHIP [10] within the helicity am plitude form alism [11] following the general strategy described in [8]. This allows to express the kernel cross sections essentially as the sum of products of resonating propagators with functions of the dimensionless variables originating from the calculation of the traces of the matrices' strings. M ass corrections have been neglected in the kinematics and in the calculation of the am plitudes. These contributions introduce terms of the order of m_b^2 =s which at LEP2 energies am ount to about 0.1% and hence they can be neglected as long as the ratio signal / background is larger than som e per cent. To take care of the peaking behaviour of the integrand the M onte C arlo event generation is treated according to the importance sampling technique[12]. The latter is applied, by m eans of proper changes of variables, to the exponentiated infrared sensitive part of the structure functions, to the di erent propagators' \singularities" (particularly to the H iggs propagator which resembles for its very narrow width a delta-like function) and nally to the jacobian peaks appearing in the phase space factor. In particular, the weights w_i and $W = \begin{bmatrix} 1 & 0 \\ 0 & 0 \end{bmatrix}$ is introduced to obtain a proper sampling of the double propagator \singularities" of the signal (Z H) and the backgrounds (Z Z , Z and in all possible combinations).

Let us show and comment some results obtained with our event generator based on the random number generator RANLUX [13]. The input parameters used are: $M_z = 91:1887 \text{ GeV}$, z = 2:4974 GeV, $M_w = 80:22 \text{ GeV}$, $m_b = 4:7 \text{ GeV}$ [14]. For the Higgs boson width the tree-level expression is adopted.

In Fig. 1a the total cross section in Born approximation is compared with the initial state QED -corrected one as a function of the cm . energy and for three di erent values of the Higgs mass. The dashed, dash-dotted and closely dotted lines represent the lowest-order results for $M_{H} = 65;100;140 \text{ GeV}$, respectively; the three solid lines refer to the above H iggs m ass values and include the e ect of the leading-bg initial state QED corrections. As a reference curve, the QED corrected total cross section obtained by excluding the Higgs boson contribution is also shown (sparsely dotted line). Cuts on the invariant masses of the + and bb pairs of M $_{+}$ 12 GeV and 12 GeV (typically used in other num erical studies [6, 7]) are applied M_{bb} in order to reduce a large fraction of the background. The values obtained for the cross sections with our event generator have been compared in detail (i.e. for di erent Higgs masses and cm. energies) with the independent results of R efs. [6, 7] and found to be in good agreem ent. It should be noted that in the LEP2 energy range the size of the total cross section ofthe + bb reaction can give by itself evidence of H iggs boson production in the $\light m ass"$ interval 65 GeV М_н 100 GeV (see also Fig. 1b), whereas for higher Higgs mass values a cm. energy larger than 200 GeV is necessarily required to distinguish the signal from the background. This feature, already pointed out in Ref. [6] for the lowest-order cross section, is not largely a ected by initial state brem sstrahlung which essentially lowers the peak cross section of about 10% and originates a m oderate radiative tail at high energies (s 300 GeV), as generally occurs for other \double

resonant" processes (W W;ZZ) above threshold. Moreover, the two-peak shape for $M_{\rm H} = 65$ GeV and $M_{\rm H} = 140$ GeV is made more at by e ect of the initial state radiation, which how ever does not cancel the two-bum p structure. Their appearing is given, with very good approximation, by the incoherent sum of the signal and backgrounds diagram s. In agreement with Ref. [6], we checked that the interference term sbetween diagram swith dierent intermediate bosons and also s channel radiative processes give a small contribution.

Figure 1b shows the ratio $_{s}=_{f}$ as a function of the Higgs mass and for three di erent energies of interest at LEP2. $_{s}$ denotes the signal cross section and $_{f}$ stands for the full four-ferm ion cross section including signal and backgrounds. The e ect of the initial state radiation is included in this plot. As already singled out by Fig. 1a, for the case of a light Higgs mass ranging between, say 65 G eV and 80 G eV, the ratio $_{s}=_{f}$ turns out to be m ore favourable for \low" centre of m ass energies; on the contrary \high" centre of m ass energies maintain the ratio m ore at and sensitive to a Higgs m ass up to, say, 100–110 G eV.

In Figs. 2-5 we show some realistic distributions of experim ental interest for the Higgs search at LEP2. These results have been obtained processing the n-tuple created by the event generator at $rac{1}{s} = 205 \text{ GeV}$. The full set of tree-level diagram s and the contribution of the initial state radiation have been taken into account in the simulation. A sample of 10^4 four-ferm ion events has been generated in order to study with small statistical error the behaviour of the distributions when varying the Higgs mass. A lthough di erent cross sections correspond to di erent Higgs mass values, the sam e num ber of events has been considered in order to study the pattern of evolution of the shapes while varying the Higgs mass. The bb invariant mass distribution (Fig. 2), the b quark scattering angle distribution (Fig. 3) and the bb relative angle distribution (Fig. 4) turn out to be useful observables to detect a Higgs signal and, if found, extract information on the quantum numbers assignment. From Fig.2 it can be seen that the bb system invariant mass distribution exhibits two clear spikes positioned at M $_{\rm H}\,$ and M $_{\rm Z}$, as long as M_{H} < say 110 GeV, the spike at M_{H} resembling a delta-like function. The rise at low invariant m asses is due to ! boin and Z diagram s. From Fig. 3 it can be seen that the b quark angular distribution shows, for the case of a light m ass H iggs where the signal dom inates the + bb cross section, a clearly isotropic spin-zero behaviour gradually disappearing as increasing the

H iggs mass. The bb relative angle distribution represented in Fig. 4 shows a two-peak structure. The peak positioned at lower $\cos \#_{bb}$ relates the presence of ZZ diagram s, while the (much smaller) one at $\cos \#_{bb}$ 1 com es from

! bb in the and Z contributions. The peak at interm ediate $\cos \#_{bb}$, well visible in the case of a light m ass H iggs, corresponds to the contribution of the signal diagram. The di erent position of the H iggs peak in the twobump shape is a consequence of the di erent Lorentz boost acting on the H iggs boson depending on its m ass value. The residual bump at interm ediate $\cos \#_{bb}$ for M_H = 140 G eV com es from Z ! bb in the Z contributions. F igure 5 shows two typical photon energy distributions (for M_H = 65 G eV and 140 G eV, respectively) where the peak at very low energies is due to dom inating soft multiphoton em ission.

To sum marize, we presented the results of a M onte C arb event generator for the four-ferm ion reaction $e^+e^-l^-$ bb, including all the Standard M odel diagram s and the e ect of initial state radiation in the leading-log approximation.
