Precision Corrections to Supersymmetric Unication

A bstract

We compute the full set of weak-scale gauge and Yukawa threshold corrections in the minimal supersymmetric standard model, including all nite (non-logarithmic) corrections, which we show to be important. We use our results to examine the elects of unication-scale threshold corrections in the minimal and missing-doublet SU (5) models. We work in the context of a unied mass spectrum, with scalar mass M $_{0}$ and gaugino mass M $_{1=2}$, and nd that in minimal SU (5) with squark masses less than one TeV, successful gauge and Yukawa coupling unication requires M $_{1=2}$ M $_{0}$ and M $_{0}$ ' 1 TeV. In contrast, we nd that the missing-doublet model permits gauge and Yukawa unication for a wide range of supersymmetric masses.

1 Introduction

With the advent of precision measurements at LEP and the observation that the gauge couplings unify in the minimal supersymmetric standard model [1], there has been a resurgence of interest in supersymmetric grand unied theories. In most analyses the values of the electromagnetic coupling, $_{\rm EM}$, and the standard-modelweak mixing angle, $s_{\rm SM}^2$ sin $s_{\rm SM}^2$ such that the leading-logarithmic contribution to the supersymmetric threshold corrections. The $s_{\rm SM}^2$ parameters are then used to determine the $s_{\rm SM}^2$ strong coupling constant at the Z-scale, $s_{\rm SM}^2$, ignoring all unication-scale threshold corrections. Alternatively, the measured value of $s_{\rm SM}^2$ is used to constrain the unication-scale parameter space.

In this letter we will take a closer look at this procedure, and report on the results of a complete next-to-leading-order analysis of supersym metric unication. Our approach is new in two respects. First, we include all nite corrections. This implies that our weak mixing angle $\2 is related to $\$^2_{\text{SM}}$ as follows,

where the leading logarithm s are of the form \log (M $_{\rm SU\,SY}$ =M $_{\rm Z}$) and the nite corrections are of order M $_{\rm Z}$ =M $_{\rm SU\,SY}$. If all the superpartner m asses are heavier than a few times M $_{\rm Z}$, the nite corrections are negligible, in accord with the decoupling theorem . However, realistic supersymmetric models typically have light particles with masses near M $_{\rm Z}$, so the nite corrections can be significant.

Second, we do not use a combined-t value of $s_{\rm SM}^2$ to compute \hat{s}^2 because the nite term in eq. (1) is dierent for each observable. Therefore, in our analysis, we calculate \hat{s}^2 directly from a given set of inputs, namely, the Fermi constant G_F , the Z-boson mass M_Z , the electromagnetic coupling E_M , the top-quark mass E_M , and the parameters that describe the supersymmetric model. (See also ref. [2].)

We emphasize that a precise evaluation of $\2 is essential because the renormalization group equations (RGE's) can naturally amplify small corrections. For example, the one-loop renormalization group equations, $d\$_i=dt=$ $_i\$_i^3=16$ 2 , together with gauge coupling unication, imply

In what follows, we will brie y describe our calculation of $^{\circ}$ and $\2 . We will then exam ineour prediction for $_{s}$ (M $_{z}$) in the supersymmetric parameter space. We will not the

uni cation-scale threshold corrections that are necessary for gauge coupling uni cation with a given supersymmetric spectrum, and compare our results with the threshold corrections that arise in the minimal and missing-doublet SU (5) models. We will close with a similar analysis under the additional assumption of bottom -tau Yukawa uni cation.

2 Gauge Coupling Unication

We start by sketching our calculation of the \overline{DR} gauge parameters \hat{g}_1 (M $_Z$) and \hat{g}_2 (M $_Z$). As discussed above, we take as inputs the Ferm i constant $G_F=1:16639-10^5$ GeV $_Z^2$, the Z-boson m ass M $_Z=91:187$ GeV, the electrom agnetic coupling $_{EM}=1=137:036$, the top-quark m ass m $_{t}$, and the supersym m etric parameters. From these we calculate the electrom agnetic coupling $_{DR}^2$ and the weak m ixing angle \hat{s}_2^2 in the \overline{DR} renormalization scheme,

Equation (5) includes the light quark contribution extracted from experimental data [4], together with the leptonic contribution. It also contains the logarithms of the W-boson, top-quark, charged-Higgs, squark, slepton, and chargino masses. In eq. (6), the $^{^{^{^{\circ}}}}$ denote the real and transverse parts of the gauge boson self-energies, evaluated in the \overline{DR} scheme. Equation (6) also includes the vertex and box contributions that renormalize the Fermi constant, as well as the leading higher-order m $_{\rm t}^4$ and QCD standard-model corrections given in ref. [5]. (For a complete description of our calculation see ref. [6]. Note that in this letter, all hatted objects are \overline{DR} quantities, and all masses are pole masses.)

From these results we not the weak gauge couplings \hat{g}_1 (M $_Z$) and \hat{g}_2 (M $_Z$) using the $\overline{\rm D\,R}$ relations

where $^{\circ}$ = \hat{e}^2 =4 . These couplings serve as the weak-scale boundary conditions for the two-loop supersymm etric RGE's. They implicitly determine the unication scale M $_{\rm GUT}$ through the condition \hat{g}_1 (M $_{\rm GUT}$) = \hat{g}_2 (M $_{\rm GUT}$) = \hat{g}_{1} UT.

We x the strong coupling \hat{g}_3 (M $_{\text{GUT}}$) at the scale M $_{\text{GUT}}$ by the unication condition

where $_g$ parametrizes the model-dependent unication-scale gauge threshold correction. We then run \hat{g}_3 (M $_{GUT}$) back to the Z-scale to nd the \overline{MS} coupling

where s denotes the weak-scale threshold correction

This procedure allows us to determ ine $_s$ (M $_z$) for a xed $_g$ and a given supersym m etric spectrum. In what follows, we will make the additional assumption that the supersym metric spectrum unies as well. Therefore we also assume that the three gaugino masses unify to a common value of M $_{1=2}$ (M $_{\rm GUT}$), the scalar masses unify to a common scalar mass M $_0$ (M $_{\rm GUT}$), and the soft trilinear scalar coupling parameters unify to A $_0$ (M $_{\rm GUT}$).

We evolve the parameters M $_{1=2}$; M $_0$ and A $_0$ to the weak scale using the two-loop supersymmetric RGE's [7]. We require the parameters to be such that electroweak symmetry is spontaneously broken, as naturally occurs when the top-quark m ass is large. Then the H iggs bosons H $_1$ and H $_2$ acquire expectation values v_1 ? (M $_Z$) and v_2 ? (M $_Z$); their ratio is denoted tan ran (M $_Z$) = v_2 = v_1 .

We extract the supersymmetric masses from the running DR parameters and tanathe scale M $_{\rm Z}$. (We choose > 0, where the superpotential contains the term + $_{\rm ij}$ H $_{\rm 1}^{\rm i}$ H $_{\rm 2}^{\rm j}$; with $_{\rm 12}$ = +1.) We then substitute these masses into eqs. (4) { (6), and repeat the entire procedure to and a self-consistent solution to the renormalization group equations. Typically, the process converges after only a few iterations. It allows us to predict $_{\rm S}$ (M $_{\rm Z}$) consistently, including all nite corrections.




Figure 1: Contours of $_{\rm S}$ (M $_{\rm Z}$) in the M $_{\rm 0}$, M $_{\rm 1=2}$ plane with m $_{\rm t}$ = 170 GeV , tan =2 and A $_{\rm 0}$ = 0. The region m $_{\rm q}$ < 1 TeV is bounded by M $_{\rm 1=2}$ < 400 GeV and M $_{\rm 0}$ < 1 TeV .

As a point of reference, we show in Fig. 1 our results for $_{\rm s}$ (M $_{\rm Z}$) in the M $_{\rm 0}$, M $_{\rm 1=2}$ plane, in the absence of unit cation threshold corrections, for m $_{\rm t}$ = 170 G eV, tan = 2, and A $_{\rm 0}$ = 0. Comparing with the experimental value $_{\rm s}$ (M $_{\rm Z}$) = 0:117 :005 [8], we see that $_{\rm s}$ (M $_{\rm Z}$) is rather large. If, for naturalness, we require the squark m asses to be below 1 TeV, we obtain the lower bound

assum ing the validity of perturbation theory, which we take to mean that the \overline{DR} top-quark Yukawa coupling $\hat{t} (M_{GUT})$ 3. If we tighten this condition to $\hat{t} (M_{GUT})$ 1, the bound increases by 0.002. For smaller m_t, _s (M_Z) is smaller. For example, if m_t = 160 GeV, the limit reduces by 0.002. These variations apply independently of the unication-scale thresholds. Our numbers agree qualitatively with the results of ref. [2].




Figure 2: The $\overline{\text{MS}}$ coupling $_{\text{S}}$ (M $_{\text{Z}}$) vs. M $_{1=2}$. The curve labeled LLA shows the result if we include only the logarithm s of the supersymmetric masses (the leading logarithm approximation), while the solid line corresponds to the full result including all nite corrections.

The values of $_{\rm S}$ (M $_{\rm Z}$) quoted here are larger than in many previous analyses for two reasons. First, during the past few years the central value of $\rm s_{SM}^2$, as determined from precision electroweak measurements, has been decreasing. (This change is correlated with the increasing best-t value of $\rm m_{t}$.) A smaller value of $\rm s_{SM}^2$ leads to an increase in $_{\rm S}$ (M $_{\rm Z}$), as can be seen from eq. (3). Second, the nite corrections decrease $\rm s_{s}^2$, and therefore increase $\rm s_{s}^2$ (M $_{\rm Z}$). The nite corrections are important in the region M $\rm _{1=2}$ < 200 GeV where $\rm _{S}$ (M $\rm _{Z}$) is appreciably larger than in the leading logarithm ic approximation, as shown in Fig. 2.

O feourse, the value of $_{\rm s}$ (M $_{\rm Z}$) can be reduced by a uni cation-scale threshold correction with $_{\rm g}$ < 0. In the m in im al SU (5) m odel [9], the uni cation-scale gauge threshold correction is [10]

where M $_{\rm H_{\,3}}$ is the mass of the color-triplet H iggs ferm ion that mediates nucleon decay. From this expression, we see that $_{\rm g}^{\,0}$ < 0 whenever M $_{\rm H_{\,3}}$ < M $_{\rm GUT}$. However, M $_{\rm H_{\,3}}$ is bounded from below by proton decay experiments, so $_{\rm g}^{\,0}$ > 0 throughout most of the parameter space.

In m in im al SU (5) we not that the sm allest possible values for $_{\rm S}$ (M $_{\rm Z}$) are typically even larger than those in Fig. 1. The only exception occurs for M $_{\rm 0}$ M $_{\rm 1=2}$, where the proton decay amplitude is suppressed. This determ ines the lower lim it

assuming $\hat{}_t(M_{GUT})$ 3. In fact, as long as m_q 1 TeV, $_s(M_Z)$ < 0:127 can only be obtained in the region M $_0$ ′ 1 TeV . For example, if M $_0$ 500 GeV, $_s(M_Z)$ > 0:128.

The m issing-doublet model is an alternative SU (5) theory in which the heavy color-triplet Higgs particles are split naturally from the light Higgs doublets [13]. In this model the uni cation-scale gauge threshold can be written as [14]

Thus, for xed M $_{\rm H_{\,3}}$, the m issing-doublet m odel has the same threshold correction as the m in im al SU (5) m odel, m inus 4%. In eq. (12), M $_{\rm H_{\,3}}^{\rm e}$ is the elective m assithat enters into the proton decay amplitude, so the bounds on M $_{\rm H_{\,3}}$ in the m in im al SU (5) m odel also apply to M $_{\rm H_{\,3}}^{\rm e}$ in the m issing-doublet m odel.




Figure 3: The light shaded regions indicate the allowed values of the gauge coupling threshold correction $_g$ in the m in imal and m issing-doublet SU (5) models. The dark shaded region indicates the range of $_g$ necessary to obtain $_s$ (M $_z$) = 0:117 0:1.

The large negative correction in eq. (12) gives rise to much smaller values for $_{\rm g}$ (M $_{\rm Z}$). This is illustrated in Fig. 3, where we show the upper and lower bounds on $_{\rm g}$ in the m inim al and m issing-doublet SU (5) m odels, together with the values of $_{\rm g}$ necessary to obtain

 $_{\rm S}$ (M $_{\rm Z}$) = 0:117 0:01. For both SU (5) m odels we bound $_{\rm g}$ from below by the limits on proton decay and from above by the requirem ent M $_{\rm H_3}$ < 10¹⁹ G eV .N ote that for the m issing—doublet m odel, the region of allowed $_{\rm g}$ nearly overlaps the region with $_{\rm S}$ (M $_{\rm Z}$) = 0:117 0:01, regardless of the supersym m etric particle m asses.

3 Yukawa Coupling Unication

In typical SU (5) models the bottom and tau Yukawa couplings unify at the scale M $_{\rm GUT}$. In the remainder of this letter, we will investigate bottom tau unication to the same next-to-leading-order accuracy that we used in our analysis of the gauge couplings. Our analysis is based on two-loop RGE's and on the complete one-loop expressions that relate the $\overline{\rm DR}$ Yukawa couplings to the physical ferm ion masses [6].

Let us illustrate our procedure for the case of the tau Yukawa coupling. We start by determining the \overline{DR} expectation value \Diamond from the Z-boson mass,

Then, given the pole mass m = 1:777 GeV [8], we not the tau Yukawa coupling $\hat{}$ (M $_{\rm Z}$) using the $\overline{\rm D\,R}$ relation

where $\hat{}$ (m) = $_1$ + m , and the tau self-energy is $_1$ + p/ + $_5$ ($_5$ + p/ $_5$). We follow a similar procedure to nd the top-quark Yukawa coupling $\hat{}$ (M $_2$):

O now we have the top and tau Yukawa couplings at the scale M $_{\rm Z}$, we evolve them to the scale M $_{\rm GUT}$ using the two-loop supersymm etric RGE's [7]. At M $_{\rm GUT}$ we x the $\overline{\rm DR}$ bottom - quark Yukawa coupling $\hat{\ }_{\rm b}$ (M $_{\rm GUT}$) through the unication condition

where $_{\rm b}$ parametrizes the unication-scale Yukawa threshold correction. We then run all the Yukawa couplings back to the Z scale, and iterate the procedure self-consistently to determ ine $_{\rm b}^{\rm c}$ (M $_{\rm Z}$). Finally, we apply the weak-scale threshold corrections to not the pole mass for the bottom quark.

For a top-quark pole m ass m $_{\rm t}$ = 170 GeV, this procedure typically gives a bottom -quark m ass outside the range of experim ent (which we take to be 4.7 < m $_{\rm b}$ < 5.2 GeV [8]). From previous analyses we know that for m $_{\rm t}$ < 200 GeV there are two regions of tan where bottom -tau uni cation might occur: tan < 2 and tan > 40. Here we focus on the small tan branch, where the top-quark Yukawa coupling at the uni cation scale is large, $^{\rm t}$ (M $_{\rm GUT}$) > 1.

As a point of reference, we st present our results with no uni cation-scale threshold corrections. In Fig. 4 we show m $_{\rm b}$ and $_{\rm s}$ (M $_{\rm Z}$) versus m $_{\rm t}$, for various values of tan , M $_{\rm 0}$, and M $_{\rm l=2}$, with $^{\rm c}$ (M $_{\rm GUT}$) = 3. From the gure we see that the bottom-quark pole m ass is generally too large, unless the squark m asses are of order 1 TeV .


The value $\hat{}_t (M_{GUT}) = 3$ was chosen because it lies on the edge of perturbation theory. Sm aller values of $\hat{}_t (M_{GUT})$ give rise to larger values of m_b , so the curves in Fig. 4 can be interpreted as lower lim its on the bottom -quark m ass. If we require the squark m asses to be below 1 TeV, we obtain the lower bound

In the absence of uni cation-scale threshold corrections, we see that, in the small tan region, bottom tau Yukawa uni cation favors large values of m_b and large values of the supersym metric mass scale. The above bound depends slightly on the top-quark mass, and sensitively on $^{\hat{}}_{t} (M_{GUT})$. For m_t = 160 GeV, the limit reduces by 0.1 GeV. The bound increases by 0.3 GeV for $^{\hat{}}_{t} (M_{GUT})$ = 2 and by 0.8 GeV for $^{\hat{}}_{t} (M_{GUT})$ = 1. These variations also apply for $_{\hat{b}} \in 0$.

As with $_s$ (M $_z$), the picture is altered by uni cation-scale threshold corrections. To understand their e ects, we set note the striking similarity between the m $_b$ and $_s$ (M $_z$) curves in Fig. 4, which implies that the value of m $_b$ is tightly correlated with the value of $_s$ (M $_z$). This leads us to expect that the gauge threshold correction will have an important e ect on m $_b$.




Figure 5: The bottom -quark m ass vs. the top-quark m ass for xed values of $_{\rm S}$ (M $_{\rm Z}$) and various tan . The solid lines correspond to $^{\rm t}$ (M $_{\rm GUT}$) = 3 while the dashed lines correspond to $^{\rm t}$ (M $_{\rm GUT}$) = 2. The upper line in each pair corresponds to a light supersym m etric spectrum with M $_{\rm O}$ = M $_{\rm I=2}$ = 80 G eV . The lower line in each pair corresponds to a heavy spectrum , M $_{\rm O}$ = 1000 G eV , M $_{\rm I=2}$ = 500 G eV .

In Fig. 5 we show the prediction form $_b$ versus m_t , for xed $_b = 0$, with $^*_t (M_{GUT}) = 2;3$ and $_q$ chosen to give a xed value of $_s (M_z)$. We see that any model which gives $_s (M_z)$ '



0:12 also predicts m $_{\rm b}$ ' 5 G eV , w ith $_{\rm b}$ = 0. Furtherm ore, any 23% < $_{\rm b}$ < 9% gives an acceptable value for m $_{\rm b}$ in this case. A lternatively, if $_{\rm s}$ (M $_{\rm Z}$) ' 0:13, a large and negative $_{\rm b}$ is required to achieve the central value for m $_{\rm b}$, namely 33% < $_{\rm b}$ < 8% . Figure 5 shows that these conclusions hold independently of the top-quark m ass and the supersymmetric m ass scale.




Figure 6: The same as Fig. 4, with the most favorable minimal SU (5) threshold corrections, as de ned in the text.

In Fig. 6 we plot the most favorable values of $_{\rm s}$ (M $_{\rm Z}$) and m $_{\rm b}$ in the minimal SU (5) model. In this model the Yukawa threshold is given by [15]

where M $_{\rm V}$ is the mass of the superheavy SU (5) gauge bosons. We do not the most favorable value as follows. We rst minimize the value of $_{\rm S}$ (M $_{\rm Z}$) by picking the smallest possible M $_{\rm H_3}$ consistent with nucleon decay. We then minimize m $_{\rm b}$ by choosing the smallest M $_{\rm V}$ allowed by the constraint that the SU (5) model Yukawa couplings remain perturbative, M $_{\rm V}$ > max (0:3M $_{\rm H_3}$; 0:5M $_{\rm GUT}$). From the gure we see that this brings m $_{\rm b}$ to an acceptable

 (M in im al SU (5); $m_q = 1 \text{ TeV}$; $m_t = 170 \text{ GeV}$): (17)

In contrast to minimal SU (5), the missing-doublet model can readily accommodate bottom-quark masses in the range 4:7 GeV < m $_{\rm b}$ < 52 GeV, with $_{\rm b}$ ′ 0. For example, with m $_{\rm t}$ = 170 GeV and M $_{\rm 0}$ = M $_{\rm l=2}$ = 100 GeV, minimal SU (5) requires $_{\rm b}$ in the range 15 to 65%. The missing-doublet model, however, requires $_{\rm b}$ in the range 30 to +20%. Hence even for smallO (100 GeV) supersymmetric masses the missing-doublet model naturally accommodates both gauge and Yukawa coupling unication.

4 Conclusion

In this paper we have computed the complete one-loop weak-scale threshold corrections in the minimal supersymmetric standard model. We used them to study gauge and Yukawa unication with and without unication-scale threshold corrections. In the absence of such corrections we not that $_{\rm S}$ (M $_{\rm Z}$) and m $_{\rm b}$ are large unless the squark masses are larger than

about 1 TeV . Adding m in im al SU (5) threshold corrections, and requiring m $_{\rm q}$ $\,$ 1 TeV , we not that $_{\rm s}$ (M $_{\rm Z}$) < 0:127 occurs only for M $_{\rm l=2}$ $\,$ M $_{\rm 0}$ and M $_{\rm 0}$ ' 1 TeV . Additionally, the condition m $_{\rm b}$ < 5:2 G eV is full led only for m $_{\rm q}$ > 1 TeV . In the m issing-doublet m odel, however, the threshold corrections perm it acceptable values for $_{\rm s}$ (M $_{\rm Z}$) and m $_{\rm b}$ for either a light or heavy supersym m etric spectrum .
