Spontaneous Chiral-Sym m etry B reaking in Three-D im ensional QED with a Chern {Sim ons Term

A bstract

In three-dimensional QED with a Chem {Sim ons term we study the phase structure associated with chiral-symmetry breaking in the framework of the Schwinger{Dyson equation. We give detailed analyses on the analytical and numerical solutions for the Schwinger{Dyson equation of the fermion propagator, where the nonlocal gauge—xing procedure is adopted to avoid wavefunction renormalization for the fermion. In the absence of the Chem {Sim ons term, there exists a nite critical number of four-component fermion avors, at which a continuous (in nite-order) chiral phase transition takes place and below which the chiral symmetry is spontaneously broken. In the presence of the Chem {Sim ons term, we not that the spontaneous chiral-symmetry-breaking transition continues to exist, but the type of phase transition turns into a discontinuous rst-order transition. A simple stability argument is given based on the elective potential, whose stationary point gives the solution of the Schwinger-Dyson equation.

I. IN TRODUCTION

This paper is the detailed exposition of our previous letter [1] on chiral-sym m etry breaking in (2+1)-dimensional QED with N avors of four-component D irac fermions (hereafter called QED3). Such a model of QED3 is chirally sym m etric in the absence of a bare fermion mass term, m $_0$, in sharp contrast to the (2+1)-dimensional gauge theory with two-component fermions, where we cannot de ne chiral sym metry [2{4]. Similarly to the four-dimensional case [5], the chiral sym metry of QED3 may be broken spontaneously due to the dynamical generation of a fermion mass. However the pattern of dynamical sym metry breaking is shown to be qualitatively different from the four-dimensional counterparts.

Recently, QED 3 has found a vast region of application in condensed matter physics as an elective theory in the long wavelength (or low-energy) limit of a more realistic microscopic model [7{9]. Especially, since the discovery of high- T_c superconductivity and fractional quantum Halle ect, a peculiarity of three-dimensional gauge theory, i.e., the existence of a Chem{Simons (CS) term [6]

has been a basic ingredient in these applications. The CS term gives the gauge eld a mass without destroying the gauge invariance. And, even if there is no bare CS term in the original Lagrangian, a CS term can be generated by radiative corrections in three dimensions. In the presence of a CS term, parity is broken explicitly, but the Lagrangian still keeps the chiral symmetry when m $_0=0$. The parity violation is a very important factor for the anyonic model to be a candidate theory of high- T_c superconductivity [7,8]. A eld-theoretic realization of such an anyonic model consists of fermions interacting with an abelian statistical gauge eld whose dynamics is governed by a CS term. In contrast to the chiral symmetry, it is known that the dynamical breakdown of parity does not occur in QED 3 [10{16}].

In this paper we pay attention to the breaking of chiral symmetry in the presence of a CS term within the framework of the Schwinger (Dyson (SD) equation [17]. In momentum space, the SD equation for the full ferm ion propagator S (p) is written as

which should be solved self-consistently and simultaneously with other SD equations for the full photon propagator D (k) and the full vertex function (q;p). In order to solve these sets of SD equations actually, however, we adopt some kind of approximations as exemplied below.

There are several quantities we must specify to write down the closed SD equation for the ferm ion propagator S (p), namely, the full photon propagator D (k) and the vertex function (p;q), and we also have to choose a suitable gauge. In general, both the photon propagator and the vertex satisfy their own SD equation, and both depend on the gauge-xing parameter a, if the covariant gauge-xing Lagrangian $\frac{1}{2a}$ (@ A)² is taken. There are also additional constraints on these n-point functions, coming from relations such as the W ard {Takahashi (W T) identity

Now one of the problems in QED3 is to nd a consistent truncation scheme for the SD equation: as a consequence of the WT identity the wave-function renormalization should be equal to the vertex renormalization, which puts a constraint on the bare vertex approximation. By using

the SD equation for S (p) is decomposed into two integral equations for A (p), the wave-function renormalization, and B (p). Although with a bare vertex it is not possible to satisfy the W T identity exactly, we should make sure to satisfy the constraint A (p) $^{\prime}$ 1 when using the bare vertex approximation.

First of all, we restrict our attention to QED without CS term. In the quenched case, in which the vacuum polarization to the photon propagator is completely neglected, the simplest treatment is to choose the Landau gauge a=0 and to take the bare vertex (p;q). This quenched approximation is equivalent to taking the N ! 0 limit in the SD equation for the fermion propagator, since this limit eliminates the radiative correction to the photon propagator coming from the internal fermion loops (with N species). Then the above SD equation leads to no wave-function renormalization: A (p) 1, irrespective of B (p), see e.g. [18]. In this case, it has been shown [19] that quenched QED 3 resides in only one phase where chiral symmetry is spontaneously broken, in agreement with the Monte Carlo simulation of non-compact lattice QED 3 [20].

In the quenched case, the bare vertex approximation is justiled in the Landau gauge a=0, because this choice is approximately consistent with the W T identity and satisfies the requirement that the wave-function renormalization and the vertex renormalization are equal. In gauges other than the Landau gauge however, we can not take the bare vertex, since A (p) deviates from one. In order to study the SD equation in a general gauge, we must modify the vertex in such a way that the result is gauge-covariant, i.e., independent of the gauge-xing parameter a. This problem persists in the three-dimensional case [21,22] as well as in four dimensions [23{25}. Such a modified vertex has to satisfy the W T identity exactly.

Now we can raise the question whether the chiral symmetry restores at a certain non-zero value of N . In the presence of the one-loop vacuum polarization (N $\, \in \,$ 0) the simple procedure mentioned above can not be applied, since there is no simple gauge choice a such that A (p) 1. Nevertheless, under the bare vertex approximation in the Landau gauge, Appelquist, N ash and W ijewardhana (ANW) [27] have shown that there is a nite critical number of avors N $_{\rm c}$, above which the chiral symmetry restores. Based on a leading-order 1=N expansion [26] (e² = 8 =N with being kept xed) for the vertex and the photon propagator in the SD equation, they gave the critical value N $_{\rm c}$ = 32= 2 = 32. Furthermore, N ash [28] claimed that the leading-order gauge-invariant critical number of avors is given by N $_{\rm c}$ = 128=3 2 and that, when 1=N 2 corrections are included, N $_{\rm c}$ coincides approximately with this result.

However, such a simple treatment of the vertex function and the wave-function renormalization function A was criticised by Pennington and Webb [29] and Atkinson, Johnson and Pennington [30]. They claimed that, if the vertex is correctly improved, using the

W T identity, and the coupled equations for A (p) and B (p) are solved together, the nite critical number of avors does not exist. This implies that the chiral symmetry is spontaneously broken in QED 3 for all values of N , i.e., $N_c=1$. On the other hand, the M onte Carlo simulation [20] of lattice non-compact QED 3 seems to support a nite critical avors: 1 N_c 3:5 0:5, see also [31]. However, it is numerically very dicult to confirm the exponential decrease of the dynamical mass for increasing N found in [29,30].

The origin of this controversy stems from the fact that in the unquenched case A (p) 1 can not be deduced as a simple consequence of the SD equation by choosing the Landau gauge, in sharp contrast with the quenched case. Nakatani [32] has proposed to use a nonlocal and momentum—dependent gauge function, instead of the usual gauge—xing term, in order to keep A (p) 1 and thus to overcome the inconsistency one has using the bare vertex approximation in the Landau gauge. A ctually the nonlocal gauge found in [33,34,16] can play exactly the same role as the Landau gauge in the quenched case, in the sense that A (p) 1 follows by choosing the appropriate nonlocal gauge in the bare vertex approximation and that the nonlocal gauge a (k) as a function of the photon momentum k reduces to the Landau gauge in the quenched limit N ! 0. Taking into account only the leading and next-to-leading order terms in the infrared region, which is the essential region in QED 3 [2,35], yields a nite critical number of avors [16]

which is the same as the leading-order result obtained by Nakatani, and coincides with the result obtained by Nash in a dierent way [28]. In this paper we use the nonlocal gauge as derived in [16].

In the present paper the existence of a nite critical number of avors is con rm ed by solving numerically the nonlinear SD equation, using a bare vertex and the nonlocal gauge as derived in [16] in order to keep A (p) 1, without further approximation. The parity-conserving and chiral-symmetry-breaking fermion mass is dynamically generated in QED 3 and there occurs a chiral-symmetry-restoring phase transition at N $_{\rm c}$ = 128=(3 2). The order of the chiral phase transition is in nite in the sense that the dynamical fermion mass m $_{\rm d}$ and the chiral order parameter h i exhibit an essential singularity at the critical point N = N $_{\rm c}$,

In the presence of CS term, as already reported in [1], the chiral phase transition turns into a rst-order transition, in sharp contrast to the = 0 case. This result is obtained by both a numerical study of the full SD equation and an analytical study of approximated equations using the same scheme as in the absence of CS term. We have also determined the critical line N = N_c() for this transition in the (N;) plane, the two-dimensional

phase diagram . In this paper we give the detailed exposition of this result [1] based on the fram ework of [16]. The rst-order transition implies that the chiral order parameter as well as the dynam ical ferm ion mass show a discontinuous change at the critical point on the whole critical line extending from $(N;) = (N_c;0)$ in the phase diagram (N;). Moreover, the critical number of avors $N_c()$ decreases as the CS coe cient increases.

This paper is organized as follows. In section II we give a description of QED3 with a CS term. We start from the formulation of QED3 using four-component ferm ions in the reducible representation of the C li ord algebra for the -m atrices in (2+1)-dim ensions. We de ne the chiral and the parity transform ations for this theory, and our decomposition of the ferm ion propagator into scalar functions. We also discuss the structure of the gauge boson propagator with the nonlocal gauge and give an explicit expression for the vacuum polarization in the leading order of 1=N expansion. After these prelim inaries, we rst discuss QED without the CS term and subsequently study the e ect of the explicit CS term. In section III we write down the SD equation for the ferm ion propagator explicitly. The SD equation is solved both analytically and numerically. Next, in section IV, we study the e ect of the explicit CS term by solving the nonlinear SD equation num erically. In section V detailed comparison of numerical and analytical result is given and the numerical results in section IV are con m ed by the analytical treatment. In order to study the stability of the chiral-sym m etry-breaking solution, we evaluate the e ective potential of Comwall (Jackiw (Tomboulis [36] in section VI. The nal section is devoted to conclusion and discussion. In Appendix A, we give integration formulae which are necessary to perform the angular integration to obtain the integration kernel in the SD equation. In Appendix B, we supplement details on the calculation of the ultraviolet boundary condition. In Appendix C, it is shown that at the stationary point the e ective potential obtained in section VI actually gives the SD equation for the ferm ion mass function in the nonlocal gauge.

II.QED3W ITH CHERN {SIM ONS TERM

In Euclidean space the Lagrangian is

We use four-component spinors for the ferm ions, and accordingly a four-dimensional representation for the -m atrices of the Cli ord algebra f; g = 2:

with a (a = 1;2;3) being the Paulim atrices; furtherm one we have the matrix, de ned by

W ith such a representation we can de ne chirality just as in four-dimensional QED, but now there are two independent chiral transformations possible, which are de ned by the $4\,$ m atrices $_3$ and $_5$:

W ithout an explicit mass m $_{\rm e}$ for the ferm ions, the Lagrangian is chirally sym metric, but the mass term m $_{\rm e}$ breaks chiral sym metry. Note that the other mass term, m $_{\rm o}$, is chirally invariant.

In this representation, the parity transformation is defined by $(x_0; x_1; x_2)$! P $(x_0; x_1; x_2)$, A $(x_0; x_1; x_2)$! (1) ¹A $(x_0; x_1; x_2)$, with P = i_{5-1} . Then the mass term m_o is odd under a parity transformation. Also the CS term is odd under this parity transformation, so in the presence of a (bare) CS term parity is always broken, even if m_o = 0. The other terms in the Lagrangian, including the chiral-symmetry-breaking mass term, are invariant under a parity transformation.

A. The Ferm ion Propagator

The inverse full ferm ion propagator can be written as

The functions A (p) and B (p) are scalar functions of the absolute values of the m omenta, and their bare values are $A_e = 1$, $A_0 = 0$, $B_e = m_e$, and $B_o = m_o$. In order to study the ferm ion propagator nonperturbatively it is useful to de ne the matrix (projection operator)

In this paper we study the dynam ical breaking of chiral sym m etry, using the SD equation for the ferm ion propagator. Perturbatively this will not happen, but just as in pure QED (without CS term), chiral sym m etry can be broken dynamically due to nonperturbative e ects, starting with a chirally sym m etric Lagrangian. So in the remainder we have put both explicit m asses m_e and m_o equal to zero m_e , and study the behavior of B nonperturbatively.

Note that in terms of B_+ and B_- , chiral sym m etry m eans B_+ (p) = B_- (p), which gives B_+ (p) = 0.

The order parameter connected with the chiral phase transition is the chiral condensate. In the presence of a CS term there are two types of condensates: a parity even condensate h i and a parity odd condensate h i. U sing the decomposition of the propagator in terms of , we can write these condensates as

In QED 3, the usual truncation scheme for the ferm ion SD equation is based on the 1=N expansion [26]. The coupling constant e^2 has the dimension of mass, and we use the large N lim it in such a way that $e^2 \# 0$ and the product N e^2 remains xed:

with xed. In this approximation scheme, the full vertex is replaced by the bare vertex, because that is the leading-order contribution in 1=N. In order to be consistent with the W T identity, or at least with the requirement that the vertex renormalization and the fermion wave-function renormalization are equal, we use a suitable nonlocal gauge function.

B. The Gauge Boson Propagator

We use a Lagrangian with a so called nonlocal gauge—xing term for the gauge eld, namely

which has certain advantages above the normal gauge-xing term: it allows for a momentum-dependent gauge parameter in the gauge boson propagator.

It is easy to show that this Lagrangian leads to the following inverse bare photon propagator

So if we can simplify the actual calculations by choosing a speci c m om entum-dependent gauge a (q), we can justify this afterwards by specifying the gauge-xing term as

The conventional (local) gauge can be recovered by the choice f(x) = (x)=a, as can easily be seen from the above form ulae.

We can show that identities relating the dierent Green's functions, like the WT identity, hold with this nonlocal gauge in exactly the same way as with a constant gauge parameter. For the (full) photon propagator this implies in momentum space

This means that also with this nonlocal gauge the gauge-dependent part of the photon propagator is not a ected by the interactions, and that the longitudinal part of the vacuum polarization is zero. Therefore we can write the full photon propagator as

where $^{\mathrm{T}}$ and $^{\mathrm{O}}$ correspond to the decomposition of the vacuum polarization tensor [6]:

In the 1=N expansion the one-loop vacuum polarization has to be taken into account, because this vacuum polarization is of order one: there are N ferm ion loops contributing to the vacuum polarization and each loop is of the order e^2 1=N . Starting with massless ferm ions, e.g. both the parity odd and parity even mass equal to zero, there is no parity odd part of the vacuum polarization. The transverse part of the vacuum polarization is

Therefore the inclusion of this vacuum polarization leads to the following gauge boson propagator

This is the photon propagator we will use in this paper, with a suitable choice for a (q) in order to keep the wave-function renormalization equal to one.

III. DYNAM ICAL SYMMETRY BREAKING IN PURE QED

W ithout the CS term in the Lagrangian, we have no explicit parity breaking term s, and the full ferm ion propagator will also be parity even: there will be no spontaneous breaking of parity [10{16}]. That means that we only have to deal with one set of two coupled integral equations for A (p) and B (p)

The SD equation for the ferm ions thus reduces to only one nonlinear integral equation for the dynam icalm ass function, which we callm (p). A fter the angular integration, which can be done analytically (see appendix A), the radial integration kernel becomes

This nonlinear integral equation can be solved num erically without further approximations, or it can be solved approximately by using a series expansion for the logarithms. This last method makes it possible to convert the integral equation into a second-order dierential equation, and to study dynamical chiral-symmetry breaking analytically.

A.Di erential Equation

In order to solve the equation analytically we make the replacement $k^2 + m^2(k)$! $k^2 + m^2(0)$, which is a good approximation both for small momenta (where m(k) is almost constant), and for relatively largemomenta (where both m(k)² and m(0)² are negligible w.r.t. k^2). One can also show that this replacement is in agreement with bifurcation analysis, see e.g. [37,25]. For very large momenta (k >) we neglect m^2 with respect to k^2 in the denominator completely.

A nother approximation, which is commonly made [2], uses the fact that the integral is heavily damped for momenta larger than the mass scale. All the essential physics comes from the infrared part of the nonlinear interal equation. Therefore one uses a series expansion for the logarithms in Eq. (38) for momenta p; k , and introduce a cuto at k = . However, we are interested in the behavior of the mass function for momenta p > as well, especially when we include the CS term. Therefore we will adopt a slightly dierent approximation, which takes into account the ultraviolet tail of the integral as well.

For this purpose we expand the integration kernel K(p;k) in powers of m in (p;k)=m ax (p;k). To leading order this gives

and two boundary conditions, infrared and ultraviolet ones, just as in the usual approxim ation scheme. It is easy to show that the behavior of this dierential equation in the infrared region is exactly the same as one would obtain by expanding f and g for small momenta directly.

Form om enta p we expand the functions f(p) and g(p), which gives to leading order in p

and again taking into account leading order only we nd a = 0 or a = 2. It is easy to see that a = 0 is the solution corresponding to explicit chiral-symmetry breaking, since

this leads to m (p) ! m $_0$ 6 0 in the ultraviolet region. W ithout a bare mass, the correct solution is a = 2, which shows that the dynam ical mass function falls o very rapidly in the ultraviolet region. This is also consistent with the ultraviolet boundary condition, but it does not provide a normalization condition.

W ith this know ledge we now consider integral equation in the infrared region, without neglecting the ultraviolet tail of the integral: we use

close to the critical number of fermion avors. The solution with the largest value of m = < 1 corresponds to the ground state, since this has the lowest energy. That m eans n = 1 in the above equation, and one can also show that the other solutions have an oscillating behavior at large m om enta; only the solution w ith n = 1 is a nodeless solution.

B. Integral E quation

A Itematively, we can solve the nonlinear integral equation for them ass function, Eq. (39), num erically, without further approximations. The integral can be calculated numerically without any cuto, since the integrand falls or rapidly for large momenta and the integral is nite. Solving the integral equation iteratively leads to qualitatively the same result as the previous analysis.

There is a critical number of ferm ion avors below which there is a chiral-symmetry-breaking solution. The critical number is the same as we have just found analytically

the only di erence is the value of the constants $_{i}$. The analytical result is $_{1}$ = $_{2}$ and $_{2}$ = 3:94, whereas the full nonlinear equation gives $_{1}$ = 3:1 and $_{2}$ = 1:8. So the main di erence between the analytical solution of the approximated equation and the numerical solution of the full equation is an overall normalization factor. This dierence is due to the fact that in the rst case we have made several approximations, but these approximations turn out not to be essential for the behavior of the infrared mass near the critical point. Both in the infrared and in the ultraviolet region the numerical and analytical solutions have the same behavior, see Fig. 2. Of course, these approximations do make a dierence in the region where p is of order , but this is to be expected since we expand to leading order only in p= and =p respectively.

C.ChiralCondensate

IV. EXPLICIT CHERN (SIM ONS TERM

In this section we add a CS term for the gauge eld to the Lagrangian. This breaks the parity explicitly, and gives rise to a parity odd mass term for the ferm ions, as well as a parity odd part of the gauge boson propagator. We use the gauge boson propagator as discussed in section IIB, with the inclusion of the leading-order vacuum polarization.

Again we will use a nonlocal gauge- xing term. For the momentum-dependent gauge function we use [16]

In analyzing these equations it is important to observe that once we have found a solution for A_+ (p) and B_+ (p), we automatically have also a solution for A (p) and B (p): namely the set A (p) = A_+ (p) and B (p) = B_+ (p). That means that we can always construct a chirally symmetric (but parity odd) solution of the SD equation, with B_e (p) = 0. The question of dynamical chiral-symmetry breaking turns into the question whether or not there exist two (or more) solutions of the set of integral equations.

W ithout the CS term there is dynam ical chiral-symmetry breaking only for N < N $_{\rm c}$ = 128=(3 2) as we have just seen. We therefore expect a similar situation in the presence of the CS term, at least if the parameter—is small. That means that for N > N $_{\rm c}$ we have only the chirally symmetric solution of the above equations, but for N < N $_{\rm c}$ we expect that there are (at least) two solutions for both B $_+$ and B $_-$ possible, which can be distinguished by their behavior under the chiral and parity transform ations and by their behavior in the lim it $_-$ # 0.

It is also essential to note that in the presence of an explicit CS term for the gauge eld in the Lagrangian there is no trivial solution B=0, as there would be without the explicit CS term. Due to the explicit breaking of parity, the ferm ions always acquire a parity-odd mass B_{\circ} , even if the explicit odd mass m_{\circ} is zero. At large momenta the CS term in the SD equation dominates (at least if there is no explicit mass term present), which leads to an ultraviolet behavior of the mass functions

at a perturbative level, whereas in the absence of the CS term the mass function m (p) falls o like $1=p^2$, as we have seen in the previous section. We will discuss this point in more detail when we are studying the breakdown of chiral symmetry analytically.

B.Num erical Results

We have rst solved the set of coupled integral equations Eq. (64) and (65) numerically without further approximations. Depending on the values of the number of fermion avors N and the CS coecient, there is only one (chirally symmetric) solution in most parameter space, but we found two solutions, allowing for a chiral-symmetry-breaking solution, for small and small N, in agreement with the above expectations. Using the notation B (p) and B (p) for the two dierent solutions of the above equations, we have found the following solutions:

- 1. B_+ (0) = B (0) = O (m (0)) > O, with B_+ (p) = B (p) > m (p), B_e (p) 0 and B_o (0) = O (m (0)) for N < N_c (= O) we not that B (p) and thus B_o (p) go towards the nontrivial solution m (p) in the lim it # 0; for N > N_c (= O) we not that B_+ (p) = B_o (p) = O (), which vanishes in the lim it # 0.
- 2. B_+ (0) B_- (0) = 0 (m (0)), with B_+ (p) > m (p) > B_- (p) = 0 (m (p)) and B_- (p) = 0 () This solution exists for values of N < N_c (= 0) and small (compared to) values of only. There is a critical number N_c () < N_c (0) for given , or critical $_c$ (N) for given N < N_c (0). In the limit # 0 both B and thus B_- go towards the nontrivial solution m (p): B_+ (p) # m (p) and B_- (p) " m (p) in this limit. The parity breaking solution B_- (p) vanishes in this limit.
- 3. $B'_+(0) = B'(0) = O(m(0)) < 0$ The chirally symmetric combination, which exists for small values of N and small values of only.
- 4. B'_+ (0) B (0) = 0 (m (0)) The fourth possible combination of B_+ and B_- , also existing for small values of N and small values of only.

The typical behavior of the numerical solutions for A and B is shown in Fig. 3. As expected, A is indeed very close to one, due to our choice of the gauge function. The solution B (p) exists for all values of both N and , allowing only a chirally symmetric solution. The other solution, B (p), is the interesting one, leading to dynamical chiral-symmetry breaking. The iterative process of solving the integral equation numerically does not converge to a (second) stable solution B for all values of N and : we cannot this solution only for N below some critical value (depending on) and below some critical value (depending on a some critical and N.

Our num erical results all indicate strongly that this phase transition is a rst-order phase transition, in contrast to the in nite-order phase transition in pure QED (=0), although it

is num erically very di cult to establish the type of phase transition at the critical values of N and . For xed and small N, there exists a second solution, B´(p), as can be seen from Fig. 4. The value at the origin B´(0) decreases rapidly for increasing N and this solution \disappears'' (without B (0) going to zero) at some critical value N < N_c(= 0), and also B_e(0) does not go to zero at this critical value. Considering B_e(0) as the order parameter for the chiral phase transition, this corresponds to a rst-order phase transition, in contrast to the in nite-order phase transition at = 0.

If we look at the behavior of B $_{\rm e}$ (0) and B $_{\rm e}$ (0) at xed N < N $_{\rm c}$ (= 0) and increase , we see a sim ilar situation. For (very) sm all values of $\,$ we not the two solutions B and B $\,$ leading to chiral-sym m etry breaking. For increasing $\,$ we not that B $\,$ (0) decreases, and disappears at some critical value $_{\rm c}$ (N), without going to zero at this critical value, see F ig. 5.

C.Condensate

Although both functions B (p) behave like =p in the ultraviolet region, leading to divergent integrals for the condensates h i, the chiral condensate is convergent due to the fact that the leading-order contributions in B₊ (p) and B (p) (or B' (p)) cancel. So the chiral order parameter is

The chirally sym metric combination, $(B_+(p); B_-(p))$ with $B_e = 0$, gives $h_- i = 0$, as would be expected from a chirally sym metric solution. Note that the other condensate, $h_- i$, is actually logarithm ic divergent because the leading-order contributions add up. Once we have the numerical solutions, it is straightforward to calculate this chiral condensate as well, see Fig. 5. The behavior of the chiral condensate also indicates a rst-order phase transition.

However, as we mentioned before, it is numerically very discult to establish such a rst-order phase transition. In order to con rm that it is indeed a rst-order transition and to determ ine the critical parameters $N_{\rm c}$ and $_{\rm c}$, we have to study the phase transition analytically. We can do this by solving the integral equations analytically, after some further approximations analytic solution in the pure QED case.

V.ANALYTICAL STUDY

In order to see whether there is indeed a rst-order phase transition, we have analyzed the SD equation analytically, after some more approximations. Based on the fact that A (p) 1 exactly if is zero, and very close to one for small values of (small compared to), we replace A (p) by one, so we get the following equation for B

The error we make in neglecting the elects of the wave-function renormalization (even if we use the nonlocal gauge) is of the order of B, which is (close to the critical number of ferm ion avors in the absence of the CS term) of the order of 2 , because the parity odd mass, generated by the CS term, is of order . So for a consistent approximation in order to get an analytical solution of the equation, it is enough to expand the kernel in and neglect all terms of order 2 and higher. 3 Expanding the nonlocal gauge in gives

Two of them correspond to the two solutions which we have found numerically, and the third is an oscillating solution which in the limit of vanishing corresponds to the rst oscillating solution in pure QED , n = 2 in Eq. (57). For extremely small values of M and there are more oscillating solutions, in the region around the origin, but these are numerically unstable, and correspond to higher excites states, just as in pure QED .

If we increase from zero at xed N , then the absolute value of the second solution, \mathcal{B} , decreases (whereas the other solution increases), until at a critical value $_{\text{C}}$ this solution coincides with a third solution, and disappears, but does not become zero at the critical point, see Fig. 6a. This clearly signals a rst-order phase transition, as was also suggested by the numerical results. For comparison, we also showed our numerical data in the same gure, where we use a dierent value of for our numerical and analytical calculation, $_{\text{num}}$ and $_{\text{an}}$ respectively, in order to have equal numerical and analytical values of m (0)= $_{\text{num}}$ in the absence of the CS term (note that the axes are = $_{\text{num}}$ and $_{\text{B}}$ (0); $_{\text{F}}$ $_{\text{num}}$ respectively). This shows clearly that both our numerical and our analytical results are in good agreement with each other.

We can also plot M versus N for some xed values of , see Fig. 6b. From that gure we can see that if we increase N for xed , the chiral-sym m etry-breaking solutions disappear if N exceeds some critical value N $_{\rm c}$, which decreases rapidly as a function of . This gure shows that the chiral phase transition is rst order in this direction as well: increasing N beyond N $_{\rm c}$ () makes the second (and third) solution disappear, but at the phase transition neither B nor B $_{\rm e}$ = (B $_{+}$ + B)=2 (which can be regarded as the order parameter of the chiral phase transition) becomes zero. In this gure we can also see that in the limit ! 0 the critical value N $_{\rm c}$ goes towards N $_{\rm c}$ (0) ' 4:32.

The critical parameters N $_{\rm c}$ and $_{\rm c}$ can be calculated by dierentiating the ultraviolet boundary condition, Eq. (86), with respect to M . This leads to an equation for M $_{\rm c}$ as function of N $_{\rm c}$ (remember that M does not vanish at N $_{\rm c}$)

which can be used as input for the ultraviolet boundary condition itself in order to calculate $_{\rm c}$. Although we do not have an explicit form for $_{\rm c}$ as function of N , we can calculate it

num erically, and have shown the critical line in Fig. 7. In this gure we also show some estimates of the critical parameters based on our num erical calculation. This shows that the num erical and analytical results are qualitatively in good agreement with each other, and the only dierence is an overall scale factor (just as in pure QED).

For sm all values of M $_{\rm c}$ and N $_{\rm c}$ () close to N $_{\rm c}$ (0) ' 4:32, we can expand the above equation in N $_{\rm c}$ (0)=N 1, leading to

In Fig. 8 we show the chiral condensate (together with the B_e (0)) as obtained both numerically and analytically for = 0 and = 10^5 as a function of N . Again, they are qualitatively in good agreement with each other, and show a discontinuity in both the chiral condensate and B_e (0) at the critical point.

In Fig. 9, we show both B_e (p) and B_o (p), as obtained num erically and analytically. The num erical and the analytical solutions have the same behavior in both the infrared and the ultraviolet region; around p = there is of course a kink in the analytical solution due to the approximations we have made. There is a scale dierence between the analytical and the numerical solution for the chiral-symmetry-breaking solution, just as in pure QED; in fact, if we compare this gure with Fig. 2, we can see that the parity-even mass function is almost the same as the dynamical mass function in pure QED. Furthermore, this gure shows very well the dierence in the ultraviolet between the even and the odd mass function: the odd mass function behaves like =p, whereas the even mass function B_e (p) $= (B_+$ (p) + B (p))=2 behaves like $1=p^2$, due to the cancellation of the terms proportional to =p.

VI.CJT EFFECTIVE POTENTIAL

We consider the elective action of Comwall (Jackiw (Tomboulis [36] (CJT) which is given by

is non-positive, $V \ [B_{sol}] \ 0$, and all the nontrivial solutions have lower energy than the trivial ones (in the case of pure QED). Therefore we can determ ine the ground state, namely the solution which minim izes the elective potential, by using Eq. (109).

W ithout actually calculating the integral, we can easily conclude that in the presence of an explicit CS term, the chirally symmetric solution (B_+,B_-) gives a lower elective potential and is thus favored above the chiral-symmetry-breaking solution (B_+,B_-) . Since the elective potential is the sum of two non-positive integrals, each of which depends on B_+^2 or B_+^2 , this elective potential is minimized by a symmetric set of solutions (B_+,B_-) and not by (B_+,B_-) . So in the presence of an explicit CS term, the chirally symmetric phase is the ground state, even if the number of fermion avors N and the CS parameter are below their critical values for dynamical chiral-symmetry breaking. This is quite surprising, since it is well-known that without the explicit CS term the chiral symmetry is broken for N below the critical number, as can also be seen from the elective potential, Eq. (109).

In solving the SD equation we have put the external source m $_{\rm e}$ and m $_{\rm o}$ to zero from the beginning. As a result, the solution for the hom ogeneous SD equation has no special direction for the dynamical mass to be generated. A ctually, if a solution is found for B $_{+}$, then another solution B $_{-}$ B $_{+}$ is automatically obtained, and it is this solution which gives the lowest elective potential. In order to study the spontaneous breaking of a symmetry in general, one can introduce an external source JO which breaks the symmetry in question and subsequently consider the limit of removing the external source. If the symmetry is broken even in this limit, which is signaled by the non-vanishing order parameter $_{-}$ lim $_{\rm J!}$ $_{0}$ hO i $_{\rm J}$, then it is said that the symmetry is spontaneously broken. In taking this limit one must specify from which direction the external source is decreased to zero, J ! 0.

In this case we must consider the two lim its: m_e ! 0, m_o ! 0. For sim plicity we keep m_e and m_o positive, m_e ; m_o 0 and consider the lim it: m_e # 0, m_o # 0, without loss of generality. Then there are vecases to be examined, which are given below.

Therefore the two solutions $(B_+;B_-)$ and $(B_+;B_-)$ are realized in two different limits: the limit $m_+ = m_- \# 0$ leads to the solution $(B_+;B_-)$, whereas the limit $m_+ = m_- \# 0$ yields the solution $(B_+;B_-)$. This last set of solutions is of course only possible if the parameters N_+ are in the chirally broken phase.

From this consideration, the two sets of solutions cannot be realized simultaneously. The result which solution is realized depends on the ordering of taking the vanishing limit keeping the relation between m_e and m_o. So in the presence of the CS term, taking the limit m_e > m_o # 0, we will get the solution (B₊;B') which has a higher value for the CJT elective potential than that of the \trivial" solution (B₊;B). That means that this solution is a quasi-stable solution of the SD equation, and will eventually decay into the \trivial" solution. This quasi-stable solution does no longer exist beyond a certain value of , the critical value $_{\rm c}$ (N) depending on N. At this point the system jumps directly to the state expressed by the solution (B₊;B), which is energetically more favored, in a discontinuous way.

VII.CONCLUSION AND DISCUSSION

In (2+1)-dimensional QED with N avors of four-component D irac ferm ions, we have solved the SD equation for the ferm ion propagator in the nonlocal gauge both analytically and numerically. In the absence of the bare CS term, we have shown the existence of a nite critical number of avors N_c = 4:3, below which the chiral symmetry is spontaneously broken, in agreement with previous analyses [27,28,16]. In the presence of CS term, \in 0, we have obtained the critical line extending from the critical point (N;) = (N_c;0) in the two-dimensional phase diagram (N;). Here a quite remarkable point is that, no matter how small is, this phase transition turns into a rst-order transition when \in 0, although the critical point (N_c;0) in the absence of CS term is a continuous (in nite-order) phase transition point. Therefore the point (N_c;0) is the only one point on the critical line which exhibits continuous phase transition.

We have shown that the chiral-symmetric solution (B₊;B) and the chiral-symmetry-breaking one (B₊;B) of the SD equation are stationary points of the elective potential of the CJT type. Here it should be remarked that the trivial solution (B₊ 0;B 0) as a trivial stationary point (equivalently the trivial solution of the SD equation) is possible only when = 0. Although the symmetric solution (B₊;B) gives lower elective potential than the symmetry-breaking solution (B₊;B), we have shown that it is possible to take the limit of removing the external source, m_e;m_o # 0, so that the spontaneously chiral-symmetry-breaking solution (B₊;B) is realized. However it is not yet clear whether they give local minima, local maxima, or possibly a saddle point of the elective potential and whether or not (B₊;B) gives the absolute minimum. In order to con much this issue, it is necessary to calculate the second functional derivative:

at the respective stationary point [42]. The system at an excited state $(B_+; B^-)$ m ight be quasi-stable and m ight decay into the more stable state $(B_+; B_-)$ in a nite time interval. The stability of the stationary point will be discussed in more detail in a subsequent paper.

It is interesting to see our result from the viewpoint of the lattice gauge theory where the lattice spacing a corresponds to the inverse of the UV cuto , a 1= . It is well known [44] that the nontrivial continuum \lim it can be possibly taken only at the secondand higher-order transition point where the correlation length diverges (in units of the lattice spacing). Hence our result implies that the meaningful continuum \lim it from the broken phase in the nonperturbatively regularized three-dimensional gauge eld theory can be taken only at the point $(N_c;0)$, i.e. in the absence of the bare CS term. This is a novel feature of the three-dimensional gauge eld theory with a bare CS term, which seems to be overlooked so far. Our result may have important implications in the application of the three-dimensional gauge theory in condensed-matter physics as a long-wavelength elective theory of the microscopic model. This will be discussed in a forthcoming paper.

This result is obtained by using a consistent expansion of the full gauge boson propagator and the vertex in 1=N. In order to satisfy the W T identity (up to terms of order 1=N and of order of the dynamically generated mass), we have adopted the nonlocal gauge function which allows us to neglect e ect from the wave-function renormalization. A more accurate

approximation would include a full 1=N 2 calculation, similar to the analysis in [28] in pure QED. Since in pure QED these 1=N2 corrections do not change the result qualitatively, but only quantitatively (leading to a slightly di erent critical number of ferm ion avors), we do not expect that those corrections will change our present result essentially. The question of gauge covariance can (in principle) be recovered by applying the Landau (Khalatnikov transform ation rules to the various G reen's functions [45]. Therefore we expect our present results to hold also in a more elaborate approximation of the SD equation.























