A Complete Supersymmetric SO (10) M odel

Abstract

A complete supersymmetric SO (10) model is constructed, which is the most general consistent with R, discrete, and U (1) avor symmetries. At the supersymmetric level there are many degenerate vacua, one of which is phenomenologically successful. This vacuum has vevs which align in certain de nite directions in SO (10) group space, such as the B L direction. Although this desired vacuum is not proven to be the global minimum of the entire theory, including supersymmetry breaking, it is separated from vacua where the vevs point in

di erent group directions by a large potential barrier. This desired vacuum simultaneously leads to three major features of the theory. (1) SO (10) is broken at scale v_{10} to SU (5), which breaks at M $_{\rm G}\,$ to the standard m odel gauge group. Beneath M $_{\rm G}$ the only light gauge non-singlet elds are those of the minim al supersymmetric standard model, so that the successful prediction for the weak mixing angle is retained. (2) The alignment of the vevs leads to a natural mass separation of the weak Higgs doublets from their colored partners via a mechanism which is closely related to the issue of the proton decay rate. A lso, the generation of the term is studied. (3) A set of particles acquire m ass at the highest perturbative scale of the theory, M and at v_{10} . W hen they are integrated out, they lead to just four avor operators for quark and charged lepton masses, and two more for neutrino m asses. These avor operators lead to m any quark and lepton mass and mixing angle relations which involve pure SO (10) group theory num erical C lebsch factors. The fam ily hierarchies result from the ratio of scales $v_{10}=M$; $M_G=v_{10}$ and $M_G=M$. While the theory is by no means unique, it is complete, and hence illustrates the close connecton between several in portant features of the theory.

1 Introduction

The Standard M odel is a great success. In the coming years experiments will continue to bok for deviations from the Standard M odelwhich m ight indicate new physics. There are already several suggestive hints of new physics.

The measured values of ; $\sin^2 w$ and ${}_{s}(M_{z})$ are consistent with the prediction of a simple supersymmetric [SUSY] grand united theory [GUT] (with ${}_{i}$ ${}_{G}$, i = 1,2,3, at M ${}_{G}$ 10^{16} GeV and a soft SUSY breaking scale of order (1 10) M_z) [1].

The measured values of m_b ; m and m_t are consistent with SUSY GUTs (with the Yukawa couplings satisfying the SU (5) relation $_b = at$ M_G). This constraint correlates m_t and the ratio of Higgs vacuum expectation values [vevs], tan . Form t 174G eV, there is both a small and large solution for tan . In fact, the SO (10) relation $_b = = t$ at M_G is also consistent with observation [2]. This constraint favors the solution with tan in the range 40 - 60.

The cosm obgical evidence for a universe led with cold and hot dark matter tsnicely into them inim alsupersymmetric standard model[M SSM] with a conserved R-parity. In this case the lightest SU SY particle is absolutely stable and is an excellent candidate for the cold dark matter constituent. A tau neutrino with mass of order several eV is the natural candidate for the hot dark matter. Such a tau neutrino may be observable at the CHORUS and NOMAD experiments at CERN and at the E 803 experiment at Fermilab.

C osm ological and astrophysical evidence for neutrino m asses and m ixing angles is indicative of right-handed neutrino components which naturally t into an SO (10) fram ework for ferm ions.^z

A ll of these hints are quite tantalizing. A s a whole they strongly suggest the notion of a SUSY GUT. It is an intriguing question then whether the sym m etry relations of a SUSY GUT can help us understand the observed pattern of ferm ion m asses and m ixing angles. Recently, several e ective SO (10) SUSY GUT m odels were found which provide a consistent and quantitative description of this low energy data [4] (from now on referred to as paper I) [5].

SO (10) [6] has the advantage that it is the minimal GUT in which all the ferm ions in one fam ily, i.e. u, d, e and , t into one irreducible representation with only one additional state { a right-handed neutrino. Thus m ass m atrices in di erent charge sectors can be related. In reference I a search was m ade for all acceptable SO (10) avor sectors in which all quark and charged lepton masses and mixings originated in just four operators. Several such m odels of avor were found to be consistent with data. This agreem ent m ay of course be completely spurious, or these operators may give the dom inant contributions to ferm ion m asses in the elective theory at M $_{
m G}$. If the latter is true then corrections to the leading order results should in prove this agreement. W hy should only a few operators contribute to ferm ion masses? W hy should nature be kind and allow us to make many avor predictions without addressing physics at the Planck scale? This is an important criticism of reference I. The answer given in this paper is that avor symmetries of the theory just beneath the Planck scale can be very powerful, forbidding the vast majority of possible operators.

The main purpose of this paper is to provide a fram ework in which such corrections may be calculated. There are several sources of corrections: electrow eak scale threshold corrections must be included, which can be signi cant for large tan . GUT scale threshold corrections and GUT scale corrections to the elective theory can a lect ferm ion masses as well as FCNC processes.

handed neutrino M a jorana m ass of order 10^{12} G eV (as indicated, for example, by a tau neutrino component of dark m atter) requires large tan [3].

In addition, new phenom ena such as proton decay and neutrino m asses can only be addressed in the context of a complete SO (10) SUSY GUT valid for energies greater than M $_{\rm G}$ up to the largest perturbative scale in the theory, M , which can be taken as the string compacti cation scale or the P lanck m ass.

In this paper we demonstrate the existence of a complete SO (10) SUSY GUT which reproduces, as an example, one of the models found in I. By a complete GUT we mean one which reproduces not only a realistic ferm ion mass spectrum (including neutrinos) but also addresses the issues of GUT symmetry breaking, the doublet-triplet splitting problem, the problem and proton decay. We show how all these problems have reasonable solutions, with one caveat. We do not claim to understand the dynamics which determ ines the scale of the GUT vevs. All GUT breaking occurs along at directions in the SUSY limit. We will also not address the question of the origin of soft SUSY breaking. We will just assume the standard set of soft SUSY breaking terms below M whenever they are needed to make contact with low energy data.

We make no claim of uniqueness for the model in this paper: there are undoubtedly many similar such models. Nevertheless, by studying a specic, complete model, one can study the connections between many dierent aspects of the theory. The orientation of the GUT vevs is crucial for understanding both the lightness of the Higgs doublets and for obtaining the operators which lead to predictions for the quark and lepton masses. Similarly, the doublet-triplet splitting problem is intimately connected with the proton decay rate. Finally, a family symmetry, which is imposed to give some understanding of the observed pattern of quark and lepton masses and mixings, has important consequences for many other aspects of the theory.

In the next section we discuss the avor sector of the elective theory at M $_{\rm G}$. It involves just four operators, and we study how this structure m ay emerge from symmetries of the full theory. In sections 3 and 4 we focus on the GUT symmetry breaking and Higgs potential respectively. Section 4

also includes the mechanisms for doublet-triplet splitting, for solving the problem and constraints from proton decay. In section 5 we consider neutrino masses. Finally in section 6, we discuss the full set of symmetries of the theory. In section 7, we give our general conclusions and directions for further work.

2 Charged Ferm ion M asses

We take the avor sector of our model to be that of model 6 in paper I. The ferm ion mass and mixing angle predictions which result from this avor sector, for a particular choice of input parameters, are shown in Table I, reproduced from paper I.

In addition to these predictions, the set of inputs in Table 1 predicts: $\sin 2 = :46$, $\sin 2 = :49$, $\sin 2 = :84$, and $J = 2:6 = 10^5$.

We have chosen model 6 of paper I since this model gives results which are in best agreement with the data. Model 9 of paper I generally gives values of V_{cb} which are larger and model 4 seems to have too little CP violation. Of course these problems may in fact be solved by corrections to these leading order results.

The avorsector is specified by a particular set of four operators fO $_{33}$; O $_{32}$, O $_{22}$; O $_{12}$ g. Three of these operators { O $_{33}$; O $_{32}$, and O $_{12}$ { are uniquely specified by choosing model 6. On the other hand there are 6 choices for operator O $_{22}$, as all give identical entries in the charged ferm ion Yukawa matrices. In order to construct the theory above M $_{G}$ one of these operators must be chosen. This am biguity is real. Perhaps further study m ight reveal that only one of these operators is preferred by sym metry arguments. In the meantime we have made a particular selection.

The four e ective ferm ion m ass operators chosen are given by

respectively with $a_1; a_2 \quad M_G$ and $a \quad V_0 > M_G$. The singlet S_M is assumed to get a vev M. The superspace potential for these elds is discussed in the next section.

Consider the sym metries which are necessary in order to guarantee these and only these ferm ion mass operators. First it is clear that adjoints with distinct vevs appearing in the operators of eqn. 1 cannot be interchanged. Interchanging them would lead to di erent C lebschs and a new, unacceptable model. For each distinct vev we need one adjoint chiral supermultiplet. A lso changing the position of the adjoints in each operator would alter the C lebschs and again lead to an unacceptable theory. In order to prevent interchangeability of the adjoints we assume they carry a di erent value of one (or possibly more) U (1) charges. However, we can only prevent the positional changes of adjoints in these operators by studying the sym metries of the theory above v_{10} , as we now demonstrate.

Each operator can be obtained via a unique tree diagram constructed with dimension 4 couplings to intermediate heavy 16 and $\overline{16}$ states. In g. 1 we show the explicit decomposition for the elective operators of eqn. 1.

We now assign unique U (1) charges to the heavy $16;\overline{16}$ states such that no other dimension 4 couplings (other than those already appearing in the vertices of g. 1) are consistent with the charge assignment. If this is possible then no other elective ferm ion mass operators can be obtained to leading order when integrating out the heavy $16;\overline{16}$ states. Note the heavy $16;\overline{16}$ states have mass greater than M $_{\rm G}\,$ since the SO (10) singlet $\,$ eld $\rm S_{M}\,$ and adjoint A are assumed to have vevs of order M ; v_{10} respectively with M v_{10} > M $_{\rm G}$. The choice for O $_{22}$ will a ect the possible U (1) charges of the interm ediate states. Not all choices are allowed. Note also that the Higgs 10 coupling to the ferm ion m ass operators carries the label 1. Two 10s are necessary for the doublet-triplet splitting mechanism used below, but only 10_1 couples to ferm ions. This will be enforced by symmetries.

The form of this superpotential is guaranteed by the symmetries discussed in section 6. In particular, an R symmetry forces it to be trilinear.

GUT Symmetry Breaking Sector 3

The superspace potential for the adjoints $A_1; A_2; \mathcal{X}$ must preserve their distinct U (1) charges. We also need 16 and $\overline{16}$ elds , to break the rank of SO (10) from 5 to 4. Finally, all states of this sector which are non-singlets under the standard m odel gauge group m ust get m ass M_G. This is necessary so that the only states with mass M_G are in the MSSM or are singlets which don't a ect the RG equations from M $_{\rm G}$ to M $_{\rm Z}$. These constraints are satis ed by the interactions



where S and S⁰ are 54 dimensional representations; ; ⁰ and $\overline{;}^{-0}$ are 16 and $\overline{16}$ respectively and $A_1; A_2; A; A_1^0; A_2^0; A^0$ are adjoints. The primed elds are necessary to preserve the distinct U (1) charge assignments for all elds. All primed elds are assumed to get zero vevs.

The superspace potential of eqn. 4 has many at directions. Once SUSY is broken these at directions will be lifted. In this paper we shall not speculate on how the combination of soft breaking terms, supergravity corrections and RG improved tree potential lifts this degeneracy to determ ine the GUT scale. We shall assume the necessary vevs and check that (a) they are consistent with a globally SUSY vacuum and (b) all states of this sector which are non-singlets under the standard model gauge group obtain mass of order M $_{\rm G}$.

The rst term forces A_1 into either the B L or T_{3R} direction but has a GUT scale barrier to a linear combination of these two directions. Thus the B L vev is natural. This is made possible by the vev of S. The third term forces \overline{A} in the X direction which is consistent with the SU (5) invariant vevs of and $\overline{}$. The 4th term allows A $_2$ to have a vev in some linear combination of Y and T_{3R} . Finally, the term s $\overline{A}_2 = {}^0; {}^{-0}A_2$ force A_2 into the Y direction. All the other terms in eqn. 4 are necessary to give mass to all states of this sector which are non-singlets under the standard model gauge group.

Above the scale v_{10} the gauge coupling is highly non-asym ptotically free. The one bop evolved gauge coupling becomes non-perturbative at about $5v_{10}$ (depending on both $v_5=v_{10}$ and on values of Yukawa couplings).

4 Higgs Sector

In the Higgs sector we distinguish between two cases which dier by the mechanism for solving the problem.

- is generated by a D term coupling of the Higgs doublets to a hidden sector eld z whose F component breaks SUSY at an interm ediate scale.
- 2. is generated by a one bop diagram containing soft SUSY breaking cubic scalar interactions. Thus is proportional to the soft SUSY breaking parameter A [7].

In both cases, the reason for having a magnitude which is related to the scale of supersymmetry breaking is no longer a puzzle. The symmetries of the theory guarantee that the Higgs doublets are massless at tree level in the superpotential, and the term arises by introducing supersymmetry breaking into a higher dimension D operator. The two cases dier as to the origin of the D operator. In the rst case it is present as a non-renormalizable operator from the P lanck scale, while in the second case it is generated by a GUT-scale loop.

H igher dimension D operators generate the desired parameter so easily that its origin should not be considered a problem. M uch m ore serious for grand unication is the large m ass splitting required between the H iggs doublets and their color triplet partners. There are several mechanisms which have been invented to avoid the netunings of non-supersymmetric GUTs and of the D in opoulos-G eorgi supersymmetric GUT [1]. In this paper we use the D in opoulos-W ilczek mechanism [8]. In the context of SO (10), this mechanism requires an adjoint eld which points precisely in the B L direction. Our theory already contains such a eld, A_1 , with the vev shown in eqn. (2). This mechanism is a very natural choice in theories where vev alignments are needed to give ferm ion mass predictions.

4.1 Case 1.

In eqn. 5 we give the Lagrangian for the Higgs sector.

where S_7 is assumed to get a non-zero vev. The nst two terms (F terms) are necessary to incorporate the D in opoulos W ilczek mechanism for doublettriplet splitting. In the doublet sector the vev A_1 vanishes leaving two doublets massless. The massless H iggs doublets lie solely in the 10_1 . Thus the SO (10) relation $_{b}=_{t}=1$ remains exact. The last term is a D term and is necessary to solve the problem. The situation for proton decay is identical to case 2 below and so we save the discussion until then.

In this case the hidden sector $\mbox{ eld }z$ is assumed to get a SUSY breaking vev such that $F_z ~~M$.

4.2 Case 2.

The 3rd and 4th terms have been introduced solely to solve the problem. D oublet-Triplet Splitting The mass matrix for the SU (5) $\overline{5}$; 5 states in 10_1 ; 10_2 ; ; 0; ; $\overline{}$; $\overline{}$ is given below.

Higgs doublets

In the doublet sector the vev A_1 vanishes leaving two doublets massless. The massless Higgs doublets, in this case, are a linear combination of the doublets in 10_1 and those in and \overline{A} s a result the boundary condition $_{b}=_{t}=1$ is corrected at tree level. The ratio is now given in term s of a ratio of m ixing angles. In principle this could allow much smaller values of tan than those predicted when $_{b}=_{t}=1$. However, in practice the predictions for $m_{u}=m_{d}$ and for the CP violating parameter J require large tan [9]. Electroweak symmetry breaking with large tan can occur with a moderate ne tune of one part in tan [10].

P roton decay

The leading contribution to proton decay comes from the exchange of superheavy colored Higgsinos [11]. The rate for proton decay in this model is set by the quantity (M^t)₁₁¹ where M^t is the color triplet Higgsino mass matrix. We nd (M^t)₁₁ = $\frac{S_7}{A_1^2}$, which must be smaller than $\frac{1}{\tan M_G}$ in order to be consistent with proton decay limits. C learly this relation may be satis ed for S₇ su ciently smaller than M_G. Note there are no heavy color triplet Higgsinos in 10₁ become D irac fermions (with mass of order M_G), but they do not mix with each other. The ratio S₇=M_G cannot be taken too small how ever. This is because the doublets in 10₂ are becoming lighter than their triplet partners. This will a ect the RG running of the gauge couplings and is thus constrained by the low energy data.

In this case is generated at the one loop level, for example by the diagram of g.2. We nd $\frac{4}{16^{-2}}$ A. Thus is naturally smaller than the scale of SUSY breaking. This is a nice feature since it is consistent with a large tan solution.

5 Neutrino Masses

A lthough right-handed neutrinos are included in the 16_i , i = 1;2;3 this does not mean that the three electroweak doublet (left-handed) neutrinos are massive.

An R symmetry, discussed in the next section, forbids operators of the form $16_i \ 16_j$ which could generate M a prana masses for the right-handed neutrinos. To avoid D irac neutrinos with weak-scale masses, extra elds must be introduced which couple to _R at the renormalizable level. The form of these interactions is very model dependent. In the simplest case the three left-handed neutrinos are massless. This is case 1. In case 2 we show how to generate mass for the left-handed neutrinos.

5.1 Case 1. - M assless N eutrinos

In this case we introduce three SO (10) singlets $ekls N_i; i = 1; 2; 3;$ one for each family. The superspace potential for neutrinos is given by

W hen $\overline{}$ gets a vev the right-handed neutrinos m ix with the singlet states to get D irac m asses of order V. The left-handed neutrinos remain m assless.

5.2 Case 2. - M assive N eutrinos

In this case there are several apriori acceptable possibilities. The di erent choices are described in terms of an electrice symmetric mass matrix M_{ij} = M_{ji} for the states N_i; i = 1;2;3. For every zero eigenvalue of M_{ij} there is a corresponding massless neutrino. Thus with only one term, for example M₂₃, the and neutrinos would be massive and the electron neutrino would be massless. There would nevertheless be mixing among all three.

Choosing a set of operators will a ect the sym metries of the theory. We can only accept operators which preserve enough sym metry to keep the theory natural. One example of an allowed neutrino mass sector is given by the following superspace potential. In this case we have electively M $_{22}$ and M $_{13}$ non-zero.

Inserting vevs yields masses for the $_{\rm R}$ in the $16_{\rm i}$, suppressed by various powers of v_{10} =M and M $_{\rm G}$ =M. These masses take part in the see-saw mechanism giving small masses to the left-handed neutrinos. The suppression factors for the $_{\rm R}$ masses leads to enhancements of the masses of the light neutrinos, which can have phenomenologically important consequences. Since there are two operator coe cients in equation 9, the 3 masses and 3 realmixing angles of the light neutrinos are given in terms of only 3 unknown parameters (two magnitudes and a phase).

6 Sym m etries

The theory of this paper is the most general consistent with several symmetries.

Continuous R Symmetry | Since the theory is scale invariant it has a continuous R symmetry in which all super elds have charge 1 and the superspace potential has charge 3. W ith this symmetry we need only consider dimension 4 operators in the superspace potential below M. This R symmetry is a U (1) Peccei-Quinn symmetry. It solves the strong CP problem and leads to an invisible axion [12].

Fam ily Re ection Symmetry { This symmetry eliminates dimension 4 baryon number violating operators and is equivalent to R parity. Thus the LSP is stable. Under this symmetry all states in the set $f16_i$; N_i; i = 1;2;3; N₁⁰; N₃⁰; a; a = 1; ;9 g are odd and all other states are even.

Z (4) R Symmetry { This symmetry guarantees that only 10 couples to fermions. Under this symmetry all primed elds, S_6 ; S_7 and 10_2 are odd; the set f 16_i ; i = 1;2;3; a; a = 1; ;9 g transform by i f g; all other elds are even.

U (1) F lavor Sym m etries. These sym m etries guarantee that the dim ension 4 operators included in equations (3 - 8) are \natural" in the sense that no other dimension 4 operators are consistent with the family rejection symmetry, the Z (4) R symmetry and the U (1) symmetries. These U (1) symmetries are the only symmetries of the theory which distinguish between the three generations, 16_i . They are largely responsible for determining which avor operators are generated; hence, we call them avor symmetries. The more terms in the superspace potential the fewer continuous symmetries exist. For example, consider the Higgs sector as in case 2 (eqn. 6) and the neutrino sector of eqn. (8). This theory has 49 elds and 47 superpotential interactions, hence there are two U (1) avor symmetries. We have checked

that these two symmetries rule out the addition of any new terms to W. The other H iggs sectors and neutrino sectors which we have discussed have fewer interactions, and correspondingly more U (1) symmetries.

The above symmetries are su cient to limit the avor interactions of the superpotential to those which lead to the desired ferm ion mass predictions. Furtherm ore, since all non-renorm alizable F term s are forbidden, the predictions can be computed exactly in terms of the renorm alizable coe cients. In general it is possible that higher dimension D operators, allowed by the above symmetries, could lead to corrections to the avor predictions. However, if the supersymm etry breaking occurs in a hidden sector of a supergravity theory, avor changing phenom enology leads to considerable constraints on the form of the higher dimension D operators. This phenomenology requires scalar masses and trilinear interactions to be close to universal, suggesting that the D term's have a trivial avor structure, as would occur if they possessed a U (N) invariance [13]. In this case the higher dimension D operators do not a ect the ferm ion mass predictions. A further consequence of the U (N) invariance of the K ahler potential is that the operator $[z \quad 10^2_1]_b$ of equation (5), which was a possible source of the term, is absent. Hence, the term should be generated radiatively as in section (4.2). $\{$

In a supersymmetric theory, it may be questioned whether there is any need to guarantee the form of the desired interactions by symmetries. It has been argued that string theories can lead to low energy elective theories with interactions which are not the most general allowed by the low energy symmetries. This makes the task of model building easier. It is probable that a much simpler grand unifed SO (10) theory can be written down if

In the limit that the gaugino mass is much larger than the scalar mass and A term s at M $_{\rm P}$, the avor changing problem is alleviated and there is no need for universal scalar masses and A term s. In this case the D term s could give corrections to the ferm ion mass predictions, suppressed compared to the leading term s by powers of v_{10} =M $_{\rm P}$. Also the term could occur via the operator $[z \ 10^2_1\,{\rm b}$.

one adopts this view point. However, in a sense it makes model building too easy. For example, as a avor sector one can simply write down the four avor operators of equation 1. There is no symmetry to forbid all other operators, but no such symmetry is needed. Further operators can be added at will. While model building is much easier in this approach, it leads to much less understanding: the origin of avor is hidden in physics above the string compactication scale. By contrast, in this paper avor physics is determined by a set of global U(1) symmetries beneath the string scale ^k

7 Conclusions

We have presented a complete SO (10) SUSY GUT incorporating the fem ion m ass predictions of m odel 6 of ref.[4]. We have addressed the issues of doublet-triplet splitting, proton decay, problem and fem ion m asses and m ixing angles. In the SUSY lim it the superspace potential has m any at directions, one of which appears consistent with low energy data. In particular, in this desired vacuum the GUT vevs align precisely in the directions necessary to yield light H iggs doublets and several ferm ion m ass predictions. The lifting of the degeneracy of these at directions has not been studied, and will lead to interesting constraints on the form of the supersymmetry breaking terms. The at directions im ply the existence of light supermultiplets which are singlets under the standard m odel gauge group. M oreover since the continuous U (1) symmetries are spontaneously broken at M $_{\rm G}$ the theory also includes an invisible axion and possibly several m assless G oldstone bosons. These m ay be problem atical in a cosm ological context and also require further study.

In this theory we can now calculate corrections to zeroth order ferm ion m ass and m ixing angle predictions[4]. Threshold corrections at the GUT

scale include corrections to (3) coming from integrating out the heavy 16 $\overline{16}$ pairs (only the zeroth order result in a power series in ratios of scales has been included in the analysis of ref. [4]). There are also radiative corrections to gauge and Yukawa parameters; for example, the radiative corrections to the gauge couplings can be signi cant in the limit S₇ M_G and thus the low energy measurement of ;sin² w and s M_Z) could constrain the proton decay rate.

Finally, several groups are now working to obtain SO (10) SUSY GUTs from string theories [15]. We hope that theories like ours can be used as a guide to nd a realistic fundam ental theory of nature.
