## Radiative Corrections to Charged Higgs Production in ete Colliders

Abstract

We study one loop electroweak corrections to the production of a pair of charged H iggs bosons through an intermediate Z-boson or photon. In particular, we consider the e ects of graphs with top and bottom quarks and squarks in the loop within the context of the M in im al Supersym metric M odel. We not that the corrections can be considerable, and typically are of the order of 10% to 20%.

The m inim al supersym m etric standard m odel (M SSM) [1] provides a very interesting extension of the standard m odel. The absence of quadratic divergencies in this m odel is an imm ediate consequence of its supersymm etric nature. The ensuing improved UV behavior am eliorates the technical aspect of the naturalness problem that haunts the standard m odel (SM). Furtherm ore, it is tempting to believe that the unication of the gauge coupling constants is not coincidental [2]; the required SUSY breaking scale is small enough to avoid the reintroduction of the naturalness problem, and the unication scale is large enough to suppress proton decay yet smaller than the Planck scale. Indeed, a supergravity theory with non-perturbative SUSY breaking may even explain the hierarchy of energy scales.

The Higgs sector of the M SSM contains two neutral Higgs bosons, a pseudo scalar Higgs boson, and a pair of charged Higgs bosons [3]. The next generation of  $e^+e^-$  colliders, notably LEP2 and the NLC, will be able to probe the M SSM Higgs sector and test the model. It is therefore important to understand the production and decay of charged Higgs bosons in detail.

Radiative corrections in the M SSM can be considerable because of the large mass splitting between the top and bottom quark. For instance, the tree-level upper bound on the lightest H iggs mass is M  $_{\rm Z}$ , but radiative corrections increase this upper bound to 130 G eV [4]. Here we study the one-loop electroweak corrections to the production cross-section of a pair of charged H iggs bosons in e $^+$  e colliders.

We work in an on-shell scheme [5], in which M  $_{\rm Z}^2=1\!=\!4\,(g^2+g^{0^2})v^2$  and M  $_{\rm W}^2=1\!=\!4g^2v^2$ , with  $v^2=v_t^2+v_b^2$ , are defined to be the physical masses of the vector bosons. Similarly, we define the tree-level expression for the mass of the pseudoscalar in terms of the renormalized parameters to be the physical mass. The residues of the poles of the photon and the pseudoscalar propagators are equal to one in our scheme, and the mixing between the photon and the Z boson vanishes at zero momentum. The normalization conditions that complete the set relevant to this paper are imposed on the coupling of the pseudoscalar to charged leptons

and the coupling of the photon to electrons

The angles  $_{W}$  and are de  $\underset{q}{\text{ned by sin}^{2}}$   $_{W}$  = 1 M  $_{W}^{2}$  =M  $_{Z}^{2}$  and tan =  $v_{b}$ = $v_{t}$ , and the electric charge is  $e = gg^{0} = g^{2} + g^{0}$ .

We consider the production of a pair of on-shell charged Higgs bosons. The momenta k and  $k^0$  of the outgoing charged Higgs bosons therefore satisfy  $k^2=\,k^{0^2}=\,$  M  $_{\rm H}^2\,$  . The amplitude for the process is given by

Here  $v_z=1=2$   $2\sin^2$  w ,  $a_z=1=2$ , v=1 and a=0. The form factors  $f_z$ ,  $f_z^0$ , f and  $f^0$  are equal to one at tree-level. Radiative corrections manifest them selves in modications of these form factors

where the tilde indicates renorm alized quantities with in nities subtracted in accordance with the normalization conditions. The various terms in the modi ed form factors are related to the gauge boson self-energies,  $^{\sim}_{ij}=i X_{ij}g+i B_{ij}p$  p with i;j=;Z, to the loop contributions of the vertices,  $^{\sim}_{Z\,H^{+}H}=i X_{Z\,H^{+}H}$  k  $i X_{Z\,H^{+}H}^{0}$  and  $^{\sim}_{H^{+}H}=A_{H^{+}H}$  k  $A_{H^{+}H}^{0}$ , and to the charged Higgs boson self-energy,  $i X_{H^{+}H}^{d}=\frac{d}{dp^{2}} Y_{H^{+}H}^{d}$ . We calculate one-loop oblique and vertex corrections. As large radiative corrections are expected to arise from the high value of the top quark mass, we furthermore limit our calculation to loops with top and bottom quarks, and with stop and sbottom squarks. In this approximation there are no contributions from box diagrams. The differential cross-section therefore has the characteristic  $\sin^{2}$  scattering angle dependence of s-channel processes. The total cross-section in terms of the form factors is

where  $^{\rm p}$  s is the center of m ass energy, and M  $_{\rm H}$  is the renorm alized charged H iggs boson m ass [6].


- Fig. 1. Renorm alized charged Higgs m ass as a function of tan  $\,$  for dierent values of the top quark mass. In solid we plot the CDF central value m  $_{\rm t}=174$  GeV . In dashes we have the 1  $\,$  deviations from the central value: m  $_{\rm t}=158$  and 190 GeV . In dotdashes we plot the 95% c.l. lower lim it m  $_{\rm t}=131$  GeV . The horizontal dotted line corresponds to the tree level charged Higgs mass.

Radiative corrections enter the total cross-section both through corrections to the charged Higgs boson mass M  $_{\rm H}$  and through corrections to the form factors. Corrections to the charged higgs boson mass M  $_{\rm H}$  manifest them selves in the fact that the tree-level mass relation M  $_{\rm H}^2$  = M  $_{\rm W}^2$  + M  $_{\rm A}^2$  is not longer valid. As shown in Fig. 1, departures from this mass relation are most pronounced for very small and very large values of tan .

In Fig. 2a we plot the total cross-section as a function of the center of mass energy  $^{\rm p}_{\rm -}$  s for various values of tan  $\,$  and the pseudoscalar m ass M  $_{\rm A}$  . W e plot the tree-level cross-section (dashed lines) and the cross-section including all one-loop corrections (solid lines) within our approximations. All soft SUSY breaking squark mass param eters are equal to M  $_{SUSY}$  = 400 G eV , and the Peccei-Q uinn sym m etry breaking parameter as well as the soft SUSY breaking trilinear couplings are taken to be zero, a choice that implies no mixing in the squark sector. The top quark mass is taken to be m  $_{\rm t}$  = 174 GeV, the central value of the recent CDF result [7]. Because the curves in Fig. 2a re ect a  $\times$  xed value of the pseudoscalar higgs boson mass M  $_{\rm A}$  , radiative corrections to the charged Higgs boson mass cause a shift in the production threshold; to lower s for low values of tan, and to higher s for high values of tan . For intermediate values of tan the dashed and the dot-dashed curves almost coincide, even near threshold, re ecting the negligible radiative corrections to the charged Higgs boson mass in this range. The solid curve corresponding to tan = 0.5 has a discontinuity in slope at  $^{P}$  = 2m  $_{t}$  = 348 GeV. This discontinuity stems from the triangular graph with two top quarks and a bottom quark in the internal lines, and its e ect is enhanced at low values of tan . In Fig. 2b we again show the cross-section as a function of the center of m assenergy  $^{\rm p}$  s, but now for xed values of the charged higgs boson m ass M  $_{
m H}\,$  . A coordingly the production threshold at tree-level (dashed line) and the at one loop (solid line) coincide, but the values of the pseudoscalar higgs m ass M  $_{\rm A}$  at tree and one-loop level di er. For center of m ass energies well above threshold, the solid lines show that for our choice of param eters one-loop corrections to the form factors reduce the cross-section by 10% to 25% with respect to the tree-level cross-section...

In Fig. 3 we plot the ratio between the one-loop renorm alized cross section and the tree level cross section, as a function of tan for various values of the top quark m ass for xed values of the pseudoscalar m ass M  $_{\rm A}$  (dashed lines). To separate the e ect of the corrections to the charged H iggs m ass, we plot the ratio between the one-loop renorm alized cross section and the cross section with corrected M  $_{\rm H}$ , but form factors

equal to one (solid lines). Solid and dashed lines coincide at interm ediate values of tan because in that region the corrections to the charged H iggs m ass are negligible, as can be seen in Fig. 1, where the renormalized charged H iggs m ass is shown as a function of tan for the same values of the top quark m ass. We appreciate from Fig. 3 that the corrections to the cross section are typically between -10% to -20% in the intermediate region of tan for our choice of parameters. For more extreme values of tan corrections can be larger and can have either sign. These large corrections stem mainly from corrections to the form factors.

Note: While we were completing this work we received a preprint concerning a similar calculation [8].






