Domain Walls in a FRW Universe

Abstract

We solve the equations of motion for a scalar eld with domain wall boundary conditions in a Friedmann-Robertson-Walker (FRW) spacetime. We nd (in agreement with Basu and Vilenkin) that no domain wall solutions exist in de Sitter spacetime for h H =m 1=2, where H is the Hubble parameter and m is the scalar mass. In the general FRW case we develop a system atic perturbative expansion in h to arrive at an approximate solution to the eld equations. We calculate the energy m om entum tensor of the dom ain wall con guration, and show that the energy density can become negative at the core of the defect for some values of the non-minimal coupling parameter . We develop a translationally invariant theory for uctuations of the wall, obtain the e ective Lagrangian for these uctuations, and quantize them using the Bunch-Davies vacuum in the de Sitter case. Unlike previous analyses, we nd that the uctuations act as zero-mass (as opposed to tachyonic) modes. This allows us to calculate the distortion and the norm al-norm al correlators for the surface. The norm al-norm al correlator decreases logarithm ically with the distance between points for large times and distances, indicating that the interface becomes rougher than in Minkowskispacetime.

1 Introduction

The form ation of topological defects in a cosm ological phase transition is a basic result in particle cosm ology lore [1, 2]. The existence of defects provides us with a powerful tool which both constrains particle theory models, such as those containing domain walls [3] and magnetic monopoles [4], and solves some outstanding cosm ological problem s, such as the form ation of structure with the use of cosm ic strings [2, 5]. Furtherm ore, during out-of-equilibrium phase transitions, topological defects such as interfaces (domain walls) are important ingredients for the dynam ics of phase separation and phase coexistence.

It has always been assumed that if a eld theory de ned in M inkowski spacetime admits topological defects, the same will be true in an expanding universe, and that furtherm ore, there will not be any signi cant di erences in the physical characteristics of these defects. Recently, however, Basu and Vilenkin [6] have shown that defects in a de Sitter background can have properties that are quite di erent from defects in at spacetime. In this work, we continue and extend this program by analyzing the equations of motion for a dom ain wall in a background Friedmann-Robertson-Walker (FRW) spacetime. We nd that although these equations cannot be solved analytically in general, a system atic perturbative expansion can be set up, with the small parameter h H=m being the ratio of the correlation length of the eld to the horizon size. Such a perturbative expansion arises naturally from the requirement that the width of the domain wall be much smaller than the particle horizon, to allow for kink boundary conditions within the microphysical horizon. The zeroth order solution is taken to be the standard at spacetime domain wall con guration, except that it is a function of the physical spatial coordinate. The higher order term s in h are then solved for in a system atic perturbative fashion. We can also analyze the de Sitter case num erically; we nd that we agree with the results of Basu and Vilenkin concerning the fact that for su ciently large values of h, no wall solutions exist { when the horizon size is sm aller than the dom ain wallwidth, a kink con guration cannot t in the horizon.

W e next perform an expansion in the physical spatial coordinate that is nonperturbative in h, and use it to exam ine the behavior of the energy m om entum tensor for the wall near the origin. This is of interest due to the possibility that a more natural form of in ation may occur in the core of the defect, where the eld is trapped in the unstable vacuum [7].

In curved spacetime, renormalization arguments suggest that, in general, a coupling to the Ricci scalar has to be introduced in the bare Lagrangian. We not that such coupling is responsible for very remarkable elects that result in a change of sign of the stress tensor at the origin. In fact, we see that this elect can also happen in at spacetime, if the so-called improved stress tensor [8] is used.

We derive the elective Lagrangian for the uctuations perpendicular to the wall. We nd corrections beyond the \N am bu-G oto" action (the 3-volum else est by the worldsheet of

the wall) in a consistent expansion in derivatives. We also nd non-trivial contributions to the surface tension from gravitational eects.

W e use this e ective Lagrangian to address the question of whether the shape of the wall uctuates, or whether it remains at at long distances and long times after the form ation of the defect. G arriga and V ilenkin [9] have discussed this question to a certain extent, how ever we nd that by using collective coordinates the long-wavelength uctuations are identied with G oldstone modes and the instability found by them is avoided.

In the next section we set up our ansatz and perturbation expansion. Section 3 deals with the energy momentum tensor for the wall in an FRW universe. We not that interesting behavior can occur by making use of the coupling R² of the eld to the Ricci scalar R. In section 4, we analyze uctuations of the wall. We dier from Garriga and Vilenkin in our treatment of translational invariance. The fact that the wall is located at a particular point along the z-axis, say, would appear to break this symmetry. However, translational invariance can be restored by use of the collective coordinate method. Doing this, we arrive at a true N am bu-G oldstonem ode for the uctuations, as opposed to one with negative mass² as found by Garriga and Vilenkin. Several equal (com oving) time correlation functions that determ ine the behavior of the shape of the wall are computed, and we not that their spatial fall-o is much slower than in at M inkow ski spacetime at long times. This leads us to the conclusion that the surface remains \rough" at large separations.

Section 5 contains our concluding remarks and some cosm ological implications of our results.

2 The Domain Wall

D om ain walls (interfaces) are eld con gurations with non-trivial topological boundary conditions. These boundary conditions dem and that the eld vary substantially within a typical spatial scale that is usually determ ined by the (nite tem perature) correlation length

 m^{1} , with m the, in general tem perature-dependent, e ective m assof the eld.

In FRW cosm ologies there is another important scale, the microphysical horizon size $d_h = H^{-1}$ where H is the Hubble parameter. Causality implies that the region in which the scalar eld can vary appreciably must be subhorizon sized, since only then can the boundary conditions that de ne the wall t inside the horizon. Thus we expect that the notion of a dom ain wall will only make sense if H = m 1.

W hen H = m 1, we expect that the dom ain wallpro lew illexhibit only sm all deviations from the M inkowski spacetime pro le. We can then study the dierences in a power series expansion in $H = m = -d_h$. Consider a scalar eld with potential

in a FRW spacetime with metric $g = diag(1; \vec{a}; \vec{a}; \vec{a})$, and Hubble parameter H <u>a</u>=a (where <u>a</u> da=dT). The second term couples the eld to the Ricci scalar R = 6(2H² + H-). Such a term is required for consistency as it will be generated by quantum corrections in general; the only xed point is = 1=6 which corresponds to conform alcoupling [10]. The equation of motion is

where r is the derivative with respect to co-m oving spatial coordinates fX;Y;Zg. It is convenient to de ne the following dimensionless quantities

Note that ! is a (dimensionless) physical coordinate. For power-law expansion (PLE) $a(t) = t^n$, we have = 4 1=n. In the radiation dominated (RD) and matter dominated (MD) at universes respectively, _{RD} = 2 and _{MD} = 2.5. In de Sitter spacetime _{dS} = 4 (or equivalently, we can take n = 1).

W e will assume a domain wall (kink) along the z-axis and that the corresponding eld con guration is independent of the transverse coordinates, so that we are considering a at interface.

The scale factor dividing the (com oving) Laplacian in eq. (2) suggests the following ansatz for the kink con guration:

Such a solution obeys

where a prime means @=@!. The right-hand side (RHS) vanishes for de Sitter spacetime, and is 0 (h^4) for PLE.

In the case of de Sitter spacetime, the elect of non-zero conformal coupling (i.e. \pm 1) can be absorbed in a simple rescaling of variables:

For PLE, this introduces additional 0 (h^4) term s on the RHS of eq. (5), since -60.

Except to discuss the energy-m om entum tensor T , we will hereafter work in the rescaled theory (and drop the bars), writing

and taking ∞ boundary conditions" (1;h) = 1. All results for PLE are thus valid only to 0 (h^2).

2.1 W alls in de Sitter Spacetim e: N um erical Solution

The di erential equation (5) is, in general, a partial di erential equation in two variables, and not easily am enable to num erical study. As we see in eq. (7), ignoring the RHS would introduce errors at O (h^4) for PLE. However, in de Sitter spacetime, where h is constant, we have an ordinary di erential equation, for which we can not exact num erical solutions. Indeed, this was done by Basu and V ilenkin [6], and our results appear to agree with theirs.

O ur results are plotted as thin curves in Fig. 1. The slope at the origin was chosen (by a shooting algorithm) by requiring smoothness through the point ! = 1=h (m arked with a tick). As found by Basu and Vilenkin [6], solutions only exist when $h^2 < 1=4$. (For PLE, if one insists on ignoring the RHS of eq. (7), solutions only exist when $h^2 < 1=$.)

We see the kink has been attened out by the e ects of the cosm ological expansion. The slope at the origin $a_1 = 0(0;h)$ decreases with h^2 as shown in Fig. 2, vanishing at $h^2 = 1=4$. In other words, for a topologically stable solution to exist, the horizon size must be greater than the correlation length (by a factor of 2).

2.2 Expansion in h^2

A lthough a numerical solution is available in the case of de Sitter, the general case is extrem ely di cult to analyze numerically, since we now have a non-linear partial di erential equation in two variables. However, when $h^2 = 1$, we can solve eq. (7) in a system atic perturbative expansion in h^2 , and the rst-order result will be valid for both de Sitter and PLE cosm ologies. We write

Here s is the kink con guration which solves eq. (7) for h = 0 (at spacetime):

This h = 0 kink is shown as a dashed curve in Fig. 1. Note that ${}_{s}^{0}(0) = 1 = \frac{p}{2}$.

Since s has the correct asymptotic behavior, we must set $^{(n)}(1) = 0$. To leading order in h^2 , (!) obeys

The solution may be found by elementary methods once a solution of the hom ogeneous equation is found. Such a solution is easily available, since translational invariance of the unperturbed di erential equation guarantees that

is a \zero m ode" of the operator \hat{O}_s of quadratic uctuations around the kink con guration.

Another linearly independent solution $_2(!)$ having unit W ronskian with $_1(!)$ can be found by elementary methods:

where we have chosen this solution to vanish at the origin. Finally the storder solution can be written

where the coe cients a; b have to be determ ined from the boundary conditions. Notice that $_{1}(!)$ is sym m etric whereas $j(!);_{2}(!)$ are antisym m etric functions of !.

Note that $_2(!)$ diverges exponentially as ! ! 1. To render the solution nite and to satisfy the boundary conditions, we must choose:

The boundary condition at in nity does not determ ine the constant a. Notice that the term $a_1(!)$ represents a local translation of the wall. Clearly the freedom of choice of a relects the underlying translational invariance. If we dem and that the wall position be at the origin, we must dem and that $^{(1)}(! = 0) = 0$; this leads to a = 0.

Thus the nalsolution to this order that satis as the boundary conditions and keeps the wall centered at the origin is given by

The results for de Sitter spacetime (=4) are shown as thick curves in Fig. 1. ⁽¹⁾ (!) for =4 is plotted in Fig. 3. This approximation underestimates the distortion away from

the h = 0 kink, and does not see the singularity at $h^2 = 1=4$, which is well beyond the regime of validity of the perturbative expansion in h^2 .

It is straightforward to see that the structure of the perturbative expansion persists to all orders. In fact we nd that

with the same dimension of the solutions of the same as (13) with $j^{(n)}$ is obtained from the solutions up to order n 1. Clearly the same functions $_1(!)$; $_2(!)$ generate the solutions, as these are the two linearly independent solutions of the hom ogeneous dimensional equation $\hat{O}_s = 0$. Thus the general form of the solution is the same as (13) with $j^{(n)}$ replacing j and coe cients a ${}^{(n)}$; $b^{(n)}$ replacing a; b.

By the same argum ents presented before, a nite solution at in nity requires that

The source term $j^{(n)}(!)$ is constructed from iterations up to order (n - 1), and for n = 1 it is given by derivatives of the unperturbed kink solution that vanish at ! = -1. It is straightforward to prove by induction that the source term $j^{(n)}(!)$ is antisymmetric and vanishes exponentially as ! ! - 1. Therefore $b^{(n)}$ is nite to all orders. Translational invariance suggests that $a^{(n)} = 0$ as before, and the the solution to order n is antisymmetric and this property ensures that the source term for the next order iteration is antisymmetric again. Thus we are led to the conclusion that the general form of the perturbative solution is given by eq. (15) with j(!) replaced by $j^{(n)}(!)$, and the only complication in carrying out this program to any arbitrary order is to not the source term iteratively. C learly this will be a highly non-local function because of the nested integrals, and the num erical evaluation will become m ore cumbersome in higher orders, but in principle this scheme will yield a consistent perturbative expansion. C learly we have no way of determining the radius of convergence of such an expansion.

2.3 Expansion in !

The eld con guration corresponding to a dom ain wallhas most of the gradient and potential energy di erence (with respect to the broken symmetry vacuum) localized in a spatial region of the order of the correlation length. Most of the contribution to the energy momentum tensor, after subtracting of the vacuum value, will arise from this small region around the position of the dom ain wall. This motivates us to obtain the kink prolenear the origin in a power-series expansion in the coordinate !. This expansion is nonperturbative in h^2 .

The motivation for this expansion is the following: one would eventually like to study the full system of Einstein's equations and matter eld in a self-consistent sem iclassical manner.

In particular we have in m ind the question of how the presence of dom ain walls a ect the gravitational elds. Since for this task one only needs the behavior of the energy m om entum tensor, and as we argued above m ost of the contribution to its components from a dom ain wall eld con guration arise from a very localized region near the position of the interface, a power series expansion near the origin m ay capture m ost of the relevant physical features for an understanding of the back reaction of dom ain walls on the gravitational eld. This argument becomes more relevant in view of the proposal of rapid in ation at the core of topological defects [7].

In the general case of de Sitter or power-law expansion we nd the following behavior of the interface pro le near the origin:

The linear coe cient a $_1$ cannot be determ ined perturbatively, and will have to be found by solving the di erential equation, its value being determ ined by requiring sm oothness through ! = 1=h. We notice, however, that as $h^2 ! 1= from below, the rst term dom inates (even for large !) and the pro le attens out to a straight line.$

Since this expansion works best for h^2 close to 1 =, but is correct only to O (h^2) for PLE, it is only useful in this case very close to the origin.

Given a value for a_1 (from the num erical solution) as input, we display this series [through $O(!^5)$] for the de Sitter spacetime (= 4) case as the thin dot-dashed curve in Fig. 1. For $h^2 > 0.2$, where the solution is very at, the small-! expansion is valid out to well past ! = 1=h. We will use these results in the following section.

3 The Energy-M om entum Tensor

W e next turn to an exam ination of the energy m om entum tensor for the dom ain wall pro le in an FRW spacetime.

In general, the energy-momentum tensor of a scalar eld con guration is given by

At this stage we restore the non-m in in al coupling to the Ricci scalar, since, as we argued above, such a term will be induced by renormalization if not present in the original Lagrangian [10]. Its presence has two major elects: the list one is to modify the form of the energy momentum tensor, while the second is to modify the led con guration for the domain wall. Unlike the analysis of the equation of motion in the previous sections, for the case of the energy momentum tensor we can no longer rescale variables to get rid of , since $(R = g) \in 0$. Let U_0 be the potential for = 0, so $U = U_0 + (=2)R^{-2}$. Perform ing the variation of eq. (19), we nd:

The presence of the non-linear coupling to the Ricci scalar modiles the denition of the energy-momentum tensor. Even in the case of Minkowski spacetime, with h = 0, this modilection of the energy-momentum tensor produces some peculiar behavior in the near the origin, despite the fact that this coupling does not a left the equations of motion. In this case, the wall solution is just s from eq. (9), and the non-zero components of the are:

For large enough , the energy density is negative at the origin: $(t_0^0)(0) = 0$ for 1=2. For < 0, a region of negative energy density occurs away from the origin.

We can substitute the small-! expansion $= a_1! + 0 (!^3)$ (which is correct even for $\neq 0$) into eq. (22) to nd the behavior at the origin. The non-zero components of t (0) are:

These results are consistent with eq. (23), where $a_1^2 = \frac{1}{2}$ [see equation (9)].

In Fig. 4 we show exact num erical calculations of t_0^0 for de Sitter spacetim e with $h^2 \notin 0$. The behavior of t_0^0 for sm all values of h^2 (such as $h^2 = 0.02$ in Fig. 4a) is qualitatively similar to eq. (23). For larger h^2 (such as $h^2 = 0.10$ in Fig. 4b) another e ect enters, namely that the wall pro le (!) is really determined by h = h = 1, as de ned in eq. (6). W all solutions in de Sitter spacetime only exist for $h^2 < 1=4$, which implies

For example, with $h^2 = 0.10$, the wall prole attens away to = 0 as ! = 12 (where $h^2 ! = 1=4$), and $t_0^0 (!) = 1=4$.

The lesson that we learn from this analysis is that the coupling to the Ricci scalar can dram atically modify the behavior of the energy momentum tensor near the origin, and may be an interesting possibility for topological in ation at the core of defects [7]. These e ects can even arise using the \improved" energy momentum tensor [8] in M inkowski spacetime, if one starts with a general curved spacetime and then takes the at limit.

4 Fluctuations of the W all

Up to this point our study has focused on the description of a \ at" interface or dom ain wall, that is the eld pro le varies only along the direction perpendicular to the dom ain wall but is constant on the perpendicular directions. However there will be uctuations both quantum and therm al that will tend to distort locally the interface. An important question to address is the following: are these uctuations \small" in the sense that the wall remains

at at long distances, or are the uctuations in portant so that the wall becomes \rough"? We will assume that the system is at zero temperature and that only quantum uctuations are important.

We begin by deriving the elective action for the uctuations of the interface and then proceed to calculate relevant correlation functions.

We depart from the treatment of G arriga and V ilenkin [9], in that we sacri œ explicit covariance to treat translational invariance in terms of collective coordinates; however, the nal result for the action will be fully covariant. This procedure, borrowed from the usual scheme to quantize the collective coordinates associated with translations of soliton solutions [11] has m any advantages.

The position of the interface explicitly breaks translational invariance. However, a rigid translation of the interface should cost no energy due to the underlying translational sym metry. Thus the uctuations perpendicular to the interface should be represented by massless degrees of freedom since, locally, they represent translations of the interface. These are the

capillary waves or G oldstone bosons [12, 13, 14] associated with the breakdown of the translation symmetry. Translational symmetry is then restored by quantizing these uctuations as collective coordinates [11].

In terms of dimensionless comoving coordinates and the dimensionless eld , the action is $(d^4x$ is the comoving volume element in dimensionless units)

We want to incorporate uctuations of the interface solution (kink) and to obtain the elective action for the long-wavelength modes. In order to understand how to achieve this goal, it proves convenient to recall how this procedure works in M inkowski spacetime.

4.1 Goldstone Modes in Flat Spacetime

Consider rst a static kink along the z-direction. As is well known [11] there is a zero mode of the linear uctuation operator

where z_0 is the position of the kink and s is the kink solution. This mode corresponds to a translation of the position of the kink, because $s(z = z_0) + 0 = s(z = z_0 + 0)$. Translational invariance guarantees that such a perturbation does not change the energy and thus is a zero mode of the linear uctuation operator. Now consider a kink in three space dimensions, corresponding to a wallalong the z-axis and centered at z_0 . A perturbation of the form

with $p_{q} = p_{x}x + p_{y}y$, is an eigenmode of the linear uctuation operator with eigenvalue $!_{p} = p_{x}^{2} + p_{y}^{2}$ [12]. These uctuations of the interface correspond to the G oldstone bosons of the broken translational symmetry, and are the capillary waves of the interface [12, 13, 14]. The perturbed solution

corresponds to a local translation of the interface. The a_p correspond to \setminus at directions" in function space. Just as in the one-dimensional case, these G oldstone modes cannot be treated in perturbation theory, because arbitrarily large a_p for p_2 ! 0 can be accessed at

no cost in energy. We will borrow results from the one-dimensional procedure and quantize these modes as ∞ explicitly coordinates" [15].

Besides these Goldstone modes there are massive modes corresponding to the higher energy states of the one-dimensional kink with dispersion relation E (p_2) = $\frac{1}{p_2^2 + 3m^2}$ [11, 12]. Because of this gap in the energy spectrum, we can safely concentrate on the long-wavelength uctuations of the interface and obtain an elective action for these Goldstone modes, treated as collective coordinates. The coordinates a_p or the eld f (x;y) are now fully quantized. In a path integral quantization procedure, collective coordinate quantization amounts to a functional integral over all congurations of f (x;y). Clearly this procedure restores translational invariance because now the eld is invariant under z ! z+ ; f (x;y) ! f (x;y) + and the eld f (x;y) is now functionally integrated with a translational invariant measure. Passing from the original integration variables in the functional integral to the new variables including f (x;y) involves a Jacobian which is seen to be unity to the order that we are working in (see below). For a thorough exposition of collective coordinate quantization in the path integral and H am iltonian forms, the reader is referred to the original literature [11, 15, 16, 17].

4.2 Goldstone Modes in a FRW Cosmology

A fler this digression in M inkowski spacetime we are ready to extend these observations to a FRW cosm ology. Let $_{s}(!)$ be a solution to eq. (7) (the h-dependence will now be implicit), and let us take the small-gradient limit, in which

(f_{xx} are second derivatives with respect to the dimensionless comoving coordinate x, etc.) This approximation is consistent with our purpose of studying the long-wavelength uctuations on distances such that 1 x; y h⁻¹. We look for a prole of the form

Note that the substitution (z;x;y;t) = a(t)[z f(x;y;t)] does not in general solve the equations of motion, but

does, in our sm all-gradient approxim ation.

The denom inator in eq. (33) has an important physical meaning. The function f(x;y;t) determines the position of the domain wall (interface). This function induces a metric $g_{ab}^{(3)}$

on the 2 + 1 dimensional world-volume swept out by the wall, and we nd, in terms of dimensionless comoving variables,

The elective action for the displacement eld f(x;y;t) in the long-wavelength approximation, is found by following the usual procedure [12, 13, 14] which consists of computing the action for the prole (32) with (33) (this is also identified with the elective action for the collective coordinate [15]). A fler integrating by parts and discarding surface terms, we nd

where d^3x represents the 2 + 1 dimensional comoving volume element, and we have used s() = s() to eliminate the integrations linear in as well as having dened:

This is the nal form of the action for the uctuations of the interface. It exhibits the translational symmetry explicitly, and only contains derivative terms as is required of a G oldstone eld. C₀ is identified with the (usual) at spacetime surface tension, and we see that curved spacetime e ects induce a renormalization of this surface tension. The rst term (proportional to $\overline{g^{(3)}}$) is recognized as the equivalent to the \N am bu-G oto" action, which is essentially the total \world-volume" associated with the uctuation eld. The second term is thus a correction to the \N am bu-G oto" action; further corrections can be obtained in a system atic expansion in derivatives for the solution of the equations of motion.

Expanding I to quadratic order in the uctuation eld shows that the uctuations are massless:

in contrast with the results found in reference [9].

An important quantity that gives inform ation about the behavior of the uctuations of the interface is the vector norm alto the interface:

Its correlation functions, to be computed below, will give inform ation on whether departures from a at interface are signi cant.

At this point we would like to compare our result with those of G arriga and V ilenkin. These authors found that the uctuations perpendicular to the interface are associated with instabilities that m anifest them selves as a tachyonic m ass for these uctuations. From the discussion above, we are led to conjecture that the appearance of this tachyonic m ass is the result of a quantization that does not preserve translational invariance.

Because our procedure does preserve translational invariance but is non-covariant in the interm ediate steps, a direct comparison of our results is somewhat subtle. However, we can gain some insight by trying dierent parametrizations of our kink-prole. Consider the following the parametrization

instead of that of equations (32,33).

We see that is not invariant under the the rigid translation $F ! F + F_0; z ! z + F_0;$ instead a translation of the interface is compensated by a time dependent transform ation F ! $F + F_0 = a(t); z ! F + f_0$. Because of the time derivative term s in the original action such a transform ation is not an invariance of the action, which is then changed by term sproportional to h (time derivatives of the scale factor), thus breaking translational invariance. Following the same steps leading to the elective action found above, neglecting higher derivative term s, integrating by parts and rearranging term s we arrive at:

Keeping only the quadratic term s in the action we nd that the uctuation eld acquires a tachyonic mass, $m_F^2 = 3h^2$. This is the same value of the mass obtained by Garriga and Vilenkin [9]. Thus we conjecture that the scalar eld that measures departures from a at interface introduced by Garriga and Vilenkin is equivalent (at least to lowest order in derivatives) to the scalar eld F param etrizing the uctuations of the interface as in equations (38,39). As explained above, this param etrization explicitly breaks rigid translational invariance in any FRW cosm ology. The appearance of the mass term is understood as a consequence of this explicit breakdown of translational invariance, although this fact does not explain the tachyonic nature of the mass.

Thus it seems to us that there are advantages and disadvantages in both formulations. W hereas the formulation of G arriga and V ilenkin is desirable in that it maintains explicit covariance, there is the feature of instabilities associated with the tachyonic mass of the uctuations, which if our analysis is correct, indicates the breakdown of translational invariance in the quantization procedure. On the other hand, our formulation, in terms of collective coordinate quantization, sacri ces explicit covariance, although the nal result is covariant, but explicitly treats translational invariance and its restoration via the collective coordinate quantization. The collective coordinates represent massless elds as a consequence of this translational invariance.

4.3 Quantization of the Fluctuations

Q uantizing the uctuations of the interface allow sus to answer some relevant questions about the dynam ics of the interface. In particular we can answer the question that we posed at the beginning of the section that is whether the interface (wall) is at or strongly uctuating at long distances. In order to answer this question we must compute the correlation function of the vectors norm alto the interface at long distances 1 r h¹ with r the distance on the two-dimensional surface of the interface.

Since we are interested in long distance physics, we will only consider slow ly varying uctuations of the uctuation eld f and neglect higher derivative terms in the action, keeping only the quadratic terms (one can be brave and pursue a perturbative expansion but we will content ourselves here with a lowest order calculation) in the action. Repeating eq. (36),

The equations of motion for the eld f are given by:

with being the two-dimensional Laplacian.

In the most general case, the time dependence of the above equation is far too complicated to pursue analytically and one would have to resort to numerical integrations. Thus we

concentrate on the case of de Sitter expansion with scale factor $a(t) = e^{ht}$ that allows an analytic treatment.

The uctuation eld is expanded in terms of creation and annihilation operators and the mode functions which are solutions of the above equation of motion:

where the \surface tension" has been absorbed in the de nition of f to make it canonical and A is the (com oving) area of the (planar) wall.

Perform ing the change of variables on the mode functions $v_p = e^{2ht} p(t)$ the equation for p reads:

whose solutions are linear combinations of the Bessel functions. The mode functions v_p are

Im posing canonical commutation relations between f and its canonical conjugate momentum $f_f = L = f_f = f_f a^4$ leads to the relation

It is a well known feature of quantization in curved spacetimes [18] that a choice of A_p corresponds to a choice of vacuum state. A lthough we do not have a physical criterion to pick a particular vacuum state, we will choose the Bunch-D avies [19] vacuum for simplicity. Such a choice implies

W ithout loss of generality we can take $A_p = 1$. Finally, the eld f is expanded in creation and annihilation operators with respect to the Bunch-D avies vacuum state as:

A sm entioned above, we are interested on the long-wavelength uctuations of the interface at long distances and at long times after its formation. Thus we will study the regime t h¹; hr 1. Furthermore there are physical cuto s that we must introduce: the (com oving) wavelengths cannot be bigger than the horizon, and because the nature of our approximation cannot be shorter than the correlation length (the expansion is in derivatives, thus valid for slow ly varying elds on the scale of the correlation length). Therefore integrals over wavevectors will be restricted to the interval p = 1.

The uctuation eld f(x;y;t) measures the departure from a at interface. Thus a quantity of interest is the correlation function of the vector norm alto the space-like interface. This norm all vector is obtained from the induced metric on the two-dimensional surface and given by

notice from eq. (50) that < n(x;t) = 1 (to the order considered) and that the correlation function does not require any short distance subtraction. Its long time, long distance behavior is found to be

where stand for sub-leading terms that fall o fast at large r.

It is instructive to compare this result with that in M inkowski spacetime, for which < n = n > 1 ³r. C learly the interface is \rougher" in de Sitter spacetime. The result (52) raises the very interesting possibility of anom abus exponents in the correlation function. Notice that for large r the logarithm ic (infrared) singularities become strong and eventually would have to be resummed in order to obtain meaningful long distance behavior. A ssuming such a resummation of the lowest order result we obtain the long distance behavior:

This result has interesting implications. In particular, we not that at long times and distances the vectors normal to the interface are uncorrelated and the interface is \rough" rather than approximately at with small uctuations that fall-o rapidly at long distances.

This situation is very similar to that of the X-Y model and other models in statistical mechanics in 1 + 1 Euclidean dimensions (typically massless scalar eld theories) in which logarithm ic singularities sum up to anom alous dimensions [20] much in the same way. This would indeed be a tantalizing possibility that needs to be studied further, perhaps by keeping higher order terms in the elective action and resumming using renormalization group arguments. This is certainly beyond the scope of this article.

Another quantity of interest that measures properties of the interface is the distortion [9]:

We evaluated this correlation function for large times and distances (t 1=h; r 1 hr) and found

This result is consistent with that of the norm al-norm alcorrelation function (52).

This correlation function shows once again that the interface is strongly uctuating at long distances and cannot be considered at.

5 Conclusions

In this article we have focused on the properties of dom ain walls in general FRW Universes. These defects will appear during phase transitions in typical in atom theories and ultimately drive the dynamics of the process of phase separation. They may also contribute to density uctuations and perhaps to structure formation.

Our results present a rich picture of the properties of these defects. A fier analyzing numerically the case of de Sitter spacetime and assuming that the boundary conditions on the eld conguration require that the horizon size be larger than the typical correlation length we set up a systematic perturbative expansion in powers of h = H = m and worked out in detail the rst order correction from curved spacetime elds. We see then that even in situations in which the Universe is expanding slowly enough to allow us to set up our perturbation theory for defects, new phenomena occurs with de nite cosm obgical implications.

In particular, we argue that in a general FRW spacetime, consistency (renormalizability) of the theory requires a coupling to the Ricci scalar. With this coupling the energy momentum tensor of defects can show some remarkable new features, including a negative energy density at the origin. Clearly this observation brings interesting possibilities for topological in ation near the center of the defect that must be studied within the full set of Einstein's equations in the presence of this conguration. For some values of the coupling to the Ricci scalar, we nd that the energy density at the center is lower than at a distance of the order of the correlation length away from the center.

Such a behavior of the energy m om entum tensor m ay provide an interesting m echanism for scalar density perturbations.

Using collective coordinate quantization of the uctuations perpendicular to the wall, we obtained the elective Lagrangian for these uctuations in the long-wavelength approxim a-

tion. There are several noteworthy features of this elective Lagrangian: curved spacetime elects renormalize the surface tension, and we indispatematic corrections to the \N ambu" action.

We have also shown how to quantize the uctuations about a completely at wall, and how the collective coordinate procedure yields the expected G oldstone mode associated with translational invariance. This analysis then allow sus to compute correlation functions and to see that, at least in the de Sitter case, uctuations are fairly strong at long distances and long times after form ation of the defect leading to conclusion that the surface tends to be rougher than in at spacetime. These results and the method developed for the quantization of the uctuations may yield some insight on novel mechanisms to study density perturbations.

W hat we have done for walls can also be done for other defects, such as cosm ic strings. These should exhibit som e interesting behavior, especially for the uctuations, since there will now be collective coordinates associated with the internal U (1) symmetry whose spontaneous breaking gives rise to the string. Interesting possibilities are corrections to the string tension from curved spacetime e ects and also corrections to the \N am bu-G oto" action from higher derivative terms, and perhaps novel behavior of the energy momentum tensor at the core of the defect when the coupling to the R icci scalar is introduced. We are currently studying these and other issues.








Fig.1: Domain wallpro les for de Sitter space, $h^2 = f.1, 2, 24g$. Dash=kink, thin=exact, thick= sm all h^2 , dot-dash= sm all-! . ! = 1=h is marked by vertical ticks.




Fig. 2: $a_1 = {}^0(0;h)$ vs. h^2 for de Sitter space.





Fig. 3: (!) for de Sitter space.






Fig. 4: t_0^0 (!) in de Sitter space, various , $h^2 = f.02$, lg.
