# D om ain W alls in a FRW U niverse

#### Abstract

W e solve the equations of $m$ otion for a scalar eld $w$ ith dom ain $w$ all boundary conditions in a Friedm ann-R obertson $W$ alker ( $F$ RW ) spacetim e. We nd (in agreem ent w ith Basu and Vilenkin) that no dom ain wall solutions exist in de Sitter spactim e for $h \quad H=m \quad 1=2$, where $H$ is the $H$ ubble param eter and $m$ is the scalar $m$ ass. In the general FRW case we develop a system atic perturbative expansion in $h$ to arrive at an approxim ate solution to the eld equations. W e calculate the energy m om entum tensor of the dom ain wall con guration, and show that the energy density can becom e negative at the core of the defect for some values of the non-m in im al coupling param eter . W e develop a translationally invariant theory for uctuations of the wall, obtain the e ective Lagrangian for these uctuations, and quantize them using the B unch $-D$ avies vacuum in the de Sitter case. U nlike previous analyses, we nd that the uctuations act as zerom ass (as opposed to tachyonic) m odes. This allow s us to calculate the distortion and the norm alnorm al correlators for the surface. T he norm al-norm al correlator decreases logarithm ically w ith the distance between points for large tim es and distances, indicating that the interface becom es rougher than in M inkow skispaœtim e.

## 1 Introduction

The form ation of topological defects in a cosm ological phase transition is a basic result in particle cosm ology lore［1］， which both constrains particle theory models，such as those containing dom ain walls［⿳亠丷厂彡

 ofequilibrium phase transitions，topological defects such as interfaces（dom ain walls）are im portant ingredients for the dynam ics of phase separation and phase coexistence．

It has alw ays been assum ed that if a eld theory de ned in M inkow skispacetim e adm its topological defects，the sam e will be true in an expanding universe，and that furtherm ore， there will not be any signi cant di erences in the physical characteristics of these defects． Recently，how ever，$B$ asu and $V$ ilenkin $\left.{ }_{6} \overline{6}\right]$ have show $n$ that defects in a de Sitter background can have properties that are quite di erent from defects in at spactime．In this work，we continue and extend this program by analyzing the equations ofm otion for a dom ain wall in a background Friedm ann－R obertson－W alker（FRW）spacetim e．We nd that although these equations cannot be solved analytically in general，a system atic perturbative expansion can be set up，w th the sm all param eter $h \quad H=m$ being the ratio of the correlation length of the eld to the horizon size．Such a perturbative expansion arises naturally from the requirem ent that the width of the dom ain wall be much sm aller than the particle horizon， to allow for kink boundary conditions within the $m$ icrophysical horizon．The zeroth order solution is taken to be the standard at spacetim e dom ain wall con guration，except that it is a function of the physical spatial coordinate．The higher order term $s$ in $h$ are then solved for in a system atic perturbative fashion．W e can also analyze the de Sitter case num erically； we nd that we agree w th the results of Basu and Vilenkin conceming the fact that for su ciently large values of $h$ ，no wall solutions exist \｛ when the horizon size is sm aller than the dom ain wallwidth，a kink con guration cannot $t$ in the horizon．

W e next perform an expansion in the physical spatial coordinate that is nonperturbative in $h$ ，and use it to exam ine the behavior of the energy $m$ om entum tensor for the wall near the origin．This is of interest due to the possibility that a $m$ ore natural form of in ation $m$ ay occur in the core of the defect，where the eld is trapped in the unstable vacuum［in

In curved spacetim e，renorm alization argum ents suggest that，in general，a coupling to the $R$ ioci scalar has to be introduced in the bare Lagrangian．W e nd that such coupling is responsible for very rem arkable e ects that result in a change of sign of the stress tensor at the origin．In fact，we see that this e ect can also happen in at spacetim e，if the so－called im proved stress tensor［僃］is used．
$W$ e derive the e ective Lagrangian for the uctuations penpendicular to the wall We nd corrections beyond the $\backslash \mathrm{N}$ am bu－G oto＂action（the 3－volum e sw ept by the w orldsheet of
the wall) in a consistent expansion in derivatives. We also nd non-trivial contributions to the surface tension from gravitationale ects.

W e use this e ective Lagrangian to address the question of whether the shape of the wall uctuates, or whether it rem ains at at long distances and long tim es after the form ation of the defect. G arriga and V ilenkin $\left[\frac{19}{\dagger}\right]$ have discussed this question to a certain extent, how ever we nd that by using collective coordinates the long-wavelength uctuations are identi ed w ith G oldstone $m$ odes and the instability found by them is avoided.

In the next section we set up our ansatz and perturbation expansion. Section 3 deals $w$ ith the energy $m$ om entum tensor for the wall in an FRW universe. $W$ e nd that interesting behavior can occur by $m$ aking use of the coupling $R^{2}$ of the eld to the $R$ icciscalar $R$. In section 4, we analyze uctuations of the wall. W e di er from Garriga and Vilenkin in our treatm ent of translational invariance. T he fact that the wall is located at a particular point along the z-axis, say, would appear to break this sym $m$ etry. H ow ever, translational invariance can be restored by use of the collective coordinate $m$ ethod. D oing this, we arrive at a true $N$ am bu-G oldstone $m$ ode for the uctuations, as opposed to one $w$ th negative $m$ ass ${ }^{2}$ as found by $G$ arriga and $V$ ilenkin. Several equal (com oving) tim e correlation functions that determ ine the behavior of the shape of the wall are com puted, and we nd that their spatial fallo is much slower than in at M inkow ski spacetime at long tim es. This leads us to the conclusion that the surface rem ains \rough" at large separations.

Section 5 contains our concluding rem arks and som e cosm ological im plications of our results.

## 2 The D om ain W all

D om ain walls (interfaces) are eld con gurationsw th non-trivial topologicalboundary conditions. These boundary conditions dem and that the eld vary substantially within a typical spatial scale that is usually determ ined by the (nite tem perature) correlation length
$m^{1}$, w ith $m$ the, in general tem perature-dependent, e ective $m$ ass of the eld.
In FRW cosm ologies there is another im portant scale, the $m$ icrophysical horizon size $d_{h}=H^{1}$ where $H$ is the $H$ ubble param eter. C ausality im plies that the region in which the scalar eld can vary appreciably m ust be subhorizon sized, since only then can the boundary conditions that de ne the wall $t$ inside the horizon. Thus we expect that the notion of a dom ain wall will only $m$ ake sense if $H=m \quad 1$.

W hen $H=m \quad 1$, we expect that the dom ain wallpro lewillexhibit only sm alldeviations from the $M$ inkow ski spacetim e pro $l e . W$ e can then study the di erences in a power series expansion in $\mathrm{H}=\mathrm{m}=\mathrm{d}_{\mathrm{h}}$.

C onsider a scalar eld with potential

in a FRW spacetim e w th m etric $g=\operatorname{diag}\left(1 ; a^{2} ; \quad a^{2} ; \quad a^{2}\right)$, and $H$ ubble param eter $H$ a=a (where a da=dT). The second term couples the eld to the $R$ icci scalar $R=6\left(2 H^{2}+\right.$ $\mathrm{H}-$ ). Such a term is required for consistency as it $w$ ill be generated by quantum corrections in general; the only xed point is $=1=6$ which corresponds to conform alcoupling equation ofm otion is

$w$ here $r$ is the derivative $w$ th respect to co-m oving spatial coordinates $f X ; Y ; Z g$. It is convenient to de ne the follow ing dim ensionless quantities

N ote that! is a (dim ensionless) physical coordinate. For power-law expansion (PLE) $a(t)=t^{n}$, we have $=41=n$. In the radiation dom inated (RD) and $m$ atter dom inated (MD) at universes respectively, $\mathrm{RD}_{\mathrm{D}}=2$ and $\mathrm{mD}_{\mathrm{D}}=2: 5$. In de Sitter spacetime ds $=4$ (or equivalently, we can take $n=1$ ).

W e will assum e a dom ain wall (kink) along the $z$-axis and that the corresponding eld con guration is independent of the transverse coordinates, so that we are considering a at interface.

The scale factor dividing the (com oving) Laplacian in eq. (2, ) suggests the follow ing ansatz for the kink con guration:

where a prim e m eans $@=@!$. The right-hand side (RHS) vanishes for de Sitter spacetim e, and is $O\left(h^{4}\right)$ for PLE.

In the case of de Sitter spactim e , the e ect ofnon-zero conform alcoupling (i.e. (1) can be absorbed in a sim ple rescaling of variables:

E xcept to discuss the energy-m om entum tensor $T$, we willhereafterw ork in the rescaled theory (and drop the bars), w riting
and taking \soliton boundary conditions" ( $1 ; h$ ) $=1$. All results for PLE are thus valid only to $0\left(h^{2}\right)$.

### 2.1 W alls in de Sitter Spacetim e: N um erical Solution

The di erential equation (5ِ) is, in general, a partial di erential equation in two variables, and not easily am enable to num erical study. As we see in eq. ( $\bar{q}_{1}$ ), ignoring the RHS would introduce errors at $\mathrm{O}\left(\mathrm{h}^{4}\right)$ for PLE. H ow ever, in de Sitter spactim e, where $h$ is constant, we have an ordinary di erential equation, for which we can nd exact num erical solutions. Indeed, this was done by B asu and V ilenkin [ $[\overline{-1}]$, and our results appear to agree w ith theirs.

O ur results are plotted as thin curves in Fig. 1. The slope at the origin was chosen (by a shooting algorithm ) by requiring sm oothness through the point ! = $1=\mathrm{h}$ ( $m$ arked w th a tick). A s found by B asu and V ilenkin 娮], solutions only exist when $\mathrm{h}^{2}<1=4$. (For PLE, if one insists on ignoring the RHS ofeq. ( $\bar{i}$ ), solutions only exist when $h^{2}<1=$.)

We see the kink has been attened out by the e ects of the cosm ological expansion. The slope at the origin $a_{1} \quad{ }^{0}(0 ; h)$ decreases $w$ ith $h^{2}$ as show $n$ in $F$ ig. 2 , vanishing at $h^{2}=1=4$. In other w ords, for a topologically stable solution to exist, the horizon size m ust be greater than the correlation length (by a factor of 2).

### 2.2 Expansion in $h^{2}$

A though a num erical solution is available in the case of de Sitter, the general case is extrem ely di cult to analyze num erically, since we now have a non-linear partial di erential equation in two variables. H ow ever, when $h^{2} \quad 1=$, we can solve eq. ( $(\underset{1}{\prime})$ in a system atic perturbative expansion in $h^{2}$, and the rst-order result w ill be valid for both de Sitter and P LE cosm ologies. W e w rite

Here $s$ is the kink con guration which solves eq. (īi) for $h=0$ ( at spacetim e):

This $h=0$ kink is show $n$ as a dashed curve in $F$ ig. 1 . N ote that ${ }_{s}^{0}(0)=1={ }^{\mathrm{P}} \overline{2}$.

Since s has the correct asym ptotic behavior, we must set ${ }^{(n)}(1)=0$. To leading order in $h^{2}$, (!) obeys

The solution $m$ ay be found by elem entary methods once a solution of the hom ogeneous equation is found. Such a solution is easily available, since translational invariance of the unperturbed di erential equation guarantees that

N ote that ${ }_{2}(!)$ diverges exponentially as! ! 1 . To render the solution nite and to satisfy the boundary conditions, we m ust choose:

The boundary condition at in nity does not determ ine the constant $a$. N otice that the term $a_{1}(!)$ represents a local translation of the wall. C learly the freedom of choine of a re ects the underlying translational invariance. If we dem and that the wall position be at the origin, we m ust dem and that ${ }^{(1)}(!=0)=0$; this leads to $a=0$.

Thus the nalsolution to this order that satis es the boundary conditions and keeps the w all centered at the origin is given by

The results for de Sitter spactim e ( = 4) are shown as thidk curves in Fig. 1. (1) (!) for $=4$ is plotted in $F$ ig. 3. This approxim ation underestim ates the distortion aw ay from
the $h=0 \mathrm{kink}$, and does not see the singularity at $h^{2}=1=4$, which is wellbeyond the regim e of validity of the perturbative expansion in $h^{2}$.

It is straightforw ard to that the structure of the perturbative expansion persists to all orders. In fact we nd that

w ith the sam e di erential operator $\hat{O_{s}}$ as in $(\overline{1} \overline{0} \overline{-1})$, and where the source term $j^{(n)}$ is obtained from the solutions up to order n 1 . C learly the sam efunctions ${ }_{1}(!)$; $_{2}(!)$ generate the solutions, as these are the tw o linearly independent solutions of the hom ogeneous di erential equation $\hat{O_{s}}=0$. Thus the general form of the solution is the same as $\left.{ }_{(1-1 \overline{1})}^{1} \bar{Y}\right)$ with $j^{(n)}$ replacing $j$ and coe cients $a^{(n)} ; b^{(n)}$ replacing $a ; b$.

By the sam e argum ents presented before, a nite solution at in nity requires that

The source term $j^{(n)}(!)$ is constructed from iterations up to order ( $n \quad 1$ ), and for $n=1$ it is given by derivatives of the unperturbed kink solution that vanish at ! = 1 . It is straightforw ard to prove by induction that the source term $j^{(n)}(!)$ is antisym $m$ etric and vanishes exponentially as ! ! 1 . Therefore $b^{\left(b^{(n)}\right)}$ is nite to all orders. Translational invariance suggests that $a^{(n)}=0$ as before, and the the solution to order $n$ is antisym $m$ etric and this property ensures that the source term for the next order iteration is antisym $m$ etric again. Thus we are led to the conclusion that the general form of the perturbative solution is given by eq. (19 $\overline{1}$ ) w ith $j$ (! ) replaced by $j^{(n)}(!)$, and the only com plication in carrying out this program to any arbitrary order is to nd the source term iteratively. C learly this w ill be a highly non-local function because of the nested integrals, and the num erical evaluation w ill becom e m ore cum bersom e in higher orders, but in principle this schem e will yield a consistent perturbative expansion. C learly we have no way of determ ining the radius of convergence of such an expansion.

### 2.3 Expansion in !

The eld con guration corresponding to a dom ain wallhasm ost of the gradient and potential energy di erence (w ith respect to the broken sym m etry vacuum ) localized in a spatial region of the order of the correlation length. M ost of the contribution to the energy m om entum tensor, after subtracting $o$ the vacuum value, will arise from this sm all region around the position of the dom ain wall. This m otivates us to obtain the kink pro le near the origin in a power-series expansion in the coordinate!. This expansion is nonperturbative in $\mathrm{h}^{2}$.

Them otivation for this expansion is the follow ing: one would eventually like to study the full system of $E$ instein's equations and $m$ atter eld in a self-consistent sem iclassicalm anner.

In particular we have in $m$ ind the question of how the presence of dom ain walls a ect the gravitational elds. Since for this task one only needs the behavior of the energy $m$ om entum tensor, and as we argued above $m$ ost of the contribution to its com ponents from a dom ain wall eld con guration arise from a very localized region near the position of the interface, a power series expansion near the origin $m$ ay capture $m$ ost of the relevant physical features for an understanding of the back reaction of dom ain walls on the gravitational eld. This argum ent becom es $m$ ore relevant in view of the proposal of rapid in ation at the core of topological defects [ $\underline{Q}_{1}$ ].

In the general case of de Sitter or pow er-law expansion we nd the follow ing behavior of the interface pro le near the origin:

$T$ he linear coe cient $a_{1}$ cannot be determ ined perturbatively, and $w i l l$ have to be found by solving the di erentialequation, its value being determ ined by requiring sm oothness through $!=1=h . W$ e notioe, how ever, that as $h^{2}$ ! $1=$ from below, the rst term dom inates (even for large !) and the pro le attens out to a straight line.

Since this expansion works best for $h^{2}$ close to $1=$, but is correct only to $O\left(h^{2}\right)$ forPLE, it is only useful in this case very close to the origin.
$G$ iven a value for $a_{1}$ (from the num ericalsolution) as input, we display this series through O $\left(!{ }^{5}\right)$ ] for the de Sitter spactim e $(=4)$ case as the thin dot-dashed curve in $F$ ig. 1. For $h^{2}$ > 0.2 , where the solution is very at, the sm all-! expansion is valid out to well past ! = 1=h. W e will use these results in the follow ing section.

## 3 The Energy -M om entum Tensor

W e next tum to an exam ination of the energy $m$ om entum tensor for the dom ain wall pro le in an FRW spacetime.

In general, the energy m om entum tensor of a scalar eld con guration is given by

At this stage we restore the non-m in im al coupling to the $R$ icci scalar, since, as we argued above, such a term $w$ ill be induced by renorm alization if not present in the original

Lagrangian $[\underline{10} \mathbf{1} 0-1$. Its presence has two $m$ ajor e ects: the rst one is to modify the form of the energy $m$ om entum tensor, while the second is to $m$ odify the eld con guration for the dom ain wall. Unlike the analysis of the equation ofm otion in the previous sections, for the case of the energy $m$ om entum tensor we can no longer rescale variables to get rid of, since $(R=g) 0$. Let $U_{0}$ be the potential for $=0$, so $U=U_{0}+(=2) R^{2}$. Perform ing the variation ofeq. (1] $\overline{1})$, we nd:

The presence of the non-linear coupling to the R icci scalar modi es the de nition of the energy m om entum tensor. Even in the case of M inkow ski spacetim e , w ith $\mathrm{h}=0$, this $m$ odi cation of the energy $-m$ om entum tensor produces som e peculiar behavior in $t$ near the origin, despite the fact that this coupling does not a ect the equations ofm otion. In this case, the wall solution is just s from eq. $\left(\frac{\overline{9}}{(9)}\right)$, and the non-zero com ponents oft are:

( $\overline{-} \mathbf{( \overline { G } )}$. W all solutions in de Sitter spactim e only exist for $\mathrm{h}^{2}<1=4$, which im plies

The lesson that we leam from this analysis is that the coupling to the R icci scalar can dram atically m odify the behavior of the energy $m$ om entum tensor near the origin, and $m$ ay be an interesting possibility for topological in ation at the core of defects [ipi]. These e ects
 if one starts w ith a general curved spactim e and then takes the at lim it.

## 4 F luctuations of the W all

Up to this point our study has focused on the description of a $\backslash$ at" interface or dom ain wall, that is the eld pro le varies only along the direction penpendicular to the dom ain wall but is constant on the perpendicular directions. H ow ever there $w i l l$ be uctuations both quantum and therm al that $w$ ill tend to distort locally the interface. A $n$ im portant question to address is the follow ing: are these uctuations \sm all" in the sense that the wall rem ains at at long distances, or are the uctuations im portant so that the wall becom es \rough"? W e will assume that the system is at zero tem perature and that only quantum uctuations are im portant.

W e begin by deriving the e ective action for the uctuations of the interface and then proceed to calculate relevant correlation functions.
 covariance to treat translational invariance in term s of collective coordinates; how ever, the nal result for the action will be fully covariant. This procedure, borrowed from the usual schem e to quantize the collective coordinates associated w ith translations of soliton solutions [1]

The position of the interface explicitly breaks translational invariance. H ow ever, a rigid translation of the interface should cost no energy due to the underlying translationalsym me try. Thus the uctuations penpendicular to the interface should be represented by m assless degrees of freedom since, locally, they represent translations of the interface. These are the
 lation sym $m$ etry. Translational sym $m$ etry is then restored by quantizing these uctuations as collective coordinates [1]inill.

We want to incorporate uctuations of the interface solution (kink) and to obtain the e ective action for the long-w avelength $m$ odes. In order to understand how to adhieve this goal, it proves convenient to recall how this procedure works in M inkow ski spacetim e.

no cost in energy. W e w ill borrow results from the one-dim ensional procedure and quantize these m odes as \oollective coordinates" గīj-1.].

Besides these $G$ oldstone $m$ odes there are $m$ assive $m$ odes corresponding to the higher

 wavelength uctuations of the interface and obtain an e ective action for these G oldstone m odes, treated as collective coordinates. The coordinates $a_{p}$ or the eld $f(x ; y)$ are now fully quantized. In a path integralquantization procedure, collective coordinate quantization am ounts to a fiunctional integral over all con gurations of $f(x ; y)$. C learly this procedure restores translationalinvariance because now the eld is invariant under $z$ ! $z+\quad$; $f(x ; y)$ ! $f(x ; y)+$ and the eld $f(x ; y)$ is now functionally integrated with a translational invariant $m$ easure. P assing from the original integration variables in the functional integral to the new variables including $f(x ; y)$ involves a Jacobian which is seen to be unity to the order that we are working in (see below). For a thorough exposition of collective coordinate quantization in the path integral and H am iltonian form s , the reader is referred to the original literature閶高,

### 4.2 G oldstone M odes in a FRW C osm ology

A fter this digression in $M$ inkow ski spacetim e we are ready to extend these observations to a FRW cosm ology. Let $s$ (!) be a solution to eq. (in) (the h-dependence w ill now be im plicit), and let us take the sm all-gradient lim it, in which

This is the nal form of the action for the uctuations of the interface. It exhibits the translational sym $m$ etry explicitly, and only contains derivative term $s$ as is required of a G oldstone eld. $C_{0}$ is identi ed with the (usual) at spactim e surface tension, and we see that curved spacetim e e ects induce a renom alization of this surface tension. The rst term (proportional to $\overline{g^{(3)}}$ ) is recognized as the equivalent to the $\backslash \mathrm{N}$ am bu-G oto" action, which is essentially the total \world-volum e" associated w ith the uctuation eld. The second term is thus a correction to the $\backslash N$ am bu-G oto" action; further corrections can be obtained in a system atic expansion in derivatives for the solution of the equations ofm otion.

Its correlation functions, to be com puted below, will give inform ation on whether departures from a at interface are signi cant.

At this point we would like to com pare our result w th those of G arriga and $V$ ilenkin. $T$ hese authors found that the uctuations penpendicular to the interface are associated $w$ ith instabilities that $m$ anifest them selves as a tachyonic $m$ ass for these uctuations. From the discussion above, we are led to con jecture that the appearance of this tachyonic $m$ ass is the result of a quantization that does not preserve translational invariance.

Because our procedure does preserve translational invariance but is non-covariant in the interm ediate steps, a direct com parison of our results is som ew hat subtle. H ow ever, we can gain som e insight by trying di erent param etrizations of our kink-pro le. C onsider the follow ing the param etrization

This is the sam $e$ value of the $m$ ass obtained by $G$ arriga and $V$ ilenkin $[\overline{9}]$. Thus we con jecture that the scalar eld that $m$ easures departures from a at interface introduced by $G$ arriga and $V$ ilenkin is equivalent (at least to low est order in
derivatives）to the scalar eld $F$ param etrizing the uctuations of the interface as in equa－ tions（ $\overline{3} \bar{a}, 1,3 \overline{-1})$ ）A s explained above，this param etrization explicitly breaks rigid translational invariance in any FRW cosm ology．The appearance of the $m$ ass term is understood as a consequence of this explicit breakdown of translational invariance，although this fact does not explain the tachyonic nature of the $m$ ass．

Thus it seem s to us that there are advantages and disadvantages in both form ulations． W hereas the form ulation of $G$ arriga and $V$ ilenkin is desirable in that it $m$ aintains explicit covariance，there is the feature of instabilities associated with the tachyonicm ass of the uc－ tuations，which if our analysis is correct，indicates the breakdow $n$ of translational invariance in the quantization procedure．On the other hand，our form ulation，in term s of collective coordinate quantization，sacri ces explicit covariance，although the nal result is covariant， but explicitly treats translational invariance and its restoration via the collective coordinate quantization．The collective coordinates represent $m$ assless elds as a consequence of this translational invariance．

## 4．3 Q uantization of the F luctuations

Q uantizing the uctuations of the interface allow sus to answ er som e relevant questions ab out the dynam ics of the interface．In particular we can answ er the question that we posed at the beginning of the section that is whether the interface（wall）is at or strongly uctuating at long distances．In order to answer this question we m ust com pute the correlation function of the vectors nom al to the interface at long distances $1 \quad r \quad h^{1}$ with $r$ the distance on the two－dim ensional surface of the interface．

Since we are interested in long distance physics，we will only consider slow ly varying uctuations of the uctuation eld $f$ and neglect higher derivative term $s$ in the action， keeping only the quadratic term s（one can be brave and pursue a perturbative expansion but we w ill content ourselves here w ith a low est order calculation）in the action．Repeating eq．（3̄⿱一𧰨⿵人），

A sm entioned above, we are interested on the long-w avelength uctuations of the interface at long distances and at long tim es after its form ation.  raises the very interesting possibility of anom alous exponents in the correlation function. $N$ otice that for large $r$ the logarithm ic (infrared) singularities becom e strong and eventually would have to be resum $m$ ed in order to obtain $m$ eaningful long distance behavior. A ssum ing such a resum $m$ ation of the low est order result we obtain the long distance behavior:

This result has interesting im plications. In particular, we nd that at long tim es and distances the vectors nom al to the interface are uncorrelated and the interface is \rough" rather than approxim ately at with sm all uctuations that fallo rapidly at long distances.

This situation is very sim ilar to that of the $\mathrm{X}-\mathrm{Y}$ m odel and other m odels in statistical $m$ echanics in $1+1$ Euclidean dim ensions (typically massless scalar eld theories) in which logarithm ic singularities sum up to anom alous dim ensions $[\underline{2} \overline{0}] \quad \mathrm{m}$ uch in the sam eway. This would indeed be a tantalizing possibility that needs to be studied further, perhaps by keeping higher order term $s$ in the e ective action and resum $m$ ing using renom alization group argum ents. This is œertainly beyond the soope of this article.

A nother quantity of interest that $m$ easures properties of the interface is the distortion鹯]:

$W$ e evaluated this correlation function for large tim es and distances (t $\quad 1=\mathrm{h} ; \mathrm{r} \quad 1 \mathrm{hr}$ ) and found

$T$ his result is consistent $w$ th that of the norm al-nom al correlation function ( $\overline{5} \overline{2} \overline{2})$.
This correlation function show s once again that the interface is strongly uctuating at long distances and cannot be considered at.

## 5 C onclusions

In this article we have focused on the properties of dom ain walls in generalFRW U niverses. These defects will appear during phase transitions in typical in aton theories and ultim ately drive the dynam ics of the process of phase separation. They $m$ ay also contribute to density uctuations and perhaps to structure form ation.

O ur results present a rich picture of the properties of these defects. A fter analyzing num erically the case of de Sitter spacetim e and assum ing that the boundary conditions on the eld con guration require that the horizon size be larger than the typical correlation length we set up a system atic perturbative expansion in powers of $h=H=m$ and worked out in detail the rst order correction from curved spacetim e e ects. W e see then that even in situations in which the Universe is expanding slow ly enough to allow us to set up our perturbation theory for defects, new phenom ena occurs with de nite cosm ological im plications.

In particular, we argue that in a generalFRW spacetim e, consistency (renorm alizability) of the theory requires a coupling to the R iociscalar. W ith this coupling the energy m om entum tensor of defects can show som e rem arkable new features, including a negative energy density at the origin. C learly this observation brings interesting possibilities for topological in ation near the center of the defect that $m$ ust be studied $w$ ithin the full set of $E$ instein's equations in the presence of this con guration. For som e values of the coupling to the $R$ ioci scalar, we nd that the energy density at the center is lower than at a distance of the order of the correlation length aw ay from the center.

Such a behavior of the energy $m$ om entum tensor $m$ ay provide an interesting $m$ echanism for scalar density perturbations.

U sing collective coordinate quantization of the uctuations penpendicular to the wall, we obtained the e ective Lagrangian for these uctuations in the long-w avelength approxim a-
tion. There are several notew orthy features of this e ective Lagrangian: curved spaœetim e e ects renom alize the surface tension, and we nd system atic corrections to the \N am bu" action.

W e have also shown how to quantize the uctuations about a com pletely at wall, and how the collective coordinate procedure yields the expected $G$ oldstone $m$ ode associated $w$ ith translationalinvariance. This analysis then allow s us to com pute correlation functions and to see that, at least in the de Sitter case, uctuations are fairly strong at long distances and long tim es after form ation of the defect leading to conclusion that the surface tends to be rougher than in at spacetim $e$. These results and the $m$ ethod developed for the quantization of the uctuations $m$ ay yield som e insight on novel $m$ echanism $s$ to study density perturbations.

W hat we have done for walls can also be done for other defects, such as cosm ic strings. $T$ hese should exh ibit som e interesting behavior, especially for the uctuations, since therew ill now be collective coordinates associated w ith the intemalU (1) sym $m$ etry whose spontaneous breaking gives rise to the string. Interesting possibilities are corrections to the string tension from curved spactim ee ects and also corrections to the $\backslash \mathrm{N}$ am bu-G oto" action from higher derivative term s , and perhaps novel behavior of the energy m om entum tensor at the core of the defect when the coupling to the $R$ icci scalar is introduced. W e are currently studying these and other issues.
