K! 2 Decay in the Nambu-Jona-Lasinio Model

A bstract

We study the K ! 2 decays using the U_L (3) U_R (3) version of the N am bu-Jona-Lasinio m odel with the elective S=1 nonleptonic weak interaction. The $I=\frac{3}{2}$ amplitude is in reasonable agreement with experimental data. On the other hand, the calculated $I=\frac{1}{2}$ amplitudes strongly depend on the mass of the low-lying scalar-isoscalar meson, and therefore give a strong constraint on the parameters of the model.

I. IN TRODUCTION

The $I=\frac{1}{2}$ rule in the K ! 2 decays is one of the interesting problems of the low-energy hadron physics. Since all the particle in the initial and nal states in these decay processes are the octet pseudoscalar m esons, which are considered as the N am bu-G oldstone (NG) bosons associated with the spontaneous breaking of chiral symmetry, one can use all the known properties of the NG bosons in the analyses of the processes.

One of the widely used fram eworks to study the low-energy properties of the NG bosons is the chiral perturbation theory (ChPT) [1]. In ChPT, we introduce an elective lagrangian

constructed in terms of nonlinearly transforming NG boson elds and treat the explicit breaking of the chiral sym metry and the external momenta of the NG bosons perturbatively.

In order to study hadronic weak interactions at low energy, an elective weak interaction lagrangian is commonly introduced. For K $\,!\, 2\, decays$, we use $\,S=1\, non\, leptonic\, weak$ interaction lagrangian L_W , which has been derived from the standard theory by integrating out heavy degrees of freedom. The renormalization group equation with one-loop QCD corrections is solved to give L_W at a hadronic mass scale in terms of local four quark operators [2{8].

Using L_W , the K ! 2 decays have been studied in the ChPT [7,9]. In this approach, the four-quark operators in L_W have to be mapped on to the operators of the NG bosons. Thus, one should exam ine whether this treatment is justiled. It should be also noted that the K ! 2 decay amplitudes are expected to be sensitive to the explicit breaking of the chiral symmetry because the matrix elements vanish in the SU (3) limit. In ChPT, this symmetry breaking is represented by the nite masses of the NG bosons. It is, however, controversial whether the ChPT can qualitatively handle the explicit symmetry breaking in the strangeness sector [10]. Therefore it seems interesting to study the K ! 2 decays in an elective theory with the symmetry breaking in a direct form.

In order to investigate these two points, it may be a good idea to use a chirale ective quark model such as the Nambu-Jona-Lasinio model [11]. If the quark elds in the chiral elective quark model are identified with those in $L_{\,\rm W}$, there is no ambiguity of using $L_{\rm W}$. A nother good point of the chirale ective quark model is that the explicit breaking of the chiral symmetry can be introduced naturally by the current quark mass term.

A few years ago, M orozum i et al. [12] derived a chiral weak lagrangian by performing the bosonization of the L_W using the NJL m odel as a guide and applied it to the K ! 2 decays. They compared their results with those in ChPT and found that the $I=\frac{1}{2}$ amplitude receives additional enhancement and thus the long-standing $I=\frac{1}{2}$ enhancement problem is solved. However in ref. [12] the derivative expansion was used and the current squark mass was treated as a free parameter. Furthermore they calculated only the leading

contributions in the $\frac{1}{NC}$ expansion.

We present fuller calculations of the K ! 2 decays in a U_L (3) U_R (3) NJL model combined with the elective S=1 nonleptonic weak interaction lagrangian L_W in the Feynman diagram approach. Here the low-lying meson states are calculated by solving the Bethe-Salpeter type equations in the ladder approximation without using the derivative expansion. Them odelparameters, such as the quark masses, are chosen so as to be consistent with the observed NG boson properties. We calculate not only the leading terms but also the next order terms in the $\frac{1}{N_C}$ expansion of the K ! 2 decay amplitudes.

A lthough the NJL model does not con nequarks, it is considered that the NG bosons are strongly bound and therefore the processes containing only the NG bosons, such as K! 2 transitions, can be described by this model fairly well. It is also known that the low energy theorems of the NG bosons are satisfied in this model.

II.EXTENDED NAMBU-JONA-LASINIO MODEL

We work with the NJL model lagrangian density extended to U_L (3) U_R (3) case [10]:

Here the quark eld is a column vector in color, avor and D irac spaces and a is the U (3) generator in avor space. The lagrangian $L_{N JL}$ incorporates the current quark m ass matrix $m = diag (m_u; m_d; m_s)$ which breaks the chiral U_L (3) U_R (3) invariance explicitly.

Q wark condensates and constituent quark m asses are self-consistently determ ined by the gap equations. We assume the isospin symmetry, i.e., $m_u = m_d$. The pseudoscalar channel quark-antiquark scattering amplitudes are then calculated in the ladder approximation. From the pole position of the scattering amplitude, the pion mass meand the kaon mass meand the kaon mass meand are determined. The pion-quark coupling constant geand the kaon-quark coupling constant g_K are determined by the residues of the scattering amplitudes at the pion and kaon poles respectively. The pion decay constant feand the kaon decay constant f_K are also determined by calculating the quark-antiquark one-loop graphs.

III. EFFECTIVE NONLEPTONIC W EAK INTERACTION

The e ective S = 1 nonleptonic weak interaction lagrangian density we have used is

with $_{i}$ $V_{id}V_{is}$ and V is the K obayashi-M askawa matrix. The four-quark operators Q $_{r}$ are

where and are indices in the color space. Q_1 and Q_2 have both the $I=\frac{1}{2}$ and $I=\frac{3}{2}$ components while Q_3 , Q_5 , Q_6 and Q_2 Q_1 have only the $I=\frac{1}{2}$ component. As for the W ilson coe cients C_r^c and C_r^t , we take the results at the energy scale =0.244G eV with the top quark mass $m_t=200$ G eV in ref. [8]. The numerical values are $C_1=0.216$, $C_2=0.346$, $C_3=7.12$ 10^3 , $C_5=3.89$ 10^3 and $C_6=0.021$ for C_r $C_{rc}^c+C_{rt}^t$.

IV.K ! 2 DECAY AMPLITUDES

The invariant amplitude for the K $\,\,!\,\,$ 2 $\,$ decay $T_{K\,\,!\,\,2}$ $\,$ is de ned by

By calculating the Feynm an graphs shown in g. 1, we obtain the following results.

where $Tr^{(c;D)}$ m eans trace in color and D irac spaces. The e ect of the qq-collective m eson in the intermediate state is expressed by

where $\operatorname{Tr}^{(c;f;\mathcal{D})}$ means trace in color, avor and D irac spaces and $\operatorname{u}^{q} = \frac{q}{\frac{2}{3}} \operatorname{u}^{0} + \operatorname{u}^{q} = \frac{1}{3} \operatorname{u}^{8}$ is a matrix in avor space. Fig. 1 (e) does not contribute because the integral

vanishes in the isospin symmetry limit.

V.NUMERICAL RESULTS

The experimental values of the invariant amplitudes for the K! 2 decays are as follows [13].

Here the K $^+$! $^+$ 0 decay is a pure I = $\frac{3}{2}$ decay and the other two decays have both I = $\frac{1}{2}$ and I = $\frac{3}{2}$ components.

In our theoretical calculations, the parameters of the NJL model are the current quark masses m $_{\rm u}$ = m $_{\rm d}$, m $_{\rm s}$, the coupling constant G $_{\rm S}$ and the covariant cuto . First, we take m $_{\rm u}$ = m $_{\rm d}$ as a free parameter and study them $_{\rm u}$ dependence of the K ! 2 decay amplitudes. O thereparameters m $_{\rm s}$, G $_{\rm S}$ and are determined so as to reproduce the observed values of m , m $_{\rm K}$ and f . The calculated results of $\mathbf{f}_{\rm K^+l}$ + $_{\rm o}\mathbf{j}$ $\mathbf{f}_{\rm K^{\, o}l}$ + $_{\rm j}$ and $\mathbf{f}_{\rm K^{\, o}l}$ $_{\rm o}$ $_{\rm j}$ jare shown in g. 2. As can be seen from g. 2, the I = $_{\rm d}$ amplitude has little dependence on m $_{\rm u}$, while I = $_{\rm d}$ amplitudes strongly depend on m $_{\rm u}$. This strong dependence is attributed to the T term in Y $_{\rm 2}$, eq. (10). In g. 3 we show the calculated constituent quark masses M $_{\rm u}$ and M $_{\rm s}$ as functions of the current u-quark mass m $_{\rm u}$. As a result of our thing procedure, the constituent quark masses almost linearly increase when the current u-quark mass increases. The quark-antiquark scattering amplitude in the scalar-isoscalar channel has the pole of the meson just above the constituent quark-antiquark threshold in the NJL model [14]. Therefore T ($_{\rm q}$ = m $_{\rm K}$) quickly increases when m ('2M $_{\rm u}$) become scales to m $_{\rm K}$ by changing m $_{\rm u}$.

If we thin we as as to reproduce the $I=\frac{1}{2}$ amplitudes reasonably, then we obtain the NJL model parameters, mu = md = 7.1MeV, ms = 178.2MeV, = 0.844GeV and $\frac{^2N_c}{4^2}G_S=0.66$. The calculated constituent quark masses are Mu = Md = 286.2MeV and Ms = 529.3MeV and the meson-quark coupling constants are g=3.023 and $g_K=3.254$. We have used m, mk and f as inputs, so f_K is the prediction and our result is $f_K=101$ MeV, which is about 11% smaller than the observed value. The ratio of the current squark mass to the current u,d-quark mass is ms=mu=25.1, which agrees well with ms=m^2=25.25, $m^2=\frac{1}{2}$ (mu+md) derived from ChPT [15].

The calculated results of the K! 2 decay amplitudes in the above parameter set are

Here the numbers in parentheses are the results without including $\frac{1}{N_C}$ terms. The $\frac{1}{N_C}$ terms enhance the $J_{K+1}+0$ jand reduce the $J_{K+1}+0$ jand $J_{K+1}+0$

The contributions from each diagram are as follows. $X = 2.49 10^2 \text{ GeV}^3$, $Y_1 = 0.274 \text{ GeV}^3$, $Y_2 = 1.564 \text{ GeV}^3$ and $Y_3 = 4.1 10^4 \text{ GeV}^3$. The contribution of Y_3 type is not included in the ChPT and the bosonization approach in ref. [12]. As far as we know, this is the rst estimation of this type of the contribution, however our numerical result shows that its contribution is negligible.

The main origin of the enhancement of the $I=\frac{1}{2}$ amplitudes is the existence of the low-lying scalar-isoscalar meson, which is not experimentally conmed. It is argued that the meson has a very large ! 2 decay width and thus is not observed. In our calculation, the ! 2 decay width is not taken into account although the meson has a small (50M eV 100M eV) ! qq decay width. We estimate the elect of the strong ! 2 decay on the K ! 2 transitions by using the following scalar-isoscalar form factor

instead of T (q^2) in eq. (12). Here is the parameter which represents the ! 2 decay width and g is determined so as to reproduce our results given in eq. (15) in the case of = 0. If one takes = 500M eV, then the amplitudes become $jT_{K^0!}$ + j= 8:59 10 8 G eV

and $J_{K^{0}!} \circ j = 6.52 \cdot 10^{8} \, \text{GeV}$, which are about $\frac{1}{3}$ of the original values. Even in this case, if the model parameters are retted again, one can reproduce the K ! 2 decay amplitudes reasonably by taking m close to m_K.

VI.CONCLUDING REMARKS

Using a three-avor Nambu-Jona-Lasinio (NJL) model with the low-energy elective S=1 nonleptonic weak interaction, we have studied the K ! 2 decays. As suggested in ref. [12], we have found that the existence of the meson with the mass close to m_K enhances the $I=\frac{1}{2}$ amplitudes and all the K ! 2 decay amplitudes are reproduced reasonably well. The role of the meson in the low-energy hadron physics is not established so well. In the K ! 2 decays, the weak interaction gives rise to the avor changes ! d and it is one of the reason why the plays an important role in the processes. It may be useful to study the K ! 2 decays and the scattering processes simultaneously by including the two pion intermediate states in the analysis since the meson plays an important role in the scattering processes too. It is left as a further study.




- Fig. 1 Feynm an diagram s for the K ! 2 decays. The dotted lines correspond to the qq-collective m esons in the NJL m odel while the solid lines to the constituent quark propagators. The hatched ellipses represent the elective S = 1 nonleptonic weak interactions. The diagram S(a), S(b), S(c) and S(c) contributions respectively.




















