New Physics from U (3)—Family Nonet Higgs Boson Scenario

A bstract

Being inspired by a phenom enological success of a charged lepton mass formula, a model with U (3)-fam ily nonet Higgs bosons is proposed. Here, the Higgs bosons $_{\rm L}$ ($_{\rm R}$) couple only between light ferm ions (quarks and leptons) $f_{\rm L}$ ($f_{\rm R}$) and super-heavy vector-like ferm ions $F_{\rm R}$ ($F_{\rm L}$), so that the model leads to a seesaw-type mass matrix M $_{\rm f}$ ' $m_{\rm L}$ M $_{\rm F}$ 1 m $_{\rm R}$ for quarks and leptons f = u; d; and e. Lower bounds of the physical Higgs boson masses are deduced from the present experimental data and possible new physics from the present scenario is speculated.

New Physics from U (3)-Family Nonet Higgs Boson Scenario

A bstract

Being inspired by a phenom enological success of a charged lepton m ass form ula, a m odel w ith U (3)-fam ily nonet H iggs bosons is proposed. Here, the H iggs bosons $_{\rm L}$ ($_{\rm R}$) couple only between light ferm ions (quarks and leptons) $f_{\rm L}$ ($f_{\rm R}$) and superheavy vector-like ferm ions $F_{\rm R}$ ($F_{\rm L}$), so that the m odel leads to a seesaw-type m ass m atrix M $_{\rm f}$ ' m $_{\rm L}$ M $_{\rm F}$ $^{\rm 1}$ m $_{\rm R}$ for quarks and leptons f = u;d; and e. Lower bounds of the physical H iggs boson m asses are deduced from the present experimental data and possible new physics from the present scenario is speculated.

1 Motives

One ofmy dissatisfactions with the standard model is that for the explanation of the mass spectra of quarks and leptons, we must choose the coe cients y_{ij}^f in the Yukawa coupling p_i^p p_i^p q_i^p q_i

Nevertheless, I would like to dare to challenge to a model with U $(3)_{fam ily}$ nonet H iggs bosons which leads to a seesaw type quark and lepton mass matrix

One of the motives is a phenomenological success of a charged lepton mass relation [2]

which predicts m = 1776:96927 0:00052 0:00005 M eV for the input values [3] of m $_{\rm e}$ = 0:51099906 0:00000015 M eV and m = 105:658389 0:000034 M eV (the rst and second errors in (1.2) come from the errors of m and m $_{\rm e}$, respectively). Recent m easurements [4] of tau lepton m ass m = 1776:96 $^{+0.18+0.20}_{0.19}$ M eV excellently satisfies the charged lepton m ass relation (2). An attempt to derive the m ass relation (2) from a H iggs m odel has been tried [5]: We assumed U (3) fam ily nonet H iggs bosons $_{\rm i}^{\rm j}$ (i; j = 1;2;3), whose potential is given by

Here, for sim plicity, the SU $(2)_L$ structure of has been neglected, and we have expressed the nonet Higgs bosons $_i^j$ by the form of 3 3 m atrix,

where $_{oct}$ is the octet part of , i.e., $Tr(_{oct}) = 0$, and 1 is a 3 3 unit matrix. For $^2 < 0$, conditions for m in in izing the potential (3) lead to the relation

together with $v=v^y$, where v=h i, $v_{\text{oct}}=h$ octi and $v_s=h$ si, so that we obtain the relation

If we assume a seesaw-like mechanism for charged lepton mass matrix M $_{\rm e}$, M $_{\rm e}$ ' m M $_{\rm E}$ 1 m, with m / v and heavy lepton mass matrix M $_{\rm E}$ / 1, we can obtain the mass relation (2).

A nother m otives is a phenom enological success [6] of quark m ass m atrices with a seesaw-type form (1), where

The model can successfully provide predictions for quark mass ratios (not only the ratios m $_u$ =m $_c$, m $_c$ =m $_t$, m $_d$ =m $_s$ and m $_s$ =m $_b$, but also m $_u$ =m $_d$, m $_c$ =m $_s$ and m $_t$ =m $_b$) and KM matrix parameters.

These phenomenological successes can be reasons why the model with a U $(3)_{fam\ ily}$ nonet Higgs bosons, which leads to a seesaw-type mass matrix (1), should be taken seriously.

2 Outline of the model

The model is based on SU (2)_L SU (2)_k U (1)_f U (3)_{fam ily} [7] sym m etries. These sym m etries except for U (3)_{fam ily} are gauged. The prototype of this model was investigated by Fusaoka and the author [8]. However, their Higgs potential leads to massless physical Higgs bosons, so that it brings some troubles into the theory. In the present model, the global sym metry U (3)_{fam ily} will be broken explicitly, and not spontaneously, so that massless physical Higgs bosons will not appear.

The quantum numbers of our fermions and Higgs bosons are summarized in Table I.

Note that in our model there is no H iggs boson which belongs to (2,2) of SU $(2)_L$ SU $(2)_R$. This guarantees that we obtain a seesaw type m ass matrix (2) by diagonalization of a 6 m ass matrix for fermions (f;F):




Fig.1. Mass generation mechanism of M $_{\rm f}$ ' m $_{\rm L}$ M $_{\rm F}$ 1 m $_{\rm R}$.

3 Higgs potential and \nonet" ansatz

We assume that h $_{\rm R}$ i / h $_{\rm L}$ i, i.e., each term in V ($_{\rm R}$) takes the coefcient which is exactly proportional to the corresponding term in V ($_{\rm L}$). This assumption means that there is a kind of \conspiracy" between V ($_{\rm R}$) and V ($_{\rm L}$). However, in the present stage, we will not go into this problem moreover. Hereafter, we will drop the index L in $_{\rm L}$.

The potential V () is given by

where V_{nonet} is a part of V () which satis es a \nonet" ansatz stated below, $V_{0 \text{ ct Singl}}$ is a part which violates the \nonet" ansatz, and V_{SB} is a term which breaks U (3)_{fam ily} explicitly.

The \nonet" ansatz is as follows: the octet component $_{\rm oct}$ and singlet component $_{\rm s}$ of the Higgs scalar elds $_{\rm L}$ ($_{\rm R}$) always appear with the combination of (4) in the Lagrangian. Under the \nonet" ansatz, the SU (2) $_{\rm L}$ invariant (and also U (3) $_{\rm fam\ ily}$ invariant) potential $V_{\rm nonet}$ is, in general, given by

For a time, we neglect the term $V_{\rm SB}$ in (10). For 2 < 0, conditions for m in im izing the potential (10) lead to the relation

under the conditions $_4+_5+2(_6+_7)=0$, and $v=v^y$, where we have put $_3=_3$ for simplicity.

4 Physical Higgs boson masses

For convenience, we de ne:

Then, we obtain masses of these Higgs bosons which are sum alized in Table II.

The m assless states $_1$ and $_1^0$ are eaten by weak bosons W $_{\rm W}$ and Z $_0^0$, so that they are not physical bosons. The m ass of W $_{\rm W}$ is given by m $_{\rm W}^2$ = ${\rm g^2v_0^2}$ =2, so that the value of ${\rm v_0}$ de ned by (16) is ${\rm v_0}$ = 174 G eV .

5 Interactions of the Higgs bosons

(A) Interactions with gauge bosons

Interactions of $_{\rm L}$ with gauge bosons are calculated from the kinetic term ${\rm Tr}(D \ _{\rm L}D \ _{\rm L})$. The results are as follows:

where $g_z = g = \cos w$ and $_1 = _1^0 = 0$.

(B) Three-body interactions among Higgs bosons

The full expression will be given elsewhere.

(C) Interactions with ferm ions

Our H iggs particles $_{\rm L}$ do not have interactions with light ferm ions f at tree level, and they can couple only between light ferm ions f and heavy ferm ions F . However, when the 6 6 ferm ion m ass m atrix is diagonalized as (9), the interactions of $_{\rm L}$ with the physical ferm ion states (m ass eigenstates) become

For charged leptons, since $U_L^e = 1$, the interactions of $_L^0$ are given by

Therefore, in the pure leptonic modes, the exchange of $_{\rm L}$ cannot cause family-number non-conservation.

For quarks, in spite of $U_L^q \in 1$, the Higgs boson H_1^0 still couples with quarks q_i diagonally:

However, the dotted parts which are interaction terms of $_2$, $_3$ and $_i^j$ (i $\stackrel{6}{\bullet}$ j) cause fam ily-num ber non-conservation.

6 Fam ily-num ber changing and conserving neutral currents

(A) Fam ily-num ber changing neutral currents

In general, the Higgs boson H $_1^0$ do not contribute to avor-changing neutral currents (FCNC), and only the other bosons contribute to \overline{P}^0 - P^0 m ixing. For the special case of m (H) = m (), we obtain the elective H am iltonian

where (k;l;m) are cyclic indices of (1;2;3), so that the bound can reduce to m $(H_2^0) = m (_2^0) > a$ few TeV. Note that FCNC can highly be suppressed ifm $(H_2)'$ m (H_3) .

(B) Fam ily-num ber conserving neutral currents

The strictest restriction on the lower bound of the Higgs boson masses comes from

The present data [3]B (K $_{\rm L}$! e) $_{\rm exp}$ < 3:3 $_{\rm 10^{11}}$ leads to the lower bound m $_{\rm H~3}$ = v_0 > 12, ie., m $_{\rm H~3}$ > 2:1 TeV .

7 Productions and decays of the Higgs bosons

As stated already, as far as our H iggs boson H $_1^0$ is concerned, it is hard to distinguish it from H 0 in the standard m odel. W e discuss what is a new physics expected concerned with the other H iggs bosons.

(A) Productions

Unfortunately, since masses of our H iggs bosons $_2$ and $_3$ are of the order of a few TeV , it is hard to observe a production

even in e^+e^- super linear colliders which are planning in the near future. Only a chance of the observation of our H iggs bosons $_i^j$ is in a production

at a super hadron collider with several TeV beam energy, for example, at LHC, because the coupling a_{tu} (b_{tu}) is su ciently large:

(B) Decays

Dominant decay modes of $(H^0)_3^2$ and $(H^0)_3^1$ are hadronic ones, i.e., $(H^0)_3^2$! $t\overline{c}$, $b\overline{s}$ and $(H^0)_3^1$! $t\overline{u}$, $b\overline{d}$. Only in $(H^0)_2^1$ decay, a visible branching ratio of leptonic decay is expected:

8 Summary

We have proposed a U(3)-family nonet Higgs boson scenario, which leads to a seesaw-type quark and lepton mass matrix M $_{\rm f}$ ' m $_{\rm L}$ M $_{\rm F}$ 1 m $_{\rm R}$.

It has been investigated what a special form of the the potential V () can provide the relation

$$m_e + m_e + m_e = \frac{2}{3} (p_{\overline{m}_e} + p_{\overline{m}} + p_{\overline{m}})^2$$
;

and the lower bounds on the masses of L have been estimated from the data of $P^0 - \overline{P}^0$ mixing and rare meson decays.

Unfortunately, the H iggs bosons, except for H $_1^0$, in the present scenario are very heavy, i.e., m $_{\rm H}$ 'm a few TeV. We expect that our H iggs boson (0) $_1^3$ will be observed through the reaction u! t+ (0) $_1^3$ at LHC.

The present scenario is not always satisfactory from the theoretical point of view:

- (1) A curious ansatz, the \nonet" ansatz, has been assumed.
- (2) The potential includes an explicitly symmetry breaking term $\,V_{\text{SB}}\,$.

These problems are future tasks of our scenario.
