Isgur-W ise Function and Observables of b Baryon

A bstract

In connection with planned experiments devoted to investigation of semileptonic decays of beauty baryons Isgur-W ise function and observables of $_{\rm b}$ baryon (decay rates and distributions, leptonic spectra and asym metry parameters) are calculated in the framework of diquark model with taking into account of infrared regime for heavy quark.

1 Introduction

Weak decays of heavy hadrons containing a single heavy quark can be considered as a unique tool to determ ine of Cabibbo-Kabayashi-Maskava matrix elements, original source to probe hadronic structure and investigation of eects beyond Standard Model.

The growth of interest to such processes is connected with considerable progress in experimental investigation and new theoretical ideas which were borned. One has to remark that during a long time the experimental programs were concentrated mainly on heavy mesons and charm baryons. Nowadays the facilities of modern accelerators allow to us investigate properties of beauty baryons. Particular rst observation of $_{\rm b}$ baryon was made in the decay $_{\rm b}$! J= at the pp collider (CERN) [1]. Sem ileptonic decays of $_{\rm b}$ baryon $_{\rm b}$! $_{\rm c}$ X e were studied by ALEPH and OPAL group at LEP [2, 3]. Observation of $_{\rm b}$ production in the Z $^{\rm 0}$ decays and measuring of $_{\rm b}$ lifetime were full led by DELPHIC ollaboration [4].

From a theoretical point of view weak decays of heavy quarks are interested because of a new type of sym metry of strong interactions was discovered – spin– avour sym metry in the world of heavy quarks (Isgur W ise sym metry) [5] and also heavy quark elective theory (HQET) [5]–[7] – perturbative calculating scheme for investigation properties of hadrons containing a single heavy quark. Isgur W ise sym metry manifested itself in the limit when heavy quark masses go to in nity m_Q! 1;Q = b;c (Isgur W ise limit). The consequences of these symmetries for weak heavy-hadron form factors were worked out by Isgur and W ise in ref. [5, 6]. Isgur and W ise showed [5], that form factors of B-meson weak decays B! D' B! D? are expressed through universal function (!) (mesonic Isgur W ise function), where ! is the scalar product of the four-velocities of the initial and nal heavy-hadron states.

In paper [6] the consequences of Isgur-W ise sym m etry were obtained for form factors of sem ileptonic decays of heavy baryons. It was shown that in the Isgur-W ise lim it (baryonic form factors satis ed to group conditions and expressed through three unknown universal functions (!), (!) (!) [6]. For example, matrix element corresponding to decay b | ce in the Isgur-W ise lim it has a trivial shape J (v; v) / (!) u (v) (1 + 5) u (v).

For decays $_{b}(_{b})$! $_{c}(_{c})$ e $_{b}(_{b})$! $_{c}^{?}(_{c}^{?})$ e connections between form factors are m ore complicated. However, all form factors can be expressed through two functions (!) and (!). Unfortunatelly, HQET as realistic theory of heavy avoured hadrons has no possibility to calculate functions (!), (!) and (!). So calculation of barrionic Isgur-W ise functions got dissemination within various phenomenological approaches: In nite Momentum Frame (IMF) models [8, 9], QCD Sum Rules [10], Quark Connement Models [11] and so on.

In [8, 9] sem ileptonic decay b! ce was considered in the framework of IMF m odel where it was assumed that heavy baryon consists of a heavy quark and light spin-zero diquark system. In ref. [9] Bauer-Stech-W irbeltype in nite momentum frame wave functions for the heavy -type baryons were used and in [8] D rell-Yan ones. Isqur-W is function (!) [8, 9] and various observables of $_{\rm b}$! $_{\rm c}$ e decay (rates, spectra and asymmetry parameters) were computed. Using QCD Sum Rules technique (!) form factor was calculted in paper [10]. In [11] sem ileptonic decays of heavy baryons by contract the contract of and b! ce are considered in the fram ework of Quark Con nem ent Model [12] with taking into account of so-called quark-diquark approximation [11]. It was showed in [11,12] that all form factors of $_{\rm b}$! $_{\rm c}$ e and $_{\rm b}$! $_{\rm c}$ e decay are expressed through a single unversal function (!) which is equal identically to Isgur-W ise function and is given the $(!) = \ln (! + \frac{P_{12}}{!^2}) (!^2)^{1=2}$. Later it was founded by X u [13] expression (!) that obtained results within QCM [11] contradict to B prken sum rule for sem ileptonic b decay which give the following restriction on function (!): 2 (!) 3 =(1 + 2! 2). So form factors obtained in the QCM are su iciently "hard".

In our paper we obtained suppression of baryonic Isgur-W ise functions using for heavy quark propagator so-called "infrapropagator", which describes behaviour of heavy quark near its mass-shell, i.e. in the limit when heavy quark mass goes to in nity (Isgur-W ise limit). Recently, in [14, 15] idea about infrared behaviour of heavy quark in the limit m_Q ! 1 was successfully used in calculation of mesonic Isgur-W ise function (!). Then we use obtained Isgur-W ise function in the calculation of observables of baryon (decay rates and distributions, leptonic spectra and asymmetry parameters).

2 M odel

At the consideration of b! c decays of beaty baryons we will use diquark factorization of baryon structure, which is based on a observation that light degrees of freedom in these processes are manifested itself as spectator or diquark. Thus heavy baryon can be presented as two-particle bound state of heavy quark an light diquark. In the case of b and baryons light diquark D a must possesses by the following quantum numbers: spin J=0, izospin I=0 and positive P-parity. Hence quark-diquark current with quantum numbers of b and baryons has the form $J_Q(x)=Q^a(x)D^a(x)$; Q=c; b. The interaction Lagrangain describing transition of heavy baryon Q into quark-diquark pair and vice versa is written as

Full Lagrangian needed for describing of decay b! c' is given by the formula:




Fig.1 Sem ileptonic decay of b baryon.

The corresponding Feynm an diagram is drawn in Fig.1. As light diquark propagator we will use standard propagator of scalar eld S_D (p^2) = 1=(M $_D^2$ p^2) where M $_D$ is a diquark mass.

As it is known from HQET [5]-[7] in the Isgur-W ise lim it heavy quark is near its mass-shell, i.e. infrared regime comes for heavy quark. Infrared asymptotics of one-particle G reen function was investigated in an Abelian theory (Quantum Electrodynamics) in many papers (see, for example, ref. [16]). So-called infrapropagator of electron has the following shape

Here parameter is connected with gauge parameter do by well-known condition

where em is a nestructure constant.

In the papers [14, 15] as the rst approximation in frapropagator of an Abelian theory is used in the calculations of Isgur-W ise function. We also will use this propagator. Particular heavy quark propagator is given by formula

The parameter must be bigger than zero to make all matrix elements ultroviolet nite. Therefore our model contains three parameters: light diquark mass M $_{\rm D}$, parameter = M $_{\rm B_Q}$ m $_{\rm B_Q}$ and infrared parameter . Experimental restrictions on the parameter are absent. Theoretical evaluation of value was made using QCD Sum Rules Technique by Neubert [17]. It was founded that = 0:50 0:07 GeV . Within QCM under consideration of leptonic decays of B and D mesons it was obtained that the parameter must exchange in limits 0 0:6 GeV . In our calculations we will x the parameter equaled to 0.6 GeV (as in various phenomenological approaches, see for example ref. [9]).

3 b! c Isgur-W ise Function

Isgur-W ise function in our model depends on parameter and ratio of diquark mass and parameter : $R = M_D =$ and is written as

In our calculations of Isgur-W ise function we try to get the best agreement with results of IMF models [8, 9]. It was achieved when parameter—is closer to value 1. Results for !-dependence of Isgur-W ise function for parameter—=1 and various meaning of parameter R in the interval 1.2 < R < 2 are presented in Fig.2. For comparison results of other theoretical approaches are given (IMF model [9] and QCD Sum Rules [10]). One can see that a good agreement with IMF model is achieved when R = 1.25. This choice of parameter R will called in our paper as the best—t. It is clear that in this case the diquark mass is equal to 0.7 GeV.

Let us to calculate also charge radius of Isgur-W ise function $^2 = d = d!$ j = 1

4 Weak Properties of b Baryon

Observables of sem ileptonic decays of $_{\rm b}$ baryon (decay rates, dierential distributions, leptonic spectra and asymmetry parameters) we will determ in $_{\rm b}$ in the terms of helicity

am plitudes H $_{\rm f}$ $_{\rm W}$ [9,18], where $_{\rm f}$ is helicity of baryon in the nalstate and $_{\rm W}$ is helicity of W -boson out of m ass-shell. We will present the calculations of $_{\rm b}$ baryon properties in the case of the best t In the Isgur-W ise limit helicity amplitudes are expressed through function (!):

Decay rates of sem ileptonic decays are calculated in accordance with formula

where indices T and L denote partial contributions of the transverse ($_W$ = 1) and longitudinal ($_W$ = 0) components of the current transition. Partial distributions are equal

where H $_{f}$ $_{W}$ = H $_{f}$ $_{W}$ H $_{f}$ $_{W}$. The results for decay rates are given in Table 2. For comparison we present the results of IFM model [9]. The curves of dierential distributions are drawn in Fig.3. One can to underline that our results for $\frac{d}{d!}$ are practically coincide with ones obtained in ref. [9].

Our results for leptonic spectra are pictured on Fig.4.

Let us to consider two-cascade weak decay $_{\rm b}$! $_{\rm c}$ [! $_{\rm s}$]+ W [! ' ·] which is characterizes by asym m etry param eters. Form alism and detailed analysis of asym m etry param eters was fulled in paper [14]. Here we calculate asym m etry param eters of non-polarized $_{\rm b}$ decay (; $^{\rm 0}$;) and polarized one ($_{\rm P}$; $_{\rm P}$) which in the term s of helicity amplitudes are given by following expressions

In our paper we will calculate average meanings of asymmetry parameters (< >;< 0 > and so on) as result of separate integration over parameter! of numerator and denomerator of eq. (8) with weight ($!_{max}$!) p = 1 in the interval 1 ! $!_{max}$. Results for average meanings are given in Table 3. Also the results of paper [9] are presented.
