Excited charm onium decays by ux{tube breaking and the anomaly at CDF

Abstract

The hadronic decay of radially and orbitally excited charmonium above charm threshold by ${}^{3}P_{0}$ pair creation and chrom oelectric ux{tube breaking is discussed in an harmonic oscillator approximation. We nd independent evidence from a study of widths for a 2S admixture in the predominantly 1D state (3770), and explore the possibility of metastable radially excited 2 ${}^{3}P_{0;1;2}$ states being a source of the anom alously large production of ${}^{\circ}$ at the Tevatron. At least one of them is expected to be narrow as a consequence of the existence of nodes in the radial wave function.

1 Introduction

Recently [°] enhancement at CDF [1] has generated considerable interest. This may currently be the largest discrepancy between the predictions of the standard model and experiment, and arises because the behaviour of QCD in the strongly interacting region is inadequately understood theoretically. There are four possible sources of enhanced [°] discussed in the literature [2, 3, 4, 5]: 2 ⁺ cc below the D D threshold [2, 3] (D = 0 and D = 1), radial (states (i.e. 2P charmonia) [3, 4], hybrid charmonium [3] and [°] with a cogg(component [5]. Investigation indicated that 2 ⁺ is an unlikely candidate [2, 3] unless [°] contains signi cant ³D₁ in its wave function. Detailed study [4] of fusion and fragm entation contributions to the production of radial (states indicated that they could explain the [°] excess if they are very narrow [3, 4] (1 M eV). We investigate whether this is likely or even possible in a QCD inspired model of Isgur and Paton [7], which is related closely to the phenom enologically successful [8] ³P₀ (m odel [9]. The extension of earlier work on light m esons [6] to charm ed hadrons is novel in its own right, and will form the basis for a subsequent study [10] of hybrid charm onium .

The strategy is to study rst the D D width of (3770). This is the cleanest example [11], being a natural 1D -2S candidate. The only real uncertainty is the 1D /2S (m ixing, though e^+e { and {transitions suggest a dom inantly 1D state. We not that the width ts with parameters determ ined elsewhere [6, 12, 13, 14, 15]; and discover that the next potential cc state of higher m ass, the 3S [16], would not enable sensible tting of the (3770) widths.

It is encouraging that the width of (3770) ts well in this picture. In fact, it ts in so well that we nd the need to constrain the model parameters by also tting energetically higher lying states, such as (4040), (4160) and (4415), to experiment.

W hen the model is applied to calculations of the widths of radial {states the results depend rather critically on the mass of these states, and hence the phase space available for their D D and D D decays. The 2^{++} decays in D-wave into D D; D D, while 1^{++} ! D D are likely to be near to threshold. As anticipated in ref. [3] we not the 2^{++} generally quite narrow (0.5 5 M eV) in the range of predicted masses. The 1^{++} and 0^{++} widths are very sensitive to the nodes of the radial wave function. It is possible that they are very narrow (1 M eV), but this would be a coincidental conspiracy, which nevertheless can be attained near the nodes. We not that for sensible parameter solutions to (3770), it is likely that some of the (0;1;2)⁺⁺ widths are considerably reduced, which is su cient for the enhanced production of $^{\circ}$ at CDF.

The basic structure of the paper is as follows.

In x2 we discuss the charm onium system and introduce the ux-tube model and the parameter values used. In x3 we t the (3770) to experiment and compare the range of possible mixing angles with those obtained from e^+e^- annihilation. We are encouraged by the consistency of these results, which prompts us to look at the higher radially excited states in x4, and observe to which degree their experimental signatures can be accounted for. The parameters obtained are used in x5 to look at radial {states and to exam ine whether they may be a source of the anom alously large production of $^{\circ}$ at CDF.We conclude by outlining the experimental consequences.

2 Outline of cc phenom enology

The ux{tube model decay amplitude [6] by pair creation di ers from the familiar ${}^{3}P_{0}$ { model amplitude, although they coincide in the case when is a universal constant for all outgoing mesons. This is shown in Appendix A, xA 2. In this work, we allow variation of

. Hence the two models are not identical, though their qualitative features are similar [8], allowing comparison with earlier studies [9, 15, 17, 18]. α

The only free parameter in the model is the overall normalization of decays $\frac{3e}{9^{P} \cdot \frac{1}{3} 2} A_{00}^{0} \stackrel{\text{fb}}{=}$ (eqn. 11, Appendix B). This dimensionless factor is common with light meson decays and was phenomenologically found to equal 0:64 [6] for creating light quark pairs with u; d and s avours². We adopt it here; thus implying that ccw idths are predicted independently.

From the ISGW non-relativistic t [23] to spin-averaged m eson m asses we take the string tension b = 0:18G eV², and the constituent-quark m asses m_{u,d} = 0:33 G eV, m_s = 0:55 G eV and m_c = 1:82 G eV. M eson m asses are taken to be the PDG m asses [24], and where not available (which is also the case for ${}^{3}P_{1}={}^{1}P_{1}$ m ixing angles) motivated by spectroscopy predictions [16], adjusted in absolute value relative to known m asses. The procedure for the calculation of widths is outlined in refs. [6] and [25, x2]³.

The experim ental total decay widths in M eV are [24]:

where we indicated the dom inant⁴ decay modes considered in this work, and z indicates modes that have been observed [24]. The modes indicated in eqn. 1 are assumed to dom inate over decays to ∞ + mesons. In the next section we shall calculate these

contributions to the hadronic width in our model, and sum them up in order to t them to the total experimental widths in eqn. 1.

3 Fitting the overall widths to experiment

3.1 (3770)

For some time there has been a need to obtain an overall picture of excited charm online with modern parameters. The process (3770) ! D D produces a D {m eson of momentum $p_B = 0.26 \text{ GeV}$ (see table 1). The decay happens far from where the widths vanish, i.e. from the nodes in the 1D/2S {am plitude, for all phenomenologically relevant ($_A$;). This, the fact there is only one hadronic decay mode, and that the width has been estimated successfully before [11, 26], make it the cleanest charm online candidate above charm threshold. We shall now proceed to discuss this state in more detail.

The J= has unambigously been identi ed as dominantly 1S, so the cc state (3770) must be a higher radial or orbital excitation: most probably, on mass alone, a 1D {2S mixture [16]. This can independently and non-trivially be established by considering its width. We nd that the (3770) width is consistent with it being 1D or 2S, i.e. with a 1D {2S mixture. The alternative \gedanken" assumption that (3770) is a 3S or 4S state leads to a contradiction: this would imply a width to D D too small to be consistent with experiment (for $_{\rm A}$; 0:1 1 G eV). Hence we believe that the 1D -2S nature of

(3770) established from width considerations, being consistent with mass spectroscopy, is signi cant.

Noting that the (3685) is predom in antly 2S, we expect (3770) to be mainly 1D, with a 2S admixture⁵ as j (3770) i = cos jlD i + sin j2S i. In gure 1 we indicate regions in parameter space where (3770) can be tted to experiment as a 1D {2S mixture for various . The fact that the width can be tted at all is non-trivial, as will be brie y outlined. If we mix the 1D and 2S decay amplitudes as a new amplitude f = cos 1D + sin 2S,

then $f^2 (1D)^2 + (2S)^2$; with the maximum of f_2 joccuring at tan = 2S=1D and the minimum f = 0 at tan = 1D = 2S. C learly there is a large range of widths that the m ixed state can have as is varied. There is still a restriction, though: in regions where $(1D)^{2} + (2S)^{2} < 24$ 3 M eV, the (3770) total width f² (1D)² + (2S)² cannot be tted for any . However, there is a large region where f is large enough to reproduce experiment.

We can restrict the parameter space (A;) by incorporating theoretical prejudice about the 's.D; D and D have in the region⁶ 0:30 0:70 GeV; and (2S) and (1D) have $_{A} = 0.30$ 0.55 GeV. From gure 1 we note that (3770) can be tted for any in this region of parameter space, although a sizable 2S admixture with sin 30 45% appears to be preferred. This will be reinforced when we tm ore massive states in x32.

It can be estimated⁷ from the observed $e^+e_{\text{widths of}}^\circ$ and (3770) that either sin = 17% [27] or 23% [28] or sin $= \{49\%$ [27] or sin $= \{44\%$ [28], employing our convention for . Clearly our analysis prefers sin > 0, concurring with notings on the detailed analysis of [27] and cc radiative [28] decays. This also in agreem ent with theoretical calculations in the coupled channel form alism, which nd sin = 17% [11] or 20% [29].

G iven that the overall norm alization of decays was taken from light m eson spectroscopy as part of a uni ed study, in contrast to earlier or calculations [15, 17, 18, 22, 30], we do not regard the disagreement of our estimate with that from e^+e {widths as signicant. Our determ ination of the 2S admixture in (3770) is hence broadly consistent with its e^+e width and the phenomenology of the ⁰. We thus consider ($_{A}$;) consistent with a realistic and dom inant 1D component in (3770), but with a sizable 2S adm ixture of

30% in am plitude.

In sum m ary we conclude that this model of decay by ux {tube breaking can successfully account for the (3770) as a 1D {2S m ixture in this study of widths, consistent with both the a priori theoretical estimates for $(_{A};)$ and the restrictions on from $e \in \{w : dths. T \}$ conclusions based on its width are also in line with mass spectroscopy. In the next section we shall nd that higher states can also be described with varying degrees of success.

3.2 Higher mass charm on ium

As far as states m ore massive than (3770) are concerned, we are led to identify them as 3S { 2D m ixtures, or higher radial excitations, due to the existence of convincing candidates for 1S, 2S and 1D states. The (4160) and (4040) (which may be either simple resonances or a collection of states), should at least contain the 3S and 2D states, otherwise the (4415) must be 3S or 2D, leading to a contradiction: the 1S, 2S, 3S, 1D and 2D wave functions produce (4415) total widths too large to be consistent with experiment (for 0.2 0.8). Hence by default the natural interpretation of (4160) and Α; (4040) is that they are 3S{2D mixtures. They can be tted consistently with experiment in the phenom enologically relevant region $_{\rm A}$; 0:3 0:6. Also, (4415) can be tted as 4S 0:4 0:6 GeV. We shall hence adopt⁸ these assignments, 0:3 0:6 GeV and for A which are in agreem ent with m ass spectroscopy [16, 31].

We expect the (4160) to be the easiest to describe. This is because there is an experimental constraint on the width ratios of (4040) [17] (see below), casting doubt on whether it is conventional cc. Also, the (4415) has num erous decays modes (including decays to D D), making its narrowness [17] potentially di cult to understand.

It is theoretically expected that the magnitudes of $_{\rm A}$ for higher excited states are smaller than those of lower states (e.g. (3770) in this case) by $^{<}$ 0:1 GeV [6]. A llowing for this, we nd⁹ that all three of the higher states can be accommodated with a 2S admixture in (3770) of 30 45 % in amplitude. It can be seen by comparing gures 1 and 2.

If we choose parameters consistent with a sizable 2S component in (3770), gure 2 indicates that it is possible to t (4160) as 3S, and to a lesser extent as 2D, in a wide range of theoretically acceptable ($_{\rm A}$;). If we require near to the ISGW value [23], ($_{\rm A}$;) = (0.30,0.39) GeV gives a good t form ost states. Some of these values also allow ts of (4415) (see tables 2 and 3), e.g. ($_{\rm A}$;) = (0.42,0.52) GeV, where we nd excellent agreement. The point ($_{\rm A}$;) = (0.50,0.54) GeV, which ts (4040) in addition (see below), also lies in this region.

We now proceed to discuss the (4040). The issue of whether it can be understood as ordinary charmonium has historically been controversial, due to its anom alously large D D branching ratio. The large experimental ratios $[24] R_1$ (D D) = (D D) = 5 -20 and R_2 (D D) = (D D) = 1 - 2.5 can conceivably be explained by looking for nodes (zero's) [11] in the decay am plitudes corresponding to decays into D D and D D. This can arise if the kinematics of the decay are controlled by nodes arising from the

radial wave functions of the 3S or 2D states. There is thus the possibility of the DD and D D amplitudes being near enough to two^{10} di erent nodes or to the same node [17]. We proceed to seek cases ($_{\rm A}$;) where ${\rm R}_1$ and ${\rm R}_2$ are consistent with experiment. A lthough $R_{1:2}$ can be tred for (4040) as 2D with (A;) (0:3;0.2), the total width is too small, leading us to the conclusion that a consistent picture of (4040) can only be obtained with it as 3S.Our search provides three areas in parameter space where the (4040) may be realized as 3S (see table 4 and qure 2). If in addition we require the (3770) and (4160) to be consistent with experiment, (4160) to be 2D (as a consequence of (4040) being 3S), and the parameters to be consistent with theoretical estimates, we are restricted to (A;) around (0.50,0.54) GeV. This region represents the only area where we can tall experim ental data on excited charm onium decays, including the (4160) and (4415), with the (3770) a 1D-2S m ixture as usual (see tables 3 and 4). The region also appears to be related to the one found by Le Y aouanc et al. [17], who also identi ed¹¹ (4040) as 3S. This in plies that it is possible to t (4040) consistent with experiment without contradicting the phenom enology of the other {states, although it severely constrains the parameters, requiring considerable coincidence of parameters [18] and ne tuning of A to 1 3%, in order to obtain the correct branching ratios.

The ts obtained for ($_{\rm A}$;) = (0.42,0.52) and (0.50,0.54) GeV above are remarkable in the sense that we can accurately t three am plitudes (i.e. (3770), (4160) and (4415)) to experiment with two parameters $_{\rm A}$ and , with the additional conclusion that (4040) can possibly be tted, and furthermore that the assigned nS, nD classications are consistent with m ass spectroscopy.

In sum m ary we conclude that the higher states m ay also be accommodated in this model. We have thus established another rung on the ∞ ladder, highlighting the di culties associated with (4040) and (4415).

4 2P charm onia and the $^{\circ}$ anom aly at CDF

The experimental production rate of $^{\circ}$ is 30 times larger than theoretical estimates [1] at large transverse momentum in pp collisions at the Tevatron. One proposed source [3, 4] is the production of 2P charmonia followed by their radiative decay $2^{2S+1}P_J$! $2^{3}S_1 + ...$, enhancing the $^{\circ}$ rate. This can only happen if the 2P charmonia have small hadronic widths. These states are expected [16, 31] to lie above the D D {threshold (3.73 GeV), probably above the D D {threshold (3.87 GeV), and possibly above the D $_{s}D_{s}$ {threshold (3.94 GeV) but beneath the D D {threshold (4.02 GeV). In these circum stances we nd that their hadronic widths may be small.

If the 2P states lie below the D D {threshold (say at 3.85 GeV), then the $2^{3}P_{2}$ and $2^{3;1}P_{1}$ are narrow : $2^{3}P_{2}$ (because of D-wave phase space) has width 0-4 M eV, and $2^{3;1}P_{1}$ is narrow because only decays to D D are allowed.

If the 2P states lie above the D D {threshold the $2^{3}P_{2}$ has the unique property that the total width remains small (because of D-wave phase space) at 0-7 MeV (3.90 GeV) and 1-14 MeV (3.95 GeV). Figure 3 indicates that in the theoretically reasonable region where (_A;) (0:3;0:4) (0:4;0:6) GeV these widths can be $^{<}$ 1 MeV if (_A;) is tuned to only (15,20) %. This is of special interest for the resolution of the CDF anomaly. The $2^{3;1}P_{1}$ and $2^{3}P_{0}$ states only have small widths if the kinematics of the decay cause the amplitude to be controlled by the nodes arising from the radial wave functions of the 2P states (otherwise the amplitude can be substantial, even near thresholds).

For decays of $2^{3;1}P_1$ the S-wave nodes occur in a line of parameter space (_A;) (0:3;0:4) (0:45;0:6) GeV coinciding with narrow $2^{3}P_2$ (see gure 3). It is fascinating that this region coincides with D-wave nodes, reinforcing the narrow ness of $2^{3;1}P_1$.

For decays of $2^{3}P_{0}$ the S-wave nodal line occurs for ($_{A}$;) (0:4;0:3) (0:5;0:6) GeV (see gure 3). Estimates [16] suggest this to be the lightest 2P state, and hence possibly narrow (i.e. below the $D_{s}D_{s}$ {threshold, which ensures that $2^{3}P_{0}$! $D_{s}D_{s}$ does not overshadow the decay).

Hence we expect at least one of $2 {}^{3}P_{2}$, $2 {}^{3}P_{1}$ or $2 {}^{3}P_{0}$ to be narrow; the $2 {}^{3}P_{2}$ being most likely, since obtaining $2 {}^{3}P_{0}$ and $2 {}^{3}P_{1}$ widths of 1 MeV requires netuning (_A;) respectively to (4,7) % and (1,1) % in gure 3. Theoretically we expect _{2P} 0:3 0:45 GeV, tantilizingly in accord with the values where we expect nodes to occur.

Both the best regions in x3 tting experiment (i.e. near ($_A$;) = (0:42;0:52) and (0:50;0:54) GeV) can be consistent with one of the 2P states being very narrow (1 M eV), depending sensitively on their masses.

If an amplitude lies near a node, it becomes especially sensitive to dimensial amounts of phase space e.g. for D^0D^0 and D^+D nal states. This sensitivity may be decreased if other small decay modes far from a node swamp the decay. Since $p_B = 1 = p_B$, the change in available phase space is largest when the decay is nearest to threshold, so that amplitude variations¹² are pronounced near thresholds. Hence, when 2P m asses are known experimentally, these elects should be incorporated near the various thresholds if there is nodal suppression of an amplitude.

¹²W e have not considered these e ects in x3.1. They are expected to be largest for (3770) ! DD, because it is near threshold (see table 1), and the dom inant hadronic decay mode. However for realistic ($_{\rm A}$;) it is far from a node, with typically 5 – 15 % variation in width due to varying the phase space of decays to D⁰D⁰ and D⁺D . So the e ect is small compared to variations in ($_{\rm A}$;).

5 Conclusions

Our results from hadronic decays of charm onium are as follows:

(3770)! D D can be understood with the (3770) as a mixture of $2^{3}S_{1}$ and $1^{3}D_{1}$. We nd that the width ts with parameters determined elsewhere [6, 12, 13, 14]; and discover that the next state of higher mass, the 3S [16], would not enable sensible tting. We favour a sizable 2S admixture in (3770) (30% in am plitude), consistent with e⁺ e {annihilation. This is also in observational agreement with higher states.

We not further encouragement that the widths of (4160) and (4040) twell if they are 3S {2D m ixtures. We note that they do not admit solutions as 2S-1D states.

(4160) ! DD;DD;DD;D, $D_{s}D_{s}D_{s}D_{s}D_{s}$ can be understood with the (4160) as either $3^{3}S_{1}$ or $2^{3}D_{1}$, depending on the preferred value of ($_{A}$;) in x3. Study of the branching ratios of this state at a -charm factory could be a rather critical test of its wave function composition.

(4040) cannot be understood as $2^{3}D_{1}$, due to an inability to reproduce simultaneously the total width and correct branching ratios into DD; DD; DD. These are experimentally (neglecting statistical uncertainties) 1:8:14. Remarkably, the state can be understood as $3^{3}S_{1}$ in three regions of parameter space (see table 4). This, however, severely constrains parameters. Previous interpretations of (4040) as cc [15] m ay hence now be invalid due to a change in preferred parameters. This leaves open the possibility of (4040) being a DD molecule [19] or a threshold e ect [32] (the state is 10 - 30 MeV above the DD threshold with a width of 40 - 60 MeV, and can hence not be treated well in the narrow resonance approximation). There may be several 1 states in the 4.0 - 4.3 GeV region, due to the possible additional existence of a hybrid meson of mass 42 GeV [31, 33], but whose e⁺ e production is suppressed due to the radial wave function vanishing at the origin [31].

The (4415) is pinned down to having a 4S wave function. Its total width tends to be small enough only in restricted regions, suggesting that the narrowness [17] of (4415) remains an interesting issue¹³. It is not easy [30] to identify dom inant decay modes without xing ($_{\rm A}$;) and the degree of mixing, as was electively done in the literature [17, 18, 15], in contrast to earlier expectations [17, 18] where D $_{2^{++}}$ D was indicated as possibly signilicant.

W here energetically allowed, decays to $D_s; D_s$ are suppressed by a avour factor of two, relative to decays to D; D. This, together with P-wave phase space, conspires to make the branching ratios of (4040), (4160) and (4415) to D and D consistently larger than those to D_s and D_s . This is violated for (4040) ! D_sD_s , where the lack of a corresponding experimental width estimate may indicate additional suppression of ss creation [11, 17] (see table 4 and footnote 2).

Radial {states m ay be the source of a signi cant \degree cross{section at the Tevatron if their widths are narrow. Their widths depend rather critically on their m asses, and hence

 $^{^{13}}$ The narrowness can be increased by increasing the radial excitation. Studies of the (4415) width [17, 18, 22] and mass [29] tend to nd a 4S assignment. A 5S assignment (with an accompanying 4S

⁽⁴¹⁶⁰⁾⁾ has, how ever, been suggested [28, 30]. This possibility is found to be consistent with experimental widths by our study, and can as such not be ruled out.

the phase space available for their D D and D D decays. The 2^{++} decays in D-wave into D D; D D, while 1^{++} decays to D D are likely to be near to threshold. As anticipated in ref. [3] we nd the 2^{++} generally quite narrow (0.5 5 M eV) in the range of predicted masses, with the narrower widths corresponding to D-wave nodal suppression. The 1^{++} and 0^{++} widths are very sensitive to the nodes of the radial wave function. It is possible that they are very narrow (1 M eV), but this would be a coincidental conspiracy. For 0^{++} below the D $_{s}D_{s}$ (threshold, nodal suppression is quite consistent with (3770) decays. We thus nd that for sensible parameter solutions to (3770), it is likely that some of the (0;1;2)⁺⁺ widths are considerably reduced. This would suggest placing emphasis on searching for the $2 {}^{3}P_{2}$ in events containing ${}^{\circ}$. We predict that if its hadronic width is found to be 1 M eV, then the $2 {}^{3;1}P_{1}$ m ay also be found to narrow (depending sensitively on their mass).

The overall consistency of excited charm onium with observation vindicates the expectation that the pair creation amplitude is similar for charmonium and light meson decays (in each case light quarks are created). In view of the slightly exaggerated 2S admixture we obtain in (3770), this amplitude may have to be adjusted slightly. This procedure would however not a ect the nodes in the decay amplitude, leaving the ($_A$;) where {states are narrow unaltered.

We highlight the need for improved data on excited charmonia: to con m whether they are true resonances, to study their branching ratios into various channels and to discover whether som em ay be narrow. Rather clear signals, in particular in e^+e_{-} {annihilation, may also reveal hybrids and molecules.

A Appendix : The coincidence of ux-tube and ³P₀{ model decay amplitudes in limiting cases

For m eson decays to m esons the ${}^{3}P_{0}$ and the ux-tube m odels coincide in the limit of an in nitely thick ux{tube, i.e. where the pair creation amplitude is constant all over space. This is indicated explicitly in xA 1. It is possible to make a stronger statement : The ${}^{3}P_{0}$ and ux-tube models coincide when is a universal constant for all outgoing m esons, even if the ux{tube has nite thickness. This is demonstrated in xA 2.

We focus on two initial quarks of mass M, with pair creation of quarks of mass m. The decay amplitude of an initial meson A into nalmesons B and C can be shown [25, Appendix A] in the rest frame of A (where $p_A = 0$) to be given by

Here (B \$ C) indicates a term obtained by interchanging the avour and spin m atrices B \$ C and momenta p_B \$ p_C in the 1st term in eqn. 2. For cc decaying by the creation of a uu, dd or ss pair, only one of the term s contribute (due to Tr(A^TBC)_{flavour}); and the space part of the term di ers by a sign from the space part of the displayed term in eqn. 2. So from now on it is su cient just to consider the the displayed term .

The pair creation position y [6] is measured relative to the CM of the initial quarks, and y_2 (y \hat{r}_A) \hat{r}_A is a perpendicular \com ponent" of y to the initial QQ {axis r_A . The Qq-axes of the nalstates B and C are $r_B = r_A = 2 + y$ and $r_C = r_A = 2$ y respectively [6].

A.1 Spatially constant pair creation

The pair creation amplitude (or ux-tube overlap) is

The thickness of the ux-tube is related inversely to f. A detailed discussion of these quantities and the structure of eqn. 3 m ay be found in ref. [6, eqn. A 21] and ref. [34]. The estimated values f = 1:1 and $A_{00}^0 = 1:0$ [25, 34] are used in this work. The in nitely thick ux-tube with f = 0 corresponds to the ${}^{3}P_{0}$ (model [17]. In this case ($r_{A}; y_{?}$) is a constant (which should be normalized to be non-zero), and the qq{pair is created with uniform amplitude anywhere in space. Fourier transforming (a relevant part of) eqn. 2 yields

we can see that it equals the last line of eqn. 4 [15] (with $p_A = 0$) when we make a change of variables to $k_A = (k_1 \quad k_2)=2$ and $k_{CM} = k_1 + k_2$. Here kY_1 (k) = $\frac{q}{\frac{3}{4}}e$ k was used. We have thus connected the ux-tube and ${}^{3}P_0$ (model notation explicitly; showing that the two models coincide for an in nitely thick ux{tube; and verifying the expectation that a zero momentum qq{pair corresponds to complete freedom in creating the pair anywhere in space.

Since the ${}^{3}P_{0}$ {m odel [9] corresponds to taking f = 0 in the amplitude above, we see that the ux-tube m odel amplitude di ers from the ${}^{3}P_{0}$ {m odel amplitude by a factor of 1+ fb=2 2 for both S + S and P + S nalstates. This explains the system atics of an earlier calculation [6, table II : com pare colum ns 2 and 3] by Isgur and K okoski, with = 0.4 throughout. Hence in the approximation where (the nalstate) is constant throughout for all m esons, the ux-tube and ${}^{3}P_{0}$ {m odels yield identical amplitudes when norm alized to experiment.

The reason why Isgur and K okoski's results for the ${}^{3}P_{0}$ and ux-tube m odels are slightly di erent, is because they use a cigar-shaped overlap, which m odi es the in nite cylinder overlap of eqn. 3 longitudinally away from the QQ (axis. The sm all deviation of their results for the two m odels from one another (5% in width) demonstrates that this overlap, although physically reasonable, m akes little quantitative di erence on the scale of m odel errors, and is hence safely neglected, vindicating our choice of ux (tube overlap in eqn. 3.

The di erential operator depends only on $\$, and can hence be pulled out when the integration in eqn. 2 over r_A and y is performed. The amplitudes for radially excited m eson decay can hence be found by applying the di erential operators in eqn. 14 to the amplitudes in table 5.


Figure 1: The contours indicate (3770) totalhadronic widths thing the mean experimental width in eqn. 1. Where there is 1D-2S mixing with mixing angle , we display sin (which can be positive or negative). Pure 1D and 2S states are also shown. The \square" indicates theoretically acceptable parameters.


