Top Quark Distributions in Hadronic Collisions

A bstract

We present kinem atical distributions for top quark pairs produced at the Tevatron pp Collider, as predicted within Next-to-Leading-Order QCD. We consider single and double-inclusive distributions, and compare our results to those obtained with the shower Monte Carlo HERW IG. We discuss the implications of our indings for experimental issues such as the measurement of the top quark mass.

Now that the existence of the top quark has been my established via its detection in hadronic collisions [1, 2, 3], experimental studies will focus on the determination of its properties. In particular, them easurement of its mass and of the production cross section and distributions will certainly be among the rst studies of interest. The top mass represents one of the crucial parameters for testing the Standard Model [4], while the production properties, should they display anomalies, could point to the existence of exotic phenomena [5].

Early estim ates of the total production cross section for top quarks [6, 7] have later been updated [8]. In ref. [9] a partial resum m ation of leading logarithm s from soft gluon em ission has also been included.

In this Letter we present a set of kinem atical distributions of relevance for the study of production dynam ics, as obtained from full N ext-to-Leading-O rder (N LO) QCD perturbative calculations. We will consider inclusive $p_{\scriptscriptstyle T}$ and pseudorapidity () distributions, as well as invariant mass (M (tt)), transverse momentum ($p_{\scriptscriptstyle T}$) and azim uthal correlations () of the top quark pair.

The inclusive p_T distribution is sensitive to channels such as W g! tb [10], which are found to contribute with a small cross section, predom inantly at low p_T . The invariant m ass of the pair is an obvious probe of the possible existence of strongly coupled exotic resonances, such as technim exons [5]. The transverse momentum of the pair is an indication of the emission of hard hadronic jets in addition to those coming from the top decays. The presence of these additional jets generates potentially large combinatorial backgrounds to the reconstruction of the top mass peak from the decay products [2]. An accurate understanding of these backgrounds is in principle very important for a precise measurement of the top mass.

The NLO total, single and double inclusive cross sections for the production of heavy quarks in hadronic collisions have been calculated in references [6], [11] and [12], respectively. Since most experimental studies are performed using shower Monte Carlo event generators [13] to simulate the behaviour of the events in the detectors, we will compare our NLO results with those we obtained with HERW IG [14]. This is important in order to assess the reliability of the theoretical inputs used by the experiments. It has been recently pointed out [15] that there are possibly signicant dierences in the jet activity predicted by xed-order parton level calculations and the results of HERW IG, with possible implications for the experimental mass measurement. We will discuss here a possible origin of these discrepancies.

For our calculations we use m $_{\rm t}$ = 176 GeV (CDF, ref. [1]). Dierences of 15 GeV, approximately the current experimental error, do not a ect the shapes of the distributions we present nor any of our conclusions. Our default set of parton densities is MRSA [16], and we explore a range of renormalization and factorization scales $_{0}$ =2 < $_{\rm R}$ = $_{\rm F}$ < 2 $_{0}$, with $_{0}$ ² = m $_{\rm t}$ ² + p $_{\rm F}$ ² ($_{0}$ ² = m $_{\rm t}$ ² + ($_{\rm t}$ p $_{\rm t}$) $_{\rm t}$ ²)=2) for single (double) dierential distributions.

Throughout our plots, we rescale the HERW IG calculations by the perturbative K factor given by the ratio of the O ($_{\rm s}^3$) and the O ($_{\rm s}^2$) results. The K factor is of the order of 1.3 for all choices of param eters. The distributions of $p_{\rm r}$, and M (tt) are shown in gures 1{3. The solid lines correspond to the NLO results obtained using $_{\rm R}=_{\rm F}=_{\rm 0}$. The curves obtained using a di erent choice of scales, within the




Figure 1: Inclusive p_T distribution of the top quark.

range quoted earlier, result in an overall normalization change, by approximately 10%. No change in the shapes is observed, and we therefore decided not to include these curves in the plots for the sake of clarity. The square points correspond to the HERW IG prediction for $_{R}$ = $_{0}$, rescaled by a K factor equal to 1.34.

The gures indicate clearly that distributions which are not trivial at leading order, such as $p_{\scriptscriptstyle T}$, and M (tt), agree perfectly between the NLO and HERW IG calculations, at least for values of $p_{\scriptscriptstyle T}$ and M (tt) not too large. This result follows naturally both from the observed stability of those distributions under radiative corrections regardless of the heavy quark m ass [12], and from the large inertia of the top quark against the combination of higher order and non-perturbative corrections introduced by the M onte C arlo. At large $p_{\scriptscriptstyle T}$ and M (tt), however, one starts observing a small deviation, due to the multiple gluon emission from the nal state top quarks. This e ect is not described by the NLO QCD calculation, which only includes one gluon emission. Multiple gluon emission becomes relevant for $p_{\scriptscriptstyle T}$ m, where it leads to a top quark fragmentation function softer than predicted by the xed order NLO calculation. Due to the smallness of the cross section in these regions, large statistics will be needed in order to test this behaviour.

Those distributions which are trivial at leading order, and P $_{\rm T}^{\rm tt}$, are viceversa m ost sensitive to multiple gluon em ission from the initial state. This is because even small perturbations can smear a distribution which at leading order is represented by a delta function, which is the case of P $_{\rm T}^{\rm tt}$ and . The most visible e ect is observed in P $_{\rm T}^{\rm tt}$, Figure 4, where we include the NLO curves relative to the three choices of scales, $_{\rm R} = _{\rm F} = _{\rm 0}$ (solid), $_{\rm 0}/2$ (dots) and 2 $_{\rm 0}$ (dashes). Contrary to the previous cases, signicant dierences in shape arise here among the three choices in the small p region. The HERW IG result (normalized to the area of the solid curve) is also shown. The NLO and the HERW IG distributions assume the same shape only for P $_{\rm T}^{\rm tt}$ larger than approximately 20 G eV.




Figure 2: Inclusive pseudorapidity distribution of the top quark.

To better quantify the di erences, we quote in Table 1 the value of the average $P_{_{\mathrm{T}}}^{\,\,\mathrm{tt}}$ and of the fraction of the total cross section with $P_{_{\mathrm{T}}}^{\,\,\mathrm{tt}}$ > 10;20 GeV for the di erent curves appearing on the plot. First of all we notice the strong scale dependence of the results in Table 1. This is a rst indication of the lack of reliability of the xed order calculation for these particular quantities. Observe that the NLO result obtained with the lowest scale is closer to the HERW IG result. In fact, a lower scale is presum ably more appropriate in this problem. This is because there are two relevant scales in this case: the mass of the top, and the transverse momentum cut. Since the production of top quarks takes place mainly through the exchange of a highly virtual gluon (with virtuality of the order of the top mass), while the em ission of the jet takes place at the smaller scale of the jet transverse m om entum, it is sensible to take in the O ($\frac{3}{s}$) cross section two powers of $\frac{3}{s}$ at the large scale $\frac{3}{s}$ and one at the transverse m om entum of the jet. W e have perform ed this exercise, $(P_{T}^{tt} > 10 \text{ GeV}) = 1.987 \text{ pb, which is } 43\% \text{ of the total cross section}$ and obtained




Figure 3: Invariant mass distribution of the tt pair.

com puted at the scale 0.

The high value of hP_T^{tt}i for the NLO calculation indicates that the probability of em itting a gluon with transverse energies k_T of the order of 10 GeV is of order 1. Technically, this is related to the appearance of a large double logarithm 0 ($_{\rm S}$ log² [m $_{\rm t}$ = $k_{\rm T}$ 2]). It is well known [17] that in these circum stances multiple gluon em ission, corresponding to multiple powers of these double logs, needs to be resum med. A typical example can be found in W and Z production at small k_T [18].

The M onte Carlo HERW IG performs the resumm ation of leading and some subleading double logarithms, faithfully reproducing the behaviour of the analytically resummed cross sections in known cases [14]. The large topm assextends the region where Sudakov elects are important up to $k_{\scriptscriptstyle T}$ values which are often considered within the domain of applicability of standard xed-order perturbation theory.

We have in plemented a leading logarithm version of the resummation procedure described by Collins Soper and Sterman in [18], and qualitatively reproduced the behaviour of the M onte Carlo . We therefore conclude that the parton level result (with the factorization and renormalization scale taken of the order of the mass of the top quark) is less reliable than the M onte Carlo in the small $P_{\rm T}^{tt}$ region, and gives a cross section (for $P_{\rm T}^{tt}>10~{\rm GeV}$) which is roughly 60% of what one would get with a more judicious choice of the scale, and with the inclusion of Sudakov exts. We also point out that no choice of scales in the NLO calculation would describe the detailed shape in the region $P_{\rm T}^{tt}<20~{\rm GeV}$. On the other hand, we expect the parton calculation to be more accurate in the large $P_{\rm T}^{tt}$ region, where the soft approximation used in the M onte Carlo breaks down.

A similar problem should be expected in the description of jet radiation during the production of any massive system, in particular $\mathbb W$ or $\mathbb Z$ boson pairs. This might a ect parton level calculations of backgrounds to tt production in the dilepton plus




Figure 4: Transverse m om entum distribution of the tt pair.

two jet channel. A simple estimate along the lines of what performed above for the top, sets the threshold below which xed order perturbation theory becomes unreliable at about 10-15 GeV, which still corresponds to jets su ciently energetic to be reconstructed as such by the Collider detectors. A confirmation of this estimate can be found in the study of resummation elects on the $p_{\scriptscriptstyle T}$ distribution of Z pairs presented in reference [20].

The observations made above partially explain the disagreement found in ref. [15] between the relative fraction of jets em itted during the production process and jets em itted from the b quark resulting from the top decay. These authors found that their parton level calculation gave rise to a ratio smaller than HERW IG's. They interpreted it as a de cit in jet radiation o the nal state b quark within HERW IG. In order to make a more de nite comparison with the results of ref. [15], we have com puted the tt jet cross section with the same value of the parameters and the same set of cuts that they applied. We used therefore $m_t = 174 \text{ GeV}$, $_0 = m_t$, j_{int} j < 2.5, $P_T^{tt} > 10$ GeV. In order to emulate the cuts they perform on the bijets com ing from top decays, we let the top quark decay isotropically, and in posed the additional cuts $j_b j < 2.5$ and $p_r^{(b)} > 10$ G eV . W e veri ed that these additional cuts a ect the cross section by less than 3%. We obtained a cross section of 1.30 pb, to be compared with the value of 1.0 pb of ref. [15]. We have no explanation for this di erence. From the considerations made previously, we expect that the inclusion of Sudakov e ects should increase the cross section by roughly 66%, leading to a value of 2.16 pb, m ore than a factor of two larger than the result of ref. [15].

Figure 5, nally, shows the tt azim uthal correlations. Notice that most of the shape discrepancies observed at $P_{\tau}^{tt} < 20$ GeV are forced here into the bin around




Figure 5: A zim uthal distance distribution of the tt pair.

the = point. This is because even a 20 GeV kick will only de ect the trajectory of the tort quark (each traveling with momentum of the order of $m_{\rm t}/2$), by about 1/10 of a radian.

W hile completing this paper, a study of single inclusive distributions of top quarks at the Tevatron appeared [21]. These authors improved the NLO calculation with the inclusion of a partial resummation of leading soft logarithms [9]. Their results indicate that single inclusive distributions are only a ected in overall normalization, but not in shape (at least for p_r not much larger than m_t). This is consistent with the results presented here, and provides yet more con dence in the validity of the perturbative predictions applied to single inclusive quantities.

In concusion, we presented here a set of kinematic quantities which should be used to test the dynamics of top quark production in hadronic collisions. Most of these quantities were shown to be subject to very small theoretical uncertainty within NLO perturbative QCD, and to be rather insensitive to higher order or hadronization e ects. One noticeable exception is the transverse momentum of the pair, which is in turn related to the spectrum of jets recoiling against the top pair. We found in our study that an accurate description of the region $P_{\tau}^{tt} < 20$ GeV requires the resummation of leading soft and collinear double logarithms, as implemented in appropriate shower Monte Carlo programs.
