## ABSTRACT

U sing the $S$ \{m atrix pinch technique we obtain to one loop order, gauge independent $W W^{+}$and Z W $W^{+}$vertices in the context of the standard $m$ odel, w ith all incom ing m om enta $o$ \{shell. W e show that the vertices so constructed satisfy sim ple Q ED \{like W ard identities. T hese gauge invariant vertiges give rise to expressions for the $m$ agnetic dipole and electric quadrupole form factors of the $W$ gauge boson, which, unlike previous treatm ents, satisfy the crucial properties of infrared niteness and perturbative unitarity.

## 1. Introduction

A new and largely unexplored frontier on which the ongoing search fornew physics w ill soon focus is the study of the structure of the three-boson couplings. A general param etrization of the trilinear gauge boson vertex for on $\{$ shell $W \mathrm{~s}$ and $\circ$ \{shell $\mathrm{V}=; \mathrm{Z}$ is

w th $\mathrm{g}=\mathrm{gs}, \mathrm{g}_{z}=\mathrm{gc}$, where g is the $\mathrm{SU}(2)$ gauge coupling, $\mathrm{s} \quad \sin \mathrm{w}$ and C Cos w, and the ellipses denote om ission of $C, P$, or $T$ violating term $s$. The four$m$ om enta $Q$ and are related to the incom ing $m$ om enta $q_{1} p_{1}$ and $p_{2}$ of the gauge bosons $V ; W$ and $W^{+}$respectively, by $q=2 Q, p_{1}=Q$ and $p_{2}=Q$ 畐. The form factors v and $\mathrm{Q}_{\mathrm{v}}$, also de ned as $\mathrm{v}^{2}={ }_{\mathrm{v}}+{ }_{\mathrm{v}} 1$, and $\mathrm{Q}_{\mathrm{v}}=2 \mathrm{v}$, are com patible w ith $C, P$, and $T$ invariance, and are related to the $m$ agnetic dipole $m$ om ent $w$ and the electric quadrupole $m$ om ent $Q_{w}$, by the follow ing expressions:

In the context of the standard $m$ odel, their canonical, tree level values are $f=1$ and $\mathrm{v}=\mathrm{Q}_{\mathrm{v}}=0$. To determ ine the radiative corrections to these quantities one $m$ ust cast the resulting one\{ loop expressions in the follow ing form :

$w$ here $a_{1}^{V}, a_{2}^{V}$, and $a_{3}^{V}$ are com plicated functions of the $m$ om entum transfer $Q^{2}$, and the $m$ asses of the particles appearing in the loops. It then follow sthat v and Q v are given by the follow ing expressions:

Calculating the one-loop expressions for $v$ and $Q v$ is a non-trivial task, both from the technical and the conceptual point of view. If one calculates just the Feyn$m$ an diagram s contributing to the $\mathrm{W}^{+} \mathrm{W}$ vertex and then extracts from them the contributions to and $Q$, one arrives at expressions that are plagued $w$ ith several pathologies, gauge-dependence being one of them. Indeed, even if the two W are considered to be on shell, since the incom ing photon is not, there is no a priori reason why a gauge-independent (g.i.) answ er should em erge. In the context of the renom alizable $R$ gauges the nal answer depends on the choige of the gauge xing param eter, which enters into the one-loop calculations through the gauge-boson propagators ( $W$, Z, , and unphysical $H$ iggs particles). In addition, as show $n$ by an explicit calculation perform ed in the Feynm an gauge ( $=1$ ), the answer for is infrared di̇vergent and violates perturbative unitarity, e.g. it grow s m onotonically for $Q^{2}!1 \xrightarrow[n_{1}^{\prime}]{2} . A \not l$ the above pathologies $m$ ay be circum vented if one adopts the pinch technique (PT) $\underline{l n}^{\prime 3 \prime}$. T he application of this m ethod gives rise to new expressions, ^ and $\widehat{Q}$, which are gauge xing param eter ( ) independent, ultraviolet and infrared nite, and well behaved for large $m$ om entum transfers $Q^{2}$.

## 2. The pinch technique

The Sm atrix pinch technique is an algorithm that allows the construction of m odi ed g.i. n-point functions, through the order by order rearrangem ent ofFeynm an graphs, contributing to a certain physical and therefore ostensibly gi. am plitude, (an $S m$ atrix in our case). This rearrangem ent separates the $S$ \{m atrix into kinem atically distinct pieces, akin to self\{energies, vertices and boxes, from which the new e ective $n$-point functions can be extracted. T he resulting expressions are independent of the initial gauge choige and of the speci c process one em ploys. For the case of vertioes, the PT am ounts into identifying and appending to the usual vertex \{graphs those parts of the box graphs that exhibit a vertex $\{$ like structure. T hese parts are called pinch parts; they em erge every tim e a gauge\{boson propagator, a three gauge boson vertex or a scalar\{scalar\{gauge boson vertex contributes an integration $m$ om entum $k$
to the original graph's num erator. Such $m$ om enta, when contracted $w$ ith a $m$ atrix, trigger an elem entary identity of the form

The rst term on the rh.s. of Eq. ( $\mathbf{L}_{1}$ ) rem oves the intemal ferm ion propagator and generates a pinch term, while the second vanishes on shell. Collecting all vertexlike pinch parts and appending them to the usual vertex graphs gives rise to a g i. sub \{am plitude, w ith the sam e kinem atical properties as a vertex.
3. G auge \{ invariant gauge boson vertices and their $W$ ard identities

W e consider the S-m atrix elem ent for the process

and isolate the part $T\left(q ; p_{1} ; p_{2}\right)$ of the $S\{m$ atrix which depends only on the $m$ om entum transfers $\mathrm{q}, \mathrm{p}_{1}$, and $\mathrm{p}_{2}$. Since the nal result (w th pinch contributions included) is $g . i$, we choose to work in the Feynm an gauge ( $i=1$ ); this particular gauge sim pli es the calculations because it rem oves all longitudinal parts from the tree-level gauge boson propagators. So, pinch contributions can only originate from appropriate $m$ om enta fumished by the tree\{level gauge boson vertioes. A pplying the pinch technique algorithm we isolate all vertex \{like parts contained in the box diagram $s$ and allot them to the usual vertex graph. The nal expressions for one loop g.i. trilinear gauge boson vertioes are :

The quantities $I_{i j}$ and $M$ are integrals $w$ ith two and three scalar propagators, respectively; their explicit expressions have been reported elsew here ${ }^{\text {itu }}$.

The g.i. vertioes satisfy the follow ing sim ple $W$ ard identities ( $W$ I), relating them to the gi. W self energy and W W vertex constructed also via the PT :

These W I are the one\{loop generalizations of the respective tree levelW I; their validity is crucial for the gauge independenœ of the $S$ \{m atrix. It is im portant to em phasize that they $m$ ake no reference to ghost term $s$, unlike the corresponding Slavnov-Taylor identities satis ed by the conventional, gauge\{dependent vertioes.

For the case of on \{shell $W$ s one sets $p_{1}^{2}=p_{2}^{2}=M_{W}^{2}$ and neglects all term $s$ proportional to $p_{1}$ and $p_{2}$, as well as the left over pinch term s of the $W$ legs. Then the $W$ W vertex reduces to the form

This is of course the same answer one obtains by applying the PT directly to the $S\left\{m\right.$ atrix of $e^{+} e!W^{+} W$. Thus for the form factors ; $Q$ the only function we need is B , given below

4. $M$ agnetic dipole and electric quadrupole form factors for the $W$

H aving constructed the g.i. W W vertex we proceed to extract its contributions to the $m$ agnetic dipole and electric quadrupole form factors of the $W$. $W$ e use carets to denote the g.i. one\{loop contributions. C learly,

where $Q^{(=1)}$ and $Q^{(=1)}$ are the contributions of the usual vertex diagram $s$ in the Feynm an gauge ${ }^{2}$, whereas $Q{ }^{P}$ and $Q{ }^{P}$ the analogous contributions from the pinch parts. By perform ing the $m$ om entum integration in $B$, we nd for $p_{1}^{2}=p_{2}^{2}=M_{W}^{2}$

$W$ e observe that ${ }^{P}$ contains an infrared divergent term, stem $m$ ing from the double integral show $n$ above, when $V=$. This term cancels exactly against a sim ilar infrared divergent piece contained in $(=1)$, ${ }_{2}^{\prime}$ thus rendering ${ }^{\wedge}$ infrared nite. A fler the infrared pieces have been cancelled, one notioes that the rem aining contribution of ${ }^{P}$ decreases $m$ onotonically as $Q^{2}$ ! 1 ; due to the di erence in relative signs this contribution cancels asym ptotically against the m onotonically increasing contribution from $\quad(=1)$. Thus by including the pinch part the unitarity of ${ }^{\wedge}$ is restored and ${ }^{\wedge}$ ! 0 for large values of $Q^{2}$. It would be interesting to determ ine how these quantities could be directly extracted from future $\mathrm{e}^{+}$e experim ents.

## 5. C onclusions

W e showed how to use the PT in order to construct gi. gauge\{boson vertioes, which satisfy naive QED \{like W ard identities. These vertices give rise to m agnetic dipole and electric quadrupole form factors for the $W$, which can, at least in principle, be prom oted to physical observables.
