BFKL predictions at sm all x from k_T and collinear factorization view points

Abstract

H and scattering processes involving hadrons at small x are described by a k_T -factorization formula driven by a BFKL gluon. We explore the equivalence of this description to a collinear-factorization approach in which the anomalous dimensions $_{gg}$ and $_{qg}=_{S}$ are expressed as power series in $_{S}$ log (1=x), or to be precise $_{S}=!$ where ! is the moment index. In particular we confront the collinear-factorization expansion with that extracted from the BFKL approach with running coupling included.

Recently there have been several studies [1-5] of the validity and possible modi cation of the conventional A ltarelli-Parisi (or G LAP) description of deep inelastic scattering in the small 10^4 . The relevant m odi cations are the x region that has become accessible at HERA, x inclusion of contributions which are enhanced by powers of $\log(1=x)$, but which lie outside the leading (and next-to-leading) A larelli-Parisiperturbative expansion. Form ally they correspond to the expansion of the anom alous dimensions $_{gg}$ and $_{gg}=_{s}$ as power series in $_{s}=!$ where ! is the moment index. An alternative approach which automatically resums all these leading $\log(1=x)$ contributions to $_{gg}$ and $_{gg}=_{S}$ is provided by the BFKL equation coupled with the $k_{\rm T}$ -factorization formula for calculating observable quantities [6, 7]. The main aim of this paper is to explore the connection between these two approaches. To be speci c we study the relation between the collinear-factorization form ula with $\log(1=x)$ terms included and the k_T factorization form ula based on the solution of the BFKL equation [8] with running coupling 5. We show that both approaches generate the same st few terms in the perturbative expansion of ga and, more important, of ga, which are presumably the most relevant contributions for the description of deep inelastic scattering in the HERA range. They dier substantially, however, in the asymptotically small x regime.

Deep inelastic unpolarised electron-proton scattering may be described in terms of two structure functions, $F_2(x;Q^2)$ and $F_L(x;Q^2)$. As usual, the kinematic variables are dened to be $Q^2 = q^2$ and $x = Q^2=2p_Tq$, where p and q are the four-momenta of the incoming proton and virtual photon probe respectively. At small values of $x;x < 10^3$, these observables reject the distribution of gluons in the proton, which are by far the dom inant partons in this kinematic region. The precise connection between the small x structure functions and the gluon distribution is given by the k_T -factorization formula [6, 7],

with i = 2;L, which is displayed pictorially in Fig. 1. The gluon distribution $f(x;k_T^2)$, unintegrated over k_T^2 , is a solution of the BFKL equation, while F_i^g are the o-shell gluon structure functions which at lowest-order are determined by the quark box (and crossed-box) contributions to photon-gluon fusion, see Fig. 1.

For su ciently large values of Q² the leading-twist contribution is dominant, and it is most transparent to discuss the Q² evolution of $F_i(x;Q^2)$ in terms of moments. Then the x^0 convolution of (1) factorizes to give

with similar relations for \overline{F}_i and \overline{F}_i^{g} .

Fixed $_{\rm S}$: $k_{\rm T}$ -factorization to collinear-factorization

It is illuminating to rst consider the case of xed coupling $_{\rm S}$ [2]. Then the photon-gluon moments, $\overline{\rm F}_{\rm i}^{~g}$ are simply functions of $Q^2=k_{\rm T}^2$ (and !), for massless quarks. Hence (2) becomes a convolution in $k_{\rm T}^2$ which, in analogy with the x⁰ convolution, may be factorized by taking moments a second time. In this way we obtain representations for the $\overline{\rm F}_{\rm i}$ with factorizable integrands

where the F_i^{g} are dimensionless, but f carries the dimension (k_0^2) ¹. Representation (4) enables the leading-twist contribution to be identified from a know ledge of the analytic properties of f and F_i^{g} in the complex plane.

The gluon distribution f (x; k_T^2) satisfies the BFKL equation, which in moment space has the form 7

where K () is the eigenvalue of the BFKL kernel corresponding to the eigenfunction proportional to (k_T^2) . It can be shown that

where is the logarithm ic derivative of the Euler gamma function, (z) $(z)^{0}(z) = (z)$, and (n) is the Riem ann zeta function.

We see from (4) that the large Q^2 behaviour of \overline{F}_i (!; Q^2) is controlled by the pole at = of f (!;) of (8) which lies to the left of, and nearest to, the contour of integration in the -plane. For a physically reasonable choice of input f^0 , this pole arises from the zero of the denom inator of (8). That is

- is the leading-twist anom alous dimension [9]. If we insert the pole of (10) and (8) into (4), and we close the contour of integration in the left-half plane, then we obtain the high Q² behaviour

Eq. (13) is the usual form ula for the factorization of collinear (or mass) singularities written in m om ent space. This becomes more apparent if we express (13) in the form

is the moment of the (process dependent) coe cient function and

is the moment function of the (integrated) gluon density. Thus we can identify $(Q_0^2)^- f^0(!; -)$ with the moment of the gluon distribution at the \starting" scale Q_0^2 of the evolution in Q^2 .

The quantity R, the residue in (10), is renorm alisation scheme dependent [2]. For studies of the BFKL equation, (7), it is appropriate to regularise R by choosing an inhomogeneous term of the form

On the other hand $\overline{}$, and F_i^{g} , are scheme independent (at least in the so-called regular schemes). The scheme dependence of R is compensated by subleading contributions of O ($_{s}$ ($_{s}=!$)ⁿ) in the anomalous dimension $_{gg}$, which are still at present unknown. This cancellation takes place when we allow the coupling to run.

The above collinear factorization formula (13) is true as it stands for F_L , but some care is needed for F_2 . First we check its validity for F_L . Since $\overline{F_L}^g$! constant for large, we see from (5) that $\overline{F_L}^g$ (!;) 1=. However, this potential singularity at = 0 is cancelled by the factor in the numerator of (10). On the other hand $\overline{F_2}^g$! log() and hence $\overline{F_2}^g$ (!;) 1=²,

where the double pole relects the collinear singularity associated with the $g ! q\bar{q}$ transition. The integration contour in (4) therefore also encloses the pole

which gives rise to a \scaling sea" contribution to F_2 which is independent of Q^2 . To rem ove this contribution and to focus attention on the elects of the perturbative pole at = we consider the observable $@F_2=@\log Q^2$, rather than F_2 itself. In this case the collinear factorization form ula is of the form

de ned to be a regular function at = 0. Since is known [2] in term s of the quark box (and crossed box), we can determ ine the perturbative expansion of P_{qg} by calculating

with - and R given by the perturbative expansions of (11) and (12) respectively. To be precise we substitute for - in (22) and obtain the perturbative expansion of P_{qg}= _s as a power series in -s=!. This provides the recipe to compute the leading log (1=x) contribution to P_{qg}.

A lthough we have expanded the observables in a perturbative series in $__{s}=!$, we should recall that the small x behaviour of F_{L} and $(F_{2}=0 \log Q^{2})$ is controlled by the singularities of $\overline{F}_{i}(!;Q^{2})$ in the ! complex plane. The singularities arise from $_$. The leading singularity of $_$ is the BFKL branch point at ! = !_L = $(4 \log 2)^{_s}$. To see this we note that the position of the singularity is controlled by the value of K () at its symmetry point, $=\frac{1}{2}$. We expand K about this point

where $!_{L} = (4 \log 2)_{S}^{-}$. In x space the leading singularity of the anom abus dimension gives an x $!_{L}$ behaviour of the gluon distribution at asymptotically small values of x. On the other hand the perturbation series in $-_{S}=!$, as in (11), enables the collinear factorization formula to be used to investigate the approach to the BFKL x $!_{L}$ form, as x decreases since

The collinear factorization formulae give well-de ned perturbative expansions for F_L and $@F_2=@\log Q^2$ which allow the leading $__S \log(1=x)$ contributions to be resummed. We will discuss the implications of the reduction of k_T -factorization to collinear form after we have implemented the running of $_S$.

Running $_{\rm S}$: collinear-factorization to $k_{\rm T}$ -factorization

To see the e ect of the running of -s we simply replace

In the small x BFKL lim it $\bar{}$ is simply a function of the ratio $\bar{}_{s}(q^{2})=!$, as in the xed coupling case. We see immediately the important role played by the non-perturbative region. To illustrate the elect, it is su cient to take

The rst term on the right-hand-side leads to the usual double-leading-logarithm ic (DLL) behaviour of the gluon distribution $g(!;Q^2)$. The sum in the second term builds up the BFKL behaviour, and here we see the dominance of the $-_{s}(Q_0^2)=!$ power series evaluated at the starting scale Q_0^2 as compared to the truly perturbative power series in $-_{s}(Q_0^2)=!$. In other words the leading singularity in (31) is the BFKL branch point at $! = -_{s}(Q_0^2)4\log 2$. In

principle it should be reabsorbed in the starting distribution $g(!;Q_0^2)$, having the perturbative contribution which is controlled by $-_s(Q^2)$; yet in practice it is the full form ula (31) which is used [1, 3, 4, 5].

The above representation contains therefore an equivalent infrared sensitivity to that contained in the direct BFKL predictions [7], but we see that it has been explicitly isolated in a factorizable form. By infrared sensitivity we mean that the leading singularity in the ! plane is controlled by $_{\rm S}$ (Q $_0^2$) and not by $_{\rm S}$ (Q 2). The distinction between Q 2 and Q $_0^2$ is, of course, im material in the region (Q $^2 > Q_0^2$) of applicability of the genuine leading log (1=x) approximation, that is $_{\rm S}$ (Q $_0^2$) log (Q 2 =Q $_0^2$) 1, but $_{\rm S}$ (Q $_0^2$) log (1=x) 0 (1).

The BFKL corrections to the DLL contribution only enter the expansion for the anom abus dimension (31) at order ($_{s}=!$)⁴ and above, whereas for P_{qg} of (23) it can be shown that all terms (n = 0;1;:::) are present in the expansion P B_n ($_{s}=!$)ⁿ. For this reason we expect that the sm all x behaviour of $@F_{2}=@log Q^{2}$ in the HERA regime will be controlled m ore by the perturbative expansion of P_{qg} than of $^{-}$. However, as x decreases the expansion of $^{-}$ will begin to play a dom inant role.

The BFKL equation was originally derived for xed $_{\rm S}$. The correct way to include the running of $_{\rm S}$ is not rm by established. The procedure usually adopted is to take $_{\rm S}$ ($k_{\rm T}^2$) in (7) so that the DLL limit of GLAP evolution is obtained. Here we not the perturbative expansion obtained from this prescription. We are therefore able to check the validity of the procedure by comparing with the expansion obtained from the renorm alization group (or collinear factorization) approach, that is (27)-(31).

If we replace the xed $_{\rm S}$ of (7) by $_{\rm S}$ ($k_{\rm T}^2$) the BFKL equation becomes

From the extension of (4) and (21) to running $_{\rm S}$ we see that the $k_{\rm T}$ -factorization gives

where H 0 (!) will eventually have to be xed by the starting gluon distribution, f^{0} .

We now inspect the perturbative expansion of (34) and nd that the rst few terms are identical to those in the renormalization group expansion. To make this identication we concentrate on the expansion in terms of powers of $_{s}(Q^{2})=!$ which contain the hard scale Q^{2} . The non-perturbative contributions can always be absorbed into a rede nition of H $^{0}(!)$.

To begin we note that the leading twist contribution is controlled by the strip 1 < < 0 of the branch cut in the plane, where the branch point at = 0 is generated entirely by the 1 = term in K (). We isolate this singularity by introducing the function

The integral I has, of course, to be understood in the sense of an analytic continuation since it diverges at = 0. To expand I in a perturbation series we rst change the variable of integration

Here the contribution from t < < 1 gives higher-twist term swhich vanish as $1=Q^2$, modulo logarithm ic corrections. The term (b=!) can be reabsorbed into the starting distribution, where it belongs, and we not the perturbative expansion of I is of the form

We see that the rst two terms (n = 1;2) are identical to the rst two terms (n = 4;6) in the perturbative expansion of (31), which are proportional to $-_{s} (Q^{2})^{3}$ and $-_{s} (Q^{2})^{5}$ respectively. The DLL contribution in (31) corresponds to the $t^{b=!}$ factor in (44).

To generate the expansion of $P_{qg} = {}_{S}$ as a power series in $-{}_{S} = !$ we expand the function (!;) of (41) around = 0. This procedure generates the same rst three terms as those in the expansion shown in (22). At higher order, $(-{}_{S} = !)^{3}$ and above, we see that the terms of 0 (!) in (43), as well as various other contributions, will also contribute to the expansion of P_{qg} . However, it is the rst few terms that are important for the onset of the BFKL behaviour in the HERA sm all x regime [1, 3]. Note that the perturbative expansion in (44) contains an additional factor of b=! which enables this series to be separated from the perturbative expansion of (!;).

Before we conclude, we can gain further insight into the relation between the BFK L equation and collinear factorization in the case of running $_{\rm S}$ if we estimate the integral (34) using the saddle-point method. Inserting (35) we see that the position of the saddle-point, -, is given by the implicit equation

This representation is applicable in the region $! > !_{L}$ $(4 \log 2 \sum_{s} (Q_{0}^{2}))$. For smaller values of ! the saddle-point estimate involves two (stationary phase) contributions which lead to a di erent representation of the integral. In other words (47) is not a valid approximation of the integral (34) for ! < !_L. Unlike the case of xed _s, the BFKL solution for running _s does not contain the branch point singularity at ! = !_L, but rather it has (an in nite number of) poles in the ! plane. The poles are determined by the starting point condition and hence are controlled by $\overline{}_{s}$ at Q_{0}^{2} . It turns out that the leading pole singularity occurs at ! < !_L ($_{s} (Q_{0}^{2})$) [14, 13].

In summary, we have confronted the collinear-factorization approach for the calculation of observable quantities at small x with the evaluation based on the k_T -factorization formula. For xed $_{\rm S}$ both approaches are equivalent at the leading-twist level. In fact the insertion of the solution of the BFKL equation into the k_T-factorization formula provides a recipe for calculating - $_{qq}$ and $P_{qq} = _{s}$ as power series in $_{s} = !$, where ! is the m on ent index. The e ect of introducing a running s in the collinear-factorization form alism is summarized by (27) and (28). We noted that the leading singularity in the ! plane is a branch point at $! = !_{L} (Q_{0}^{2})$ which is controlled by $_{\rm S}$ (Q $_0^2$) rather than $_{\rm S}$ (Q 2), c.f. (31). That is the truly perturbative behaviour is hidden behind a non-perturbative contribution. In principle, the latter could be factored o and absorbed into the starting distribution. We then exam ined $k_{\rm T}$ -factorization with BFKL input with running $_{\rm S}$ and compared the predictions with those obtained from collinear factorization with running s. We found the remarkable result that both the factorization prescriptions generate a perturbative expansion as a power series in -s (Q²)=! with exactly the same rst few non-trivial term s, on top of the same DLL contribution. These term s are them ost in portant perturbative contributions for the onset of the leading $\log(1=x)$ behaviour in the HERA regime. In practice, in both the collinear- and k_T -factorization approaches, the leading singularity in the !-plane, which controls the small x behaviour, depends on Q_0^2 . The location of the singularity is dierent, however. In the rst case the power series in $-_{s} (Q_{0}^{2})=!$ builds up a branch point at $! = !_{L} (Q_{0}^{2})$, whereas in the second case we generate a leading pole at a considerably smaller value of ! . We conclude that the truly perturbative contributions in the two approaches are rem arkably similar, but in practice they are partially hidden by non-perturbative term s.
