# BFKL predictions at sm all $x$ from $k_{T}$ and collinear factorization view points

#### Abstract

$H$ ard scattering processes involving hadrons at sm all $x$ are described by a $\mathrm{k}_{\mathrm{T}}$-factorization form ula driven by a BFKL gluon. W e explore the equivalence of this description to a collinear-factorization approach in which the anom alous dim ensions gg and $q 9 \mathrm{~s}$ are expressed as pow er series in $s \log (1=x)$, or to be precise $s=$ ! where ! is the $m$ om ent index. In particular we confront the collinear-factorization expansion $w$ ith that extracted from the BFKL approach w ith running coupling included.


[^0]Recently there have been several studies [1-5] of the validity and possible m odi cation of the conventionalA ltarelli-P arisi (or G LA P ) description of deep inelastic scattering in the sm all x region that has becom e accessible at HERA, x $10^{4}$. The relevant modi cations are the inclusion of contributions which are enhanced by pow ers of $\log (1=x)$, but which lie outside the leading (and next-to-leading) A ltarelli-P arisiperturbative expansion. Form ally they correspond to the expansion of the anom alous dim ensions gg and ${ }_{q g}=s$ as power series in $s=$ ! where ! is the m om ent index. A n altemative approach which autom atically resum s all these leading $\log (1=x)$ contributions to $g g$ and $q g=s$ is provided by the BFKL equation coupled $w$ th the
 paper is to explore the connection betw een these two approaches. To be speci c we study the relation betw een the collinear-factorization form ula with $\log (1=x)$ term $s$ inchuded and the $k_{T}$ factorization form ula based on the solution of the BFKL equation [G] w ith running coupling $s$. W e show that both approaches generate the sam e rst few term $s$ in the perturbative expansion of $g g$ and, $m$ ore im portant, of $q g$, which are presum ably them ost relevant contributions for the description of deep inelastic scattering in the HERA range. T hey di er substantially, how ever, in the asym ptotically sm all $x$ regim $e$.
$D$ eep inelastic unpolarised electron-proton scattering $m$ ay be described in term $s$ of two structure functions, $F_{2}\left(x ; Q^{2}\right)$ and $F_{L}\left(x ; Q^{2}\right)$. As usual, the kinem atic variables are de ned to be $Q^{2}=q^{2}$ and $x=Q^{2}=2 p: q$, where $p$ and $q$ are the fourm om enta of the incom ing proton and virtualphoton probe respectively. At sm all values ofx;x<10 ${ }^{3}$, these observables re ect the distribution of ghoons in the proton, which are by far the dom inant partons in this kinem atic region. The precise connection betw een the sm allx structure fiunctions and the ghon distribution is given by the $\mathrm{k}_{\mathrm{T}}$-factorization form ula ${ }_{\underline{-6},}$,

$w$ ith $i=2 ; L$, which is displayed pictorially in $F$ ig. 1 . The gluon distribution $f\left(x ; k_{T}^{2}\right)$, unintegrated over $\mathrm{k}_{\mathrm{T}}^{2}$, is a solution of the BFKL equation, while $\mathrm{F}_{\mathrm{i}}{ }^{g}$ are the o -shell glyon structure functions which at low est-order are determ ined by the quark box (and crossed-box) contributions to photon-ghon fusion, see Fig. 1.

For su ciently large values of $Q^{2}$ the leading-tw ist contribution is dom inant, and it is $m$ ost transparent to discuss the $Q^{2}$ evolution of $F_{i}\left(x ; Q^{2}\right)$ in term $s$ of $m$ om ents. Then the $x^{0}$ convolution of (1]i) factorizes to give

## Fixed $\mathrm{s}: \mathrm{k}_{\mathrm{T}}$-factorization to collinear-factorization

It is illum inating to rst consider the case of xed coupling s $\underline{[1]}]$. Then the photon-ghon $m$ om ents, $\bar{F}_{i}{ }^{g}$ are simply functions of $\quad Q^{2}=k_{T}^{2}$ (and !), for $m$ assless quarks. H ence ( becom es a convolution in $k_{T}^{2}$ which, in analogy with the $x^{0}$ convolution, $m$ ay be factorized by taking m om ents a second time. In this way we obtain representations for the $\bar{F}_{i}$ w ith factorizable integrands

where the $F_{i}{ }^{9}$ are dim ensionless, but $f$ carries the dim ension $\left(k_{0}^{2}\right) \quad{ }^{1}$. Representation ( $\left.\overline{4}\right)$ enables the leading-tw ist contribution to be identi ed from a know ledge of the analytic properties of $f$ and $F_{i}{ }^{9}$ in the complex plane.

The ghon distribution $f\left(x ; k_{T}^{2}\right)$ satis es the BFKL equation, which in $m$ om ent space has the form

W e see from ( ${ }_{-1}$ ) that the large $Q^{2}$ behaviour of $\bar{F}_{i}\left(!; Q^{2}\right)$ is controled by the pole at $=-$ of $f(!$; ) of ( $(\mathbf{i})$ ) which lies to the left of, and nearest to, the contour of integration in the -plane. For a physically reasonable choice of input $f^{0}$, this pole arises from the zero of the denom inator of (8) $\left.{ }^{-1}\right)$. That is

is the $m$ om ent function of the (integrated) ghon density. Thus we can identify $\left(Q_{0}^{2}\right)^{-} f^{0}(!;-)$ $w$ th the $m$ om ent of the gluon distribution at the \starting" scale $Q_{0}^{2}$ of the evolution in $Q^{2}$.

The quantity $R$, the residue in $(\underline{1} \overline{1} \underline{\underline{Q}})$, is renorm alisation schem e dependent $\left[\begin{array}{l}{[\overline{1}} \\ 1\end{array}\right]$. For studies of the BFKL equation, $(\underset{-1}{(\overline{1})}$ ), it is appropriate to regularise R by choosing an inhom ogeneous term of the form

On the other hand - , and $\mathrm{F}_{\mathrm{i}}{ }^{\text {g }}$, are schem i independent (at least in the so-called regular schem es). The schem e dependence of $R$ is compensated by subleading contributions of $O\left(\mathrm{~s}(\mathrm{~s}=!)^{\mathrm{n}}\right)$ in the anom alous dim ension gg , which are still at present unknown. This cancellation takes place w hen we allow the coupling to nun.

The above collinear factorization form ula ( $\overline{1} \overline{\underline{3}})$ is true as it stands for $F_{L}$, but som e care is needed for $F_{2}$. F irst we check its validity for $F_{L} . S$ ince ${\overline{F_{L}}}_{\mathrm{L}}{ }^{g}$ ! constant for large, we see from $(\underset{-1}{ })$ that $\mathrm{F}_{\mathrm{L}}{ }^{9}(!;) \quad 1=$. H ow ever, this potential singularity at $=0$ is cancelled by the factor in the num erator of $(\underline{\overline{1}} \overline{-})$. O $n$ the other hand $\bar{F}_{2}^{g}!\log ()$ and hence $F_{2}{ }^{g}(!;) \quad 1={ }^{2}$,
where the double pole re ects the collinear singularity associated with the $g$ ! q $\bar{q}$ transition. The integration contour in ( $(\underset{\sim}{\overline{4}})$ therefore also encloses the pole

which gives rise to a \scaling sea" contribution to $\mathrm{F}_{2}$ which is independent of $\mathrm{Q}^{2}$. To rem ove this contribution and to focus attention on the e ects of the perturbative pole at $=-$ we consider the observable $@ F_{2}=@ \log Q^{2}$, rather than $F_{2}$ itself. In this case the collinear factorization form ula is of the form

To be precise we substitute for ${ }^{-}$in (2-2ㄹ) and obtain the perturbative expansion of $\mathrm{P}_{\mathrm{qg}}=\mathrm{s}$ as a power series in ${ }_{S}=$ !. This provides the recipe to com pute the leading $\log (1=x)$ contribution to $P_{q g}$.

A though we have expanded the observables in a perturbative series in $-_{S}=$ !, we should recall that the sm all x behaviour of $\mathrm{F}_{\mathrm{L}}$ and $@ \mathrm{~F}_{2}=@ \log Q^{2}$ is controlled by the singularities of $\bar{F}_{i}\left(!; Q^{2}\right)$ in the ! com plex plane. The singularities arise from ${ }^{-}$. The leading singularity of ${ }^{-}$ is the BFKL branch point at $!=!_{\mathrm{L}}=(4 \log 2)-_{S}$. To see this we note that the position of the singularity is controlled by the value of $\mathrm{K}^{( }()$at its sym m etry point, $=\frac{1}{2} \cdot \mathrm{~W}$ e expand $\mathrm{K}^{\sim}$ about this point

In x space the leading singularity of the anom alous dim ension gives an $x{ }^{!}$I behaviour of the gluon distribution at asym ptotically $s m$ all values of $x$. On the other hand the perturbation series in $-_{S}=$ !, as in ( $\overline{1} \overline{1}_{1}$ ), enables the collinear factorization form ula to be used to investigate the approach to the BFKL x $!^{\mathrm{L}}$ form, as x decreases since

The collinear factorization formulae give well-de ned perturbative expansions for $\mathrm{F}_{\mathrm{L}}$ and $@ F_{2}=@ l o g Q^{2}$ which allow the leading $-_{s} \log (1=x)$ contributions to be resum $m$ ed. We will discuss the implications of the reduction of $k_{T}$-factorization to collinear form after we have im plem ented the running of $s$.

Running $s$ : collinear-factorization to $k_{T}$-factorization
To see the e ect of the running of ${ }^{-}{ }_{s}$ we sim ply replace

In the small x BFKL lim it $^{-}$is simply a function of the ratio ${ }^{-} s\left(q^{2}\right)=$ !, as in the xed coupling case. W e see im m ediately the im portant role played by the non-perturbative region. To illustrate the e ect, it is su cient to take

The rst term on the right-hand-side leads to the usual double-leading-logarithm ic (DLL) behaviour of the ghon distribution $g\left(!; Q^{2}\right)$. The sum in the second term builds up the BFKL behaviour, and here we se the dom inance of the ${ }_{s}\left(Q_{0}^{2}\right)=$ ! power series evaluated at the starting scale $Q_{0}^{2}$ as com pared to the truly perturbative power series in $-_{s}\left(Q^{2}\right)=!$. In other words the leading singularity in ( $\underline{3}_{-1}^{1}$ 1) is the BFKL branch point at $!=-_{s}\left(Q_{0}^{2}\right) 4 \log 2$. In
principle it should be reabsorbed in the starting distribution $g\left(!; Q_{0}^{2}\right)$, leaving the perturbative contribution which is controlled by $-_{S}\left(Q^{2}\right)$; yet in practice it is the full form ula ( $\overline{3} \overline{1} \overline{1}$ ) which is


The above representation contains therefore an equivalent infrared sensitivity to that contained in the direct BFKL predictions $\left[\frac{\bar{\eta}}{1}, \mathrm{l}\right.$, but we see that it has been explicitly isolated in a factorizable form. By infrared sensitivity we $m$ ean that the leading singularity in the! plane is controlled by $s\left(Q_{0}^{2}\right)$ and not by $s\left(Q^{2}\right)$. The distinction betw een $Q^{2}$ and $Q_{0}^{2}$ is, of course, im $m$ aterial in the region $\left(Q^{2>} Q_{0}^{2}\right)$ of applicability of the genuine leading $\log (1=x)$ approxim ation, that is $s\left(Q_{0}^{2}\right) \log \left(Q^{2}=Q_{0}^{2}\right) \quad 1$, but $s\left(Q_{0}^{2}\right) \log (1=x) \quad O(1)$.

TheBFKL corrections to the D LL contribution only enter the expansion for the anom alous dim ension ( $\overline{3} \overline{1} \overline{1})$ ) at order $(s=!)^{4}$ and above, whereas for $P_{q 9}$ of $(\overline{2} \overline{3})$ it can be show $n$ that all term $s(n=0 ; 1 ;:::)$ are present in the expansion ${ }^{P} B_{n}(s=!)^{n}$. For this reason we expect that the sm all x behaviour of $@ F_{2}=@ \log Q^{2}$ in the HERA regim e w illle controlled $m$ ore by the perturbative expansion of $\mathrm{P}_{\mathrm{qg}}$ than of ${ }^{-}$. H ow ever, as x decreases the expansion of ${ }^{-} \mathrm{w}$ ill begin to play a dom inant role.

The BFKL equation was originally derived for xed $s$. The correct way to include the running of $s$ is not $m$ ly established. The procedure usually adopted is to take $s\left(k_{T}^{2}\right)$ in ( $\bar{i}_{1}$ ) so that the D LL lim it of GLAP evolution is obtained. Here we nd the perturbative expansion obtained from this prescription. W e are therefore able to check the validity of the procedure by com paring w th the expansion obtained from the renom alization group (or collinear factorization) approach, that is $\left(\underline{2} \overline{2}_{1}\right)-\left(\overline{3} \overline{1} \overline{1}_{1}\right)$.

If we replace the xed $s$ of (i, i, by $s\left(k_{T}^{2}\right)$ the BFKL equation becom es

and sim ilarly for $F_{L}\left(!; Q^{2}\right)$, where the double-m om ent of the gluon $f(!;)$ is the solution of ( $\overline{3} \overline{3} \overline{-1})$. The leading-tw ist contribution is controlled by the solution of the hom ogeneous form of ( $\overline{(1)} \overline{\overline{3}})$ [

[^1]where $H^{0}$ (! ) w ill eventually have to be xed by the starting ghon distribution, $\mathrm{f}^{0}$.
W e now inspect the perturbative expansion of $(\underline{\overline{3} \overline{4}} \mathbf{-})$ and nd that the nst few term $s$ are identical to those in the renorm alization group expansion. To make this identi cation we concentrate on the expansion in term sofpow ers of ${ }^{-}\left(Q^{2}\right)=!$ which contain the hard scale $Q^{2}$. The non-perturbative contributions can alw ays be absorbed into a rede nition of $H^{0}$ (!).

To begin we note that the leading tw ist contribution is controlled by the strip $1<0$ of the branch cut in the plane, where the branch point at $=0$ is generated entirely by the $1=$ term in $K() . W$ e isolate this singularity by introducing the function

The integral I has, of course, to be understood in the sense of an analytic continuation since it diverges at $=0$. To expand I in a perturbation series we nst change the variable of integration

where we have om llted a factorizable non-perturbative contribution com ing from the upper lim it. W hen we expand the exponential in $(\overline{4} \overline{2})$ and insert the series into ( $\overline{4} \overline{\overline{1}})$ we encounter integrals of the form

Here the contribution from $t \ll 1$ gives higher-tw ist term $s$ which vanish as $1=Q^{2}$, m odulo logarithm ic corrections. The term ( $\mathrm{b}=$ !) can be reabsorbed into the starting distribution, where it belongs, and we nd the perturbative expansion of $I$ is of the form

We see that the rst two term $s(n=1 ; 2)$ are identical to the rst two term $s(n=4 ; 6)$ in the perturbative expansion of ( $\overline{3} \overline{1} \overline{1})$ ), which are proportional to ${ }_{S}\left(Q^{2}\right)^{3}$ and ${ }_{s}\left(Q^{2}\right)^{5}$ respectively. The D LL contribution in ( $\left.\overline{3 n}_{-1}^{1}\right)$ corresponds to the $t^{b=!}$ factor in ( $(\overline{4} \overline{4})$.

To generate the expansion of $\mathrm{P}_{\mathrm{qg}}=\mathrm{s}$ as a power series in ${ }_{\mathrm{s}}=$ ! we expand the function
(! ; ) of ( $4 \overline{1} \overline{1} 1$ around $=0$. This procedure generates the same rst three term $s$ as those in the expansion shown in $(\underline{2} 2 \overline{2})$. At higher order, $\left(\Gamma_{s}=!\right)^{3}$ and above, we see that the term $s$ of O (!) in ( $(\underset{4}{2} \overline{-1})$, as well as various other contributions, will also contribute to the expansion of $\mathrm{P}_{\mathrm{qg}}$. H ow ever, it is the rst few term $s$ that are im portant for the onset of the BFKL behaviour in the HERA sm all $x$ regim e $[\underline{1}, \underline{1}, \underline{3}]$. N ote that the perturbative expansion in ( $\overline{4} \overline{4} \overline{4})$ contains an additional factor of $\mathrm{b}=$ ! which enables this series to be separated from the perturbative expansion of (! ; ).

B efore we conclude, we can gain further insight into the relation betw een the BFK L equation and collinear factorization in the case of running $s$ if we estim ate the integral ( $\overline{3} \overline{4} \overline{4})$ using the saddle-point $m$ ethod. Inserting ( $\left.\overline{3} \overline{5})_{1}\right)$ we see that the position of the saddle-point, ${ }^{-}$, is given by the im plicit equation

$T$ his representation is applicable in the region ! $>!_{\mathrm{L}} \quad\left(4 \log 2 \Gamma_{S}\left(Q{ }_{0}^{2}\right)\right.$. For sm aller values of ! the saddle-point estim ate involves two (stationary phase) contributions whidh lead to a di erent representation of the integral. In other words ( integral ( not contain the branch point singularity at ! $=!_{\mathrm{L}}$, but rather it has (an in nite num ber of) poles in the ! plane. T he poles are determ ined by the starting point condition and hence are controlled by ${ }_{S}$ at $Q_{0}^{2}$. It tums out that the leading pole singularity occurs at! < ! $L\left(\mathrm{~s}_{\mathrm{S}}\left(\mathrm{Q}_{0}^{2}\right)\right)$


In sum $m$ ary, we have confronted the collinear-factorization approach for the calculation of observable quantities at sm all $x$ w ith the evaluation based on the $\mathrm{k}_{\mathrm{T}}$-factorization form ula. For xed s both approaches are equivalent at the leading-tw ist level. In fact the insertion of the solution of the BFKL equation into the $k_{T}$ factorization form ula provides a recipe for calculating ${ }^{-} \quad$ gg and $P_{q g}={ }_{s}$ aspowerseries in ${ }_{S}=$ !, where! is them om ent index. Thee ect of introducing a running $s$ in the collinear-factorization form alism is sum $m$ arized by ( $2 \overline{1} \bar{\eta}_{1}$ ) and $\left(\underline{2}_{-1}^{-1}\right) . W$ e noted that the leading singularity in the ! plane is a branch point at ! $=!_{\mathrm{L}}\left(Q_{0}^{2}\right)$ which is controlled by $s\left(Q{ }_{0}^{2}\right)$ rather than $s\left(Q^{2}\right)$, c.f. ( $\left.{ }_{-1}^{1} \overline{1}\right)$. T hat is the truly perturbative behaviour is hidden behind a non-perturbative contribution. In principle, the lattercould be factored o and absorbed into the starting distribution. W e then exam ined $k_{T}$-factorization w ith BFKL input $w$ th running $s$ and com pared the predictions $w$ ith those obtained from collinear factorization $w$ th running $s$. W e found the rem arkable result that both the factorization prescriptions generate a perturbative expansion as a power series in ${ }_{S}\left(Q^{2}\right)=$ ! w ith exactly the same rst few non-trivialterm $s$, on top of the sam eD LL contribution. These term sare them ost im portant perturbative contributions for the onset of the leading log ( $1=x$ ) behaviour in the HERA regim e. In practioe, in both the collinear-and $k_{T}$-factorization approaches, the leading singularity in the $!-p l a n e$, which controls the $s m$ all $x$ behaviour, depends on $Q_{0}^{2}$. The location of the singularity is di erent, how ever. In the rst case the power series in ${ }_{S}\left(Q_{0}^{2}\right)=$ ! buidds up a branch point at $!=!_{\mathrm{L}}\left(Q_{0}^{2}\right)$, whereas in the second case we generate a leading pole at a considerably sm aller value of!. W e conclude that the truly perturbative contributions in the two approaches are rem arkably sim ilar, but in practice they are partially hidden by non-perturbative term s.
