## Spin Contents of Nucleons with SU (3) B reaking

## Abstract

We apply a model for SU (3) breaking to the analysis of the spin contents of the nucleon from the the latest data on rst moments of the spin dependent structure functions and include higher order QCD corrections. The results show that the value of the total quark spin contribution to the nucleon spin u + d + s remains about 0.3 and is very insensitive to SU (3) breaking, while the result for the strange quark contribution varies considerably with SU (3) breaking.

Recent experiments of polarized deep inelastic scattering (DIS) provided us with high quality data for the spin structure functions of the proton, deuteron and neutron [1, 2, 3, 4]. These measurements are used to evaluate the rst moments of the spin dependent structure functions which can be interpreted in terms of the contributions of the quark spins ( = u+ d+ s) to the total spin of the nucleon. The stresults from the measurem ents of the proton spin structure function by the EM Collaboration [5] were very surprising, in plying that is rather sm all (about 10%) and that the strange sea is strongly polarized. The new measurements [3, 4], together with the new values of F and D [6, 7], suggest is signi cantly larger than what was inferred from the EMC experiment, that concluding that 0:27 0:14 and s = 0:100:05. Incorporating also the recent SLAC E143 data for the proton with all other proton data, has not changed these results, and the combined analysis yields [8] for the st m om ent  ${}^{p}_{1}$  (Q  ${}^{2}_{0}$  = 5G eV  ${}^{2}$ ) = 0.137 0.010 and = 0.28 0.09 and s = 0:10 0:03 W ith  $\int_{0}^{r_{1}} g(x) dx = \frac{1}{2} \int_{1}^{r} e_{f}^{2} dx$  the underlying hypothesis in these analyses is the quark parton model (QPM) interpretation of the neutron weak decay constant  $q_A = u$ d and the SU (3) avor symmetry interpretation of D = u + d 2 s3F

It is usually in plied that the experim ental evaluation of and s is based on exact SU (3) avor symmetry. However, the extracted values are always quoted with errors which are derived from the experimental errors on the measured quantities ( $_1$ ;  $g_A$  and 3F D). Little attention has been given to evaluating the e ect of SU (3) breaking on these results.

We rst exam ine the information obtainable from experimental data to separate results which do not assume SU (3) from those which do. We will see that the value of deduced from the measured rst moment of the spin dependent structure function is not sensitive to the assumption of exact SU (3), or to the values of the SU (3) parameters F and D.

In the quark parton model,  $\frac{p}{1}$  can be expressed as

where  $C_{ns}(-)$  and  $C_{s}(-)$  include the higher order QCD corrections which are taken from Ref. [9] for the linear combinations of the matrix elements of the axial-vector current which transform under SU (3) like members of an octet and singlet respectively. Here, anom alous contributions to in the singlet term were neglected, and u; d and s are assumed to be the same in the singlet and non-singlet term. At this stage there is no assumption of SU (3) symmetry for the nucleon wave function. There is therefore no relation between the values of the contributions to the quark spins u, d and s and other parameters determ ined from weak decays. W hen SU (3) symmetry is assumed for the octet baryon wave function, the expression 4 u 2 d 2 s can be expressed entirely in terms of the quantities measured in weak decays ( $g_A$  and 3F D). Substituting

gives the conventional expression,

(where the (-) refers to the neutron case). A similar expression can be written for the deuteron rst m om ent which can be expressed as a sum of those of the proton and neutron:

where corrections for the D-state contributions in the deuteron ground state were considered.

It is interesting to exam ine the case when only isospin symmetry is assumed for the nucleon wave function. The expression 4 u 2 d 2 s can be written in terms of the quantity  $g_A$  measured with high precision in the neutron decay,




Figure 1: vs s for the proton (a) and for the deuteron (b).

We can then express as a function of s for given values of  $q_{A}$  and  ${}_{1}^{N}$ . Taking the result for the \world" value for the proton [8]:  ${}_{1}^{p}(Q_{0}^{2} = 5 \text{ GeV}^{2}) = 0.137$  0.010 and the recent results of SLAC E143 for the deuteron [10]  ${}_{1}^{d}(Q_{0}^{2} = 3 \text{ GeV}^{2}) = 0.042$  0.005 we show in Fig. 1 the dependence of with the variation of s from -0.2 to +0.15. We can conclude that obtained from the spin structure function rst m om ent is well established, and variations of s by som e m odel (like using input from hyperon decays with SU (3) breaking) will have a relatively smalle ect on .

Introducing SU (3) breaking into the analysis of hyperon decays is nontrivial and model dependent. The quantity denoted by  $g_A$  is really a ratio of axialvector and vector matrix elements. Both matrix elements can be changed by SU (3) symmetry-breaking, but it is only the axial matrix element that is relevant to the spin structure. The information from hyperon decays used in conventional treatments of spin structure is expressed in terms of D and F parameters which characterize the axial couplings only under the assumption that the vector coupling is pure F and normalized by the conserved vector current, where the whole SU (3) octet currents are conserved. Thus any attempts to parameterize SU (3) breaking in thing hyperon data by de ning e ective" D and F parameters im – mediately encounter the di culty of how much of the breaking com es from the axial couplings and how much comes from the vector and the breakdown of the conserved vector currents for strangeness changing currents. The vector matrix element is uniquely determined by Cabibbo theory in the SU (3) symmetry limit. The known agreement of experimental vector matrix elements with Cabibbo theory places serious constraints on possible SU (3) breaking in the baryon wave functions. On the other hand the strange quark contribution to the proton sea is already known from experiment be reduced roughly by a factor of two from that of a avor-symmetric sea [11].

To assess the the uncertainty on and s due to avor symmetry breaking we use a model consistent with the above constraints [12] suggested by one of us (H.J.L.), to incorporate the weak decay data with the polarized D IS results. The good results of C abibbo theory for the weak vector decays are kept by assuming that the weak current strangeness changing matrix elements are due to a strangeness change in a valence quark, while the sea wave functions have a nearly 100% overlap and that the valence quark wave functions satisfy SU (3). In this picture it is convenient to express q as the sum of its valence and sea contributions,  $q = q^v + q^s$ . We immediately obtain the result that the SU (3)

ts to hyperon decay data give inform ation only about the wave functions of the valence quarks and the values of the D and F parameters give inform ation about the spin contributions  $u^v$ ,  $d^v$  and  $s^v$  from the valence quarks.

In this model the avor SU (3) symmetry breaking relevant for the ! n decay is realized by a suppression of the strange pair production in both neutron and seas, and described by a parameter . Noting that the neutron has no valence strange quarks, and that  $u^s$  is the same for both neutron and seas the follow ing results were obtained [12]

C om bining this result with the corresponding relation for the neutron weak decay constant (and SU (2) isospin symmetry):

with the values for  $g_A$  and 3F D taken from [6, 7].

W ith the new QPM interpretation of 3F D under the avor symmetry breaking we can substitute 3F D in Eq. 1 with




Figure 2: (a) and s (b) for the proton as a function of the SU (3) sym m etry breaking parameter .




Figure 3: (a) and s (b) for the deuteron as a function of the SU (3) sym m etry breaking parameter .

Taking for experimental value for  $\frac{p}{1}$ , we show in Fig.2 the variations of and

s as a function of the asymmetry parameter . There is hardly a noticeable change in which moves from 0.28 at = 0 (which is the exact SU (3) symmetry limit), to 0.31 for = 2:0 n the other hand s varies from -0.10 to -0.04, which in plies no signi cant contribution due to the strange sea if avor symmetry is signi cantly broken. The same conclusions can be drawn from the neutron results or from the deuteron measurement of  $\frac{d}{1}$  as shown in Fig. 3.

In conclusion, the value of the quark spin contribution to the nucleon spin extracted from the rst moments of the spin dependent structure functions is relatively independent of the assumption exact SU (3) avor symmetry. The latter a ects the value obtained for the \strange sea" contribution s. It is interesting to assess the anom alous contributions in the singlet term, and study the variations of the extracted spin contents with di erent models for the gluon contribution in the spin structure functions.
