Chaos Driven by Soft-Hard Mode Coupling in Thermal Yang-Mills Theory

A bstract

We argue on a basis of a simple few mode model of SU (2) Yang-Mills theory that the color o -diagonal coupling of the soft plasm on to hard therm alexcitations of the gauge eld drives the collective plasm a oscillations into chaotic motion despite the presence of the plasm on mass.

The chaoticity of classical nonabelian gauge elds was originally discovered for spatially hom ogeneous gauge potentials [1] and later extended to special, radially symmetric eld con gurations [2,3]. More recently, the chaotic dynamics of the full classical Yang-Mills equations was investigated in numerical studies of Hamiltonian SU (N_c) lattice gauge theory with $N_c = 2$; 3 color degrees of freedom [4,5]. The complete Lyapunov spectrum of the SU (2) gauge eld was calculated [6], and it was found that the eld congurations ergodically cover the available phase space on the time scale of the inverse of the leading Lyapunov exponent,

 $1=_0$ / $1=g^2E$, where E is the energy per lattice degree of freedom. The leading Lyapunov exponent coincides with twice the plasm on damping rate obtained in resummed perturbation theory at nite temperature T [7].

The coupling to the heat bath gives rise to a mean inertia of the plasmon eld. For long wavelength (k ! 0) and static elds (! = 0) it coincides with the Debye mass square $m_P^2 = \frac{N_c}{3} g^2 T^2$; for on-shell plasmons in the lim it k ! 0 one has $m_P^2 = \frac{N_c}{9} g^2 T^2$. Such a mass restricts the region of chaotic motion to large amplitude plasmon elds. In fact a control parameter,

$$R = \frac{m_p^4 V}{16q^2 E} \tag{1}$$

with E being the total classical energy of the plasm on eld and V the plasm a volume, has been found to control chaos in sim ple, few mode models of the Yang-Mills eld theory [8]. For $sm \ all R$ 02 chaos develops. If the mean plasm on mass m_P were the sole elect of hard therm algluons, then $sm \ all \ am \ plittude$ plasm on elds would not grow chaotic [9].

We now argue that even small amplitude collective plasma oscillations can be chaotic because of the color-nondiagonal coupling to the uctuating components of the plasmon self-energy. These color non-diagonal matrix elements can render some eigenvalues of the mass square matrix M_P negative. This is a source of instability for small amplitude soft elds. Once the energy stored in the soft components has grown, the classical chaotic behavior sets in.

We are not able yet to prove the above scenario generally. In this paper we study as an

example the coupled dynamics of some selected Fourier components of the vector potential to show how the mechanism discussed above can be realized. The central point here is the existence of a hierarchy of relevant time scales in the dynamics of oscillations of the gauge eld. In fact, three such time scales can be identified. The hard thermal modes oscillate over a period of t_1 = 1=T. Due to the nonabelian coupling they in where the soft mode dynamics on the time scale t_2 = 1=gT. This also sets the time scale for the evolution of the soft plasma oscillations. Finally, the thermal ensemble average over particular hard mode congulations is characterized by the time scale of the gluon damping rate t_3 = 1=g²T. The fact that t_2 = t_3 requires that the ensemble average has to be taken over solutions of the plasmon equation of motion rather than over the equation itself.

Let us now consider a simplied model retaining the essential features. Here we build on the infrared limit of Yang-Mills eld theory (Yang-M ills mechanics" [1]). Each Fourier mode of the SU (2) gauge eld representing hard thermal gluons carries six degrees of freedom (two polarizations, three internal degrees of freedom). Soft modes, neglecting spatial derivatives, can be described by the three eigenvalues of the O (3) O (3) symmetric vector potential A_i^a . Without loss of generality they can be chosen as [10]:

The most general ansatz describing one hard and one soft momentum contains therefore nine coupled modes

denote the hard thermal modes with time-dependent amplitudes u_i^a and v_i^a . We choose the thermal wave number $K = Te_3$ to point in the third direction. Then all longitudinal components $w_3^a = 0$ vanish and only one derivative (in the third direction) diers from zero in this ansatz:

Choosing the temporal gauge, $A_0^a = 0$, the electric eld components are simply the time derivatives of the vector potential

The nonabelian magnetic eld has the following components

In order to obtain the elective Hamiltonian for the soft modes, which are taken to be constant throughout space, we perform a spatial average over the relevant terms in the

Ham iltonian. For the quadratic and quartic expressions of the hard amplitudes w_i^a we use the following relations

The spatially averaged Hamiltonian,

contains three parts: $H_{\rm T}$, describing the hard therm alm odes interacting among them selves; $H_{\rm S}$, describing the soft modes in isolation; and $H_{\rm T}$ denoting the interactions between hard and soft modes. A coording to the usual picture of a gluon plasm a we treat the hard modes perturbatively, neglecting their mutual interactions. This yields:

in the leading order approximation.

The part of the Hamiltonian which contains soft modes must be treated nonperturbatively, so we keep the quartic anham onic terms here. We get

for the soft mode part and

are the components of the elective mass square matrix for the soft modes and Q^3 is the uctuating color charge of the hard modes, which acts as a source for the soft modes.

The Ham iltonian H $_0$ (10) describes independent oscillations with a frequency of ! = $\Re j = T$. For the dynam ical evolution of the soft modes x;y;z this is a very fast motion; we can therefore average over many time periods in order to arrive at an elective soft mode Ham iltonian $\overline{H_I}$ for the interaction. The ensemble averaging over the relative phases and slow ly uctuating amplitudes of the hard thermal components, however, cannot be done at this point, because these quantities change on the timescale t_3 $1=g^2T$. Consider the hard thermal eigenmodes of the Ham iltonian (10):

The initial am plitudes U_i^a ; V_i^a and phases $'_i^a$, $_i^a$ (i = 1;2 a = 1;2;3) determ ine the quantities M_i^a and Q_i^a which in turn in which evolution of the soft modes x; y; z. In order to obtain the correct scaling M_i^a g^2T^2 of the elements of the mass matrix (13) we take the amplitudes of the fast oscillations to be Q_i^a . As seen from (10) this is consistent with an energy density Q_i^a in the hard modes, as expected for the thermal bath.

If, for the sake of sim plicity, we assume all am plitudes equal to each other, so $U_i^a = V_i^a$ $V_i^a = V_i^a$ $V_i^a = V_i^a$

These e ective m ass term s in the averaged H am iltonian H $_{\rm I}$ are the analogue of the plasm on m ass term in the full therm all gauge theory. For small am plitudes of the soft m odes x;y;z they dominate over the anharm onic term s in (11) and apparently cause the soft m odes to oscillate harm onically with a frequency $!_{\rm S}$ gT.

However, the presence of non-diagonal elements M $_1^2$ in the mass square matrix can destabilize these oscillations. The time averaged o -diagonal term \overline{M}_1^2 , as well as the source term \overline{Q}^3 , depend on the phases of the hard thermal oscillations (14):

Because of their dependence on the relative phases of the fast modes \overline{M}_1^2 and \overline{Q}_3 would vanish if a complete ensemble average over the fast modes were performed. However, as pointed out at the beginning of our discussion, the phases and amplitudes of these modes change more slowly (on timescale t_3) than the soft modes oscillate (on timescale t_2). Hence, both \overline{M}_1^2 and \overline{Q}_3 must be considered as secular quantities in the averaged (over timescale t_1) Hamiltonian $H_S + \overline{H}_I$ governing the evolution of the soft modes.

Far from the \average" case, $\overline{M}_1^2 = \overline{Q}^3 = 0$, there is the extreme possibility of $\overline{M}_2^1 = 3$ m 2 =2 and $\overline{Q}^3 = m^2$ T=2g gT 3 obtained for $'_1^1 = '_2^2 = _1^2 = _1^2$, $_1^1 = _2^2 = '_2^1 = '_1^2$. As we will see below, in this case the mass square matrix of the coupled x and y modes has negative eigenvalues giving rise to an exponentially growing solution of the linearized equations of motion for small amplitudes x and y.

We now consider small amplitude oscillations and neglect terms nonlinear in x or y. The z-coordinate then decouples from the x-y motion, as seen from (13). It is most convenient to cast the resulting equation into matrix form

where we rem ind the reader that the \bar" denotes the time averaged quantities for xed phase $'^a_i$; a_i and amplitudes U^a_i ; V^a_i . Since the average over the ensemble of these initial conditions must be performed after the full solution is obtained, we proceed with solving (18) by inding the eigenvalues and eigenvectors of the matrix operator on the left hand side.

Seeking the solution with $x;y / e^{i!t}$, we not the eigenvalue equation

C learly, for j j> 1 one of the eigenvalues becomes unstable with an imaginary frequency.

W ith the help of the eigenvalues! and eigenvectors (x; y) the general solution of the time-averaged equation (13) can be written in the form

w here

where $(c_i;d_i)$ are the eigenvectors corresponding to the eigenvalues $!_i^2$. It is not discult to show that the product c_id_i vanishes when it is averaged over the phases $'_i^a$ and $_i^a$. As a result, the full therm all ensemble average gives rise to a color diagonal elective soft mode propagator h (t)i, which contains an exponentially growing part originating from those regions of phase space where $!^2 < 0$, as is seen from (22).

Sum marizing, we demonstrated in a simple model that the coupling of soft plasmon oscillations to hard thermal gluons can drive the soft eld amplitude into an exponential growth and with that into a chaotic dynamical behavior. There are, of course, many possible few mode approximations to the Yang-Mills eld theory. The example we discussed above was generic in the sense that it showed both dynamical mass generation and the development of chaotic instability due to o-diagonal parts of the self-energy, as well as source term coupling to the soft modes. One may expect that by this mechanism the dynamics of long wavelength modes in a hot gluon plasma remains chaotic despite the presence of a dynamical plasmon mass.
