$U(2)_L$ $U(2)_R$ Chiral Theory of Mesons

A bstract

A U $(2)_L$ U $(2)_R$ chiral theory of pseudoscalar, vector, and axial-vector m esons has been proposed. VMD has been revealed from this theory. The physical processes of normal parity and abnormal parity have been studied by using the same lagrangian and the universality of coupling has been revealed. Two new mass relations between vector and axial-vector mesons have been found. We inberg's rst sum rule and new relations about the amplitude of a_1 decay are satistical. KSFR sum rule is satistical pretty well. The pole in pion form factor has been achieved. The theoretical results of a_1 and a_2 , a_3 , a_4 ,

 f_1 !, f_1 !, f_1 !, f_1 ! are in good agreement with data. We inberg's scattering lengths and slopes and a $_2^0$, a_2^2 , and b_1^1 have been obtained. Especially, the resonance in the amplitude T_1^1 of scattering has been revealed from this theory. Two coe cients of chiral perturbation theory have been determined and they are close to the values used by chiral perturbation theory.

Chiral symmetry is one of the most important features revealed from quantum chrom odynamics (QCD). The chiral perturbation theory (CPT) is successful in describing the pseudoscalar m eson physics[1,2]. Chiral lagrangian has been used to study physics of vector and axial-vector m esons before QCD [3]. W einberg's sum rules[4] of and a m esons, KSRF sum rule [5] of meson are also among earlier works in this eld. On the other hand, in ref. [6] in terms of large N $_{\rm C}$ expansion tH ooft argues that QCD is equivalent to a meson theory at low energies. In principle, all mesons should be included in this meson theory. Of course, in chiral perturbation theory the e ects of other mesons have been included in the coe cients of the lagrangian up to $0 (p^4)$. As a matter of fact, in ref. [7,8] the authors have found that the vector m eson dom inates the structure of the phenom enological chiral lagrangian. Various e ective theory including and a₁ m esons has been studied in last decade [9]. W ess-Zum ino lagrangian [10] is an important part of the e ective meson theory. Witten [11] and other authors[12,13] have generalized W ess-Zum ino lagrangian to include vector and axial-vector m esons by the requiring gauge invariance. In refs.[12,14] the generalized W ess-Zum ino term s have been used to study meson physics. In this paper a U $(2)_L$ U $(2)_R$ chiral theory of m esons including pseudoscalar, vector and axial-vector has been studied. The form alism of U $(2)_L$ U $(2)_R$ chiral theory of m esons In this paper only two avors are taken into account and we do not need to worry about the processes forbidden by O ZI rule. Om eson will not be discussed. Therefore, U (1) problem is not an issue of this paper. In avor space the mesons are coupled to quarks only. The background eld method is a convenient way of deriving elective lagrangian of mesons. The ingredients of this elective meson theory are pseudoscalar mesons (pions and u and diquark components of), vector mesons (and !), axial-vector mesons (a and f1 (1285)), quarks, leptons, photon, and Websons. Using U $(2)_L$ U $(2)_R$ chiral symmetry and the minimum coupling principle, the lagrangian has been constructed as

where $a = ia^i + f$, $v = i^{-i} + !$, A is photon eld, $Q = \frac{3}{2} + \frac{1}{6}$ is the electric charge operator of u and d quarks, W i is W boson, and u = expif $_5$ ($_{i-i} + _{i-1}$)g, m is a parameter.

where $U = \exp i(i_{i} + i)$. M esons are bound states solutions of QCD and in QCD m esons are not independent degrees of freedom. Therefore, in eq.(1) there are no kinetic terms form eson elds. The kinetic terms of m eson elds are generated from quark loops. Using m ethod of path integral to integrating out the quark elds, the elds, the elds are generated by M) are obtained

The functional integral has been used and the quark elds are regulated by proper time method [16]. A review of this method has been given by Ball[15]. This integral can be done in Euclid space (forget photon and W boson rst)

From this e ective lagrangian it can be seen that the physical processes with normal party are described by $L_{\rm RE}$ and the ones with abnormal party are described by $L_{\rm IM}$. In terms of Schwenger's proper time method [16] we have

There are correspondence between the schemes of regularization used in this paper and in ref.[15]. Upon this correspondence and transforming the formalism of ref.[15] to M inkofsky space, it can be found that this formalism (13) is the same with the one presented in ref.[15].

The imaginary lagrangian (6) describes the physical processes with abnormal party. It should be the generalized W ess-Zum ino lagrangian. We do not use the method of path integral to $\operatorname{nd} L_{\operatorname{IM}}$ and we evaluate the term $\operatorname{sof} L_{\operatorname{IM}}$, which can be used to study physical processes, in M inkofsky space directly in this paper.

De ning physical meson elds

In eq.(13) there are divergences. The theory studied in this paper is an elective theory and it is not renormalizable. In order to build a physical elective meson theory, the introduction of a cut-oloute to the theory is necessary and the cut-oloute will be determined in this theory. We

The relationship between the cut-o and F^2 , g will be explored. From the kinetic terms of meson elds in eq.(13) we can see that the meson elds in eq.(13) are not physical. The physical meson elds can be de ned in following ways that make the corresponding kinetic terms in the standard form.

New mass formulas of vector mesons and its chiral partners. In lagrangian (1) that vector mesons and axial-vector masons are chiral partners. However, it can be seen from eqs. (19,22) that vector and axial-vector meson elds behave dierently. Due to eqs. (22,23), in the couplings of axial-vector elds to others there is an additional factor (1 $1=2^{2}g^{2}$) 1=2.

The physical masses of vector mesons are defined by eq.(17). For the masses of axial-vector mesons there are three contributors: the mass term in the lagrangian (1); the contribution of the rst term of the lagrangian (13), which is $\frac{F^2}{g^2}$; the normalization factor (1 $\frac{1}{2^{-2}g^2}$) 1.

Put all these three factors together the a_1 m ass has been found to be

The deviation of this relation from physical values (m $_{\rm a}=126{\rm G\,eV}$ and m $_{\rm f}=1285{\rm G\,eV}$) is about 2% .

In chiral lim it there are three param eters in this theory, which can be chosen as g, f, and m. Take f and m as inputs and choose

to get a better ts. The couplings in all the physical processes described by L_{RE} and L_{IM} are xed by g and c. This is the universality of coupling in this theory.

Vector m eson dom inance (V M D)

Vector meson dominance (VMD) has been revealed from this theory. From eq.(1) it can be

seen that except the kinetic term of photon, photon and vector mesons always appear in the combinations

The ratio of $\frac{1}{f}$ to $\frac{1}{f_!}$ is $1:\frac{1}{3}$, that is the same with quark model. The comparison between theoretical and experimental values of f and $f_!$ can be found in Table II. The photon-vector meson couplings shown by eqs.(35) are just the ones proposed in ref.[18]. On the other hand, there are interactions between and ! mesons with other masons, in general, these interactions can be written as

Therefore, besides the direct coupling of photon and meson (35) another type of interaction between photon and other mesons can be found by the substitution (32)

The cause obtaing the explicit expression of VMD in this theory can be manifested in another way. It is well known that in QCD the electric current takes the form of

In ref.[20] we have developed a method to not the electric currents in the case that only pseudoscalar elds are taken as background elds. In this paper this method has been generalized to include vector and axial-vector mesons. From the lagrangian (1) the equation satisfied by the quark propagator has been obtained

In present theory the reason of dom inance is the consequence of the cancellation between the original pion and the pion obtained from the shift of a! a c@. On the other hand, the energy dependence of the am plitudes (83,84) have been predicted by present theory. The am plitudes A (t;s;u) and A (u;t;s) (84) predict the resonance structure of (770) in the channel of I = 1 and I = 1. The experimental data [32] clearly shows the (770) resonance in the am plitude I_1^1 . The comparison between theoretical predictions and experimental data are shown in Fig.1. From Fig.1, it can be seen that $I_1^1I_1$ is in good agreement with data and $I_2^0I_1$, $I_2^0I_2$, and $I_3^0I_2$ agree with data well. However, this theory does not provide an imaginary part for $I_0^0I_1$ and the experimental data shows that there is an imaginary part in $I_0^0I_2$. On the other hand, the data shows (Table I)

that the theoretical predictions of a_0^0 and b_0^0 are lower than the experimental data. Therefore, in the channel of I=0 and l=0 something is missing in this theory. In ref.[33] the 0^{++} f_0 (1300) meson has been introduced to the elective meson theory to improve the theoretical value of a_0^0 . The f_0 (1300) meson can be introduced to the lagrangian (1), however, this is beyond the scope of this paper.

!! and other related processes

In 60's, Gell-M ann, Sharp and W agner[34] used the coupling of ! to compute the decay rates of ! and 0 ! in terms of VMD. The Syracuse group [12] has used the generalized W ess-Zum ino action to study these processes.

In the process !! only pion is associated with $_5$ in this theory. Therefore, this process should be described by the electric lagrangian L_{IM} (6). This formula is exact the same with the one obtained by Syracuse group [12]. In ref.[12] the Bardeen form of the anomaly [36] has been accepted and an arbitrary constant in their formula has been chosen to be 1. The authors of ref.[12] claim that their Wess-Zum ino lagrangian with spin-1 elds agrees with Witten's [11] expression except an inadvertently omitted term. In eq.(99) all the couplings are xed by g and c. This is the universality of coupling in this theory.

If only !! and ! are taken into account the width of!! 3 is 5.4M eV. The experimental value is $7.43(1 \ 0.02)$ M eV. From this study we can see that the process of!! is dominant the decay of!! 3 as proposed by the authors [34]. The direct coupling of!! 3 is responsible for about 20% of the decay rate. The agreement between theoretical and experimental decay rates of 0!, if we will not a show sthat!! obtained in this theory is more reliable. However, at tree level due to the cancellation f_{13} is too small and has a wrong sign. Therefore, corrections from loop diagram s and terms with higher order derivatives to f_{13} are needed.

The decays of f_1 (1285) m eson

In this theory f_1 (1285) meson is the chiral partner of! meson (see eq.(1)). The decay of

 f_1 ! 4 consists of two processes: direct coupling f_1 ! and f_1 ! a_1 ! . f_1 m eson is associated with f_1 (see eq.(1)), hence, odd number of f_2 are involved in these two processes. Therefore, the decay of f_1 ! can not be found in eq.(13) and should be found in the W ess-Zum ino lagrangian with vector and axial-vector m esons. In this paper the method used to not the extive lagrangian of these processes is the same with the one used to study the decays of! m eson. From the lagrangian (1) and normalization of f_1 m eson the vertices of f_1 decays can be found from following form ula

From this lagrangian, the same conclusion with ref.[14] has been reached that the decays of f_1 ! and !! are forbidden. Therefore, f_1 m eson can not decay to two realphotons. This is Yang's theorem [38].

Theoretical predictions are in good agreement with data. For ! besides! and

!!!, the process ! also contributes to ! , we will study ! in another paper in which the strange avor is included.

A first the study of those physical processes, three problems of this theory should be discussed. They are: loop diagrams, dynamical chiral symmetry breaking, and momentum expansion.

Large N_c expansion

According to t'Hooff[6], in large N_c limit QCD is equivalent to a meson theory at low energy. Therefore, large N_c expansion plays a crucial role in the connection between QCD and elective meson theory, even though we do not know how to derive the lagrangian of elective meson theory from QCD directly. In present theory the large N_c expansion plays an important role too. The quark elds in lagrangian (1) carry colors. In order to obtain the elective lagrangian of mesons from the lagrangian (1), the quark elds have been integrated out by path integral. A fler this integration the trace in the color space generates the number of color N_c . Parameter moof the lagrangian (1) is 0 (1) in large N_c expansion. Eq.(14) determines that F^2 is order of N_c , hence f is order of N_c . The coupling constant f denoted by eq.(15) is f order of f order normalization, the physical meson elds, pion, f in all are all at order of f order of f

results, it is not discult to and out that all the vertices of this paper are at order of N $_{\rm c}$ and it is obvious that the propagator of m eson is order of O (1). Therefore, order of m agnitude of a Feynm an diagram of m esons in large N $_{\rm c}$ expansion is given by

where N $_{\rm V}$ is the number of vertices and N $_{\rm P}$ is the number of internal lines. Eq.(122) tells that all tree diagram s are at order of O (N $_{\rm C}$), hence they are leading contributions. A diagram with loops is at higher order in large N $_{\rm C}$ expansion. For instance, a diagram of one loop with two internal lines is order of O (1). In this paper all calculations have been done at tree level. Most of the theoretical predictions are in agreement with data. This success can be viewed as a support of the large N $_{\rm C}$ expansion. However, in some cases due to cancellation, for instance the direct coupling of ! ! 3 , or other reasons the leading term is very small a correction of loop diagram should be taken.

Dynam ical chiral sym metry breaking

The parameter m in eq.(1) is associated with quark condensate which is de ned as

This is u and d quark condensate. Nonzero quark condensate means dynamical chiral symmetry breaking. Therefore, there is dynamical chiral symmetry breaking in this theory. Detailed discussion of masses of pseudoscalar mesons can be found in ref.[31]. Eq.(126) is a well known formula obtained by the theory of chiral symmetry breaking proposed by Gell-Mann, Oakes, and Renner[39], and by Glashow and Weinberg[40] Eq.(126) tells that the quark condensate is negative, hence the parameter m is negative too. It is about twice the current value [41]. As pointed in ref. [41], the determ ination of absolute value of quark m ass is model dependent.

D erivative expansion

This theory is an elective meson theory at low energies. Like the chiral perturbation theory [1], the derivative expansion (to be accurate, covariant derivative expansion) has been applied. It seems that the derivative expansion works in the studies presented in this paper. The calculations of decay widths are good examples. If the terms at the second order in derivatives in lagrangian (13) contribute to the decay of a meson, the decay width of this meson is broader. decay and a_1 decay are two examples. If only the terms at the fourth order in derivatives contribute to the decay, the decay width is narrower. The reason is that in the decay amplitude there is a factor of $\frac{1}{2}$. The predictions of narrower widths for decays, $\frac{1}{2}$. $\frac{1}{2}$, $\frac{1}{2}$, and $\frac{1}{2}$, $\frac{1}{2}$, $\frac{1}{2}$, $\frac{1}{2}$, $\frac{1}{2}$, which are obtained from the terms at the zeroth order or the second order in derivatives, are much greater than a_2^0 , a_2^2 , and b_1^1 which are from the terms at the fourth order in derivatives.

Derivative expansion is momentum expansion and is the maximum momentum. The momentum expansion requires that the momentum is less than . The masses of ,!, a_1 , and f_1 are less than . However, there is physical case in which momentum expansion is not suitable. In scattering there is resonance in the scattering amplitudes (84). At very low energy the momentum expansion has been applied to scattering amplitudes, however, in the region of resonance the momentum expansion is not working because it destroys the resonance. Therefore, we do not apply the momentum expansion to the amplitudes of resonance in this paper.

Sum m ary of the results

To sum marize the results achieved by this theory. VMD has been revealed from this theory. We einberg's rst sum rule and new relations about a_1 meson decay are satisted. KSFR sum rule is satisted pretty well. New mass relations between vector and axial-vector mesons have been found. We einberg's scattering lengths and slopes have been revealed. The amplitude

of ⁰! obtained by this theory is exact the same with the prediction of triangle anomaly. This theory provides a united description of the physical processes with normal and abnormal parity and the universality of coupling has been revealed. The elective lagrangians used to treat the processes of abnormal parity are exactly the same with the ones obtained from gauging Wess-Zumino lagrangian with vector and axial-vector mesons. In chiral limit, we take found meaning as inputs. The coupling constant g is chosen to the data. In phase spaces physical meand meaning meaning the meaning terms have been kept in chiral perturbation. The results of scattering have been shown in Table I and Fig.1.0 ther results are listed in Table II.
