M odel of Four Light N eutrinos in the Light of All P resent D ata

A bstract

M otivated by existing and recent data on possible neutrino oscillations, we propose a model of four light neutrinos ($_{\rm e}$; , and a singlet $_{\rm S}$) with a pattern of m assess and m ixing derivable from a discrete Z $_{\rm 5}$ sym m etry and the seesaw m echanism . Atm ospheric neutrino oscillations occur between and as pseudo-D irac partners; whereas solar neutrino oscillations occur between $_{\rm e}$ and $_{\rm S}$, a linear combination of which is m assless. Additional oscillations m ay occur between $_{\rm e}$ and to account for the recent observation of the LSND (Liquid Scintillator N eutrino D etector) experiment.

The physics of light neutrinos appears poised on the edge of major discoveries. Many hints have accumulated over the past years towards nonzero masses and avormixing of these special elementary fermions without charge. They include the solar neutrino decit[1], the atmospheric neutrino anomaly [2], the need for a cosmological hot dark matter component [3], and nally the excess of ! events observed recently by the LSND (Liquid Scintillator Neutrino Detector) experiment [4]. If all these strands are put together in a total picture, along with the nonobservations of neutrinoless double -decay [5] and any depletion of reactor antineutrinos (such as from the Bugey experiment [6]), one is led naturally to a variation of a simple scenario already proposed [7]. We over in this paper a theoretical understanding of this special scenario in terms of a hierarchical seesaw model of the masses and avormixing of four light neutrinos with an assumed discrete Z_5 symmetry.

We recount the constraints from the above observations. In a two-oscillator picture involving $_{\rm e}$, the solar neutrino de cit favors either of two matter-enhanced oscillation solutions with $\rm m_e^2$ 10 6 to 10 5 eV 2 , $\sin^2 2_{\rm e}$ 5 10 3 and with $\rm m_e^2$ 10 6 to 10 4 eV 2 , $\sin^2 2_{\rm e}$ > 0.4 or a vacuum oscillation solution with $\rm m_e^2$ 10 10 eV 2 , $\sin^2 2_{\rm e}$ > 0.75. Here $\rm m_e^2$ is the dierence of the squares of the two neutrino masses and $\rm e$ is the mixing angle between $\rm e$ and another light neutrino . The atmospheric neutrino anomaly can be understood in a two-oscillator scenario involving and another neutrino with $\rm m^2$ 10 $\rm ^2$ eV 2 and $\rm sin^2 2_{\rm e}$ = 0 (1). The LSND results, on the other hand, suggest $\rm m_e^2$ 0.5 10 eV 2 and $\rm sin^2 2_{\rm e}$ (6 3) 10 $\rm ^3$ once again in a two-oscillator picture. It is clear that with only the three known neutrino avors ($\rm _{e}$; ;), we cannot explain all three $\rm m^2$'s. The orders of magnitude of the latter are too disparate to be explained even by invoking three—avor oscillations. We are thus prompted by the need to explain all of the above to add a singlet neutrino $\rm _S$ which is by itself noninteracting, but will be allowed to mix with the other neutrinos. In this way, we are also able to consider the cosmologically

desirable requirem ent[3] that the masses of the usual three neutrinos sum up to about 5 eV.

With four neutrinos as suggested above, there is a simple hierarchical situation involving only two-oscillator scenarios[8]. Let and be nearly degenerate with masses of about 2.5 eV each and close to maximal mixing. The m² here is about 10^2 eV^2 . The singlet neutrino shas a mass of order 10^3 eV whereas e is very much lighter but mixes with shas a well as by small amounts. In this scenario, because e is lighter than there is a potential confict with rapid neutron capture (r-process) in Type II supernovae[9]. However, if the hierarchy is inverted[10] to avoid this problem, then e is a few eV in mass and the constraint of neutrinoless double edecay that me < 0.68 eV [11] cannot be satisted. Given the manifold uncertainties of the r-process calculation in a hot-bubble scenario, we choose to disregard it in favor of the double edecay constraint.

We view the large mixing but small mass splitting of and as suggestive of their pseudo-D irac origin. We also envisage a massless $_{\rm e}$ and a very light $_{\rm S}$ as two Majorana neutrinos with a small mixing. A united seesaw model of these hierarchical masses would need a Dirac seesaw [12] for the former pair with a minimum 4-4 matrix and a Majorana seesaw [13] for the latter pair with a minimum 3-3 matrix. An additional small mixing between these two sectors is necessary for understanding the LSND results and can only come from both matrices being submatrices of one 7-7 neutrino mass matrix.

It may appear dicult at rst sight to construct a model of the lepton sector generating naturally a mass matrix with the above requirements from a symmetry. However, as shown below, a reasonably simple model does emerge if one supplements the standard SU $(2)_L$ U $(1)_Y$ electroweak gauge symmetry with a discrete Z_5 symmetry [14] which might be the product of a more fundamental underlying theory. This discrete symmetry will be broken spontaneously resulting in the appearance of domain walls. However, it is now known [15] that higher-dimensional operators, induced at the Planck scale, can make such domain walls

collapse very quickly after form ation so that we need not consider this as a potential problem.

We take the \mathbb{Z}_5 elements to be! 2 ,! 1 ,1,!, and! 2 with! 5 = 1. Let the three lepton families of left-handed electroweak doublets be denoted by (;1)_L, with = e; ; . Let the three right-handed charged lepton singlets \mathbb{I}_R be accompanied by four right-handed neutrino singlets ($_R$; $_{SR}$). The \mathbb{Z}_5 transform ations of the leptons bearing subscripts e; ; ;S are chosen to be 1,! 2 ,! 2 ,! 1 respectively. The scalar sector is assumed to consist of two doublets $_1$ = ($_1^+$; $_1^0$), $_2$ = ($_2^+$; $_2^0$) and a complex singlet 0 transforming as 1,! 2 , and! respectively. The charged lepton mass matrix linking \mathbb{I}_L and \mathbb{I}_R is now of the form

where the diagonal entries a; b; c com e from the nonzero vacuum expectation value of 0_1 and the o-diagonal entries d; e com e from that of 0_2 . The zeros of this matrix are protected at tree level by the assumed discrete Z_5 symmetry. As it stands, this mass matrix shows possible e_L but very little e_L mixing. There could be substantial e_R mixing, but that is not observable as far as vector gauge interactions are concerned.

Turning to the neutrino sector, we not the mass matrix spanning $_{eL}$, $_{L}$, $_{eR}$, $_{R}$, and $_{SR}$ to be given by

where m_1 ; m_2 ; m_3 come from h_1^0 i, m_6 ; m_7 from h_2^0 i, m_4 ; m_9 from h_1^0 i, m_5 ; m_8 from h_1^0 i, and m_1 ; m_2 are allowed mass terms even in the absence of symmetry breaking. The zeros are again protected at tree level by the assumed discrete Z_5 symmetry.

Note rst that M has one zero m ass eigenvalue, corresponding to an eigenstate which is mostly $_{\rm e}$ as we will show. In the absence of symmetry breaking, all the m's are zero and we have only M $_{\rm 1}$ and M $_{\rm 2}$, corresponding to one massive M ajorana ferm ion and one massive D irac ferm ion respectively. These allowed masses can be very heavy and will act as the anchors for the seesaw mechanisms which generate the requisite small neutrino masses of our model. Note that the 4 4 submatrix spanning $_{\rm eL}$, $_{\rm L}$, and $_{\rm SR}$ is indeed identically zero, even in the presence of symmetry breaking.

Consider now the situation where only m $_2$; m $_3$ are m ade nonzero in addition to M $_1$; M $_2$. Then we have a D irac seesaw mass m $_2$ m $_3$ =M $_2$ for and , whereas $_e$ and $_S$ remain massless. Thus M has a global vector U (1) sym metry as well as two chiral U (1) sym metries in this case. If the other m's are also made nonzero, then these sym metries are broken except of course for that corresponding to the zero mass eigenvalue noted before. Hence it is natural[16] to assume that these other m's are much smaller in magnitude than m $_2$; m $_3$ which are in turn much smaller than M $_1$; M $_2$. As it turns out, we also need to make the ratio m $_1$ =m $_4$ small because it corresponds to $_e$ $_S$ mixing for explaining solar neutrino data. To sum marize, we assume

For very large M $_1$; M $_2$, the seesaw reduction of M $_2$ yields the following 4 $_3$ 4 m ass m atrix spanning $_3$ R, $_4$ L, and $_4$ L:

Taking the m $_2$ m $_3$ =M $_2$ entries in the above m ass m atrix to be dom in ant, it is easily seen that a further seesaw reduction yields a 2 $_2$ m atrix spanning only $_{SR}$ and $_{eL}$ with elements

given by the upper-left-corner submatrix proportional to $1=M_1$. To not the eigenvalues 0 of M 0 which we denote by $=M_1M_2$, we write down its characteristic equation:

U sing the mass hierarchy assumed in Eq. (3), the four eigenvalues are easily obtained:

The corresponding mass eigenstates are then related to the interaction eigenstates by

In Eqs. (6) to (10) we have consistently retained only the leading term s.

We now have our desired pattern of neutrino masses and mixing. We see that and are pseudo-Dirac partners with mass dierence squared given by

The singlet neutrino $_{\rm S}$ is mostly $_{\rm 2}$ which has a small mass, whereas $_{\rm e}$ is mostly $_{\rm 1}$ which is massless. Their mixing is given by m $_{\rm 1}$ =m $_{\rm 4}$. Furthermore, oscillates to $_{\rm e}$ with mixing given by m $_{\rm 6}$ =m $_{\rm 2}$ as shown by Eq. (10). For illustration, let M $_{\rm 1}$ = M $_{\rm 2}$ = 100 TeV, m $_{\rm 2}$ = 10 MeV, m $_{\rm 3}$ = 25 MeV, m $_{\rm 4}$ = 0.5 MeV, m $_{\rm 6}$ = 0.4 MeV, m $_{\rm 7}$ = 0.6 MeV, and m $_{\rm 1}$ = 20 keV; then

the common mass of and is $m_2 m_3 = M_2 = 2.5 \text{ eV}$, the mass of s is $m_4^2 = M_1 = 2.5 \cdot 10^{-3}$ eV, $m_{34}^2 = 1.8 \cdot 10^{-2} \text{ eV}^2$, e s mixing is $m_1 = m_4 = 0.04$, e mixing is $m_6 = m_2 = 0.04$, yielding an elective $\sin^2 2 = 6.4 \cdot 10^{-3}$ in either case as indicated by the solar-neutrino and LSND data.

With four light neutrinos, the nucleosynthesis bound [17] of N < 3:3 is an important constraint. A lthough $_{
m S}$ is a singlet neutrino, it m ixes with $_{
m e}$ and m ay contribute signi cantly to N through oscillations. However, for the matter-enhanced nonadiabatic e oscillations which explain the solar data, this is not a problem [18]. Note that if we had made $m_1 >> m_4$ instead, then s would be mostly massless and the resulting scenario would be excluded by nucleosynthesis. By the same token, if we had tried to let oscillate into s to explain the atmospheric neutrino data, it would also be in con ict with nucleosynthesis. These requirements are su cient to pin down uniquely our model of four light neutrinos provided we restrict ourselves to only two-oscillator e ects[8] and the viewpoint that two alm ost degenerate neutrinos should be pseudo-D irac. Of course, this forces us to have maxsector and we must disregard part of the Frejis data [19], but if im alm ixing in the a smaller e ective $\sin^2 2$ (say 0.7) is desired, then the underlying symmetry as well as the m echanism for generating M 0 become much more complicated [7]. As it is, all we need is a discrete Z_5 sym m etry and the seesaw m echanism.

Although e mixing is very small as given by Eq. (10), it may instead come from the charged-lepton mass matrix of Eq. (1). Hence our model can also accommodate such an eect. Because two dierent Higgs doublets contribute to the lepton mass matrices, avordhanging neutral-current processes do occur via the exchange of scalar bosons. For example, e is possible, but because all the Yukawa couplings are suppressed in this model, these are all negligible as far as present experimental bounds are concerned.

Regarding the Higgs sector which consists of two doublets and a singlet, it can be shown

that the imposition of our discrete Z_5 symmetry actually results in a continuous U (1) symmetry which is of course broken in the Yukawa sector as 0 couples both to $_{\rm eR}$ $_{\rm SR}$ and $_{\rm R}$ $_{\rm R}$. This means that a pseudo-Goldstone boson appears with a mass of order m $_5$ =4 which is too small to be compatible with present data. To avoid this problem, a simple solution is to enlarge the scalar sector with a real singlet $_0$ and a neutral complex singlet $_2$ transform ing under Z_5 as 1 and ! 2 respectively. In order that they do not couple directly to the leptons, they are also assumed to be odd under an extra discrete Z_2 symmetry. Because of the newly allowed terms $_2$ $_2$, $_0$ $_2$, and $_0$ $_0$, there is no longer any unwanted U (1) symmetry in this case and all the scalar bosons can be heavy.

The 4 A neutrino mass matrix given by Eq. (4) is similar but not identical to those of Ref. [7]. We assume that and to be pseudo-D irac partners whereas Peltonism i and Valle took and a linear combination of and $_{\rm e}$, while Caldwell and Mohapatra did not consider them as pseudo-D irac partners at all. Our model also diers in that we have a massless eigenvalue in the neutrino mass matrix and they do not. However, the most important dierence is in how we realize the desired form of the mass matrix. We use a simple discrete Z_5 symmetry and the seesaw mechanism whereas both papers of Ref. [7] require more complicated symmetries as well as radiative mechanisms for mass generation. Hence their scalar sectors are much more involved and contain many particles of exotic hypercharge whereas we have only the usual doublets and neutral singlets. Presumably, these are experimentally accessible at the electroweak energy scale and would serve as discriminants of one model against another.

In conclusion, we have shown that with all present desiderata, a simple model of four light neutrinos can be constructed with pairwise oscillations explaining the solar neutrino de cit ($_{\rm e}$ $_{\rm S}$), the atmospheric neutrino anomaly (), and the LSND observation ($_{\rm e}$). If the m² of the last experiment is indeed 6 eV², then there is also the cosmological

connection of neutrinos as candidates for hot dark m atter, though that would be in m arginal con ict with another neutrino experim ent [20]. If the experim ental inputs chosen by us do indeed stand the test of time, the matrix of Eq. (2) with the hierarchy of Eq. (3) could well be the harbinger of a complete theory of neutrino masses and mixing.
