ON MEASURING THE WIDTH OF THE INTERMEDIATE-MASSHIGGSATA PHOTON LINEAR COLLIDER

Abstract

The identi cation of the interm ediate-m ass Higgs process ! H ! bb will be one of the most important goals of a future photon linear collider. Backgrounds from the continuum ! $c\bar{c};b\bar{b}$ leading-order processes can be suppressed by using polarized photon beams in the $J_z = 0$ initial-state. The radiative processes ! $c\bar{c}g;b\bar{b}g$ can m in ic the two-jet topology of the Higgs signal and provide the dom inant background in the $J_z = 0$ channel. Particularly problem atic is the ! $c\bar{c}g$! 2 jets process. The e ects of imposing additional cuts are investigated and it is shown that the radiative background could be reduced to a manageable level.

1. Introduction

The rapid advance of laser technology makes possible the collision of highbrightness, high-energy photon beams at future linear colliders [2-3] through C om pton backscattering. One particularly intriguing use of such a photon linear collider is to measure the two-photon decay with a Higgs boson, (H !) [4-6]. In a photon linear collider (H !) is deduced by measuring the Higgs production cross section in the reaction ! H ! X where X is the detected nal state. The number of events is proportional to the product (H !) B (H ! X) where B (H ! X) is the branching ratio of the Higgs boson into the nal state X.

For a Higgs boson in the interm ediate-m ass region, 50 GeV < 150 GeV, the dom – inant decay mode is to bb. M easurem ent of the two-photon width in this mass region requires suppressing the continuum ! bb; \overline{cc} background beneath the resonant

by vertexing. The background can be greatly suppressed by using polarized photon beam s. The Higgs signal is produced by photons in a $J_z = 0$ initial state, whereas the backgrounds are primarily produced by photons in the $J_z = 2$ initial state, the $J_z = 0$ Born cross section being suppressed for large angles by a factor of $m_q^2 = s$ [6, 7].

The radiative processes can have an important impact (\radiation dam age") since the presence of the additional gluon (s) in principle removes the suppression of the $J_z = 0$ background channel [1, 8]. The radiative process ! $q\bar{q}g$ with q = b; c can m in ic the dom inant two-jet topology of the H iggs signal in two important cases: (i) if two of the three partons are collinear, for example a fast quark recoiling against a collinear quark and gluon, or (ii) if one of the partons is either quite soft or is directed down the beam pipe and is therefore not tagged as a distinct jet. A particularly interesting example of the latter is when one of the incom ing photons splits into a quark and an antiquark, one of which carries m ost of the photon's momentum and C om pton scatters o the other photon, $q(\bar{q})$! $q(\bar{q})g$. Two jets are then identi ed in the detector, with the third jet remaining undetected. Here we discuss the impact of the radiative $q\bar{q}g$ process on the study of an intermediate-m ass H iggs boson at a photon linear collider.

2. Non-radiative processes

For H iggs boson in the interm ediate-m ass region, the beam energy spread is much greater than the total width, and so the number of H $\,!\,$ bb events expected is

where $W = \frac{p}{s}$ is the two-photon invariant m ass.

In the Born approximation the background (! $b\bar{b};c\bar{c}$) cross section is given by

where $q = \frac{1}{1} - 4m_q^2 = s$ and m_q and Q_q are the mass and electric charge of the quark respectively.

Note the strong cos dependence of the cross section and that the J_z = 0 cross section vanishes, for jcos j< 1, in the high-energy limit. This cross section can therefore be significantly reduced by using polarized beams and cutting on cos . Note that in comparing signal (S) to background (B) cross sections it is convenient to normalize the signal cross sections as if (dL=dW)_S = (L)_B / (10 GeV). This is equivalent to assuming that the experimental resolution on reconstructing the Higgs mass is 10 GeV, see [5].

Fig. 1 shows the Bom cross sections for $b\bar{b}$ and $c\bar{c}$ production and illustrates the very large suppression that is possible with polarized photons in the $J_z = 0$ state.

Before discussing the radiative background we comment on the origin of the largeangle suppression of $q\bar{q}$ production in the $J_z = 0$ channel as $m_q^2 = s ! 0$. Consider the symmetry properties of the Born amplitude in the ! 1 limit. Because of helicity conservation at the photon vertices, only amplitudes with opposite helicities for the quark and antiquark survive. However, the combined impact of C ;P and T invariance, photon Bose statistics, and unitarity, can be shown to lead to a vanishing amplitude in this limit at lowest order in perturbation theory [1].

There are some instructive lessons from studying these symmetry properties:

- 1. For the $J_z = 0$ case the interferences between the Born and higher-order nonradiative diagram s are additionally suppressed by a factor of $m_q = \frac{p}{s}$.
- 2. For boproduction at W 100 GeV the suppression factor $\frac{W_{b}}{s} \xrightarrow{s}$ and the virtual gluon O ($_{s}^{2}$) corrections should be taken into account in computation of the two-jet background in the $J_{z} = 0$ channel².
- 3. For the special case of scattering at 90°, the $\frac{m_q}{p_s}$ -suppression of all $J_z = 0$ non-radiative amplitudes (i.e. not just at leading order) follows simply from rotational invariance about the ferm ion direction and photon Bose statistics. For this particular angular con guration the T-invariance argument is redundant.

3. Radiative background

W hile at su ciently high energies the lowest order $q\bar{q}$ large-angle cross sections are 0 (2 =s) and 0 (2 m 2_q =s²) for J_z = 2 and 0, respectively, the $q\bar{q}g$ cross sections are 0 (2 s=s) in both cases, i.e. the ! $q\bar{q}g$ cross section is in principle not suppressed in the J_z = 0 channel. Furtherm ore, there are regions of phase space where the three-parton nal state may be tagged as a two-jet event. In the case of bbg and $\bar{c}q$, the event may have a vertex structure sim ilar to the non-radiative case, in which case this process could easily be misidenti ed as a bb nal state. In contrast, the J_z = 2 cross section for ! $q\bar{q}g$ is simply an 0 (s) correction to the much larger J_z = 2 ! $q\bar{q}$ cross section and will not be considered further here.

In Ref. [1] we discussed the various radiative contributions which could be tagged as two-jet events. The analytic form ulae were presented in the lim it of vanishing quark masses and the results for the realistic case of massive quarks were calculated num erically. Recall that in the total cross section the infrared singularity is cancelled by one-loop virtual gluon correction to the Born cross section.

The largest background is from the ! \bar{ccg} process which results in an order of magnitude increase of the $J_z = 0$ two-jet production cross section at $P_{\bar{s}}$ 100 GeV. This cross section is, in principle, in excess of the Higgs signal. An important contribution corresponds to one of the photons splitting into a quark and an antiquark, one of which undergoes a C ompton scattering with the other photon to produce an energetic quark and gluon. The extent to which these two jets are back-to-back in the

center-of-m ass frame (and therefore constitute a background to H ! $q\bar{q}$) depends on how the momentum is apportioned between the active and spectator quark in the

! $q\bar{q}$ splitting. It is worth noting that there is no $J_z = 0$ suppression in this case.

To estim ate the size of the virtual C om pton scattering contribution, one can use the leading pole approximation [9], i.e.

where $\overline{x} = 2\overline{p}_0 = \frac{p}{s}$ is the energy fraction of the quark which does not participate in the hard scattering. For this process to give a two-jet background, most of the scattering energy $\frac{p}{s}$ should be deposited in the detector, thus $0 < \overline{x} < where is a small parameter that will be directly related to the allowed acollinearity of the two jets in the detector. Recall that discrim inating two-jet topology on an event-by-event basis requires specifying a jet-nding algorithm.$

It is convenient to use a clustering form alism exemplied by the JADE algorithm [10]. If we use this algorithm y_{ut} and the pure $q\bar{q}$ events could be e ciently tagged with a y_{cut} of 0.02{0.03.

The transverse momentum integration of the spectator quark gives rise to a large logarithm, $\ln(s=m_q^2)$, where s is some fraction of s, and so the overall size of this contribution is roughly

Note that the requirement that most of the collision energy should be deposited at large angles in the detector in the case of monochromatic photon beams provides a very strong suppression of other 'resolved photon' contributions, such as ! gX followed by $g ! q\bar{g} [\beta]$.

Recall that for $\frac{P}{s}$ / 100 GeV, $\frac{m}{P}\frac{b}{s}$ \xrightarrow{s} y_{cut} and the Born contribution and the virtual and gluon radiative corrections to the two-jet cross section are all of the same order.

4. Experim ental considerations

The $J_z = 0$; ! $q\bar{q}g$ cross section, even for small values of y_{cut} , is a few per cent of the $J_z = 2$; ! $q\bar{q}$ cross section. This cross section for bottom and charm quarks, in the massless approximation is illustrated in Fig. 2 along with the non-radiative backgrounds. In a photon linear collider, it is possible to achieve a $\frac{J_z=0}{J_z=2}$ ratio of 20 (50), so in order to bring the rates for the radiative processes down it is necessary to nd cuts which further reduce the radiative backgrounds by a factor of about 5-10, without seriously degrading the H ! bb signal. To explore this in Ref. [1] a M onte-C arbo integration was employed (via JETSET 6.3 [11]) with a simple detector simulation.

Assuming W ' 100 G eV and imposing a y_{cut} of 0.02 with jcos j< 0:7 we found

$$J_{z=0} (! H ! b\bar{b} ! 2jets) = 0.86 \text{ pb};$$

$$J_{z=2} (! b\bar{b} ! 2jets) = 2.21 \text{ pb};$$

$$J_{z=2} (! c\bar{c} ! 2jets) = 35.6 \text{ pb};$$

$$J_{z=0} (! b\bar{b}g ! 2jets) = 0.035 \text{ pb};$$

$$J_{z=0} (! c\bar{c}g ! 2jets) = 0.87 \text{ pb};$$

A lthough a y_{cut} tends to select very two-jet events the $q\bar{q}g$ backgrounds (especially in the case of the Compton-regime con guration) still correspond to a somewhat di erent pro le of jets. In addition vertexing proves to be a very useful tool in separating b's from c's. In order to reduce the radiative backgrounds to a manageable level it was proposed in [1] to impose additional event shape, jet width and vertex cuts.

Applying a sphericity cut of 0.02, a jet width cut of 20° , and requiring 5 tracks with high 3-D impact parameter results in the following cross sections:

$$J_{z=0} (! H ! b\bar{b} ! 2jets) = 0:48 \text{ pb};$$

$$J_{z=2} (! b\bar{b} ! 2jets) = 1:2 \text{ pb};$$

$$J_{z=2} (! c\bar{c} ! 2jets) = 0:54 \text{ pb};$$

$$J_{z=0} (! b\bar{b}g ! 2jets) = 0:0031 \text{ pb};$$

$$J_{z=0} (! c\bar{c}g ! 2jets) = 0:0059 \text{ pb}:$$

Thus, we anticipate that a modern vertex detector should be capable of achieving the necessary rejection of background events while remaining reasonably e cient for the signal b-quark events.

This discussion should not be closed without underlying that the results presented in Refs. [1, 8] can be considered only as the starting points for more re ned and detailed investigations.
