# Standard M odel H igher O rder C orrections to the W W =W W Z Vertex

#### Abstract

U sing the $S\{m$ atrix pinch technique we obtain to one loop order gauge independent $W W^{+}$and ZW $W^{+}$vertices in the context of the standard $m$ odel, $w$ ith all incom ing $m$ om enta o \{shell. We show that the vertices so constructed satisfy sim ple QED \{like W ard identities. T hese gauge invariant vertices give rise to expressions for the $m$ agnetic dipole and electric quadrupole form factors of the $W$ gauge boson, which, un like previous treatm ents, satisfy the crucialproperties of in frared niteness and perturbative unitarity.


## IN TRODUCTION

A new and largely unexplored frontier on which the ongoing search for new physics will soon focus is the study of the structure of the three-boson couplings $\left[\left[_{1}^{1}\right)\right.$. In the above form ula term s which are odd under the individual discrete sym $m$ etries of $C, P$, or $T$ have been om itted. The fourm om enta $Q$ and are related to the incom ing $m$ om enta $q_{1} p_{1}$ and $p_{2}$ of the gauge bosons $V ; W$ and $W^{+}$respectively, by $q=2 Q, p_{1}=Q$ and $p_{2}=Q . T h e$ form factors v and Q v , also de ned as

In the context of the standard $m$ odel, their canonical, tree level values, are $\mathrm{f}=1$ and $\quad \mathrm{v}=\mathrm{Q}_{\mathrm{v}}=0$. To determ ine the radiative corrections to these quantities one $m$ ust cast the resulting one\{loop expressions in the follow ing form :

C alculating the one-loop expressions for v and Q v is a non-trivialtask, both from the technicaland the conceptualpoint ofview. Ifone calculates just the Feynm an diagram scontributing to the $W^{+} W$ vertex and then extracts from them the contributions to and $Q$, one arrives at expressions that are plagued with several pathologies, gauge-dependence being one of them. Indeed, even if the two W are considered to be on shell, since the incom ing photon is not, there is no a priori reason why a gauge-independent answer should em erge. In the context of the renorm alizableR gauges the nalansw er depends on the choice of the gauge xing param eter, which enters into the one-loop calculations through the gauge-boson propagators (W, Z, , and unphysical scalar particles). In addition, as shown by an explicit calculation perform ed in the Feynm an gauge ( $=1$ ), the answer for is infrared divergent and violates perturbative unitarity, e.g. it grow s m onotonically for $Q^{2}$ ! 1 (7) . C learly, regardless of the $m$ easurability of quantities like
and $Q$, from the theoretical point of view one should at least be able to satisfy such crucial requirem ents as gauge-independence and infrared niteness, when calculating the $m$ odel's prediction for them. Indeed, all the above pathologies $m$ ay be circum vented if one adopts the pinch technique
(PT ), rst invented by C omw all ( $\overline{8}_{1}^{\prime}$ ). The application of this $m$ ethod gives rise to new expressions, ${ }^{\wedge}$ and ${ }^{-} \hat{Q}$, which are gauge xing param eter ( ) independent, ultraviolet and infrared nite, and well behaved for large $m$ om entum transfers $Q{ }^{2}(\underline{\underline{q}} \mathbf{( 9 )}$.

## I. THEPINCHTECHNIQUE

The sim plest exam ple that dem onstrates how the P T w orks is the ghon tw o point function (1-1). C onsider the $S-m$ atrix elem ent $T$ for the elastic scattering such as $q_{1} q_{2}!q_{1} q_{2}, w h e r e q_{1}, q_{2}$ are two on-shell test quarks w th $m$ asses $m_{1}$ and $\mathrm{m}_{2}$. To any order in perturbation theory T is independent of the gauge xing param eter. On the other hand, as an explicit calculation show s , the conventionally de ned proper self-energy depends on . At the one loop level this dependence is canceled by contributions from other graphs, which, at rst glance, do not seem to be propagator-like. That this cancllation m ust occur and can be em ployed to de ne a gauge-independent selfenergy, is evident from the decom position:

where the function $T_{0}\left(t_{;}\right)$depends kinem atically only on the $M$ andelstam variable $t=\left(\hat{p}_{1} \quad p_{1}\right)^{2}=q^{2}$, and not on $s=\left(p_{1}+p_{2}\right)^{2}$ or on the extemal $m$ asses. Typically, selfenergy, vertex, and box diagram s contribute to $T_{0}$, $T_{1}, T_{2}$, and $T_{3}$, respectively. Such contributions are dependent, in general. H ow ever, as the sum $\mathrm{T}\left(\mathrm{s} ; \boldsymbol{t} ; \mathrm{m}_{1} ; \mathrm{m}_{2}\right)$ is gauge-independent, it is easy to show that Eq $(\underline{9}, \underline{9})$ can be recast in the form

where the $\hat{T}_{i}(i=0 ; 1 ; 2 ; 3)$ are individually -independent. The propagatorlike parts of vertex and box graphs which enforce the gauge independence of $T_{0}(t)$, are called pinch parts. They em erge every tim e a ghion propagator or an elem entary three-ghon vertex contributes a longitudinalk to the original graph's num erator. The action of such a term is to trigger an elem entary $W$ ard identity of the form

$w$ hen it gets contracted with a $m$ atrix. The rst term rem oves (pinches out) the intemal ferm ion propagator, whereas the second vanishes on shell. From the gauge-independent functions $\hat{T_{i}}(i=0 ; 1 ; 2 ; 3)$ one $m$ ay now extract a gauge-independent e ective ghon (G) self-energy ${ }^{\wedge}$ (q), gauge-independent $G q_{i} q_{i}$ vertices ${ }^{\wedge}{ }^{(i)}$, and a gauge-independent box $\hat{B}$, in the follow ing way:

$w$ here $u_{i}$ are the extemal spinors, and $g$ is the gauge coupling. Since all hatted quantities in the above form ula are gauge-independent, their explicit form $m$ ay be calculated using any value of the gauge- xing param eter, as long as one properly identi es and allots all relevant pinch contributions. T he choige $=1$ simpli es the calculations signi cantly, since it elim inates the longitudinal part of the ghon propagator. Therefore, for $=1$ the pinch contributions originate only from m om enta carried by the elem entary threeghon vertex $T$ he one-loop expression for ${ }^{\wedge} \quad(\mathrm{q})$ is given by (1]) :

$T$ his procedure can be extended to an arbitrary $n$-point fiunction; ofparticular physical interest are the gauge-independent three and four point functions

$F$ inally, the generalization of the $P T$ to the case of non-conserved extemal currents is technically $m$ ore involved (13). . Them ain reasons are the follow ing:
(a) The charged $W$ couples to ferm ions $w$ th di erent, non-vanishing $m$ asses $m_{i} ; \mathrm{m}_{j} \in 0$, and consequently the elem entary $W$ ard identity ofEq. (11 in gets modi ed to :

are the chirality pro jection operators. The rst two term sofeq (2012) w illpinch and vanish on shell, respectively, as they did before. But in addition, a term proportional to $m{ }_{i} P_{L} \quad m{ }_{j} P_{R}$ is left over. In a general $R$ gauge such term $s$ give rise to extra propagator and vertex-like contributions, not present in the m assless case.
(b) Additional graphs involving the \unphysical" would-be G oldstone bosons and , and physical H iggs $H$, which do not couple to $m$ assless ferm ions, $m$ ust now be included. Such graphs give rise to new pinch contributions, even in the Feynm an gauge, due to the $m$ om enta carried by interaction vertioes such as ${ }^{+}, Z^{+}, W^{+}, H^{+}$, e.g. vertices $w$ ith one vector gauge boson and two scalar bosons.

## II. THECURRENTALGEBRA FORMULATION OF THEPINCH TECHN IQUE

We now present an altemative formulation of the PT introduced in the context of the standard $m$ odel (14). In this approach the interaction of gauge bosons with extemal ferm ions is expressed in term s of current correlation functions [15), i.e. $m$ atrix elem ents of Fourier transform $s$ of tim e-ordered products of current operators. This is particularly econom icalbecause these am plitudes autom atically include several closely related Feynm an diagram s. w hen one of the current operators is contracted with the appropriate feurm om entum, a W ard identity is triggered. The pinch part is then identi ed $w$ ith the contributions involving the equal-time com $m$ utators in the $w$ ard identities, and therefore involve am plitudes in which the num ber of current
operators has been decreased by one or m ore. A basic ingredient in this form ulation are the follow ing equal-tim e com $m$ utators;

$W$ hen an appropriate $m$ om entum, say $k$, from the vertex is pushed into the integral over $d x$, it gets transform ed into a covariant derivative $\frac{d}{d x}$ acting on the tim e ordered product $<\mathrm{f} \ddagger{ }_{\mathrm{J}}\left[\mathrm{J}_{\mathrm{W}}{ }^{\mathrm{Y}}(\mathrm{x}) \mathrm{J}_{\mathrm{W}}(0)\right] \mathbb{j}>$. A fter using current conservation and di erentiating the -fiunction term s , im plicit in the de nition of the $T$ product, we end up with the left-hand side of the second of $\mathrm{Eq}(22)$. So, the contribution of each such term is proportional to the $m$ atrix elem ent of a single current operator, nam ely < $\mathrm{f} \mathrm{J}_{3}$ 屰 $>$; this is precisely the pinch part. O bviously, the integral in Eq(2) is the generalization of the Q CD expression Eq (1-5) to the case ofm assive gauge bosons.
III. GAUGE\{INVARIANTGAUGEBOSON VERTICESANDTHEIR WARD IDENTITIES

W e consider the $S-m$ atrix elem ent for the process

$w$ ith $(s ; i)=(; W)$ or $(; Z)$ and explicitly depend on $i$. On the other hand, the propagators of the ferm ions (quarks and leptons), as well as the propagator of the physicalH iggs particle are i-independent at tree-level.

Since the nal result (with pinch contributions included) is gaugeindependent, we choose to work in the Feynm an gauge ( $i=1$ ); this particular gauge sim pli es the calculations because it rem oves all longitudinal parts from the tree-level gauge boson propagators. So, pinch contributions can only originate from appropriate $m$ om enta fumished by the tree\{level gauge boson vertioes. A pplying the pinch technique algorithm we isolate all vertex $\{$ like parts contained in the box diagram s and allot them to the usual vertex graphs. The nal expressions for one loop gauge-independent trilinear gauge boson vertioes are :

T hese W I are the one\{loop generalizations of the respective tree level W I; their validity is crucial for the gauge independence of the $S\{\mathrm{~m}$ atrix. It is im portant to em phasize that they $m$ ake no reference to ghost term $s$, unlike the corresponding Slavnov-T aylor identities satis ed by the conventional, gauge\{ dependent vertioes.

For the case of on $\left\{\right.$ shell W s one sets $\mathrm{p}_{1}^{2}=\mathrm{p}_{2}^{2}=\mathrm{M}_{\mathrm{W}}^{2}$ and neglects allterm s proportional to $p_{1}$ and $p_{2}$, as well as the left over pinch term $s$ of the $W$ legs. Then the $W$ W vertex reduces to the form

[^1]Having constructed the gauge-independent W W vertex we proceed to extract its contributions to the $m$ agnetic dipole and electric quadrupole form
factors of the $W$. W e use carets to denote the gauge independent one\{loop contributions. C learly,

The task of actually calculating $\wedge$ and $\widehat{Q}$ is greatly facilitated by the fact that the quantities $\quad(=1)$ and $Q^{(=1)}$ have already been calculated in $\left(\bar{I}_{1}\right)$. It $m$ ust be em phasized how ever that the expression for $\quad(=1)$ (but not $Q^{(=1)}$ ) is infrared divergent for $Q^{2} \in 0$ due to the presence of the follow ing double integral over the Feynm an param eters $(t, a)$, given in Eq. $(26)$ of $\left.\underline{T}_{1}\right)$ :

It is im portant to notice that even though $Q^{P}=0$ both $w$ and $Q_{w} w$ ill assum e values di erent than those predicted in the $=1$ gauge. Indeed, even though the value of does not change, the value of changes, and this change a ects_both $w$ and $Q_{w}$ through Eq( $\left.\overline{\mathbf{L}_{1}^{\prime}}\right)$ and $E q\left(\frac{1}{1}\right)$. In the expression given in $E q(5 \underline{d})$ the rst tem (for $V=Z$ ) is infrared nite ( $\operatorname{since} M_{z} \in 0$ ), whereas the second term (for $\mathrm{V}=$ ) is infrared divergent, since $\mathrm{M}=0$. C alling this second term we have

B oth $Q^{(=1)}$ and $\quad(=1)$ have been com puted num erically in $\left(\bar{T}_{1}\right)$. Setting $=\left(\right.$ () ${ }^{\wedge}$ we have:

The double integral $z$ can in principle be expressed in a closed form in term $s$ of Spence functions [see for exam ple ( $1 \underline{\text { G }}$ )], but this is of lim ited usefulness for our present calculation. Instead, we evaluated this integral num erically. W e used the sam e values for the constants appearing in our calculations as in (근), nam ely $\quad=\frac{1}{128}, M_{\mathrm{w}}=80: 6 \mathrm{G} \mathrm{eV}, \mathrm{M}_{\mathrm{z}}=91: 1 \mathrm{GeV}$ and $s=0: 23$.

The result of the com putation is very interesting. ${ }^{\mathrm{P}}$, which originates from pinching box diagram $s$, fumishes exactly the contributions needed to restore the unitarity of the nalanswer. Indeed, as the authors of $\bar{T}, \bar{\prime})$ em phasized, $\quad(=1)$ is by itself not a gauge invariant ob ject in the lim it $Q^{2}!1$, where the localSU (2) $U$ (1) sym $m$ etry is restored. For large values of $Q^{2}$,
${ }^{P}$ is nearly equal in $m$ agnitude and opposite in sign to ${ }^{P}$. Therefore,
 as $Q^{2}$ ! 1 . C learly, the inclusion of the pinch parts from the box graphs is crucial for restoring the good asym ptotic behavior of the $W$ form factors.
V. CONCLUSION S

W e presented a study of the structure of trilinear gauge boson vertioes in the context of the standard $m$ odel. $U$ sing the $S$-m atrix pinch technique gauge-independent W W and Z W W vertices were constructed to one-loop order, $w$ ith all three incom ing $m$ om enta o -shell. T hese vertices satisfy naive Q ED \{likeW ard identities, which relate them to the gauge independent $W$ selfenergy, which w ere also obtained via the pinch technique. T he tree-levelW ard identities are to be contrasted $w$ th the com plicated $W$ ard identities satis ed by the conventionally de ned gauge-dependent vertices; in particular, no ghost term s need be included. Finally, when the appropriate Lorentz structures are extracted, these vertices give rise to gauge-independent, in frared nite, and asym ptotically well-behaved magnetic dipole and electric quadrupole form factors for the W, which can, at least in principle, be prom oted to physical observables. It would be interesting to determ ine how these quantities could be directly extracted from future $\mathrm{e}^{+} \mathrm{e}$ experim ents.
