Ferm ionic D ispersion Relations in the Standard M odel at F inite Tem perature

A bstract

We compute the one-loop dispersion relations at nite temperature for quarks, charged leptons and neutrinos in the M inim al Standard M odel. The dispersion relations are calculated in two di erent plasm a situations: for a vacuum expectation value of the Higgs eld \Leftrightarrow 0 (broken electroweak symmetry) and for = 0 (unbroken electroweak symmetry). The avour and chiralnon-degeneracy of the quasi-particle spectrum is studied. Numerical results show that the therm all ective m asses for fermions in the broken phase have a smaller value than those in the unbroken phase. The temperature dependence of the top quark and electron neutrino therm all electron masses is also presented. G auge invariance of one-loop dispersion relations is studied.

1 Introduction

The behaviour of the plasm a in the high tem perature regin e plays a fundam ental role in the attempts to explain several puzzles in cosm ology, as for example the present baryon asymmetry of the universe [1, 2] in the electroweak scenario. W hen the tem perature of the universe (T) was near the critical one of the cosmological electroweak phase transition $(T_{\rm c})$, the dynamics of the plasma was governed by the interactions of the M inim al Standard M odel (M SM). It is now well known that the interaction of a ferm ion with the therm all background in a plasm a modi es the poles of the ferm ion propagator with respect to those at tree level. In a pioneering work $[\beta]$, W eldon studied the modi cation of the ferm ion dispersion relation, i.e. poles of the ferm ion propagator, due to high tem perature e ects for a chirally invariant gauge theory (for instance, QCD or QED with massless ferm ions). In the same work, he showed that for a chirally invariant gauge theory with parity violation, as is the case for the SU $(2)_{L}$ $U(1)_r m odel_r$ the dispersion relations for the right- and left-handed massless ferm ions are independent. This decoupling in plies that the therm all elective ferm ion masses, de ned as the energy values for zero m om entum, are di erent.

For a parity preserving gauge theory at nite tem perature, the ferm ion dispersion relation has two possible solutions. These solutions (branches in the phase space), both of positive energy, describe the propagation of the ferm ionic excitations of the plasm a (quasi-particles) through the therm alm edium. In the literature, these solutions are generally known as norm aland abnorm albranches. Each point of a branch corresponds to the energy and momentum values of a quasiparticle. The quasi-particles described by the normal branch (quasi-ferm ions) have the helicity equal to their chirality, while those described by the abnorm al branch (quasi-holes) have the helicity opposite to their chirality. This was studied in detail by W eldon for massless quarks in QCD [4, 5] and by P isarski for light massive fermions in QCD/QED [6]. The normal branch is so called because it becomes the ordinary ferm ionic branch at large momentum (large mass), $k (M_f) > qT$, where q stands for the coupling constant and M_f for the ferm ion mass. The abnormal branch owes its name to the fact that it appears as an additional physical solution only if tem perature e ects are taken into account. Quasi-particles relect a collective behaviour of the plasma system at low mom enta [7]. The collective behaviour of the quasi-holes only exists for k < qT, where their creation probabilities are non-zero. Moreover, the QCD/QED quasiholes are physically possible for $M_f < gT$ and they disappear from the spectrum for M $_{\rm f}$ ' T [6,8].

The theoretical expectation that a cosm obgical electroweak phase transition [9] took place during the cooling of the early universe ism otivated by the existence of the electroweak spontaneous symmetry breaking (ESSB) in the MSM and its extensions. The idea of the electroweak phase transition in the framework of the MSM allows the consideration of the two following phases. For T > T_c , the

gauge sym m etry of the ferm ion elds is SU (3)_C SU (2)_L U (1)_R, = 0 and the plasm a scenario is the electrow eak unbroken phase. For $T < T_C$, the electrow eak sym m etry SU (2)_L U (1)_R is spontaneously broken. The gauge sym m etry of the ferm ion elds is SU (3)_C U (1)_{EM}, \Leftrightarrow 0, and the plasm a scenario is the electrow eak broken phase.

Fermionic excitations are present in both electroweak phases of the plasma. The spectrum of quasi-particles can be obtained from the therm al loop contribution to the ferm ion self-energy. The energy of the quasi-particles is of order g_sT. Quasi-particles, during their propagation in the plasma, scatter with the therm alm edium and this phenom enon induces a damping rate [10]. This is proportional to the in aginary part of the self-energy [11]. The energy of the quasi-particles com pared to is large and it is thus possible to speak about the existence of quasi-particles as coherent excited states. Quasi-particles have a -1=2 and they can eventually turn into a new state, which is out nite lifetim e of phase with the initial one. If the group velocity is $\frac{1}{2}$, the mean free path is $\frac{1}{2}$. The quantum spatial coherence, i.e. the phase relation between points separated by a distance jv = 2, is lost [2, 12]. Since we are interested in obtaining the branches which describe the quasi-particles, only the real part of the one-bop contribution to the self-energy will be calculated.

The main purpose of the present work is to compute exactly the one-bop dispersion relations for the di erent ferm ion sectors of the M SM for the following situations of the plasm a: for the electrow eak broken phase and for the electrow eak unbroken one. We study num erically the behaviour of the norm aland abnorm al branches taking into account all terms in the ferm ion $\mathfrak{self-energy}^3$. The avour and chiral non-degeneracy of the quasi-particle spectrum is studied. Our attention is focused in the low-m om entum regim e where collective phenom ena develop. Since mass and T corrections are considered num erically, we obtain a novel result, namely that therm all ective masses for ferm ions have a lower value in the broken phase than in the unbroken one. The existence of a similar shift was observed in [13] where, through a lattice calculation, it was found that therm al e ective masses for massive bosons are smaller than those for massless bosons. We also con m the particular behaviour of the branches in the broken phase found in [1, 2]: at variance with what happens in the unbroken phase, an energy gap of order M_f is obtained between the two branches that now have hyperbolic form. This behaviour is crucial for the mechanism of electroweak baryogenesis produced at the scattering of quasi-particles o the boundary created during the rst order electroweak phase transition.

The T dependence for the top quark dispersion relations in the broken phase and for the neutrino dispersion relations in both phases is also studied. We

have found, for the top quark, that the therm all elective mass for two of the four branches can have negative value for T M_t . In order to study the gauge independence of the dispersion relations, we compare one-loop computations in Feynm an and Landau gauges. The dispersion relations are only gauge independent at leading order.

In section 2, we de ne the ferm ion dispersion relations for the di erent types of gauge theories involved in the calculations. In section 3, the generic gauge boson and scalar diagram s of F ig. 2 are calculated in the Feynm an gauge and the real part of the nite temperature contribution to the ferm ion self-energy is given. In section 4, the Lorentz-invariant functions for quarks, charged leptons and neutrinos in the M SM are calculated and the corresponding dispersion relations in both phases are derived. In section 5, we study in detail the gauge invariance for the one-loop dispersion relations for massless and massive quarks in QCD. The results are extended to the M SM dispersion relations. Num erical results of the dispersion relation computations are presented in section 6. Our conclusions are sum marized in section 7. Results about the calculation of the real part of the ferm ion self-energy in the Landau gauge are presented in Appendix B. In Appendix C, the Lorentz-invariant functions calculated in the Landau gauge are also presented.

2 Some useful de nitions

The ferm ionic dispersion relations, for the di erent cases in which the chiral and parity symmetry are preserved or violated by a gauge theory, are presented in this section. The ferm ionic spectrum of the quasi-particles in a plasma is described by the branches obtained from the ferm ion dispersion relation, which is derived from the real part of the therm al contribution to the self-energy. The ferm ion self-energy is written as a linear combination of the matrices 1, k, u and ku, where u is the four-velocity of the plasma, with u u = 1, and K is the ferm ion m on entum. In the one-loop calculation, ku term s are not generated and the real part of the therm al contribution to the ferm ion self-energy, for a gauge theory with parity and chirality violations, has the following form [3]:

where L $\frac{1}{2}(1 \ _5)$ and R $\frac{1}{2}(1 + _5)$ are the left- and right-handed chiral projectors respectively, and M _I is the ferm ion mass. The functions a_L , a_R , b_L , b_R , c_L and c_R are the chiral projections of the Lorentz-invariant functions a, b, c de ned in the following way:

In the rest fram e of the plasm a u = (1;0), Eq. (2.11) leads to the ferm ion dispersion relation for a gauge theory with chiral and parity violations (for instance, the M SM after the ESSB):

Equation (2.12) describes in a coupled way the behaviour of the left and right components. This equation is of fourth order in !, so that for each value of k there are four solutions for !. Therefore four branches (two norm al and two abnorm al) in the phase space are obtained from the dispersion relation. It is not possible to associate a speci c chirality with the quasi-particles because the chiral symmetry is broken.

For massless ferm ions, the chiral symmetry is preserved by the theory. The functions $_{\rm L}$ and $_{\rm R}$ in (2.11) are equal to zero and the poles of the propagator are found from ${\rm L}^2<^2=0$. Thus, for a chirally invariant theory with parity

violation, as is the case of the M SM $\,$ before the ESSB, the dispersion relations are given by

Left- and right-handed components now obey decoupled relations. Equations (2.13) and (2.14) are of second order in !; as a consequence, for each momentum value k there are two values of ! re-solving each equation. For each ferm ion chirality, two branches (one norm all and one abnorm all) are solutions of the dispersion relation. Four branches describe the ferm ionic quasi-particles of the plasm a. The quasi-particles have a specie c chirality, in contrast with what happens in the chiral violation case.

For a parity-symmetric gauge theory, the projections of the Lorentz-invariant functions over the left- and right-handed components coincide. Setting $a_L = a_R = a$, $b_L = b_R = b$ and $c_L = c_R = c$ in (2.12), the dispersion relation for a parity-invariant gauge theory with chirality violation (for instance, QCD with m assive quarks) is obtained:

The left- and right-handed components of the dispersion relation are superimposed in this case, and the ferm ionic excitations are only described by two branches.

If chiral symmetry is preserved by a parity-invariant gauge theory, as is the case of QCD with massless quarks, the dispersion relation is given by (2.15), with M $_{\rm I} = 0$,

3 Real part of the ferm ion self-energy

The nite temperature contribution of the one-loop ferm ion self-energy is calculated in this section. The MSM Feynm an diagram s that contribute to the one-loop ferm ion self-energy have the form of the generic diagram s of Figs. 1 and 2. These generic diagram s are calculated, in the Feynm an gauge, using the realtime form alism of therm all eld theory [14]. It is straightforward to see that tadpole diagram s represented by Fig. 1 only contribute to the imaginary part of the self-energy, as is shown in Appendix A. The diagram s that contribute to the realpart of the self-energy are represented by the generic diagram s of Fig. 2. To calculate the poles of the ferm ion propagator, we are only interested in the contribution to the realpart of the ferm ion self-energy from these diagram s. The sam e calculation is also perform ed in the Landau gauge (Appendix B). Finite tem perature Feynman rules for vertices are the same as those in the M SM at T = 0, while the therm alpropagators form assive ferm ions S (p), massive gauge bosons D (p) and massive scalar bosons D (p) are given by

where g is the coupling constant and C_c is the quadratic C asim ir invariant of the re-presentation. The contribution to the ferm ion self-energy from the generic scalar boson diagram shown in Fig.2b has the same form as the gauge boson contribution. The factor $2g^2C_c$ in (3.9) is replaced by $jl^2 j C_{L,R}^0$, where l is the Yukawa coupling constant and $C_{L,R}^0$ are given in terms of the matrices of C lebsch-G ordan coecients ⁱ. The generic scalar boson contribution for left and right chiralities is proportional to $({}^{i}{}^{i}{}^{y})_{m\,m^0}$ $C_{L,m\,m^0}^0$ and $({}^{iy}{}^{i}{}^{i})_{nn^0}$ C_{R,nn^0}^0 respectively [3].

where the Lorentz-invariant functions a(!;k);b(!;k) and c(!;k) can be written in terms of their chiral projections, as was shown in (2.2)–(2.4), and M_I is the mass of the external ferm ion.

Since each one-bop diagram contribution to the real part of the ferm ion selfenergy is proportional to the generic gauge boson contribution (3.9), it is possible to write x

where the Lorentz-invariant functions are obtained by adding up the contributions n coming from each diagram involved in the calculation; M_1 and M_2 refer to the internal ferm ion and to the boson m ass of the loop diagram, respectively.

4 Ferm ionic dispersion relations

In this section, the one-loop dispersion relations at nite temperature for quarks, charged leptons and neutrinos in the MSM are derived. The chiral projections of the Lorentz-invariant functions in the broken and in the unbroken phases are calculated following the procedure explained in the last section. The unbroken phase Lorentz-invariant functions calculated in the Landau gauge are presented in Appendix C.

In the M SM , the W and Z gauge bosons and the ferm ions acquire m ass after the ESSB. These m asses are written as functions of in the form : $M_W^2 = g^2 {}^2=4$, $M_Z^2 = (g^2 + g^{12})^2=4$ and $M_F^2 = l_F^2 {}^2=2$, where g and g^0 are the gauge coupling constant stants of SU (2)_L and U (1)_Y respectively and l_F is the Yukawa coupling constant

of the ferm ion F to the H iggs boson. The mass of the H iggs boson is M $_{\rm H}^2 = {}^2=2$, where is a free parameter of the H iggs potential. The therm ald ependence of the boson and ferm ion masses is given through by (T) ' $_0$ (1 T²=T_c²)¹⁼², where T_c 100 G eV is the critical temperature of the electroweak phase transition and $_0 = 246$ G eV is the vacuum expectation value of the H iggs eld at T = 0. The latter expression is valid for values of T near and below T_c.

4.1 Quark dispersion relations

As we have already mentioned, the damping rate of the quasi-particles in the plasma is proportional to the imaginary part of the ferm ion self-energy. The damping rate is induced by the incoherent scattering of the quasi-particles with the therm alm edium. The scattering of the quasi-particles associated to quarks is generated by the strong and electroweak therm al interactions. The most im – portant contribution to the damping rate com es from QCD therm al interactions. It has been calculated at leading order for zero quasi-particle momentum in [11] giving: $_{QCD} = 0.15 \text{g}^2\text{T}$, i.e. 19 GeV at T = 100 GeV, where g is the strong coupling constant.

Assuming that, in the vicinity of k = 0, the damping rate is not changed appreciably by the electroweak thermal interactions, the nite lifetime of the 1=40 G eV¹. Since the group velocity is quasi-particles is 1=3, the mean free 1=120 G eV¹. Thus, the quantum spatial coherence is lost for points path is separated by a distance $1=120 \text{ GeV}^{-1}$. We show below that the electroweak corrections to the branches for light quarks are of the order of the quark m asses M_{T} . Thus, the imaginary part of the QCD self-energy is much larger than the electroweak contributions to the real part of the self-energy for all quarks but the top. This means that coherent electroweak quantum phenomena associated to quarks (for instance, CP violation) cannot take place in the plasm a because the lifetime of the quasi-particles is very small with respect to the characteristic time of the electroweak processes [2, 12]. W hen a quasi-particle scatters, the electroweak coherence is lost.

4.1.1 Broken phase

The therm all background interacting with quarks in the plasma is constituted by massive quarks of three avours with colour charge, massive Higgs bosons, massive W and Z gauge bosons, photons and gluons. Quarks of electric charge 2=3 are called up quarks and those of electric charge 1=3 down quarks. The one-bop diagrams with photon, gluon, Z gauge boson, neutral G oldstone and Higgs boson, which contribute to the quark self-energy, do not induce a change of avour in the quark. The diagram swith an exchange of charged G oldstone and W gauge bosons induce a avour change in the incoming quark I to a di erent outgoing quark F. In the latter contributions, the avour i of the internal quark (inside the bop) runs over the up or down quark avours according to the type of the external quark (outside the bop). The one-bop contribution from gauge boson and scalar boson to the real part of the self-energy gives

where K represents the Cabibbo-Kobayashi-Maskawa (CKM) matrix, I is de ned as $I = M I = M_W$, g is the weak coupling constant, Q_I is the quark charge and $s_W (c_W)$ is the sine (cosine) of the electroweak mixing angle W. The Yukawa coupling constant l_I is related to I through $l_I = g I = 2$. The substitution of the expressions (4.1)-(4.3) in (2.12) results in a non-diagonal matrix because of the presence of mixing in the CKM matrix. From the quark dispersion relation obtained, the branches are computed. The mass non-degeneracy of the quark spectrum and the di erent Yukawa coupling constants for the distinct quark avours introduce the avour non-degeneracy of the branches. The branches associated to each quark avour are di erent because of the presence of M I, I, Q_I and the CKM matrix in (4.1)-(4.3).

The spectrum of quasi-particles for massive quarks with only QCD interactions was studied in [6, 8]. The quasi-particles are described by one norm al and one abnorm albranch. If electroweak e ects are introduced, as they are here, the m entioned spectrum is modiled in a complicated way. Although the electroweak corrections are quantitatively small for all avours but the top, some important consequences are derived from these elects. In particularly, as was explained in section 2, four branches are present (two norm all and two abnorm all) instead of the two QCD ones. The four branches for the s and c quarks are shown in F igs. 3 and 4. Because the chiral symmletry of the theory with massive quarks is broken, it is impossible to associate a specil c chirality to the branches. The top quark acquires a large mass during the electroweak phase transition. We note a particular behaviour of the top quark branches with the T variation: a couple of branches lowers down appreciably as T is lowered (M_t increases) as is shown in F ig. 5, by means of the T variation of the top quark branches, we will rst study the much simpler QCD case.

It is very easy to check that (4.1)-(4.3) reduce to QCD functions when g is xed to zero in the coe cients (4.4)-(4.9). That is for a $_L = a_R = a$, $b_L = b_R = b$, $c_L = c_R = c$,

For values of k close to zero, the normal branch is above $(M_{I}^{2} + 4M_{Lead}^{2})^{1=2} = 2$ by $M_{I} = 2$ while the abnormal one is below that value by the same amount. The separation between the branches is M_{I} and this increases with the quark mass. When the electroweak corrections are taken into account, a similar electric is also present. An energy gap of order M_{I} appears between the minimum and the maximum of the hyperbolic branches (see Figs. 3 and 4). If the quark mass is large, the energy gap is larger than the separation between the thermal electrive masses. As a consequence, the norm all and abnorm all branches with the same therm all elective m as appear closer. For some T, the therm all elective m ass of sm aller energy can be negative, as is suggested by Fig. 5.

M one works about the dispersion relation for massive quarks in QCD can be found in the literature. Analytic expressions for the dispersion relation were calculated, in the lim it M $_{\rm I}^2 + k^2 >> M _{\rm Lead}^2$, by Seibert [15]. In the lim it M $_{\rm I}^2 >> M _{\rm Lead}^2$ as was done in [16], the approximation for the dispersion relation $!^2 = k^2 + M _{\rm I}^2 + M _{\rm Lead}^2$ is valid. The properties of the quark spectrum were studied by Lebedev and Sm ilga [17] considering a dynam ical therm alm ass for the quarks in the træe-levelm atrix G reen's Functions.

4.2 Charged-lepton dispersion relations

The scattering between the quasi-particles associated to charged leptons and the them alm edium is governed by the weak and electrom agnetic them al interactions. It is expected for k = 0, in analogy with QCD calculations [11], that the damping rate at leading order originated only from weak or electrom agnetic them al interactions were $_{EW}$ gT. The weak and electrom agnetic leading contributions of the real part of the self-energy are both of order gT. This means that the energy of the quasi-particles, of order gT, is large in comparison with the damping rate, i.e. it contains one additional power of g. Thus, it is possible to speak of the existence of quasi-particles as coherent excited states. C oherent electroweak quantum phenomena associated to charged leptons can take place in the plasm a because the lifetime of the quasi-particles is of the order of the characteristic time of the electroweak processes.

The therm all background interacting with charged leptons in the plasma is constituted by massive charged leptons of avour e, massless neutrinos of avour e, massive Higgs bosons, massive W and Z gauge bosons and massless photons. The diagram s with charged G oldstone and W bosons change from the external charged lepton to the associated neutrino avour inside the loop. The spectrum of quasi-particles for charged leptons in QED was studied in [19]. For this case, the quasi-particles are described by one norm aland one abnormal branch, and left- and right-handed branches are superposed. The breaking of the parity symmetry by the weak interactions causes the doubling of the QED branches. Thus, for charged leptons in the MSM, the quasi-particles are described by two norm aland two abnormal branches, as is shown in Fig. 6 for the lepton. As in the quark case in the broken phase, an energy gap between the hyperbolic branches appears.

Following a procedure analogous to the one performed for massive quarks in QCD, the Lorentz-invariant functions for massive electrons in the QED case are obtained by turning o the weak interactions into the functions (4.33)-(4.35). The expressions derived are similar to expressions (4.10)-(4.12), with f⁰ changed to d and M_I to M_e. The analytic form of the two branches, for k << T, is given by (4.13) and (4.14).

Some aspects of the dispersion relation for massive electrons in QED have been studied at nite temperature, considering an elective chemical potential in [20, 21]. The spectrum of quasi-particles in a hot relativistic electron plasm a was studied in [22], where it is shown num erically that the full spectral weight is not gauge independent. By comparing one-loop computations in the Feynm an and in the Coulomb gauges, it was shown in [22] that the location of well-de ned poles in the propagator is gauge independent at leading order since the poles correspond to physical excitations, while the widths of the quasi-particles are gauge dependent. The dispersion relation at zero temperature has been studied in [23].

The branches for massless charged leptons are computed from the dispersion relation derived by substituting (4.41)–(4.44) in (2.13) and (2.14). Two norm all branches (one for each chirality) and two abnorm albranches (one for each chirality) describe quasi-particles and quasi-holes respectively (see Fig. 6). The quasi-particle spectrum is avour non-degenerate, but, because $\frac{2}{e}$ in (4.45) and (4.46) is so sm all for all charged lepton avours, the di erences between avours are very sm all. The type of quasi-particle characterized by the abnorm albranch has been called the \plasm ino" by B raaten and P isarski [24]. 4.3 Neutrino dispersion relations

The damping rate of quasi-particles associated to neutrinos is induced by the weak them al interactions. In analogy with the assumption in the charged-lepton case, the damping rate (leading order) of neutrino quasi-particles for k = 0 is $_{EW}$ g^2T . The weak leading contribution of the real part of the self-energy is of order gT. The energy of the quasi-particles, of order gT, compared to the damping rate is large. The quasi-particles exist as coherent excited states. Coherent weak quantum phenomena associated with neutrinos can take place in the plasm a because the lifetime of the quasi-particles is of the order of the characteristic time of the weak processes.

4.3.1 Broken phase

The therm all background interacting with neutrinos in the plasm a is constituted by massless neutrinos of avour e, massive charged leptons of avour e and massive W and Z gauge bosons. The one-loop contribution from scalar and gauge boson sectors to the real part of the self-energy lead to

where $_{e} = M_{e}=M_{W}$. The projection of the Lorentz-invariant functions is only over the left-handed component. Substituting (4.47) and (4.48) in (2.13), the branches are computed from the dispersion relation obtained. A norm al and an abnorm albranches of left-handed chirality describe the quasi-particles as is shown in Fig. 7. F lavour non-degeneracy exists from the mass non-degeneracy present in (4.47) and (4.48), for di erent neutrino avours. Because $M_{e} << M_{W}$ in the integrals of (4.47) and (4.48), the di erences for di erent avours are very sm all.

The neutrino dispersion relation presented here was studied by D 'O livo, N ieves and To-mes in [25] for temperatures of the plasm a much lower than the W and Z m asses. This approximation allows to neglect the thermal dependence for the gauge boson propagators. These authors performed the calculation in a general gauge and they found that the neutrino self-energy depends on the gauge parameter, but the dispersion relation is independent at leading order in $g^2=M_W^2$. Several works, previous to [25], on this subject can be found in the literature. In [26, 27], the same calculation was performed but using the unitary gauge. The computation of the neutrino thermal self-energy was considered in [28, 29].

4.3.2 Unbroken phase

Expressions (4.47) and (4.48) with gauge boson masses equal to zero reduce to the left-handed projection of the Lorentz-invariant functions in the unbroken phase:

and an abnorm albranch of left-handed chirality describe the quasi-particles (see Fig. 7). The quasi-particle spectrum is avour non-degenerate, but, since $\frac{2}{e}$ is very sm all for all neutrino avours, the di erences for the di erent avours are very sm all. The variation with the tem perature of the therm all elective m asses for both phases is presented in Fig. 8.

The branches for left-handed neutrinos are the sam e as those for left-handed charged leptons. This result rejects the presence of the SU $(2)_L$ symmetry in the MSM before the ESSB. The neutrino dispersion relation in the unbroken phase was considered with a non-zero chemical potential in [30]. The sam e authors in a later work [31] studied the dispersion relation in the case where the charged leptons have a running m assolution using the renorm alization group equations.

5 Remarks about gauge invariance

The gauge invariance of the one-loop dispersion relations presented in this work is studied in this section. The num erical results for the dispersion relations have been obtained considering all the terms in the Lorentz-invariant functions (3.18)-(3.20). This fact implies the introduction of a sm all gauge dependence originated from the non-leading order term softhe ferm ion self-energy [32]. These, in turn, lead to sub-leading contributions to the dispersion relations. Indeed, by confronting QCD computations in the Feynm an and Landau gauges, we show that the sub-leading contributions to the dispersion relations are gauge dependent. We also study the e ect of these contributions in our num erical results.

In Appendix B, we calculate the nite temperature contribution to the onebop real part of the ferm ion self-energy in the Landau gauge Re $^{\circ}$ (K). We show in (B.4) that it is possible to write: Re 05 (K) = Re 0 (K) + Re 0 (K), where $R e^{-0}$ (K) is the real part of the therm alcontribution to the self-energy in the Feynm an gauge (3.8) and Re^{-0} (K) is the real part of the gauge dependent therm al contribution of Re 0 (K) (B.5). The W ard identities ensure that the gauge dependent contribution disappears if the external leg is projected on the zeroth order pole [32]. This can easily be seen because Re^{-0} (K) can be written as proportional to ₩ M_{α} . In QCD at nite temperature, for instance, the shift of the quark propagator pole position with respect to the pole position at zero tem perature is of order $q_s T$. This means that the argument of the integral in (B.5) is proportional to $q_s T$, for this case, because this integral is proportional M_{a} . Consequently, the Re⁰ (K) contribution to the dispersion relation to ⊯ is of a higher order in g_s with respect to the Re $\,^0(\!K\,)$ contribution.

For example, in the QCD case for massless quarks, Re 0 (K) vanishes on the zeroth order pole corresponding to ! = 0, for k = 0. So, Re 0 (K) contribution is a non-leading order in !=T. These non-leading order contributions lead to a sub-leading contributions to the therm all elective mass. This fact can be guessed because the leg projection on the rst order pole means !=T g. This conclusion is in accordance with [32], where it is formally shown that nonleading contributions to the quark self-energy allow gauge dependent sub-leading modi cations to the dispersion relation.

Let us now show in an explicit calculation that the non-leading contributions to the one-loop QCD self-energy are sub-leading in the dispersion relations. By comparing one-loop computations in the Feynm an and in the Landau gauge for massless and for massive quarks, we will show that indeed the sub-leading contributions to the dispersion relations are gauge dependent. First, we consider massless quarks in QCD. The Lorentz-invariant functions in the Feynm an gauge (3.18) and (3.19) for this case are

For k ! 0, the integrals I_1 , I_2 , I_3 can be written as $I_i(!;k;T) = kF_i(!;T) + O(k^3)$, where i = 1;2;3. The reason of this is that (5.3)-(5.5) are antisymmetric for the change k ! k. It was not possible for us to obtain analytic expressions for the integrals (5.3)-(5.5). They were computed numerically for dienent values of !, k and T, in the limit k ! 0. By means of a t of the numerical results obtained, we have found an analytical form for the integrals. Numerically we have proved that $(!I_1 2\xi) = O(k^3)$, i.e. $(!F_1 2F_3) = 0$. For this reason

The inclusion of non-leading contributions leads to increase M $_{Lead}$ by 2.223%. We have checked the validity of expressions (5.11) and (5.12) by comparing the results obtained from them with the results obtained by means of the exact numerical solution of the dispersion relations. The relative error of the results obtained from (5.11) and (5.12) is smaller than 0.01% with respect to the exact numerical results. Given the t (5.10), the solution of (5.8) can be well approximated by

Expanding the root square in (5.13), we can see that the non-leading terms of the quark self-energy modify M $_{\text{Lead}}$ as / $g_s^{(n)}T$, with (n = 3;5;:::), in accordance with the conclusions given in [32].

where A (0;0) and B (0;0) are given by (3.21) and (3.22) with $M_1 = M_2 = 0$. The integrals A_0 (0;0) and B_0 (0;0) are given by (B.9) and (B.10) with $M_1 = 0$. Substituting (5.14) and (5.15) into (2.16), we compute the quark dispersion relations in the Landau gauge. These dispersion relations coincide with those at leading order O (g_sT) in the Feynm an gauge, as is shown in Fig. 9. In other words, the Lorentz-invariant functions (5.14) and (5.15) reduce to the analytical form of (4.21) and (4.22) with $L_{1F} = 4g_s^2 = 3$. This means that non-leading contributions of A (0;0) and B (0;0) in (5.14) and (5.15) are canceled exactly by A_0 (0;0) and $B_0(0;0)$ contributions, respectively. For k << !, we have analytically proved this fact. For the Landau gauge, the gauge dependent parameter in (5.10) is zero. This result indicates that the one-loop dispersion relations are only gauge invariant at leading order O ($g_s T$) [3, 33]. As the therm al in aginary part of the one-bop self-energy contains only non-leading term s, it is highly gauge dependent. For a consistent calculation of this part, it is necessary to go to the in aginary time form alism of the therm al eld theory and to use P isarski's method for resum m ing therm al loops [11, 34].

W e will now study the massive quark case in QCD. The Lorentz-invariant functions in the Feynman gauge (3.18)–(3.20) contain terms dependent of M $_q$. For the case M $_q << !$, it is possible to neglect⁵ M $_q$ in the logarithm ic integrals, following the same arguments as given in [8].

The dispersion relations given by (4.13) and (4.14), with M de ned by (5.20), contain all T contributions from the one-loop self-energy. We have also checked the validity of these analytical dispersion relations by comparing the results obtained from them with those obtained sol-ving num erically the dispersion relations. For $M_q < M_{Lead}=20$, the relative error is sm aller than 0.01%.

The quark dispersion relations in the Landau gauge are computed inserting (5. 21)-(5. 23) into (2. 15). These dispersion relations coincide with those obtained at leading order in the Feynman gauge, as is shown in Fig. 10. The gauge dependent parameters and in (5. 20) are zero in the Landau gauge computation; consequently, the massive quark dispersion relations are gauge invariant at leading order in temperature O (g_sT) and in mass O (M_q).

The inclusion of the non-leading one-loop contributions changes the leading therm ale ectivem assess according to the quark mass. For instance, the change in the leading therm ale ective masses for the c quark at T = 100 GeV are: $M_+ = 0.0202M_+$ and $M_- = 0.0241M_-$. For the s quark, they are: $M_+ = 0.0220M_+$ and $M_- = 0.0224M_-$. Thus, the e ect of the sub-leading contributions to the dispersion relations is nearly 2% for the light quarks. We have not obtained a similar t of the therm ale ective masses as (5.20) for the heavy quark case. We have checked num erically for this case that the sub-leading contributions to the therm ale ective mass are small in comparison with the leading contributions.

For the M SM dispersion relations in the unbroken phase, the situation is quite similar to the QCD case for massless quarks. For instance, the thermal e ective masses including leading and non-leading contributions in the Feynman gauge are given by (see Eq. (5.10)):

In a similar way as the QCD case, the branches in the Landau gauge are superimposed on the Feynm an gauge branches at leading order. In consequence, the ferm ion dispersion relations in the unbroken phase are gauge invariant at leading order. The consideration of all terms in the quark self-energy introduces a small gauge dependence in the dispersion relations. Taking into account (5.24), the sub-leading contribution to the therm all elective mass in the Feynman gauge is

where ' 0.023 for this case. This contribution induces a gauge dependence in our num erical computations of nearly 2%. By the mentioned general considerations this sub-leading contribution is of order g_3^2 T in a general gauge.

The results obtained form assive quarks in QCD can be extended to the MSM in the broken case. The quark dispersion relations are gauge invariant at leading order in temperature and in quark mass. The non-leading order terms in the quark self-energy introduce a small gauge dependence in the dispersion relations. We have checked num erically that the thermal elective masses in the broken phase M $_{\rm LR}^{\rm b}$ can be written as:

In this equation x_z , x_H , x_W denote the e ect of the boson mass contributions on the therm all ective masses, being $0 < x_z$, x_H , $x_W << 1$. This fact permits

to understand why the therm all elective masses in the broken phase M $_{L,R}^{b}$ are smaller than those in the unbroken phase M $_{L,R}^{u}$. The sub-leading contribution to the therm all elective masses in the Feynman gauge, taking into account (5.27), is

inducing a gauge dependence in our num erical computations about 2% for the light quarks. Due the mentioned general grounds, the sub-leading contribution to the therm all elective masses is of order q_{q}^{2} [I M_{q}] for quarks, and of order

 \vec{g} [I M_e] for charged leptons and neutrinos in a general gauge.

It is easy to prove that the gauge dependence induced in the shift of the thermal elective masses between the two phases is smaller than the one mentioned above. The difference between the gauge dependent contributions to the thermal elective masses in a general gauge is of order $q_q^3M_q$ for quarks and of order

This gauge dependence is smaller than (5.26) and (5.31).

6 Num erical results

W enow give the num erical results we have obtained for the dispersion relations for up quarks (u;c;t), down quarks (d;s;b), charged leptons (e; ;) and neutrinos ($_{e}$; ;). For T = 100 G eV, the following values for the masses in G eV have been used: M_W = 52, M_Z = 59, M_H = 100, M_d = 0.006, M_s = 0.09, M_b = 2.9, M_u = 0.003, M_c = 1.0, M_t = 114.7, M_e = 0.0003, M = 0.069, M = 1.176 and m assless neutrinos. A swe have mentioned, we are specially interested in the low-momentum regime where the collective behaviour is present. A dequate boson and ferm ion mass values for each tem perature have been used, for the cases where the therm aldependence has been studied. The values of the coupling constants have been xed to $_{s} = 0.1$, $_{w} = 0.035$ for all tem peratures.

In Figs. 3 and 4, we show the branches for quarks s and c respectively in both phases. In the unbroken phase, the left-handed branches are above the right-handed ones. A lthough the branches in the broken phase are not associated to a speci c chirality, the num ber of branches is also four. W hile in the unbroken phase the left-handed abnorm all branch is crossed by the right-handed norm all branch, in the broken phase there is not crossing between the branches. In the broken phase, the branches that now have a hyperbolic form are separated between the minimum and the maximum by an energy gap of order M_f . The quasi-particle excitations cannot exist in this energy range.

The branches for each quark avour are di erent in the broken phase and clearly the ferm ionic spectrum described by them is avour non-degenerate. In the unbroken phase, the left-handed branches for the di erent quark avours are num erically the same in our computation, but a very small di erence should exist for them. The ferm ionic spectrum is avour non-degenerate, but the di erences for di erent avours are very small. The ferm ionic spectrum described by the right-handed branches is also avour non-degenerate in a sim ilar way to the lefthanded ferm ionic spectrum.

Since tem perature and m ass corrections are considered, the therm all elective m assess in the broken phase are smaller than those in the unbroken phase. For the s quark case, for instance (see Fig. 3), the therm all elective m ass of the left-handed branches in the unbroken phase is ' 51.4 GeV, while that for the corresponding branches in the broken phase is ' 50.0 GeV. The shift of the therm all elective m assess for the lower branches is also present, but is smaller. In our perturbative calculation, this elect can be understood through the presence of the m assive boson propagator (3.2) in the ferm ion self-energy. This discontinuity of the therm all electroweak phase transition has recently been noted in [13]. In this reference, using a num erical simulation of the phase transition in the SU (2) Higgs m odel on the lattice, was found that the therm all elective m ass for the broken phase than in the unbroken one.

The dependence with T of the top quark them all elective masses for the branches in the broken phase is presented in Fig. 5. Two branches go down appreciably as the tem perature is lowered (M t increases). For T below 120 GeV, these branches can become unphysical as is suggested by this gure.⁶ The special behaviour of the top quark branches is obtained because this quark acquire a large mass during the electroweak phase transition.

The branches for the lepton are shown in Fig. 6. An energy gap between the hyperbolic branches in the broken phase is also present. As in the quark case, the therm all elective masses for charged leptons in the broken phase are smaller than those in the unbroken one. In the broken phase, the branches for each avour are di erent and consequently the fermionic spectrum is avour non-degenerate. In the unbroken phase, the branches of a speci c chirality are the same for di erent avours within the precision of the present com putation. The fermionic spectrum described is avour non-degenerate, but the di erences for di erent avours are very small.

The branches for the electron neutrino are shown in Fig. 7. There are only two branches because the left-handed chirality of the neutrino. In both phases, the branches for di erent avours are the same in our computations. However, the

ferm ionic spectrum is avour non-degenerate, in both phases, but the di erences are very small for di erent avours. The therm all ective masses for neutrinos in the broken phase are smaller than those in the unbroken one. The T dependence of the electron neutrino therm all ective mass is presented in Fig.8. The therm all ective mass is zero for T = 0, as can be concluded from this gure.

7 Conclusions

O ne-loop dispersion relations for the di erent ferm ionic sectors of the M SM were obtained. The calculation was performed in the real time form alism of the therm all eld theory, in the Feynman gauge. Numerical results were presented for temperatures of the plasma near the critical one of the electroweak phase transition. For all the ferm ions in the broken phase and in the unbroken one, the ferm ionic spectrum described by the branches of the dispersion relations is avour non-degenerate.

In the unbroken phase, the ferm ionic quasi-particles can be associated to a speci c chirality because the chiral symmetry is preserved by the M SM before the ESSB. Since the chiral symmetry is violated by the M SM after the ESSB, the quasi-particles cannot be associated to a speci c chirality in the broken phase for the case of massive ferm ions. The number of branches for quarks and charged leptons is four in both phases, while it is only two for neutrinos.

The therm all elective m assess for all ferm ions in the broken phase are smaller than those in the unbroken one. The existence of this shift for the therm all elective m assess can be understood through the presence of the massive boson propagators in the ferm ion self-energy. A similar shift for the W and Higgs boson therm all elective mass has recently been observed in [13], but through a nonperturbative lattice calculation. For quarks and charged leptons in the broken phase, an energy gap of order M_f was obtained between the branches that have a hyperbolic form. This gap appears as a consequence of the electrow eak contributions to the dispersion relations.

The T dependence of the therm ale extive m asses for the top quark and for the electron neutrino was studied num erically. The results for the massive top quark suggest that two branches become unphysical in the broken phase for T < 120 GeV.

We have studied the gauge dependence of the dispersion relations for the massless and massive quark cases in QCD by confronting computations in the Feynm an and the Landau gauges. We have found for both cases that the dispersion relations in the Landau gauge are equal to those obtained at leading order in the Feynm an gauge.

The ferm ion dispersion relations in the MSM include leading and sub-leading

contributions. For the unbroken phase, in a similar way as the massless QCD case, the branches in the Landau gauge are superimposed on the Feynman gauge branches at leading order. Consequently, the ferm ion dispersion relations are gauge invariant at leading order. The consideration of the non-leading terms in the ferm ion self-energy introduces a small sub-leading gauge dependence in the dispersion relations. General considerations indicate that the sub-leading contribution to the therm all ective masses, in a general gauge, is of order $q_i^2 T$ for quarks and $g_i^2 T$ for charged leptons and neutrinos. Particularly, the sub-leading contribution in the Feynman gauge is $M_{L,R}^u = M_{L,R}^{u(Lead)}$ for the quark case, where $M_{L,R}^{u(Lead)}$ is the thermal ective mass at leading order in the unbroken phase (see Eqs. (5.25)) and ' 0.023. The sub-leading contribution induces a gauge dependence in our num erical computations of nearly 2%.

The ferm ion dispersion relations in the broken phase are gauge invariant at leading order in temperature and in ferm ion mass. The small sub-leading contribution to the dispersion relation is gauge dependent. On general grounds, the sub-leading contribution to the therm all ective masses, in a general gauge, is of order q_s^3 [T M_q] for quarks, and of order q_s^3 [T M_e] for charged leptons and neutrinos. The sub-leading contribution in the Feynman gauge is $M_{L,R}^{b}$ (M_q) = $M_{L,R}^{b(\text{Lead})}$ 1 $\frac{M_q}{2T}$ + $\frac{M_q^2}{4T}$, where $M_{L,R}^{b(\text{Lead})}$ are the therm all ective masses at leading order in the broken phase (see Eq. (5. 29)), and the gauge parameters ' 0:023 and ' 0:14. The gauge dependence induced in our num erical computations is about 2% for the light quark case.

The gauge dependence induced in the shift of the therm all elective m asses between the two phases is smaller than the one mentioned above. The dilerence between the gauge dependent contributions to the therm all elective masses in a general gauge is of order $q_{\rm M}^3 M_{\rm q}$ for quarks and of order $q_{\rm M}^3 M_{\rm e}$ for charged leptons and neutrinos. This dilerence for light quarks in the Feynman gauge is: $M_{\rm L,R}^{\rm u} = M_{\rm L,R}^{\rm b}$, $M_{\rm L,R}^{\rm b(Lead)} \frac{M_{\rm q}}{2T} = \frac{M_{\rm q}^2}{4T}$. In our num erical computations is true that $M_{\rm L}^{\rm u} = M_{\rm L}^{\rm b} < < M_{\rm L}^{\rm u}$, showing that the gauge dependence in the shift is very small.

The argument of the delta-D irac functions of the expressions (A.4) and (A.5) have the zeros when $p_0 = (jp_1^2 + M_1^2)^{1=2} = I$. When we integrate over p_0 , we obtain the positive and the negative contributions of I. Immediately, one can see that (A.5) is zero and the integral (A.4) is seen to be zero after the angular integration. It is direct to prove that if we take the trace of (A.3), the result vanishes. As a consequence, the contribution of the Z-tadpole diagram to the real part of the ferm ionic therm al self-energy is zero. This result di ers from that given in [25], where the tadpole diagram contributes to the real part of the method there was de ned without the absolute value that we used in (3.6).




Figure 1: Generic Z-tadpole diagram




Figure 2: Generic gauge and scalar boson diagram s





Figure 3: D ispersion relations at T = 100 GeV for the s quark in the broken (solid curves) and the unbroken (dotted curves) phases, neglecting quark m ixing. The upper (lower) dotted curves correspond to left (right) chirality branches. An energy gap (' 0:1 GeV) appears between the minimum and maximum of the hyperbolic branches.




Figure 5: Variation with temperature of the therm all electrice m asses for the top quark in the broken phase.




Figure 6: D is persion relations at T = 150 GeV for the lepton in the broken (solid curves) and the unbroken (dashed curves).




Figure 7: D ispersion relations at T = 150 GeV for the electron neutrino in the broken (solid curves) and the unbroken (dashed curves) phases.





Figure 8: Variation with temperature of the electron-neutrino therm all electron masses for the broken (solid curves) and unbroken (dotted curves) phases




Figure 10: Norm albranch for them assive b quark in QCD computed for three different cases at T = 100 GeV. The lower dashed curve is computed in the Feynm an gauge considering only the leading O (T^2) contribution to the self-energy (leading curve). The upper dashed curve corresponds to the results in the Feynm an gauge considering all the contributions to the self-energy (Feynm an curve). The solid curve is computed in the Landau gauge also considering all the contributions (Landau curve). The leading and Landau curves are superimposed.
