E lectrow eak P recision D ata and a H eavy Z $^{\rm 0}$

Abstract

We consider the physics of an extra U (1) gauge boson Z⁰, which can m ix with Z through interm ediate ferm ion bops. The bop contribution due to the heavy top quark signi cantly a ects the bw-energy observables, and for m_{Z⁰} > m_Z, one can always adjust the shifts in these observables to be in the right direction suggested by experiments, when we impose the anomaly cancellation conditions for Z⁰.

W ith the ever-increasing precision of the electroweak experiments, some disturbing signatures about the validity of the Standard M odel (SM) are com – ing into view. M ost notable among them are (i) $R_b = (Z \ bb) = (Z \ bd)$ hadrons), (ii) the left-right asymmetry A_{LR} measured at SLAC, and (iii) the

-polarization asymmetry, P . At the same time, observables such as the total Z -width, $_{\rm Z}$, and the hadronic cross section at the Z -peak, $_{\rm had}$, are so well measured that arbitrary extensions of the SM are severely constrained. Am ong the non-supersymmetric extensions, technicolor is struggling to make itself compatible with the oblique electroweak parameters, R_b, and the FCNC data, and is not yet convincingly successful; extra fermion generations do not seem to resolve the discrepancies in the measured values of the abovem entioned quantities, and are also restricted by the oblique parameters S and T. It has been shown [1] that addition of any number of arbitrary scalar representations, satisfying the constraints on and on asymptotic unitarity, invariably worsens the discrepancy in R_b, and is totally insensitive to A_{LR}.

The only physically interesting choice that remains is the addition of one or more extra gauge bosons. Holdom [2] and Caravaglios and Ross [3] have already discussed that possibility in the literature. Both of these references add an extra neutral gauge boson Z^{0} to the SM particle spectra. W hile Holdom has considered a tree-level mixing between Z and Z^{0} , Caravaglios and Ross have focussed on the Born graph of $e^{+}e^{-1}$ ff mediated by Z^{0} . However, the Z^{0} ff couplings derived from the experimentally measured parameters are not free from anomaly, and thus one has to add extra ferm ions to the model. These ferm ions not only contribute to the oblique parameters, but m ay also introduce signi cant bop corrections to the observables, thus making the whole pattern of the new couplings som ewhat confusing, and at the worst case, untraceable. The oblique parameters are also a ected by a tree-level $Z = Z^0$ m ixing.

The important point stressed by Caravaglios and Ross is that one needs an imaginary amplitude coming from new physics elects to give a nonzero interference with the SM amplitude. In other words, the real part of the new physics amplitude does not contribute to physical observables if $M_{new} f$ $M_{SM} f$. To satisfy this property, the authors in ref. [3] have considered a Z⁰ nearly degenerate with Z so that both Z and Z⁰ propagators are imaginary (apart from a factor of ig). However, the Z lineshape and _z, asm easured at LEP, are in such conform ity with the SM that the Z⁰e⁺ e coupling has to be unreasonably sm all compared to the Z⁰th coupling, whose value is xed from the measurement of R_b. Unless there is some strong logic (as suggested in ref. [2]) which forbids Z⁰ to couple with the rst two ferm ion generations (in the weak eigenbasis), such a model, according to our view, seem s to be quite arti cial.

In this letter we consider what we think to be a much more realistic scenario. We assume that there is only one neutral U (1) gauge boson Z^0 . There exists a number of models which predict such a Z^0 , though their properties vary with the models chosen. We want to make an analysis which is su – ciently model-independent, except the existence of a Z^0 , which is the common factor among these variety of models. A swe do not con ne ourselves within a particular model, our results are more qualitative than quantitative and

to be taken as trends. However, in nearly all the cases, the trends are in conform ity with the experimental data.

Even in perform ing a general analysis, one requires som e sort of a guideline, and fortunately, the Z⁰-physics is so well-studied that we have quite a Z^0 few of them. For example, Langacker and Luo [4] have shown that a Z m ixing at tree-level, if exists, is bound to be very sm all (less than 1%). Thus one does not m ake any great error in neglecting the tree-level Z Z⁰ m ixing altogether; moreover, it keeps the oblique parameters una ected by Z 0 . Another quideline is the condition that Z⁰-current is to be anom aly-free, and if one does not want to extend the ferm ion spectrum, it in poses some restriction on the Z 0 ff couplings. Thus, our study will be a general one except the in position of these two constraints. There also exists a mass bound on Z^{0} : for a Z⁰ with SM couplings to the ferm ions, the mass limit (at 95% CL) is 412 GeV (from direct search in pp colliders) and 779 GeV (from electroweak t to the LEP data) [5]. If the Z⁰ff couplings do not m in ic the SM ones, these lim its may not be valid (e.g., Z^0 which couples only to the third generation ferm ions). However, there is no reason for Z⁰ to be nearly degenerate with Z, and we will drop this assumption made in ref. [3].

One notes that if $m_{z^0} \notin m_z$, the only way to have a non-vanishing interference term is to consider a Z Z^0 m ixing mediated by ferm ion loops, as shown in g.1. This is similar to the well-studied Z m ixing; while the latter e ects are subtracted from experimental measurements, the former e ects are not, and so the concerned amplitude is a coherent sum of two amplitudes: pure SM electroweak, and that arising from new physics. As

the loop contribution is proportional to m_f^2 , only the top loop is considered. Note that the two-loop Z Z^0 Z amplitude is real and hence does not a loct the interference term.

First, let us consider a toy model in which Z^0 couples only to the third generation. This will help us to understand the trend. The SM amplitude of e^+e ! ff is

and the new physics am plitude is

where the conventional Z ff vector and axialvector couplings are denoted by g_V^f and g_A^f respectively, and analogous quantities for the Z ⁰qq vertex (we will always use q to denote a third generation ferm ion) are denoted by $g_V^{q 0}$ and $g_A^{q 0}$ (thus, the Z ⁰qq vertex factor is given by (g=2 cos _W) ($g_V^{q 0}$ ($g_V^{q 0}$ ($g_V^{q 0}$). We neglect the QED terms in the amplitudes. At the Z -peak, one has

where $= m_{z^{0}} = m_{z}$ (as we are not on the Z^{0} -peak, z^{0} can be neglected), and f is the two-point loop integral given in Appendix 1. W ith $m_{t} = 175$ GeV [6] and taking the QCD corrections into account, we get

W ith $g_V^{t\,0}$, $g_A^{t\,0}$ and of the order of unity, $jr_2=r_1 j$ is of the order of 0.1, so it is justiable to neglect the $jr_2 f$ contributions. We have also neglected the QCD and the electroweak corrections to the internal top loop, as well as the threshold elects of 0 (${}^2_s m_t^2$), and have only taken the corrections to the external fermions into account. This introduces an error of at most two to three per cent and as we mainly concentrate on the qualitative features, the approximation is a good one. A nyway, the quantitative results are hardly a ected. We note that it is the massive top quark that makes the interference amplitude non-negligible.

The cross-section with initially polarized electron beam com es out to be

where A is a num erical constant (= $m_z^2 = 64^{-2}$), and T_1 , T_2 are given by

In the above form ulae, N_c is the relevant color factor, which is 1 for leptons and $3(1 + {}_{s}(\mathfrak{m}_{Z}^{2}))^{-1} + 1:409 {}_{s}^{2}(\mathfrak{m}_{Z}^{2})^{-2} = 12:77 {}_{s}^{3}(\mathfrak{m}_{Z}^{2})^{-3})$ for quarks. The right- and the left-handed ferm ion couplings are related to the vector and axialvector couplings in the conventional way:

From eqs. (6) and (7), it is clear that only those observables which involve third generation ferm ions in the nal state will be modi ed. Thus,

the forward-backward electron asymmetry $A_{\rm F\,B}^{\,e}$ or the partial width $\,$ (Z $\,!$ $e^{\scriptscriptstyle +}\,e$) retain their SM values, while observables like $_{\rm Z}$, $A_{\rm FB}^{\rm b}$, P , $R_{\rm b}$ (and other partial widths) will have contributions coming from the Z Z^0 m ixing. Low -energy observables are not sensitive to this mixing as the Z -propagator, ig , is real, and the interference term vanishes. Lepton univerapart from sality is also not respected in this model. The expressions for the modi ed observables follow immediately from eqs. (1) and (2); however, they do not throw much light on the nature of the modi cation, as one has to take account of seven arbitrary Z⁰qq couplings (three in the lepton sector and four in the quark sector). Here we impose the condition that the Z $^{\rm 0}$ current has to be anom aly free. This assures that no new ferm ions are required in the model and eq. (5) remains unchanged. A simple way to do that is to take the new couplings proportional to the hypercharge Y of the corresponding ferm ions (this is, by no means, the only choice). Denoting this proportionality constant by a, we obtain

The total e^+e^- annihilation cross-section at $s = m_z^2$ changes by an amount , which is also a measure of the change in $_z$. With the couplings given

in eq. (11), this change com es out to be

where we have taken G = 1:16639 10 5 GeV 2 , m_z = 91:189 GeV and z = $\frac{SM}{Z}$ = 2:497 GeV. Note that eq. (12) is independent of the sign of a; this is because Z ⁰qq couplings always com e in pair, one being the internal Z ⁰tt coupling. It depends on the sign of , and for m $_{z^{0}} > m_{z}$, the deviation is positive. From the experimental bound

which, for a = 1, yields m $_{Z^{\circ}}$ 181 G eV. The change in the hadronic cross-section is

which is well within the allowed lim it, and can be used to nd the change in $R_{\rm b}$:

The SM value of R_b , 0.2156, is for $m_t = 175$ GeV and takes the two-bop corrections induced by the heavy top quark into account [7]. Branching fraction for charm, R_c , is reduced, but not very signi cantly:

The change in forward-backward basymmetry is small, and negative:

whereas for the -lepton, the fractional change in the left-right asymmetry $A_{LR} = A_{LR}$ is negative, and thus more than resolves the discrepancy of the experimental value with the SM prediction:

We note that in all these cases, the changes are in the right direction, and more often than not, are in the right ballpark. However, the leptonuniversality breaking ratio, $(Z ! ^{+})=(Z ! e^{+} e)$, does not allow such a high value of $a^{2}=(1 ^{2})$:

A loo, the e ective number of light neutrino species is enhanced, but within the allowed lim it:

Thus, the upper bound of $a^2 = (1 \ ^2)$ is one order of magnitude smaller than that allowed by $_z$. As Holdom has pointed out [2], if the Z⁰⁺ coupling is dominantly vectorial in nature, the bounds obtained from the last two equations can be evaded.

From eqs. (6) and (7), it is evident that A_{LR} does not change. This motivates us to move to our second model, where Z^{0} couples to all the known fermions. The condition of anomaly cancellation hints to a coupling pattern as shown in eq. (11), but the a's may be different for different generations. Thus, we are introducing three new parameters in this case compared to one

in the earlier case. Evidently, it will be easier to m atch the experim ental data by adjusting these parameters; on the other hand, predictive power of the m odel will be som ew hat lost. How ever, there are certain m odel-independent facts which one should take into account.

First, the Born graph, e^+e^- ! ff mediated by Z⁰, will not contribute to the interference, and therefore the new physics contribution to the treelevel amplitude will be suppressed by a factor of $1=^2$. Second, if all the a_i 's (i = 1;2;3) are same, there will be no lepton non-universality, and it is possible to tune the a_i 's in such a way that the non-universality remains within the allowed limit, while keeping other predictions more or less intact. Third, even for > 1, the shift in the total cross-section at the Z-peak, tot, can be either positive or negative.

Eqs. (6) and (7) are now modied to

First let us assume, for simplicity, $a_1 = a_2 = a_3 = a$. The limiting value of $a^2 = (1 \quad 2)$, as obtained from z = z, is more constrained compared to model 1:

leading to m_{Z^0} 446 GeV for a = 1. Unfortunately, A_{LR} is negative (= 0:0065), and so this choice fails to be the desired one. However, if one puts $a_1 = a_2 = a_3 = a$, the total cross-section decreases (for > 1), and from the experimental bound, one obtains

which explains the trend of the SLAC result perfectly.

O nem ust comment about the other observables, none of which are much a ected, due to the highly constrained value of $a^2=1$ ². The change in R_b, for the latter choice of a's, is positive, and the result is in agreement with the experimental data.

Thus, both these models allow FCNC processes, forbidden in the SM.For the second model, one needs di erent a_i 's (and thus the maximum splitting between the a_i 's can be restricted). The processes now allowed include G \mathbb{M} – violating Z -decays, and tree-level B_d B_d (and B_s B_s) mixing. However, the inherent uncertainties limit the usefulness of such processes in detecting a new gauge boson indirectly.

In this letter, we show that the trend of som e of the present experim ental data, which may indicate a deviation from the SM, can be explained by

considering a heavy neutral gauge boson Z^{0} . A crucial role is played by the heavy top quark which ensures a signi cant contribution from the interference term in the e⁺ e ! ff am plitude. Twom odels are considered; one in which Z^{0} couples only to the third generation ferm ions and another in which it couples to all the three generations. The rst model allows a lower value of m $_{Z^{0}}$. Guided by the anom aly cancellation conditions of the new gauge boson, we not that the shifts in the measured observables are always in the right direction. We expect that these results may motivate a search, direct or indirect, for Z^{0} in the future colliders.

- 2. The two-point gauge boson vacuum polarization diagram .




