SPECTRA OF BARYONS CONTAINING TW O HEAVY QUARKS

ABSTRACT

The spectra of baryons containing two heavy quarks test the form of the QQ potential through the spin-averaged masses and hyper ne splittings. The mass splittings in these spectra are calculated in a nonrelativistic potential model and the e ects of varying the potential studied. The simple description in terms of light quark and pointlike diquark is not yet valid for realistic heavy quark masses.

It is well-known that the quarkonium (and) spectra test the QCD potential between quark and antiquark. In this case, a phenom enological avor-independent potential and a QCD -derived hyper ne interaction can be used to describe the masses and splittings of the cc and bom esons [1]. Furtherm ore, such models allow predictions to be made for the unobserved states in the spectra [2] and for the B_c system [3]. In the same e way, the doubly-heavy baryons (those containing ccq or bbq) test the potential between two quarks. The one-gluon-exchange potential between heavy quarks di ers from the quark-antiquark potential by a relative color factor 2. This relation does not hold at higher orders: the one-loop corrections to the QQ and QQ potentials are not equal [4]. The con ning potential, which is determined phenom enologically, should be studied for QQ interactions as it has been for QQ.

Tests of the QQ potential can be implemented not only in the spin-averaged spectra of the doubly-heavy baryons, but also by studying the hyper ne splittings of these particles. This is surprising, as the hyper ne interactions contain two types of terms: those describing the spin-spin interaction between the heavy quarks ($1=m_Q^2$), which depend on the QQ potential analogously to the quarkonium case, and those describing the spin-spin interactions between heavy and light quarks ($1=m_Q m_q$), which m ight be thought to depend on the light-heavy quark interaction and not signi cantly on the heavy-heavy quark potential. Nevertheless, the wave function of the light quark depends su ciently on the heavy quark pair to provide information on the QQ binding.

Baryon spectroscopy with non-relativistic potential models is relatively accurate, although not perfect. The method is clearly limited by its use of a non-relativistic treatment of the light quarks. Nonetheless, such models provide a relatively good description of the baryon spectra and stable predictions for the hyper ne splittings $_{\rm Q}$ and $_{\rm Q}$ for the baryons containing one heavy quark [7]. One potential choice which provides a good t to the observed baryon spectrum is the power-law form [8]:

The light and strange quark masses and the power are held xed at reasonable values, and the parameters A, B, and C are obtained from a t to the masses of the N, , and . The charm and bottom quark masses are t to the $_{\rm c}$ and $_{\rm b}$. This potential, when rescaled by the relative color factor of 2 between QQ and QQ one-gluon exchange, ts the J= and spin-averaged spectra as well. Such power-law potentials are familiar from the description of QQ bound states [9] and give the

choice of used above. The value of C given above is how ever significantly larger than that obtained from a t to the $J= \{ c \text{ hyper ne splitting, which is } 1.172 [8].$

A lthough this potential to the known baryon spectrum, it is not convenient for study of the e ects on the spectra of variation of the QQ potential. In particular, it is interesting to be able to vary separately the C oulom b-like sm all distance contribution to the potential and the long-distance con ning term. The potential between light and heavy quarks is therefore left as in Eq. (1), while the QQ interaction is replaced with the C ornell form [10]:

The parameters a, k, and c are obtained from a to the J = and spectra, with the quark masses and <math>C held xed to the values given above. The e ects on the hyper ne splittings of sm all variations in a and k are then studied. These variations, as well as the power-law type potential given above, are plotted in Figure 1 for com parison.

In the limit of heavy quark mass, the heavy QQ pair is more easily excited to higher-energy states than the light quark. In the harm onic oscillator potential, for example, the ratio of the excitation energies for light and heavy degrees of freedom is

 $(2m_h + m_l)=3m_l$ [11]. The states considered here are those containing two identical heavy quarks (cc and bb rather than bc) in a relative S-wave state, so that Ferm i statistics require that the heavy quarks be in a spin-1 (symmetric) state. In the standard notation the lowest-energy states for QQu or QQd are $_{QQ}$ ($_{QQ}$) for spin 1/2 (3/2), and for QQs they are denoted by $_{QQ}$ ($_{QQ}$). The heavy-heavy hyper ne term s cancel in the di erence between spin-3/2 and 1/2 states as the expectation value of the spin-spin operator, < $\sim_1 _2 \sim$ >, is identical for these two cases. The hyper ne splittings discussed below thus originate solely from the light-heavy quark interactions. Three di erent m ass splittings are considered here for each com bination of heavy and light quark avors. The rst is the di erence between the centers-ofm ass of the states in which the QQ pair is in 2S and 1S states. The other two are the hyper ne splittings between the spin-3/2 and spin-1/2 baryons for the 2S and 1S QQ con gurations.

Once the potentials are set, the solution of the three-body problem can be approached using a variety of num erical methods [11]. The Born-Oppenheim er method is an e cient solution method for the case of two heavy and one light quark. The wavefunction is split into heavy- and light-quark degrees of freedom,

where is the distance between the two heavy quarks (m_1 and m_2), and \sim =

 $(r_3 \quad R_{12})^{q} \quad \overline{m_3 (m_1 + m_2)} = {}_{12} (m_1 + m_2 + m_3)$ is proportional to the distance between the light quark m_3 and the center-of-m ass R_{12} of the heavy-quark pair. This choice of variables separates the non-relativistic kinetic energy term s: $p_1^2 = (2m_1) + p_2^2 = (2m_2) + p_3^2 = (2m_3) = [p^2 + p^2] = (2_{12})$, where $_{12}$ is the reduced m ass of the two heavy quarks. The dependence on the light-quark m ass has been absorbed into the de nition of . The light quark wavefunction f is found for xed

where r_{i3} is the distance between the light quark and heavy quark i. The energy of the QQq state is approximated by:

Keeping only the zeroth term in the expansion of corresponds to the so-called \uncoupled adiabatic" [12] approximation.

The Born-Oppenheimer method integrates over the distances between the heavy quarks in the second step (Eq. (5)), so that the above approximation diers from that in which the heavy-quark pair behaves as a spin-one pointlike diquark, as it would for in nitely heavy quark mass. Because this method does not depend on the limit of in nite m_Q, it works well already for the charmed baryons. In the limit m_{1,2} m₃ these equations approach the expected form : The distances r_{i3} in Eq. (4) are independent of the quark masses, and the term $p^2=2_{12}$! $p_3^2=2m_3$, so that the light-quark wavefunction is independent of the distance between the heavy quarks. Eq. (5) then reduces to the usual non-relativistic two-body equation. In the limit of in nite m_Q, the QQq spectra can be simply related to the meson spectra [5]. The splittings obtained in this way are how ever signi cantly smaller than those obtained from the potential model calculation, and the masses of the spin-averaged states som ewhat higher. This limit gives the values: M_{cc} = 3:811G eV, M_{cc} = 3:742 G eV, M_{bb} = 10:484 G eV, and M_{bb} = 10:460 G eV [6].

The C oulom b and linear term s in the Q Q potential are now varied by introducing parameters x_a and x_k :

which are varied between 0.8 and 1.2 to determ ine the e ect on the m ass di erences M (2S){M (1S), M (1S), and M (2S).Variations in c do not a ect the splittings, only the m asses them selves. Variations in C obviously cause proportional changes in the hyper ne splittings. The e ect of C on the 2S{1S m ass di erence com es from the

 $1=m_Q^2$ hyper ne term s only, and is small. These results of the x_a and x_k variations are presented in Table 1, along with the percent change 100 (M ($x_i = 12$) M ($x_i = 0.8$))= M ($x_i = 1$). The values for $x_a = x_k = 1$ are in agreement with previous calculations [14] when the power-law type potential is used for the QQ interaction.

The hyper ne splittings are analogous to those in a heavy-light meson system, so that in the limit of in nitely heavy m_Q they should approach =m_Q, where is independent of heavy-quark avor. The mass splittings in the table give (ccq,1S) = 0.242 and (bbq,1S) = 0.305. These states are not yet heavy enough to be accurately described by the simple heavy-quark limit. The values of extracted for these and for heavier masses are shown in Fig. 2, where may be seen to approach the heavy-mass limit for m_Q > 15{20 GeV. This is in contrast to what is known from meson spectroscopy, where the simple 1=m_Q description of the splittings works even for the strange quark. A lihough the masses of the diquarks are quite large ($2m_Q$), the radii for these states are also large for realistic quark masses, so that the simple application of the in nite-mass limit is not yet valid here. Typical radii < r> for QQ states are 2.4 GeV¹ for cc 1S, and 1.5 GeV¹ for bb 1S. For QQ states, typical radii are 1.7 GeV¹ for cc, and 1.0 GeV¹ for bb.

The percent changes in the mass splittings are given in Fig. 3 for QQq. The sensitivity of the QQs states to changes in the potential is almost exactly that of the QQq states. M (2S) {M (1S) is more sensitive to changes in the QQ potential than either of the hyper ne splittings. This mass di erence is essentially the mass splitting between the 1S and 2S states of the two-body QQ potential, so that the strong dependence here is unsurprising. The dependence of M (2S) {M (1S) on x_k is about one-quarter(half) that on x_a for the cc (bb) states. The bb pair is more closely bound than the cc so that these states depend more strongly on the Coulomb (x_k) part of the potential.

The hyper ne splitting in the 1S states, M (1S), depends more strongly on x $_a$ than on x_k for the ∞ case, and on x_k than on x_a for bb. The strong dependence of the bb 1S splitting on the Coulomb term in the potential rejects the closer binding of the b quarks. On the other hand, M (2S) depends in both cases more strongly on x_a than on x_k . This is a rejection of the larger radius (< r > 3.0 GeV 1) of the bb 2S state.

In conclusion, the spectra of doubly-heavy baryons have been studied in a non-relativistic potential model, with emphasis on the sensitivity of the mass splittings of these states to variations in the interaction between the two heavy quarks. A lthough the hyper ne splittings are between the two possible spin states of the light quark relative to a heavy spin-1 system, it was found that dependence on the QQ interaction remains. This dependence is however rather small. The 2S{1S mass di erence is more sensitive to variations in the potential than the hyper ne splittings. A com - parison of the splittings between the center-ofm ass of the 2S and 1S states and the

hyper ne splittings in these levels exhibits di erent dependences on the strengths of the separate parts of the potential (C oulomb vs.con ning term s). M ore importantly, it is demonstrated that the use of the in nitely heavy m_Q limit, where the heavy quarks form a pointlike diquark and the baryon as a whole a meson-like system, is not yet valid for realistic heavy quark masses.




