## Reheating the Post In ationary Universe

## Abstract

We consider the non-equilibrium evolution of the in aton eld coupled to both lighter scalars and fermions. The dissipational dynamics of this eld is studied and found to be quite di erent than that believed in in ationary models. In particular, the damping time scale for the expectation value of the zero momentum mode of the in aton can be much shorter than that given by the single particle decay rate when the in aton amplitudes are large, as in chaotic in ation scenarios. We nd that the reheating temperature may depart considerably from the usual estimates.

The Universe after in ation is a cold and dark place. The in ationary expansion phase has driven the matter and radiation energy densities down to almost zero. If we are to recover the Universe of the standard hot big bang model, som e source of energy (or perhaps more accurately, entropy) must be enlisted to retherm alize the Universe.

Once in ation has ended, the standard picture of in ation [1,2] has it that the zero momentum mode of the in atom eld oscillates about them in imum of its (e ective) potential. As it oscillates, the couplings of the in atom to lighter particles that would give rise to single particle decays induce a friction-like term, which in turn gives rise to dissipational dynam ics for the zero mode. This dissipation allows for the energy contained in the zero mode's oscillations to be used for the creation of light quanta which will eventually therm alize and allow the standard big bang picture to proceed [3].

This scenario has been questioned recently when it was realized that the evolution of the zero mode of the in atom induces large amplication of the quantum uctuations resulting in copious particle production [4{6]. We call this mechanism of particle production induced amplication. (In the case of exactly periodic elds this reduces to parametric resonance [9]). When the zero mode of the in atom eld has a large amplitude, this mechanism of induced amplication is much more e cient for particle production than single particle decay. In this letter we compare the time scales for damping and particle production for the mechanism s of induced amplication and single particle decay as well as the distribution of particles produced. It is important to understand the di erent processes, because these time scales determ ine the reheating temperature [1].

We consider the situation in which the in atom is coupled to lighter scalar and ferm ion elds and track the behavior of the expectation value the in atom zero mode, as well as the various modes of the lighter eld. We not that the modes of the lighter eld are not distributed therm ally, but are more skewed towards modes with momentum k = M. This may have implications for the therm alization phase of the reheating process. Interactions will tend to therm alize this spectrum to temperatures M. The case of coupling to ferm ions is qualitatively di erent > from the coupling to bosons because of Pauli blocking.

In both cases, we consider relaxation both in the linear regime, where the amplitude of the zero mode is not large and an amplitude expansion of the elective equation of motion can be used reliably, as well as non-linear relaxation, where the initial amplitude is large; this is typically the behavior of the in atom in chaotic in ationary models [7].

We use the techniques that we developed previously [6] to construct the electric equations of motion for the zero mode in the presence of uctuations due to the highermomentum modes. The reader is referred to this and for the or mode in good [8] for more details.

Throughout we will assume that the typical rates involved in the particle production process are much larger than the expansion rate of the Universe H; this allows us to restrict ourselves to the M inkowski space case.

Linear Relaxation of the In aton: Consider the following Lagrangian for the in ation a scalar and a fermion eld:

where , are the lighter degrees of freedom (M >> M ; M ). As in our previous work

[6] we write (x;t) = (t) + (x;t) where (t) is the expectation value of the zero mode of in the non-equilibrium density matrix and h (x;t)i = 0 [6]. The expectation value of the eld is assumed zero; this is consistent with the equations of motion. Following the form alism of [6], we arrive at the linearized, non-equilibrium equation of motion for (t):

The kernel r(t = t) is obtained in the loop expansion and is determined by the retarded self-energy. This self-energy needs appropriate substractions which are absorbed into mass and wave function renormalization. From now on, all masses and couplings will be the renormalized ones. We choose to start the evolution at t = 0 using the initial conditions

 $(0) = _{0}; -(0) = 0$ . This equation can be solved via the Laplace transform [6,8]. The inverse Laplace transform is performed along the B rom with contour and requires the identication of the singularities of the inverse propagator: G (s) =  $[s^{2} + M^{2} + _{r}(s)]^{1}$  where s is the Laplace transform variable. We have to distinguish di erent cases: i) U nbroken sym metry case: a) If y = 0, the lowest order contribution to  $_{r}$  (t  $t^{2}$ ) is given by the two-loop retarded self-energy which has a cut for  $s^{2} > (M + 2M)^{2}$ .

For weak coupling G (s) has a one-particle pole below the three particle threshold. The contribution of this pole gives oscillatory behavior of (t) with the period determ ined by the position of the pole. The contribution from the continuum to the long time dynam ics is determ ined by the behavior of the imaginary part of r near threshold and it yields a power law t<sup>3</sup> at long times for all non-zero masses. The imaginary part of the self-energy does not indicate exponential relaxation and although the amplitude of the oscillation damps out, it reaches a non-zero asymptotic limit at long times. It is straightforward to prove that the ratio of the am plitudes at two di erent times is a renorm alization group invariant [8]. b) If y for 0 then the kernel receives a contribution at one loop from the ferm ionantiferm ion interm ediate state. The self-energy has a cut beginning at  $s^2 =$ 4M<sup>2</sup>. If > 2M, the one-particle pole moves o the physical sheet into the second sheet and М for weak coupling, the spectral density has the Breit-W igner form with a narrow resonance at the renorm alized value of the scalar mass and width √<sup>2</sup>M =8 (for M м). The expectation value (t) now relaxes exponentially with a relaxation time  $t_{el} =$ <sup>1</sup>, for  $^{1}$  ln (M = ), but eventually the long time behavior is dominated by the behavior of t< the discontinuity of the imaginary part of the self energy near threshold leading to a t  $^{5-2}$ power law behavior. Two subtractions of the self-energy are needed, resulting in mass and wave function renormalization. If M < 2M there is a one-particle pole below the twoparticle threshold i.e. in the physical sheet, and the long time behavior of (t) is oscillatory with nonzero asymptotic amplitude. The continuum contribution falls o with the power law above. C learly an in aginary part for the self energy does not translate to exponential relaxation. ii) Spontaneously broken symmetry case: If  $M^2 = \frac{2}{3} < 0$ , the new minimum is at  $_0 = 6^2 =$ , and we write  $(x;t) = _0 + (t) + (x;t)$ . The self energy now has two-particle cuts beginning at  $s^2 = 4(M + g_0)^2$ ;  $4(M + y_0)^2$ ;  $8^2$ . If  $2^2$  is greater than the lowest two particle threshold the one-particle pole moves into the second, unphysical, sheet and the spectral density features a narrow resonance, for weak coupling, at the renorm alized value of the scalar m ass of total width given by tot = +  $v^2 2 =$  $8 + 3g^2 = (4 \sqrt[6]{2})$ . In this case (t) exhibits exponential relaxation on a time scale that is typically as the one above. Eventually, however, a power law tailbehaving as t  $^{3=2}$ , which is determined by the two-particle scalar threshold, will develop.

From our discussion above, we not two important points: (i) In the case when the in atom mass is above the multiparticle thresholds, the narrow resonance gives rise to exponential relaxation for a long period of time. During this time, the evolution is similar to that obtained from the elective evolution equation  $+m^2 + t_{tot} = 0$  with tot given by the total decay rate. The equation of motion (2) provides a 'proof" of this elective description; however this only applies for small amplitudes. (ii) U sually the imaginary part of the self energy is identied with a 'therm alization" or relaxation rate. We have seen above that this is only the case whenever there is a resonance i.e. a pole in the unphysical sheet. If there is a one particle pole below the multiparticle threshold, then the long time behavior is undam ped and oscillatory. The continuum contribution falls o with a power law which is determ ined completely by the behavior of the spectral density at threshold.

N on-Linear R elaxation of the In aton: W e now contrast the linear relaxation scenario with the non-linear one, which is found by considering evolution equation for the expectation value of the scalar eld including the back-reaction of the quantum uctuations by absorbing (t) in the de nition of the now time dependent mass term for the scalars and ferm ions:

W e can then obtain the one-loop evolution equations [6,8]

where the non-equilibrium expectation values are the one-bop Feynm an graphs but with the time dependent masses given by eq.(3):

The mode functions  $f_k$  (t) de ne the spinor solutions of the hom ogeneous D irac equation.

From eqs.(7-9), induced am pli cation of quantum uctuations becomes evident through the time dependent mass; them ode functions obey harmonic oscillator equations with a timedependent frequency. If the time dependence were truly periodic this would be parametric ampli cation through the presence of resonances and forbidden bands [4,5,9]. However, when back reaction is incorporated as in the set of equations above, these time dependent frequencies are not exactly periodic precisely because of the damping elects. This case should be distinguished from parametric amplication and we refer to this case as induced amplication.

The rst order quantum correction to the evolution equation is obtained by replacing the classical trajectories for (t) in the mode equations (7-9). However, this will lead to in nite particle production via parametric amplication. In reference [4], the classical evolution for

(t) was kept in the mode equations. We, however, will keep the full evolution for (t) thus obtaining a self-consistent one-loop approximation that incorporates the back-reaction of the eld into the uctuations and vice-versa. In eld, this procedure is a non-perturbative resummation of a large set of diagrams self-consistently.

Induced am pli cation will give rise to dam ped evolution for (t), whose am plitude dim inishes at long times. Thus, incorporating the full evolution of (t) in the mode equations will shut-o particle production at long times as the energy of the scalar eld is transferred to the produced particles. This closed system of consistent equations will ensure that particle production will be nite.

To obtain the dynam ics of the zero mode, we will integrate the equations above num erically, using the initial conditions  $(0) = _0; -(0) = 0$ . These conditions in ply that the modes written above correspond to positive frequency modes for t < 0. We have to renormalize the equations to one-bop order absorbing the relevant divergences into mass, wave-function and coupling constant renormalizations [8]. The nalform for the zero mode equation is as given by eq.(4) in terms of renormalized couplings and masses and the expectation values have been twice subtracted with the aid of a high momentum cuto (typically, 100 M ). Such a cuto is necessary in any case in order to perform the momentum integrals appearing in the expectation values num erically. The results have been checked to insure that there is no cuto sensitivity in physical quantities. The higher mode equations take the same form as in eqs.(7 - 9), but in term of the renormalized parameters [6,8].

 $W_{\alpha}$  e now use these equations, written in terms of the dimensionless quantities () =  $=6M^{2}$ ; = M t, to any alze the dynamics of the zero mode as well as to com -(t) pute the number of ; quanta produced by induced amplication [6,8]. iii) Unbroken for  $=8^{2} = 0.2$ ; q =sym m etry case: a) y = 0: Figure 1 shows () vs. ; M = 0.2 M; (0) = 1.0; (0) = 0. The amplitude dam ps out dram atically within a few periods of oscillation. The asymptotic behavior corresponds to small undamped oscillations. This is to be contrasted with the linear relaxation case, in which the two-loop self-energy leads to undam ped asymptotic oscillations and a power law behavior at long times. We also nd that the number of particles in a volum  $e M^{-3}$ , as a function of wave number k, is peaked at M . Induced amplication is much more e ective than one-particle decay in producing k low momentum particles and drawing energy from the background eld, thus damping its evolution. One-particle decay considerations would predict a slow power law tails to a nal amplitude that is perturbatively close (notice that the perturbative parameter is  $=8^{2}$ ) to the initial.

We also nd [8] that both the quantum uctuation h  $^2$  (x;t) i and the total number of produced particles as a function of time grow rapidly within the time scale in which damping is most dram atic, as can be seen in qure (1), clearly showing that damping is a consequence of induced amplication of uctuations and particle production. b)  $y \in 0$ ; q = 0: Figure 2 shows () vs for M = 0;  $y^2 = 2 = 0.5$ ;  $= 6y^2 = 1.0$ . C learly there is some initial dam ping that shuts o early on. This is in marked contrast with the prediction of the linear relaxation approximation that predicts exponential relaxation with a relaxation time (in the above units) rel 0:1 for the above value of the couplings. We nd [8] that the number of particles in a volum  $\in M^{-3}$  as a function of wave number is peaked at k M with maximum value of 2 given by the exclusion principle. We interpret the lack of damping as a consequence of the Pauli blocking; all the low momentum states are fully occupied. In the initial stages of evolution an excited state quickly ensues and the available ferm ionic states are occupied blocking any further damping. Both the quantum uctuation h (x;t) (x;t)iand the num ber of produced particles as a function of time grow very rapidly within the time scale of the initial dam ping, but then oscillate around a constant value at the time when the damping e exts have shut o [8]. iv) Spontaneously broken symmetry case: y = 0. Figure 3 shows the time evolution of () vs for  $=8^2 = 0.2$ ; q= = 0:05; M = 0.2 M; (0) = 0.6; (0) = 0.6 For these values of the parameters, linear relaxation predicts exponential dam ping with a relaxation time rel 360. This relaxation time is about six to eight times larger than that revealed in gure (3). Furtherm ore, this gure clearly shows that the relaxation is not exponential. The asymptotic value of () oscillates around the minimum of the elective action which, as observed in the quie, has been displaced by a large amount from the tree level value = 1. We notice num erically a slow damping in this asym ptotic behavior, which could be related to the linear relaxation time, though we were unable to establish this num erically. We nd [8] that the num ber of produced particles in a volum e M<sup>3</sup> is peaked at low wave num ber with a fairly large contribution within the region M. As a function of time the quantum uctuation  $h^{2}(x;t)$  i grows rapidly within k the time scale in which damping is most pronounced and the same behavior is observed for the number of particles created as a function of time, thus leading to the conclusion that the rapid non-linear relaxation is clearly a result of particle production and the growth of quantum uctuations. In all cases we nd the total density of produced particles to be  $N = N M^{3}; N$ 0 (1).

C on clusions: W e have learned that induced am pli cation of quantum uctuations in the non-linear regime is a highly e cient mechanism for dam ping the evolution of the in aton zero mode as well as for creating particles. The typical time scales associated with this dam ping mechanism are much shorter than the time scales associated with single particle decays. This leads us to conclude that there may be a wide separation between the time scales of induced particle production and that of therm alization of these produced particles via collisional relaxation, since this latter scale is typically related to perturbative couplings and thus fairly large. Single particle decay will be operative on the same time scale as collisional therm alization.

The nalreheating temperature, however, will be determined by the total number of particles produced. Typically,  $T_{reh}$  N<sup>1=3</sup>. Similarly, the total entropy produced will depend on the number of produced particles. A sum ing that the process of single particle decay produces far fewer particles than induced amplication and that a therm alized state ensues from collisional relaxation, one can estim ate the nal reheating tem perature by evolving the equations above and following the evolution of the number of particles. C learly this number will depend on the particular details such as coupling, masses but not in the perturbatively obvious manner. A ssuming that the produced particles them alize via collisions in the cases that we studied we typically obtain reheating temperatures  $T_{reh}$  M [8] which is about two orders of magnitude less than the estimate from the elementary theory of reheating [1]. However, it is not clear how long a distribution that is so di erent from them alw ill take to them alize. In an expanding universe, this time lag will serve to dilute the energy density of the produced particles. U ltim ately, a realistic calculation will involve the num erical evolution of the self-consistent equations. Furtherm ore our study will have to be extended to an FRW cosm ology since the expansion of the universe can lead to many e ects not accounted for here. This work is in progress.
