A ngular D istribution and Polarization of Photons in the Inclusive D ecay $_{\rm b}$! X $_{\rm s}$

ABSTRACT

We study the angular distribution of photons produced in the inclusive decay of a polarized $_{\rm b}$, $_{\rm b}$! X_s, using the technique of heavy quark elective theory. Finite non-perturbative corrections are obtained relative to the free quark decay b! s. These corrections a ect signi – cantly the intensity and polarization of photons em itted at sm all angles relative to the $_{\rm b}$ spin direction.

The decay b ! s , calculated on the level of free quarks, has three interesting features:

(i) The photon is monochrom atic, its energy spectrum being

W hereas feature (i) is purely kinem atical (re ecting the two-body nature of the decay), features (ii) and (iii) are specic consequences of the standard model, in which the elective H am iltonian governing b! s has the structure

The purpose of this paper is to study how the characteristics of b! s, sum marized in Eqs. (1.1) { (1.3), are altered when the b-quark is embedded in a polarized b baryon, and when the nals-quark is a part of a hadronic system that is sum med over. These changes have their origin in the \Ferm im otion" of the b-quark within the hadron, as well as its spin-dependent interaction with the environment, and can be parametrized using the method of heavy quark elective theory (HQET) [1,2]. In Sec. II, we outline the method of calculation, and discuss our results in Sec. III.

II.HQET AND THE DECAY b! Xs

The di erential decay rate for the inclusive decay $_{\rm b}$ (p) ! X $_{\rm s}$ (p $_{\rm X}$) (p) in the standard m odel can be written as

where the e ective Ham iltonian H $_{\rm e}$ is given in (1.4). Using the optical theorem, and writing the phase space element as

The time-ordered product appearing in T can be expanded in powers of $1 = m_b$, using methods described in [2[8]. To order $1 = m_b^2$, we obtain

The distributions in Eq. (2.7) yield physically meaningful results only if one integrates over the photon energy (see e.g. Ref. [8]). The leading term proportional to $(y y_0)$ reproduces the result of the free quark model (FQM). The corrections to the free quark result, involving ${}^{0}(y y_0)$ and ${}^{00}(y y_0)$, are parametrized by two phenom enological constants K and ${}_{b}$, de ned as

(Refs. [4,8] use a parameter $_1$ related to K by K = $_1=2m_b^2$). Integration of Eq. (2.3) over y then yields the angular distribution

Eqs. (2.10) { (2.12) are the HQET analogs of the free quark result (1.2) { (1.3).

III.D ISCUSSION OF RESULTS

To evaluate the HQET corrections, we need an estimate of the parameters K and b. Following Ref. [5] we use K ' 0.01, although this parameter has a large uncertainty. From the fact that d =dcos 0 for all scattering angles (independent of the value of m_s or K) we must have $_{\rm b} < 0$ (see Eq. (2.10)). We will use the value $_{\rm b} = \frac{2}{3}$ K suggested in Ref. [3].¹ This is in agreement with the bound derived in Ref. [9].

From the angular distribution in Eq. (2.10), we infer that the e ect of nonperturbative corrections is to reduce slightly the forward-backward asymmetry in the photon emission. In Fig. 1, we plot the fraction of decays producing a photon

in the forward cone $\cos_0 < \cos < 1$:

The result is compared with that in the free quark model.

From the results in Eqs. (2.11) and (2.12), we obtain the polarization of the photon as a function of its direction:

O noe again, as shown in Fig. 2, corrections to the free quark model are signi cant for photons emitted in the near-forward direction.

To summarize, the angular distribution of inclusively produced photons in the decay $_{\rm b}$! X_s of a polarized $_{\rm b}$ baryon can be calculated unambiguously in HQET. This distribution tests the structure of the underlying Hamiltonian H_e in a way that is not possible by studying the mesonic decay B ! X_s . The angular distribution is a well de ned observable which involves no divergences of the type that appear in the calculation of the energy spectrum (delta functions and derivatives thereof). Our calculation m ay be viewed as an illustration of the utility (and limitation) of the HQET approach in determining the elects of hadronic binding on the decay of a heavy quark. The deviations from free quark decay in the reaction $_{\rm b}$! X_s are found to be globally small, but are signi cant for photons emitted in the forward direction.
