CHIRAL PREDICTION FOR THE N S{W AVE SCATTERING LENGTH α TO ORDER O (M 4)

A bstract

We evaluate the S-wave pion{nucleon scattering length a in the framework of heavy baryon chiral perturbation theory up{to{and{including terms of order M 4 . We show that the order M 4 piece of the isovector amplitude at threshold, $T_{\rm thr}$, vanishes exactly. We predict for the isovector scattering length, 0.088 M $_{+}^{1}$ a 0.096 M $_{+}^{1}$.

Chiral sym metry severely constrains the interactions of the strongly interacting particles at low energies, rst formulated in terms of current algebra (CA). One of the most splendid successes of CA was Weinberg's prediction for the S{wave pion{nucleon scattering lengths [1],

with M = 139.57 MeV the charged pion mass, m_p = 938.27 MeV the proton mass, F = 92.5 MeV the pion decay constant and the superscripts + = refer to the isoscalar and isovector N amplitude, respectively. The Karlsnuhe{Helsinkiphase shift analysis of N scattering [2] leads to a = 0.092 0.002 M and a = 0.008 0.004 M, impressively close to the CA prediction, eq.(1). The Karlsnuhe{Helsinki analysis is based on dispersion relations thus requiring a solid data base as input. However, over the last few years there has been some controversy about the low {energy N data which has not yet been settled. Consequently, the uncertainties in a are presumably larger and even the sign of a could be positive. A more direct way to get a handle at these zero momentum (i.e. threshold) quantities is the measurement of the strong interaction shift ($_{1S}$) and the decay width ($_{1S}$) in pionic atoms. The PSIETH group has recently presented as the results of their impressive measurements in pionic deuterium and pionic hydrogen [3] [4] [5] (for earlier work in the eld see e.g. [6], [7] [8]). The S{wave scattering length are related to $_{1S}$ and $_{1S}$ via the Deser{type formulae [9],

with q the m om entum of the 0 , P the Panofsky ratio and the constant C = $4E_{1S}\!=\!r_{\!B}$ is proportional to the point-C oulomb binding energy, E_{1S} , of the system in the 1S state divided by the pion B ohr radius, $r_{\!B}$. and describe electrom agnetic corrections to the scattering lengths, see [10]. The consequent analysis of the data leads to [5] a = $0.096~0.007M^{-1}$ and $a^{+}=0.0077^{-}0.0071M^{-1}$. If one combines the pionic hydrogen shift measurement with the one from the pionic deuterium, one has a = $0.086~0.002M^{-1}$ and $a^{+}=0.002^{-}0.001M^{-1}$. The largest uncertainty comes from the width measurement of pionic hydrogen. B oth determinations are consistent within one standard deviation. We conclude that a is larger than the CA value and that a^{+} is consistent with zero.

Heavy baryon chiral perturbation [11] allows to system atically calculate the corrections to the CA predictions, eq.(1), for the S{wave scattering lengths. This topic was already addressed in ref.[12]. In this note, we want to further sharpen the prediction for the isovector scattering length. In particular, we will calculate all contributions which are of order M 4 and furtherm ore give a realistic estimate of the uncertainties for the one loop result (which was not done in [12]). The starting point is the elective pion {nucleon Lagrangian,

where the superscript (i) refers to the number of derivatives or quark mass insertions. The structure of L $_{\rm N}$ is discussed in detail in the review [13] and a pedagogical introduction can be found in [14]. The S-wave scattering lengths can be calculated from the on{shell forward N scattering amplitude T $^{\rm ba}$ = T $^{+}$ (!) $^{\rm ba}$ + i $^{\rm bac}$ $^{\rm c}$ T (!) with ! = p q=n, the pion lab energy. Evaluation at threshold! = M gives them as a = T $_{\rm thr}$ =(4 (1 + M =m $_{\rm p}$)). The one-loop result for T $_{\rm thr}$ to order M $^{\rm 4}$ reads

$$T_{thr} = \frac{M}{2F^2} + \frac{g_N^2 M^3}{8m_p^4} + \frac{M^3}{16^2 F^4} + 2 \ln \frac{M}{m} + B^r () M^3 + T_{thr}^4 + O (M^5); \quad (4)$$

where the chiral corrections at order M 3 come from the expansion of the nucleon pseudovector B orn term, the loop corrections and the counterterm s. $T_{\rm thr}^{~74}$ denotes the order M 4 contribution to the isovector forward N amplitude at threshold to be discussed below. We note that the contribution from the B orn term is just 1% of $a_{\rm CA}$. To determ ine the counterterm contribution, one needs to pin down the value of B $^{\rm r}$ () which is a particular combination of some low {energy constants from L $_{\rm N}^{(3)}$ [12] [13]. In fact, these low-energy constants are not known and have been estimated in [12] via resonance exchange,

In eq.(5), we have explicited the corresponding (1232) and the N (1440) contributions. The range of the various resonance parameters like R and Z is discussed in [12]. This procedure induces a spurious dependence on the scale of dimensional renormalization () which enters through the divergences from the one loop contribution. In [12], was xed at the mass of the (1232) since this resonance is most important in the estimation of the contact term B $^{\rm r}$ (). However, in the framework of resonance saturation this scale should be varied between M = 550 MeV and m $_{\rm N}$ = 1:44 GeV . Would we be able to xB $^{\rm r}$ () from some data, the prediction for a would, of course, be {independent.

We now turn to the calculation of the order M 4 corrections. First, contact terms from L $_{\rm N}^{(4)}$ can not contribute to $T_{\rm thr}$ at O (M 4) because of the crossing property of the isovector forward N amplitude,

with ! the pion lab energy. Thus we are left with one { loop graphs with exactly one insertion from L $_{\rm N}^{(2)}$. M any of these diagrams cancel with their crossed partners due to the crossing property, eq.(6), and special properties of the loop functions entering, as exemplified in Fig.1. In particular, the terms with one insertion proportional to $c_{1,2,3,4}$ from L $_{\rm N}^{(2)}$ vanish because

at threshold, ! = M (the pertinent loop functions are given in appendix B of [13]). However, this does not hold for the thirteen diagram s shown in Fig 2. These remaining graphs can be grouped into ve classes as indicated in Fig 2. Straightforward calculation gives

where we have exhibited the contributions from the various classes separately. This result is rem insident of the non{renorm alization of the isovector charge of the nucleon. Consequently, the next chiral corrections appear at order M 5 , from two{loop graphs, one loop graphs with one insertion from L $_{\rm N}^{(3)}$, counterterms and so on. They are suppressed by four powers of M= (4 F $_{\rm N}$) compared to the leading order term, eq.(1) and are thus expected to be small, even though the exact numerical coecients can be of order ten (as indicated from the O (M 3) correction to the CA result).

Varying the various resonance parameters which enter the estimate of B $^{\rm R\,es}$ and the scale within their bounds, we not as a conservative estimate for the one{loop prediction of a ,

which is consistent with the various empirical values discussed before and 10:::20% larger than the CA prediction [1]. As already stressed in [12], it is the chiral loop correction at order M 3 which closes the gap between the lowest order (CA) prediction and the empirical value. An indication of the size of the next corrections can be obtained by writing the one{loop result as $a=a_{CA}(1+a_1)'a_{CA}\exp(a_1)$. The next correction follows to be $a_1^2=2$ which is of the order of $a_1^2=2$ which is

To sum marize, we have sharpened the chiral perturbation theory prediction for the isovector N S{wave scattering length a by showing that the term of order M 4 in $T_{\rm thr}$ is identical to zero. Varying all uncertainties entering the one{loop expression for a [12], we arrived at the band, eq.(9), which is consistent with the existing data. Concerning the isoscalar scattering length a^+ , no m prediction can be given at present as discussed in [12] since there are large cancellations which make the result for a^+ very sensitive to some not very accurately known counterterms.

- Fig 2 Classes of non {vanishing diagram s at order M 4. For notations, see Fig.1.


