The M onte C arlo program WWGENPV, designed for computing distributions and generating events for the four-ferm ion process e⁺ e ! W ⁺ W ! 4f, is described. It is based on the calculation of the exact tree-level matrix element of the four-ferm ion reaction and includes initial-state radiation in the leading-log approximation within the structure function approach. The program can be used in a two-fold way: as a M onte C arlo integrator for weighted events, providing predictions for the total cross section, the W invariant-mass distribution, the radiative energy and invariant-mass loss; as a true event generator of unweighted events, useful for simulation purposes.

Nature of physical problem

The precise measurement of the W-boson mass M $_{\rm W}$ constitutes a primary task of the forthcoming experiments at the high energy electron {positron collider LEP2 (2M $_{\rm W}$ $^{\rm P}$ $^{\rm S}$ 210 GeV). This experimental goal will be possible through the study of the four-fermion reaction e $^{\rm t}$ e $^{\rm t}$ W $^{\rm t}$ W $^{\rm t}$ 4f. A meaningful comparison between theory and experiment requires an accurate description of the fully exclusive process e $^{\rm t}$ e $^{\rm t}$ W $^{\rm t}$ V $^{\rm t}$ 4f, including the main e ects of radiative corrections, with the nalgoal of providing predictions for the realistic distributions measured by the experiments [2].

M ethod of solution

In order to e ciently perform the high-dimensional integration (due to the four-ferm ion nalstate) in the presence of realistic cuts, the total cross section, the energy and invariant-m ass loss and the W invariant-m ass distributions are

computed by means of a Monte Carlo integration for weighted events. For simulation purposes, the program can also be used as an event generator that provides a sample of unweighted events, de ned as the components of the four nal-state fermions momenta, plus the radiative variables of the incoming electron and positron, plus s, stored into proper n-tuples. The importance-sampling technique [3] is employed to take care of the peaking behaviour of the integrand, both in the integration and in the generation modes.

Restrictions on the complexity of the problem

Electroweak processes originating the same four-ferm ion nal state of the double-resonating diagram s e^+e^- ! W $^+$ W $^+$! 4f (background processes) are not included in the present version of the program . The treatment of the initial-state radiation is limited to the gauge-invariant subset of the leading-logarithmic corrections which are the most important contribution from the phenomenological point of view . Furthermore, the kinematics of the event in the presence of the initial-state radiation is limited to the collinear approximation, i.e. $p_T = p_L$ exists are neglected for the time being.

Typical running time

As integrator, the code needs about 5 h of HP 9000/735 for generating 10^8 weighted events; the relative errors on the cross section and on the energy and invariant-m ass losses are about 2 $\,10^{-4}$ and 6 $\,10^{-4}$, respectively. The generation of a sam ple of 10^4 unweighted events requires about 3 m in on the sam e system .

1 Introduction

The precise m easurem ent of the W-boson mass M $_{\rm W}$, and more generally the study of its physical properties, constitutes a primary task of the forthcoming experiments at the high energy electron-positron collider LEP2 (2M $_{\rm W}$ s 210 GeV).

A large am ount of theoretical work has been performed up to now, following essentially two main streams.

On the one hand, one can not sem i-analytical works, whose leitm otiv is computing analytically as much phase-space integrations as possible [1]. Typically, these works give (QED-corrected) distributions for the invariant masses of the W , integrating a priori all the other independent phase-space variables, from which total cross sections can be easily computed. A fiter such an analytical e ort, the sem i-analytical codes developed along this line are very fast, precise and e cient. They are hence typically well suited for thing purposes, their main drawback being the lack of a full reconstruction of the true event phase-space con guration.

On the other hand, one can not M onte C arbo codes. In principle they can guarantee the full event reconstruction, since they handle the four-momenta of the nal-state particles. Of course, the accuracy with which this goal is achieved depends on the dynamics built—in in the code; in particular, the exclusive control of all the features of the full four-ferm ion event, including all the possible correlations between nal-state particles, requires the knowledge of the exact four-ferm ion matrix element, at least in the Born approximation (for instance, no isotropic decays of the intermediate bosons can be allowed).

Common to both the above-mentioned approaches, is the problem of treating QED corrections, which, as is well-known, are large and strongly dependent on the experimental cuts applied. In particular, it happens that the energy lost in the beam pipe (which at the leading-logarithmic level is well described by initial-state radiation in the collinear approximation) represents an important part of the systematic error on M $_{\rm W}$. Therefore one needs also a reliable model for, at least, initial-state radiation.

Som e M onte C arbo codes are already available for the four-ferm ion processes of interest at LEP2 [2]. Nevertheless, the critical comparison between independent approaches to a problem has always been a useful and powerful tool for understanding the theoretical accuracy of the results. The aim of this work is to present and describe in some detail WWGENPV, a M onte C arbo event generator for e⁺ e ! W ⁺W ! 4f, including initial-state QED corrections

in the structure functions form alism .

2 Theoretical Background and General Features

The theoretical formulation implemented in the program has been described in some detail in β]. To calculate the cross section of the e^+e^- ! W ^+W ! 4f process in the presence of the initial-state radiation, the basic formula reads:

In this equation, dPS] denotes the volume element in the 7-dimensional phase space connected to the independent variables of the hard scattering reaction in the centre-ofm ass frame; d_0=dPS] is the exact dierential kernel cross section in the Born approximation, limited at present to the W-signal diagrams. The inclusion of the complete set of background diagrams is in progress. At any rate their election be cut-oby proper selection criteria on the nal-state invariant masses. Finally D (x;Q²) is the electron structure function describing initial-state radiation [4]. For its explicit expression the following form is chosen:

where $L=\ln (s=m^2)$ is the collinear logarithm, E=1 is the Euler constant and (z) is the gamma function. The rst exponentiated term of G ribov {Lipatov form describes multiphoton soft radiation, the second and third ones hard collinear bremsstrahlung. This choice of the structure function is a consistent solution of the Renormalization G roup evolution equation at the leading-logarithmic level, and guarantees that, after an expansion down to 0 (), the well-known factorized and hence universal bremsstrahlung spectrum is exactly recovered.

W ith the choice of the independent variables adopted in [3], the di erential kernel cross section is proportional to the tree-level squared m atrix element as follows:

Therefore, in the kernel cross section two kinds of \singularities" can be recognized, namely the one related to the vector boson propagators (on $^2_{1;2}$), the second arising from the Jacobian appearing in (4) (on $^2_{3}$; $_2$). To e ciently perform the M onte C arb integration in the presence of the above peaking structure, the importance-sampling technique [5] has been employed. For instance, for the W-boson propagator singularities, an integration must be performed, which has the form

where $x^2 = \frac{2}{i}$, $a^2 = M_W^2 = s$, $b^2 = \frac{2}{2}M_W^2 = s^2$ and the function $f(x^2)$ is regular. Multiplying and dividing the integrand by the weight function

where the quantity in square brackets is no longer singular at $x^2=a^2$. The integral I can be rewritten as

Therefore, by generating c at between 0 and 1 an accurate estimate of I can be obtained.

Concerning the singularities arising from the Jacobian factor, the integrations to be performed are of the following kind:

In this case the importance sampling can be applied by introducing the weight function

When including initial-state QED corrections, in order to perform the importance sampling on the generation of the radiative variable x in the soft region x! 1, the weight function is chosen as the all-order soft part of the structure function, i.e.

W ith respect to the original formulation of QED corrections given in [3], besides a dierent choice of the structure function, the Coulomb singularity, which is important in the threshold region, is included in the code according to the very recent formulae given in [6]. For details and links with other approaches to the problem, the reader is referred to the original literature.

3 Program Structure

A fter the initialization of the Standard M odel parameters and of the electromagnetic quantities, the calculation within the program proceeds as described

in the following. As a rst step, the random number generator RANLUX is called to extract a vector of twelve components which are converted from REAL*4 to REAL*8 precision in order to be consistent with the calculational environment, which is in REAL*8 precision. The rst two random numbers are used to generate the radiative variables $x_{1:2}$ according to the distribution given by the soft exponentiated part of the structure function; eight random numbers are em ployed to fully reconstruct the kinem atics of the four-ferm ion hard scattering process in the centre-of-mass frame: seven of them are needed to generate the independent variables previously introduced for the kernel reaction, one to choose between the two possible solutions of the non-linear constraint. G iven the independent variables, all the invariants related to the 2! 4 kernel reaction are computed. The variables $\frac{2}{1:2:3}$ and $\frac{2}{2}$ are, in particular, generated by means of the importance-sampling procedure to take care of the peaking behaviour of the integrand, as described in the previous section. The other variables $(z_{1:3}; 1)$ are generated according to the uniform distribution in the physical range relative to an extrapolated set-up. When in itial-state radiation is switched on, the four-momenta of the outgoing fermions are reconstructed in the laboratory frame, taking into account the Lorentz boost due to the em ission of unbalanced electron and positron radiation and given by the $_{\rm L}$ Lorentz factor $_{T} = (x_1)$ $(x_1)=(x_1+x_2)$. At this point, one further random number is generated to perform a random rotation around the beam axis to account for a trivial overall azim uthal angle. The last random number is required in the generation branch for hit-or-m iss. A fter that, a call to SUBROUTINE CUTUSER is performed in order to implement the rejection algorithm on the nal-state particles. If the event is accepted, the squared matrix element in Born approxim ation is returned by a call to SUBROUTINE BORN. In conclusion, at the end of the loop over the events, the averages and squared averages are cumulated to provide the \weighted events" M onte C arlo results for the required observables and their num erical errors.

When the program runs as a generator of unweighted events, after the hitorm iss procedure, the components of the four nal-state ferm ions momenta, plus the radiative variables of the incoming electron and positron, plus s, are stored into a proper n-tuple. Each event stored in the n-tuple has the structure $(x_1; x_2; E_b; q_1; q_2; q_3; q_4)$, where E_b is the beam energy and q_i are the three-momenta of the outgoing particles, assumed to be ultrarelativistic. In this case, the cross section for unweighted events is given as output.

4 Input

Some input parameters and ags are introduced in the program in order to allow the user to select the output of interest. A short explanation of their meaning is addressed in the following and is also printed when running the code interactively.

OGEN (CHARACTER*1)

It controls the use of the program as a M onte C arlo integrator for weighted events (OGEN = I) or as a M onte C arlo event generator of unweighted events (OGEN = G). If the rst choice is requested, the code returns in a LOGFILE the value of the cross section for weighted events, together with the average energy loss and invariant-m ass loss, de ned as h(2 x_1 x_2) s=2i and h(1 x_1x_2) s=2i, respectively. If the second choice is requested, it prints in a LOGFILE the value of the cross section for unweighted events and lls an n-tuple, EXAMPLE.DAT, containing the generated (unweighted) events. The LOGFILE contains also the value of NBIAS/NMAX. If it is > 0, the generation procedure is biased and it is necessary to run the code again, after having properly increased the value of FMAX (default = 1000).

RS (REAL*8)

The centre-of-mass energy (in GeV).

NHITWMAX (INTEGER)

Required by the integration branch. It gives the maximum number of calls for the M onte Carlo loop.

NHITMAX (INTEGER)

Required by the event-generation branch. It is the maximum number of hits for the hit-or-miss procedure.

IQED (INTEGER)

This ag allows the user to switch on/o the contribution of the initial-state radiation. If IQED = 0 the distributions are computed in lowest-order approximation, while for IQED = 1 the initial-state QED corrections are included in the calculation. This choice can be performed both for the integration and for the generation mode.

ODIS (CHARACTER*1)

Required by the integration branch. It selects the kind of experimental distribution. For ODIS = T the program computes the total cross section (in pb) of the process, eventually including the cuts supplied by the user in SUBROUTINE CUTUSER (see below); for ODIS = W (only possible with OGEN = I) the W invariant-mass distribution is returned (in pb/GeV). In this case one can choose between the two opposite charged W -bosons, namely W (IWCH = 1) and W $^+$ (IWCH = 2), and the invariant-mass of interest must be entered by the user in GeV.

OWIDTH (CHARACTER*1)

It allows a dierent choice of the value of the W -w idth. OWIDTH = Y means that the tree-level Standard M odel formula for the W -w idth is used; OWIDTH = N requires that the W -w idth is supplied by the user in $G ext{ eV}$. This freedom in the choice of the W -w idth has been introduced so as to simplify the comparisons of the results of our code w ith those of other programs.

NSCH (INTEGER)

The value of NSCH allows the user to choose the calculational scheme for the weak mixing angle and the gauge coupling. Three choices are available. If NSCH=1, the input parameters used are G_F ; M_W ; M_Z and the calculation is performed at tree level. If NSCH = 2 or 3, the input parameters used are (Q^2) ; G_F ; M_W or (Q^2) ; G_F ; M_Z , respectively, and the calculation is performed using the QED coupling constant at a proper scale Q^2 , which is requested as further input.

OCOUL (CHARACTER*1)

This ag allows the user to switch on/o the contribution of the Coulomb correction. If OCOUL = Y (N) the distributions are computed with (without) the above electrom agnetic e ect.

5 Test Run Output

The typical calculations that can be performed with WWGENPV are illustrated by the following examples of test run output.

Sam ple 1 Calculation of total cross section, average energy loss and average invariant-m ass loss for 10^8 weighted events, including initial-state QED corrections.

Sam ple 2 Calculation of total cross section for 10^4 unweighted events and ling the n-tuple EXAMPLE.DAT, including initial-state QED corrections.

The output of sample 1 can be obtained with the following input:

OGEN = 'I'

The integration branch is chosen.

RS = 176.D0

The centre-of-mass energy is xed at 176 GeV.

NHITWMAX = 100000000

The maximum number of calls is xed.

IOED = 1

Initial-state QED corrections are included.

ODIS = 'T'

The total cross section is computed (together with the corresponding average energy and invariant-m ass loss).

OWTDTH = 'Y'

The W -boson width is computed at the tree level in the Standard Model.

NSCH = 2

(Q $^2)$, G $_{\rm F}$ and M $_{\rm W}$ are used as input param eters.

1/ALPHAI = 128.07D0

The value of $1 = (0^2)$ is entered.

OCOUL = 'N'

The Coulomb correction is not included.

The output of sample 2 can be obtained with the following modi cations:

M oreover the value of ODIS is not required.

Both for the integration and generation branch, the output returns the values of the \Feynman rules" GVE, GAE, GWF and GWWZ linked to the vertices occurring in the diagram $sofe^+e^-$! W ^+W ! 4f as follows:

6 Program Implementation

In this section a short description of each routine im plemented in the program is given. For random -number generation the routine RANLUX by F. James is used and inserted in the code. For more details about RANLUX the reader is referred to the proper literature [7].

To be supplied by the user. The subroutine allows the user to implement any kind of experimental cut on the four-momenta of the nal-state fermions. G lobally, the event is specified by 15 ingredients: the radiative variables $x_{1,2}$ (EVENT (1), EVENT (2)), the beam energy (EVENT (3)) and the components of the three-momenta of the four outgoing fermions (EVENT (I), with I = 4;15). The energies are simply derived by the mass-shell condition for ultrarelativistic fermions. The reference frame is assumed to be with the z-axis along the direction of the incoming positron.

The routine returns a ag (CUTFLAG = 0, 1), which controls if the event is accepted (CUTFLAG = 1) or rejected (CUTFLAG = 0) by the selection criteria.

SUBROUTINE BORN (S, X13, X14, X34, X35, X15, X16, X23, X24, X25, X26, X36, X45, X46, X56, SQM, IOVFL, IOEFL, IOES, JOEFL, JOES)

IMPLICIT REAL*8 (A-H, O-Z)

It returns in SQM the squared tree-levelm atrix element associated to the s-and t-channels Feynm an diagram s of the kernel process e⁺ e ! W ⁺W ! 4f. The squared matrix element is computed numerically, squaring the amplitude obtained by means of SCHOONSCHIP [8] in the framework of the helicity—amplitude formalism [9] formassless nalfermions. If the ect of the Coulomb correction is required, the value returned for SQM is given by:

where $_{\text{C}}$ represents the Coulomb correction factor and v the relative velocity of the two W -bosons (see [6] for more details and explicit formulae).

FUNCTION DOP(X)

IMPLICIT REAL*8 (A-H,O-Z)

COMMON/EM/RL,ETA,BETA,SDELTA

The QED structure function, adopted to account for the radiation emitted by the incoming leptons, is computed according to the analytical expression reported above. It is given by the sum of an exponentiated term of the Gribov { Lipatov form, associated to soft multiphoton emission, with up to 0 (2) contributions describing hard brem sstrahlung in collinear approximation. Actually, in order to perform importance sampling on the generation of the radiative variable x in the soft region x! 1, the following formula is implemented in FUNCTION DOP:

where p(x) is the weight function given by (14).
