A MODEL FOR THE CHARMED D $_{\rm s}^{+}$ MESON DECAYS INTO THREE PIONS

Abstract

We propose a phenomenological three component model describing the decay amplitude of the process D $_s^+$! 3. The rst component is a constant background, the second one is a Breit-Wigner amplitude associated to a quasitwo-body f_0 (980) $_s^+$ state and the third one another Breit-Wigner amplitude corresponding to a possible quasitwo-body (770) state. We show that it is possible to reproduce the observed total rate for D_s^+ ! $_s^+$ as well as the two other measured branching ratios for the non resonant part and the resonant f_0^- one. Implication of the $_s^+$ state, of which an experimental limit has been given, is discussed. An upper bound in the 10 MeV range for the decay constant f_0^- of the (1300) meson is obtained.

I Introduction

We are interested, in this paper, in the decay of the D $_s^+$ m eson into three pions. Experimental data are available only for the nal state $_{-}^{+}$ [1,2], but not for the $_{-}^{0}$ of the new By inspection of the results, we observe that the quasitwo body state f_0 (980) has been clearly identified [1] whereas for the quasitwo body $_{-}^{0}$ (770) has state, no significant signal has been found [1]. A nother remarkable feature of the data is an important fraction of the decay proceeds into a non resonant $_{-}^{+}$ state [1], this fact necessarily implies a sizable W hannihilation contribution. More precisely, the rate for D $_s^+$ decays into a non resonant $_{-}^{+}$ state is about 1/3 of the dominant spectator decay rate D $_s^+$! hoth being governed by the same Cabibbo-Kobayashi-Maskawa (CKM) favored factor $V_{cs}V_{ud}$.

A first a brief discussion of the kinematics for three body decay and a presentation of the experimental results in section II, we construct a three component model for the transition amplitude of the mode D_s^+ !
The rst component corresponds to a quasitwo body
Since meson is a $(u\bar{u} - d\bar{d}) = \frac{p}{2}$ isovector state, the decay D_s^+ !
The can proceed only through the Wearn inhibition mechanism (henceforth Wear). In section III, we propose a model for the Wearn involving an intermediate virtual (1300) meson. The experimental upper limit for the branching ratio B (D_s^+) !
The constant of the wearn to be around 10 MeV.

The second component is associated to the observed quasitwo body f_0^+ state followed by the decay f_0^+ . The quark content of the f_0^- (980) m eson is crucial for constructing the amplitude D_s^+ ! f_0^- . If the f_0^- is a pure $(u\overline{u}+d\overline{d})=\frac{p}{2}$ isoscalar state, we must again use the WA, as for the 0^+ previously. In section IV we show that by comparing the D_s^+ ! 0^+ and D_s^+ ! f_0^- rates, such an assignment $(u\overline{u}+d\overline{d})=\frac{p}{2}$ for f_0^- (980) is in strong disagreement with experiment. Then the f_0^- (980) must content a large $s\overline{s}$ component or even be a pure $s\overline{s}$ state. Now the spectator mechanism can be used for the decay D_s^+ ! f_0^- , and from experiment, we estimate in section IV the magnitude of the hadronic form factor $F_0^{D_s f_0^-}$ (m²) describing the D_s ! f_0W^+ transition. If f_0^- (980) is a pure $s\overline{s}$ state, we obtain, from experiment $F_0^{D_s f_0}$ (m²) 0.36, a reasonable value.

For the third component associated to a non resonant $^+$ $^+$ state, we introduce a complex constant amplitude which corresponds to an uniformly populated Dalitz plot. Such a component is determined, from experiment, in section V where, in addition, the total rate for D_s^+ ! $^+$ is computed using the three component model described above. The result, consistent with experimental data, is presented as a function of a possible phase for the constant non resonant amplitude.

The $^+$ and energy distributions for the decay D $^+_{\rm s}$! $^+$ are computed in section VI. The f $_0$ $^+$ quasitwo body state is clearly seen in the $^+$ energy distribution, as already obtained in [1], no 0 $^+$ enhancement is present, and the energy distribution does not reveal any particular structure even if it is very dierent from the pure phase space distribution. It is then straightforward to make predictions for the decay mode D $^+_{\rm s}$! 0 0 $^+$ using isospin considerations relating the two nal states $^+$ and 0 0 $^+$. In section VII, we present our results for the rate and for the 0 , $^+$ energy distributions of the D $^+_{\rm s}$ decay into 0 0 $^+$.

Finally, we end this introduction by few considerations concerning the quark content of the f_0 (980) scalarm eson based rstly on SU (3) avor sym m etry and secondly on the decay products of the f_0 (980). The SU (3) avor nonet $J^{PC} = O^{++}$ contents an isovector m eson a_0 (980), two isoscalar m esons f_0 (980) and f_0 (1300) and two isodoublets of strange m esons K $_0$ (1490). The physical particles f_0 (980) and f_0 (1300) are expected, as usual, to be the result of a con guration m ixing between the isoscalar octet and singlet weights. We remark that the quasi degeneracy in mass between the a₀ (980) and f₀ (980) is rem in iscent of that between the (770) and !(782) in the $J^{PC} = 1$ nonet. A rst naive expectation is that f_0 (980), like ! (782), is dominantly a ($u\overline{u} + d\overline{d}$) = 2 bound state, the f_0 (1300) like (1020) being essentially a $s\bar{s}$ state. However such an assignment is wrong for at least two reasons from both theoretical and experim ental considerations. Indeed if one tries to apply for the scalar $J^{PC} = O^{++}$ nonet the usual mixing form alism which has been very successful in the $J^{PC} = 1$, 0^+ , 2^{++} , $3^$ cases, then we are faced with the impossibility to determ ine the mixing angle s for scalar mesons. Because of the large mass of the K $_0$ (1490) meson, the formalism leads to $\tan^2 s < 0$, no matter is used the quadratic or linear Gell-M ann - O kubo mass formula. Therefore the previous analogy between the $J^{PC} = 1$ and 0^{++} nonets is meaningless. The second reason is an examination of the experim ental decay products of the f_0 (980) and f_0 (1300), in particular the and K \overline{K} channels. In spite of the tiny phase space available for f_0 (980)! K \overline{K} , its branching ratio 22% is actually a very large number. The situation is inverted for the second meson f_0 (1300), the available phase space for K $\overline{\text{K}}$ is much larger, however its branching ratio is only 7.5%, with 93.6% into . From these experim ental considerations, we conclude that if the $J^{PC} = 0^{++}$ nonet is made of quark-antiquark bound states, the f_0 (980) must contain a large $s\bar{s}$ component and the f_0 (1300) a small $s\bar{s}$ one, with a $(u\overline{u} + d\overline{d}) = 2$ component being dominant for f_0 (1300) and secondary for f_0 (980). Moreover, we shall see in section IV that the comparison of the D $_{\rm S}$! 0 + and D $_{\rm S}$! f_{0} (980) + rates also con rm s the dom inant $s\bar{s}$ component of the f_0 (980) m eson. Such $s\bar{s}$ classication for f_0 (980) has also been recently advocated in 31.

- II G eneralities and Experim ental results.
- 1). We study the decay of the D_s^+ m eson of energy m omentum P into three m esons of energy m omenta p_1 , p_2 , p_3 with the relation $P = p_1 + p_2 + p_3$. We introduce the M andelstam variables s_1 ; s_2 ; s_3 and the m eson energies in the D_s^+ rest fram e E_1 ; E_2 ; E_3 . At the level of accuracy of the experiments, it is legitimente to neglect the mass dierence between charged and neutral pions and we get

Energy momentum conservation implies the relations

We rem ind that the transition matrix element < 3 $\mathcal{T} \mathcal{D}_s^+$ > involving three body nal state is dimensionless. In the $(E_1; E_2)$ plane, the phase space is dened by the constraints

Of course, the mass dierence between charged and neutral pions being neglected, we have the same phase space in the two other planes $(E_2; E_3)$ and $(E_1; E_3)$. Two possible three pions nal states are $^+$ and 0 0 $^+$. We make the following choice of meson variables

2). Let us now discuss the experimental situation concerning the only observed 3 pion $\,$ nal state $^{+}$ $^{+}$. The decay rate for the mode D $_{\rm s}^{+}$! $^{+}$ has been $\,$ rst m easured by the E 691

collaboration at Ferm i Lab. [1] and the result has been con rm ed few years later within error by the NA 82 collaboration at CERN [2]. In addition, the E 691 group has been able to exhibit in the $^+$ $^+$ D alitz plot a structure due to the f_0 (980) $^+$ quasitwo body state. However a structure due to the 0 (770) $^+$ quasitwo body state has not been clearly identified. The various branching ratios in [1] are normalized to the most easily measured mode D $_{\rm s}^+$! $^+$. U sing the Particle D ata G roup value [4]

where, in (8) the subscript N R m eans non resonant [1]. Our results (8), (9), and (10) agree with those given in [4]. However the branching ratio of Eq.(7) quoted in [4] is slightly smaller, (1:35 0:31)%, because an average has been made between the data obtained in [1] and [2]. For a question of consistency we shall use, in this paper, the set of data (7) (10) in order to preserve the relative fractions of the various terms as quoted in [1].

III. The decay mode for D $_{\rm s}^+$! $^{+}$ + $^{+}$

1). Let us consider the quasi two body $\,$ nal state $\,$ 0 . The transition $\,$ m atrix element has the form

where e (p) describes the meson polarization. The dimensionless quantity g_{D_s} is a weak complex coupling constant in terms of which, the decay width is given by

Here K is the center of m ass m om entum of the nal particles in the D $_{\rm s}^+$ m eson rest fram e.

2). The 0 and pion are quark-antiquark bound states containing only u and d quarks and the decay D $_{\rm s}^+$! 0 + can only proceed through the WA, since both charm and strange quarks being absent in the nal state. For the transition W $^+$! 0 + we assume, by the Partial Conservation of the Axial Current (PCAC) the contribution of an intermediate state having the quantum number of a $^+$ meson [5, 6, 7] and which might be the meson itself or its recurrence (1300). It has been checked that the meson intermediate state gives a contribution many order of magnitude smaller than that of the (1300) and only the latter one is retained in the diagram of Fig.1.

Here $^{\circ}$ (1300) and the corresponding expression of the weak decay constant $g_{D\,s}$ is given by

where a_1 is the phenomenological parameter introduced by Bauer, Stech, W irbel (henceforth BSW) [8]; V_{cs} ; V_{ud} the relevant CKM matrix elements; f_{D_s} and f_o are the leptonic decay constants of the D_s^+ and 0 mesons respectively.

The dimensionless strong decay constant $g \circ i$ is related to the corresponding decay rate by

where K $^{\circ}$ is the C \cdot M \cdot m om entum in the $^{\circ}$ rest frame of the nal state.

3). For m asses, w idths and CKM m atrix elements we use the values collected by the Particle D ata G roup [4]. The quantity f_{D_s} is choosen to be $f_{D_s} = 280$ M eV consistent with recent experimental data [4] and theoretical expectations. For the decay (1300)! we use [4]

and we leave $f \circ as$ a free param eter. For a_1 we take $a_1 = 126$ [9].

In the following, we use the simple energy dependence m (s) = ${}^p \bar{s}$ (m 2) for the widths, although more sophisticated expressions have been proposed [5, 6]. Because of the not too large dierence between the 0 and D ${}^+_s$ m asses, we expect the sensitivity of Eqs.(13) and (16) to dierent forms of 0 (m ${}^2_{D_s}$) to be relatively modest.

We now write the branching ratio B (D $_{\rm S}^{+}$! 0 +) in the form

Theoretical value for $f \circ$, as large as 40 M eV, seem s to be overestim ated in the literature [7]. Eq.(20) gives, to our know ledge, the rst experimental information on $f \circ$, and our result is compatible with theoretical calculations using non-relativistic chiral quark model [10] or QCD sum rule technique [11].

4). We now take into account the non-zero meson width e ect. The production of the quasitwo body state 0 + is followed by the decay 0 ! + . For the nal state + + , E₁ and E₂ are the + energies and E₃ is the energy. The decay amplitude for D_s ! 0 + ! + is given by

The energy dependence of the meson width has been taken as explained previously and the factor $\frac{1}{2}$ in Eq.(22) is due to the presence of two identical + in the nal state.

The dimensionless constant g is related to the meson width by

It is straightforward to estimate the importance of the non-zero 0 m eson width. The result is obviously independent of g_{D_s} and comparing Eq.(12) and (22) we get

1). We consider now the quasitwo body nal state f_0 (980) $^+$. Since two body decay amplitude has a mass dimension, let us write the transition matrix element for spinless particles in the form,

2). The considerations made in the introduction concerning the quark content of the f_0 (980) meson can be tested in the decay of interest here, D_s^+ ! f_0^- . Let us rst assume that f_0 (980) is a $(u\overline{u}+d\overline{d})=\frac{p}{2}$ bound state, then we can show that this assumption is in contradiction with experimental data. Indeed under such assumption, the only possible mechanism for both decays D_s ! f_0^- and D_s ! is the WA and the coupling constant $g_{D_sf_0}$ is obtained from a diagram similar to the one of Fig.1 where the 0 is replaced by the f_0 . It is straightforward to derive a relation between the two weak coupling constants

in complete disagreem ent with the observed experim ental value Eq.(9).

It follows that the dom inant component of f_0 (980) cannot be $(u\overline{u}+d\overline{d})=\frac{p}{2}$ and a large $s\overline{s}$ component must be present. In fact such an $s\overline{s}$ component will be responsible for the observed strong decay mode f_0 ! K \overline{K} .

3). Having shown that f_0 (980) is mainly a pure $s\bar{s}$ state by both considerations based rathy on its decay modes into K \bar{K} , secondly on those of D $_s^+$ into f_0 (beside the mixing in the $J^{PC}=0^{++}$ SU (3)

avor nonet argum ent m entioned previously in the Introduction), the dom inant decay m echanism for the mode D $_{\rm s}^+$! f_0^- is then the spectator diagram. The weak coupling constant $g_{\rm D_sf_0}^-$ is now computed from the diagram of Fig 2 and the result is

where $F_0^{D_sf_0}(q^2)$ is the D_s ! f_0 hadronic form factor in the BSW notation associated to the spin zero part of the weak axial vector current. Using the experimental branching ratio B (D_s^+ ! f_0^-) in Eq. (9), we deduce the value of the hadronic form factor $F_0^{D_sf_0}$ (m²)

Of course, j j 1, such that the true form factor is $F_0^{D_s f_0}$ (m²) j 0.36⁺ 0.08.

It is interesting to compare this phenom enological value with the similar one coming from the well measured D_s^+ ! + decay mode. In the ideal mixing situation close to reality, the meson is a pure $s\bar{s}$ state and the decay D_s^+ ! + is described by the spectator mechanism involving the hadronic form factor $A_0^{D_s}$ (m²). Using the experimental result quoted in Eq.(6) we obtain an experimental value for $A_0^{D_s}$ (m²)

Of course this form factor is larger than the one previously obtained for $F_0^{D_s f_0}$ (m²), but there are no reasons why they should be equal.

However let us rem ind that both $F_0^{D_sf_0}$ and $A_0^{D_s}$ are determined by the factorization method. It is possible that non-factorization contributions will change these numerical estimates in a sizable way, unfortunately, to our knowledge, a convincing approach to compute the non-factorization term is not yet available.

The result of our calculation of I ($^+$ $^+$)_{TOT} directly gives the total branching ratio by the relation (62) and is represented in Figs.3 as a function of the phase parameter $_{\rm N\,R}$ for the two extrem e cases = 0 and = 1. The one standard deviation domains can be compared with the experim ental result of Eq.(7).

It is clear from Fig.3-a corresponding to a two component model (= 0), and Fig.3-b where a maxim al 0 + contribution has been added (= 1), that there is no diculty in thing the experimental result (7) within one standard deviation, for any value of the phase parameter $_{NR}$.

Energy distributions of the pion in D_s^+ ! + + decay

1). The two $^+$ m eson energies being E $_1$ and E $_2$ with our convention of section II, the function F (E1; E2) introduced in section V is symmetrical in the exchange of E1 and E2. Such a property extends to the Dalitz plot which is a double di erential distribution proportional to \mathcal{F} (E₁; E₂) \mathcal{F} . However it is probably premature to discuss the detailed properties of the Dalitz plot and it is more realistic to consider single di erential quantities like the meson energy distributions.

We must keep in mind that a distribution in the pion energy E_j is just the mirror of a distribution in the invariant two pion mass squared s_j because of the relations (1), $s_j = m_{D_s}^2 + m^2$ $2m_{D_s}E_j$.

The $^+$ energy distribution G $_+$ (E $_1$) and the energy distribution G (E₃) for all + + have been computed performing a single variable integration with the relevant functions de ned in section V, H_{f_0} (E_1 ; E_2) 2 , H (E_1 ; E_2) 2 , H_{f_0} (E_1 ; E_2), H (E_1 ; E_2), and H (E_1 ; E_2) H_{f_0} (E_1 ; E_2). We observe that the last three integrals are complex with an energy dependent phase and, as a consequence, the nature of constructive or destructive of the various interferences is an energy dependent

concept. The term $s\,F_{N\,R}$, A_{f_0} , and A are treated as in section V with their moduli extracted from the measured branching ratios. The two extreme cases = 0 and = 1 have been considered.

It is clear that the shape of the $\,$ m eson energy distributions G_+ (E_1) and G_- (E_3) depends on the constant phase of the non resonant amplitude F_{NR} in a very sensitive way. We notice in [1] that we have a Dalitz plot in the ($s_1; s_2$) plane corresponding to the (68:1 12:4) events observed in D_s^+ ! + decays. A projection of this Dalitz plot on the s_1 axis shows clearly a peak associated to the f_0^- quasi two body state and an important background. Of course, such an histogram in [1] is nothing but our + m eson energy distribution G_+ (E_1).

The G_+ (E_1) distribution has been studied for values of $_{N\,R}$ between 0^0 and 360^0 . Comparing our theoretical curves with the shape of the experimental histogram [1], we obtain an acceptable agreement if the angle $_{N\,R}$ is in the range

In the non resonant component, the last phase is $_{NR}$. We observe that the value $_{NR}$ = 90° compatible with the range (79) makes the quantity iF_{NR} real and negative. In the absence of more detailed experimental informations we shall make a simple choice $_{NR}$ = 90° in what follows.

We have represented in Figs.4 and Figs.5 the pion energy distributions G_+ (E₁) and G_- (E₃) for the two cases = 0 and = 1 using $_{NR} = 90^{\circ}$. For completeness we give the theoretical branching ratios corresponding to $_{NR} = 90^{\circ}$ which can be directly extracted from Figs.3.

Both values Eqs.(80) and (81) agree with the experimental one of Eq.(7), $(1.54 \ 0.42)$ %.

VII. Predictions for D $_{\rm s}^{+}$! 000 + decay mode.

We have no experim ental data on the decay mode D $_{\rm s}^+$! O 0 + . However we shall use the same three component model for this decay mode and let us start our discussion with isospin considerations concerning these three components.

1). Consider st the case of a non resonant 0 0 $^{+}$ state. The constant F_{NR} has no reason to be the same for the two modes $^{+}$ $^{+}$ and 0 0 $^{+}$. By assumption, with a constant function

 F_{NR} (E₁;E₂), we have a full symmetry in space between the three pions. From the Bose-Einstein symmetry, the isospin conguration has also to be totally symmetric. Consider now a third rank fully symmetric tensor in a three dimensional space. It has 10 independent components. With respect to the isospin SO (3) orthogonal group, such a tensor is reducible into an isospin I = 3 part with 7 components and an isospin I = 1 part with 3 components. In our speciec Wightham annihilation model for the non resonant three pions, only the later part contributes, the und weak current being an isovector. By inspection of the relevant Clebsch-Gordan coecients, we get the result

The 0 and $^{+}$ energy distributions $G_{0}(E_{1})$ and $G_{+}(E_{3})$ for the nal state 0 0 $^{+}$ are computed with the formulae (76) and (77) using now the function $F(E_{1};E_{2})$ given in Eq.(88). The procedure of calculation is similar to the one explained in section VI for the $^{+}$ $^{+}$ nal state.

We have represented respectively in Figs.7 and 8 the 0 and $^+$ energy distributions $G_0(E_1)$ and $G_+(E_3)$ for the two extreme situations = 0 and = 1, using as previously the phase $_{NR} = 90^0$ for the non resonant amplitude. Figs.8 show clearly the peak due to the quasitwo body f_0^+ state and a possible quasitwo body $_0^+$ contribution is clearly seen in Fig.7-b.

Let us end by considering the $\,$ m eson energy distribution corresponding to an uniform ly populated phase space of a constant amplitude. The energy distributions for each pion are obviously identical and in the case D $_{\rm S}^{+}$! ($^{+}$) $_{\rm N\,R}$ we obtain, using Eq.(5), the analytic form

U sing the experimental value (54) of \mathcal{F}_{NR} $\hat{\mathcal{F}}$, we obtain the distribution represented in Fig.9.

VIII. Sum mary and Concluding Remarks

We have studied, in this paper, the decay of the D $_s^+$ m eson into three mesons by analyzing the experimental data available for the decay mode D $_s^+$! + The amplitude can be considered as the superposition of two mechanisms: the spectator decay of the c quark contained in the D $_s^+$ meson and the W $_s^+$ annihilation into three pions. Both mechanisms are needed to explain the data and the latter appears to be considerably important.

The non observation of the quasitwo body state allows us to determ ine an upper limit of about 10 M eV for the leptonic decay constant $f \circ$ of the (1300) m eson. Such an upper bound of $f \circ$ is compatible with theoretical estimates using non-relativistic chiral quark model [10] and QCD sum rule technique [11]. We remark that the commonly used values of the $f \circ$ decay constant [7] are much larger than our upper limit.

The large f_0 ⁺ branching ratio compared to the 0 ⁺ one allows us to exclude the dominant $(u\overline{u}+d\overline{d})=\frac{p}{2}$ quark structure for the f_0 (980) m eson. A ssum ing the f_0 (980) to be a $s\overline{s}$ state, the spectatorm echanism will govern the decay D_s^+ ! f_0 (980) ⁺ and from experimental data it is possible to estimate the hadronic form factor $F_0^{D_sf_0}$ (m²) to be $0.36^{+0.06}$.

Furtherm ore, a large branching ratio of the D $_s^+$ m eson into a non resonant three pion state has been experim entally m easured. This decay can only proceed through the WA and the corresponding decay amplitude is assumed to be independent of the meson energies. We then introduce a phenom enological complex constant F_{NR} , its modulus is extracted from the non resonant branching ratio $B(D_s^+ ! + D_{NR}^+)$.

For the full decay amplitude, we propose a three component model involving the non resonant

background, the f_0 ⁺ quasitwo body state, and a possible quasitwo body state with a parameter such that for = 1, the branching ratio B (D $_{\rm S}$! $_{\rm O}$ ⁺) takes the value of the 90% con dence level upper limit. We rst compute the total rate for D $_{\rm S}$! $_{\rm O}$ ⁺ as a function of the phase $_{\rm N\,R}$ of the constant amplitude $F_{\rm N\,R}$. A green ent with experiment is obtained, within one standard deviation, in both cases = 0 and = 1, for all values of $_{\rm N\,R}$ between $_{\rm O}$ 0 and $_{\rm O}$ 0.

For the decay mode D $_{\rm s}^+$! $_{\rm NR}^+$, we compute the $_{\rm NR}^+$ and energy distributions which depend on the phase parameter $_{\rm NR}$. A qualitative agreement between our $_{\rm NR}^+$ distribution with the experimental histogram [1] in the invariant ($_{\rm NR}^+$) mass is obtained when $_{\rm NR}^+$ is restricted in the range given by Eq.(79) including $_{\rm NR}^+$ = 90°. Fixing now $_{\rm NR}^+$ = 90°, we present our predictions for the $_{\rm NR}^+$ and energy distributions including one standard deviation errors deduced for those of the experimental rates.

The same model is used to make preditions for the decay mode D_s^+ ! 0 0 $^+$ which is not yet experimentally observed. The total rate for D_s^+ ! 0 0 $^+$ is found to be essentially one order of magnitude smaller than the D_s^+ ! $^+$ rate and this might be the reason why the decay D_s^+ ! 0 0 $^+$ has not yet been detected. Also the 0 and $^+$ energy distributions are predicted by our model.

If the quasi two body states f_0 and can be theoretically understood, the non resonant part has been treated, in this paper, only from a purely phenomenological view point, using a constant complex parameter $F_{N\,R}$. It would be interesting to explain theoretically the experimental values found for $F_{N\,R}$ jand $_{N\,R}$. To our knowledge no model has been proposed for such case.

The detailed understanding of the W A is very important in its own right, and for that purpose, the D $_{\rm s}^+$, like the B $_{\rm c}^+$, are particularly auspicious for W A to manifest in its full strength due to both color and CKM favored factors. In all other cases, i.e., D $_{\rm s}^+$; D $_{\rm s}^0$; B $_{\rm s}^+$; B $_{\rm s}^0$; and B $_{\rm s}^0$, the W A is either masked by the color and CKM suppressed factors, or contaminated by the spectator decay mechanism at the quark level, such that unambiguous W A extra behardly isolated. Therefore experimental and theoretical investigations of the D $_{\rm s}^+$ (and the B $_{\rm c}^+$ later) decays into pions, in both inclusive and exclusive modes, are of great interest. They are the ideal laboratories for studying the weak annihilation mechanism .




Figure 1: W annihilation mechanism for $D_s^+ \to \rho^0 + \pi^+$ decay mode.





Figure 2: Spectator mechanism for $D_s^+ \to f_0 + \pi^+$ decay mode.






Figure 3: Total branching ratio for the decay $D_s^+ \to \pi^+\pi^-\pi^+$ as a function of the phase parameter ϕ_{NR} , (a) in the two component model : $\lambda = 0$, (b) in the three component model with the maximal $\rho\pi^+$ contribution : $\lambda = 1$. One standard deviation errors are indicated and the horizontal bound is the experimental result including one standard deviation errors.




Figure 4: The π^+ meson energy distribution function $G_+(E_1)$ for the final state $\pi^+\pi^-\pi^+$, (a) for $\lambda=0$ in the two component model, (b) for $\lambda=1$ in the three component model with the maximal $\rho\pi^+$ contribution. One standard deviation errors are indicated. Here the quantity $E_{f_0}=0.7453~GeV$ is associated to the f_0 resonance and $E_{\rho}=0.8386~GeV$ is associated to the ρ^0 resonance.





Figure 5: The π^- meson energy distribution function $G_-(E_3)$ for the final state $\pi^+\pi^-\pi^+$, (a) for $\lambda = 0$ in the two component model, (b) for $\lambda = 1$ in the three component model with the maximal $\rho\pi^+$ contribution. One standard deviation errors are indicated.







Figure 1: Total branching ratio for the decay $D_s^+ \to \pi^0 \pi^0 \pi^+$ as a function of the phase parameter ϕ_{NR} , (a) in the two component model : $\lambda = 0$, (b) in the three component model with the maximal $\rho \pi^+$ contribution : $\lambda = 1$.






Figure 2: The π^0 meson energy distribution function $G_0(E_1)$ for the final state $\pi^0\pi^0\pi^+$, (a) for $\lambda=0$ in the two component model, (b) for $\lambda=1$ in the three component model with the maximal $\rho^+\pi^0$ contribution. One standard deviation errors are indicated. Here the quantity $E_{\rho}=0.8386~GeV$ is associated to the ρ resonance.




Figure 3: The π^+ meson energy distribution function $G_+(E_3)$ for the final state $\pi^0\pi^0\pi^+$, (a) for $\lambda = 0$ in the two component model, (b) for $\lambda = 1$ in the three component model with the maximal $\rho^+\pi^0$ contribution. One standard deviation errors are indicated. Here the quantity $E_{f_0} = 0.7453~GeV$ is associated to the f_0 resonance.




Figure 4: The π meson energy distribution $G_{NR}(E)$ for the non resonant part of the decay $D_s^+ \to \pi^+\pi^-\pi^+$. One standard deviation errors are indicated.
