Cheshire Cat Scenario in a 3 + 1 dim ensional Hybrid Chiral Bag

Abstract

The total energy in the two-phase chiral bag model is studied, including the contribution due to the bag (C asim ir energy plus energy of the valence quarks), as well as the one coming from the Skyrm ion in the external sector.

A consistent determ ination of the parameters of the model and the renorm alization constants in the energy is performed.

The total energy shows an approximate independence with the bag radius (separation limit between the phases), in agreement with the Cheshire Cat Principle.

The hybrid chiral bag [1, 2] is an elective model to describe the behavior of strongly interacting baryons. In this model, color degrees of freedom are conned to a bounded region and coupled to a bosonic external eld (skyrmion) through boundary conditions.

These two phase models are intermediate between two successful descriptions of baryons: bag models [3, 4] { with QCD degrees of freedom at short distances { and Skyrm e model [5, 6, 7], an e ective (non renormalizable) nonlinear sign a model, useful when the low energy properties of baryons are considered.

An interesting feature of Chiral Bag M odels (CBM) is the appearance of the so called Cheshire Cat Principle (CCP) [1, 8], according to which ferm ionic degrees of freedom can be replaced by bosonic ones in certain regions of space, the resulting position of the lim it of separation between the two phases having no physical consequences.

In 1+1-dimensions, the Cheshire C at behavior follows from the bosonization of ferm ionic elds [1]. In the 3+1 case, topological quantities, such as the baryonic number, have a similar behavior [9] but, for non topological ones, the CCP is expected to be only approximately valid.

In what follows, we will study the energy of a four-dimensional hybrid model consisting of quarks and gluons con ned to a spherical bag plus a truncated exterior Skyme eld in a hedgehog con guration. It is our aim to study the dependence of the total energy on the size of the bag, thus testing the Cheshire C at hypothesis.

In bag models, quarks and gluons are conned to a bounded region that, in our case, will be taken as an static sphere of radius R. A dequate boundary conditions are imposed on the eld so as to guarantee the vanishing of the ux of color current to the external sector.

In the M IT bag m odel β the boundary conditions for ferm ions and gluons are

The D irac operator for the ferm ionic eld, together with the boundary condition (1) de ne an elliptic boundary value problem [10]. M oreover, (1) gives a vanishing current at the boundary, $n_{\rm R} = 0$. But the axial symmetry, present in QCD with massless quarks, is broken at the boundary when condition (1) is satistical. To avoid such unwelcome behavior, CBM [4] have been proposed, which amount to imposing on the fermionic eld the boundary condition

where $_{i}$ are Paulim atrices, and adding an external sector to the bag.

Through this boundary condition, the ferm ionic eld is connected with the external eld represented by the \chiralangle" (R). A sit will be shown later, the external phase can be described using the Skyrm e m odel.

To obtain the energy in the chiral bag model we will proceed in steps, using some results previously obtained in references [11, 12].

In the rst place, we will introduce the di erence between C asim ir energies of chiral and M IT ferm ionic bags. It corresponds to the zero tem perature limit, T ! 0, of the results presented in [11]. As a second step, we will study the reference vacuum energy, i.e., the M IT C asim ir energy, which is the T ! 0 limit of the cases analized in [12] for the ferm ionic and gauge elds. An external Skyrm e eld will then be introduced, so as to complete the two phase m odel (TPM). The caracteristic param eters in its Lagrangian, together with the renorm alization constants in the bag energy, will be determ ined through physical considerations, thus obtaining the total energy of the TPM.

D eterm inants of quotients of elliptic di erential operators under di erent boundary conditions can be expressed as p-determ inants of quotients of Form an's operators [13, 14, 15]. This leads, for a bounded euclidean time, to the study of di erences of free energies of the physical system subject to two di erent boundary conditions. In such a way, in reference [11] the di erence between the free energies of an SU (2) chirally sym etric system of m assless ferm ions, con ned to a spherical region and subject to chiral and M II boundary conditions respectively, was calculated.

To construct Form an's operator, which is totally de ned by its action over functions in the kernel of i @, a discrete basis of the space of solutions was considered. The di erential operator and the boundary conditions are invariant under the diagonal subgroup of SU (2)_{rotation} SU (2)_{isospin}, and leave invariant the subspaces caracterized by the quantum numbers fk; j; l;m g, associated with the eigenvalues of $fK^2; J^2; L^2; K_zg$, where K = L + S + I. In particular, k takes non-negative integer values.

where the Casim ir energies have been adding ensionalized. The rst and second terms in the rh.s. of (4) correspond to the subspaces k = 1. The third and fourth ones, to the k = 0 case. We have used the de nitions

where I (x) is the modi ed Bessel function. In (4), (k;x) represents the rst few term s¹ in the asymptotic (D ebye) expansion of the other term s in the argument of the logarithm, required to isolate the divergent pieces in the C asim ir energy.

In obtaining (4), an analytic regularization of non-absolutely convergent series has been performed through the introduction of the factor s, for < (s) large enough, and then taking the nite part at s = 0 [11], giving rise to the rst term in the rh.s. This procedure leaves an arbitrary nite part proportional to $\sin^2()$, which requires the introduction of the undeterm ined constant K_Q. This amounts to the introduction, in the Lagrangian of the external Skym e eld, of the counterterm [16]

where $L = U^{y} Q U = e^{i (~r)} Q e^{i (~r)}$.

The second and fourth term s of (4) require num erical calculations. In the rst case, the sum over the index k has been cutted when the tail of the series becomes negligible. Integrations in the x variable have been num erically solved in both cases.

As it was said before, the reference (M II) Casim ir energy for ferm ions and that corresponding to gluons have been studied in a complem entary way. In reference [12], the free energy for a ferm ionic and an abelian gauge eld (enough for the 1-loop description of the free energy for gluons) was studied. Such evaluations have been m ade using analytically regularized traces which involve the G reen functions of the boundary problem s considered.

The T ! 0 lim it of the results in [12] has a simple structure. A s it can be understood by dimensional analysis, the Casim ir energy (once singularities

have been removed by the renorm alization of the zero-loop energy) takes the form

where $K_{M IT}$ is the arbitrary nite part left by the renormalization procedure.

We thus have now the total Casim ir energy of the bag, including the correction due to the interaction of ferm ions with the external Skyrm e ed, represented by the chiral angle ,

up to the know ledge of the constants K $_{\rm Q}$ and K $_{\rm M~IT}$. A s we will show later, they can be determined in posing physical conditions in the fram ework of the two phase chiral bag m odel.

A further contribution has to be included if the total inner bag energy (energy of the defect, in the remaining of the paper) is studied.

In reference [9], it has been proved that the valence quark contribution must be taken into account in the 0 =2 region, to obtain the baryon number, B, in the TPM. In fact, when adding the contributions coming from the truncated Skyrm em odel, the D irac sea and the valence quarks, one obtains B = 1 for any value of . This can be understood by studying the energy of the fundam ental eigenstate of the D irac H am iltonian [17]. When

< =2, the fundam ental energy becom espositive and valence quarks leave the D irac sea. In this case, they must be explicitly included. A s regards the bag energy, the valence quark contribution can be written as

where () is the fundamental eigenvalue and H $(\!x\!)$ is the Heaviside step function.

Note that our regularization prescription lead to a nite bag energy (depending on K_Q and $K_{M IT}$). All derived quantities will also be nite. Such is the case of the axial ux through the boundary of the sphere,

where $e_t() = [e_c() + e_q() + K_{M IT}]$. The last term, coming from the MIT bag, is -independent and does not contribute to the axial ux.

As it was proposed in reference [18], the vanishing of the ux when R ! 0 determ ines the K_{Q} renormalized constant. This physical imposition is consistent with the analysis we will perform later, when treating the TPM.

The external phase of the TPM is described by the Skyrm em odel [5, 6]. The lagrangian can be written as

where the scalar eld U (x) takes its values in the SU (2) group.

Two parameters have been introduced here: F , associated with the pion's decay constant (experimental value $F^{exp} = 186 \text{ MeV}$) and e^2 , which represents the strength of the stabilizing term. These parameters will be adjusted later in the framework of the two phase model [2].

The Skyrm ion is a topologically stable classical solution of the Lagrangian in (12), when the whole space is considered. It is given by

where (r) is what we are calling the chiral angle. Spatial and isospinorial indexes are linked in the argument of the exponential.

By the imposition of the boundary conditions

an skyrm ion of topological baryonic number (winding number) B = 1 is obtained (in the pure Skyrm e model).

Replacing the Skyrm e ansatz in the Lagrangian (12), the equation of motion is obtained as a nonlinear di erential equation for (r) [7].

The Skyrm e lagrangian is invariant under SU (2) $_{\rm L}$ $\,$ SU (2) $_{\rm R}$ chiral transform ations

where A and B belong to SU (2). When $A = B^{1}$, we are in the case of axial symmetry leading to the locally conserved axial current. Chiral boundary conditions guarantee its conservation even at the boundary, when the TPM is considered.

The ux of the axial current through an sphere of radius r, in terms of the adim ensionalized radius $\hat{\mathbf{r}} = \frac{eF}{2}\mathbf{r}$, is given by

It is not di cult to show that, when R $!~0~(~!~;~^0<1~)~^{\rm Sk}~!~0$. It is reasonable to extend such behavior to the ~ux from the inner ferm ionic phase, using this criterium to determ ine the value of the renorm alized constant K $_{\rm Q}$.

In the TPM, the Skym ion is truncated to the exterior of an sphere of radius R. In the R ! 0 lim it, the pure skym ion should describe the baryon properties. The contribution $K_{M IT} = R$ to the Casim ir energy is forbidden in such scheme. Then, the validity of the hybrid chiral model, even in the R ! 0 lim it, in poses $K_{M IT} = 0$.

Once our renorm alization scheme has been established, a t can be proposed for the num erically evaluated C asim ir energy. Following [18] we propose

The required vanishing of the axial ux of ferm ions in the R ! 0 limit inmediately leads to

thus elim inating the contribution proportional to $()^2$ for R ! 0.

Having xed the renorm alized constants, the energy of the inner phase is as shown in Figure 1.0 ur results are totally consistent with those presented in [18]. The symmetry of the Casim ir energy (dashed line) about = =2 is

evident. Such property was a priori expectable from simple properties of the eigenvalues of the D irac ham iltonian of the m odel.

In the same gure, the solid line represents the total energy of the inner phase (when the valence quark contribution is also taken into account). As in reference [18], the resulting interior energy is a smooth function.

In the TPM picture, the axial ux through the boundary of the defect should be continuous for all values of the bag radius. So, a ne tunning of the strength of the stabilization term e(R) must be performed to ensure

To impose this condition, the know ledge of the chiral angle as a function of R, (R), is necessary. As it was said, its value can be obtained num erically,

by solving a nonlinear di erential equation. But, following the proposition of M. Atiyah and N. M anton [19], U (x) con gurations can be constructed by evaluating the holonomy of Yang-M ills elds with topological charge k, in the time direction. This is derived from a t'H ooft instanton of width .

For the k = 1 case, the resulting chiral angle is

Replacing $(\hat{\mathbf{r}})$ in the energy of the skyrm ion [7]

and m inim izing with respect to $\hat{}$, the value of this parameter is xed to $\hat{}$ = 1:452 [19]. The resulting probe is very close to the one obtained num erically. For computational convenience, we will use this approximation for the rest of the paper.

W ith the Atiyah-M anton pro le, equation (19) gives

when parametrized by the chiral angle .

W hen the ! (R ! 0) lim it is taken, the stabilization strength for the pure skyrm ion is obtained

to be compared with the value e = 5.45 obtained by G.S.Adkins, C.R.N appiand E.W itten by the masses of the nucleon and the particle.

Now, the value of F can be xed in the scheme proposed in [7]. Having e and the nucleon mass $M_n^{exp} = 938M \text{ eV}$, expression (9) of [7] (with and M calculated for the Atiyah-M anton pro le) leads to F = 99:59M eV. This value, far from the experimental one, is, however, near F = 129M eV

obtained in [7]. As a consistency check, the particle mass has been calculated with our parameters, giving M = 1206 MeV (experimental value: $M^{\text{exp:}} = 1230 \text{ MeV}$).

The calculations just detailed complete the determ ination of the param – eters of the Skyrm e model, in a consistent way with the TPM under study. Now, recovering the dimensional variable r, the strength e(R) is as shown in Figure 2.

To complete our task, the energy contained in the Skyrm e external sector must be evaluated. To do this calculation, the integral in (21), with the lower lim it truncated to the radius of the defect, must be studied. We have perform ed the num erical evaluation of this quantity using the A tiyah-M anton pro le and the parameters of the Skyrm emodel F and e(R), thus obtaining

the energy in the Skym e sector as a function of the defect radius.

Figure 3 is the main result of this paper. It shows in dashed lines, from top to bottom, the energy of the external Skyrm e phase and the energy of the defect, as functions of the position of the limit between the phases. Also shown, in solid line, is the total energy of the hybrid chiral bag model. This last shows a remarkable independence with the bag radius (for $0 \ R \ 1 \ fm$), as suggested by the CCP.

Sum m arizing, we have employed the results presented in [11, 12] for the internal C asim ir energies in a chiral bag m odel. In these papers, by the use of analytical regularizations, a renormalized C asim ir energy, dependent on the K_Q and K_{M IT} constants, was obtained. In the present paper, a TPM was completed, by introducing an external Skyrm e phase. The renormalized

constants K $_{\rm Q}\,$ and K $_{\rm M~IT}$, as well as the param eters F $\,$ and e (R) of the truncated Skyrm e Lagrangian were determ ined according to physical conditions, suitable for the TPM .

In reasonable agreement with the Cheshire Cat hypothesis, the total energy of this model shows an approximate independence with the bag radius (separation limit between the phases) in the range of $0 \, R \, 1 \, \text{fm}$.

The study of CBM at nite temperature [20, 21] is an interesting e ective approach to the analysis of decon nement transitions. In those references, succesive approximations to the problem, based on the validity of the Cheshire Cathypothesis at T = 0 have been made. The present results give a ground to such hypothesis, thus making it sensible to look for the presence of decon nement transitions only in the temperature-dependent contributions to the free energy of the bag.
