MAGNETIC CONFINEMENT AND SCREENING MASSES

A bstract

Con ned and decon ned phases are de ned through nonperturbative correlators and nonperturbative background perturbation theory is used to compute the critical temperature $T_{\rm c}$ and spatial string tension. Taking evolution along one of the spatial axes the set of H am iltonians H $(n_1;n_2)$ with dierent M atsubara frequencies is obtained.

M eson and glueball screening m asses and wave functions are computed for H (0;0) and compared with available lattice data.

1. Finite tem perature QCD, and in particular the dynam ics of decon nem ent phase transition and the physics beyond the critical tem perature $T_{\rm c}$ is an important testing ground for our ideas about the nature of the QCD vacuum.

During the last few years, a lot of lattice data have appeared which point to the nonperturbative character of dynam ics above T_c . To this belong i) the area law of spatial W ilson loops [1,2], ii) the screening m assess of m esons and baryons [3-5] and glueballs [6], iii) the temperature dependence of Polyakov (line correlators [7-9]. In addition, the behavior of " 3p above T_c has a bump incompatible with the simple quark (gluon gas picture [10]. Thus the inclusion of nonperturbative (NP) con gurations into QCD at T > 0 and also at T > T_c is necessary.

One of the authors has developed a system atic method for QCD, treating NP elds as a background and performing perturbative expansion around that both for T=0 [11] and T>0 [12].

To describe the phase transition, a simple choice of decon ned phase was suggested [12] where all N P color magnetic con gurations are kept intact as in the con ned phase, whereas color electric correlators that are responsible for con nement vanish.

This picture together with the background perturbation theory [11,12] forms a basis of quantitative calculations, where eld correlators (condensates) are used as the NP input.

As an immediate check one computes T_c for a dierent number of avours n_f in good agreement with lattice data. One purpose of the present letter is to treat quantitatively the points i)-iii) systematically in the framework of the samemethod. Doing so we meet some limitations. First, in the description of the deconned phase in the spirit of the aforementioned method [12], one uses the magnetic correlators (and spatial string tension $_s$) from the lattice calculations [1,2]. In the conned phase below T_c and up to the temperatures T 1:5 T_c in the

decon ned phase these correlators are practically the same as are known for T=0. Therefore in the mentioned tem perature region the spatial string tension $_{\rm S}$ is regarded as T { independent and coincides with the standard string tension $_{\rm S}$ at T=0. This is because the main dynamics (and contribution to the free energy) is due to the scale anomally which essentially changes at the tem perature of the order of the dilaton mass, i.e. at T<1GeV. However, at large T, a new physics sets in: that of dimensional reduction, which causes $_{\rm S}$ to grow [2,13]. For tem peratures larger than $1.5~T_{\rm C}$ we have used the scaling behavior of $_{\rm S}$ (T) from [2], that is consistent with the dimensional reduction regime. We can no ourselves to the region 0 T<2 3T and consider problem $_{\rm S}$ i)—iii) point by point.

The second limitation is of technical character, since the proposed method is used for simplicity in conjunction with the 1=N $_{\rm c}$ expansion. Therefore values of T $_{\rm c}$ are computed in the leading and subleading orders of 1=N $_{\rm c}$ expansion and strictly speaking the conclusion obtained for the rst order of decon nement phase transition cannot be extended to N $_{\rm c}$ = 2.

To calculate the screening masses one should rst write the Green function of quark { antiquark (qq) or two gluons (gg) in terms of the Wilson loop average [14,15] and derive from it the Ham iltonian taking evolution along one of the spatial axes. In fact, one obtains a set of Ham iltonians, containing all higher Matsubara frequencies. Our results for mesons in general agree with one of the choices adopted before in [17], and justify in that special case the conning ansatz made there.

Of special importance are the gg Ham iltonian and the corresponding glueball screening masses (G SM). Here the lowest M atsubara frequency is zero and the next one is 2 T. Therefore within our picture only the nonperturbative interaction between gluons { spatial string tension { determ ine the temperature behavior of the lowest G SM. In contrast to that, the meson screening masses for the lowest states have an additional temperature dependence through the lowest M atsubara frequency.

We calculate the GSM corresponding to lowest states and compare our results with recent lattice data [6]. With the scaling behavior $_{\rm S}$ (T) [2] GSM forms the similar pattern to that of the meson case. This picture is in agreement with existing lattice data [7-9].

2. We derive here the basic formulas for the partition function, free energy and G reen function in the nonperturbative background formalism at T > 0 [12]. The total gluonic eld A is split into a perturbative part a and a nonperturbative background B

where both B and a are subject to periodic boundary conditions. The principle of this separation is imm aterial for our purposes here, and one can average over elds B and a independently using the 'tHooft's identity 1 (form ore discussion see [18])

with arbitrary weight (B). In our case we choose (B) to x the eld correlators and the string tension at their observed values. For simplicity have omitted gauge x ing and ghost term s in (2).

To the lowest order in ga the partition function and free energy are

where $\hat{W} = D^2$ (B) $20\hat{F}$ and D^2 (B) is the inverse gluon and ghost propagator, respectively, (t) is a regularizing factor [12].

The ghost propagator can be written as [11,12]

with = 1=T. For the gluon propagator an analogous expression holds true, except that in (4) one should insert the gluon spin factor P_F exp2gF into (x;y). For a quark propagator the sum over windings in (5) acquires a factor (1) and the quark spin factor is expg F [12].

We are now in a position to make the expansion of Z and F in powers of ga (i.e. perturbative expansion in $_{\rm s}$), and the leading {nonperturbative term Z_0 ; F_0 { can be represented as a sum of contributions with dierent N $_{\rm c}$ behavior of which we system atically will keep the leading term s 0 (N $_{\rm c}^2$); 0 (N $_{\rm c}$) and 0 (N $_{\rm c}^0$).

To describe the tem perature of decon nem ent phase transition one should specify the phases and compute the associated free energy. For the conning phase to lowest order in $_{\rm s}$, the free energy is given by Eq.(3) plus contribution of the energy density " at zero temperature

and the next terms in (6) correspond to the contribution of mesons (we keep only pion gas) and glueballs. Note that " = 0 (N $_{\rm c}^2$) while two other terms in (6) are 0 (N $_{\rm c}^0$).

For the high tem perature or second phase we make an assumption that there all color magnetic eld correlators are the same as in the rst phase, while all color electric elds vanish. Since at T=0 color magnetic correlators (CMC) and color electric correlators (CEC) are equal due to the Euclidean O(4) invariance, one has

The vanishing of $_{\rm E}$ implies that gluons and quarks are liberated, and this will contribute to the free energy in the decon ned phase via their closed loop terms (3), (4) with all possible windings. The CMC entervia the perimeter contribution < (x;x) > (x;x

where $_{q}$ and $_{g}$ are perimeter terms for quarks and gluons, respectively, the latter was estimated in [22] from the adjoint Polyakov line. In what follows we replace by one for simplicity.

Comparing (6) and (10), and setting F (1) = F (2) at T = T_c , one nds to order 0 (N $_c$), disregarding all m eson and glueball contributions

For the standard value of G_2 $\stackrel{\circ}{-}$ < F^2 >= 0.012G eV 4 [19] (note that for n_f = 0 one should use an approxim ately 3 times larger value of G_2 [19]) one has for SU (3) and different values of n_f = 0;2;4, respectively T_c = 240;150;134: This should be compared with lattice data [10] T_c (lattice) = 240;146;131. The agreement is quite good. Note that at large N_c , one has T_c = 0 (N_c^0), i.e. the resulting value of T_c does not depend on N_c in this limit. Hadron contributions to T_c are 0 (N_c^2) and therefore suppressed if T_c is below the Hagedom temperature, as typically happens [23].

3. In this section we derive the area law for spatial W ilson loops, expressing spatial string tension in terms of CMC.

For temporal W ilson loops, in the plane i4; i=1;2;3; only color electric elds $E_i=F_{i4}$ enter in (12), while for spatial ones in the plane ik; i;k=1;2;3 there appear color magnetic elds $B_i=\frac{1}{2}e_{ik1}F_{k1};$ in the standard way [21], one obtains the area law for large W ilson loops of size L, L $T_{\alpha}^{(m)}$ ($T_{\alpha}^{(m)}$) is the magnetic correlation length)

and n is the component normal to the plane of the contour, while the last term in (14) denotes the contribution of the fourth and higher order cumulants. On general grounds, one can write for the integrand in (14)

This holds sim ilarly for the tem poral W ilson loop in the plane i4, so that one has the area law for $T < T_c$ with tem poral string tension

For T = 0 due to the 0(4) invariance, CEC and CMC coincide and $_{\rm E}$ = $_{\rm S}$. For T > T $_{\rm C}$ in the phase (2) CEC vanish, while CMC change on the scale of the dilaton mass 1G eV. Therefore one expects that $_{\rm S}$ stays intact till the onset of the dimensional reduction mechanism. This expectation is con rmed by the lattice simulation { $_{\rm S}$ stays constant up to T 1:4T $_{\rm C}$ [1,2]. Recent lattice data [2] show an increase of $_{\rm S}$ at T 2T $_{\rm C}$ for SU (2), which could imply the early onset of dimensional reduction.

4. In this section we consider the qq and gg G reen functions G (x;y) at $T > T_c$ and derive corresponding H am iltonians for evolution in the spatial direction. We start with the Feynm an $\{Schwinger representation\ [24]\ for\ G\ (x;y),\ where for\ sim\ plicity\ we neglect\ spin\ interaction\ term\ s$

Here K and (D z) $_{xy}^{W}$ are de ned in (5) and < W (C) > in (12), where the contour C is formed by paths z(), z() and t x y is for de niteness taken along the 3'rd axis. Since by de nition at T > Tc electric correlators are zero, only elements d in (12) in planes 12,13 and 23 contribute. As a result one obtains for < W (C) > the form (13) with

As a next step one can introduce the "dynam ical masses"; similarly to [14,15]. We are looking for the "cm" Ham iltonian which corresponds to the hyperplane where $z_3 = z_3$. Note that z_4 ; z_4 are not governed by NP dynam ics and enter A only kinematically (through K; K), and hence can be easily integrated out in (23) using Eq.(5) for the 4-th components { with $(x y)_4 = 0$ (see [18] for more detail).

de ne the so{called screening masses and corresponding wave{functions, which have been measured in lattice calculations [3-6].

The lowest mass sector form esons is given by H $_{00}$, where for $n_1=n_2=0$ one has $b(n_1)=b(n_2)=1$ in (32). For light quarks one can put m $_1=m_2=0$ and expand at large T square roots in (32) to obtain

A ssum ing the param etrization $\frac{P_{-s}}{s} = cg^2(T)T$ with c being numerical constant dierent for SU (2) and SU (3) [2] and the scaling behavior of $g^2(T)$, one has M $_{00}$ 2 T + O ((ln (T= $_T$)) $^{4=3}T$) tending to twice the lowest M atsubara frequency, as was suggested before in [26]. (This lim it corresponds to the free quarks, propagating perturbativly in the space{time with the imposed antiperiodic boundary conditions along the 4th axis). Eq. (34) coincides with that proposed in [17], where also numerical study was done of M $_{00}$ and $'_{00}(r)$ O ur calculations of Eq. (33–34) for SU (3) with c=0.586 [2] agree with [17] and are presented in Fig.1 together with lattice calculations of $'(r)_{00}$ for {m eson [5]. The values of M $_{00}$ (T) found on the lattice [3,4] are compared with our results in Fig.2. Note, that our M $_{00}$ (34) does not contain perimeter corrections which are signicant. Therefore one has to add the meson constant to M $_{00}$ to compare with lattice data. We disregard the spin {dependent and one-gluon-exchange (0 GE) interaction here for lack of space and will treat this subject elsewhere [18]. It is known [17], however, that 0 GE is not very in portant at around T 2 7 C.

We note that the lowest meson screening mass appears also in Yukawa type exchanges between quark lines and can be compared with the corresponding masses in Yukawa potentials.

The eigenvalue E () of h () should be m in im ized with respect to and the result E ($_0$) is known to yield the eigenvalue of (35) within a few percent accuracy [27]. The values E ($_0$) M $_{qq}$ thus found are presented in Fig 2. The corresponding wave functions $'_{00}$ (r) are given in

Fig.1. These data can be compared with the glueball screening masses, found on the lattice in [6].

A nother point of comparison is the Polyakov line correlator

It is easy to understand that $M = M_{gg}$ and one can compare our results for the GSM M_{gg} (T) with the corresponding lattice data for M in Fig 2.

Taking again into account an unknown constant perim eter correction to our values of M $_{gg}$, one can see a reasonable qualitative behavior. We refer the reader to another publication for m ore detail [18].

In addition to the purely nonperturbative source of G SM described above there is a competing mechanism { the perturbative formation of the electric D ebye screening mass $m_{el}(T) = gT(\frac{N_c}{3} + \frac{n_f}{6})$ for each gluon with g(T) given by the temperature dependence of g(T) = gT(T) another H am iltonian, which is obtained from (32) replacing g(T) = gT(T)

It turns out that up to tem peratures T $2T_c$, one can consider the e ect of m_{el} (T) as a small correction to the eigenvalue of (35) E

where a '1:74 and this justi es our nonperturbative treatment of the GSM in the temperature region concerned.

We note that the transition between these two regimes (with the dominance of nonperturbative and then perturbative dynamics) is smooth, with the GSM tending to twice the Debye mass at large T [18].

6. In conclusion, we have pursued a selfconsistent analysis of nonperturbative dynam ics at $T > T_{\rm c}$, including the calculation of $T_{\rm c}$, spatial area law and meson and glueball screening masses. We stress that in both meson and glueball cases, the nonperturbative mechanism plays an essential role in the formation of the screening masses in the temperature region 0 < T < 2 $3T_{\rm c}$, while at large T, the lowest screening masses tend to the corresponding limits, governed by perturbative dynamics. We obtain in all cases a reasonable agreement with known lattice data supporting our picture of magnetic connement above $T_{\rm c}$, while there is electric connement below $T_{\rm c}$. An additional piece of data is necessary to consmooth our prediction.




Figure 1: W ave functions for the $\{m \in Sn \text{ (solid line) and glueball (dashed line) vs } r=a (a=0.23 \text{ fm) for } T=210 \text{ M eV}$. The data from ref.[5] correspond to T 210 M eV.




Figure 2: The screening m asses for m esons (solid line) and glueballs (dashed line) as a function of tem perature. The data from refs. [3,4] (squares) and [6] (triangle).
