Optim ized - Expansion and Triviality or N on - Triviality of Field Theories

A bstract: We use a very simple version of the optimized (linear) — expansion by scaling the free part of the Lagrangian with a variational parameter. This method is well suited to calculate the renormalized coupling constant in terms of the free one and the cuto. One never has to calculate any new Feynman graphs but simply can modify existing results from the literature. We not that $\frac{4}{4}$ —theory as well as QED are free in the limit where the cuto goes to in nity. In contrast to this, the structure of Yang-Mills theories enforces a special choice of the Lagrangian of the —expansion. Together with the change in the sign of the —function, this leads to a dierent behavior and allows Yang-Mills theory to become non trivial.

1 Introduction

The \optim ized -expansion" (for the older literature see Stevenson [1] and references therein), also called \linear -expansion", is a powerful method which combines the merits of perturbation theory with those of variational approaches. The underlying idea is simple. Generically, the Lagrangian is split into a free and an interacting part in such a way that an arbitrary parameter (or more) is articially introduced. The interacting part is multiplied by a factor which serves as expansion parameter and is put equal to one at the end. The exact solution should be independent of the parameter while any approximate solution will depend on it. The idea, often called \Stevenson's principle of minimal sensitivity" [2], is that the approximate solution should depend as little upon the parameter as possible. This means that should be chosen such that the quantity to be calculated has an extrem um. In this way the result becomes non perturbative because becomes a non linear function of the coupling constant. In every order of perturbation theory the parameter has to be calculated again and usually goes to in nity with growing order.

The method has been applied with great success to simple cases like the zero dimensional and one dimensional (quantum mechanics) anharmonic oscillator [3], where rigorous proofs for the (rapid) convergence exist. There are also interesting applications to the calculation of the elective potential and the question of spontaneous symmetry breaking [4] - [7]. In this context the method is usually called \Gaussian elective potential" (GEP), or, in higher orders, \post Gaussian elective potential" (PGEP). We also mention applications in lattice theory [8].

In [4] - [7] the mass parameter of the free Lagrangian was treated as variational parameter. In our approach we will x it at the physical mass. Instead we scale the free part of the Lagrangian with a factor . That's all! Due to the `benevolent paradox" [9] of the linear -expansion we don't need to calculate any Feynman graphs. We simply can use existing calculations and modify the results. We not that this method is not only quite simple but also very useful in order to calculate the renormalized coupling constant in terms of the bare one and the cuto . All our results are already obtained in one-loop order.

For \(^4_4\) - theory, treated in sect. 2, and QED in sect. 3, one easily nds that these theories are free, i.e. that the renormalized coupling constant goes to zero when the cuto goes to in nity, irrespective of the behavior of the bare coupling. In the case of \(^4_4\) - theory one can explicitly show that the conclusion holds in any (even) order of perturbation theory in . In QED one can use a realistic cuto and give an upper bound for the ne structure constant. Yang-M ills theories are treated in sect. 4. Here two important changes happen. Firstly, the change of the sign of the -function is crucial. Secondly, gauge invariance enforces special conditions on the splitting of the Lagrangian. Both together implies that the theory can become non-trivial. In all cases generalization to higher orders is straightforward in principle.

Our methods are not rigorous but they give transparent analytical expressions in a simple way and lead to an understanding of the relevant features of the various theories.

$2 \frac{4}{4}$ - Theory

We split the Lagrangian

by introducing an articial parameter which scales the free Lagrangian. The expansion parameter is called as usual. The parameter M will not be treated as a variational parameter but will be xed at the physical mass. This is very convenient and will lead to the results in a simple way.

For = 1 the original Lagrangian is recovered.

The Feynman rules are directly read o from (2.2). The essential modi cation is that the propagator acquires a factor and that we obtain insertions containing the free Lagrangian. They will be denoted by a thick dot in order to distinguish them from the mass insertions which, as usual, are denoted by a cross:

It is easy to see how the insertions of the free Lagrangian work. If we combine an insertion with one adjacent propagator, the p^2 M² cancels and one is left with a factor (1). Sum ming up the geometrical series consisting of the bare propagator together with 1;2; ;n insertions and putting = 1 gives

C learly the extrem um is at the \natural" value = 1. For 0 < < 2 the series converges and the lim it is independent of as it should be. In a theory with interactions there are, of course, additional contributions which will shift the extrem um away from 1.

Calculations with the Lagrangian (2.2) are easily performed by just modifying the expressions of usual perturbation theory. Although our essential results are already obtained at the one loop level we present the general procedure. Let $_{2N}$ (p_i) be the connected one particle irreducible G reen function with 2N external legs, the propagators for the external legs are not included. In usual perturbation theory with respect to the bare coupling constant g_0 , one has an expansion of the form

In our approach the G reen function will depend on and in any nite order, therefore we denote it by $_{2N}$ (p_i ; ;). If we expand it with respect to , every internal line gets an extra factor . There are I=2V-N internal lines in the graphs with V vertices which contribute to $_{2N}^{(V)}$ (p_i). Furtherm ore, we have to take into account the insertions of the free Lagrangian which give a factor (I-V) compared to the graph without the insertion. The number of possibilities to place J insertions on I internal lines (compare the well known analogous problem of B ose statistics to put J indistinguishable particles into I boxes) is

Consider next the two point function G_2 (p²; ;) of all one particle irreducible contributions to the propagator, which will be needed to calculate the wave function renormalization Z (;). The graphs which contribute to G_2 (p²; ;) up to order ² are shown in g.1. In general one has the expansion

The propagator D $(p^2; ;)$ is obtained by sum m ing up the geom etrical series of all one particle irreducible contribution contained in G $(p^2; ;)$. Putting

Besides the propagator and the wave function renormalization constant we need the vertex function $(p_i; ;)$ (normalized such that the expansion starts with 1). This, in turn, determines the vertex renormalization constant Z_V (;) through

Since we are only interested in the behavior for cuto to in nity, the special choice of the momenta for the renormalization prescription of is unessential.

In ordinary perturbation theory with respect to the bare coupling constant g_0 , one has the form alexpansions

where $^{()}$ are the coe cients $^{()}(p_i)$ taken at the external momenta where the renormalization prescription is imposed.

The corresponding expansion for Z (;) with respect to is obtained from (2.11), (2.9), (2.8). The quadratically divergent tadpole in g. 1 is independent of the external momentum and only contributes to the mass renormalization. If M is chosen as the physical mass, it is canceled by the mass counterterm. Therefore we may omit all tadpole contributions here and in the following. From the graphs in g. 1, together with the foregoing considerations we get

In general, a term g_0^2 Z $^{(1)}$ would also show up in the curly bracket of (2.14) which, however, vanishes in 4 -theory.

and b is the rst coe cient in the usual expansion of the - function, $(g) = \log^2 + H$ ere and in the following we use the results of well known one loop calculations which may be found e.g. in [10].

Before going on we have to clarify an important conceptional point. In quantum mechanics or any other theory without in nities one would prescribe g_0 and then calculate g as a power series in . In the usual treatment of quantum eld theory, however, one proceeds the other way round. One xes g at its physical value and calculates g_0 as a power series with coe cients that are divergent in the limit! 1. We stress that the latter method is not applicable here! The reason is that the expansion of g starts with a term proportional to . If we invert (2.17), we obtain

But now the rest contains an in nity of terms of order $\,^0$, because $\,g_0^{\ 2}=g+$ starts with order 1, not with order $\,^0$. Therefore it is not allowed to truncate the series. If we do it nevertheless, this means that we return to naive perturbation theory in g. In the latter case one easily not that the renormalized vertex function $\,^{\rm ren}(p_i)=Z_V\,(p_i)$ as well as other renormalized quantities like the self-energy, become independent of . This also happens in higher orders. The renormalization procedure is powerful enough to remove our manipulations with the Lagrangian!

We will see now, however, that the linear -expansion in our special formulation is extremely useful and simple in order to obtain information about the renormalized coupling constant in terms of the bare coupling and the cuto. We return to (2.17), truncate after the order 2 , and put = 1, thus ending up with

Therefore, in the lim it ! 1 the renormalized coupling constant g will necessarily converge to zero, irrespective whether g_0 becomes constant, goes to zero, or diverges.

In the literature there are suggestions for possible non-trivial and stable 4_4 -theories, the \precarious" theory [11], [1], [5], [6] ($g_0 < 0$ in nitesimal, g < 0 nite) and the \autonom ous" theory [12], [5], [7] ($g_0 > 0$ in nitesimal, g > 0 nite, in nite wave function renormalization). As we have just seen, an autonom ous theory cannot arise in our approach. Let us look for the possibility of a precarious theory by putting g_0

< 0. In this case (2.21) has two solutions with > 1. A nite value of g in the lim it C! 1 can now be obtained if C! 0, ! 1= C! 1. Therefore the negative bare coupling constant must become in nitesimally small. For g one then would get g! 1=2 2 C 3 which is positive. Depending on how fast vanishes in the lim it! 1, this may converge to 0, 1, or to a nite value. We consider this possibility, however, as unacceptable. A coording to the general philosophy of the principle of m in in alsensitivity the second extremum at 1+ C should be preferred because the second derivative is (drastically!) smaller. (This would also, and even stronger, be the case if we would have chosen 1= as variation variable.) This second solution would lead to a negative ! 0. Therefore these exotic possibilities do not show up in our approach.

It is instructive to look at the perturbative features and the analyticity properties contained in (220), (221). One may expand the solution (221) for the extrem um

The linear term in g_0C coincides with that of naive perturbation theory as it should, because we expand at the extrem um.

Obviously (2.24) has a branch cut at $g_0C = 1=4$, corresponding to = 2, which determ ines the radius of convergence of (2.25). We expect that in higher orders of the optim ized - expansion the branch cut approaches zero as it happens in simple models. So the method shows how the non-analytic behavior at $g_0 = 0$ and the divergence of ordinary perturbation theory for any g_0 arises.

It is surprising that all the previous conclusions can form ally be extended to arbitrary orders n of the optim ized -expansion. Instead of (2.17) one obtains a more complicated formula of similar structure, which again has a factor g_0^2 in front. What we need is information about the behavior of the various contributions in the limit! 1 and about the presence of an extremum for positive .

If we expand the factors Z 2 (;) and 1=Z $_V$ (;) in (2.16) with respect to we obtain series involving the coe cients Z $^{()}$ and $^{()}$ in (2.13), modiled by the changes performed in the Lagrangian. Because we have chosen M as the physical mass, all quadratically

divergent tadpole contributions cancel and only the logarithm ic divergences survive in the coe cients. For ! 1 one has

The important point is that we know the signs of the coe cients C . These signs are easily obtained from inspecting the various factors is term ming from the propagators, vertices, and rotations to euclidean space in the integration variables, for a graph contributing to . The remaining integrand is then positive denite. A special cuto prescription for higher order graphs is e.g. the replacement of the euclidean propagator by exp[$(P^2 + M^2) = ^2 = (P^2 + M^2)$. There is no simple statement concerning the signs of the coelients z , but fortunately these signs are unimportant. In our approach we have the same modications as in (2.7): Every propagator gets an additional factor , this has the consequence that Z () as well as () always appear together with a factor 2 . The insertions of the free Lagrangian give factors of (1) compared to the corresponding graph without the insertion.

The clue for the existence of an extrem um is the sign of the term with the highest power of in the expansion of g in (2.16). From the previous remarks it is clear that the highest power of contains no insertions. Furtherm ore, the coe cients of $^{(\)}$ have one power of ln (2 =M 2) m ore than those of Z $^{(\)}$. To nd the leading term in the coe cient for ! 1 , we therefore have to take the lowest order of Z 2 (;) and the highest order of 1=Z $_{\rm V}$ (;). Therefore the term with the highest power of in the expansion of (2.16) reads

It has a de nite sign and is negative for $g_0 > 0$ and even order n. This term with the highest power of is also the one with the highest power of $\ln(^2=M^2)$.

The term with the lowest power of $\,$ is, correspondingly, obtained if we take the lowest order in Z 2 (;) and 1=Z $_{\!\! V}$ (;), and only consider the insertions. This gives

O bviously this factor is positive. Together w ith the previous result this guarantees that for even n there w ill always be at least one m axim um at positive w, i.e. the principle of m inim all sensitivity is applicable.

It is now easy to see what happens in the lim it ! 1 . In the case that $g_0 \ln (^2=M^2)$ stays nite (or goes to zero) there will be a maximum at some nite. In this case g_0 necessarily goes to zero, therefore the extra factor g_0 in front as in (2.17) will imply that g vanishes for ! 1. Let us next assume that $g_0 \ln (^2=M^2)$ diverges for ! 1. Then at the maximum has to go to zero, because otherwise the highest order term would dominate all the other ones. Therefore the expression may be simplied considerably.

In any term we only need to consider the highest power of $\ln(^2=M^2)$ and the lowest power of . Insertions therefore only give powers of . We end up with an expression of the form

The S $_{,j}$ are uninteresting numerical coecients, the important point is that we know the highest one: $S_{n-1;0}=(1)^{n-1}C_{n-1}<0$ for n even.

The rest is trivial. Putting ${}^2g_0 \ln ({}^2=M^2) = x$ and setting = 1, (2.30) becomes

For even n there is a maximum for some nite x, if this is chosen one nds that $g \,! \, 0$ for $\,! \, 1$, i.e. the theory is trivial.

The case of a precarious theory with $g_0 < 0$ can be excluded in the same way if one chooses n odd.

We cannot make a general statement whether there is an extremum for $g_0 > 0$ and nodd or vice versa; for n = 3 there is none in the limit $g_0 \ln (^2=M^2) ! 1$. This does not matter at all because we always may choose a convenient subset of values of n. It is a well known feature of the optimized — expansion, which shows up already in the completely understood toy model of a \zero dimensional 4 — partition function" [3], that one has to restrict to even or odd n, respectively.

Of course we don't claim that the previous considerations provide a proof that 4_4 -theory is free. (See [13] for this topic.) However, they certainly give some new and alternative insight into the problem and add further evidence for the triviality of this theory.

3 QED

The situation is very \sin ilar to that in 4 -theory, therefore we can concentrate on the modi cations. For \sin plicity we work in the Feynm an gauge. The free Lagrangian

We have now introduced two scaling param eters, $_2$ for the free electron Lagrangian, and $_3$ for the free photon Lagrangian. M is chosen as the physical mass of the electron. The expansion parameter is again which is put equal to 1 at the end. Only for =1 the Lagrangians have to coincide. This freedom was used to choose dierent powers of in the various terms of $L_{\rm I}$ (), namely for the electron-photon vertex but 2 for the free Lagrangian insertions and the mass insertions. The reason for doing this is that in the familiar perturbative treatment of QED the contributions to the mass counter term mass well as to the renormalization constants Z_1 ; Z_2 ; Z_3 always arise in connection with loop graphs, which in lowest order are proportional to $_0 = e_0^2 = 4$. The Lagrangian (3.2) has the corresponding structure, it is not only invariant under the transformation e_0 ! e_0 ; A! A, but also under!; A! A. This guarantees that at the end expansions go with $_0$, not with e_0 itself.

The Feynman rules which are derived from (3.2) read:

As in the previous section, G reen functions can be calculated by using the expansion coe cients of ordinary perturbation theory. Because it is more convenient to write the expansion in $_0$ instead of e_0 we introduce the following notation. Let $2N_e$ denote the number of external electron lines, $2N_e + w$ ith $e_0 + w$ or 1 the external photon lines, and $2V_0 + w$ the vertices. The usual perturbation expansion of the vertex function then reads

The graphs which contribute to $\frac{(V)}{2N_e,i2N_-}$ have $I_e=2V+N_e$ internal electron lines and I=V N internal photon lines. Considering the additional factors in the propagators and the insertions in analogy to (2.7), we obtain for the expansion up to order 2n+

We keep as close to the usual notation as possible. The vertex renormalization, electron wave function renormalization, and photon renormalization constants are now functions of $_2$; $_3$; and are denoted by Z_k ($_2$; $_3$;). For $_2$ = $_3$ = $_1$ they go over into Z_1 ; Z_2 ; Z_3 . The formal expansion of the latter in usual perturbation theory reads

The quantities Z_k ($_2$; $_3$;) can be expanded into series in . The calculation of order is completely parallel to the one in the last section, therefore we just give the result:

Clearly $Z_1(2;3;) \in Z_2(2;3;)$, i.e. the W and identity does not hold in it's usual form! The reason for this is easily traced back to the extra contribution of the free

electron Lagrangian insertion in g.3 which contributes to the self-energy and therefore to Z_2 ($_2$; $_3$;), but does not appear in the vertex function and in Z_1 ($_2$; $_3$;). It is, however, easy to derive the modi ed W ard identity from the familiar one. The result is

O riginally, instead of $Z_3^{(1)}$ one had $Z_3^{(1)} + 2Z_2^{(1)} - 2Z_1^{(1)}$, the last two terms canceldue to the W ard identity. This cancellation also happens in higher orders. Therefore, though the W ard identity is modified in our approach, the \old"W ard identity for the coecients, $Z_1^{(1)} = Z_2^{(1)}$, still does its job.

We have to determ ine the extrem um of (3.12) for = 1 with respect to the two variables $_2$; $_3$. One easily sees that

It is tempting to look into the consequences of the inequality (3.18) if one takes it seriously. To do this we have to extend the theory by including all elementary charged ferm ions and the charged W -bosons (assuming, of course, that there exist no further elementary charged particles). We use the same factor for all particles in generalization of (3.14). In the order in which we work, the various contributions to the vacuum polarization simply add up. We obtain again the relations (3.15), (3.18) but now

respectively. Because is a monotonically increasing function of $_0$ these bounds are reached for $_0$! 1. The value 1=137 would be obtained for $_0$ 1=98 and $_0$ 1=90 respectively. Clearly these considerations are highly speculative at this stage.

4 Yang-Mills Theory

The results of the last two sections, 4 -theory and QED, clearly depended on the sign of the rst non-trivial correction to the renormalized coupling constant. This, in turn, is directly connected to the positive sign of the —function for small coupling. Yang-Mills theories are asymptotically free, the —function is negative and the sign of the rst non-trivial correction changes. Naively one would expect that we again obtain an equation like (3.15) in QED, but with the sign of the term with C reversed. This would imply that there is no extrem um in the limit $_0$ C! 1. So the method would simply avoid to run into the previous conclusions by refusing to produce an extrem um.

Actually, what happens is much more subtle. The structure of non-abelian gauge theories will enforce a special choice of the Lagrangian of the —expansion, in order that all the usual compensations of the theory still take place. This in turn will reduce the power of in the term with $_0$ C so that there will be an extremum now. For a suitable behavior of $_0$ C the position of this extremum moves to in nity when C ! 1 . So, a nite renormalized coupling constant arises.

The usual YM - Lagrangian (the following considerations hold for any non-abelian gauge group, for simplicity we use the language of QCD) has the form

Here L_0 denotes the free part of L, L_3 and L_4 denote the three-gluon and four-gluon couplings, $L_{\rm Gh}$ the ghost Lagrangian, $L_{\rm F}$ the ferm ion-gluon coupling, and $L_{\rm GF}$ the gauge xing term . The explicit expressions are well known and there is no need to repeat them here. We use again Feynman gauge for simplicity. Remembering the result for QED in the last section we introduce a common scaling parameter—for all elds from the beginning. An essential modication is necessary now in order not to destroy the compensations between various graphs of the same order in g_0 . Consider, as illustration, the second order contributions of g. 4 to the gluon propagator. The three graphs in the second line have two internal lines and would get a factor 2 , the graph in the third line which contains the four gluon vertex has only one internal gluon line and would get a factor—only. This would, of course, be a disaster.

Fortunately this apparent di-culty can be simply overcome by an appropriate choice of the Lagrangian of the -expansion. We introduce three functions w_0 (;); w_3 (;); and w_4 (;) to be specified later, which will be multiplied with the free part and the three- and four-gluon couplings respectively. Our Lagrangian reads

The requirement that the original Lagrangian is recovered for = 1 gives the conditions

but we cannot $\sin p \ln p$ put all $w \ln p$ identical to one for the reasons just mentioned; we have to impose the conditions imposed by gauge invariance. Consider the vertex function $p \ln p \ln p$ with N external gluon lines. In ordinary perturbation theory it has the expansion

This should be obvious from comparison with the analogous expansions in the previous sections. The sum over J which represents the insertions, can be performed using $_{\rm J}^{\rm P}$ $_{\rm J}^{\rm I+J}$ $_{\rm J}^{\rm I}$ x $^{\rm j}$ = (1 x) $_{\rm J}^{\rm I}$, and V $_{\rm J}$ and V $_{\rm J}$ eliminated from (4.6). We must insist that the compensations between various graphs of the same order in g_0 have to take place also in the —expansion. This will be the case if and only if all the contributions $N^{(V;I)}$ will get a factor which depends on the order V only, but not on the number I of internal gluon lines. Therefore the curly bracket in (4.8) must be equal to one. This gives a relation between the W_k :

For = 1, where the w_k are equal to one, this relation is fullled.

It is easily seen that the inclusion of ghosts and ferm ions does not alter the previous considerations because the latter always appear in three particle vertices.

Using (4.9), the sum over I in (4.8) simplifies to $_{N}^{(V)}$ (p_i). The insertions have, of course, only apparently disappeared, they are now taken into account through the functions w₃ and w₄ and their behavior dictated by (4.9).

There is some freedom in solving (4.9). If we insist on a reasonable and simple solution, however, the result becomes essentially unique. We want all w_k to be polynomials in , in order to be sure that we don't introduce any singularities into the Lagrangian (4.2). In order that we can take the square root of w_3^2 (;) in (4.9) we have to choose w_4 (;) = [1 w_0 (;) (1) |= where the factor 1= is implied by (4.3). Finally we may simply choose w_0 (;) = 1. So we arrive at

The calculation of the renorm alized coupling constant (2) at the renorm alization scale in order 2 is now straightforward along the lines of the two preceding sections. The only dierence is the consideration of the additional factors (4.10) in the appropriate order. It is the factor of 1= there which implies essential changes in the powers of . The result reads

Now, if for C ! 1 the bare coupling $_0$ goes to zero such that 1 $_0$ C ! ! O one has ! 1=C which will be nite if is proportional to 1=C .

To be more explicit we have to note that $_0$ 1=C must not depend upon the arbitrary renormalization scale. Therefore we have to introduce a dimensional parameter $_{\text{QCD}}$ and take $_0$ 1=[4 bln (2 = $_{\text{QCD}}^2$)]. This leads to = ln (2 = $_{\text{QCD}}^2$)=ln (2 = $_{\text{QCD}}^2$) and

as it should. In a higher-order calculation it should be possible to relate $_{\rm Q\,C\,D}$ to the cuto .

If there were so many ferm ions that the theory would no longer be asymptotically free, bwould be negative and the theory would become trivial as in the examples of the previous sections.

5 Conclusions

The ansatz of scaling the whole free Lagrangian, including the kinetic term, appears both simple and powerful. In this paper we restricted to one loop order and to a calculation of the renormalized coupling constant. Generalizations to higher orders and/or to the calculation of the whole elective potential appear straightforward in principle, without any new conceptional problems.

A characteristic of the method is, that one has to consider the bare constant g_0 as given and the renormalized coupling constant g as a function of the expansion parameter. One cannot do it the other way round, because then an expansion with respect to becomes impossible. Therefore it will need some further considerations before the method can be applied to other problems in eld theory.

Finally, one should frankly adm it that all these m ethods of going beyond perturbation theory have a \distinctly alchem ical avor" as phrased by D uncan and Jones [3]. The splitting of the Lagrangian into L_0 and $L_{\rm I}$ is widely ambiguous, sometimes it may be advantageous or even m and atory to use a more complicated dependence of $L_{\rm I}$ upon , and nally every quantity to be calculated (even a function, say a power or a logarithm, of the original quantity) leads to a dierent position of the extrem um. Nevertheless, the inherent ambiguities of the method can be overcome by using physical principles and simplicity arguments and lead to results which go far beyond naive perturbation theory.

- Fig. 4: Contributions to the two point function in Yang-Mills theory.






