Heavy Quark Fragm entation Functions for D-wave Quarkonium and Charmed Beauty Mesons

### Abstract

At the large transverse momentum region, the production of heavy-heavy bound-states such as charm onium, bottom onium, and bom esons in high energy e<sup>+</sup> e and hadronic collisions is dominated by parton fragmentation. We calculate the heavy quark fragmentation functions into the D-wave quarkonium and bom esons to leading order in the strong coupling constant and in the non-relativistic expansion. In the bom eson case, one set of its D-wave states is expected to lie below the open avor threshold. The total fragmentation probability for a bantiquark to split into the D-wave bom esons is about

2  $10^{5}$ , which implies that only 2% of the total pseudo-scalar ground state B  $_{\rm C}$  com es from the cascades of these orbitally excited states.

#### I. IN TRODUCTION

The production of heavy quark-antiquark bound states like charm on ium, bottom on ium, and the yet undiscovered charmed beauty mesons at high energy ete and hadronic machines can provide very interesting tests of perturbative QCD. In the charm onium case, our traditional wisdom has been taken the following scenario: most of the J= com es predom inately from either the radiative decay of the P-wave at states produced by the lowest order gluon fusion mechanism or the weak decays of B mesons, whereas the should be produced alm ost entirely from B m eson decays. Sim ilarly, m ost of the should be produced from the radiative by decay. Only until recently can this naive thinking be confronted by the wealth of high energy experim ental data collected at the Tevatron. During the 1992-1993 run, the CDF detector recorded surprisingly large production rates of the prompt J=,  $^{0}$ , and  $_{GJ}$ which are orders of magnitude above the theoretical lowest order predictions [1]. In 1993 [2], it was realized that fragm entation can play an important role in quarkonium production at the large transverse m om entum  $(p_T)$  region at the Tevatron. Parton fragm entation into quarkonium is formally a higher order process but nevertheless it can be enhanced at the su ciently large transverse m om entum region com pared with the usual gluon fusion process [2]. A simple explanation of the enhancement is that the fragmenting partons are produced at high energies but with small invariant masses which can lead to the enhancement factor of powers of  $(p_T = m_C)^2$  compared with the gluon fusion mechanism.

M ost of the fragm entation functions for quarkonium that are relevant to phenom enology have now been calculated. G luon fragm entation functions were calculated in Ref. [2] for the S-wave, Ref. [3,4] for the P-wave, and Ref. [5] for the  $^{1}$ D  $_{2}$  state; heavy quark fragmentation functions were calculated in Ref. [6,7] for the S-wave, and Ref. [8{10}] for the P-wave. Phenom enological applications of these fragmentation functions have been performed by a

number of groups [11,12]. The current scenario of charmonium production at high transverse momentum is as follows: among all fragmentation contributions that are relevant to J= production, the dominant ones come from (i) gluon fragmentation into a color-octet  ${}^3S_1$  constate followed by a double E1 transition into J=, and (ii) gluon fragmentation into  ${}_{C\!J}$  followed by the radiative decay  ${}_{C\!J}$ ! J= + . The former mechanism is the most dominant one for  ${}^{C\!J}$  production because of the absence of  ${}_{C\!J}$  (2P) states below the  $D\!D$  threshold. The current experimental status with this new fragmentation insight has now been reviewed by many people in various occasions. We refer the readers to Refs. [11{14}] for more details.

The charm ed beauty bc m esons are expected to be observed soon at the Tevatron and prelim inary limits on the production rate already exists [15]. Parton fragmentation has been applied phenomenologically to the production of bc mesons as well at the Tevatron [16,17]. The heavy quark fragmentation functions for b! (bc) were calculated in Ref. [18] for the S-wave and in Refs. [8,9] for the P-wave. The validity of the parton fragmentation has been questioned in some recent exact 0 ( $\frac{4}{s}$ ) calculations [19]. However, these calculations obtained different results and led to conficting conclusions among them selves. It was only until the recent appearance of the results of Ref. [20] that this controversy can be settled down and the validity of the fragmentation approximation can be established in the production of (bc) mesons at the Tevatron. One can, therefore, use the fragmentation approximation with confidence in calculating the production cross sections and transverse momentum spectra of the (bc) mesons, including the leading logarithm is corrections, induced gluon fragmentation contribution [17], and contributions from all orbitally excited states.

The purpose of this paper is to extend the previous calculations of heavy quark fragmentation functions to the D-wave case. The D-wave orbitally excited states are of interests phenom enologically. In the ( $\infty$ ) case, one set of the D-wave states is predicted by potential models to lie below the BD threshold. These states, once produced, will cascade into the pseudo-scalar ground state B<sub>c</sub> via pion and/or photon emissions and thereby contribute to the inclusive production rate of B<sub>c</sub>. The excited D-wave charmonium resonances have

also been suggested [21] to resolve the <sup>0</sup> surplus problem observed at CDF. In Section II, we brie y review the factorization model of Bodwin, Braaten, and Lepage [22] that can consistently factor out the long-distance physics and short-distance perturbative factors for the inclusive production and decay rates of heavy quarkonium. In Section III, we present the calculation of the D-wave fragmentation functions for both the unequal and equal mass cases within the spirit of the factorization model. We discuss our results in Section IV and conclude in Section V.

### II. THE FACTORIZATION MODEL

A rigorous theory based on non-relativistic QCD (NRQCD) has been developed recently by Bodw in, B raaten, and Lepage [22] for the inclusive decay and production of heavy quarkonium. Using this form alism, the fragmentation function for a heavy quark Q to split into a quarkonium state X with longitudinal momentum fraction Z can be written as

where O  $_{\rm n}$  are local 4-ferm ion operators de ned in NRQCD. The short-distance coe cients d $_{\rm n}$  (z; ) are independent of the quarkonium state X . For a fragmentation scale of order of the heavy quark mass m $_{\rm Q}$ , the coe cients d $_{\rm n}$  (z; ) can be calculated using perturbation theory in strong coupling constant  $_{\rm s}$  (2m $_{\rm Q}$ ). The relative size of the matrix elements hO  $_{\rm n}^{\rm X}$  i for a given state X can be estimated by how they scale with m $_{\rm Q}$  and with the typical relative velocity v of the heavy quarks inside the quarkonium . Thus, the factorization formula Eq.(1) is a double expansion in  $_{\rm s}$  and v. To determ ine the relative importance of the various term s in this formula, one should take into account both the scaling in v of the matrix elements hO  $_{\rm n}^{\rm X}$  i and the order of  $_{\rm s}$  in the coe cients d $_{\rm n}$  (z; ). The leading term in v of this formula corresponds to the popular color-singlet model [23]. However, keeping only the leading term in this double expansion can sometimes lead to incomplete or even inconsistent results due to the presence of infrared divergences [22,24].

One important feature in the factorization model is that the quarkonium state X is no longer considered as solely a  $Q \overline{Q}$  pair but rather a superposition of Fock states. For example, the spin-triplet  $^3D_J$  quarkonium states, denoted by  $^Q_J$ , have the following Fock state expansion,

where the notations  $\underline{1}$  and  $\underline{8}$  refer, respectively, to the color-singlet and color-octet states of the  $Q\overline{Q}$  pair. In the above Fock-state expansion there are also other 0 ( $v^2$ ) states, e.g.,  $\mathfrak{D} \overline{\mathfrak{Q}}$  ( ${}^{3}\mathfrak{D}_{J}$ ; 8 or 1)ggi, but their production will be further suppressed by powers of v. Heavy quark fragm entation into D-wave quarkonium  $^{Q}_{J}$  can be deduced from the leading Feynm an diagram s of Q !  $(Q\overline{Q})Q$  as shown in Fig.1 and Fig.2. In Fig.1, the  $Q\overline{Q}$  pair can be either in the color-singlet  $^3D_J$  state, in the color-octet  $^3P_{J^0}$ , or in the color-octet or color-singlet  $^3S_1$  states, whereas in Fig 2 it can only be in the color-octet  $^3S_1$  state. The short-distance factors deduced from these diagrams are all of order  $\frac{2}{s}$ . Furtherm ore, all these diagrams are also of the same order in v. A coording to the NRQCD [22], the relevant local 4-ferm ion operators describing these three Fock states are O  $_1$  ( $^3$ D  $_J$ ), O  $_8$  ( $^3$ P  $_{J^0}$ ), and O  $_8$  ( $^3$ S  $_1$ ) which have relative scalings like  $v^4$ ,  $v^2$ , and  $v^0$ , respectively. However, the Q  $\overline{Q}$  pair in the color-octet Pwave and S-wave states can evolve nonperturbatively into the physical D-wave quarkonium state  $^{\mathbb{Q}}_{\mathbb{J}}$  by em itting one and two soft gluon (s), respectively. Em itting a soft gluon costs a factor of v at the amplitude level in NRQCD and hence a factor of  $v^2$  in the probability. Thus, with a non-relativistic normalization convention in the state, all three matrix elements  $\text{MO}_{1}^{\circ}$  ( $^{3}\text{D}_{J}$ )i,  $\text{MO}_{8}^{\circ}$  ( $^{3}\text{P}_{J^{0}}$ )i, and  $\text{MO}_{8}^{\circ}$  ( $^{3}\text{S}_{1}$ )i scale like  $\text{MO}_{Q}^{\circ}$  v<sup>7</sup>. As a result, both Fig.1 and Fig.2 contribute to the fragm entation functions of order  ${}_{s}^{2}v^{7}$  and should all be taken in account for a consistent calculation. With appropriate normalization, the color-singlet matrix elements  $\text{MO}_{1}^{^{\circ}}$  ( $^{3}\text{D}_{J}$ ) i as well as  $\text{MO}_{1}^{^{\circ}}$  ( $^{1}\text{D}_{2}$ ) i for the spin-singlet D-wave state  $^{\circ}$  can be related to the non-relativistic radial D-wave wave-function  $\overline{R_D^{(0)}}$  (0), which is the spin average of the spin-singlet and spin-triplet  $R_D^{\infty}$  (0)'s, by

Potentialm odels can be used to determ ine the value of the wave-function so that the NRQCD m atrix elements for the color-singlet contributions are xed. Unfortunately, potential models cannot determ ine the color-octet matrix elements since dynamical gluons are involved. However, from our experience of the P-wave quarkonium case [8], we do not expect the color-octet com ponent to play a major role in the heavy quark fragm entation. We note that this is in sharp contrast with the gluon fragmentation in which a gluon can fragment into the color-octet  ${}^3S_1$  state via the process g!  $Q\overline{Q}$ . This process is of order s and is at least one power of  $_{\rm S}$  lesser than the leading color-singlet term in the gluon fragmentation. We also note that the color-singlet contribution of heavy quark fragm entation from Fig.1 is free of infrared divergences. On the other hand, infrared divergences will show up in the gluon fragm entation function into the spin-triplet D-wave quarkonium. It is necessary to include the color-octet contributions in order to achieve a nite and sensible perturbative answers for the gluon fragm entation functions into spin-triplet D-wave states. In what follows we will restrict ourselves to the color-singlet contribution in the heavy quark fragmentation into D-wave quarkonium. If the color-octet matrix elements can be determined in the future, it is straightforward to include their contributions since their corresponding short-distance coe cients can be extracted easily from the previous S-wave and P-wave calculations by m odifying the color factors.

The factorization model for the quarkonium system can be extended to the unequal mass case like the ( $\infty$ ) meson system. In what follows, we will denote the spin-singlet and the spin-triplet D-wave ( $\infty$ ) meson states by  $^{10}$  and  $^{10}$ , respectively. In this case, gure 2 is absent for the color-octet contribution.

# III. HEAVY QUARK FRAGMENTATION FUNCTIONS INTO D-W AVE HEAVY-HEAVY MESONS

The general covariant form alism for calculating the production and decay rates of S-w ave and P-w ave heavy quarkonium in the non-relativistic expansion was developed some times ago [25]. It is straightforward to extend it to the case of unequal mass and higher orbital excitation. We shall present a covariant form alism for the production of D-w ave meson (Qq) by some unspecified short-distance processes. Let  $m_Q$  and  $m_q$  be the masses of the two quarks with  $m_Q > m_q$ , and introduce the mass parameters  $r = m_q = (m_Q + m_q)$  and  $r = m_Q = (m_Q + m_q) = 1$  r. In the leading non-relativistic approximation, the mass M of the meson is simply  $m_Q + m_q$ . The amplitude for producing the bound-state (Qq) in a state with momentum P, total angular momentum J, total orbital angular momentum L, and total spin S is given by

orbital angular momentum, and in general is a product of D irac matrices. The heavy quarks Q and q have momentum rP + k and rP k, respectively, where 2k is the small relative momentum of the quarks inside the bound state.  $_{\rm LL_{Z}}$  (k) is the Bethe-Salpeter wave-function in the momentum space and is assumed to be a slow-varying smooth function of k. Sometimes M (P;k) is a trace by which the on-shell spinors v (rP + k;s) and u (rP k;s) are brought together in the right order.  $_{\rm SS_{Z}}$  (P;k), up to second order in k, is given by

where in the middle parenthesis  $^5$  is for  $S=S_Z=0$  (spin-singlet) and  $=(P;S_Z)$  is for S=1 (spin-triplet).

Since k=M is a small quantity, we can expand M (P;k) around k=0 in a Taylor expansion:

where the rst, second, and third terms correspond to quantum numbers L=0;1; and 2 of the orbital angular momentum, and so forth. Thus for the S-wave (L=0), P-wave (L=1), and D-wave (L=2) states, the amplitude A (P) will depend on the radial wave-functions  $R_S(0)$ ,  $R_P^0(0)$ , and  $R_D^\infty(0)$  through the following relations:

where is the polarization vector for the spin-1 particle, and is the totally symmetric, traceless, and transverse second rank polarization tensor for the spin-2 particle. In the D-wave case, the amplitude becomes

A fler writing down the form alism for the general production of D-wave mesons, we shall specify the production mechanism. The speci c production of D-wave (Q q) mesons that we are considering is by the fragmentation of a heavy quark Q:

where the o-shell Q is produced by a high energy source. The fragmentation function is then given by the form ula [6,18]:

where  ${}^{P}$   $\not A_0 \mathring{f} = N_c Tr(\overline{q})$  is the tree-level amplitude squared to create an on-shell Q quark with the same 3-m omentum q, and  ${}^{P}$   $\not A$   $(P)\mathring{f}$  is the amplitude squared for producing (Qq) + q from the same source. The general procedures to extract the fragmentation function have been described in detail in Ref. [6,18] and we shall be brief in what follows.

## A. UnequalM ass Case

We shall rst derive the fragmentation functions for a heavy quark Q into an unequal mass D-wave (Qq) meson. The fragmentation of Q into a Qqmeson is given by the process in Eq. (20), of which the leading Feynman diagram is given in Fig. 3. In reality, the above fragmentation process applies to b!  $\frac{1}{100}$  + c (b!  $\frac{1}{100}$  + c) and also its charge conjugate b!  $\frac{1}{100}$  + c (b!  $\frac{1}{100}$  + c). The amplitudes that are presented in the following are for Q! (Qq) + q, while the amplitudes for the conjugate process can be obtained by complex conjugation. However, the nall expressions for the fragmentation functions are valid for both Q! (Qq) + q and  $\frac{1}{100}$ ! (Qq) + q fragmentation processes.

The amplitude A (P) for producing the spin-singlet D-wave state is given in Eq. (10) with  $\frac{e^2M}{e^2k}$  given by

In the above formulas,  $s=q^2$  and we have chosen the axial gauge associated with the 4-vector  $\mathbf{n}=(1;0;0;1)$ . In this gauge, gure 3 is the only leading Feynm an diagram where factorization between the short distance process and fragmentation becomes manifest! We square the amplitude A (P) and sum over colors and helicities of q and (Qq), and put them into Eq. (21). The heavy quark fragmentation function for the  $^1D_2$  state thus obtained is given by

Therefore, we also need to calculate the fragm entation function  $D_{m ix}(z)$ . We note that in the case of charm on ium it is the charge-conjugation quantum number C that prevents the mixing of  $cc(^{1}D_{2})$  and  $cc(^{3}D_{2})$  states, because  $cc(^{1}D_{2})$  has C = +1 while  $cc(^{3}D_{2})$  has C = 1. In

the unequal-m ass case the meson does not have this quantum number C to prevent the mixing. The mixing fragmentation function is obtained by calculating the interference term  $A(^1D_2)A(^3D_2) + A(^1D_2)A(^3D_2)$  and sum over the colors and helicities of the particles in the nal state as before. The mixing fragmentation function thus obtained is

#### IV.D ISCUSSIONS

We have seen that the covariant form alism used to calculate the D-wave fragmentation functions is quite cum bersom e and tedious. The complicated results are therefore needed to be cross-checked by other means. To be sure we have recalculated the D-wave fragmentation functions for the equal mass case from scratch and we did end up with the same results as what we have in the above for r = 1=2. Two additional nontrivial checks are performed by using the Braaten-Levin spin-counting rule and the heavy-quark spin-counting rule which we will discuss in turns.

### A.Braaten-Levin Spin-counting Rule

The fragmentation function D  $_{i!}$  H (z) for a parton is politting into a hadron H is related to the distribution function  $f_{i=H}$  (x) of nding the parton is inside the hadron H by the analytic continuation [27,28]

The results of perturbative fragmentation functions allow us to study the perturbative tail of the distribution functions of the heavy quark inside the heavy mesons as well. From our explicit calculations, we see that  $f_{i=H}$  (x) has a pole located at x = r. The pole is cut o by non-perturbative e ects related to the formation of bound states of the (Q q) pair. This pole is of order 6, 8 and 10 for S-, P-, and D-wave states, respectively. In the general case of

L-waves we expect this pole is of order 6+2L. Therefore, we can expand f(x) as a Laurent series,

The B raaten-Levin rule states that the leading r-dependent coe cients a  $_{\rm n}$  (r) satisfy the simple spin-counting. Speci cally, we have

The applicability of these counting rules has been demonstrated for the S- and P-wave cases in Ref. [8]. For the D-wave case we can expand the distribution functions, which are obtained from the D-wave fragmentation functions by Eq. (53), around x = r and obtain the rst two terms in the Laurent series:

where  $N = {2 \over s} R_D^{\infty} (0) f = (3240 \text{ M}^7)$ . Therefore, the leading coe cients a  $_{10}$ 's indeed satisfy the spin-counting ratio 5:3:5:7. A ctually, we found that not only the rst term but also the second term in the Laurent series of f(x) obey the B raaten-Levin spin-counting rules, while the third term does not. We conjecture that the B raaten-Levin spin-counting rule can be applied to the rst two coe cients in the expansion (54) for all L-wave (L = 0, 1, 2, ...) cases.

#### B. Heavy-Light Lim it

Hadrons containing a single heavy quark exhibit heavy quark symmetry in the limit m\_Q=\_QCD ! 1 . In the lim it of m\_Q=\_QCD ! 1 , both the heavy quark spin S\_Q and the total spin  $\mathcal{J}$  of a heavy hadron containing a single heavy quark  $\mathbb{Q}$  become good quantum numbers. This implies that in the spectroscopy of the hadron containing a single heavy quark Q , the angular m om entum of the light degrees of freedom  $\mathcal{J}_1$  =  $\mathcal{J}$   $S_{\mathbb{Q}}$  is also a good quantum number. We refer collectively to all the degrees of freedom in the heavy-light hadron other than the heavy quark as the light degrees of freedom. For heavy-light (Qq) m esons,  $\mathcal{J}_1$  =  $S_q$  +  $\Sigma$  where  $S_q$  is the spin of the light quark q and  $\Sigma$  is the orbital angular m om entum. Thus, hadronic states can be labeled simultaneously by the eigenvalues j and j of the total spin J and the angular momentum of the light degrees of freedom  $J_1$ , respectively. In general [29], the spectrum of hadrons containing a single heavy quark has, for each j, a degenerate doublet with total spins  $j_+ = j_1 + 1 = 2$  and  $j_- = j_1 - 1 = 2$ . (For the case of  $j_1 = 0$ , the total spin must be 1=2.) For D-wave heavy-light mesons, j can either be 3/2 or 5/2. Thus  $(j; j_+) = (1; 2)$  and (2, 3) for  $j_1 = 3/2$  and 5/2, respectively. As a result, we expect to have two distinct doublets  $(^3D_1; 2^{+0})$  and  $(2^+; ^3D_3)$  in the lim it of  $m_Q = m_q ! 1$ , i.e. r! 0. In this lim it, the mixing coe cients in Eq. (37) can be determined by the Clebsch-Gordan coe cients in the tensor product of a spin 1=2 state and a spin 2 state with the following result:

i.e., we are transform ing the states  $^{1}$ D  $_{2}$  and  $^{3}$ D  $_{2}$  in the LS coupling scheme to the states  $^{2}$ + and  $2^{+}$  in the jj coupling scheme.

In their discussions of the heavy quark fragmentation functions within the context of Heavy Quark E ective Theory, Ja e and Randall [30] showed that fragmentation functions can have a 1-m o expansion if expanded in terms of a more natural variable

rather than the usual fragm entation variable z, and the heavy-quark m ass expansion is given as a power series in r,

where a (y); b(y), etc. are functions of the variable y. The leading term a (y) is constrained by the heavy quark spin-avor symmetry while all the higher order terms contain spin-avor symmetry breaking e ects. One can recast our results for the D-wave fragmentation functions derived in Sec.III in the above form, by carefully expanding the powers of r and (1 rz). The leading 1=r terms of the fragmentation functions are then given by

#### V.CONCLUSIONS

The detections of the D-wave orbitally excited states of heavy-heavy mesons are much more dicult than their ground states. So far, none of D-wave quarkonium has been identied. The basic reasons are (i) the production rates are small, (ii) small branching ratios in subsequent decays, and (iii) the very small e ciencies in subsequent levels of identication. From the potential model calculations, D-wave charmonium are likely to be above the D  $\overline{D}$  threshold and hence they will decay predom inantly into a pair of D mesons. In principle, D-wave quarkonium can be identied partially by their pure leptonic decay (e.g.  $^3D_1!$  ), or by their subsequent decays into the lower-lying states. It is because of the subsequent levels of decays that reduce substantially the branching ratios and e ciencies in identifying these D-wave bound states. However, both the branching ratios and e ciencies are uncertain at this stage. In the following, we shall estimate the production rates of the D-wave charmonium, bottomonium, and (bc) mesons based upon the fragmentation functions obtained in Sec. III and IV.

The values of  $\Re_D^{\infty}$  (0) f for the (cc), (bb), and (bc) system swere sum marized nicely in Ref. [31] using dierent potential models. We choose the QCD-motivated potential of Buchmuller and Tye [32], and the corresponding values of  $\Re_D^{\infty}$  (0) f for the (cc), (bb), and (bc) system s are 0.015, 0.637, and 0.055 GeV<sup>7</sup>, respectively. These values are for the rst set of the D-wave states. We note that the values of  $\Re_D^{\infty}$  (0) f obtained using the Buchmuller-Tye potential are the smallest ones of the four potential models studied in Ref. [31].

In the following analysis, we will adopt the values  $m_c = 1.5$  GeV and  $m_b = 4.9$  GeV that were used in the t of the Buchmuller-Tye potential to the bound state spectra [31]. We rst evaluate the fragmentation probabilities for a bantiquark into D-wave (bc) mesons by substituting  $r = m_c = (m_b + m_c) = 0.234$  into Eqs. (40) { (43). Using  $_s$  (2m  $_c$ ) 0.253,  $\Re_D^\infty$  (0)  $\Im = 0.055$  GeV for the (bc) system, and ignoring the possibly small mixing elects, we obtain

Therefore, the total probability is about 2:3  $10^{5}$ . We can compare this value with the corresponding probabilities of the S-wave and P-wave states. Using the same s and the values of  $\Re_S$  (0) f and  $\Re_P^0$  (0) f calculated with the same Buchmuller-Tye potential, the total fragm entation probabilities of the 1S and 1P (bc) states are about 1  $10^3$  and 1:7  $10^4$ , respectively [8]. These total fragmentation probabilities show a similar suppression factor of order v<sup>2</sup> in going from 1S to 1P states and from 1P to 1D states, which are in accord with the velocity counting rules in NRQCD [22].

Next, for the D-wave charm onium we use  $_{s}$  (2m  $_{c}$ ) 0.253 and  $\Re_{D}^{\infty}$  (0)  $\Im_{D}^{2}$  = 0.015G eV  $^{7}$ , and obtain

The total probability is about 1:1  $^{5}$  , to be compared with the probabilities of P (c! J= ) 1:8 10  $^4$  [6] and P (c!  $h_c$ ;  $_c$ ) 8 10  $^5$  [8] obtained using the same inputs. The total probability for the D-wave bottom onium is very small  $5.4\,$   $10^{\,8}$ . This is to be compared with the probabilities of P (b!)  $2\,$   $10^{\,5}$  [6] and P (b!  $h_b$ ;  $_b$ )  $2.5\,$   $10^{\,6}$ . We observe that the relative probabilities for the S-wave to P-wave quarkonium and for the P-wave to D-wave quarkonium are roughly suppressed by a similar factor of  $v^2$  as in the bc case.

At the Tevatron the b-quark production cross section is of order 10 b with  $p_T > 6$ GeV, which implies about 109 b-quarks with an accumulated luminosity of 100 pb 1. Using the fragm entation probabilities calculated above, we expect about 104 D-wave (cc) m esons, while there are only about 50 D -wave bottom onium. At large  $p_T$ , charm quark production is very similar to bottom quark production. Therefore, the c-quark production cross section is also of order 10 b and there should be about 10<sup>4</sup> D-wave charm on ium for the same lum inosity. Although the production rates of D-wave (cc) mesons and charmonium are rather substantial, the small branching ratios and e ciencies of identication in subsequent levels of decays render their detections extremely dicult. For example, the combined branching ratio  $Br(^{1}D_{2}(cc) ! ^{1}P_{1} ; ^{1}P_{1} ! J= ^{0}; J= ! ^{+})$  has been estimated to be about 10 4 [5]. Even after the installation of the Main Injector when the yearly luminosity can be boosted to 1 { 3 fb 1, the chance of detecting the D-wave (bc) m esons or charm on ium is still quite slim. The future Large Hadron Collider (LHC) can produce  $10^{12}$   $10^{13}$  bb pairs and cc pairs per year running. It can then produce about  $10^7$   $10^8$  D-wave (cc) m esons and charm on ium. A fter taking into account the branching ratios and e ciencies, there should be a handful number of these D-wave states that can be identied. Nevertheless, detection of the D-wave bottom onium does not seem to be feasible even at the LHC! The production of bb and oc pairs at LEP, LEP II, and other higher energy e e or colliders are much smaller than at the hadronic colliders. Therefore, it is much more dicult to identify the D-wave quarkonium or (bc) mesons at the ete or

In conclusions, we have computed the heavy quark fragmentation functions into D-wave heavy-heavy mesons containing two heavy quarks to leading order in strong coupling constant and to leading order in the non-relativistic expansion within the framework of fac-

torization model of Bodw in, Braaten, and Lepage. The color-singlet contributions can be expressed in terms of the NRQCD matrix elements which are related to the second derivative of the non-relativistic radial D-wave wave-function. The color-octet contributions are expected to be quite small in the heavy quark fragmentation and therefore we have ignored them in the present analysis. The fragmentation functions obtained in this work should be useful in the production of the D-wave charmonium, bottom onium, and (bc) mesons at the future Large Hadronic Collider.

- 3. Feynm an diagram for Q (q) !  $Qq(P;1) + q(p^0)$ .






