I. IN TRODUCTION

The Heavy Quark E ective Theory (HQET) has been used to describe the heavy hadron phenomena successfully in the past few years [1]. The mass correction for HQET is needed to compensate the in nite heavy quark mass lim it sim plicity [2]. In the quark language, the heavy hadrons may be taken as composed of one heavy quark and light brown muck. The come nem ent interactions between heavy quark and light brown muck are almost the QCD energe scale $_{OCD}$. As the mass m_O of the heavy quark being much larger than $_{OCD}$, one can specify the ratio of the total m omentum P_Q over m $_Q$ to be the velocity v which characterize the heavy quark states. Since the most m om entum of heavy hadron is carried by the heavy quark, thus one can identify heavy hadron total m om entum P_{M} to be M v if the hadron m ass M is equal to m $_{Q}$ + $_{H}$, where the $_{H}$ is the relevant parameter to denote the contribution of light brown m uck to heavy hadron m ass. A fier extracting the velocity part of total m om entum , the rest is de ned as the residual m om entum kof the heavy quark to denode the momentum uctation of heavy quark due to interactions with light brown muck. The system atic expansion in HQET is the expansion in terms of k and m $_0^{-1}$. M any m ass expansion schemes have been derived according to dierent physical and mathematical reasons β]. A lthough full physical green functions are independent of mass expansion scheme, but the results from HQET are really dependent on mass expansion scheme. This dependence comes from that one can not calculate to all orders of m ass expansion. Such limitation confronts us to need a good mass expansion scheme which can at least satisfy the properties of a free eld theory [4]. Mass expansion scheme can be separated into two types, one is the lagrangian type m ass expansion and the other is the eld type m ass expansion. The form er is derived by functional integral m ethod and the latter is to solve the mass expansion equation. The idea is to nd the transformation between mass correction eld and e ective eld. Since most physical interests are about the green functions which are composed of relevant elds. Thus the eld type mass expansion scheme is appropriate. We developed the projection operator m ethod to meet the requirements of the eld type mass expansion [4].

If we set the relevant energe scale as the chiral sym m etry energe scale , then we can combine the heavy quark sym m etry and chiral sym m etry to write down the heavy hadron e ective theory (HHET) [5]. Such a approach opens an new era for applying the heavy quark sym m etry to the heavy hadron transitions involving light pions. A lthough m ass correction for HHET is analogous to that of HQET, but the m ass expansion scheme of HHET is still not developed plentily as compared to that of HQET [6]. The main obstacle is beacuse now the basic objects are heavy hadrons which are more complicated than heavy quark. To directly apply the mass expansion scheme in HQET for HHET is not so easy and in some cases will lead to wrong [6]. In [7] we used the idea of the projection operator method in HQET to develope the heavy meson elective theory HMET type projection operator method and get the mass correction. Here we will extend such a approach to all kinds of heavy hadron. In the following we will review the projection operator method in HQET and HMET respectively.

A.Review of projection operator method in HQET

For a heavy quark eld Q (x) we de ne the correction led as

B.Review of projection operator method in HMET

The above review tells us that the heavy quark mass correction for heavy quark and heavy mesons is irrelevant to the properties of the light brown muck excepting for the total wave function mass corrections (see below). Such a superising result can be tracked back to the factorizability of matrix elements of a heavy quark current between hadronic states into heavy and light matrix elements in the heavy quark mass in nite limit as

Our organization is as following. In section II we derive the mass correction for heavy baryons. In section III we derive the mass correction for heavy mesons. In section IV we want to genegraliz the B jorken sum rule to include the mass corrections. In section V is the sum mary .

II.M ASS CORRECTION OF HEAVY BARYONS

To discuss the mass correction of heavy baryon, one need to rstly specify which quantum number is good or almost good. Since in the in nite heavy quark mass lim it the quantum number of the angular momentum of the light brown muck, j appears to be good, this comes from the spin interaction between heavy degree of freedom (do.f) and light brown muck (lb m) is proportional to 1=m o. Applying the same argument for nit mass cases, one can still use j (alm ost good) to classify the nit mass heavy baryons to undo the mass correction derivation by requiring that the heavy dof is on-shell. The reason can be thought as following. A Ithough now j is nom ore a good one, but since the heavy dof is on-shell the spin interactions between heavy dof and lbm will not a ect the heavy dof's equation of m otion. This means that the complicate interactions should be realized via the mass expansion series and while one derives the m ass correction form alism unnecessary to consider these complicate dynamical e ects and should leave them to the lagrangian one gets. So the whole program of the derivation of the mass correction is now easy and can be picture as that the mass correction is a transformation between the nite mass eld and in nite mass eld, while both are free. And , since the on-sell is always true for in nite eld , then the nit mass eld should be also on-shell. The on-shell require ent of heavy dof is the source of the \velocity reparam etrization invarint". Thus the whole argum ent is self-consistent. The general heavy baryons can be still classi ed according to the light brown muck total angular momentum j 1 with two specied heavy quark spin states. Thus we classify the heavy baryons with total angular m om entum $J = j + \frac{1}{2}$ and write them as [8]

One sees that the e ective heavy baryons just those de ned in [9] and their related equations of motion and constraints also just de ned in there.

Having arrived at these mass correction heavy baryons, we may see that the whole mass correction factor

So, it is easy to see that such factor is unitary. This is an important property to make sure that the unitarity of whole theory will not be broken by mass correction.

III. M ASS CORRECTION OF HEAVY MESONS

In this sction we want to discuss the mass correction of heavy mesons. The light brown muck for heavy meson is more complicated than that in heavy baryons. The light brown muck in heavy meson may appear in two kinds of states specified according to j = 1 $\frac{1}{2}$; 1 1. We identify these states as

For the $j = \frac{1}{2}$; l = 0 heavy m esons can be referred to IB. The whole derivation of the m ass correction heavy m esons is straightward and repeates same techniques. If our present heavy quark elective theory approach is right, then our projection operator method presented here will reveal itself to be a good one.

O ne rem ark should be noted that the norm alization convections for baryons and m esons are di erent. The baryons' convection is as usual while that of m esons is de ned as $\frac{p}{m_0}$.

IV.MASS CORRECTION OF BJORKEN SUM RULE

As an application of our mass correction of heavy hadrons, we choose to use the formalisms derived here to the Bjorken sum rule. Firstly, let's look at the following situation

where $\overline{Q}_v = Q_{v^0}^0$; $\overline{Q}_{v^0}^0 = Q_v$ are the the correction heavy quark currents, (v) is the elective baryon 1=0 state and $X^{n^0}(v^0;s^0)$ are the baryons intermediate states. Since the in nite mass limit m_Q; m_{Q0}! 1 of the Eq. 4.1 will reproduce the B jorken sum rule, we can use this formalism to study its mass correction formalism. To use the formalisms derived here, one can use the following matching identities

if the nal and initial states are h (v) jand $\c X^{n^0}$ (v°; $\c s^0$) i. We substitute these into Eq. 4.1 and we obtain

where the $C_{B,X}$ $_{(I)}$ and $C_{X^0(I^0);B}$ are relevant form factors with corresponding $b_{v^0;v}$; $b_{v^0;v}$ which are relevant velocity variable, g and f atrix resp.. Thus we have derived the mass correction B pirken sum rule. To further study the above equation , we can substitute the mass expansion forms of the relevant baryon eld operators. For the meson case we also have the same results. In general, if we let f^0_v as any correction heavy hadrons, the B pirken sum rule for nite mass should take the following form

This general form alism then can be studied for every order of $1 = n \cdot Q \cdot (Q \cdot Q)$. The detail structure will need careful analysis of every related matrix element, so we leave it to our future publication.

V.SUM MARY

We have derived the mass correction of heavy hadrons of arbitrary spin. We list them by their relevant quantum numbers. These correction eld operators can be used to derive mass correction lagrangian for heavy hadron elective theory. As an application we use them to derive the B price sum rule for nite mass.
