M om ent analysis of energy spectra and the e ect of running coupling

A bstract

Single particle inclusive energy spectra in e^+e^- annihilation are analyzed in terms of moments. By assuming Local Parton Hadron Duality (LPHD), experimental data in a wide cm. energy range from 3 GeV up to LEP energy are compared to the theoretical predictions of Modied Leading Log Approximation (MLLA) of QCD with and without taking into account the running of s. MLLA with running coupling (Limiting Spectrum) is found to reproduce experimental results very well, while the model with exed coupling is inconsistent with data. Rescaled cumulants are shown to be sensitive to the running of s in the asymptotic regime, while the Lorentz-invariant distribution, Edn= ${\rm d}^3p$, points out this elect at very small energy E of few hundreds MeV. These results give a direct evidence of the running of the QCD coupling in inclusive energy spectra and lend further support to the LPHD picture.

MOMENT ANALYSIS OF ENERGY SPECTRA AND THE EFFECT OF RUNNING COUPLING

ABSTRACT

Single particle inclusive energy spectra in e^+e^- annihilation are analyzed in terms of moments. By assuming LocalParton Hadron Duality (LPHD), experimental data in a wide cm. energy range from 3 GeV up to LEP energy are compared to the theoreticalpredictions of Modied Leading Log Approximation (MLLA) of QCD with and without taking into account the running of $_s$. MLLA with running coupling (Limiting Spectrum) is found to reproduce experimental results very well, while the model with exed coupling is inconsistent with data. Rescaled cumulants are shown to be sensitive to the running of $_s$ in the asymptotic regime, while the Lorentz-invariant distribution, Edn= $_s$ 0, points out this e ect at very small energy E of few hundreds MeV. These results give a direct evidence of the running of the QCD coupling in inclusive energy spectra and lend further support to the LPHD picture.

1. Introduction

The main open problem in strong interaction phenomenology is the understanding of the hadronization mechanism. There is indeed a gap between theoretical predictions coming from perturbative QCD at parton level and experimental results at nalparticle level. A bridge between these two sides is given by a soft connement mechanism $^{1;2}$: single particle inclusive spectra are simply required to be proportional to single parton inclusive spectra obtained from perturbative QCD, provided the parton cascade is evolved down to a cuto—scale of the order of the hadronic masses Q0' mh. This hypothesis of Local Parton Hadron Duality (LPHD) has been particularly successful in describing both the shape and the position of the maximum of single inclusive charged particle momentum spectra in hadronic jets in e^+e^- annihilation ranging from PETRA/PEP to LEP energy $^{5;6;7;8}$. Recently, similar results have been obtained in DIS for inclusive momentum spectra in the Breit frame at HERA $^{9;10}$.

In this paper, I report on the results obtained in collaboration with W olfgang O chs¹¹. We performed the analysis of moments up to order 4 of single particle inclusive energy spectra in hadronic jets in e⁺ e annihilation. Since moments are sensitive to the tail of the distribution, i.e., to the low energy region, a consistent kinematical scheme has been dened to relate parton and hadron spectra. Our aim was two-fold:

rstly, to investigate the sensitivity of single particle energy spectra to the running of the coupling $_{\rm s}$, in particular for soft particles in the low energy region, where the coupling is stronger; secondly, to test the validity of the description in terms of perturbative QCD plus LPHD in the small cm. energy domain.

2. The theoretical fram ework

2.1. M LLA Evolution Equations

The evolution equation of single parton inclusive energy distribution in the fram e-work of MLLA is given by²:

with the boundary condition at threshold $P=Q_0$, xD_A^B (x; $logQ_0)=(1-x)_A^B$. Here P and denote the primary parton energy and jet opening angle respectively, x is the energy fraction carried by the produced parton, i(z) are the parton splitting kernels and i,j, A, B, C label quarks, antiquarks and gluons. The QCD running coupling is given by its one-loop expression i(z) (i(z)) = 2 = i(z)0 by i(z)1 with i(z)2 coupling is given by its one-loop expression i(z)3 the number of colors and of avors respectively. The scale of the coupling is given by the transverse momentum i(z)4 colors are expectively. The shower evolution is cut of i(z)5 by i(z)6 colors and i(z)6 colors are expectively. The integral equation can be solved by M ellin transform:

with $Y = log \frac{P}{Q_0}$ ' $log \frac{P}{Q_0}$, $= log \frac{Q_0}{k}$ and parton energy k.

In avorspace the valence quark and () m ixtures of sea quarks and gluons evolve independently with dierent \eigenfrequencies". At high energies, the dominant contribution to the inclusive spectrum comes from the \plus"-term, which we denote by D $_{!}$ (Y;). By keeping now, as usual, only the leading singularity in !-space plus a constant term, one gets:

the evolution equation for the inclusive spectrum can also be written as a di erential equation for \cdot . In general this nonlinear equation has two roots and the solution consists of a superposition of two terms of the type (4). The explicit solution of eq. (3) can be expressed indeed as a linear superposition of two hypergeom etric distributions². An interesting case of the general solution is the Limiting Spectrum, where the two parameters coincide, $Q_0 = \cdot$, i.e., = 0. In this case, the expressions simplify and a simpler integral representation of the spectrum has been achieved.

2.2. M LLA with xed s

In order to study the sensitivity of the single particle inclusive energy distribution to the running of the coupling, we built a new model based on M LLA formalism but with the coupling kept xed at a given value. In this case, the value of the coupling or, equivalently, the value of the parameter $_0$, $_0^2 = 6_s =$, replaces as a free parameter of the model. A coordingly, eq. (3) becomes now:

One can then perform explicitly the inverse M ellin transform and get an explicit solution for the inclusive energy spectrum in M LLA with xed- $_{\rm s}$:

3. M om ent analysis: from m om entum spectra to energy spectra

3.1. M om ent analysis

In addition to the standard study of single particle inclusive distribution, one can also study the multiplicity N and the normalized moments of the distribution, < q(Y;)>, given by:

One also introduces the reduced cumulants $k_q = q$, in particular the skewness $s = k_3$ and the kurtosis $k = k_4$. The cumulants q can be derived from the expansion:

At high energies, one term of the form (4) dom inates and one obtains

This equation shows the direct dependence of the moments on $_{\rm s}$ (Y). For xed $_{\rm s}$, for example, one obtains directly $_{\rm q}$ (Y) / Y for high energies.

Let us stress that the study of moments and cumulants is worth to be pursued, since explicit analytical expressions for their dependence on cm. energy have been obtained in moments of order q in the M LLA model with running coupling can indeed be expressed as a function of a, b, Y + and , while moments for the Limiting Spectrum can be expressed in a simpler way in terms of the parameter B a=b and the variable z $16N_cY=b$. In the xed s model, the solution is straightforward, since in this case the evolution equation for the anomalous dimension reduces to an algebraic equation. In addition, if the higher order cumulants (q > 2) are su ciently small, one can reconstruct the -distribution from the rst four order cumulants, using a D istorted G aussian parametrization of the spectrum 12 .

However, let us notice again that high order moments are sensitive to the tail of the distribution; therefore, one has to look carefully at the treatment of the low energy region $E \,!\, Q_0$. This point is discussed in detail in the next Subsection.

3.2. The rescaling procedure

In theoretical calculations, partons are taken as massless, $E_p=p_p$, but a p_t cuto Q_0 , p_t-Q_0 , is needed for infrared regularization; therefore, E_p-Q_0 and the theoretical spectrum goes linearly to 0 for E ! Q_0 . These predictions are usually compared to experimental results on single particle inclusive momentum spectrum, which show a nite tail down to very low momentum (large). The difference of the two spectra in their tails could a ect significantly the moment analysis. In order to cure this anomaly, let us remaind that observable hadrons are massive, therefore E_h-m_h . It has been therefore suggested to identify the cuto parameter Q_0 appearing in theoretical calculations with an elective hadron mass averaged over all charged particles. In addition, one has to look at energy spectra rather than at momentum spectra. Let us also remaind that the Lorentz-invariant distribution $E_{\frac{dn}{d^3p}}$ approximately follows an exponential law in low-energy experiments for suiciently small energies:

with E $_0$ ′ 150 M eV $^{14;15;16}$. By performing a suitable rescaling, the spectrum E $_h$ dn=dp $_h$ goes then linearly to 0 for E ! Q $_0$.

In conclusion, we propose to compare theoretical predictions for single particle inclusive energy spectra with the experim ental spectrum

where an elective mass Q $_0$ is assigned to all particles, i.e., $E_h = \frac{q}{p_h^2 + Q_0^2}$. Notice then that experimental spectra do depend on the chosen value of Q $_0$.

4. Results

4.1. M om ents

Figure 1 shows (the logarithm of) the average multiplicity N $_{\rm E}$ and the rst four cumulants of charged particle energy spectra as a function of Y = log (s=2Q $_{\rm O}$) for Q $_{\rm O}$ = 270 M eV . For the calculation of moments, an additional value for the bin in the unmeasured interval near $_{\rm E}$ 'Y (small momenta) has been added by linear extrapolation. Errors of the moments are taken as the sum of statistical and system atic errors. The latter particularly a ects the overall normalization and then the average multiplicity; higher order moments are on the contrary independent of the overall normalization. The errors of the moments also includes the errors on the central values of $_{\rm E}$ in each bin, taken as half the bin-size. The value of Q $_{\rm O}$ has been obtained by comparing the moments determined for a selected Q $_{\rm O}$ with the theoretical predictions of MLLA with running $_{\rm S}$ at different values of . The best agreement is obtained for the Limiting Spectrum

P redictions of the Lim iting Spectrum with this value of Q_0 and number of avors $n_f = 3$ are shown in the Figure (solid lines). For the average multiplicity we added two new free parameters:

where the factor 4=9 is the proportionality factor between quark and gluon jets and the factor 2 accounts for the two hem ispheres; the two additional free parameters c_1 and c_2 give the proportionality factor between parton and hadron spectra and the leading particle contribution respectively. This second parameter is needed to recover the right behavior near threshold, as the prediction of the Limiting Spectrum does not full 11 the correct boundary conditions. The values of the two parameters have been xed by thing the lowest and the highest energy data points.




Fig. 1. The average multiplicity N $_{\rm E}$ and the rst four cumulants of charged particles' energy spectra E dn=dp vs. $_{\rm E}$, i.e., the average value $_{\rm E}$, the dispersion 2 , the skewness s and the kurtosis k, are shown as a function of Y = \log ($_{\rm S}$ =2Q $_{\rm O}$) for Q $_{\rm O}$ = 270 M eV .D at a points from MARK I 16 at $^{\rm P}$ $_{\rm S}$ = 3, 4.03, 7.4 G eV , TASSO 4 at $^{\rm P}$ $_{\rm S}$ = 14, 22, 35, 44 G eV and LEP at $^{\rm P}$ $_{\rm S}$ = 91.2 G eV (weighted averages of A LEP H I 8 , L3 6 and O PA L 5). Predictions of the Limiting Spectrum (i.e. Q $_{\rm O}$ =) of M LLA with running $_{\rm S}$ and of M LLA with xed $_{\rm S}$ are also shown (for n $_{\rm f}$ = 3). Predictions of the average multiplicity refer to the two-param eter form ula N $_{\rm E}$ = $c_1 2\frac{4}{0}$ N $_{\rm P}$ art + c_2 .

The predictions from M LLA with running $_{\rm S}$ and normalization at threshold are remarkably successful considering the fact that there are only two parameters, actually coinciding, for the four cumulants. The deviation in $_{\rm E}$ at the lower energies may suggest that the leading valence quark, which is now neglected by restricting to the D $^+$ spectrum, plays indeed a role at low cm . energies. O therwise, the predictions are con rm ed at an almost quantitative level down to the lowest cm . energies.

Figure 1 also shows the theoretical predictions for M LLA with xed $_{\rm S}$ (dashed lines) for the same value of Q $_{\rm 0}$ and n $_{\rm f}$ and $_{\rm 0}$ = 0.64. This value of $_{\rm 0}$ has been chosen in order to obtain a good to for the average multiplicity, where we proceed as above to a twith two additional free parameters. With this value of $_{\rm 0}$, the asymptotic slope for $_{\rm E}$ is also well reproduced. An adjustement of the absolute normalization of $_{\rm E}$ at a particular energy Y $_{\rm 0}$ would be possible if the perturbative QCD evolution towards lower energies and the normalization at threshold are abandoned. Looking at higher order moments, however, the model with xed $_{\rm S}$ is unable to reproduce the experimental behavior. In addition, the xed $_{\rm S}$ regime can be excluded already close to threshold. Indeed, if we suppose that the coupling is xed for a certain energy interval near threshold Y $_{\rm 0}$ Y Y $_{\rm 1}$ and only runs for Y > Y $_{\rm 1}$, then would be shifted towards smaller values because of the very different evolution near threshold, in contrast to the experimental behavior.

4.2. Rescaled cum ulants

In addition to the standard moment analysis, it is interesting to consider the rescaled cumulants $_{\rm q}=$; in the high energy lim it they become energy independent in the model with xed coupling (see eq. (10)) and therefore exhibit more directly the dierence to the case of running coupling in the asymptotic domain.

Figure 2 show the experimental results on rescaled cumulants of order 2, 3 and 4 for Q $_0$ = 270 MeV; a clear Y-dependence in the available energy range is visible; this result is well reproduced by predictions of MLLA with running $_{\rm s}$ and $\rm n_f$ = 3, while is again in contradiction with the constant behavior expected for xed $_{\rm s}$. It would be interesting to continue this type of studies for instance at TEVATRON, where jets of higher energies are available, in order to test whether the rescaled cumulants show the remarkable dependence on Y predicted by the theory.

Let us also comment the dependence of the above results on the number of active avors $n_{\rm f}$. In leading order $n_{\rm f}$ enters only through the running coupling $_{\rm s}$ (Y; $n_{\rm f}$), while at next-to-leading level also through the parameter a. It has been argued that the number of avors $n_{\rm f}$ should be kept xed at 3, as light quarks should dominate quark-pair production in a well-developed cascade. However, one can also include heavy quark thresholds in the calculation $\sin pl_y$ by taking $_{\rm l}$ (y) under the integral with $n_{\rm f}$ as the number of open avors at energy y. Restricting our discussion to the leading term we note that in the original eq. (1) the scale of $_{\rm s}$ is $k_{\rm t}$ ' $_{\rm c}$ (1) $_{\rm c}$)P < P=4.




Fig. 2. Rescaled cumulants $_{\rm q}=$ as a function of Y = $\log(\frac{1}{s}=2Q_0)$ with the corresponding predictions of the Limiting Spectrum of M LLA with running $_{\rm s}$ either without or with heavy avors included. Data as in Figure 1. For xed $_{\rm s}$ these quantities approach constant values at high energies.

Therefore, we included the e ect of heavy quarks in n_f for momentum $P>4m_Q$. The e ect of including heavy quarks thresholds in the model gives a correction of a few %, as shown for rescaled cumulants in Figure 2 (dashed lines). In addition, let us rem ind that further uncertainties on the scale of the running, two-loop e ects and a possible explicit mass dependence of the coupling 17 are neglected in this approach.

4.3. Low-energy behavior: Boltzmann factor or running-s e ect

Let us consider again the Lorentz-invariant distribution E dn= d^3p as a function of the particle energy E for sm all energies up to $1 \ G$ eV . The experimental exponential behavior is often related to the B oltzm ann factor in the therm odynam ical description of m ultiparticle production.

Figure 3a shows experimental data on the invariant distribution at three dierent cm. energies. All three distributions tend to a common behavior at very low energies E, even though deviations from a simple exponential are visible at larger cm. energies. Theoretical predictions for the Limiting Spectrum of MLLA with running s and for MLLA with xed s (with 0 = 0.64) with the same value of Q0 are also shown. Both theoretical curves are normalized to the experimental average multiplicity. Figure 3b compares the same data with theoretical predictions from the Limiting Spectrum of MLLA with running s in a wide energy range up to 30 GeV. It is remarkable that the Limiting Spectrum of MLLA is in good agreement with experimental data in a wide energy range and can approximately reproduced the exponential decrease of the spectrum in the low energy region. On the contrary,




Fig. 3. Invariant distribution E dn=d³p as a function of the particle energy E for Q $_0$ = 270 M eV. a) comparison of experimental data from MARK $\rm I^{16}$ (diamonds), TASSO 4 (triangles) and OPAL 5 (squares) with predictions from MLLA with running $_{\rm S}$ (Limiting Spectrum) (solid lines) and with xed $_{\rm S}$ (dashed lines). b) same as in a), but in the energy range up to 30 GeV; only predictions from MLLA with running $_{\rm S}$ are shown; c) analytical predictions of the Born term of DLA with running $_{\rm S}$ (solid line) and with xed $_{\rm S}$ (dashed line); both curves are arbitrarily normalized to a common value.

the exact solution of the $\,$ xed- $_{\rm s}$ m odel shows a $\,$ atter behavior, inconsistent with experim ental behavior.

This behavior near the kinem atical lim it E $\,!\,Q_0$ can be qualitatively understood in an analytical way in the DLA, where eq. (1) becomes:

The above evolution equation can be solved iteratively; with one iteration, one gets the Born term, which is the leading term in the \lim it E ! Q_0 :

The di erence between the xed and the running $_{\rm s}$ case is fully due to the expression of the anom alous dimension: in the xed- $_{\rm s}$ model, $_{\rm 0}$ becomes a constant, then:

whereas for running s, 0 $(y^0) = 12=b=(y^0+)$,

Notice that in both cases the spectra go to nite values independent of cm. energy in the limit E! Q_0 ; the dependence of the spectrum on cm. energy enters in higher orders term s. Predictions for the Born term sofD LA in the two models (with arbitrary normalization) are shown in Figure 3c; notice the relative enhancement at low energy E in the model with running s. This behavior can be intuitively explained: as for decreasing particle energy E also the typical particle p_t is necessarily decreasing, the coupling s $p_t = 1$ is rising in the running scase, whereas the xed model cannot account for such an elect.

5. Conclusions

The analysis of energy spectra in terms of moments has been performed. A consistent kinem atical scheme to relate parton and hadron spectra in the low-energy region has been de ned. This yields a good agreem ent of experim ental data with theoretical predictions of M LLA with running splus LPHD in a wide cm. energy range from 3 GeV up to LEP energy. The best agreement with data is found for the Lim iting Spectrum, where the two parameters of the theory coincide, i.e., $Q_0 = i$; the best value of Q_0 has been estimated to be 270 20 MeV. The zero-th order moment, i.e., the average multiplicity, requires two more parameters to x the overall normalization for particle production and the leading particle contribution. Predictions of M LLA plus LPHD but with xed coupling are inconsistent with the experimental behavior in the full energy range, thus showing a direct evidence for the running of the coupling in hadronic energy spectra. The e ect of the running s is most pronounced near threshold where the variation of the coupling is strongest; it approximately reproduces the exponential dependence of the Lorentz-invariant distribution E dn=d3p at low particle energies E of few hundreds M eV. The analysis of rescaled cumulants is shown to be more sensitive to the dierence with the xed_{s} regime in the highenergy region, for instance at TEVATRON energies. A similar analysis ranging from low to high values of the available energy can be performed also at HERA by looking at hadronic jet production in the Breit fram e.

The obtained results give further support to the LPHD picture. A word of caution is appropriate nevertheless. The M LLA is based on high energy approximations (restriction to D $^+$ contribution, neglect of N ext-to-N ext-to-Leading e ects) which have been extended into the low-energy region. A deviation in at 3 G eV could indeed suggest that further contributions are needed. A lso additional scheme-dependence of the coupling and two loop e ects have been neglected in the calculation. Finally let us remained that we safely identified Q $_0$ with an elective hadron mass, since we referred to single inclusive spectra for all charged particles, but this identification cannot be pushed forward to single inclusive spectra for identified particles without taking into

account the e ects of resonance decay, as recently shown in 18 .
