## F lavor and $H$ orizontal Sym m etries

#### Abstract

A fter a brief introduction to what are the basic avor questions to be addressed, I introduce the underlying ideas of horizontal sym $m$ etries, with group $G_{H}$. For the purposes of speci cmodelbuilding, it is usefulto classify m odels according to the scale at which $G_{H}$ is broken. I consider the three cases: below $\mathrm{m}_{\mathrm{t}}$; som ew hat above $\mathrm{m}_{\mathrm{t}}$; and at $\mathrm{M}_{\mathrm{Gu}} \mathrm{t}$. A fter a discussion of the shadow sector in the $\mathrm{E}_{6} \quad \mathrm{E}_{8}^{0}$ superstring, there is a sum $m$ ary.


x1. F lavor $Q$ uestions.

W e m ay identify three issues:
(i) Replication.

Surely the $m$ ost basic avor question is why there exists the replication of the quarks: $u, d ; c, s ; t b$ and sim ilarly for the leptons: e;e; ; ; ; .

W hy are there three fam ilies? A lthough there are papers about this topic, it will not be my sub ject here.
(ii)Ferm ion m ass hierarchy.

If I de ne $=\sin c^{\prime} \quad 0: 22$, the C abibbo angle, as a "sm all" param eter then for the up-type $(Q=+2 / 3)$ quarks:

These masses are evaluated at the GUT scale $2 \quad 10^{16} \mathrm{GeV}$. W hence do such hierarchies arise?

where these four elem ents are of order $1 ;{ }^{2} ;{ }^{3}$ respectively. W hence do these hierarchies com e? ......is the third and last avor question.
$N$ ote that the ferm ion and $m$ ixing hierarchies speak to 12 of the 19 param eters of the Standard M odel: the $\mathrm{m}_{\mathrm{i}}$ and the k . The others 7 are: the three couplings i; the two CP param eters and ${ }^{-}$; and the two scales $M_{W}$ and $M_{H}$ arising in the electrow eak sym $m$ etry breaking.

## x2. H orizontal Sym m etries

Let the horizontal sym $m$ etry group $b e G_{H}$. There are choices to be $m$ ade about $G_{H}$ : w hether it is global or gauged, nite or in nite ( L ie), abelian or non-abelian.

M y choices w ill be: gauged, nite and non-abelian.
 been studied previously.

W hat Im ean by a gauged nite group will be discussed below .
$F$ inst I o er a brief review of all nite groups of order $g$ 31. D ne usually stops at $g=2^{n} \quad 1$ because_of the richness of $g=2^{n}$ ] In this range there are, according to standard textbooks $\mathbf{l}^{\mathbf{4}^{\prime} \mathbf{2}}, 93$ inequivalent groups of $w$ hich 48 are abelian and 45 are non-abelian. $g \quad 32 \mathrm{~m}$ ight be interesting too but low er $g$ is surely $m$ ore econom ic.
 the elem ents are the $p^{\text {th }}$ roots of unity, $e^{2} i=p$. The only fact one needs is that $Z_{p} \quad Z_{q}$ is equivalent to $Z_{p q}$ if and only if $p, q$ have no com $m$ on prim efactor. So if I decom pose the order $g$ of the group into its prim efactors $g={ }_{Q}{ }_{i} p_{i}^{k_{i}}$ then the num ber of inequivalent abelian nite groups at order $g$ is $N a(g)={ }^{2}{ }_{k_{i}} P\left(k_{i}\right)$, where P ( ) is the num ber of ordered partitions of . For exam ple, $\mathrm{P}(1 ; 2 ; 3 ; 4)=1 ; 2 ; 3 ; 5$.

For the cases $g$ 31, one nds $\mathrm{N}_{\mathrm{a}}(\mathrm{g})=1$ except that $\mathrm{N}_{\mathrm{a}}(\mathrm{g})=2$ for $\mathrm{g}=$ $4,9,12,18,20,25,28 ; \mathrm{N}_{\mathrm{a}}(\mathrm{g})=3$ for $18,24,27$; and $\mathrm{N}_{\mathrm{a}}(16)=5$.

Thus, adding these results gives the required answ er of 48 abelian groups w ith $g$ 31. T hese w ill not be considered further here.

N ow, and for the rem ainder of the talk, I shallconsider non-abelian nite groups. The best known are the $S_{N}$ perm utation (or sym $m$ etric) groups $w$ th order $g=$ $N$ ! Since 9 grow s so rapidly, only $N=3,4$ are in our range. $G$ enerally, $S_{N} \quad O(\mathbb{N} 1)$ and can be interpreted geom etrically as the sym $m$ etry of a regular $N-p l e x$ in ( $\mathbb{N}$ 1) spatial dim ensions.
$N$ ext com e the dihedral groups $D_{N}$, w th order $g=2 N$, which are subgroups of 0 (3). T he geom etrical intenpretation is the sym $m$ etry of a 2 -sided planar regular N -agon in 3 spatial dim ensions where the polygon is treated as a "tw o-faced" entity.
$T$ here is the one $g=12$ tetrahedral group ( $T$ ) which is the even-perm utation subgroup of $S_{4}$.

Spinorial generalizations (doubles) of the $D_{N}$ are the dicyclic groups $Q_{2 N}$ which have order $g=4 N$ and are subgroups of $S U$ (2) rather than $O$ (3).

$Q_{2 N}$ is thus the full $S U$ (2) sym $m$ etry of a planar regular $N$ agon where rotation by 2 gives a sign -1 ; only rotation by 4 brings back the identity.
2.1. $G$ auging $G_{H}=Q_{2 N}$

G auging $G_{H}$, a nite group, is subtle as is im m ediately seen by considering the covariant derivative. In fact, at a local level it is meaningless in a at spacetim e neighb orhood. G lobally, w ith respect to topological aspects of the spacetim em anifold, it is best done by gauging $S U(2)_{H} \quad Q_{2 N}$ then spontaneously breaking to $Q_{2 N}$. If this is at a high scale, the e ective theory has no gauge eld - but consistency w th worm holes is preserved.

G auging leads to consistency requirem ents:
(a) C hiral ferm ions $m$ ust be in com plete representations of $S U(2)_{\mathrm{H}}$.
(b) $\left(S U(2)_{H}\right)^{2} Y$ anom alies $m$ ust cancel.
(c) W itten's globalSU (2) $)_{\mathrm{H}}$ anom aly m ust cancel.
(b) and (c) are straightforw ard but (a) requires the dictionary for em bedding $Q_{2 N} \quad S U(2) . T h i s$ is actually a sim ple pattem:

$T$ he sym $m$ etry-breaking steps involve a VEV to a $Q_{6}$ singlet) $t m$ ass; then a VEV to a $1^{0}$ breaks $Q_{6}$ to $Z_{6}$, providing b; $m$ asses. $A\left(1 ; 2_{(1)}\right) V E V$ gives the $c m$ ass and nally a $\left(2 ; 1^{\infty}+1^{00}\right)$ VEV gives the $s ; ~ m$ asses.

Som e rem arks on the $Q_{6} \mathrm{~m}$ odel:
(i) The $\left(S U(2)_{H}\right)^{2} Y$ anom aly cancellation requires certain extra singlets predicted to lie betw een 50 GeV and 200 GeV .
(ii) T he hierarchy of Yukaw a couplings has been rem oved: they now all lie betw een 0.1 and 1.0.
(iii) It provides a rst step to understanding why the top quark m ass is so di erent from the other quark $m$ asses.

## 32. B reaking of $G_{H}$ at $1 T \mathrm{eV}$

H ere we shalluse non-abelian horizontalsym $m$ etry in connection $w$ ith derivation of an ansatz for the texture zeros in the quark $m$ ass $m$ atrices.

The horizontalsym $m$ etry $w$ illbe again $Q_{2 N}$, but now the $F$ roggatt $-N$ ielsen $m$ echan ism (1) becom es an essential part of $m$ ass generation. This $m$ eans that additional vector-like pairs of ferm ions, at high scale, are present - and these $m$ ust likew ise be assigned to rep resentations of $G_{H}$.

The quark assignm ents are:


T he lepton doublets are correspondingly $\left(2_{(1)}+1\right)$ and the singlets $\left(2_{(2)}+1^{0}\right)$. $T$ his assignm ent is com pletely anom aly-free. To consider the quark $m$ asses I put the SM H iggs doublet in to down quarks. Their VEVs give $m$ asses only to the third fam ily. The other elem ents of the up-quark $m$ ass $m$ atrix $M_{U}$ arise from FroggattN ielsen graphs shown in F ig. 1.

There are second graphs, not show $n$ in $F$ ig.1, for $\left(M_{U}\right)_{32}, ~\left(M_{U}\right)_{31}$. Sim ilar graphs for $\left(M_{D}\right)$ lead to the textures:

where the "odd" $Q_{6}$ doublets occur in the $S U(2)_{H}$ spinor representions; the "even" in the vector ones.

Three other phenom enologically-viable textures ${ }^{\text {iqi }}{ }^{(8)}$ which are sym $m$ etric $w$ ith ve zeros are not attainable and hence disfavored.
$T$ he postulation of zeros in the $m$ ass $m$ atrices reduces the num ber of free param eters in the low energy theory. This now has a dual description in term s of a horizontal sym m etry $Q_{2 N} \quad S U(2)_{H}$.

This SU (2) H could arise from a GUT group or directly from a superstring.
M y m ain point is that derivation of the values of the $m$ asses in a putative theory of everything $m$ ay likely involve a horizontal sym $m$ etry, probably gauged, as an im portant interm ediate step. T he two sim ple cases given above illustrate how this can happen.

## 3.3. $G_{H}$ Breaking $M_{G U T}$

A gain the Froggatt- N ielsen $m$ echanism is used, invoking a spectrum of superheavy ferm ions in vector-like pairs.

The symm etry group(4) is $S U(5) \quad S U(5) \quad S U(2)_{H} T h e S U(2)_{H}$ is broken to $Q_{12}$ at $M(S U(2))$ and the $S U(5) \quad S U(5)$ is broken to a diagonalSU(5) at $M_{G U T}$. Supersym $m$ etry is broken near the weak scake.

The light, heavy and superheavy ferm ion contents are in the follow ing list of chiral SU (5) SU (5) superm ultiplets. The third entry denotes the content under $S(2)_{\mathrm{H}}!\mathrm{Q}_{12}$ 。

T his list is seen to be relatively short when one realizes that it includes all the vector-like $\mathrm{F}-\mathrm{N}$ superheavy ferm ions and the light chiral ferm ions.
$T$ hee ective theory at the weak scale contains only the ferm ions of the standard $m$ odel transform ing as follow $s:(u ; d)_{L} ;(c ; s)_{L}$ as $Q\left(2_{1}\right)$; $(t ; b)_{L}$ as $T(1) ; u_{R} ; C_{R}$ as $\mathrm{U}\left(2_{1}\right) ; \mathrm{d}_{\mathrm{R}} ; \mathrm{S}_{\mathrm{R}}$ as D (2 $\mathrm{L}_{1}$; $\mathrm{t}_{\mathrm{R}}$ as T (1); $\mathrm{b}_{\mathrm{R}}$ as $\mathrm{H}_{\mathrm{d}}=\mathrm{b}\left(2_{5}\right)$.
$T$ his gives supersym $m$ etry w thout $R$-parity. $b \quad=H_{d}$ are in a horizontal doublet incom patible w ith the usualR -parity, but $m$ atter parity arises here from group properties of $\mathrm{H}_{\mathrm{H}}$. The " problem " ( $5: 5$ term at tree level) is also solved here by $\mathrm{G}_{\mathrm{H}}$.

This is a phenom enologicaly viable SusyG UT for the low energy param eters.

## x4. Shadow $E_{8}^{0}$ Sector

For the heterotic string, the $\mathrm{E}_{8} \quad \mathrm{E}_{8}^{0}$ becom es on C alabi-Y au com pacti cation typically $\mathrm{E}_{6} \quad \mathrm{E}_{8}^{0}$ and the $\mathrm{E}_{6}$ can becom eSU $(3)^{3}$, for exam ple. In the visible sector one then has uni cation at $\mathrm{M}_{\mathrm{GUT}} \quad 2 \quad 10^{16} \mathrm{GeV}$ w ith $\underset{\mathrm{GUT}}{1} 25$.
$T$ he $S U(3)^{3}$ couplings have $=0$ and consistency dictates an $M$ string $=3: 5$ $10^{17} \mathrm{GeV}$. B ridging across to the shadow sector one can choose an $\mathrm{SU}(\mathbb{N})$ gauge subgroup of $\mathrm{E}_{8}^{0}$ such that N becom es O (1) at a scale where a ghino condensate $m$ ay break supersym $m$ etry. $T$ his suggests e.g. $S U(5) \quad S U(4), U(1)$. It is possible that the shadow photino can act as cosm ological dark $m$ atter ${ }^{\left(99_{1}^{\prime}\right)}$.
x5. Sum m ary
$T$ he avor questions for ferm ion $m$ ass and $m$ ixing hierarchies $m$ ay require gauged horizontal sym $m$ etries and the above exam ples ilhustrate how the dicyclic groups are well-suited. The covering $S U(2)_{H}$ is gauged for consistency. The cases I have described show how this can happen and how it can give phenom enologically acceptable $m$ ass $m$ atrioes and $m$ ixings.
