Flavor and Horizontal Sym metries

A fler a brief introduction to what are the basic avor questions to be addressed, I introduce the underlying ideas of horizontal sym m etries, with group $G_{\rm H}$. For the purposes of speci c m odel building, it is useful to classify m odels according to the scale at which $G_{\rm H}$ is broken. I consider the three cases: below m $_{\rm t}$; somewhat above m $_{\rm t}$; and at M $_{\rm G\,U\,T}$. A fler a discussion of the shadow sector in the E $_{\rm 6}$ superstring, there is a sum m ary.

x1. Flavor Questions.

We may identify three issues:

(i)Replication.

Surely the most basic avor question is why there exists the replication of the quarks: u,d;c,s;t,b and sim ilarly for the leptons: <math>e;e;;;;.

W hy are there three fam ilies? A lthough there are papers about this topic, it will not be my subject here.

(ii) Ferm ion mass hierarchy.

If I de ne = \sin_C ′ 0:22, the C abibbo angle, as a "sm all" param eter then for the up-type (Q = + 2/3) quarks:

while for the down-type quarks (Q = -1/3):

The charged lepton masses approximately satisfy:

These masses are evaluated at the GUT scale $2 10^{16} \text{GeV}$. Whence do such hierarchies arise?

(iii) M ixing H ierarchy.

When the quark m ass m atrices are diagonalized w ith the usual bi-unitary transform ations:

and the CKM matrix is constucted by $V_{CKM} = U_L D_L^Y$ one nd that its elements have the hierarchy:

where these four elements are of order 1; ; 2 ; 3 respectively. Whence do these hierarchies come?is the third and last avor question.

Note that the ferm ion and m ixing hierarchies speak to 12 of the 19 parameters of the Standard Model: the m_i and the $_k$. The others 7 are: the three couplings $_i$; the two CP parameters and $_i$; and the two scales M $_W$ and M $_H$ arising in the electroweak symmetry breaking.

x2. H orizontal Sym m etries

Let the horizontal sym m etry group be G_H . There are choices to be made about G_H : whether it is global or gauged, nite or in nite (Lie), abelian or non-abelian.

My choices will be: gauged, nite and non-abelian.

Finite abelian groups $(Z_N)^{(1)}$ and nite non-abelian groups $(S_N \text{ only})^{(2)}$ have been studied previously.

W hat I m ean by a gauged $\$ nite group will be discussed below .

First Io erabrief review of all nite groups of order g=31. [One usually stops at $g=2^n-1$ because of the richness of $g=2^n$] In this range there are, according to standard textbooks⁴⁾, 93 inequivalent groups of which 48 are abelian and 45 are non-abelian. g=32 m ight be interesting too but lower g=32 m ore economic.

Let me deal quickly with all the abelian cases. The building block is Z_p where the elements are the p^{th} roots of unity, $e^{2} \stackrel{i=p}{=} p$. The only fact one needs is that $Z_p = Z_q$ is equivalent to Z_{pq} if and only if p,q have no common prime factor. So if I decompose the order g of the group into its prime factors $g = \frac{Q}{Q} i p_i^{k_i}$ then the number of inequivalent abelian nite groups at order g is $N_a(g) = \frac{Q}{k_i} P(k_i)$, where P(Q) is the number of ordered partitions of . For example, P(Q) is the same place of ordered partitions of .

For the cases g 31, one $\text{nds N}_a(g) = 1$ except that $\text{N}_a(g) = 2$ for g = 4,9,12,18,20,25,28; $\text{N}_a(g) = 3$ for 18,24,27; and $\text{N}_a(16) = 5$.

Thus, adding these results gives the required answer of 48 abelian groups with 31. These will not be considered further here.

Now, and for the remainder of the talk, I shall consider non-abelian nite groups.

The best known are the S_N perm utation (or symmetric) groups with order g=N! Since g grows so rapidly, only N=3,4 are in our range. G enerally, $S_N=0$ (N=1) and can be interpreted geometrically as the symmetry of a regular N-plex in (N=1) spatial dimensions.

Next come the dihedral groups D $_{\rm N}$, with order g = 2N, which are subgroups of 0(3). The geometrical interpretation is the symmetry of a 2-sided planar regular N-agon in 3 spatial dimensions where the polygon is treated as a "two-faced" entity.

There is the one g = 12 tetrahedral group (T) which is the even-permutation subgroup of S_4 .

Spinorial generalizations (doubles) of the D $_{\rm N}$ are the dicyclic groups Q $_{\rm 2N}$ which have order g = 4N and are subgroups of SU (2) rather than O (3).

The majority (32) of the non-abelian groups with order g 31 are made from

 S_N ; D_N ; T; Q_{2N} as follows:

- $g = 6: D_3 (S_3).$
- $g = 8: D_{4}; Q Q_{4}.$
- $g = 10: D_5.$
- $q = 12: D_{6}; Q_{6}; T$.
- $q = 14: D_7.$
- $g = 16: D_{8}; Q_{8}; Z_{2} D_{4}; Z_{2} Q$.
- $g = 18: D_{9}; Z_{3} D_{3}.$
- $g = 20: D_{10}; Q_{10}$.
- $g = 22: D_{11}$.
- $g = 24: D_{12}; Q_{12}; Z_2 D_{6}; Z_2 Q_{6}; Z_2 T; Z_3 D_{4}; D_3 Q; Z_4 D_{3}; S_4.$
- $q = 26: D_{13}$.
- $g = 28: D_{14}; Q_{14}$.
- $g = 30: D_{15}; D_5 Z_3; D_3 Z_5$. There are another 13 which are twisted products of Z_n :
 - $g = 16: Z_2 \sim Z_8 \text{ (tw o)}; Z_4 \sim Z_4; Z_2 \sim (Z_2 Z_4) \text{ (tw o)}.$
 - $g = 18: Z_2 \sim (Z_3 \quad Z_3).$
 - $g = 20: Z_4 \sim Z_5.$
 - $g = 21: Z_3 \sim Z_7.$
 - $g = 24: Z_3 \sim Z_q; Z_3 \sim Z_8; Z_3 \sim D_4.$
 - $g = 27: Z_3 \sim Z_9; Z_3 \sim (Z_3 \quad Z_3).$
 - Of these groups Q_{2N} is of most interest to model-building $^{3);4);5);6)$.

The group Q_{2N} with order g = 4N has 4 singlet representations $1, 1^{\circ}, 1^{\infty}$ and the (N - 1) doublets $Q_{(1)}$; 1 - j (N - 1). The doublet multiplication is:

 Q_{2N} has only singlet and doublet reprentations.

To obtain a clearer intuitive understanding of Q $_{2N}$, it is de ned by the algebra:

and for B I use the simple matrix

 Q_{2N} is thus the full SU (2) sym m etry of a planar regular N-agon where rotation by 2 gives a sign -1; only rotation by 4 brings back the identity.

2.1. G auging $G_H = Q_{2N}$

Gauging G_H , a nite group, is subtle as is im mediately seen by considering the covariant derivative. In fact, at a local level it is meaningless in a at spacetime neighborhood. Globally, with respect to topological aspects of the spacetime manifold, it is best done by gauging SU $(2)_H$ Q_{2N} then spontaneously breaking to Q_{2N} . If this is at a high scale, the elective theory has no gauge led - but consistency with worm holes is preserved.

Gauging leads to consistency requirem ents:

- (a) Chiral ferm ions must be in complete representations of SU $(2)_{\rm H}$.
- (b) (SU $(2)_H$)²Y anomalies must cancel.
- (c) W itten's global SU $(2)_{H}$ anomaly must cancel.
- (b) and (c) are straightforward but (a) requires the dictionary for embedding Q $_{2N}$ SU (2). This is actually a simple pattern:

and so on. The in nite sequence is clear from the above.

x3. M odel Building with Horizontal Q $_{2N}$ Sym metry

There are $\,$ ve "triples" in the standard model for which Q $_{2N}\,$ assignments must be made:

- (1) $(t;b)_L$; $(c;s)_L$; $(u;d)_L$.
- (2) t_R ; c_R u_R .
- (3) b_R ; s_R ; d_R .
- (4) (;)_L;(;)_L;($_{e}$;e)_L.
- (5) $_{R}$; $_{R}$; e_{R} .

These m ust be assigned to anom aly-free com plete representations of SU (2) $_{\rm H}$ G $_{\rm H}$ Q $_{\rm 2N}$. The technical details depend on the G $_{\rm H}$ breaking scale. I shall consider: A 10 G eV , B 10 TeV , C 10^{16} G eV .

3.1. _H $10 \text{GeV} (> m_b)$

A ssignm ents are arranged around the top quark such that:

At the sam e time, I exclude, or m in im ize, additional ferm ions and dem and full anomaly cancellation.

It is possible to show $^{4)}$ that of all the 93 nite groups with g 31, only the dicyclic groups rem ain as candidates for $G_{\rm H}$. The \sin plest model uses Q $_{6}$. Recall that:

The mass matrix textures are:

The sym m etry-breaking steps involve a VEV to a Q $_{\rm 6}$ singlet) t m ass; then a VEV to a 1 breaks Q_6 to Z_6 , providing b; masses. A $(1;2_{(1)})$ VEV gives the cmass and nally a $(2;1^{\infty}+1^{\infty})$ VEV gives the s; masses.

Som e rem arks on the Q_6 m odel:

- (i) The $(SU(2)_H)^2Y$ anomaly cancellation requires certain extra singlets predicted to lie between 50G eV and 200G eV.
- (ii) The hierarchy of Yukawa couplings has been removed: they now all lie
- (iii) It provides a rst step to understanding why the top quark mass is so di erent from the other quark masses.

32. Breaking of G_H at 1TeV

Here we shall use non-abelian horizontal sym metry in connection with derivation of an ansatz for the texture zeros in the quark mass matrices.

The horizontal sym m etry will be again Q_{2N} , but now the Froggatt-Nielsen m echanism 7) becomes an essential part of mass generation. This means that additional vector-like pairs of ferm ions, at high scale, are present - and these must likewise be assigned to representations of $G_{\,\mathrm{H}}$.

The quark assignments are:




Fig. 1. Froggatt-N ielsen tree graphs for M $_u$. (The sym m etric counterparts, (M $_u$) $_{23}$; another graph for (M $_u$) $_{22}$ and (M $_u$) $_{31}$ are not show n)

The lepton doublets are correspondingly $(2_{(1)} + 1)$ and the singlets $(2_{(2)} + 1)$. This assignment is completely anomaly-free. To consider the quark masses I put the SM Higgs doublet in to down quarks. Their VEVs give masses only to the third fam ily. The other elem ents of the up-quark m ass m atrix M $_{
m U}$ arise from Froggatt-Nielsen graphs shown in Fig. 1.

There are second graphs, not shown in Fig.1, for (M $_{\rm U}$)32, (M $_{\rm U}$)31. Sim ilar graphs for (M $_{\rm D}$) lead to the textures:

Here, as before, ' $\sin c$. The expansion parameter is also identied with the ratios:

where the "odd" Q_6 doublets occur in the SU (2)_H spinor representions; the "even" in the vector ones.

A nother sym m etric texture (the only other attainable one with ve zeros) is:

Three other phenomenologically-viable textures⁸⁾ which are symmetric with ve zeros are not attainable and hence disfavored.

The postulation of zeros in the mass matrices reduces the number of free param eters in the low energy theory. This now has a dual description in terms of a horizontal sym m etry Q 2N $SU(2)_{H}$.

This SU (2)H could arise from a GUT group or directly from a superstring.

M y m ain point is that derivation of the values of the m asses in a putative theory of everything may likely involve a horizontal symmetry, probably gauged, as an im portant intermediate step. The two simple cases given above illustrate how this can happen.

33. GH Breaking MGUT

Again the Froggatt-Nielsen mechanism is used, invoking a spectrum of superheavy ferm ions in vector-like pairs.

The sym m etry group $^{6)}$ is SU (5) SU (5) SU (2)_H The SU (2)_H is broken to Q_{12} at M (SU (2)) and the SU (5) SU (5) is broken to a diagonal SU (5) at M $_{\rm GUT}$. Supersym m etry is broken near the weak scake.

The light, heavy and superheavy ferm ion contents are in the following list of chiral SU (5) SU (5) supermultiplets. The third entry denotes the content under $S(2)_{H} ! Q_{12}$.

This list is seen to be relatively short when one realizes that it includes all the vector-like F-N superheavy ferm ions and the light chiral ferm ions.

Thee ective theory at the weak scale contains only the ferm ions of the standard model transform ing as follows: $(u;d)_L$; $(c;s)_L$ as Q (2_1) ; $(t;b)_L$ as T (1); u_R ; c_R as U (2_1) ; d_R ; s_R as D (2_1) ; t_R as T (1); b_R as H $_d$ = $b(2_5)$.

This gives supersym metry without R-parity. b =H $_{\rm d}$ are in a horizontal doublet incompatible with the usual R-parity, but matter parity arises here from group properties of G $_{\rm H}$. The " problem " $(\overline{5}.5$ term at tree level) is also solved here by G $_{\rm H}$.

The mass matrix textures are:

This is a phenom enologically viable SusyGUT for the low energy param eters.

x4. Shadow E₈ Sector

For the heterotic string, the E $_8$ \to 0_8 becom es on Calabi-Yau compactication typically E $_6$ \to 0_8 and the E $_6$ can becom eSU (3) 3 , for example. In the visible sector one then has unication at M $_{\rm GUT}$ 2 $10^{16}{\rm G\,eV}$ with $^1_{\rm GUT}$ 25.

The SU $(3)^3$ couplings have = 0 and consistency dictates an M $_{\rm string} = 3.5$ $10^{17} {\rm G\,eV}$. Bridging across to the shadow sector one can choose an SU (N) gauge subgroup of E $_8^0$ such that $_N$ becomes 0 (1) at a scale where a gluino condensate may break supersymmetry. This suggests e.g. SU (5) SU (4) U (1). It is possible that the shadow photino can act as cosmological dark matter $^{9)}$.

x5. Sum m ary

The avorquestions for ferm ion mass and mixing hierarchies may require gauged horizontal symmetries and the above examples illustrate how the dicyclic groups are well-suited. The covering SU $(2)_{\rm H}$ is gauged for consistency. The cases I have described show how this can happen and how it can give phenomenologically acceptable mass matrices and mixings.
