# REMARKS ON THE INCLUSIVE DECAYS $\Lambda_{b} \rightarrow X_{s} \gamma$ AND $\Lambda_{b} \rightarrow X_{c} l \bar{\nu}_{l}{ }^{*}$

#### Abstract

We consider the effects of quark-binding on the angular distribution and polarization characteristics of the inclusive decays $\Lambda_{b} \rightarrow X_{s} \gamma$ and $\Lambda_{b} \rightarrow X_{c} l \bar{\nu}_{l}(l=e, \tau)$, using the methods of heavy quark effective theory.


## 1 Introduction

This is a summary of two papers 10 in which we have considered the effects of quark-binding on the decays $b \rightarrow$ $s \gamma$ and $b \rightarrow q l \bar{\nu}_{l}$, when the $b$-quark is embedded in a polarized $\Lambda_{b}$-baryon.

In the free-quark model (FQM), the decay $\overrightarrow{\vec{b}} \rightarrow s \gamma$ of a polarized $b$-quark produces a monochromatic photon whose angular distribution relative to the $b$-spin direction is

\frac{d \Gamma}{d \cos \theta} \sim 1-\frac{1-\xi}{1+\xi} \cos \theta \tag{1a}
\end{equation*}
$$

where $\xi=m_{s}^{2} / m_{b}^{2}$. The polarization of the photon is

$$
\begin{equation*}
P_{\gamma}=-\frac{1-\xi}{1+\xi} \tag{1b}
\end{equation*}
$$

Likewise, in the decay $\vec{b} \rightarrow q l \bar{\nu}_{l}$ the angular distribution of the lepton relative to the $b$-spin is

$$
\begin{equation*}
\frac{d \Gamma}{d \cos \theta} \sim 1-\frac{1}{3} f\left(\frac{m_{q}^{2}}{m_{b}^{2}}, \frac{m_{l}^{2}}{m_{b}^{2}}\right) \cos \theta \tag{2}
\end{equation*}
$$

where $f\left(m_{q}^{2} / m_{b}^{2}, m_{l}^{2} / m_{b}^{2}\right)$ is a calculable function equal to unity when $m_{q}$ and $m_{l}$ are zero. The lepton in the final state has a characteristic polarization $\vec{P}$, with a longitudinal component $P_{L}$ and a transverse component $P_{T} \sim m_{l} / m_{b}$ in the decay plane. Our objective is to analyse how the free-quark characteristics (11) and (2) are modified when the $b$-quark is a constituent of a polarized $\Lambda_{b}$-baryon.

[^0]2 The decay $\Lambda_{b} \rightarrow X_{s} \gamma$
The decay $\vec{\Lambda}_{b} \rightarrow X_{s} \gamma$ is governed by the effective Hamiltonian

& \times \bar{s} \sigma^{\mu \nu}\left(m_{b} P_{R}+m_{s} P_{L}\right) b F_{\mu \nu} \tag{3}
\end{align*}

which produces a distribution $\left(y=2 E_{\gamma} / m_{b}\right)$
$\frac{d \Gamma}{d y d \cos \theta}=\frac{\alpha G_{F}^{2} m_{b}^{2}}{2^{7} \pi^{5}}\left|V_{t b} V_{t s}^{*}\right|^{2}\left|c_{7}\left(m_{b}\right)\right|^{2} y \operatorname{Im} T(y, \cos \theta)$,
where the function $T(y, \cos \theta)$, calculated to order $1 / m_{b}^{2}$ in the operator product expansion (OPE), is ${ }^{1}$

\begin{align*}
T(y, \cos \theta) & =2 y^{2} m_{b}^{3} \frac{1}{\left(y-y_{0}-i \epsilon\right)} \\
& \times\{[1+h(y) K](1+\xi) \\
& \left.-\cos \theta\left[1+\epsilon_{b}+h(y) K\right](1-\xi)\right\}, \tag{5}
\end{align*}

with

$$
\begin{equation*}
h(y)=\frac{5}{3}-\frac{7}{3} \frac{y}{\left(y-y_{0}-i \epsilon\right)}+\frac{2}{3} \frac{y^{2}}{\left(y-y_{0}-i \epsilon\right)^{2}} . \tag{6}
\end{equation*}

The parameters $K$ and $\epsilon_{b}$ are defined by

K & =-\left\langle\Lambda_{b}\right| \bar{h}_{v} \frac{(i D)^{2}}{2 m_{b}^{2}} h_{v}\left|\Lambda_{b}\right\rangle  \tag{7}\\
\left(1+\epsilon_{b}\right) s^{\mu} & =\left\langle\Lambda_{b}(s)\right| \bar{b} \gamma^{\mu} \gamma^{5} b\left|\Lambda_{b}(s)\right\rangle \tag{8}
\end{align*}
$$

and express the effects of quark-binding. The angular distribution of the decay photon is

$$
\begin{equation*}
\frac{d \Gamma}{d \cos \theta} \sim 1-K-\left(1+\epsilon_{b}-K\right) \frac{1-\xi}{1+\xi} \cos \theta \tag{9a}
\end{equation*}
$$

Table 1: Angular distribution of leptons in the inclusive decay $\stackrel{\overrightarrow{\Lambda_{b}}}{\Rightarrow} \rightarrow X_{q} l \bar{\nu}_{l}$, including quark-binding effects.

and the photon polarization, as a function of direction, is

$$
\begin{equation*}
P_{\gamma}(\cos \theta)=-\frac{1-\xi-\alpha(1+\xi) \cos \theta}{1+\xi-\alpha(1-\xi) \cos \theta}, \tag{9b}
\end{equation*}
$$

with $\alpha=\left(1+\epsilon_{b}-K\right) /(1-K)$. The results (9a) and (9b), which are the QCD-improvements of the results (1a) and (1b), are represented in Figs. [1] and 2, for $K=0.01$ and $\epsilon_{b}=-\frac{2}{3} K$.

## 3 The decay $\Lambda_{b} \rightarrow X_{q} l \bar{\nu}_{l}$

In the case of the decay $\vec{\Lambda}_{b} \rightarrow X_{q} l \bar{\nu}_{l}(q=u$ or $c, l=e$ or $\tau)$, the differential decay rate has the form $d \Gamma \sim L_{\mu \nu} H^{\mu \nu}$, where the hadronic tensor is

\begin{equation*}
H_{\mu \nu}=\frac{1}{\pi} \operatorname{Im} i \int d^{4} x e^{-i q \cdot x}\left\langle\Lambda_{b}\right| \mathrm{T}\left\{j_{\mu}^{\dagger}(x) j_{\nu}(0)\right\}\left|\Lambda_{b}\right\rangle, \tag{10}
\end{equation*}
$$

with $j_{\mu}=V_{q b} \bar{q} \gamma_{\mu}\left(1-\gamma_{5}\right) b$. This tensor may be expanded in terms of 5 structure functions $T_{1} \ldots T_{5}$, for unpolarized $\Lambda_{b}$, and 9 additional functions $S_{1} \ldots S_{9}$, for polarized $\Lambda_{b}$. Using OPE to order $1 / m_{b}^{2}$, it is possible to determine all of these structure functions in terms of the parameters $K$ and $\epsilon_{b}$.

The inclusive distribution of the lepton as a function of energy and angle has the form ${ }^{2}$ ( $y=2 E_{l} / m_{b}$ )

$$
\begin{equation*}
\frac{d \Gamma}{d y d \cos \theta} \sim\left[A_{0}+A_{1} K+\left\{B_{0}\left(1+\epsilon_{b}\right)+B_{1} K\right\} \cos \theta\right] \tag{11}
\end{equation*}
$$

where $A_{0,1}$ and $B_{0,1}$ are calculable functions of $y$. In the limiting case $\Lambda_{b} \rightarrow X_{u} e \bar{\nu}_{e}$, with $m_{u}=m_{e}=0$, the functions $A_{0}, B_{0}$ have a form familiar from $\mu$-decay:

\begin{equation*}
A_{0}=(3-2 y) y^{2}, \quad B_{0}=(1-2 y) y^{2} . \tag{12}
\end{equation*}
$$

Table 1 lists the inclusive distribution $d \Gamma / d \cos \theta$, integrated over $y$, for the various inclusive processes $\overrightarrow{\bar{\Lambda}}_{b} \rightarrow X_{q} l \bar{\nu}_{l}$. A further observable of interest is the $\tau$ -

polarization in the decay $\Lambda_{b} \rightarrow X_{c} \tau \bar{\nu}_{\tau}$. The $\tau$ has a longitudinal polarization component $P_{L}$ as well as a transverse component $P_{T}$ in the decay plane. These are shown in Figs. 3 and 4 , as functions of the lepton energy. The average values are $\left\langle P_{L}\right\rangle \approx-0.70$ and $\left\langle P_{T}\right\rangle \approx 0.19$. The quark-binding effects are generally small, except in the region of large $y$, where the OPE breaks down, and a "smoothing" procedure is necessary. When the $\Lambda_{b}$ is polarized, there is an interesting correlation of $\vec{s}_{\tau}$ with $\vec{s}_{\Lambda_{b}}$. In particular, the $\tau$-lepton can have a small polarization component $P_{\perp}$ perpendicular to the decay plane, which is proportional to $K$, and hence a pure manifestation of the "Fermi motion" of the $b$-quark in the hadron.
