## An N = 2 SUSY G auge M odel for D ynam ical B reaking of the G rand U ni ed SU (5) Sym m etry

## Abstract

We construct an extension of the recently proposed dynam ical model for the breaking of SU  $(5)_{GUT}$  gauge symmetry, in which a pair of massless chiral supermultiplets for H iggs doublets are naturally obtained. We point out that a model at a speci c point in the parameter space of superpotential is regarded as a low-energy e ective theory of an N = 2 supersymmetric gauge model for the strongly interacting hypercolor sector.

Recently, a dynam ical breaking scenario of the grand uni ed (GUT) gauge symmetry has been proposed based on a supersymmetric (SUSY) hypercolor SU (3)<sub>H</sub> gauge theory, where six avors of quarks Q and antiquarks  $\overline{Q}$  interact strongly at the GUT scale [1, 2]. The dynam ical breaking of SU (5)<sub>GUT</sub> also produces a pair of massless composite colortriplet states simultaneously. A use of the missing partner mechanism [3] yields a pair of massless Higgs doublets, giving large masses to the color-triplet partners.

The model assumes, in addition to Q and  $\overline{Q}$ , a hypercolor-singlet chiral multiplet in the adjoint representation of SU (5)<sub>GUT</sub> to get rid of unwanted N am bu-G oldstone multiplets. The is easily extended to the (35+1) representation of the global SU (6) by introducing a pair of 5 and 5 and two singlets of SU (5)<sub>GUT</sub>. A lthough this extended model is more complicated than the previous one, it seems to suggest a more fundam ental theory at the short distance [4]. Namely, this extended model may be regarded as the dual theory of an original SU (3) gauge theory with six avors of quarks q and  $\overline{q}$ , but without [5].

In this letter, however, we propose a di erent view on the extended model. We show that a model with a speci c choice of parameters in the superpotential is identical to the low-energy e ective theory of an N = 2 SUSY model for the strongly interacting gauge sector.

The previous model [1, 2] is based on a supersymmetric hypercolor SU (3)<sub>H</sub> gauge theory with six avors of quarks  $Q^A$  in the 3 representation and antiquarks  $\overline{Q}_A$  in the 3 representation of the hypercolor SU (3)<sub>H</sub> (=1-3 and A=1-6). The rst ves of  $Q^A$ and  $\overline{Q}_A$  (A=1-5) transform as 5 and 5 of the SU (5)<sub>GUT</sub>, respectively. In addition to the quarks and antiquarks we introduce a hypercolor singlet  $A_B^A$  (A;B = 1 5) in the 24 representation of SU (5)<sub>GUT</sub> to avoid unwanted N am bu-G oldstone multiplets [1, 2].

It is a straightforward task to extend the  $B^{A}_{B}$  to the 35+1 representation of SU (6) under which  $Q^{A}$  and  $\overline{Q}_{A}$  transform as 6 and 6, respectively. We introduce a new pair of 5 + 5 and two singlets of SU (5)<sub>GUT</sub> and combine all of them with the adjoint 24 to form 35 + 1 of the global SU (6).

W e assume the following renorm alizable superpotential;

$$W = Q^{A} {}_{A}{}_{B}\overline{Q}_{B} + Tr + m_{1}Tr^{2} + m_{2}(Tr)^{2} + {}_{1}Tr^{3}$$

so that this model has a global SU (6) U (1) symmetry in the limit of the SU  $(5)_{GUT}$  gauge coupling  $g_5$  vanishing ( $g_5 = 0$ ). The U (1) should be gauged to have an unbroken U  $(1)_Y$  gauge symmetry in the vacuum described below [1, 2].

This model contains seven complex parameters  $(, m_1, m_2, 1, 2, \text{ and } 3)$  in the superpotential. Two phases of and  $^2$ , for example, are absorbed to the elds  $Q^A$  and  $^A_B$ . At the general point of the parameter space we always have the following vacuum,

In this vacuum our gauge group is broken down to the standard-m odel gauge group as

SU (5)<sub>G U T</sub> U (1)<sub>H</sub> SU (3)<sub>H</sub> ! SU (3)<sub>C</sub> SU (2)<sub>L</sub> U (1)<sub>Y</sub>;

where the unbroken gauge group SU  $(3)_{C}$  and U  $(1)_{Y}$  are linear combinations of the SU  $(3)_{H}$ and the SU (3) subgroup of SU  $(5)_{GUT}$  and the U  $(1)_{H}$  and the U (1) subgroup of SU  $(5)_{GUT}$ , respectively. The GUT unication of the gauge coupling constants in the standard model is practically achieved by taking su ciently large gauge coupling constants of SU  $(3)_{H}$  U  $(1)_{H}$  [1, 2].

In this vacuum (2) three pairs of the  $Q^A$  and  $\overline{Q}_A$  (A = 4 6) acquire masses w. The integration of these massive quarks and antiquarks yields an  $N_f = N_c = 3$  gauge theory where  $N_f$  and  $N_c$  are the numbers of avor and color, respectively. As shown by Seiberg [6] the classical vacuum given in Eq. (2) is slightly modiled by instanton elects in the case of  $N_f = N_c$ . However, the basic structure of the vacuum is not changed and the standard-model gauge group SU (3)\_C SU (2)\_L U (1)\_Y remains unbroken even in the quantum vacuum .

Since the global SU (6) (in the lim it  $g_5=0$ ) is broken down to SU (3)<sub>c</sub> SU (3) in this vacuum, we have three true and two pseudo N am bu-G oldstone multiplets. The two true N am bu-G oldstone multiplets transforming as (3,2) and (3,2) under SU (3)<sub>c</sub> SU (2)<sub>L</sub> are absorbed to the SU (5)<sub>GUT</sub> gauge multiplets and the last one to the broken U (1) gauge multiplet. Thus, there remains a pair of pseudo N am bu-G oldstone multiplets which transforms as 3 and 3 of SU (3)<sub>c</sub>. As shown in the previous paper [1, 2], these 3 and 3 acquire GUT-scale masses together with the 3 and 3 in the standard Higgs multiplets H<sub>A</sub> (5) and  $\overline{H}^A$  (5) of SU (5)<sub>GUT</sub>. Thus, there is a pair of Higgs doublets left in the massless spectrum. It is easily proved by using the SUSY nonrenorm alization theorem [7] that this pair of Higgs doublets is exactly massless even in the quantum vacuum as far as the SUSY is unbroken.

Now, we show our main point in this letter. There is a peculiar hypersurface in the parameter space of the extended model, on which  $U(1)_R$  symmetry is restored. This surface is defined by  $= _1 = _2 = _3 = 0$  and hence it consists of only 3 parameters, m<sub>1</sub>, and m<sub>2</sub> in Eq. (1). Under the  $U(1)_R$ , each elds,  $Q^A$ ,  $\overline{Q}_A$ , and  $_B^A$  transform as

On this hypersurface we have the vacuum de ned in Eq. (2) only when  $m_2 = \frac{1}{3}m_1$  is satistical ed. Thus a the tuning of the parameters is required to obtain the desired vacuum given in Eq. (2). However, we show that such a specific point in the parameter space corresponds to a low-energy elective theory of an N = 2 SU SY gauge model for the strongly interacting sector.

The N = 2 SUSY model discussed by Leigh and Strassler [8] contains an N = 2 gauge multiplet of SU (3)<sub>H</sub> and six (= 2N<sub>C</sub>) hypermultiplets ( $Q^A; Q_A$ ). The N = 2 gauge multiplet consists of an SU (3)<sub>H</sub> adjoint chiral super eld X and the SU (3)<sub>H</sub> gauge multiplet in the N = 1 SUSY theory. Then, the superpotential is written in terms of the N = 1 SUSY elds

as

$$W = gQ^{A}X \quad \overline{Q}_{A}; \qquad (4)$$

where g is the SU  $(3)_{H}$  gauge coupling constant. The N = 2 SUSY model is de ned by introducing the mass term for X [4],

$$W = \frac{m_X}{2} T r X^2;$$

which breaks the N = 2 SUSY down to the N = 1.

The integration of X leads to an e ective superpotential

$$W^{0} = \frac{g^{2}}{m_{X}} Q^{A} \overline{Q}_{A} T^{i} T^{i} Q^{B} \overline{Q}_{B}$$
$$= \frac{g^{2}}{2m_{X}} Q^{A} \overline{Q}_{B} Q^{B} \overline{Q}_{A} \frac{1}{3} Q^{A} \overline{Q}_{A} Q^{B} \overline{Q}_{B} ; \qquad (6)$$

where T<sup>i</sup> is a generator matrix of the SU  $(3)_{\rm H}$  Lie algebra. This superpotential is rewritten by using an auxiliary eld  $_{\rm B}^{\rm A}$  as

$$W^{0} = Q^{A}_{A} \frac{B}{Q}_{B} + \frac{2m_{X}}{2g^{2}} Tr^{2} \frac{1}{3} (Tr)^{2} :$$

This corresponds exactly to the superpotential at the speci c point in the parameter space of our extended model on which the desired vacuum given in Eq. (2) is obtained. In fact, we drive F-term atness conditions for vacua directly from the superpotential (4) and (5) as,

$$X \overline{Q}_{A} = Q^{A}X = 0; \qquad (8)$$

$$m_X X = g(\overline{Q}_A Q^A - \frac{1}{3} Tr\overline{Q}Q); \qquad (9)$$

which yield the solution for  $Q^A$  and  $\overline{Q}_A$  given in Eq. (2) together with D-term atness conditions.

At the short distance the  $\frac{A}{B}$  is an auxiliary eld of dimension two in the N = 2 SUSY model while the  $\frac{A}{B}$  in the extended model is a propagating canonical eld of dimension one. However, it is very much plausible that the radiative corrections generate the kinetic term for the auxiliary eld  $\frac{A}{B}$  at the considerably long distance like at the GUT scale.

Therefore, we believe that both theories become indistinguishable at the low energies as point out in Ref.  $[7]^1$ 

Since the N = 2 SUSY model does not need a ne-tuning of parameter to have the desired vacuum, we consider that the extended model at a speci c point in the parameter space is a low-energy elective theory of the more fundamental N = 2 SUSY model.

We should note that there is a massless N ambu-G oldstone multiplet corresponding to the U  $(1)_R$  breaking. As a consequence there is a exactly at direction keeping the vacuum expectation value v in Eq. (2) undetermined unless the explicit breaking term of the U  $(1)_R$  is introduced.

F inally we comment on the nucleon's instability. Unlike the previous model [1, 2] we do not have a suppression mechanism for the dangerous d= 5 operators of the nucleon decay in the present model. Therefore, we hope that the coming nucleon-decay experiments will select one of these two diment models.

<sup>&</sup>lt;sup>1</sup> P recisely speaking, however, dynamics in our model is not the same as that in the N = 2 SUSY model in Ref. [7] because of the presence of U (1)<sub>H</sub> gauge interaction, even when one turns o the weakly interacting SU (5)<sub>GUT</sub>. Nevertheless, it is an using to note that the gauge coupling constant  $g_{1H}$  of the U (1)<sub>H</sub> is vanishing at the very long distance and hence the argument in Ref. [7] m ay be applicable even in our N = 2 SUSY model if one could take such a long distance.
