#### A bstract

C oherence phenom ena, and the non-universality of parton structure of the e ective P om eron are explained. New hard phenom ena directly calculable in Q CD such as directive electroproduction of states with M  $^2$  Q  $^2$  as well as new options to measure the light-cone wave functions of various hadrons are considered. An analogue of B prken scaling is predicted for the directive electroproduction of mesons at large momentum transfers and for the production of large rapidity gap events, as observed at HERA. A phenomenological Q CD evolution equation is suggested to calculate the basic characteristics of the large rapidity gap events. The increase of parton densities at small x as well as new means to disentangle experimentally soft and hard physics are considered. We discuss constraints on the increase of deep inelastic amplitudes with Q  $^2$  derived from unitarity of the S matrix for collisions of wave packets. New ways to probe Q CD physics of hard processes at large longitudinal distances and to answer the long standing problems on the origin of the P omeron are suggested. Unresolved problems and perspectives of small x physics are also outlined.

# Resume

Nous presentons une revue sur le role respectif de  $Q \in D$  dure et molle dans les reactions di ractives inclusives et exclusives.

## l. Introduction

The aim of this talk is to outline QCD predictions for color coherence phenomena { a result of nontrivial interplay of hard and soft QCD physics specic for high energy processes (for more detailed discussion see [1]. Coherence phenomena provide an important link between the well understood physics of hard processes and the physics of soft processes which at present is mostly phenomenological. The soft/hard interplay is elaborated for the exclusive deep inelastic processes  $_{\rm L}$  + N  $_{\rm I}$  e + N for M  $_{\rm a}^2$  Q  $_{\rm I}^2$  directly calculable in QCD. These processes provide new methods of investigating

the structure of hadrons and the origin of the Pom eron and allow to search for new forms of hadronic matter in heavy ion collisions (for a review and references see [2]). The phenomenon of coherence reveals itself in high energy processes through a large probability of occurrence of directive processes and through their specic properties. Thus in this report we concentrate mostly on directive processes.

2. Interaction cross section for sm all size wave packet.

One of the striking QCD predictions for hard processes dominated by large longitudinal distances is that if a hadron is found in a small size con guration of partons  $\frac{1}{2}$ 

it interacts with a target with a small cross section . The prediction which follows from the factorization theorem for hard processes in QCD is in variance with many phenomenological approaches based on pre-QCD ideas and on quark models of hadrons.

A su ciently energetic wave packet with zero baryon and color charges localized in a small transverse volum e in the impact parameter space can be described by a opp pair. This conclusion follows from asymptotic freedom in QCD which implies that the contribution of other components is suppressed by a power of the strong coupling constant  $_{\rm s}$  and/or a power of Q<sup>2</sup>. A fam iliar example of such a wave packet is a highly virtual longitudinally polarized in a qq state. W ithin the parton model the cross section for the interaction of such a photon with a target is suppressed by an additional power of  $Q^2$ . But at the same time the probability for a longitudinal photon to be in a large transverse size con guration (soft physics= parton m odel contribution) is suppressed by a power of  $Q^2$ . These properties explain why reactions initiated by longitudinally polarized photons are best to search for new QCD phenomena.

The cross section for a high-energy interaction of a small size qq con guration o any target can be unambiguously calculated in QCD for low x processes by applying the QCD factorization theorem . In the approximation when the leading  $_{\rm S} \ln \frac{{\rm Q}^2}{\frac{2}{{\rm QCD}}} \ln {\rm x}$  terms are accounted for  $[{\rm G},4]$  the result is

where b is the transverse distance between the quark q and the antiquark q and  $G_T(x;Q^2)$  is the gluon distribution in the target T calculated within this approximation. In this equation the  $Q^2$  evolution and the small x physics are properly taken into account through the gluon distribution. To derive similar equation in the leading  $_{\rm s} \ln \frac{{\rm Q}^{\,2}}{\frac{2}{{\rm Q}\,{\rm C}\,{\rm D}}}$  approximation one should account for all hard processes including diagram s where (anti)quarks in the box diagram with production of one hard gluon. The nal result has the same form as eq.(1), but with  $G_N$  (x;Q<sup>2</sup>) calculated in the leading  $_{\rm S} \ln \frac{{\rm Q}^{\,2}}{\frac{2}{{\rm Q}_{\rm C}\,{\rm D}}}$  approximation. It also contains a small contribution due to sea quarks. Eq.(1) accounts for the contribution of quarks Q whose masses satisfy the condition:  $l_{\text{c}} = \frac{\frac{2 \, q_0}{4 \, \text{m} \, \frac{2}{0} + \, Q^{\, 2}}}{\frac{2 \, q_0}{4 \, \text{m} \, \frac{2}{0} + \, Q^{\, 2}}} \qquad r_N^2$  . The estimate  $\frac{15}{b^2}$  was obtained in [5] by numerical analysis of the b-space representation of the cross section of the longitudinally polarized photon, L, and requiring that G  $_T$  is conventional gluon distribution calculated in the leading  $_{_S} \ln \frac{Q^2}{\frac{2}{2}}$  approximation.

There is a certain similarity between equation (1) and the two gluon exchange model of F. Low [6] and S. Nussinov [7], as well as the constituent quark 2 gluon exchange model of J. Gunion and D. Soper [8]. The factor b<sup>2</sup> which is present in the QCD expression (1) for the cross section is also present in these models. The major qualitative distinction between the results of QCD calculations and expectations of the two gluon exchange models is that the nonperturbative QCD physics is accounted for in equation (1) through experimentally measured quantities - the gluon and the sea quark distributions The latter are particularly relevant for the fast increase of the cross section at small x, for the increase of leading twist nuclear shadowing with decreasing x, for the seem ingly slow decrease with  $Q^2$  of higher twist processes. All those e ects are characteristic for QCD as a nonabelian gauge quantum eld theory which predicts an increase of parton densities in hadrons with  $\frac{1}{x}$  in contrast to quantum mechanical models of hadrons. In QCD the inelastic cross section for the collision of a su ciently energetic small size, colorless two gluon con guration o any target is [1]

where the parameter—is likely to be similar to the one present in the case of scattering of a qq pair of a target. The difference compared to equation (1) is in the factor 9=4 which follows from the fact that gluons belong to the octet representation of the color group SU (3) $_{\rm c}$  while quarks are color triplets.

# 3. Electroproduction of vector m esons in QCD.

One of the examples of a new kind of hard processes calculable in QCD is the coherent electroproduction of vector m esons o a target T,

where V denotes any vector m eson ( ;!; ;J= ) or its excited states.

The idea behind the calculation of hard di ractive processes is that when  $l_c=\frac{1}{2m_{\,\mathrm{N}}\,\mathrm{X}}$  exceeds the diam eter of the target, the virtual photon transforms into a hadron component well before reaching the target and the nal vector meson V is formed well past the target. The hadronic con guration of the nal state is a result of a coherent superposition of all those hadronic uctuations of the photon of mass M that satisfy equation  $\frac{2\,l_c}{(1+M^{\,2}\,-\!Q^{\,2})}$   $r_N$ . Thus, as in the more familiar leading twist deep inelastic processes, the calculation should take into account all possible

hadronic interm ediate states satisfying this condition. The use of completeness over di ractively produced interm ediate hadronic states allows to express the result in terms distributions of bare of quarks and gluons as in the case of other hard processes. The matrix element of electroproduction of a vector meson A can be written as a convolution of the light cone wave function of the photon  $\frac{1}{2} \frac{1}{2} \frac{1}{2}$ 

In the case of a longitudinally polarized photon with high  $Q^2$  the intermediate state jni is a qq pair. As was mentioned in the previous chaptersection, it can be demonstrated by direct calculations that the contribution of higher Fock state components and soft physics are suppressed by a factor  $\frac{1}{Q^2}$  and/or powers of  $_{\rm S}$ . The proof of this result resembles the calculation of the total cross section for the deep inelastic scattering in QCD. The situation is qualitatively dierent in the case of a transversely polarized photon due to the singular behavior of the vertex  $_{\rm T}$ ! qq when one of the partons carries a small fraction of the photon momentum. In this case soft and hard physics compete in a wide range of Q $^2$ .

To understand the applicability of PQCD for the process discussed above it is convenient to perform the Fourier transform of the amplitude into the impact parameter space which leads to

where z denotes the fraction of the photon m om entum carried by one of the quarks. Here

where K  $_0$  is the Hankel function of an imaginary argument. To estimate which values of b domainate in the integral we approximate  $_V$  (z;k $_t$ ) by  $\frac{z(1\ z)}{(k_t^2+\ ^2)^2}$  which corresponds to  $_V$  (z;b) / z(1 z)bK $_1$ (b). We vary  $k_t^2$   $^{1=2}$  =  $\frac{1}{2}$  between 300 and 600 MeV/c.

In the case of  $_{\rm L}$  the average transverse size hbi ' 0.25 fm for  $\rm Q^2=10~G~eV^2$ ; x  $10^3$  and decreases at larger  $\rm Q^2$  approximately as 0.3 fm  $\rm \frac{3G~eV}{\rm Q}$  [5]. It also weakly decreases with decreasing x. The increase of  $\rm G_{\rm T}$  (x; b²), in equation (5) with decreasing b substantially contributes to the decrease of hbi. In the case of a transversely polarized — the contribution of large b is not suppressed since

and therefore the contribution of the kinem atical region  $z \,! \, 0$  and  $z \,! \, 1$  where nonperturbative QCD dominates is not suppressed.

It is worth noting that hbi contributing in the calculation of  $_{\rm L}$  {  $b\,(\!Q^{\,2}=10\,\,{\rm G\,eV}^{\,2})$  ,  $'\,0.25\,\,{\rm fm}$  is sim ilar to that in the electroproduction of vectorm esons  $b\,\,Q^{\,2}=10\,\,{\rm G\,eV}^{\,2}$  ,  $'\,0.35\,\,{\rm fm}$  . However for larger  $Q^{\,2}$  the dierence between the two values increases and reaches a factor of 2 for Q  $^2$   $\,100\,\,{\rm G\,eV}^2$  .

It can be shown that under certain kinematical conditions the interaction of a qq pair with the target is given by equation (1). In the leading order in  $_{\rm S}\ln x\ln\frac{Q^2}{\frac{2}{Q+D}}$  the leading Feynman diagrams for the process under consideration are a hard quark box diagram with two gluons attached to it and convoluted with the amplitude for the gluon scattering of a target.

One can consider the same process in the leading  $_s \ln \frac{Q^2}{\frac{2}{QCD}}$  approximation. In this case one has to include also the diagrams where one hard quark line is substituted by the gluon line. This leads to an extra term  $/ S_T (x;Q^2)$  in equation (1) and allows to treat the parton distributions in equation (1) with  $_s \ln \frac{Q^2}{\frac{2}{QCD}}$  accuracy which is more precise than the original leading  $_s \ln x \ln \frac{Q^2}{\frac{2}{QCD}}$  approximation in equation (1).

Since Feynm an diagram sare Lorentz invariant it is possible to calculate the box part of the diagram in terms of the light-cone wave functions of the vector meson and the photon and to calculate the bottom part of the diagram in terms of the parton wave function of the proton. This mixed representation is dierent from the QCD improved parton model which only uses the light-cone wave function of the target.

The next step is to express this am plitude through the parton distributions in the target. The calculation of the imaginary part of the relevant Feynm an diagram shows that the fractions of the target momentum carried by the exchanged gluons  $\mathbf{x}_i$  and  $\mathbf{x}_f$  are not equal,

We neglect term s O  $(\frac{J_{\zeta}^2}{Q^2})$  as compared to 1, with  $l_{\xi}$  the transverse momentum of the exchanged gluons. Within the QCD leading logarithm ic approximation

when terms  $_{s}$  are neglected, the di erence between  $x_{i}$  and  $x_{f}$  can be neglected and the amplitude of the qq interaction with a target is given by equation (1) [3,4,9].

We are now able to calculate the cross section for the production of longitudinally polarized vector m eson states when the m om entum transferred to the target t tends to zero [9], but  $Q^2$ ! 1 y

 $_{\text{V ! e}^+\,\text{e}}$  is the decay width of the vector m eson into  $\text{e}^+\,\text{e}$  . The param eter  $_{\text{V}}$  is de ned as

where  $_{\rm V}$  is the light cone wave function of the vector m eson. At large Q  $^2$  equation (11) predicts a Q  $^2$  dependence of the cross section which is substantially slower than 1=Q  $^6$  because the gluon densities at small x fastly increase with Q  $^2$ . Numerically, the factor  $_{\rm s}^2$  (Q  $^2$ )G  $^2$  (x;Q  $^2$ ) in equation (11) is / Q  $^{\rm n}$  with n -1. An additional Q  $^2$  dependence of the cross section arises from the transverse momentum overlapping intergral between the light-cone wave function of the  $_{\rm L}$  and that of the vector m eson [5], expressed through the ratio  $\rm I_V$  (Q  $^2$ )

In ref. [9] it was assumed that  $I_V$  (Q  $^2$ ) = 1 as for Q  $^2$ ! 1 the ratio  $I_V$  (Q  $^2$ ) tends to 1. But form oderate Q  $^2$  this factor is signi cantly smaller than 1. For illustration we estimated  $I_V$  (Q  $^2$ ) for the following vector meson wave function:  $_V^{(1)}(z;k_t^2)=\frac{cz\,(1-z)}{(k_t^2+-2)^2}$ . The momentum dependence of this wave function corresponds to a soft dependence on the impact parameter b - exp( b) in coordinate space. We choose the parameter so that  $k_t^2$   $^{1=2}$  20:3 0:6 GeV=c.

Our num erical studies show that the inclusion of the quark transverse m om enta leads to severale ects:

Dierent k dependence of  $_{\rm V}$  leads to som ewhat dierent Q $^2$  dependence of  $I_{\rm V}$  (Q $^2$ ). Thus measuring of Q $^2$  dependence of electroproduction of vector mesons may become an electric way of probing  $k_{\rm t}-$  dependence of the light-cone qq wave function of vector mesons.

The  $\hat{\mathcal{G}}$  dependence of  $I_V$  for production of vector mesons build of light quarks u;d;s should be very sim ilar

For electroproduction of charm on ium states where c  $\frac{m \cdot J}{m}$  the asymptotic formula should be only valid for extrem ely large Q<sup>2</sup>.

The NMC data [10] and the HERA data [11] on di ractive electroproduction of mesons are consistent with several predictions of equation (11):

a fast increase with energy of the cross section for electroproduction of vector m esons (proportional to x  $^{0:8}$  for Q  $^2$  = 10 G eV  $^2$ ) ( gure 1 [5]) y;

the dom inance of the longitudinal polarization  $\frac{L}{T}$  / 0<sup>2</sup>;

the absolute magnitude of the cross section within the uncertainties of the gluon densities and of the  $k_t$  dependence of the wave functions (gure 1)

the  $\mathbb{Q}^2$  dependence of the cross section for  $\mathbb{Q}^2$  10 G eV  $^2$  which can be param eterized as  $\mathbb{Q}^n$  with n 4. The di erence ofn from the asym ptotic value of 6 is due to the  $\mathbb{Q}^2$  dependence of  $\mathbb{S}^2$  ( $\mathbb{Q}^2$ ) and of  $\mathbb{I}_V^2$  which are equally important in this  $\mathbb{Q}^2$  range.

We discussed above (see also section 8) that the perturbative regime should dominate in the production of transversely polarized vector mesons as well, though at higher Q². This may be manifested in the x-dependence of the ratio  $\frac{1}{T}$  for  $xed\ Q^2$ . At intermediate Q² 10 GeV² where hard physics already dominates in L, T may still be dominated by soft nonperturbative contributions. For these Q² the ratio should increase with decreasing x  $x^2G_N^2(x;Q^2)$ . At su ciently large Q² where hard physics dominates for both L and T the ratio would not depend on x.

The t dependence of the cross section is given by the square of the two gluon form factor of the nucleon  $G_{2g}$  (t). Practically no t dependence should be present in the block of gluon interaction for t  $Q^2$ . Thus the t dependence should be universal for all hard diractive processes. Experimentally the data on diractive production of mesons for  $Q^2$  5 GeV $^2$  [10], on photoproduction of J= mesons [13] and even on neutrinoproduction of D $_s$  mesons [14] show a universal tobehavior corresponding to  $G_{2g}^2$  (t) = exp (B t) with B

4~5 G eV  $^2$  . A certain weak increase of B is expected with increasing incident energy due to the so called G ribov di usion [15], but this e ect is expected to be much smaller than for soft processes. However in the lim it Q  $^2$  = const and s! 1 it is natural to expect an

onset of a soft regim e, which is characterized both by a slowing down of the increase of the cross section with increasing s and by a faster increase of the slope B with s,

W e want to point out that for M  $_{\rm v}^2$ e ect of QCD radiation is small. This is because brem sstrahlung corrections due to radiation of hard quarks and gluons are controlled by the parameter s  $\ln \frac{x_i}{x_{\varepsilon}}$  which is small since in the reaction considered  $\boldsymbol{x}_{\!f}$  . This argument can be put on a formal ground within the double logarithm ic approximation s  $\ln \frac{1}{x} \ln \frac{Q^2}{2}$  are taken into account. when only terms One can consider a more traditional approximation where terms 's  $\ln \frac{Q^2}{\frac{2}{QCD}}$  are taken into account but term s' s are neglected. W ithin these approximations it is legitimate to neglect the contribution of the longitudinal m om entum as com pared to the transverse one. This is a special property of small x physics. Thus the dierence between  $x_i$  and  $x_f$  leads to an insignicant correction.

Formula (11) correctly accounts for nonperturbative physics and for the diusion to large transverse distances characteristic for Feynm an diagram s, because in contrast to the naive applications of the BFKL Pomeron the diusion of small size con gurations to large transverse size is not neglected.

Electroproduction of J= mesons has been calculated in the whole Q<sup>2</sup> range in [16] within the leading s ln x approximation of QCD for the interaction with a target and the nonrelativistic charm onium quark  $m ext{ odel for } J = -m ext{ eson } w ext{ ave function. If } w ext{ e } w ext{ ould apply}$ (eq. (11)) at  $Q^2 = 0$  the result of ref. [16] coincides with the nonrelativistic  $\lim$  it of our result if  $I_V$  is assumed to be equal 1. At the sam e tim e the inclusion of the transverse momentum distribution of c quarks in the J= wave function signi cantly suppresses the cross section of the di ractive electroproduction of J= mesons for  $m_{J=}^2$  . In particular, account of the quark Ferm i m otion within the model of ref.[16] using realistic charmonium models lead to suppression of photoproduction cross section by a factor 4 8 depending on the charmonium model (see discussion in ref.[5]). Remember that transverse distances essential in the photoproduc- $\frac{3}{m}$  which are comparable tion of the J= meson are to the average interquark distance in the J= wave function. Since the energy dependence of di ractive photoproduction of J= is consistent with pQCD prediction of [16] the disagreem ent with the absolute prediction m ay indicate an important role for the interaction with interguark potential. Note that in the lim it where it is

possible to justify the application of PQCD (eq. (11)) (m $_{\rm J=}^2$  Q $^2$ ) it is necessary to use distribution of bare cquarks within J= m eson instead of charm on ium wave functions to account for the screening of color elds of c quarks.

A nother interesting process which can be calculated using the technique discussed above is the production of vector m esons in the process  $_{\rm L}$  + p! V + X in the triple R eggeon lim it when the few G eV and the Q². In this kinematical domain the domain contribution is due to the scattering of the two gluons on a parton of the target g+g+parton! parton. To avoid the uncertainties related to the vector meson wave function it is convenient to normalize the cross section of this process to that of the exclusive vector meson production at t=0 [17,1]

It follows from equation (15) that the cross section of the process  $_{\rm L}$  + p! V + X should decrease very weakly with t and therefore it is expected to be relatively large at t few G eV . Similarly to the approach taken in [18,19] one can easily in prove equation 15 to account for leading  $_{\rm S}$  ln x term s.

Equation (15) is a particular case of the suggestion (and of the formulae) presented in reference [18], that sem i{exclusive large t di ractive dissociation of a projectile accompanied by target fragm entation can be expressed through the parton distributions of the target. The advantage of the process considered here as compared to the general case is the possibility to prove the dominance of hard PQCD physics for a longitudinally polarized photon as the projectile and the lack oft dependence in the vertex + g! g+V. These advantages allow to calculate the cross section without free param eters.

Production of transversely polarized vector mesons by real or virtual photons in the double di ractive process  $_{\rm T}$  + p! V + X has been calculated recently within the approximation of the BFKL Pomeron in [20]. The calculation was performed in the triple Reggeon limit for large t but s t. Contrary to reactions initiated by longitudinally polarized photons this calculation is model dependent; the end point

nonperturbative contribution to the vertex  $_{\rm T}$  + g ! g + V , and therefore to the whole am plitude, leads to a contribution which is not under theoretical control. This problem is familiar to the theoretical discussions of high Q  $^2$  behavior of electrom agnetic form factors of hadrons.

Perturbative QCD predicts also approxim ate restoration of SU(3) symmetry in the production of vector mesons at large  $Q^2$  and signicant enhancement of the production of J=m eson as compared to SU(4):

This prediction is valid for Q  $^2$  m  $_V^2$  only. Pre{ asymptotic e ects are important in the large Q  $^2$  range. They signi cantly suppress the cross section for production of charmonium states (see above discussion). Thus the value of the J== ratio would be signi cantly below the value given by eq.(16) up to very large Q  $^2$ . For example the suppression factor is 1=2 for Q  $^2$  100G eV  $^2$  [5]. At the same time it is likely to change very little the predictions for ;!; -m eson production, since the masses of these hadrons are quite close and their qq components should be very similar.

At very large Q  $^2$  the qq wave functions of all m esons converge to a universal asymptotic wave function with  $_{
m V}$  = 3. In this lim it further enhancement of the heavy resonance production is expected

It is important to investigate these ratios separately for the production of longitudinally polarized vectorm esons where hard physics dominates and for transversely polarized vectorm esons where the interplay of soft and hard physics is more important.

Equation (11) is applicable also for the production of excited vector meson states with masses m $_V$  satisfying the condition that m $_V^2$  Q $^2$ . In this limit it predicts comparable production of excited and ground states. There are no estimates of  $_V$  for these states but it is generally believed that for  $^0$ , ! $^0$  and  $^0$  it is close to the asymptotic value, and as a rough estimate, we will assume that  $_V$  =  $_V$   $^\circ$ . Using the information on the decay widths from the Review of Particle Properties [21] we not that

In view of substantial uncertainties in the experimental widths of most of the excited states and substantial uncertainties in the values of  $_{V}$   $^{_{0}}$  and the ratio  $\frac{I_{V}}{I_{V}}$  these numbers can be considered as good to about a factor of 2. The case of  $^{_{0}}$  where  $_{V}$  is well known is less

am biguous. In this case estimates using charmonium models indicate a signicant suppression as compared to the asymptotic estimate up to  $Q^2-20 \,\mathrm{GeV}^2$  where this suppression is 0.5 [5]. In spite of these uncertainties it is clear that a substantial production of excited resonance states is expected at large  $Q^2$  at HERA. A measurement of these reactions may help to understand better the dynamics of the diractive production as well as the light-cone minimal Fock state wave functions of the excited states. It would allow also to look for the second missing excited—state which is likely to have a mass of about 1900 MeV to follow the pattern of the; !; J= families.

The predicted relative yield of the excited states induced by virtual photons is expected to be higher than for real photons. Another interesting QCD e ect is that the ratio of the cross section for the di ractive production of excited and ground states of vector mesons should increase with decreasing x and increase Q $^2$ . This is because the energy denominator  $-\frac{1}{\frac{m^2q+k^2}{2(1-2)}}$ , relevant for the transition V !

qq (with no additional partons) should be large and positive. Thus the heavier the excited state, the larger Ferm imom enta should be important. Thus the gluon distributions should enter at larger virtualities in the case of V  $^0$  production.

To sum m arize, the investigation of exclusive di ractive processes appears as the most e ective method to measure the minimal Fock qq component of the wave functions of vector mesons and the light-cone wave functions of any small mass hadron system having angular momentum 1. This would be very helpful in expanding methods of lattice QCD into the domain of high energy processes.

#### 4. Electroproduction of photons.

The diractive process + p! + p o ers another interesting possibility to investigate the interplay between soft and hard physics and to measure the gluon distribution in the proton. We shall consider the forward scattering in which case only the transverse polarization of the projectile photon contributes to the cross section. This follows from helicity conservation. In this process, in contrast to reactions initiated by longitudinally polarized highly virtual photons, soft (nonperturbative) QCD physics is not suppressed. As a result, theoretical predictions are more limited. Within QCD one can calculate unambiguously only the derivative of the amplitude over  $\ln \frac{Q^2}{Q^2}$  but not the amplitude itself. However for su ciently small x and large  $Q^2$ , when  $_{s}(Q_{o}^2) \ln \frac{Q^2}{Q_{o}^2} \ln x$  is large, PQCD predicts the asymptotic behavior of the whole

am plitude.

It is convenient to decom pose the forward scattering am plitude for the process + p! + p into invariant structure functions in a way sim ilar to the case of deep inelastic electron-nucleon scattering. Introducing the invariant structure function H  $(x;Q^2)$ , an analogue of  $F_1(x;Q^2)$  fam iliar from deep inelastic electron scattering o a proton, we have  $[\![1]\!]$

When  $Q^2$  is su ciently large, QCD allows to calculate the  $Q^2$  evolution of the amplitude in terms of the parton distributions in the target. As in the case of deep inelastic processes it is convenient to decompose H  $(x;Q^2)$  in terms of photon scattering of avors of type if

Here  $P_{qq}$  and  $P_{qg}$  are the splitting functions of the GLDAP evolution equation [22] . The factor 1+  $\frac{x}{z}$  1  $\frac{x}{z}$  takes into account the dierence of the virtualities of the initial and nalphoton. The solution of this equation is

U sually it is assumed that the soft components of the parton distributions increase at small x more slowly than the hard ones. If this is the case, at su ciently small x, in the leading  $_{\rm S}$  ln x approximation, the rst term in equation (22) can be neglected. As a result one can obtain the asymptotic formula for the whole H  $(x;Q^2)$  and not only for its derivative.

Sim ilarly to the case of electroproduction of photons it is not dicult to generalize the Q $^2$  evolution equation to the amplitude for the diractive production of transversely polarized vector mesons. One of the consequences of this evolution equation is that, at

asym ptotically large Q $^2$  and small x, the production cross section has the same dependence on the atom ic number of a target as in the case of longitudinally polarized vector m esons.

#### 5. Coherent Pomeron.

It is interesting to consider high-energy hard processes in the di ractive regim e with the requirement that there is a large rapidity gap between the di ractive system containing the high  $p_t$  jets and the target which can remain either in the ground state or convert to a system of hadrons. In PQCD such a process can be described as an exchange of a hard gluon accompanied by a system of extra gluons which together form a color neutral state. It was predicted [18] that such processes should occur in leading twist. (Note that in reference [23] it was stated that this process should rather be a higher twist e ect. This statement was due to some specic assumptions about the properties of the triple Pomeron vertex).

The sim plest example is in the triple Reggeon lim it the production of high  $p_t$  jets in a process like

where the nalstate proton carries practically the whole m om entum of the initial proton. The initial particle can be any particle including a virtual photon. To probe the new PQCD hard physics the idea [18] is to select a nal proton with a large transverse m om entum  $k_t$ . One can dem onstrate that this selection tends to compress initial and nalprotons in small con gurations at the moment of collision. In this case the use of the PQCD two gluon exchange or two {gluon ladder diagram s becom es legitim ate. A nontrivial property of these processes is a strong asymmetry between the fractions of the target m om entum carried by the two gluons (the contribution of the symmetric con gurations is a higher twist e ect with the scale determined by the invariant mass of the produced two jets [24]). Thus one expects gluon brem sstrahlung to play a certain role [25]. However since the proton is in a conguration of a size  $\frac{1}{k_1}$  this radiation is suppressed by the small coupling constant:

The prediction is that such a process appears as a leading twist e ect [18]

This prediction is in an apparent contradiction with a naive application of the factorization theorem in QCD which states that the sum of the diagram swith such soft gluon exchanges cancels in the inclusive cross section.

However in reaction (23) we selected a certain nal state with a white nucleon hence the usual proof of the factorization theorem does not hold anymore | there is no cancelation between absorption and radiation of soft gluons [24]. This conclusion was checked in a simple QED model with scalar quarks [26].

It was suggested by Ingelman and Schlein [27] to consider scattering of the Pomeron as if the Pomeron were an ordinary particle and to dene parton distributions in the elective Pomeron. In this language the mechanism of hard interaction in diffraction discussed above would contribute to the parton distribution in the Pomeron a term proportional to

This term corresponds to an interaction in which the Pomeron acts as a whole. Hence the term coherent Pomeron. In this kinematical conguration the two jets carry practically all the longitudinal momentum of the Pomeron. The extra gluon bremsstrahlung discussed previously renders the x dependence somewhat less singular at x ! 1 but the peak should be concentrated at large x [25, 24, 26] There are no other known mechanisms generating a peak at large x. The recent UA (8) data [28] on the reaction p + p! jet<sub>1</sub> + jet<sub>2</sub> + X + p, with the proton transverse momentum in the range 2 G eV <sup>2</sup>  $k_{\rm c}^2$  $1 \,\mathrm{GeV}^2$ , seem to indicate that a signi cant fraction of the two jet events corresponds 1 kinematics. It is thus possible that to the x the coherent Pomeron contributes signicantly to the observed cross section y.

The prediction is that the contribution of the coherent Pomeron to directive electroproduction of dijets at  $p_t^2$  Q  $^2$  should be suppressed by an additional power of Q  $^2$

for other hard processes originating from the hard structure of the virtual photon.

The complicated nature of the elective Pomeron should manifested itself in several ways in hard direction [18, 24].

(i) There should be a signicant suppression of the

y The coherent production of high pt jets by a real photon has been rst discussed by Donnachie and Landsho [29] and then rediscussed in reference [30]. This process, discussed in the next section, gives a negligible contribution in the kinematic regime characteristic for the coherent Pomeron.

coherent P om eron m echanism at smallt due to screening (absorptive) e ects since at smallt the nucleon interacts in an average con guration. This suppression should be larger for pp scattering than for p scattering since absorptive corrections increase with the increase of the total cross section (for p interaction the VDM e ective total cross section at HERA energies is 30 mb). (ii) Due to the contribution of soft physics, the e ective

di raction.

Therefore it would be very important to compare hard di ractive processes induced by di erent projectiles and to look for deviations from the predictions based on the simplest assumption that the Pomeron has

#### 6. Forward electroproduction of jets.

Forward di ractive photo and electroproduction of high  $p_t$  jets o a nucleon target (in the photon fragmentation region)  $+ N ! jet_1 + jet_2 + N$  is another promising process to investigate the interplay of soft and hard physics. We shall conne our discussion to the kinematical region

is the square of the invariant m ass of the produced qq system , m  $_{\rm q}$  is the m ass of quarks and z is the fraction of photon m om entum carried by the q or q. In this regim e the coherence of the produced hadron states allows to express the am plitude through the gluon distribution in the target.

An interesting e ect occurs in the photoproduction The contribution of a single Feynman diagram with the 2 gluon exchange in the t channel contains terms  $R_1 = \frac{p_t}{p_t^2 + M^2}$  and  $R_2 = \frac{m}{p_t^2}$ . Here is the mass of a bare quark, M can be calculated through m in pQCD but in general accounts for the nonperturbative physics. We omit constants and matrixes in this dimensional estimate and restrict ourselves to the contribution of large  $p_t$  only. A cancelation occurs when the sum of diagrams is considered. It accounts for the fact that the sum of diagrams describes the scattering of a colorless dipole.

Naively we should expect that after cancelation R  $_1$  term should become R  $_1$   $\frac{p_t}{(p_t^2+M^{-2})^2}$ . But in reality it becomes R  $_1$   $\frac{M^{-2}p_t}{(p_t^2+M^{-2})^3}$   $\frac{1}{p_t^5}$ . R  $_2$  term after cancelation in the sum of diagrams becomes R  $_2$   $\frac{m}{p_t^4}$ .

Thus cross section of forward photoproduction of qq pair d =dtdp2 contains term s:  $\frac{m}{p_t^8}$  [30],  $\frac{M}{p_t^{10}}$  and  $\frac{M}{p_t^9}$ .

Since mass of light quark is small it is reasonable to put it 0. It is not legitimate to put M = 0. So expected asymptotical behavior is  $\frac{M^4}{p_1^{10}}$ . Thus photoproduction of charm should dominate hard directive photoproduction processes for  $p_t$  m<sub>c</sub> [30].

Photoproduction of high  $p_t$  jets originating from the fragm entation of light avors is predom inantly due to next to leading order processes in  $_{\mbox{\scriptsize S}}$  .

The di ractive electroproduction of dijets seems to be the dom inant process in the region of M  $_{\rm qq}^2$   $\,$  Q  $^2$  , while in the region M  $_{\rm qq}^2$   $\,$  Q  $^2$  exclusive dijet production is one of m any competing processes contributing to the di ractive sector like radiation of gluons from quark and gluon lines.

In the approximation when only leading  $_{\rm S}\ln\frac{Q^2}{\frac{2}{Q_{\rm CD}}}$  or leading  $_{\rm S}\ln x\ln\frac{Q^2}{\frac{2}{Q_{\rm CD}}}$  terms are kept, the omass shell e ects in the amplitude for the qq interaction with a target are unimportant. Therefore the total cross section of directive electroproduction of jets by longitudinally polarized photons can be calculated by applying the optical theorem for the elastic qq scattering of a nucleon target and equation (1) for the total cross section of qq scattering of a nucleon:

Here B is the slope of the two gluon form factor discussed in section 4 and  $_{\text{L}}$  (z;b) is the wave function of the longitudinally polarized photon. Essentially the same equation is valid for the production by transversely polarized virtual photons of two jets which share equally the momentum of the projectile photon.

In Ref.[32] it has been assumed that diractive production of jets o a proton is dominated by hard physics and that soft physics ia unimportant. The formulae obtained under this assumption resembles equation (28) but with the gluon distribution in a target calculated within the leading  $_{
m s} \ln rac{1}{
m x}$  approximation. In view of the nontrivial interplay of soft and hard physics of large longitudinal distances this approach is di cult to justify in QCD. To visualize this point let us consider the e ect of nuclear shadowing in diractive electroproduction of jets. If the assumption that hard PQCD dominates at each stage of the interaction were correct, nuclear shadowing should be numerically small and suppressed by a power of  $Q^2$ . On the contrary, in QCD at su ciently sm all x and xed Q  $^2$  nuclear shadowing is expected to be substantial and universal for all hard processes. This conclusion is supported by current data on nuclear shadowing in deep inelastic

processes.

Dijet production has been also considered in the constituent quark model of the proton [33, 34]. In this approach the cross section for diraction is expressed through a convolution of the quark distribution in the virtual photon, the distribution of constituent quarks in the proton and their interaction cross section. A later generalization of this model [34] includes the gluon eld of constituent quarks. In QCD though, hard processes have to be expressed in terms of bare partons and not constituent ones. This is due to the use of completeness of the intermediate hadronic states in hard processes.

Equation (28) implies that in this higher twist e ect the contribution of large b, that is of the nonperturbative QCD, is enhanced as compared to the large b contribution to the total cross section. This result has been anticipated in the pre-QCD times [35] and has been con med in QCD [36]. A sim ilar conclusion has been reached in the constituent quark model [34] approach which however ignores characteristic for QCD increase of parton distributions at smallb. In OCD the hard contribution may become dom inant only at rather small x and large Q $^2$ . A sim ilar conclusion has been reached for the cross section of di ractive processes, calculated in the approximation of the BFKL Pomeron [37], in the triple Reggeon region when the mass of the produced hadronic system is su ciently large M $^2$  Q $^2$ .

Note that PQCD diagrams which were found to dominate in the large mass direction [37] are dierent from those expected from the naive application of the BFKL Pomeron [32, 34] and lead to dierent formulae.

To calculate this process within the more conventional leading s ln Q 2 approximation it is necessary to realize that in the kinem atical region where M  $_{\rm qq}^2$ the fractions of nucleon momentum carried by the exchanged gluons are strongly dierent,  $x_{hard}$  ' 2x but x. This is qualitatively dierent from the case of the vectorm eson production considered in section 3 in which the two values of x of the gluons were com parable. This is because in the case of dijet production them asses of the intermediate states are approximately equal to the m ass of the nal state. As a result of the asym m etry of the two x values the overlap integral between the parton wave functions of the initial and nalprotons cannot be expressed directly through the gluon distribution in the target. However at su ciently small x and large  $Q^2$ , when the parameter  $\frac{s}{2} \ln x \ln \frac{Q^2}{2}$ 1, electroproduction of high pt direts can be expressed through the gluon distribution in a target but in a m ore com plex way. In this particular case the factorization theorem can be applied after the st two hard rungs attached to the photon line, which have to be calculated exactly. The lowerpart of the diagram can be then expressed through the gluon distribution in the target since the asym m etry

between the gluons becomes unimportant in the softer blob. The proof is the same as for the vector meson electroproduction. Y The cross section is proportional to

where  $\mathbf{x}$  is the average  $\mathbf{x}$  of the gluons in the + gg!  $jet_1 + jet_2$  amplitude,  $\mathbf{x} = \mathbf{x}$ , and  $A_{+gg!}$   $jet_1 + jet_2$  is the hard scattering amplitude (which includes at least 2 hard rungs) calculated in PQCD.

One of the nontrivial predictions of QCD is that the decomposition of the cross section for a longitudinally polarized photon in powers of Q 2 becomes ine cient at small x. This is because additional powers of  $1=Q^2$  are com pensated to a large extent by the increase with Q  $^{\rm 2}$ of  $_{\rm s}$  (Q  $^{2}$ )xG (x;Q  $^{2}$ )  $^{2}$   $\frac{Q}{x}$  (see equations (29), (28)). Thus the prediction of QCD is that electroproduction of hadron states with M  $_{\rm X}^2$  Q  $^2$  by longitudinally polarized photons, formally a higher twist e ect, should in practice depend on Q2 rather mildly. The contribution of such higher twiste ects to the total cross section for di ractive processes may be considerable, as high as 30 40%. One of the observed channels, the electroproduction of mesons, constitutes probably up to 10% of the total cross section for di ractive processes. So far a detailed quantitative analysis of this im portant issue is m issing. On the experimental side, it would be extremely important to separate the longitudinal and transverse contributions to di raction.

# 7. Can di ractive cross sections raise forever?

We have demonstrated above that cross sections of hard di ractive processes are related to cross section of interaction of small color dipole with the target which increase fast with incident energy. However such increase cannot be sustained forever. The simplest way to obtain an upper limit for the range of energies where such increase should stop we consider here the scattering of a small object, a qq pair, from a large object, a nucleon. If only hard physics was relevant for the increase of parton distributions at small x, the radius of a nucleon should not increase (small G ribov di usion). Under this assumption the unitarity limit corresponds to a black nucleon. In this case the inelastic cross section cannot exceed the geom etrical size of the nucleon

To nd the value of  $r_N$  in eq.(30) we use the optical theorem to calculate the elastic cross section for a qq pair scattering o a nucleon,

where B is the slope of the elastic amplitude (cf. discussion in section 4). It follows from Eqs.(30),(31) and condition that  $_{\rm inel}+_{\rm el}=_{\rm tot}$  that the unitarity lim it is achieved when the elastic cross section is equal to the inelastic cross section  $_{\rm el}$   $_{\rm inel}.$  Based on this we nd  $\rm r_N^2=4B$  ' 16 GeV  $^2$  ' (0.8 fm) $^2$  is the radius of a nucleon. It follows from the above equations that practically the same estimate is obtained from the assumption that  $\frac{\rm (ell)}{\rm (tot)}$  (0.3 0.5).

Applying these inequality for the cases of  $_{\rm L}$  and -m eson production we nd [5] that unitarity lim it is reached for x  $_{\rm L}$  (Q  $^2$  = 5G eV  $^2$ ) 3 10  $^5$ , x  $_{\rm L}$  (Q  $^2$  = 10G eV  $^2$ ) 6 10  $^6$ , x (Q  $^2$  = 5G eV  $^2$ ) 3 10  $^4$ , x (Q  $^2$  = 10G eV  $^2$ ) 2 10  $^4$ .

The use of the amplitude for qq pair scattering o a nucleon to deduce the lim it allows to account accurately for nonperturbative QCD e ects through the unitarity condition for such an amplitude. On the other hand if the increase of parton distributions is related to soft physics as well then the cross section m ay be allowed to increase up to smaller x values.

The black disc limit for N has been discussed earlier (for a review and references see [38, 39]). The di erence compared to previous attempts is that we deduce the QCD formulae for the cross section of a go pair scattering o a hadron target. For this cross section the geometrical limit including numerical coecients unam biguously follows from unitarity of the S-matrix, that is the geometry of the collision. As a result we obtain an inequality which contains no free param eters. Recently a quantitative estimate of the saturation limit was obtained [40] by considering the GLR model [41,42] of nonlinear e ects in the parton evolution and requiring that the nonlinear term should be smaller than the linear term. The constraint obtained for  $xG_p(x;Q^2)$ is numerically much less restrictive compared to our result. Even a more stringent restriction follows for the interaction of a colorless gluon pair o a nucleon from the requirem ent that the inelastic cross section for the scattering of a small size gluon pair should not exceed the elastic one

For b = 0.25 fm the geom etrical lim it is achieved for x 10  $^3$  .

We want to point out that the black disc limit implies a restriction on the limiting behavior of the cross sections for hard processes but does not allow to calculate it. The dynam ical mechanism responsible for slowing down of the increase of parton distributions so that they satisfy equations (30, 32) is not clear. In particular the triple Pomeron mechanism for shadowing suggested in [41] does not lead to large e ects at HERA energies especially if one assumes a homogeneous transverse density of gluons [39, 43].

The theoretical analysis performed in this section does not allow to deduce restrictions on the limiting behavior of parton distributions in a hadron. Beyond the evolution equation approximation and/or leading  $_{\rm S} \ln x \ln Q^2$  over  $_{\rm Q\,C\,D}^2$  approximation the restriction on the cross sections of deep inelastic processes cannot be simply expressed in terms of parton distributions in a hadron target.

We want to draw attention to the fact that nonperturbative QCD e ects play an important role in the contribution of higher twisteects to  $_{\rm L}$  ( p). This is evident from the impact parameter representation of the contribution to  $_{\rm L}$  ( + p) of n consecutive rescatterings of small transverse size qq pairs. This contribution is proportional to

The inspection of this integral shows that for large 3, b which dom inates under the integral does not decrease with increasing Q  $^2$  for x  $^2$  p  $\frac{10}{Q}$  which follows from the evolution equation for small x. (This QCD e ect is absent in the applications [34] of the constituent quark model). Thus if higher twist e ects were really important in small x physics, it would imply that the small x physics is the outcome of an interplay of hard (sm all b) and soft (large b) QCD. To illustrate this point let us consider the cross section of di ractive electroproduction of hadrons with masses M<sup>2</sup> by transversely polarized photons. Applying the same ideas as in the case of longitudinally polarized photons we would obtain a similar expression as given by equation 28. The important dierence is that the wave function of a transversely polarized photon is singular for z! 0 or 1. As a result the contribution of large im pact param eters b in the wave function of the photon should give the dominant contribution to the integral in a wide kinematical range of x and  $Q^2$ . This has been understood long ago { see discussion in sections 8-9. A similar conclusion has been achieved recently [34] within the constituent quark model. (Note however that this model ignores the increase of gluon distribution with Q typical for QCD and therefore overestim ates the nonperturbative QCD contribution). Thus such type of di ractive processes should depend on energy in a way sim ilar to the usual soft hadron processes.

A good example of the consequences of the interplay

of small and large bphysics is that in electroproduction of small mass states the unitarity limit may become apparent at larger x than in the case of the total cross section of deep inelastic processes.

## 8. Diraction in DIS at intermediate Q $^2$

It has been understood long ago that the production of almost on mass shell quarks by virtual photons should give a signi cant contribution to the total cross section for deep inelastic scattering at small x [44]. One of the predictions of this approach (which is essentially the parton model approximation) is a large cross section for diractive processes. The QCD Q2 evolution does not change this physical picture radically. The only expected modication of the picture is the appearance of a number of hard jets in the current fragm entation region [36] typical for including  $_{\rm S}$  In Q  $^2$ terms. It is often stated that the dominance of the BFKL Pomeron in diractive processes predicts the dom inance of nalstates consisting of hard jets [32, 46]. However this prediction is not robust since the analysis of Feynm an diagram s for hard processes in QCD nds strong di usion e ects into the region of sm all transverse m om enta of partons (see [37] and references therein). Recent HERA data [45] seem to support the picture with a dominance of events with smallkt. Thus it seems worthwhile to investigate the role of nonperturbative QCD physics in diractive processes.

The interaction of a virtual photon with a target at intermediate  $Q^2$  and small x, when gluon radiation is negligible, can be considered as a transformation of into a qq pair which subsequently interacts with the target. In this case an important role is played by the quark con gurations in which the virtuality of the quark interacting with the target is small,

Here  $_{\rm q}$  denotes the light-cone fraction of the photon m om entum carried by the slower quark and  $k_{\rm t0}$  is an average transverse m om entum of partons in the hadron wave function, typically  $k_{\rm t0}$  0:3 0:4 GeV .

In the language of non-covariant perturbation theory the qq con gurations described by (33) correspond to an interm ediate state of m ass m  $^2$   $\,$  Q  $^2$  and of transverse size  $\,$   $\frac{1}{k_{t0}}$   $\,$  0.5 fm . These con gurations constitute a tiny fraction  $\,$   $\frac{k_{qt}^2}{Q^2}$  of the phase volume kinematically allowed for the qq pair. However the interaction in this case is strong { similar to the interaction of ordinary hadrons, since the virtuality of the slower quark is small and the transverse area occupied by color is large. The contribution of these con gurations leads to B jorken scaling since the total cross section is proportional to

 $\frac{1}{0.2}$  and in the parton model only these con gurations m ay contribute to the cross section. Hence B jorken has assumed [44] that all other con gurations are not important in the interaction though the underlying dynamics of such a suppression was not clear at that time [35]. A counting for the  $(\frac{k_{qt}^2}{O^2})$  factor in the G ribov dispersion representation allowed him to reconcile this dispersion representation with scaling. He suggested to refer to these con gurations as aligned jets since both quarks have small transverse momenta relative to the photon momentum direction. In further discussions we will refer to this approach as that of the Aligned Jet Model (AJM). Note that in term softhe Feynman fusion diagram the aligned jet contribution arises only for transversely polarized virtual photons. This is because the vertex for the transition  $_{
m T}$  ! qq is singular when the fraction of the photon momentum z carried by the slowest quark (antiquark) tends to 0. For the case of a longitudinally polarized photon the naive aligned jet approximation produces results qualitatively dierent from expectations in QCD where the contribution of sym m etric jets dom inates. This is because in QCD the dom inant contribution to the [ {nucleon cross section arises from the region of large  $k_{at} = \frac{Q}{2}$ .

In QCD the interaction of quarks with large relative transverse momenta with a target is suppressed but not negligible. The suppression mechanism is due to color screening since qq con gurations with large kt correspond, in the coordinate space, to con gurations of small transverse size, b  $\frac{1}{k_t}$ , for which equation (1) is applicable. It is easy to check that the contribution of large kt also gives a scaling contribution to the cross section. The practical question then is which of the two contributions dominates at intermediate  $Q^2 = Q_0^2$  $4 \text{ G eV}^2$ , above which one can use the QCD evolution equations. To make a num erical estimate we assume that the qq con gurations with  $k_{qt}$  $k_{\epsilon 0}$ , in which color is distributed over a transverse area similar to the one occupied by color in mesons, interact with a cross section similar to that of the pion. A comparison with experimental data for  $F_{2p}$  (x  $0.01; Q_0^2$ ) indicates that at least half of the cross section is due to soft, low kt interactions [36, 18]. A crucial check is provided by applying the same reasoning to scattering o nuclei in which the interaction of the soft component should be shadowed with an intensity comparable to that of pion-nucleus interaction. Indeed the current deep inelastic data on shadowing for  $F_{2A}$  (x;Q<sup>2</sup>) are in reasonable agreem entwith calculations based on the soft mechanism of nuclear shadowing [36, 48].

Sim ilarly to the case of hadron-nucleon and hadron-nucleus interactions, the interaction of in a soft hadron component naturally leads to diractive phenomena. Application of the Gribov representation

with a cuto on the  $k_t$  of the aligned jets in the integral leads to a diractive mass spectrum for the transversely polarized virtual photon [35]

The two major dierences compared to the hadronic case are that elastic scattering is substituted by production of states with M $^2$   $\rm Q^2$  and that the contribution of con gurations of small spatial size is larger for  $_{\rm L}$ .

If the aligned jet con gurations were dom inant, the fraction of cross section of deep inelastic N scattering due to single di ractive processes would be

Our num erical estim ates indicate that for  $Q^2$   $Q_0^2$  and x  $10^2$  the AJM contributes about 60 70% of the total cross section. So we expect that in this  $Q^2$  range the probability for direction is

This probability is actually related in a rather direct way to the amount of shadowing in interactions with nuclei in the same kinematic regime, so it is quite well determined by the nuclear shadowing data.

To estimate the probability of events with large rapidity gaps one has to add the processes of directive dissociation of the nucleon and double direction dissociation, leading to an estimate

This is rather close to the observed gap survival probability for photoproduction processes [47].

The characteristic features of the AJM contribution which can be checked experimentally are the charge and avor correlations between the fastest and the slowest diractively produced hadrons which should be similar to those in  $e^+\,e^-\,!$  hadrons at M $^2$   $\,\mathbb{Q}^2\,.$ 

A nother important feature of the soft contribution which distinguishes it from the contribution of hard processes is the t dependence of the cross section for M  $^2$  Q $^2$ . Since the size of the con gurations is comparable to that of the pion one may expect that the t slope of the cross section, B, should be similar to that of the pion-nucleon interaction, i.e. B  $10~{\rm G\,eV}^2$  which is much softer than for hard processes where we expect B  $4~{\rm G\,eV}^2$  (see discussion in section 3). The large value of the slope for the soft component is also natural in the parton type logic where only slow partons interact. It is easy to check that for t  $k_{0}^2$  0:1 G eV  $^2$  the mass of the produced hadron system is

larger than the m ass of the interm ediate state by factor  $\frac{t}{k_{t_0}}$ . Thus for large t the production of m asses M Q is suppressed. Therefore the study of the t-dependence of di raction can be used to disentangle the contribution of soft and hard m echanism s.

This discussion indicates also that the contribution of non-diagonal transitions "M $^2$ "! "M $^0$ 2" leads to a weaker decrease of the di erential cross section with M $^2$  than given by equation (34). Besides at large M $^2$  few Q $^2$  one expects an onset of the dom inance of the triple Pom eron mechanism which corresponds to

9.  $Q^2$  evolution of the soft contribution in di raction.

The major dierence between the parton model and QCD is the existence in QCD of a signicant high  $p_t$  tail in the parton wave functions of the virtual photon and the proton. This is the source of the violation of B jorken scaling observed at smallx. It is thus necessary to modify the aligned jet model to account for the hard QCD physics.

It is in general dicult to obtain with signicant probability a rapidity gap in hard processes in perturbative physics. Con nement of quarks and gluons means that a gap in rapidity is led by gluon radiation in PQCD and subsequently by hadrons [49]. It is possible to produce di raction in perturbative QCD but the price is a suppression by powers of the coupling constant s and/or powers of  $Q^2$ . In rst approximation in calculating diraction in deep inelastic processes at small x we will thus neglect di raction in PQCD. In the following analysis, for the description of large rapidity gap events, we shall use the QCD modication of the AJM model suggested in [36] as well as the suggestion of Yu Dokshitzer [50] to add to the conventional evolution equation the assumption of local duality in rapidity space between quark-gluon and hadron degrees of freedom.

In the course of the following considerations it will be convenient to switch to the Breit frame. In this frame the photon has momentum (0;  $2\mathtt{xP}$ ) and the initial proton has momentum (P,P). Correspondingly Q² =  $4\mathtt{x}^2\mathtt{P}^2$ . The process of direction can be viewed as the virtual photon scattering of a color singlet qq pair with the interacting parton carrying a light-cone fraction and the spectator parton carrying a light-cone fraction  $\mathtt{x}_1$ . We assume here the local correspondence in rapidity space between partons and hadrons. The mass of the produced system, M is given by

Here is the factor which includes the density of correlated color singlet pairs and the cross section for interaction of the photon with the parton. The total cross section for di ractive dissociation com es out to be proportional to  $\frac{1}{0^2}$ ,

We do not restrict the integration over  $x_1$  in equation (42) since the major contribution comes from the region of  $x_1$  . Thus we can formulate direction in the in nite momentum frame as a manifestation of short rapidity range color correlation between partons in the nonperturbative parton wave function of the nucleon. To calculate the Q $^2$  evolution in QCD we have to take into account that the parton with momentum fraction has its own structure at higher Q $^2$  resolution and that the scatters o constituents of the "parent" parton. This is the usual evolution with Q $^2$  which can be accounted for in the same way as in the QCD evolution equations by the substitution

where  $d_j^{\text{pert}}$  (x;Q  $^2$ ;Q  $_o^2$ ) are the structure functions of the parent parton. This e ect leads to the change of the relationship between  $x_1$  and x resulting from parton brem sstrahlung. A fler perform ing the integral over  $x_1$  we obtain

Here P denotes the probability of directive scattering in a soft interaction and  $d_j^{\text{nonpert}}$  (;Q $_0^2$ ) is the parton distribution in the soft component producing direction (compare discussion in the previous section). The function term rejects the condition that direction in the nonperturbative domain is possible only for

9.1. Qualitative pattern of x and Q $^2$  dependence of di raction.

It is easy to see that discussed equations lead to the leading tw ist di raction. To see the pattern of the x;Q  $^2$  dependence we can assume that  $d_j^{\text{pert}}\left(x;Q^2\right)=\frac{d}{x^n}$  and  $d_j^{\text{nonpert}}\left(x;Q^2\right)=\frac{d_0}{x^n}$ . It follows from equation (43) that for x the ratio  $\frac{d\,\text{iff}}{\text{tot}}$  does not depend on x. O ne can also see that the characteristic gap interval is

The second term  $\ln \frac{Q^2}{M - m_p}$  increases with  $Q^2$  in the parton model, while the scaling violation tends to reduce this increase since the mean value of M  $^2$ = $Q^2$  at xed x increases with  $Q^2$ .

There are several qualitative di erences between the QCD improved soft di raction and the parton model (AJM).

- (i) Due to QCD evolution the number of di ractively produced hard jets and the average transverse m om entum of di ractively produced hadrons should increase with Q $^2$ .
- (ii) The distribution of  $\frac{M^2}{Q^2}$  becomes broader in QCD with increasing  $Q^2$ .
- (iii) While in the parton model the cross section for the interaction of the longitudinally polarized virtual photon is a higher twist e ect, in QCD diraction is a leading twist for any polarization of the virtual photon. The nal state in the case of longitudinally polarized photons should contain at least 3 jets, two of them should have large transverse momenta comparable with Q.
- (iv) The x dependence of the soft component is likely to be faster than for soft Pomeron as seen in pp scattering both due to smaller screening corrections and due to contribution of congurations of sizes somewhat smaller than normal hadron sizes. In the laboratory frame of the target these congurations correspond to qq pairs with  $p_t$  0.5 1G eV=c.

# 9.2. Connection with the Ingelm an-Schlein Model

Ingelm an and Schlein have suggested to treat hard directive processes using the concept of parton

distribution in the Pomeron [27]. In this approach one calculates the light-cone fraction of the target carried by the Pomeron,  $x_{\rm P}$ , and light-cone fractions of the Pomeron momentum carried by quarks and gluons, . It is assumed that parton distributions in the Pomeron,  $q_{\rm P}$  ( ;Q  $^2$ );  $q_{\rm P}$  ( ;Q  $^2$ ) are independent of  $x_{\rm P}$  and the transverse momentum of the recoil nucleon. For the process of inclusive deep inelastic diraction is simply related to the observables,

The Q $^2$  evolution of the total cross section of di raction as considered in the previous subsections is consistent with the expectation of the Ingelm an–Schlein model (though the nal states are not necessarily the same). The aligned jet model in this case serves as a boundary condition de ning parton distributions in the Pomeron at intermediate Q $_0^2$  above which QCD evolution takes place. The aligned jet model corresponds to the quark distribution in the Pomeron

It follows from the discussion in the end of section 8 that taking into account the non-diagonal transitions in the aligned jet model and the triple Pomeron contribution would make the distribution atter. A similar, rather at, distribution is expected for gluons for these  $Q^2$ . This expectation of the aligned jet model is dierent from the counting rule anzatz of [27]:  $q_P(;Q^2_0)$  / (1 ). Note also that since the density of gluons at small x is larger than the qq density the elective gluon density in the Pomeron should be larger than the charged parton density already at  $Q^2$   $Q_0^2$ .

# 10. Non-universality of the pomeron in QCD.

Theoretical considerations of soft di ractive processes have demonstrated that ordinary hadrons contain components of very di erent interaction strength [51, 3]. This includes con gurations which interact with cross sections much larger than the average one and con gurations which interact with very small cross sections, described by equation (1) for a meson projectile.

The presence in hadrons of various con gurations of partons having di erent interaction cross sections with a target is in evident contradiction with the idea of a universal vacuum pole where universal factorization is expected. At the same time it is well known that the Pomeron pole approximation is not self-consistent. The vacuum pole should be accompanied by a set of Pomeron cuts [52]. For the sum of the Pomeron pole and the Pomeron cuts no factorization is expected. Thus the S

m atrix description and the QCD description are not in variance. We shall enumerate now where and how to search for the non universality of the elective Pomeron understood as the sum of the pomeron pole and the Pomeron cuts.

It is natural to distinguish two basic manifestations of the non universality of the elective Pomeron trajectory,  $_{\rm P}$  (t)  $_{\rm 0}$  +  $^{\rm 0}$ t, a dierent energy dependence of the interaction cross section, which is characterized by a dierent value of  $_{\rm 0}$ , and a dierent rate of the G ribov di usion, which would manifest itself in dierent values of  $^{\rm 0}$ .

## 10.1. Non-universality of the energy dependence.

To study the non universality of 0 it is necessary to study the energy dependence of the electroproduction of vector m esons as a function of Q2. Up to now only two results are known,  $_0$  1:08 from the photoproduction [53], and  $_0$  1:30 as estim ated from NMC and HERA data at  $Q^2$  10 GeV<sup>2</sup> [10, 11]. The key question is at what Q2 a signi cant rise of 0 starts { this will give a direct information on the transition region from soft to hard physics. A fast increase of  $F_{2p}$  (x;Q<sup>2</sup>) at small x observed at Q<sup>2</sup> as low as 1.5 GeV  $^2$  indicates that the rise may occur already at Q  $^2$   $\,\,$  3 GeV  $^2$  . The same question applies for production of heavier and J= mesons. Since the J= meson is a small object one may speculate that in this case the rise could start already for photoproduction (the experim ental data indicate that the slope of the J= exclusive photoproduction cross section is close to the value given by the two-gluon form factor of the nucleon). The practical problem for a quantitative analysis is that no accurate data on exclusive J= photoproduction at xed target energies are available at the m om ent. Inclusive xed target data where the J= m eson carries practically the whole momentum of the projectile photon which are used to extract the exclusive channel seem to be signi cantly contaminated by the contribution of the reaction + p! J = + X which is peaked at  $x_F$  $p_{T} = p$  close to 1.

## 10.2. Non-universality of the t-dependence.

The slope of the elective Pomeron trajectory  $^{0}$  should decrease with increasing  $Q^{2}$ . This is because the Gribov di usion in the impact parameter space, which leads to nite  $^{0}$  [15], becomes inessential in the hard regime. This is a consequence of the increase with energy of the typical transverse momenta of partons. Thus for the reactions + N + V + N the elective  $^{0}$  should decrease with increasing  $Q^{2}$  while a universal Pomeron exchange approximation predicts for

the energy dependence of the slope

with  $^0$  0.25 GeV  $^2$  . It is possible to look for this e ect by comparing the HERA and the NMC data on the meson production. The universalPomeron model predicts that the slope should change by B  $_2$  GeV  $^2$  between NMC energies where B  $_4$  5 GeV  $^2$  [10] and HERA energies while in the perturbative domain a much weaker change of the slope is expected.

The slope of the e ective P om eron trajectory  $^{0}$  m ay depend on the avor. It should decrease with the mass of avor. Thus it would be very important to measure the e ective  $^{0}$  for the diractive photoproduction of ; and J= . If PQCD is important for J= photoproduction one would expect a smaller increase of the slope with energy in this case.

## 10.3. Non-universality of the gap survival probability.

The presence of con gurations of di erent size in hadrons (photons) should also manifest itself in the non universality of the gap survival probability in the two jet events. Since the probability of gap survival is determined by the intensity of the soft interaction of the projectile with the target, the survival probability should increase with increase of Q², and at xed Q² it should be larger for the heavy gq components of the photon. Also, the gap survival probability in the photon case should be substantially larger than that observed in pp collisions at FNAL collider [54]. This rejects the difference between tot (pp) 80 mb and the elective cross section for the interaction of the hadronic components of ( ) with nucleon of 30 mb.

Observation of non-universalities discussed here will shed light on the structure of the elective Pomeron operating in strong interactions and will help to address the question about the major source of the increase of the total cross section of pp interaction soft physics or hard physics of small size con gurations.

# 10.4. Non-universality of di raction dissociation

Since the object which couples to the nucleon in the hard coherent processes is dierent from soft Pomeron one may expect a dierence between the value of the ratio

and similar ratio for soft processes.

Qualitatively, one may expect that since the coupling of excitive Pomeron in hard processes is more local the ratio of direction dissociation and elastic cross sections should be substantially smaller for hard processes, at least for small excitation masses.

#### 11. Sum m ary.

W e have dem onstrated that color coherent phenom ena should play in QCD a rather direct role both in the properties of hadrons and in the high energy collisions. It seems now that recent experimental data con m som e of the rather nontrivial predictions of QCD and help to elucidate such old problems as the origin of the Pomeron pole and the Pomeron cuts in the Reggeon Calculus. Thus we expect that the investigation of coherent hard and soft di ractive processes m ay be the key in obtaining a three dim ensional im age of hadrons, in helping to search for new form softhadron matter at accelerators and in understanding the problem of internucleon forces in nuclei. Forthcom ing high lum inosity studies of di raction at HERA which will include am ong other things the detection of the diracting nucleon and the  $_{
m L}$ T separation would greatly help in these studies.




Figure 1. The total longitudinal cross section,  $^{L}_{\rm N\,!\,N}$ , calculated from Eq. (11) for several recent param eterizations of the gluon density in comparison with experimental data from ZEUS [11] (full circles) and NMC [10] (squares). Typical parameters for the  $^{-}$ m eson wave functions as discussed above are taken ( $k_t^2$  $^{1=2}$ = 0.45GeV=c). We set  $_{\rm V}$ = 3 and parameterize the dependence of the dierential cross section on the momentum transfer in exponential form with B  $_{\rm S}$ GeV $^2$ . Note that a change of T $^2$ (Q $^2$ ) in the range corresponding to  $k_t^2$  $^{1=2}$ between 0.3 GeV/c and 0.6 GeV/c introduces an extra scale uncertainty of 0:7  $_{\rm I}$ 1:4.
