# Gauge-independent Thermal Function In Yang-Mills Theory

## A bstract

It is proposed to use the pinch technique (PT) to obtain the gauge-independent therm al function in a hot Y ang-M ills gas. Calculations of the therm al function are performed at one-loop level in four dierent gauges, (i) the background eld method with an arbitrary gauge, (ii) the Feynman gauge, (iii) the Coulomb gauge, and (iv) the temporal axial gauge, and they yield the same result in all four cases.

It is important for the study of the quark-gluon plasma and/or the evolution of the early Universe to fully understand the behaviour of the elective coupling constant  $_{\rm S}$  (=  ${\rm g}^2$ =4 ) in QCD at high temperature. The running of  $_{\rm S}$  with the temperature T and the external momentum (=  ${\rm j}\tilde{\rm K}$ ) is governed by the thermal function  $_{\rm T}$  [1]. However, the previous calculations of  $_{\rm T}$  have exposed various problem s [2], a serious one of which is that the results are gauge—xing dependent [3].

The background eld method (BFM) has been applied to the calculation of  $_{\rm T}$  at one-loop [2][4][5]. First introduced by DeW itt [6], BFM is a technique for quantizing gauge eld theories while retaining explicit gauge invariance for the background elds. Since the Green's functions constructed by BFM manifestly maintain gauge invariance, they obey the naive QED-like W ard identities. As a result, the spatial part of the three-gluon vertex, for static and symmetric external momenta, is related to the transverse function  $_{\rm T}$  (T;  $k_0=0$ ; = ]%) of the polarization tensor , and thus  $_{\rm T}$  is obtained in BFM from [2]

Due to the O (3) invariance, the spatial part of the gluon planization tensor  $_{ij}$  is expressed as follows:

and T can be extracted by applying the projection operator

The therm al function has been calculated in BFM at one-loop level for the cases of the gauge parameter  $_{\mathbb{Q}}=0$  [4],  $_{\mathbb{Q}}=1$  [5] and  $_{\mathbb{Q}}=$  an arbitrary number [2][7]. The results are expressed in a form,

where N is the number of colors. Contrary to the case of the QCD function at zero temperature,  $_{\text{T}}^{\text{BFM}}$  is dependent on the gauge-parameter  $_{\text{Q}}$ . The reason

why we have obtained  $_{\mathbb{Q}}$ -dependent  $_{\mathbb{T}}$  in BFM is that the contributions to  $_{\mathbb{T}}$  come from the nite part of the gluon polarization tensor and that BFM gives  $_{\mathbb{Q}}$ -dependent nite part for [8][9].

In this paper I propose to use the pinch technique (PT) to obtain the gauge-independent  $_{\rm T}$  in a hot Yang-M ills gas. The PT was proposed some time ago by Comwall [10] for an algorithm to form new gauge-independent proper vertices and new propagators with gauge-independent self-energies. First it was used to obtain the one-loop gauge-independent elective gluon self-energy and vertices in QCD [11] and then it has been applied to the standard model [12].

For example, let us consider the S-m atrix element T for the elastic quark-quark scattering at one-loop order. Besides the self-energy diagram in Fig.1, the vertex diagrams of the rst kind and the second kind, and the box diagrams, which are shown in Fig.2(a), Fig.3(a), and Fig.4(a), respectively, contribute to T. Such contributions are, in general, gauge-dependent while the sum is gauge-independent. Then we can extract the \pinch parts" of the vertex and box diagrams, which are dipicted in Fig.2(b), Fig.3(b), and Fig.4(b). They emerge when a matrix on the quark line is contracted with a four-momentum k o ered by a gluon propagator or an elementary three-gluon vertex. Such a term triggers an elementary W and identity of the form

The rst term removes (pinches out) the internal ferm ion propagator, whereas the second term vanishes on shell, or vice versa. This leads to contributions to T with one less ferm ion propagator and, hence, these contributions are called \pinch parts". The contribution of the self-energy diagram, when added pinch parts from the vertex and box diagrams, become gauge-independent. In this way we can construct the gauge-independent excive gluon polarization tensor (self-energy).

As in the case of BFM, the elective gluon polarization tensor and vertices constructed by PT obey the naive QED-like W and identities. Thus we can use the same Eq.(1) to obtain  $_{\rm T}$  in the framework of PT. M ore importantly, PT gives the gauge-independent results up to the inite terms, since they are constructed from S-m atrix. It was shown recently [13] that BFM with the gauge parameter  $_{\rm Q}$  = 1 reproduces

the PT results at one-loop order. However, for  $_{\mathbb{Q}}$   $\in$  1, this coincidence does not hold any more. In fact, BFM gives at one-loop order the gluon polarization tensor whose nite part is  $_{\mathbb{Q}}$ -dependent. Interestingly enough, Papavassiliou [8] showed that when PT is applied to BFM for  $_{\mathbb{Q}}$   $\in$  1 to construct the elective gluon polarization tensor, the gauge dependence of the nite part disappears and the previous  $_{\mathbb{Q}}$  = 1 result (or the universal PT result) is obtained.

To my know ledge, there exists, so far, only one approach, i.e. PT, which gives the gauge-independent gluon polarization tensor up to nite term s. And these nite term s give contributions to  $_{\rm T}$ . This notion inspires the use of PT for the calculations of  $_{\rm T}$ . In the following I will show that we obtain the same  $_{\rm T}$  in the fram ework of PT even when we calculate in four dierent gauges, (i) the background eld method with an arbitrary gauge, (ii) the Feynman gauge, (iii) the Coulomb gauge, and (iv) the temporal axial gauge.

## (i) The Background Field Method

In the background  $\,$  eld m ethod with an arbitrary gauge, the gluon propagator, iD  $_{ab(B\,F\,M\,)}=~i_{ab}D_{(B\,F\,M\,)}$ , and the three-gluon vertex with one background gluon eld,  $^{eabc}$ , are given, respectively, as follows [14]:

In the vertex, k is taken to be the momentum of the background eld and each momentum ows inward and, thus, p + k + q = 0.

A one-loop calculation of the polarization tensor was performed in Ref. [7], from which the transverse function  ${}^{(B \, F \, G \, )}_{T}$  ( $k_0 = 0$ ; = K) in the static lim it can be

extracted for << T as follows:

U sing this expression for  $_{\rm T}$  in Eq.(1), E lm fors and K obes obtained Eq.(4) for  $_{\rm T}^{\rm BFM}$  which is indeed gauge-parameter  $_{\rm Q}$  dependent [2].

Now we evaluate the pinch contributions to  $_{\rm T}$ . We consider the quark-quark scattering at one-loop order in the M inkow ski space. We use the gluon propagator and the three-gluon vertex given in Eqs.(6)-(8). The pinch contributions come from the vertex diagrams of the rst kind Fig. 2(b) and its mirror graph], the vertex diagrams of the second kind Fig. 3(b) and its mirror graph] and the box-diagrams [Fig. 4(b)]. We can extract from them the pinch contribution to the polarization tensor, which is expressed as [8]

where it is understood that the loop variables are related by k + p + q = 0.

When we turn to the imaginary time nite temperature formulation, we replace the integral in the M inkowski space with the following one:

Adding two contributions we nd that the sum

is gauge-param eter  $_{\mathbb{Q}}$  independent, and this gives a gauge-independent them mal function:

Note that the result coincides with  $_{\rm T}^{\rm BFM}$  in Eq.(4) with  $_{\rm Q}$  = 1 [5].

(ii) The Feynm an Gauge (The Covariant Gauge with = 1)

In the Feynm an gauge (FG) the gluon propagator, iD  $_{ab(FG)} = i_{ab}D_{(FG)}$ , is in a very simple form :

The three-gluon vertex is expressed as

where  $^{P}$  (p;k;q) and  $^{F}$  (p;k;q) are given in Eq.(8). From the one-loop polarization tensor in FG, we extract the contribution to the transverse function  $^{(FG)}_{T}$  and nd in the lim it << T,

$$_{T}^{(FG)}(T;) = N g^{2} T \frac{3}{16} + O(^{2}):$$

The pinch contribution to the polarization tensor in FG is very simple. Since the gluon propagator in FG does not have a k k term, the only contribution is coming from the vertex diagram of the second kind with the three-gluon vertex  $^{P}$  (and its mirror graph) [11], and it is given by

$$i_{P(FG)} = 2N g^2 k^2 \frac{d^4 p}{(2)^4 p^2 q^2} g$$

Following the same procedure as we did in (i), we obtain for the pinch contribution to  $_{\mathtt{T}}^{\mathtt{F}\,\mathtt{G}}$  as

$$_{T}^{P (FG)}(T;) = N g^{2} T \frac{1}{4} + O (^{2});$$

Again when we add two contributions,  $_{\rm T}^{\rm (FG)}$  and  $_{\rm T}^{\rm P (FG)}$ , we obtain the same  $_{\rm T}$  in Eq.(14) and, thus, the same  $_{\rm T}$  in Eq.(15).

## (iii) The Coulom b Gauge

In the frame of a unit vector n=(1;0;0;0), the gluon propagator in the C oulomb gauge (CG), iD  $_{ab(CG)}=i_{ab}D_{(CG)}$ , is defined by

The three-gluon vertex is the same as in FG, that is, abc (p;k;q) in Eq.(17).

The transverse function  $_{\mathrm{T}}$  is related to the polarization tensor as

Since  $k_{i\ ij}k_{j}=0$  in the static lim it  $k_{0}=0$ , we have  $_{T}(T;)=\frac{1}{2}$   $_{ii}(k_{0}=0;)$ . The  $_{ii}$  for general  $k_{0}$  and was evaluated in CG and the temporal axial gauge in Ref. [15]. Using the expression of Eq.(4.38) in Ref. [15] for  $_{ii}^{CG}(k_{0};)$ , we can calculate the static lim it of  $_{ii}^{CG}$  and obtain

$$_{T}^{(CG)}(T;) = \frac{1}{2} _{ii}^{(CG)}(0;) = N g^{2} T \frac{9}{64} + O (^{2});$$

It is straightforward to calculate the pinch contributions to the polarization tensor in CG. A gain we consider the quark-quark scattering at one-loop order. We discard the terms which are proportional to F and F, where k is the momentum transferred in the scattering, and we make use of the D irac equations satisfied by the

external quark elds, such as, (p m)u(p) = 0 and u(p)(p m) = 0. The pinch contribution to the polarization tensor in CG is expressed as

$$i_{P(CG)} = N g^{2}k^{2} \frac{d^{4}p}{(2)^{4}} \frac{k^{2}}{p^{2}q^{2}p^{2}} \frac{1}{p^{2}p^{2}} \frac{4k p}{p^{2}q^{2}p^{2}} g$$

$$+ \frac{N}{2}g^{2}k^{2} \frac{d^{4}p}{(2)^{4}} \frac{p p}{p^{2}q^{2}} \frac{k^{2}}{p^{2}q^{2}} \frac{4}{p^{2}} + \frac{2k^{2}}{p^{2}q^{2}}$$

Applying the projection operator  $t_{ij}$  to the spatial part  $_{P\ (C\ G\ )}^{ij}$ , we obtain in the static lim it and for << T

Adding the two contributions,  $_{\rm T}^{\rm (CG)}$  and  $_{\rm T}^{\rm P (CG)}$ , we not that the sum is equal to  $_{\rm T}$  in Eq.(14) and, thus, we obtain the same  $_{\rm T}$  in Eq.(15).

## (iv) The Temporal Axial Gauge

The gluon propagator in the tem poralaxial gauge (TAG), iD  $_{ab(TAG)} = i_{ab}D_{(TAG)}$ , is de ned by

where P , Q , C and D are given in Eqs.(22-25). The three-gluon vertex is given by  $^{abc}$  (p;k;q) in Eq.(17). The static lim it of  $^{(TAG)}_{ii}$  was caluculated in Ref. [15]. Using the result of Eq.(4.44) in Ref. [15], we not for << T

Following the same procedure as we extracted the pinch parts from the one-loop quark-quark scattering diagrams in CG, we obtain for the pinch contribution to the polarization tensor in TAG,

$$i_{P(TAG)} = N g^2 k^2 \frac{d^4 p}{(2)^4} \frac{k^2}{p^2 q^2 p_0^2} \frac{1}{p^2 p_0^2} + \frac{2}{q^2 p_0^2} \frac{4 k p}{p^2 q^2 p_0^2} g$$

$$+\frac{N}{2}g^{2}k^{2} \frac{d^{4}p}{(2)^{4}} \frac{p}{p^{2}q^{2}} \frac{k^{2}}{p_{0}^{2}q_{0}^{2}} \frac{4}{p_{0}^{2}} + \frac{2\tilde{k}^{2}}{p_{0}^{2}q_{0}^{2}} :$$

Then in the static lim it,  $_{\rm T}^{\rm P\ (TAG)}$  is expressed as

Due to the  $1=p_0^2$  and  $1=q_0^2$  terms coming from the TAG propagator, the above integrand contains a  $\tilde{K}^2=p^2$  singularity at the lower limit of the integration. This singularity is circum vented by the principal value prescription [15][16]. The result is for << T

Again the sum of  $_{\rm T}^{\rm (TAG)}$  and  $_{\rm T}^{\rm P \ (TAG)}$  coincides with  $_{\rm T}$  in Eq.(14) and yields the same  $_{\rm T}$  in Eq.(15).

Thave dem onstrated the calculation of the therm al function  $_{\rm T}$  in four dierent gauges, that is, in BFM with an arbitrary gauge, in FG , in CG , and in TAG . When the pinch contributions are taken care of, the same result  $_{\rm T}=\frac{q^3N}{128}\frac{7}{16}^{\rm T}$  was obtained at one-loop order in all four cases. More details will be reported elsewhere [17]. However, this is not the end of the story. Elm fors and K obes pointed out [2] that the leading contribution to  $_{\rm T}$ , which gives a term T=, does not come from the hard part of the loop integral, responsible for a  $T^2=^2$  term, but from soft loop integral. Hence they emphasized that it is not consistent to stop the calculation at one-loop order for soft internal momenta and that the resum med propagator and vertices [18] must be used to get the complete leading contribution. Since the corrections to the bare propagator and vertices, which come from the hard thermal loops, are gauge-independent and satisfy simple W ard identities [18], it is well-expected that we will obtain the gauge-independent thermal function even when we use the resum med propagator and vertices in the fram ework of PT. Study along this direction is under way.

(a) The box diagram s for the quark-quark scattering. (b) Their pinch contribution.








